

Civil Defense Notes

FOOD SUPPLIES FOR EMERGENCY FEEDING

It is the policy of the Federal Civil Defense Administration to encourage each family to maintain at all times for current use an average, normal three-day food supply on its pantry shelf. Current knowledge, especially concerning radioactive fallout, makes it necessary to enlarge this concept to a sevenday food supply, maintained in a sheltered area.

Following an enemy attack, it is assumed that in and around target areas public utilities, such as gas, electricity, telephone, water and sewage, would be inoperative. Persons for whom evacuation is not immediately feasable would probably have to depend, at least for the first few days, wholly upon their own food and resources for survival. Therefore, persons who must be evacuated should be equipped with at least a minimum of basic food and water supplies on which to subsist until other assistance is made available.
