## **Total Budget** Of \$134,325.00 **Is Presented**

The budget hearing of Kewaskum Community High School Jt. District No. 2 was called to order by Melvin Riley, director of the Board of Education, at 7:00 p. m. on Monday, June 25, in the high school auditorium.

The proposed budget was read and explained to the electors. There was considerable discussion concerning the cost of equipment for the new building and the most feasible plan of raising the money to pay for same. It was suggested that the board investigate the possibility of borrowing additional funds on a long-term basis to finance the cost of equipment.
