## State Hearing on Township Reassessment Controversy Held

The Wisconsin Department of Revenue conducted a public hearing here Thursday afternoon on a petition asking for reassessment of taxable property in the Town of Kewaskum.

The 40 or so who attended the 2½-hour hearing were told that a decision will be rendered within 60 days—hopefully within a month.

There were 12 petitioners and sworn testimony was taken from seven who were present: Miss Marilyn Reinhardt, Elton Liepert, Ned Sengpiel, Gerald Stoffel, William Thull, Harold Schmidt and Edward Theusch. Petitioners not present were Thurman Anderson, James D. Reigle, Gilbert Reindl, Edward Schneider and Alvin Vorderbruggen.

Sworn testimony also was taken from two residents, Dr. Charles Ogi and Elton Kirchner who spoke for reassessment and from Mrs. Raymond Schaefer who is opposed; from Town Chairman Mervin Thompson and Raymond Schaefer who has been assessor since April 1973, both of whom are opposed and from Alfred Seefeldt who retired one year ago after 40 years as town clerk. Seefeldt defended a 1969 reassessment of town property.

Miss Reinhardt said she went through the assessment roll, examined listings and made a digest of many properties which she then gave to the Department of Revenue representatives.

She said she also searched Washington County Register of Deeds records, looking at recent property sales in the town. "My idea was to see what property was selling for and compare it with what it was assessed for, she said.

Her conclusion, she noted, was that more recent property owners are being assessed at a higher level than those who have held property for some time. Those who bought recently are being assessed at 80 per cent, or more, of full market value, while property owners of some years standing are assessed at about 50 to 60 per cent of current market value. "Newcomers are being discriminated against," said Miss Reinhardt. "The legal level is supposed to be at 70 per cent."

She purchased the former Arthur Ramthun farm about four years ago, remodeled the home and has lived in it for about three years. Her property is located just east of Kewaskum, along Highway 28.

Those who own a house and lot are assessed higher than those who own farms, Miss Reinhardt observed.

She then cited numerous properties, from almost every section of the town, which she said were sold for substantially higher prices than their assessed valuation.

In answer to the question,

## Rev. Hoenecke Elected to Board

The home office is at 6800 North 76th St., Milwaukee.

The Social Service Center offers the services of adoption, infant boarding care, counseling of unmarried parents, and family counseling. The Convalescent Center provides skilled nursing care, restorative services, and custodial care for 111 patients in a modern nursing home. The Resident Center offers a home to 48 senior citizens in a residence wing built in 1968.

## Award 2 Firsts To KHS Choirs; Band Takes 2nd

Two firsts were awarded to the Kewaskum choirs in Class B competition. The high school band, competing in Class A, received a second rating from Judge Don Cutbart of Ripon College. The Music Festival was hosted by West Bend West High School, March 16. Other schools in attendance were: Grafton, Slinger, Kettle Moraine, Mayville and West Bend.

Each performing group must play a warm-up piece, which cannot exceed four minutes, a selected number, chosen by the band, and a required number from the list established by Wisconsin School Music Association.

Class A participants must sightread a piece. This involves playing a piece, never viewed by either the director of his group, which tests discipline, rhythmic accuracy, melodic accuracy, interpretation, and balance. Larry Ammel, director of the 67-piece high school band, chose to enter Class A competition, although many similar bands were in Class B. Kewaskum players performed: Three Marriages for the Duke of Orleans, Second Symphony for Band as a selected number and Pineapple Poll, from the required list.

The vocal department entered two choirs, in Class B, both with the direction of Mrs. Christine Stark. The concert choir chose to perform: Two Canzonets by Jean Berger, Hie schon leuchtet der Morgenstern, In Natali Domini by M. Praetorius and O'Magnum Mysterium, by Victoria. The girls choir: He's Gone Away arranged by Ron Nelson, Willow Song by Vaughan Williams, and How Merrily We Live by Michael Este.

## Reigle Withdraws From Congressional Race



Ron Reigle, Vice President of Marketing and Management at Regal Ware, Inc., and an aspirant for the Democratic

9th District Congressional nomination, this week announced he was withdrawing from the race.

Reigle, who has travelled and spoken extensively throughout the district the past several months, cited campaign financing as his principle reason for dropping out of the race.

"It has become increasingly clear that a Democratic primary would be extremely costly and it appears impossible for me to raise the large sums of money needed to win, without appealing to powerful special interest groups. This would be against everything I stood for in my campaign." Reigle went on to state, "I strongly support legislation limiting campaign spending, so that all classes of American citizens will again be represent-

ed in the American government."

A recently conducted poll showed that Reigle could have won the 9th District Congressional seat, but that it would have taken an expenditure in the mid-five figures to be successful. Reigle stated he is turning the results of this professional poll over to the Democratic Party for their use this fall.

The Kewaskum businessman expressed his desire to remain active in the Democratic Party and government affairs. Reigle termed the past few months a "very rewarding experience" and expressed his gratitude for the support and friendship of the thousands of people he met during this time. He urged those supporters to continue their work toward the principles of his campaign.

Among the business of the school board at the meeting held March 11, names of candidates for position on the ballot to be used at the Tuesday, April 2, Spring Election of School Board Members for the Kewaskum District were drawn by lot by the Clerk, James Oelhafen. The names of candidates were drawn as follows: (1) Clara J. Trapp, (2) Richard L. Edwards, (3) Richard Theusch, (4) Thomas W. Gundrum.

Reports and discussion on the building program was held. Items mentioned were the hoist purchase for the high school shop area, boiler capacity for the middle school and that costs were being checked on wherein an alternate plan to add a sewing room to the existing home ec area, rather than moving the home ec department to the 700 area of the present school would be considered. If this were the case and costs allowed it, the 700 area could then be used for a library-study area. The board did approve installing the base equipment to provide for a hoist, although approval of a hoist purchase was tabled to a future meeting when additional information is reported, on a vote of 6 to 1. Dr. Ogi cast the "no" vote.

Donald Hammes questioned the board relative to procedures used by Ken Erickson and Jack Sutton regarding disciplining of his children involving bus problems and an incident on the elementary school site.

Mr. and Mrs. John Kleinke gave the board a formal complaint on a bus driver involving her two kindergarten children and requested that a written report within a reasonable time explaining how the complaint is followed up and corrected.

After a lengthy discussion the board informed Mr. Hammes they would investigate the situations reported and reply at the next meeting on his inquiries.

Mr. Earl Morenzen inquired about a recent incident involving his son and Ken Erickson reported that the matter had been taken care of.

The board approved payroll, vouchers payroll, debt service and short term investment from the general fund, as well as payments to Thern Associates and Westra Construction from the building fund.

The board approved a 2c increase on the rate of Otto School Transportation of Newburg involving the transportation of students to special classes at Oak Knoll and Threshold at West Bend. This increase was requested because of gasoline costs rising.

The board approved the issuance of contracts for 1974-75 to the 98 staff plus 4 administrative personnel per the list and recommendations of Mr. Brenholt on the 1973-

"do you think your assessment is fair?" Miss Reinhardt replied that it is too high in relation to all property in general, and added that when she was before the Board of Review, she was told she was being assessed at 80 per cent of market value. "I think it's even higher," she stated.

"What do you think is fair?" she was asked. "I would like to have it reassessed and let some experts decide," was her answer.

When asked, "how do you think the inequities can be corrected?" she replied, "with a reassessment of the 1973 tax roll."

Asked if she believes the assessor can do it by himself, Miss Reinhardt responded, "I don't think he should be asked to do a job that big."

She stated that "the town never had a reassessment. In 1969, a retired tax official came in and did a very limited job."

Seefeldt then was called upon to explain what happened in 1969. He said that a man who for 20 years had been supervisor of assessments for the Fond du Lac district then retired was engaged by the Town of Kewaskum to reassess all properties. He offered to do the job for \$3,000.

Despite the fact that there has been criticism, Seefeldt continued, "by and large his job was as well done as any. Even though there were objections, we had fewer complaints at that time than at any other time."

Dr. Ogi commented, "when I see the number of people here and considering my contact with people, which is

very close, the sentiment for reassessment is very strong."

Of the seven petitioners present, only Miss Reinhardt favored a reassessment of the 1973 roll. The other favored a revaluation in 1974.

Under sworn testimony, Assessor Schaefer said he protests reassessment because there is not sufficient evidence. Town Chairman Mervin Thompson stated that the town board "has backed up our assessor on what he had done this year. He can correct any inequities in his 1974 assessments."

Asked if there has been "any thought to giving him (Schaefer) assistance," Thompson replied, "we will wait for your answer."

The Department of Revenue will now review the testimony. It will also make a field investigation, checking the assessment roll and assessor's records and assessments of the properties discussed, plus others chosen at random. Various property classifications, in relation to one another, will also be checked. "What we're after is uniformity in the tax roll," said the Revenue Department representative who conducted the hearing.

There are now three alternatives, he said. The department can order reassessment of the 1973 tax roll; it can order a 1974 supervised assessment under which there would be a revaluation by a professional appraiser, with costs charged to the town; or it can deny the petition if it feels it is not in the public interest. Denial would not mean that there are no inequities, the representative said.

74 salary schedule since negotiations are still in process.

The board appointed Mr. Brenholt and Tom Gundrum as representatives to attend the meetings held for area schools on negotiations, with Dr. Ogi as an alternate. Further, they had no objections to using the WASG services on gathering negotiation information for these schools, with the cost of paper, postage, etc. to be shared by the schools involved.

Discussion was held for summer school sessions for 1974 with Mr. Brenholt outlining some of the changes being anticipated as discussed by staff. He indicated that Mr. Pearson did not wish to be the director. The board was of the consensus to proceed with the summer school program as recommended by Mr. Brenholt. Persons interested in being the director can make application with Mr. Brenholt.

Discussion was held on a question raised as to the first aid knowledge of staff and supplies on inventory in the district schools.

Resignations from Mr. Michael Schweighardt, who has accepted another contract, and Mrs. Helene Miller, who wishes to retire, were accepted by the board.

Approval was granted by the board to change the job description of the high school secretary to include an additional 40 hours per year, as the original set up to allow compensatory time is not working out.

Discussion was held relative to Mr. Brenholt's request that consideration be given to approving the district to set up a trainable class for 1974-75, because West Bend has indicated they do not wish to provide services for

our students who are presently attending their school on a tuition basis. He mentioned that this program is 70% reimbursable by state aids and further indicated that application could be made for funds under Title VI B.

Bidding for the work at the high school wherein the

basement area would be paved and used for storage was brought up and the board asked that additional bids be requested.

No definite plans were made for an Open House at the Wayne School.

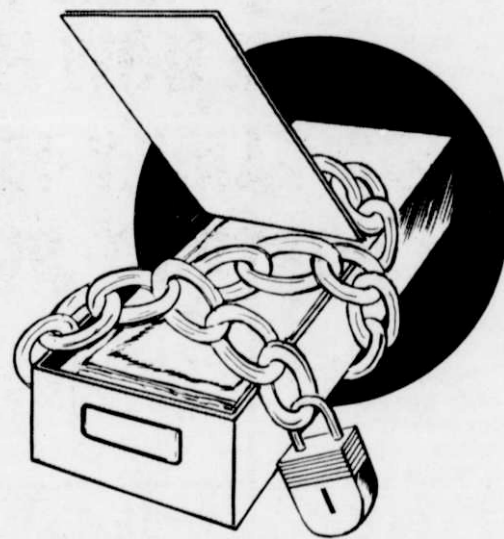

## G. Walz, Retired Works Manager At Regal Dies



Gottlieb (Shorty) Walz, 71, of 309 Braatz Drive, Kewaskum, retired plant works manager for Regal Ware, Inc. in Kewaskum and Wooster, Ohio, passed away Friday, March 15, at St. Joseph's Community Hospital, West Bend.

Walz was born Feb. 11, 1903 in Spielberg, Germany, and came to America at the age of 20. He married Betty Bobinger in Milwaukee on Aug. 5, 1933. Prior to joining Regal he spent 24 years with the Lakeside Bridge and Steel Company, Milwaukee, in various capacities. Walz served his 4 year tool and die apprenticeship in his native Germany and studied industrial techniques at the University of Wisconsin and Marquette University.

In 1946 he joined the Kewaskum plant and later became plant superintendent for the day shift. Walz was transferred to Wooster in 1964 after Buckeye Ware was purchased by Regal Ware, where he was works manager for 130 employees. In 1970 he returned to Kewaskum with his wife Betty to join their children and their families and was promoted to works manager at Regal, succeeding John E. Pearson, in which capacity he served until the time of his retirement.

During his six years at the Wooster plant he increased employment to nearly 600. During this period the production of high quality cookware was increased and many of the plant operations streamlined. Wages and benefits more than doubled during the time of his employment there. Relations with the bargaining unit, Buckeye Lodge No. 981 of the International Association of Machinists, increased to the point that management and union worked as a team.

He was succeeded at Wooster by Leo Lipomanis, who formerly served as chief engineer.

Surviving are his widow, a son, Norman (Martha) Walz, a daughter Marion (DeWayne) Fritz, one daughter-in-law, one son-in-law, four grandchildren, all of Kewaskum; one sister, Mrs. William (Martha) Gross of Germany; five brothers, William of Florida, Jacob, Karl, Emil and Ernst, all of Germany; other relatives and a host of friends. His parents, the late Gottlieb and Maria Walz, Sr., prede-

ceased him.

Walz was a former member of the Kiwanis Club of Kewaskum.

Funeral services were held at 2 p. m. Monday at Peace United Church of Christ, Rev. Daniel Schowalter officiating. Interment was in the church cemetery. Visitation was at Miller's Funeral Home from 3 to 9 p. m. Sunday and from 8 to 11 a. m. Monday and at the church from noon until the time of services.

Richard W. Pagel, 83, of Meadowbrook Manor, West Bend, a former resident of Kewaskum, passed away Sunday, March 17, unexpectedly at home.

He was born Feb. 17, 1891 at Pommern, Germany. He married Hedwig Voss in Germany on April 18, 1916. They came to the United States in 1923 and had been area residents since 1925. He was employed in the mason trade. His wife preceded him in death in 1969.

Surviving are six children, Hattie (Burt) Krueger, Otto (Dorothy) Pagel, Edith (Eugene) Veers, and Herbert, all of West Bend, Ruth (Carl) Slavic, Gladwin, Mich. and Gertrude (Harold) Schlosser, Allenton. 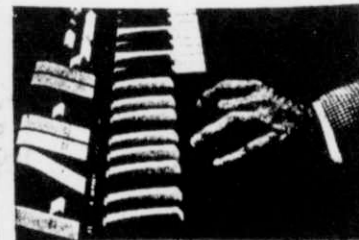

## Bids Let for Phosphate Removal Equipment and Truck Chassis

By Ruth Held

Bids were let for permanent phosphate removal equipment and a truck chassis for the village waste water control center during an adjourned session of the village board Monday night.

The village is under orders to remove phosphate from its sewage effluent. It is presently being removed with temporary equipment.

The R. P. Honold Co., Sheboygan, was given the contract for the mechanical portion on its bid of \$21,367, the low of two. On its bid of \$13,198, Kettle Moraine Electric, Kewaskum, was awarded the contract for electrical work. It was the low of two.

The contract for general construction went to Blohm Bros. Steeplejack Construction of Cudahy on its bid of \$6,840, low of two bids. The project, among other items, includes removing the present incinerator to make room for phosphate removal equipment. The bid of Stocker Ford-Mercury, West Bend, to provide a 1974 truck chassis was accepted. The truck will be used to haul sludge.

All bids were opened March 4 and were given to Robinson and Welch, consulting engineers, for study and recommendations. Bid approval came in the form of a resolution which reads that the village approve these bids pending approval of the Department of Natural Resources (DNR) and the Environmental Protection Agency (EPA). These two agencies have final say because of state and federal reimbursement grants that are involved in the total expansion of the waste water control center, and the phosphate project is tied in.

The treatment facility was enlarged during 1972 at a cost of about \$490,000. The village will receive state and federal grants amounting to about 75 per cent of the cost. The actual share to be paid from village funds amounts to about \$122,000.

To date, the village has received one payment from the DNR in the amount of \$90,975 and from the EPA amounts of \$94,500 and \$59,400. The \$59,400 represents 84 per cent of \$65,400 which was released last week. The

final payment from the EPA hinges upon the approval by the village board of a revised ordinance that will set new and more equitable sewage charges than are in force now.

According to Village Commissioner William Martin, final payment is not also expected until the phosphate removal project is complete and until records are audited to determine the complete costs.

In connection with the revised sewage service charges, an informational meeting was held Monday night for all village residents. Only representatives of Regal Ware, Inc., Fairmont Foods and Hilltop Laundry turned out. Commercial establishments

and industries will get a boost while the householder who is not a big water user will get a break under the new charges.

Dr. Raymond Kinn of Marquette University, who worked out the proposed new sewage charge formula, was present Monday night to answer questions.



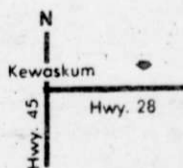

Village of Kewaskum, Wisconsin**

Notice is hereby given of village election to be held in and for the Village of Kewaskum, Washington County, Wisconsin, on the 2nd of April, 1974, at which the officers named below shall be chosen.

**INFORMATION TO ELECTORS**

The following instructions are given for the information and guidance of electors:

(a) Upon entering the polling place, an elector shall give his name and address before receiving the ballot from the ballot clerk. The initials of 2 ballot clerks must appear on the ballot. Upon receiving the ballot, the elector shall retire alone to a voting booth and mark his ballot. A ballot clerk may inform the elector of the proper manner for marking a ballot, but he shall not in any manner advise or indicate for whom to vote.

(b) To vote for a person whose name is printed on the ballot, make a cross (X) or mark in the square after the name of the person for whom you desire to vote. To vote for a person whose name is not printed on the ballot, write the name in the blank space provided for the purpose.

(c) The ballot should not be marked in any other manner. If the elector spoils a ballot, he shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. Not more than 5 minutes' time shall be allowed to mark the ballot. Unofficial ballots or a memorandum to assist the elector in marking his ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot it marked.

(d) After the official ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerks' initials on the outside do show. After folding the ballot, the elector shall leave the booth, give his name to the inspector in charge of the ballot box, hand him the ballot to be placed in the ballot box, and leave the polling place promptly.

(e) An elector may be assisted by 2 election officials of different political parties in marking the ballot if he declared to the presiding official that he is unable to read or that due to physical disability he is unable to mark his ballot. If an elector declares that he is visually handicapped, he may have anyone assist him in marking his ballot. The presiding official may administer an oath as to a person's disability.

(f) Any qualified elector who is absent, or expects to be absent from the village in which he is a qualified elector, or who, because of sickness or physical disability cannot appear at the polling place on election day, may vote at such election by means of an absent voter's ballot to be secured upon application to the Village Clerk, not more than sixty days and no less than three days, or by personal application, not later than the close of office hours on the day prior to such election.
