Lions Chicken Barbeque and Marathon Sunday, Aug. 11

SPECIAL EVENTS INCLUDE FOOT RACE, BIKE RACES, WRIST WRESTLING, RACE FOR BLIND

A chicken barbeque, race tandem bike over a designafor the blind, wrist wrestling, bike races and a footrace or mini-marathon will be special events at the Kewaskum Lions Club third annual Chicken Barbeque Sunday, Aug. 11. The public is invited to participate in all of the activities.

The barbeque will begin at 11 a. m. in the village park and continue until everyone has been served, probably around 4 p. m. The price is \$2 for adults and \$1.25 for children 12 and under with a ringside seat for all the events. Prizes will also be awarded.

The first event will be the "Kettle 20," which will begin at 10:15 a. m. This is a 12.4 mile or 20,000 meters footrace or mini-marathon that will be run through the Kettle Moraine area, starting and ending in the park. Dave Stratman, chairman, has been contacting marathon racers throughout the state and hopes to have at least 60 entered. Girls are also invited. The cost for entering is \$3 and this includes a chicken dinner as well as 'a T-shirt with a "Kettle 20" emblem printed on it. Prizes and certificates will be given to all finishers. Trophies will be awarded to the first and second place finishers with medals being given to the third through 15th places. Those interested can call Stratman at 626-4631 or may sign up the day of the race. Some runners should be completing the race by 11:30.

There will 'also be three bicycle races, A-ages 10-13. B-14 through 17, and C-18 and over. Entry fee for the two younger classes will be 50 cents while Class C participants will have a \$1 fee. The Class A race will begin at 12:15 and will be 6.5 miles in length. The B and C racers will tour the 12.5 Kettle 20 course, beginning at 12:45. Again, there will be trophies. ribbons and certificates for Another feature will be wrist wrestling with competition beginning at 1:15 in the park. Tom Larsen is in charge. Two wrist wrestling tables have been placed in Tom's Place and Amerahn so that hopefuls can practice at this test of strength. Wrist wrestling will be divided into three classes according to weight, up to 150, 151 to 190. and 191 and up. Entry fee is \$1 to pay for the trophies and awards. The new students will be returning to the UW campus Aug. 19-23 to complete their orientation into university life. Their fall semester classes will begin on Aug. 26.







NOTICE OF RECEIPT

Of Design Approval Of Interstate 57 and Highway 10 Between The Sheboygan River In Sheboygan County And County Trunk Highway "MM" In Brown County Sheboygan, Manitowoc, And Brown Counties

All interested persons are hereby given notice that the Wisconsin Department of Transportation, Division of Highways, has, on July 18, 1974, received approval from the Department of Transportation, Federal Highway Administration, for the design of about 52.1 miles of Interstate Highway 57 between the Sheboygan River in Sheboygan County and County Trunk Highway "MM" in Brown County, and 4.1 miles of Highway 10. A series of three design public hearings were held, with the first being held in the City of Sheboygan on November 1, 1973, the second in the City of Manitowoc on No-vember 6, 1973, and the third in the Village of Denmark on November 8, 1973.

After analyzing the social, economic, and environmental effects of the alternates developed for these highway segments, and after reviewing the transcripts of the public hearings and subsequent written testimony, the Division of Highways received approval of a design for Interstate 57 presented at the hearings, described as follows:

The project begins at the junction of the Sheboygan River and Highway 141 in Sheboygan County and proceeds northerly along Highway 141 to the interchange at Highway 42. Two northbound lanes will be constructed from the river to the interchange with Highway 42 utilizing the existing highway right of way. The interchange with Highway 23 will be reconstructted to be compatible with he future development of ghway 23. From the inchange with Highway 42



ready

to the junction with County Trunk Highway "X", the roadways will be on relocation generally one-half mile west of existing Highway 141, bypassing the Village of Cleveland. From County Trunk Highway "X" to the interchange with County Trunk Highway "C", the roadways follow existing Highway 141. From County Trunk Highway "C" to the junction with Middle Road. the roadways will parallel existing Highway 141 one-quarter mile to the west. The relocation from Middle Road to Hillcrest Road is due north, bypassing the residential development of White Water Acres to the west, and remaining westerly of existing Highway 141. The relocation from Hillcrest Road to County Trunk Highway "Z" remains about

one mile west of Highway 141, proceeding northwesterly to Fisherville Road, 'then northerly to County Trunk Highway "Z" From County Trunk Highway "Z" to Highway 96 the relocated roadways remain westerly of Highway 141, with the segment from County Trunk Highway "Z" to Zander Road proceeding northerly, the segment from Zander Road to the county line proceeding northwesterly, and then northerly to the interchange with Highway 96 westerly of the Village of Denmark. The roadways will then parallel existing Highway 141 from Highway 96 to the interchange with County Trunk Highway "MM" remaining one-half mile to the west.

The Division of Highways received approval of a design for Highway 10 presented at the hearings, described as follows:

The project begins on Highway 10 at the Branch River Bridge in the Village of Branch. The roadway then proceeds northeasterly to County Trunk Highway "D" and then is concurrent with County Trunk Highway "D" to existing Highway 141.
