Thaw, Rain Cause Flooding in Area



Several days of spring thaw of snow last week followed by thunderstorms which boomed and flashed over the area Friday night with a heavy downpour of rain boosted rivers and streams over their banks and caused much flooding. The flooding was described as the worst in 20 years here.

With only the topsoil of the frozen ground thawed out the water couldn't sink in and had no place to go but to run off to the low spots. Much topsoil was washed away.

Rivers and streams flooded their banks and many fields were under water.

Some highways and town roads in the area were under water in spots. West of Kewaskum State Hwy. 28 was closed in Dodge County between Hwy. 41 and State Hwy. 175.

Numerous basements at various locations in the village were flooded, some with a foot or more of water. Some residents worked most of the night removing water and cleaning up.

The flooding caused the ice on the Milwaukee river here to loosen up and go out. The ice, some a foot thick, was jammed from the dam in the village park almost back to the Main St.

bridge Monday and still is. The huge piled up ice chunks put a lot of pressure on the dam.

Brooklane Drive and Clinton St. were under about a foot of water Friday night on the west side of the village from the heavy rain and runoff from higher surrounding streets. This corner was a main problem area and village crews hauled in sand and concrete blocks to block off Clinton St. and divert the water to the creek at the south end of the village, which also overflowed. Village crews with their equipment worked most of the night. Many basements in that section were flooded and it was reported one home had water running under the front door. The street blockade was not removed until Monday morning while Clinton St. was closed to traffic. This section was also without light and power for about two hours Friday night after lightning struck a transformer on an electric pole on adjoining Midland Ave.

The sewerage lift station on the west side of the river at the village beach was sandbagged as water was up to the front door. The sandbags also protected the building from the huge floating ice chunks.

Sleet Sunday afternoon and more rain at night didn't help matters. There was also snow flurries Monday, Tuesday and Wednesday.

The top photo, taken from the Main St. bridge, looking south toward the dam, shows the flooded river.

The lower photo, taken from Parkview Dr. south of the bridge, shows the water almost up to the bridge, water up to the doors of the old village garage and almost up to the road, snowmobile trail markers, and a park bench in the water. The horseshoe pits are under water.

School Board Members, Village, Town Officials to Be Elected Apr. 1

Next Tuesday, April 1, is spring election day in Kewaskum, Washington County and throughout the State of Wisconsin. Polls will be open from 9 a. m. to 8 p. m. Balloting for the Village of Kewaskum will be at the municipal building and for the Town of Kewaskum at the Labor Center.

To be elected in this area are school board members, village and town officials, a justice of the supreme court and four referendum questions will be voted on.

Three school board members will be elected to three year terms in Kewaskum Community Schools, Jt. District No. 2. The four candidates for the position are incumbents Allen A. Tessar, Charles J. Ogi and James D. Oelhafen and newcomer Daniel W. Stoffel.

In the Village of Kewaskum incumbent Charles F. Miller will be unopposed for re-election to a two year term as president. There are six candidates for the three Trustee offices for two year terms. Incumbents Alfred Kral, Roger Strack and Daniel S. Schmidt will be opposed by newcomers Roger J. Schmitt, David E. Nigh and Oscar G. Knoeck.

In the Town of Kewaskum the only opposition will be for the office of supervisors, where there are three candidates for the two positions for two year terms. Incumbents James Andre and Jer-

ome Herriges will be opposed by newcomer Edward Kukulinski. Unopposed incumbents are Chairman Mervin Thompson, Clerk Barbara Hinz, Treasurer William Bruhn and Assessor Raymond Schaefer.

In the Town of Wayne the only opposition will also be for the supervisor posts, there being four candidates for the two offices. Incumbents Daniel Coulter and Leo Zehren will be opposed by Walter Theusch and Merlin Ernisse. Unopposed candidates are Chairman John Oelhafen, Sr., Clerk Orville Kern, Treasurer Raymond Kudek, Assessor Alvin Wiesner, Jr. and Constable Ronald Panzer.

In the Town of Auburn there will also be opposition for the two supervisor posts, where there are four candidates. Incumbents Hilary Hoepner and Donald Stoffel will be opposed by Richard Thieme, Jr. and A. D. Weaver. Unopposed candidates are Chairman Roger Schleif, Clerk Camilla Butzke, Treasurer Elmer A. Krueger, Assessor Norbert Gatzke and Constable Donald Hammes.

Voters will also cast their ballots for a Justice of the Supreme Court. Candidates are Christ Alexopoulos and Nathan S. Heffernan.

The four referendum questions to be voted on will be found in a facsimile ballot notice on another page of this issue.

Kewaskum Is Named Bicentennial Community

Kewaskum is one of four newly-named Bicentennial Communities Congressman Bob Kasten (R-Ninth District) announced last Wednesday.

Kasten said he was pleased Kewaskum has received the designation. "As our country nears its 200th birthday, we will become more aware of the history and contribution of communities like Kewaskum," Kasten said.

To earn the designation, a county or town must submit a bicentennial activities plan to the American Revolution Bicentennial Commission. The communities receive a bicentennial flag and permission to use the national bicentennial symbol to promote their activities.

"Community activities planned by the Kewaskum bicentennial committee," Kasten said, "will rekindle spirit of unity and achievement for common goals which bound our country together 200 years ago."

The other communities earning the designation at this time are Jefferson County, Addison and Waterloo.

There are 34 Bicentennial Communities in Wisconsin.

REGULAR MEETING OF BOARD OF EDUCATION

The Kewaskum Board of Education will hold its regular meeting Monday evening, March 31, at 8 p. m. in the administrative offices. The two major topics of discussion will be a building report, including an updating of cost figures, and staffing. The latter will include a report on pupil-teacher ratios, needed high school staffing and Middle School staffing. The board will also consider a resolution of Title II funds, and discuss requesting bids on remodeling at the high school. Also on the agenda will be a discussion of possible added insurance coverage, as well as miscellaneous items which may come up. In executive session, the board will discuss salaries for Merv Thompson, as well as salaries of non-scheduled professional personnel and administrators.

Young Rescuer Receives Award

The Washington County Sheriff's Department and the Washington County Deputy Sheriff's Association awarded their "Meritorious Service Award" certificate to 18-year-old David W. Katt of 5371 Road 3, Silver Lake.

He is the son of Paul and Ann Katt of Silver Lake.

David also received a Heroism Award from the Wisconsin County Traffic Police Association. They were presented as a result of his heroic rescue efforts last Dec. 28, when a snowmobile went through the ice on Silver Lake.

He saw what happened to be a snowmobile enter an open water area of the lake. He immediately set out to react, running out of the house. Hearing a cry of "help" and "drowning," he grabbed a ladder and ran several hundred feet to where the machine entered the water. He used the ladder for support and located the helmeted operator under the surface of the water.

His parents and a neighbor responded by pushing a nearby rowboat out onto the ice and into the open water to assist. David applied mouth to mouth resuscitation and entered the icy water to assist in getting the victim into the boat.

He continued resuscitation and external heart massage while the boat was skidded back to shore and until sheriff's officers arrived.

The West Bend Fire Department rescue squad responded and transported the man to St. Joseph's Hospital in West Bend where he died some 21 hours later of injuries.

Unknown to David and other immediate rescuers, there was a 10-year-old girl passenger on the machine. Her body was recovered a short time later.

David was a November, 1974, graduate of National Ski Patrol advanced first aid course held in Delavan, Wis.

He is a senior at West Bend West High School. The awards were presented Monday at the West Bend Rotary luncheon meeting.

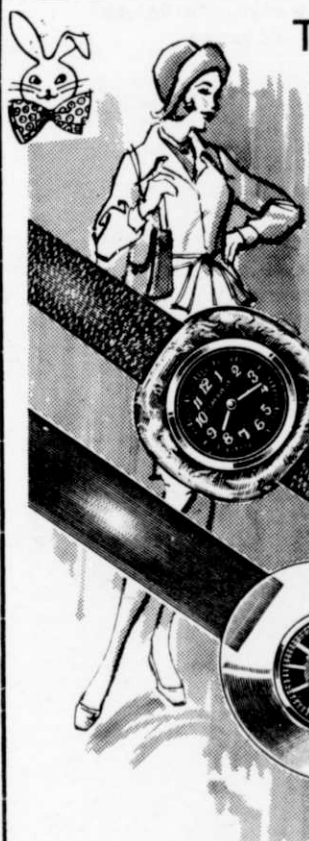

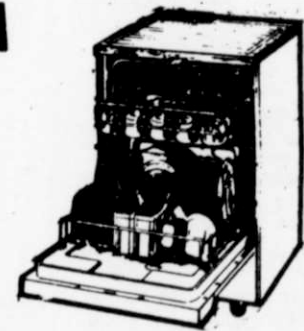

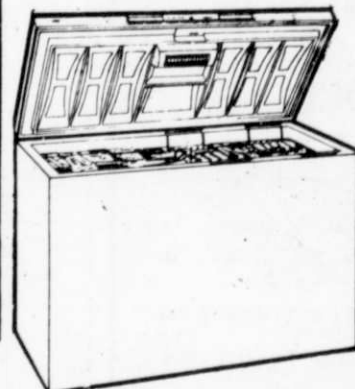

Facsimile Ballot Notice of Judicial, Referendum and State Senator - 4th District Election

April 1, 1975

OFFICE OF WASHINGTON COUNTY CLERK

TO THE ELECTORS OF WASHINGTON COUNTY:

Notice is hereby given of a Spring Election to be held in the several wards in the County of Washington on the 1st day of April, 1975, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office and under the appropriate party or other designation, each in its proper column, together with the questions submitted to a vote, in the sample ballot below.

INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his name and address before receiving the ballot from the ballot clerk. The initials of two ballot clerks must appear on the ballot. Upon receiving the ballot, the elector shall retire alone to a voting booth and mark his ballot. A ballot clerk may inform the elector of the proper manner for marking a ballot, but he shall not in any manner advise or indicate for whom to vote.

At a nonpartisan election, the elector shall place a cross or other mark in the square at the right of the candidate's name for each office for whom he intends to vote, or insert or write in the name of his choice for a candidate.

The following is a facsimile of the official ballot:

On referenda questions, the elector shall make a cross or other mark in the square at the right of the answer which he intends to give.

If the elector spoils a ballot, he shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. Not more than 5 minutes' time shall be allowed to mark the ballot. Unofficial ballots or a memorandum to assist the elector in marking his ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After the official ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerks' initials on the outside do show. After folding the ballot, the elector shall leave the booth, give his name to the inspector in charge of the ballot box, hand him the ballot to be placed in the ballot box, and leave the polling place promptly.

An elector may be assisted by 2 election officials of different political parties in marking the ballot if he declares to the presiding official that he is unable to read or that due to physical disability he is unable to mark his ballot. If an elector declares that he is visually handicapped, he may have anyone assist him in marking his ballot or operating a voting machine. The presiding official may administer an oath as to a person's disability.

MINUTES OF VILLAGE BOARD MEETING

Regular Meeting
March 3, 1975
8:00 P. M.

The Village Board of Kewaskum, Washington County, Wisconsin, met in regular monthly session in the Council Room of the Municipal Building.

President Miller presided and all Board Members were present.

The minutes of the meeting of February 3, 1975 were approved as printed upon motion by Trustee Herriges, seconded by Trustee Schmidt. Unanimous vote.

Mr. and Mrs. George Egert appeared to register a complaint about the icy road conditions at the intersection at Third and Park View which causes vehicles to skid and damage their trees. The Board agreed to take whatever steps are necessary to correct the condition.

Dr. Charles Ogi, representing the local School Board, met with the Board to discuss the possibility of constructing a sidewalk to the Bel-Ric Acres Subdivision and thereby eliminate school busing to that area. Referred to Committee.

Roger Schmitt appeared to register a complaint about a semi-trailer truck with the motor running parking overnight in a residential area

near his home. Referred to the Police Department.

A renewal lease between Raymond Klein and the Village, for a parcel of land upon which a Village welcome sign is located south of the Village on the east side of Highway 45, was approved for a period of five (5) years commencing on June 1, 1974, at a cost of one hundred dollars (\$100.00). Motion by Trustee Strack, seconded by Trustee Yoost. Roll Call Vote unanimous.

James Arthur of Arthur and Associates, Fond du Lac, explained to the Board five (5) proposed plans for the development of the site designated as Kewaskum Kiwanis Park.

Upon the recommendation of the Plan Commission, the park site area recently purchased from Mrs. Spoerl and as described in Warranty Deed, recorded as Document

No. 360303, dated December 30, 1974, be and the same hereby is zoned Park District (P-1). It was further stipulated that if any portion of the site is found to be in the Milwaukee River Floodland District (MRF), such portion shall be so zoned. Motion by Trustee Schmidt, seconded by Trustee Kral. Roll Call Vote unanimous.

The Board authorized the installation of protective screens for the front windows of the main sewage lift station at a cost of approximately one hundred seventy-five dollars (\$175.00). Motion by Trustee Herriges, seconded by Trustee Strack. Roll Call Vote unanimous.

The installation of a scanner, at a cost of not to exceed two hundred dollars (\$200.00), in the police car, was authorized upon motion by Trustee Schmidt, seconded by Trustee Yoost. Roll Call

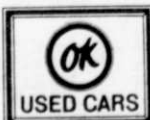

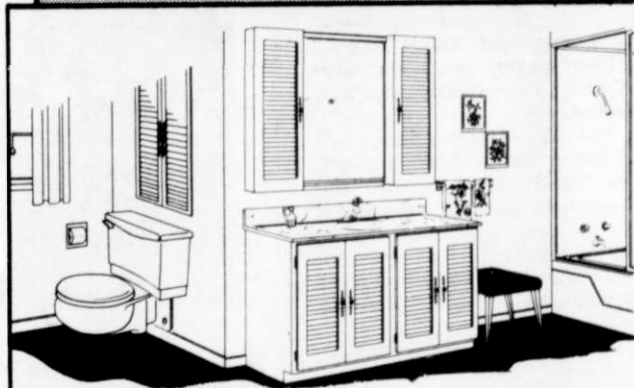

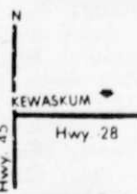
