FIREMEN'S PICNIC SUNDAY

All is in readiness for this year's annual Kewaskum Firemen and Rescue Squad picnic to be held this Sunday, July 11, in the village park. Plans have been completed to make the event another outstanding one.

An excellent parade at 12:30 p. m. sharp will highlight the picnic and get the festivities underway. The parade will feature the Crusaders - Gladiators Drum and Bugle Corps of New Berlin, Marquis Drum and Bugle Corps of Fond du Lac, West Allis Wranglers Drum and Bugle Corps, West Bend Patriots Drum and Bugle Corps, Saberettes Baton and Drum Corps of Franklin, Mariners of Port Washington Drill Team, Thunderbolt Kadets Drum and Bugle Corps of Cedarburg, Kewaskum High School Band, plus other musical organizations.

Other units will include the Tripoli Motorcycle Corps of Milwaukee, drill teams, beautiful floats, baton twirlers, majorettes, children's specialties, visiting firemen and equipment, Legionnaires, comic entries, orchestras, ancient cars, riding horses,

clubs, organizations and many more.

The parade will form at the high school and adjacent streets, from where it will proceed to the park. All participants should be present to line up no later than noon. Persons wishing to enter the parade should contact Bob Staehler, parade chairman, or Jim Staehler. Theme for this year's parade will be "Spirit of '76." Businessmen and organizations are invited to enter a float. Prizes will be awarded for the best floats and children's specialties.

Immediately following the parade there will be exhibitions by drum and bugle corps in the park. There will be continuous music and entertainment throughout the afternoon and evening. Live music will be furnished on the stage and in the beer garden by the Joe Karman Band and Bob Kuether and his TV Recording Orchestra.

The popular water fights will again be held at 6:30 p. m. with neighboring fire departments competing.

There will be kiddie rides, concessions, games and a variety of refreshments and food.

ANNOUNCE AGENDA FOR SCHOOL BOARD MEETING

The regular meeting of the Kewaskum Board of Education will be held Monday, July 12, at 8 p. m. in the administrative offices.

First item on the agenda will be a visit by the board to inspect the area of school property which George Egert has requested to be sold to him. Other items on the agenda will include opening of oil and milk bids, last minute items concerning the Annual Meeting and administrative salaries. Action will be taken on recommended teacher contracts for next year. Miscellaneous items which arise will also be discussed.

Proposals for Sewer Rodder Opened by Board

Three proposals for a sewer rodder ranging from \$9,437 to \$11,769 were opened by the Kewaskum Village Board on Tuesday.

In the past, the village has rented this type of machine, which is used to clean out clogged sewers. Which machine to accept will be decided by the equipment committee and Supt. of Public Works Bilgo, who will examine the bids and report back to the board at their next meeting in two weeks.

The board passed an ordinance officially annexing properties owned by Paul Buczek and Dennis Giese, located on U.S. 45 south, which adjoin the lands belonging to Dr. Sison that were also recently annexed. At the previous meeting a resolution accepting their petition for annexation was accepted, but before the annexation becomes official, an ordinance must be passed.

Gerald Stollenwerk was appointed to the board of appeals, filling the vacancy caused by the resignation of John Battaglia, by a 6 to 1 margin, with Trustee Dan Schmidt voting against the motion. A total of five names were submitted to President Miller by the board, at their last meeting, and he selected Stollenwerk as his nominee, subject to the board's confirmation.

North Street at the intersection of Western Avenue will receive stop signs as a result of a complaint by Trustee Dave Nigh that people are driving through the intersection too fast, and visibility is restricted. Chief Don Hlavaty agreed with him, calling the intersection "a bad one" and agreed to have the signs installed at once.

A resolution was passed unanimously, declaring that this week will be known as Bicentennial Week, and that the pageant that will be held on Thursday at the high school gym should be recognized as an official Bicentennial activity. At that time, the portrait of Chief Kewaskum being painted by Dan Meilahn will be shown for the first time.

The weeds along Edgewood Road that were the subject of a complaint by Stan Woolman at the last meeting were sprayed by the village on July 1, since the property owners in question did not take care of the problem themselves, so they will be billed for the work that was done.

Facilities for New Park Discussed

Jim Arthur of Arthur and Arthur of Fond du Lac, discussed plans for the pond planned for the Kewaskum Kiwanis Park with village officials recently.

Park committee chairman Dan Schmidt asked that specifications for the entire park be prepared so that approval for the pond can be obtained from the Dept. of Health and Social Services in Madison. Arthur agreed to have them ready by July 19, the day that bids will be opened for the pond excavation project, and will meet with the members of the village board an hour before their meeting on that date.

About 150 people per day are expected to use the pond each day once it has been completed, although its maximum capacity will be slightly under 1100 swimmers. Sufficient shower and sanitary facilities will be provided, as required by state statutes, with provisions for more at a later date, if necessary.

Other facilities to be included in the park are two basketball courts, six horse-shoe pits, four tennis courts, and two softball diamonds. No provision was made for any hardball diamonds, because there is a much greater demand for softball facilities in the area.

Lighting will be provided at no cost to users of the softball diamonds, and the possibility of installing coin-operated lights at the tennis courts and horseshoe pits will be studied. Playground equipment will also be installed there, but the "modern" type, made out of timbers or concrete will be used, instead of the metal type that is in the present park.

The officials present could not decide whether to install a floating diving board or a stationary one, so they instructed the architects to investigate both possibilities and report back. They were concerned about the stability of a floating one, although no one claimed to be knowledgeable in that area. No row-boat will be necessary according to state statutes, and no plans are pending for a pier, either, because it was felt that it would only get in the way, and would have to be removed in the winter to allow for ice skating anyway.

Arthur confirmed that the engineer's report stated that no liner would be needed at the bottom of the pond, but he was instructed to include the addition of a standard one to the specifications, in order to reduce future cloudiness in the water. Turbidity will be decreased somewhat if the board decides to purchase silica sand instead of

normal sand, because the former is heavier and would tend to stay settled. No sand will be required at depths greater than six feet, which includes about half of the pond.

The bathhouse will be constructed of concrete blocks with a brick face, which will be supplied courtesy of the Kewaskum Bicentennial Committee, and will be completely enclosed, except for the dressing area. Inside will be the dressing room, a multipurpose room for vending machines, etc., bathrooms, and a lifeguard's room which could also double as a first aid room. Space will be provided to install baskets to store valuables while swimming. It was emphasized that plenty of space should be allowed for future expansion, and for use as a warming house for ice skaters during the winter.

Cost estimates for the entire project, and for some of the individual projects within the park will be drawn up as soon as possible, but will not be ready when the bids are opened for the pond.

Sign Up July 10 for 2nd Swim Lessons

Saturday, July 10, at the Municipal Building from 9:00 to 11:00, the sign up for the second session of swimming lessons will take place. If you were registered before, no money is required.

Tentatively the times will be 10:00, 10:30, 11:00 and 11:30 as beginners, 12:00 as advance beginners and 12:30 as intermediate and swimmers. Your cooperation will be appreciated and the lessons will start on Monday, July 12.

Abel Fined In Ogi Case

Paul G. Abel, 830 E. Washington St., West Bend, was fined \$200 last week in Washington County Court for an incident last Jan. 8 in which he threatened Dr. Charles Ogi, a veterinarian of R. 2, Kewaskum, with a hammer. A jury found Abel guilty of disorderly conduct.

In addition to the fine, he was ordered to pay \$9 court costs and \$16.50 in witness fees, for a total of \$225.40. The alternative would be 70 days in jail.

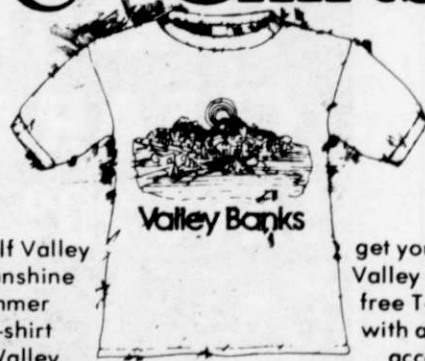

MILLER BRICKYARD

The Charles Miller brickyard was the second industry in the Village of Kewaskum. Miller built and lived in the house recently bought by the village from the Wallace Geidel estate. Judging from the early tax records of the Town of Kewaskum, the first brick was made about 1865. Charles Miller was no relation to the Charles Miller who had the drug store.

The yard was first located between Highway 45 and the C. & N.W. Railroad just east

of the present Sison Clinic. In 1886 the brick for the county jail, now the Historical Society, was made here. When the clay on the west side of the railroad tracks was all used the plant was moved to the east side next to the North Side Park.

Jim's uncles, Bill and John Kohn, who worked for Mil-

ler, told him they were paid part of their wages, \$5.00 a week, on Saturday night and the balance when the brick was sold. When the yard closed about 1906, it was owned by William Miller, a son of the founder. Brick was also made in the Buss brickyard, now part of the late Carl Meilahn farm.

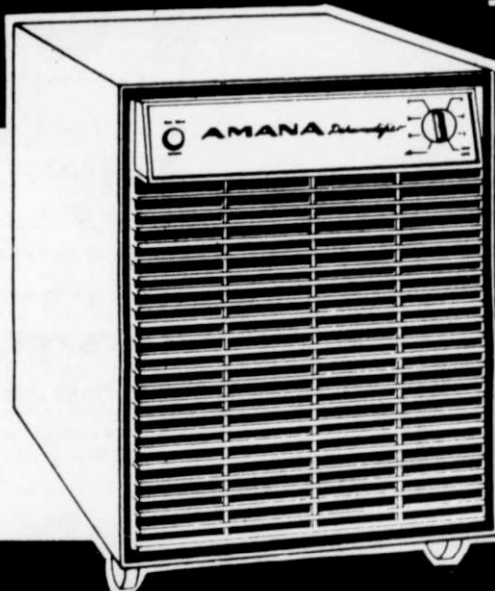

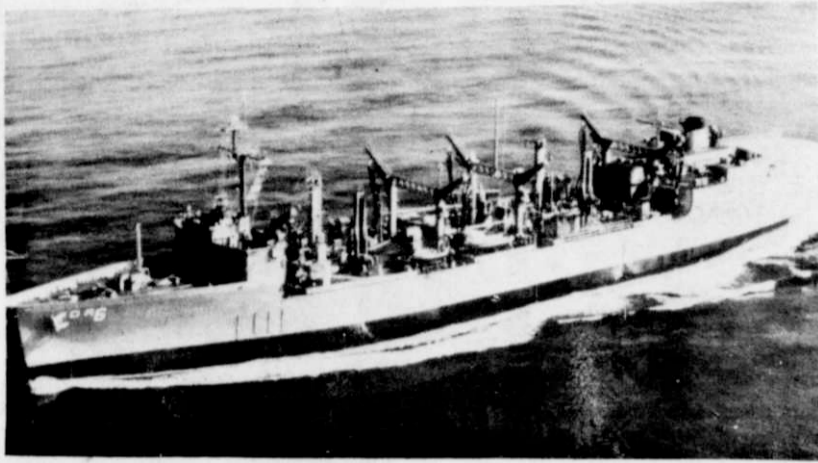

"OPERATION 200" — Navy Operations Specialist Seaman Eugene R. Kopping, Jr., son of Mr. and Mrs. Eugene R. Kopping of Kewaskum, was scheduled to participate in the International Naval Review in New York Harbor on July 4th as a crewman of the replenishment oiler USS Kalamazoo.

He was one of the 20,000 Navymen taking part in the Navy's formal Bicentennial commemoration of our nation's Maritime heritage. The Review included a total of 50 ships representing more than 30 countries.

This was the fourth International Naval Review sponsored by the U. S.; the last was conducted in 1957 in Hampton Roads, Va. His oiler joined 21 other U. S. ships taking part in the Review. This task force was composed of ships from the Atlantic Fleet and led by Vice Admiral John J. Shanahan, commander of the U.S. Second

Fleet. Its participation in the Review was one of the most significant events of an ongoing fleet exercise titled "Operation 200."

"Operation 200," a seven-week exercise, includes fleet maneuvers and missile firings. In addition, there will be amphibious operations, plus naval gunfire support and anti-submarine warfare training. Many of the "Operation 200" ships will have Midshipmen from the U. S. Naval Academy and Naval Reserve Officer Training Corps (NROTC) Units embarked. The Midshipmen are undergoing summer training to learn shipboard routines and gain practical experience in seamanship, navigation, gunnery, and communications.

A 1974 graduate of Kewaskum High School, he joined the Navy in October 1974. His ship is homeported in Mayport, Fla.

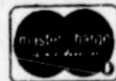
