Win Kiwanis Conservation Farming Awards



Allen Schulz and James Degnitz are this year's winners in the annual Kewaskum Kiwanis Conservation Farming Award. The award is presented each year to area farmers who practice sound conservation methods on their land. One criteria that the winners must have is a farm plan developed through the Washington County Soil and Water Conservation District.

Schulz, who lives in the Town of Wayne, has been a Washington County District Cooperator since 1973. Prior to this, he and his father initiated some of the conservation practices that Allen still follows. Some of these practices include a conservation cropping system, 700 feet of grassed waterways, and 170 feet of diversions. The conservation cropping system is a main ingredient of a workable farm plan. It involves developing a crop rotation that fits the individual's needs and still keeps soil erosion at tolerable levels. Among the 90 acres of land under proper crop rotations 34 acres are being farmed in contour strips that have been laid out since 1959.

Allen also keeps 34 acres under wetland habitat management. By keeping this area protected from fire and

grazing, wildlife habitat is maintained and wildlife itself will prosper. Allen plans on planting trees and developing ponds in this area in the future.

Plan Referendum at Spring Election on Sidewalk Issue

Kewaskum voters will have a chance to voice their opinion on the sidewalk installation issue this coming spring.

Despite some confusion as to whether or not new sidewalks would be discussed Monday night twelve people attended the Village Board meeting to object to the Sidewalk Committee's report. After considerable discussion as to the merits of an "advisory vote" in conjunction with the next spring's election, Daniel Schmidt succeeded in getting board approval of a sidewalk referendum before a final vote on the committee's "Seven Year Sidewalk Proposal." "More input and time should be given to the matter," Schmidt said, due to the negative response received from 151 out of over 600 property owners. That figure increased by about ten when more signatures were submitted at the meeting.

Besides stressing lack of use, disruption of terrain and fear

of increasing safety risks to children through loss of school bussing, some members of the group charged that an unfair burden would be placed upon property owners installing new sidewalks. They reminded the board that in years past the village had aided taxpayers by paying for half the cost of new sidewalk installation. Schmidt said that the village discontinued that practice in 1969.

Both village officials and members of the group agreed that the whole Village of Kewaskum would be affected by the sidewalk proposal, necessitating a widespread poll such as the referendum. The intentions of Trustees Schmidt and Dave Nigh in submitting the plan were defended by President Miller as having been directed toward the good of the entire community. Schmidt and Nigh indicated they still had faith in the program as being "fair" and ultimately of "benefit" to the village "in years to come." They countered that greater safety could be provided

children now walking in the street if strategic areas had sidewalks.

Next year's budget, which should be finalized by the end of the year, tentatively totals \$1,443,231.40. Although the board cannot set the tax rate to meet expenses until total assessment figures arrive from Madison sometime next week, the public hearing to discuss next year's village finances was set for Tuesday, Dec. 13, at 7:00 p. m.

Bound to be part of those figures is equipment for spreading sand and salt. Bids were opened and one representative was on hand to explain his company's bid for Kewaskum's business. Max Hussiman answered questions about the various types of sanding equipment and particularly about the \$3,365 hopper-type spreader for sale by his firm, the Hein Equipment Co. If a new hydraulic pump unit is needed in addition to the hopper, Hussiman offered one for \$1,400.

Other hopper prices ranged from \$2,962 (Monroe Machine of Menomonee Falls) to \$4,619 (Central Engineering Company of Milwaukee). Optional equipment and brackets would be extra.

Discussion also centered around used street sweeping equipment offered by Hein for \$9,000. Comparable new units sell for more than \$30,000. No decision was made on either the spreader or the sweeper.

Also being studied further are new license and permit fees. Many fees increased, some to the maximum allowed by state law. Most had been unchanged for many years. Bob Danielsen added a proposed "Park Use Fee" to the list of twelve. He called

Hardening of the arteries is the result of higher living, says Dr. John Houston, Dir. of Cardiology, Milwaukee Cty. Hospital. James Degnitz owns and operates 248 acres in the Town of Farmington. He has been a District Cooperator since 1973. Over the years proper conservation cropping systems have been followed on 128 acres of land, 73 acres are in contour strips, 110 acres of minimum tillage is practiced by Jim on his farm. Minimum tillage involves limiting the number of operations over the land. Instead of turning the crop residue over each fall, the residue is left on the soil surface over the winter and then the seedbed is prepared in the spring of the year by chisel plowing, wheel-trak planting, or some type of no-till method. This operation not only conserves energy, but improves

soil tilth, conserves moisture, and reduces soil erosion.

The winners were chosen by a group of people representing the Kewaskum Kiwanis and the Soil Conservation Service. The Award Banquet was held on Nov. 21 in Kewaskum. Roy Esser, Farm City Chairman, and Dick LaFleur, Kiwanis President, presented the awards.

Any qualified voter, unable to get to the polling place on election day, may ask to vote by absentee ballot. A qualified voter is one who is a U.S. citizen, will be 18 years of age or older on election day, and who has resided in the ward or aldermanic district where voting is desired to be accomplished for at least 10 days prior to the election. If the voter resides in a municipality which requires voter registration, then registration is also a requisite for the voter who is qualified in other respects.
