Village Board Denies Beer License For Newly Proposed Supermarket

Kewaskum Village Board members and several citizens Monday night voiced their opposition to having another beer outlet in a newly proposed supermarket.

Paul Behring wished to know the board's feelings on a possible license to sell beer so he could finalize his plans for the Kewaskum United Foods Store. This would be located in the as yet undeveloped shopping center on Highway 45 south of the village.

Behring showed plans of the 12,000 sq. ft. building. In addition to the usual produce, dairy, meat and bakery departments, he considered selling beer which he felt was a grocery item. He pointed out that all major West Bend stores also stock beer.

Several local liquor store owners were present to speak against the proposal. Sylvester "Smokey" Keller representing the Uptown Liquor Mart said, "I think we got enough right now." He added "...we got tough going already, the way it is."

Mrs. Ellen Coulter representing Coulter's Liquor Mart also agreed there were enough outlets and said any more taverns or beer dealers would only hurt them. Mrs. Ned Seng-

piel said it wasn't fair to pay a high price for a license and have others come along and "open up anything."

Lehman Rosenheimer of Rosenheimer's Department Store was also present to ask if the board had reconsidered its decision to not allow selling beer in his grocery department. He pointed out a new store in Germantown with a liquor department that was only 10 feet away from a liquor store. He added, "You know which side of the fence I'm on."

Trustee Raynor Herriges observed that Behring's appearance was listed on an amended agenda which had not been posted at the post office or Valley Bank. He questioned whether the board could even act on this matter. President Bob Danielsen said it could be discussed, however.

All board members agreed that there were enough outlets for beer within the village and that control of sales to minors was a factor. As Danielsen pointed out, these were the reasons that Rosenheimer had previously been denied a license.

Herriges personally thought there were enough outlets and pointed out that even filling stations might be selling beer (not his, however). Trustee Carl Spoeth also felt "...the saturation is there."

Trustee Don Mlodzik said the board could not change its mind about refusing a license to a grocery store. Trustee Jerry Stollenwerk likewise stated, "We ought to be consistent."

Trustees Paul Blumer and Dave Nigh as well as others also felt that beer would be easier to control and not get into the hands of teenagers if the number of outlets was limited.

Behring was apparently satisfied with the board's viewpoint and even quipped he'd have to "put in a flower section" instead.

The board also authorized its engineer to draw up specifications for bidding on a press

used to further dewater sludge at the sewage treatment plant.

Don Woller of Foth and Van Dyke of Green Bay recommended this after a Permutit Company sludge dewatering pilot unit had operated at the plant for the last two weeks. Results of tests showed that the consistency of the sludge did not permit it to be hauled in open dump trucks as planned.

Woller elaborated that this was due to unforeseen circumstances. Each community's sludge is unique and behaves differently when dewatered. Kewaskum's was such that when it contained 9% solids it still did not appear "conditioned," whereas another community's sludge might appear "conditioned" with 9% solids.

The village had originally specified that 8-10% solids be consistently achieved. Woller said the results came "pretty close to 9%," ranging from a minimum 8% to about 9% on last Saturday's test. One other test ran above 10%.

He advocated that an additional secondary unit, or press, be bid upon so that a drier sludge of around 15% solids could be achieved.

AFS Chapter Seeks Families To Host Overseas Students

The Kewaskum chapter of AFS is in the process of searching for two families who would like to host an overseas student for the coming school year. The student will live with the family and attend classes at Kewaskum High School. The main requirement for an AFS host family is the parent's concern for and interest in young people.

AFS International Headquarters in New York carefully screens candidates who apply for a year's stay in the United States. Fees for the students are paid by the Kewaskum AFS and by the student's themselves. AFS sends a monthly allowance to the students for personal expenses and also extends medical coverage to its students.

While many families participating in the AFS program include children who are high

school students, any family is eligible to serve as host. Families with young children are also selected to host students.

Any family wishing to apply as a host family in the Kewaskum School District or who would like more information regarding the AFS program should contact Mrs. Ruth Schmitt at 251-6130.

Kindergarten Registration Feb. 5 and 6

This year's annual "round-up" for the parents of all prospective kindergarten pupils in the Kewaskum School District will be held during the day on Tuesday, February 5, and Wednesday, February 6, from 9:00 a.m. to 12:00 noon, and 1:00 to 3:00 p.m. in the Beechwood, Farmington, Kewaskum, and Wayne school offices. To be eligible for enrollment in kindergarten, children must have attained their fifth birthday on or before October 1*, 1980. *This is a change in the State Statutes. Evidence of date of birth, either a birth certificate or a baptismal certificate, must be brought to the office at the time of enrolling.

Parents of bus pupils will need their section number and fire number as well and also fill out bussing forms.

Parent will register their children for next year's term and get the necessary health forms. If you know of any new families in this district, please pass this information on to them.

Richard E. Zarling, Director of Elementary Education, stresses the importance of registering your child on either of these two days so that plans may be made for them and staff requirements for next year are known.

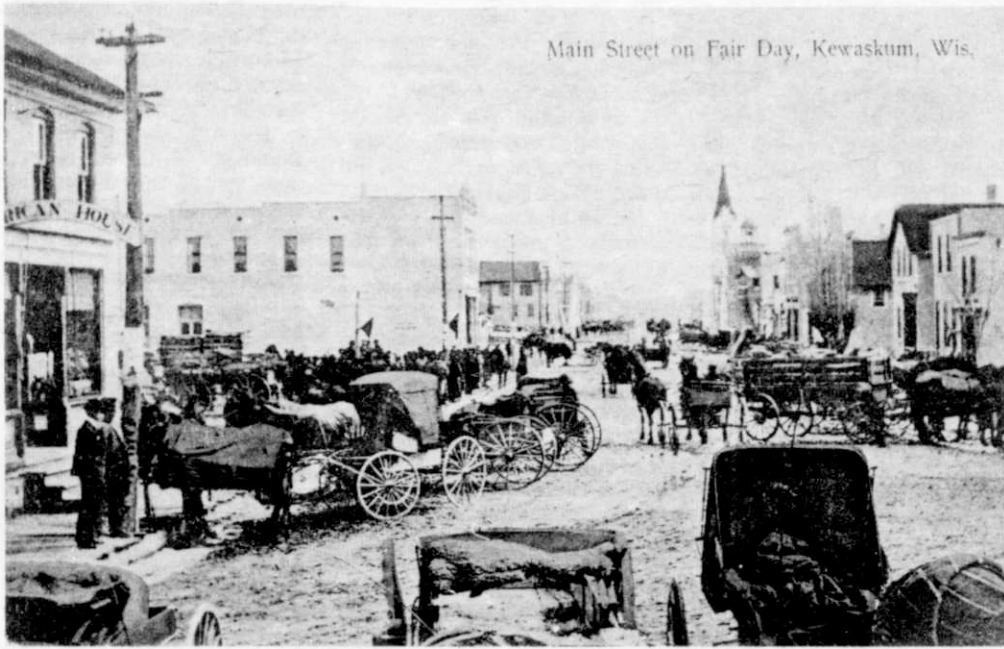

A secondary unit press had also been tried out with the pilot project. The resultant sludge ranged from 15% solids to over 18% solids. Superintendent of Wastewater Treatment Pete Albers exhibited two samples of the sludge - one more liquid and one more solid - to illustrate the dewatering effect of the press.

Woller also said that the performance particulars of the agreement with Permutit were met through the pilot project tests.

Another issue was brought up concerning the hauling of the sludge and possible stockpiling. Presently, the village can only haul more liquid sludge onto one 40-acre plot with permission from the DNR. This may only be temporary and hauling is at the mercy of farmers and the weather.

The more conditioned sludge of 15% solids would require only two loads per week, each costing about \$12 to haul. In order to offset the price of the press, it was suggested that the dry sludge be stockpiled with some precautions for runoff.

Mlodzik asked if farmers could possibly pick up the sludge. Albers said there was a "very good possibility" that "we would not have to haul off of the premises." Albers added that some farmers wished to acquire the sludge as it is high in nutrients and "does wonders

on corn" and other above-ground crops. Farmers could possibly load their trucks under a hopper setup.

The board members all supported the idea of an additional press, possible stockpiling, and the elimination of labor costs in hauling it away. It was also pointed out that the cost of the Permutit primary unit and an additional secondary press would still be considerably less than some other types of dewatering equipment which have the two units within a single apparatus.

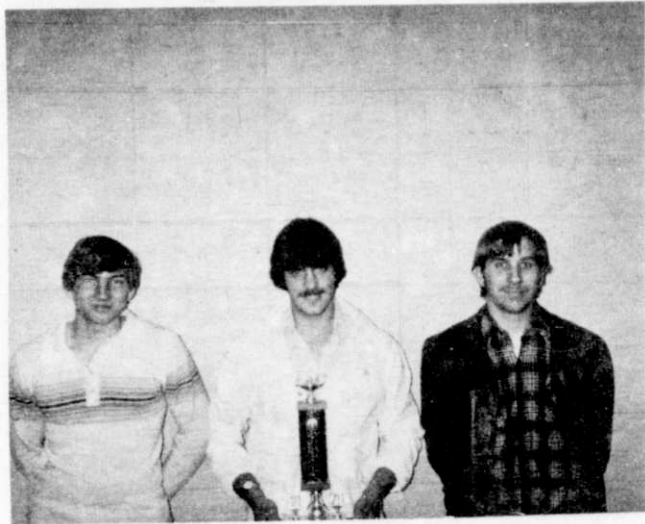

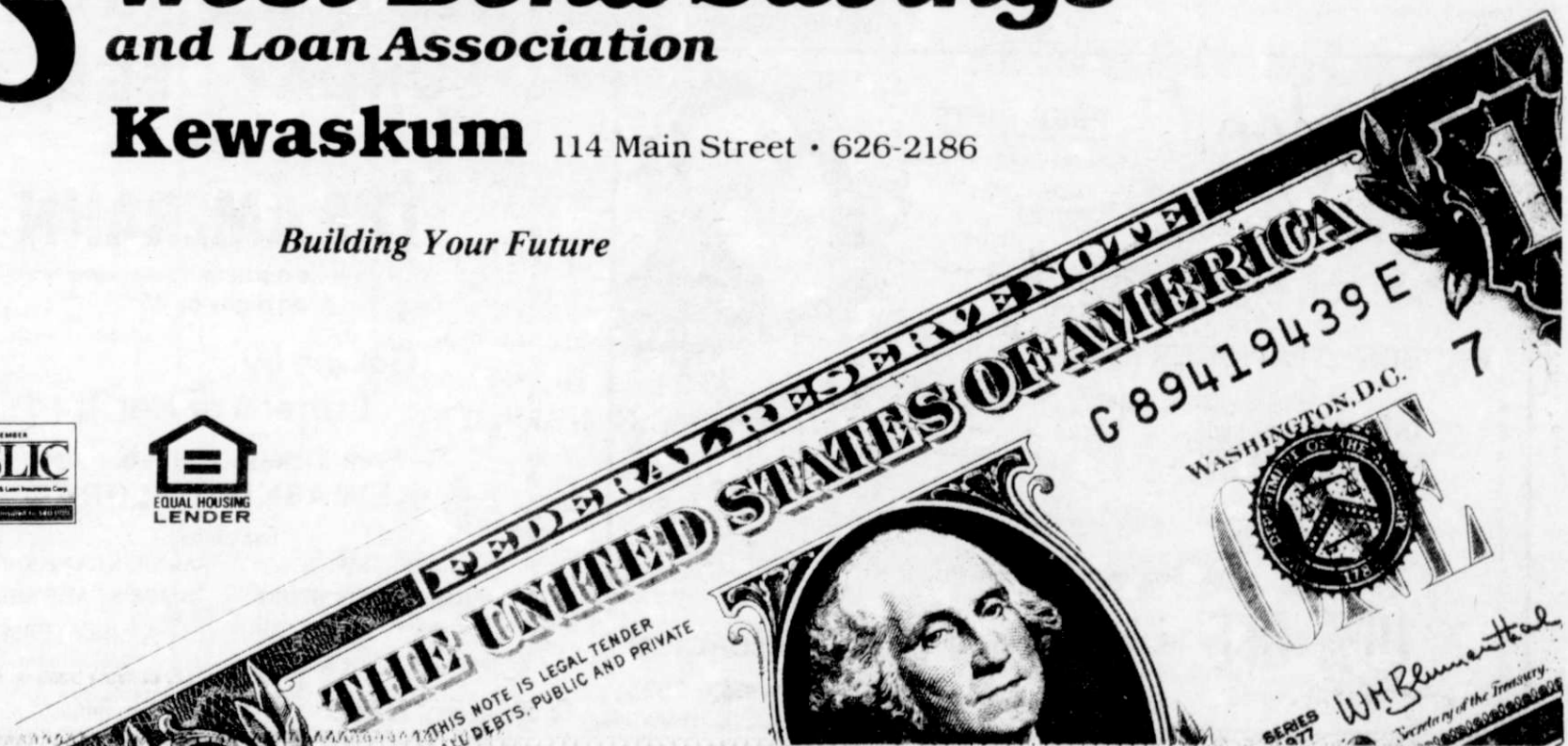

Some Public Housing Residents Eligible For Rent Rebate

WASHINGTON, D. C. - U. S. Representative F. James Sensenbrenner, Jr. (R-Wis.) today reported that low-income tenants of certain federal housing projects may be eligible for partial rebates on the rent they paid during the period of 1975 to 1977.

Sensenbrenner said the rebates, which will total an estimated \$60 million nationwide, are the result of recent federal court litigation against the U. S. Department of Housing and Urban Development (HUD). That agency was ordered to rebate funds for property taxes and utility bills it arbitrarily withheld low-income tenants in certain housing projects.

Sensenbrenner pointed out that tenants of any Section 236 HUD apartment housing for any period between February 1, 1975 and September 30, 1977 are eligible for rent refunds. The only other requirement is that the tenants must have paid more than 25 to 30 percent of their adjusted income for the rent. The deadline for application for the refunds is January 31, 1980.

Anyone residing in such housing in the Ninth District during the 1975-77 period should secure a claim form from their Section 236 project manager, if they still reside in such housing. Those no longer living in such projects should call 1-800-824-7980, a toll-free number, for information and to request a claim form.

Sensenbrenner urged all persons believing they may be eligible for the refunds to secure claim forms and file them as soon as possible.

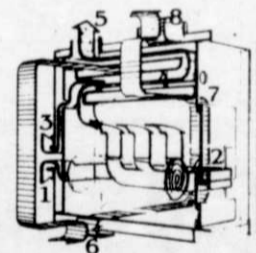

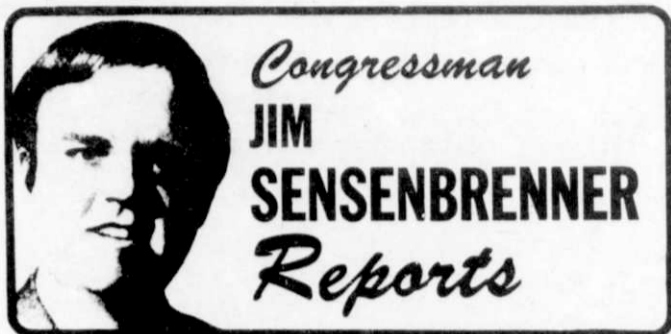

Veterans Must Send in Income Questionnaire

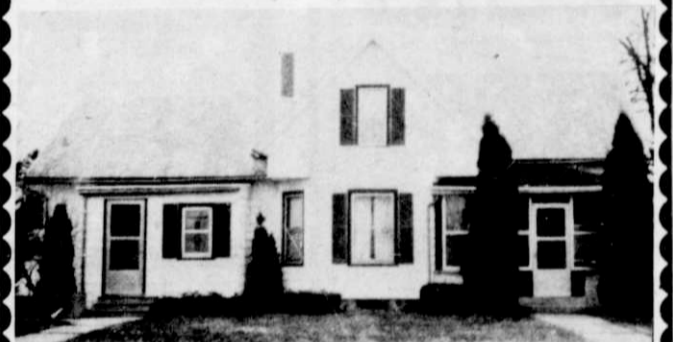

Unless a name has been erased or crossed out, another name written in, a mark placed to the right of a candidate for the same office in another column or a sticker applied, a mark in the circle at the top of the column is a vote for all the party's candidates listed in the column. If an elector does not wish to vote for all

the candidates nominated by one party, the elector shall make a cross or mark in the square at the right of or separately depress the levers or buttons next to each candidate's name for whom he or she intends to vote, or shall insert or write in the name of a candidate.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. If the ballot has not been initialed by 2 ballot clerks or is defective in any other way the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copies. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerks' initials on the outside do show. After casting his or her ballot, the elector shall leave the booth or machine, and where paper ballots are used, give his or her name to the inspector in charge of the ballot to be placed in the ballot box, and shall leave the polling place promptly.

An elector may be assisted by 2 election officials of different political parties in casting his or her vote if the elector declares to the presiding official that he or she is unable to read or has difficulty reading, writing or understanding English or that due to physical disability is unable to cast his or her ballot. Alternatively, an elector making such declaration may have another elector of the county assist in marking the ballot or operating a voting machine. The presiding official may administer an oath to a person making such declaration.

If you desire to vote for particular persons without regard to party, mark in the square at the right of the name of the candidate for whom you desire to vote, if it be there, or write any name that you wish to vote for in the proper place.
