Lift Overnight Parking Ban

Jeff Rohrer Appointed Village Board Trustee

Jeff Rohrer was appointed as a trustee to the Kewaskum Village Board Monday night. The position had been vacated when Jerry Stollenwerk was appointed Village President to succeed Robert Danielsen, who recently resigned. Rohrer's term will expire in April, 1981.

Nine residents had indicated interest in the position in response to ads in several newspapers. They were: Rohrer, Vincent Groh, Richard Schmidt, Buddy Rumsey, Jr., Charles Sparks, Harry Koch, Marvin Schmidt, and Michael Kardos, Sr. President Stollenwerk wished to have the board members vote for a new trustee instead of directly appointing one himself.

On the first closed ballot, the field of candidates was narrowed to three — Rohrer, Groh, and Dick Schmidt. The following ballot gave Rohrer a majority.

Rohrer, age 31, resides at 1124 Edgewood Road, Kewaskum. He is married and has two children. He is employed at Regal Ware, Inc. as an Industrial Designer.

Rohrer graduated from the Layton School of Art in Milwaukee and lived in Manitowoc before moving to Kewaskum in 1971.

Rohrer had served as an alternate on the Board of Appeals. He said he liked being involved in community activities and having a part in decision-making. The smooth operation of the village board impressed Rohrer and he felt he could blend in and contribute to that attitude and progression.

Several citizens were present to discuss the water situation on Edgewood Road. During the recent thawing and re-freezing, Edgewood Road has been inundated by water and ice. The road consists of two lanes separated by a wide ditch and lies in a very flat and wet area on the west side of the village.

Dave Berndes complained that the situation had existed for four years with cars having to be pulled through water and the use of the street nearly impossible. Recently, a youth drove across several lawns in

the area.

Jan Sackett claimed that the ditch was a health hazard, breeding mosquitos in the summer. She was also afraid some child may drown in the deep water.

The ditch contains several different sized culverts and drains slightly northward under normal conditions. The grade is so slight and deceptive that it appears the water has to run uphill. When the area was developed, former village engineers had approved the drainage system.

Stollenwerk was well aware of the problem, since he lives in that area. He said the village engineers were presently looking into the situation and hopefully would find a solution before next winter. Neither Stollenwerk nor Administrator Dan Schmidt elaborated on the specific alternatives. Schmidt said a further meeting could be scheduled with the residents when there were definite feasible solutions and the exact cost figures were known.

The citizens did praise the efforts of the Department of Public Works to keep the area open and as free of ice as possible.

Several meetings ago, Civil Disaster Director Marvin Martin had requested the board to consider blowing the sirens each noon to acquaint people with the warning signal. The village had been blowing them monthly beginning in April. Martin felt it would be advantageous to test them every noon, since the sirens are no longer used as a fire department signal.

The board members mostly felt that this would be a nuisance to a lot of people. Trustee Paul Blumer felt it would be like crying "wolf," and the signal might become meaningless.

Several suggestions were made to blow the emergency siren once a week, however, Supt. of Public Works Augie Bilgo felt that often might lead to more confusion. Trustee Rohrer suggested blowing the siren at some other time of the day to make the public even more aware of the emergency signal.

Eventually the board decided to have the one cycle warning siren blown for a full three minutes only once a month - on the first Thursday at 10:30 a.m.

The board lifted the overnight parking ban, since the weather gives every indication of remaining mild. As of midnight on March 18, cars may again be parked on the public streets from 2 a.m. to 6 a.m. without being ticketed as many had been during the virtually snowless winter.

Paul Blumer reported on the cable TV committee meeting of March 4. He said it would be at least a year before cable television hook-up is available in Kewaskum. Bob Schaefer of River Bend Cablevision had told the committee that, depending on various economic factors, Kewaskum might have its own receiving "dish" instead of being an offshoot of the West Bend system.

Contrary to some rumors, cable would be installed throughout the village, and anyone would have access to it, whether or not a certain percentage of one's neighbors hooked on. At least 30 channels would be available, including ones for televising local civic, school, or athletic functions. Kewaskum could only receive cablevision after River Bend had laid the cable in West Bend.

The board voted to have a college student CETA worker

conduct a survey of residences to determine if clear water is entering the sanitary sewers. This would be at no cost to the village. The worker would determine if a follow-up visit were necessary to insure that sump pumps were installed or drainage pipes diverted.

Dan Schmidt reported that the alarm system at the village's wells, lift stations, and other buildings were installed. He indicated a need for either a radio set-up or a phone line to the sheriff's department that would notify the local police of any malfunctions or break-ins at village installations when no one is present at the municipal building.

The board approved closing the land fill site in the Town of Auburn and only allowing dumping by appointment. The DNR dictates that refuse must be deposited, and apparently outsiders are using the dump without permission.

Carl Spoeth, Chairman of the Parks and Recreation Committee, said that tennis lessons would be available for adults and students this summer. Six lessons, lasting one hour each, would cost adults \$5.00 and students \$2.50.

The board approved an increase in fees for women's and men's baseball leagues from \$80 to \$85 per team. A \$25 fee per team for usage of the lights was also approved. An "over-30" league will also be formed.

Two bartenders' licenses for Kathy Rohlinger and Tom Gundrum were approved. Augie Bilgo was authorized to purchase about \$1250 worth of fireworks for the annual July 3 display.

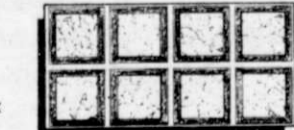

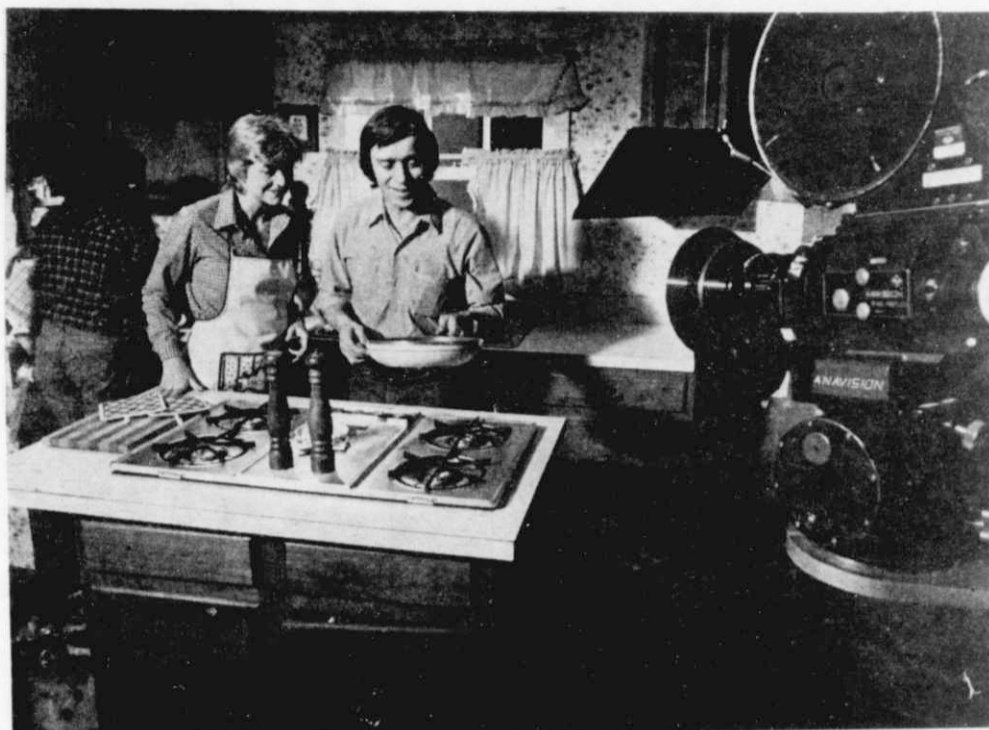

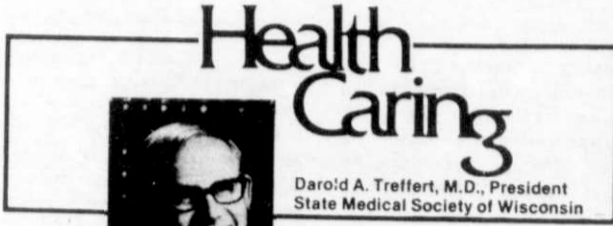

National Poison Prevention Week Observed

Each year more than half a million children accidentally poison themselves. They swallow such items as aspirin, insecticides, bleach, cleaners, detergents and soaps, fingernail polish, furniture polish, gasoline, after-shave lotion, newspaper and crayons.

The third week in March has been designated as National Poison Prevention Week to remind parents to take precautions in storing and using potentially harmful substances in the home.

Following are a few "Do's" and "Don'ts" for accidental poisoning prevention:

DO — Keep the medicine cabinet up-to-date at all times. Throw out old medicines and be sure to use the "childproof" safety cap containers whenever possible.

DO — Keep all purses and any bags or parcels containing drugs out of the reach of children. Nearly half of all women's purses contain some type of self-medication. Medication carried in a purse is a ready source of poison for the curious child who customarily seeks candy, gum, or goodies in the handbag.

DO — Keep dangerous products and drugs out of the reach of children and place the familiar "Mr. Yuk" stickers on all harmful products. "Mr. Yuk" stickers are available from the five poison control centers in Wisconsin. Teach your children that "Mr. Yuk" means poison and poison will make them sick.

Here are a few "don'ts" that are equally important in the prevention of accidental poisonings.

DON'T — tell children that medicine is candy. Teach children to respect medicine and to take it only when a person (parent, grandparent, doctor) gives it to them.

DON'T — put dangerous products into containers that are ordinarily associated with food or drink. Paint remover or gasoline in a soda pop bottle can look deceptively inviting to a thirsty child.

DON'T — leave potential poison unattended, particularly while answering the doorbell or telephone.

If an accidental poisoning does occur, here are some very important guidelines to follow:

—Give the victim milk or water.

—Call a poison center or hospital emergency room immediately. Five poison control centers exist in Wisconsin to provide emergency treatment and poison prevention services. Keep the 24-hour emergency telephone number for the poison control center in your area near your telephone for easy access. The five centers and hotline numbers are:

Vomiting may be recommended by the poison center or emergency room staff. For this reason it is wise to keep a bottle of Syrup of Ipecac at home for this purpose. It is available at any drug store at a low cost and without prescription. Never use it unless instructed to do so, however.

If it is necessary to take the victim to a hospital emergency room, remember to take the poison container with you.

The most important thing to remember is that if an accidental poisoning does occur, never hesitate in getting help - your physician, hospital emergency room, or poison control center in your area.

INFORMATION TO ELECTORS

The following instructions are given for the information and guidance of electors:

(a) Upon entering the polling place, an elector shall give his name and address before receiving the ballot from the ballot clerk. The initials of 2 ballot clerks must appear on the ballot. Upon receiving the ballot, the elector shall retire alone to a voting booth and mark his ballot. A ballot clerk may inform the elector of the proper manner for marking a ballot, but he shall not in any manner advise or indicate for whom to vote.

(b) To vote for a person whose name is printed on the ballot, make a cross (X) or mark in the square after the name of the person for whom you desire to vote. To vote for a person whose name is not printed on the ballot, write the name in the blank space provided for the purpose.

(c) The ballot should not be marked in any other manner. If the elector spoils a ballot, he shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. Not more than 5 minutes' time shall be allowed to mark the ballot. Unofficial ballots or a memorandum to assist the elector in marking his ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

(d) After the official ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerks' initials on the outside do show. After folding the ballot, the elector shall leave the booth, give his name to the inspector in charge of the ballot box, hand him the ballot to be placed in the ballot box, and leave the polling place promptly.

(e) An elector may be assisted by 2 election officials of different political parties in marking the ballot if he declares to the presiding official that he is unable to read or that due to physical disability he is unable to mark his ballot. If an elector declares that he is visually handicapped, he may have anyone assist him in marking his ballot. The presiding official may administer an oath as to a person's disability.

(f) Any qualified elector who is absent, or expects to be absent from the village in which he is a qualified elector, or who, because of sickness or physical disability cannot appear at the polling place on election day, may vote at such election by means of an absent voter's ballot to be secured upon application to the Village Clerk, not more than sixty days and no less than three days, or by personal application, not later than the close of office hours on the day prior to such election.

A reminder to sportsmen and others interested in the Wisconsin outdoors that the Wisconsin Conservation Congress' annual spring hearings will be held in each county in the state on Monday evening, April 28, beginning at 7:30 p.m. All residents of Wisconsin are invited to attend and participate.

Southeast District

Numerous flocks of Canada geese are moving through the district, giving an indication that spring is on the way. 20-24 inch lake trout are being taken on Lake Geneva in Walworth County. Jig type baits with small minnows fished near the bottom in about 70-feet of water are producing best. The bag limit is two fish and they must be at least 17" in length. Ice fishing for panfish is generally good, however, fishing pressure is extremely light. Small perch are being taken from Wind Lake in Racine County and Random Lake in Sheboygan County. Crappies and a few northern pike are being taken from Sheboygan Marsh in Sheboygan County. Bluegills are biting well in Pewaukee Lake in Waukesha County, Waubeesee Lake in Racine County and Lauderdale Lake in Walworth County. Some brown and rainbow trout are being taken on spawn sacs in the Sheboygan River in Sheboygan County and Lake Michigan anglers are having success generally with smelt or spawn sacs for bait at the Sheboygan power plants, the Port Washington Harbor and the Oak Creek Power Plant in Milwaukee County.

Winnebago County—Walleye fishing has improved considerably on Lake Winnebago with some nice fish being taken south of Oshkosh. Walleyes and crappies are being taken on Lake Poygan. Northern pike action is picking up on Lake Poygan.

Fond du Lac County—Panfish fishing is poor in all inland lakes but is expected to get better in a few weeks with the coming of warmer weather especially on Long Lake, Mauthe Lake and the Kettle Moraine lakes.

Dodge County—Small catches of perch and crappies are being taken on Fox Lake and Beaver Dam Lake. Ice conditions on the Rock River are poor with the dam open and the current is causing open areas.

This is hazardous for snowmobilers and ice anglers.

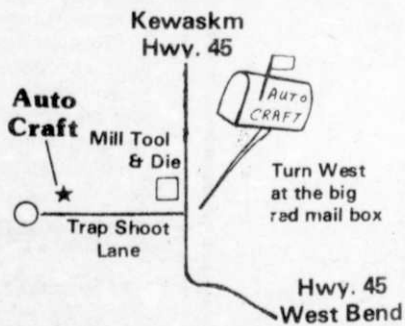
