Figure Below Projection; Board Won't Pursue Challenge in Count

Preliminary Census Count Shows Village Population Around 2400

The Kewaskum Village Board agreed to not pursue a challenge to the Bureau of the Census regarding a discrepancy between their population and dwelling count and the Dept. of Local Affairs and Development.

According to census figures, the preliminary population count of the village is 2329, while DeLAD has its projection as 2560. In a phone conversation with Administrator Dan Schmidt, a census person said this figure was about 85% of the final figure, so about 70 more people could be expected. Schmidt objected to this since the population would still be 200 less than the projection. He was then told, "You just don't have as many people as you thought you had."

Kewaskum supposedly has 806 dwelling units according to the census. One district west of Hi-way 45 has 3.3 people per unit while a second district east of 45 has 2.65 per unit. Schmidt apparently agreed with the number of units so was told that not much could be done about this. Schmidt originally found it hard to believe that the east

side had significantly less people per unit than the west side, but after taking a sample survey, he found that a lot of single people live east of 45 and did come up with close to a 2.65 average.

The reason a challenge was suggested is that federal revenue sharing and state sharing and machinery and equipment reimbursement is based upon the rate of growth and the relative agreement between DeLAD and census figures. Schmidt also added that with the 4.4% state cut in all departments, "We're going to be hurting financially." 2500 is also a magic number as far as some state requirements. Certain forms must be submitted regarding landfill and the recently appointed certified building inspector is required once 2500 population is exceeded.

The figures could also affect the tax base, but it was noted that everyone's census figure seemed to be lower than the DeLAD projections. For instance, West Bend's projection was for 23,110 while the census figure was 21,298. Later Clerk-Treasurer Bill Martin wondered if it really would affect revenue

sharing, since all communities seemed to have relatively the same disparity. He noted Milwaukee had a terrific drop between estimated and actual population.

The method of any challenge would be to take a recount. It was estimated by Schmidt that 2 days might be involved, but Police Chief Don Hlavaty estimated only one day if he had uniformed officers assist. Hlavaty also said several years ago there was a re-count challenge, but it did not help the situation.

Schmidt said, "The basis for the entire change is on dwelling units," but since there was little disagreement on this, any challenge might not be worth the expense and effort. Board member Dave Nigh felt it didn't pay to pursue it if dwelling units were the only relevant factor. The board agreed to not pursue the matter further and no action was taken.

Supt. of Wastewater Treatment Pete Albers was attending a convention so could not comment on the operation of the new sludge conditioner. A special meeting had been held (Continued on Page 3)

Minz Supply to Relocate, Construct New Building

Minz Supply, Inc., a lumber and hardware dealer in Kewaskum, is planning to relocate from 128 Main St. to a 1.5 acre plot at 985 Fond du Lac Ave. or just south of Hilltop Laundry near the intersection of Hi-ways 'H' and '45'.

Ken Weddig, Manager of the Kewaskum store, said a proposed 100 ft. x 120 ft. building would house its lumber supply and hardware store all under one roof. It would be arranged so trucks could drive through the enclosed yard for lumber pickup. Parking for 50 cars would be available.

Weddig explained that the new facility would be a complete "home center" geared to the "do-it-yourselfers" in the area. All lines of merchandise as hardware and paint would be

expanded as well as providing new lines of building and home improvement materials.

Minz Supply, Inc. would also continue to advise people on building and would feature free delivery of lumber.

Prior to any construction, a public hearing will be held on Monday, August 18, to rezone the parcel of land from an R-1 single family residence status to a B-2 general retail and service status.

Assuming rezoning is approved by the village board, Minz Supply hopes to break ground and pour footings as early as August 19. It is hoped that the new building will arrive the first week in September. Actual construction will be done by Minz Building System. The facility is tentatively scheduled to be in operation by November 1.

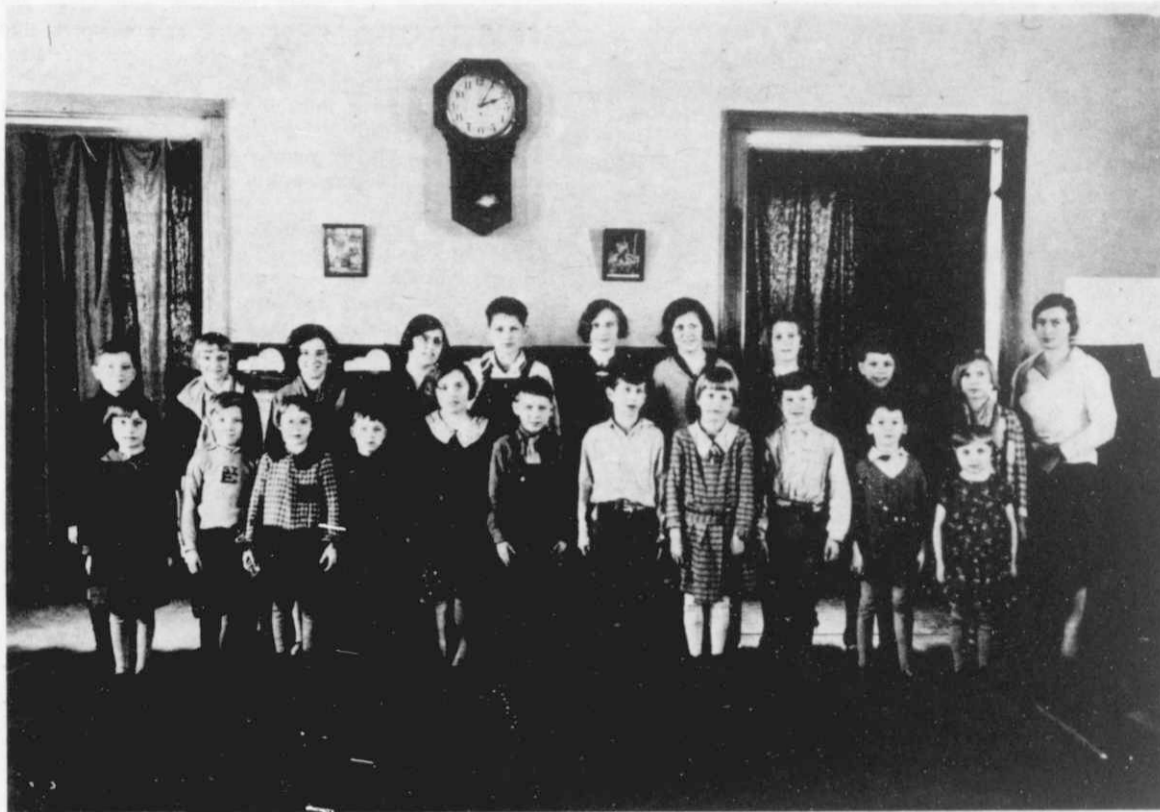

on July 30 at which problems with the dewatering device were reviewed. Tom Lawn of Permutit Co. was present to explain that the necessary 2-ply screens for the press unit were being sought. The original screens had broken after 6 weeks but the machine was running on new screens for 2 weeks. The screens were supposedly out of stock, but a letter was received from Jim Devaney of Permutit saying that other vendors were being contacted. The machine must operate

with no breakdowns for 100 continuous days or until about the end of August when the situation will be reviewed. Presently, the machine seems to be working alright and has been run 8 full days over the last 2-week period. The conditioned sludge is hauled by dumptruck and stockpiled by a farmer who mixes it with organic material for dispersal on his land.

Tom Lawn also agreed verbally at the special meeting that no payment would be required until the village board accepts the performance data.

A proposed reduction in the speed limit from 45 mph to 30 mph on Hi-way 45 south of the village was turned over to the

Protection and Public Safety Committee. If the proposed shopping center and Minz's new store are located in that area, this was deemed appropriate. The committee will make its recommendation so the change can be officially applied for.

The board was invited by Peter Knaup, a contractor from Beaver Dam, to inspect a housing project for the elderly there. Such a project has been approved for Kewaskum and will be located on land owned by

Kilian Honeck near the south end of Roseland Drive.

Parks and Recreation Committee Chairman, Jeff Rohrer, reported that the village has agreed to pay one-half of a bill of \$550.96 for athletic field lighting repairs while the School District of Kewaskum would pay the other half. There was also an agreement that the village not incur any more expense for this athletic field this year.

Rohrer also said a special meeting of the Parks Committee

would be held on Monday, August 18, at 7 p.m. at which interested citizens could voice their opinions and offer constructive criticism about the parks and recreation program.

Supt. of Public Works Augie Bilgo said that 2 loads of culverts for the Edgewood ditch-enclosing project had arrived and work would probably begin this week. Permission has also been received from Nic Stoffel to alter the entrance to a small stream allowing for one more foot of pitch in the new drainage system.

A letter was received from the Kewaskum Historical Society thanking the village for its \$1,000 contribution to assist with the reconstruction of a log house near the museum. The letter continued, "When this structure is completed, it will be an attractive historical asset to our community."

Summer Playground Notes

This was "Carnival Week" at Kewaskum's Summer Playground. The children worked on posters to advertise it, tickets to sell, and the various booths. The MDA carnival itself was held on Thursday from 1:30 - 3:30. Everyone had a good time with prizes, candy popcorn and lemonade.

Last week's Super Stars awards were given to Petra Thull and Kevin Hinz.

Next week will be "Closing Week." A good variety of miscellaneous projects will be worked on throughout the week. If enough children attend, kickball will be the featured game.

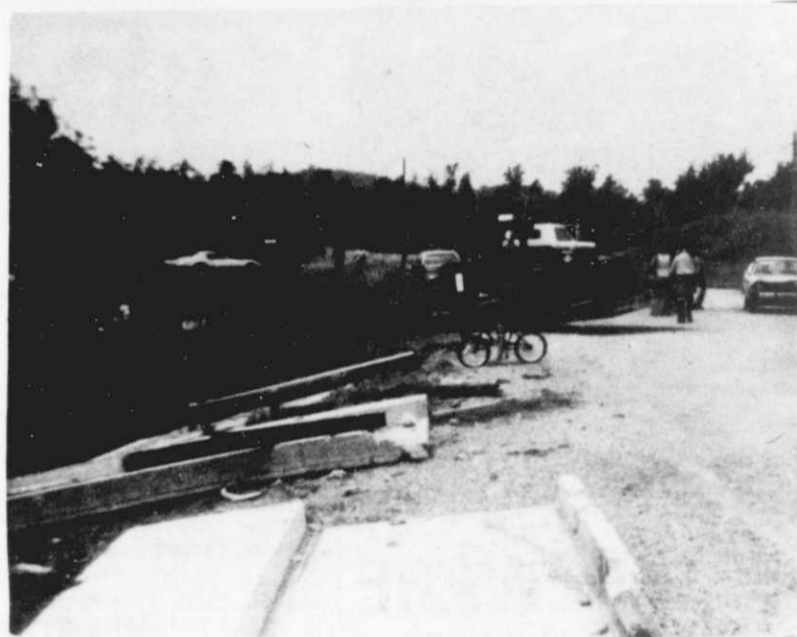

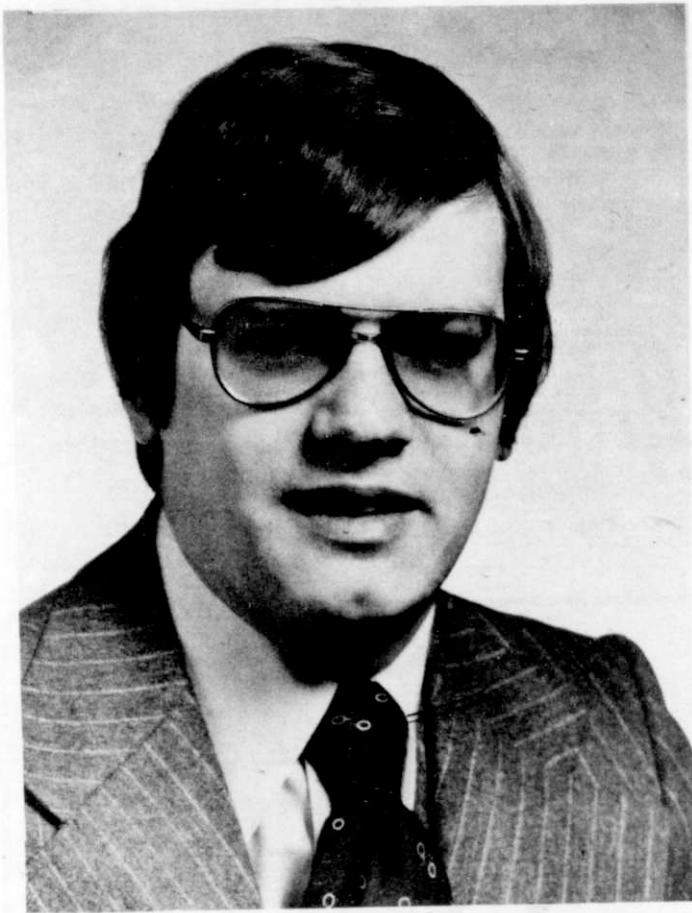

Floyd Stautz Resumes Duties For Environmental Protection

Floyd Stautz returned full circle May 19, reassuming duty as Southern District assistant district director for environmental protection, a position he left in 1974.

Stautz, a Kewaskum native, laterally transferred from the central office, where he served as director of the bureau of Water Regulation and Zoning.

He succeeds Bob Behrens, who transferred to the Lake Michigan District and is now heading up their sewage treatment plant operations and maintenance team.

Some things have changed in six years, according to Stautz. "Wisconsin had its own environmental protection program before the federal government became involved," he explained.

"But these new federal laws covering air pollution, solid waste and water pollution have established stringent standards and reporting requirements. More emphasis has been placed on enforcement and less toward technical assistance."

However, other things haven't changed in six years.

"Some major pollution problems in the Southern District still exist from 1974, caused mainly by shortage of construction funds and legal delays," he noted.

And for the future, especially the 1980's Stautz sees the major

concerns as "finding adequate hazardous waste disposal sites, county or regional landfill sites, groundwater pollution and funds for municipal wastewater treatment."

Stautz earned a bachelor of science in civil engineering and master of science in civil and sanitary engineering from the University of Wisconsin in 1956 and 1966 respectively.

His professional career began in 1956 as a water pollution engineer with the State Board of Health's old Committee on Water Pollution, an agency later transferred to the former Department of Resources Development and subsequently merged with the Conservation Department.

Other appointments for Stautz included: Region 1 (Southern) director, Department of Resource Development, 1967-1969; assistant district director, Environmental Protection, Southern District, 1969-1974; and acting and then bureau director, Bureau of Water Regulation and Zoning, 1974-1980.

He is a son of Mr. and Mrs. Clifford Stautz, Kewaskum.

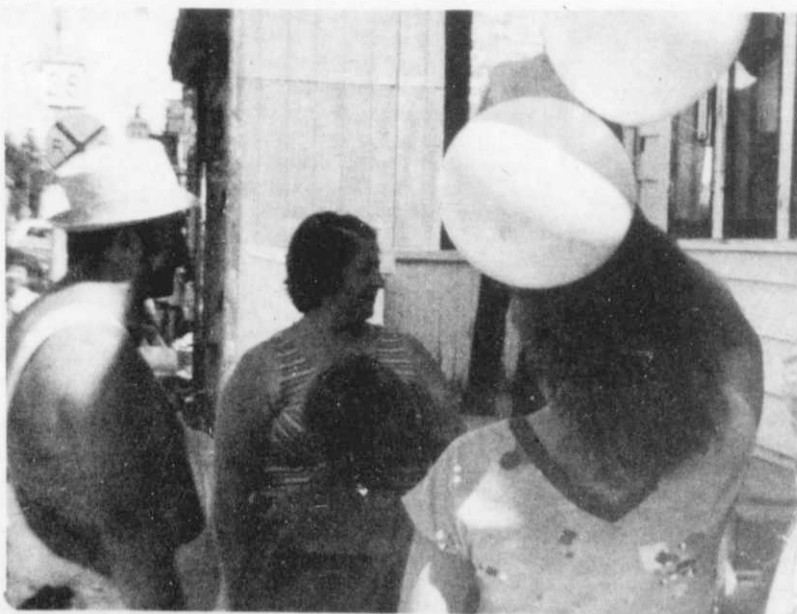

AROUND THE COUNTY

MAKE LESS EXPENSIVE MEATS SUITABLE FOR OUTDOORS COOKING

Keeping a tight rein on the food budget doesn't mean that you have to limit outdoor meat cookery to hot dogs and hamburgers. Less expensive cuts of meat will be suitable for grilling if treated with tenderizers or marinades or with pre-cooking.

Barbecuing on the grill is a form of dry heat cookery similar to roasting and broiling and usually requires high quality, relatively tender cuts for best enjoyment. But meat tenderizer, containing plant enzymes to break down connective tissue modified less tender cuts so that you can barbecue sirloin tip and top round steaks and rump and round roasts.

A marinade also tenderizes. It is a mixture of acids, oils and flavoring in which cuts of meat are soaked. Acids such as vinegar, lemon or tomato juice or wine tenderize the meat by softening the connective tissue. The oil bastes the meat and carries the flavoring ingredients into the meat interior. Marinating meat overnight produces best results. Keep the meat covered in the refrigerator in a glass or stainless steel container to avoid staining the pan. Bottled tangy French and Italian dressings make flavorful, quick marinades.

Beef chuck roasts and steaks, beef short ribs and pork spare ribs benefit from pre-cooking.

Slow braising in a covered pan with liquid present breaks down connective tissue and makes the meat tender before the final barbecuing adds flavor. Pre-cooking meat cuts down grilling time and prevents some of the drying and surface charring which can occur with prolonged barbecuing.

Simmer fresh brats and fresh pork sausage 5-10 minutes before cooking on the grill. You can use water or half water and half beer as the braising liquid. Another way to add beer flavoring and keep brats hot until serving time is to place the hot grilled brats in a pan of hot beer as soon as they are cooked.

Cook most meats on a moderate or slow fire to keep meats from drying out and to allow thicker cuts, especially pork, to heat thoroughly before the outside becomes too brown. Use slow fires for chicken and sausages which burn easily or for meats like spareribs which require a long cooking period for tenderization.

Too hot a fire chars meat and may cause toxic substances to form on the burnt surfaces.

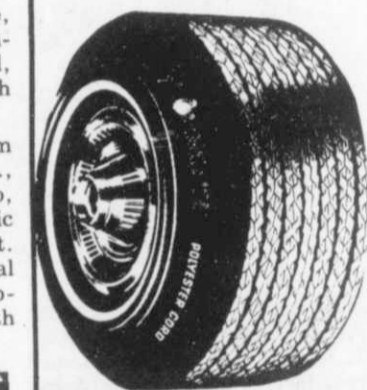

Area Parishes Among Leaders In Catholic Fund Appeal

Holy Angels parish in West Bend, St. Patrick parish in Thompson, and St. Michael parish, St. Michaels, were top achievers among parishes in Washington County during the 1980 Catholic Stewardship Appeal, according to a parish performance report published last week in the Catholic Herald Citizen.

Holy Angels ranked first in total gift amount with subscriptions of \$29,867. St. Patrick headed the list in average gift amount with \$42.89. St. Michael surpassed all other parishes with 87% participation by potential donors.

Other leading parishes and missions in the county were:

Total gift amount: St. Frances Cabrini, West Bend, \$27,139; St. Kilian, Hartford, \$22,617; St. Peter, Slinger, \$11,540.

Average gift: St. Augustine, Trenton, \$42.47; St. Peter, Slinger, \$41.81; St. Mary, Holy Hill, Hubertus, \$39.83.

Percent of participation: St. John of God, Farmington, 80%; St. Boniface, Germantown, 80%; St. Lawrence, St. Lawrence, 72%.

Washington County leader for the drive was Leo F. Schlaefel of West Bend. He was assisted by associate leaders Jerome Krantz of Allenton, Erwin J. Benka of Hartford, Robert Kirst of Kewaskum, and James A. Spella of West Bend.

Among all the 286 parishes and missions in the Archdiocese of Milwaukee, the overall leaders were St. Mary of Elm Grove in Waukesha County, with pledges totaling \$91,914 from 1,192 donors; St. Francis Seminary faculty and students of the Southeast district of Milwaukee County with an average gift of

\$161; and St. Martin parish of Ashford in Fond du Lac County with 95% participation of potential donors.

The annual fund appeal surpassed its \$4,200,000 goal with subscriptions totaling \$4,234,505 from 114,386 donors. As of July 22, \$3,511,009.43 had already been received in cash and pledge payments.

General chairman Norbert J. Stefaniak of West Allis pointed out that the success of the appeal is due to the effort of more than 1,000 volunteers on the parish level, particularly parish chairpersons and parish priests.

Gerald M. Schaefer, director of development for the archdiocese, indicated that the appeal is a year-long process which only closes on December 31, 1980. He said that some contributors prefer to make their gifts in November or December, but that all contributions received in 1980 are credited to the 1980 campaign.

VOTING BY ABSENTEE BALLOT

Any qualified voter, unable to get to the polling place on election day, may ask to vote by absentee ballot. A qualified voter is one who is a U.S. citizen, will be 18 years of age or older on election day, and who has resided in the ward or aldermanic district where voting is desired to be accomplished for at least 10 days prior to the election. If the voter resides in a municipality which requires voter registration, then registration is also a requisite for the voter who is qualified in other respects.

To obtain an absentee ballot, contact the clerk in the city, village or town in which you reside by mail or telephone, or in person, and request an application form. After properly completing and returning the application to the municipal clerk, an absentee ballot will be sent to you along with a postage pre-paid return envelope, or given to you if the application is submitted to the clerk in person. The deadline for receipt of the application by the municipal clerk is 5:00 p.m. on the Friday before election day in the case of applications mailed to the municipal clerk, and 5:00 p.m. on the day before the election in the case of applications made in the clerk's office.

With one exception, the voter who wants to cast an absentee ballot must make a separate application before each election. Voters indefinitely confined to their home or care facility because of illness, age or disability need not file an application before each election; a special statement on the application form can be completed asking that an absentee ballot be automatically mailed to them before each election; if they fail to make and return the ballots sent to them in an election, they must complete another application later on.

Absentee ballots can be voted at home anytime after they arrived in the mail. They can also be voted right in the clerk's office if submitting the application in person. If returning the ballots by mail, the affidavit-certificate must be properly completed and witnessed by two persons. 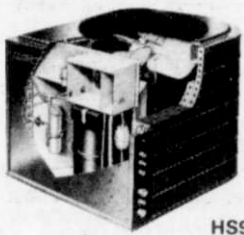

Walks Hurt

Slinger's Giant Killers Edge Indians in WIAA Sectional, 5-4

The Slinger Owls, who finished second last in the Scenic Moraine Conference with a 4-11 record, but turned out to be giant killers in WIAA tournament play, did it again last Wednesday when they edged Kewaskum in the WIAA Sectional at Slinger, 5-4, to oust the Indians from further competition. The Indians had defeated Slinger twice during the regular season.

Previously Slinger had upset Scenic champion West Bend East (15-1) and fourth place West Bend West (10-6) in tournament play before knocking off second place Kewaskum (11-5) Wednesday. But the Owls, underdogs in each of these games, were eliminated the next night by Port Washington, 9-3, sending Port to the State Tournament at West Bend this week. In the State Meet Port was eliminated by New Holstein Tuesday, 16-3. Kewaskum had reached the Slinger Sectional by beating Campbellsport in the Regional.

The Owl-Indian game was close as expected, even though Slinger jumped off to a 5-0 lead in the first two innings. Kewaskum came back with four of their own in the fourth but that ended the scoring and the Owls hung on for the victory. The Indians' all-Scenic selection, soph pitcher Jeff Geidel, got off to a bad start in the 3-run first inning, issuing four walks and a

hit before calming down and getting out of the inning.

The Owls made it 5-0 with two more in the second on another walk, sacrifice, bloop single and a double. Then Geidel settled down as Slinger got just one more hit the rest of the way but it was too late.

The Indians finally got to John Theisen in the fourth. Singles by Scott Muench, Steve Yahr and Henry Schilter loaded the bases. One run scored on a fielder's choice. Then Dave Donath lashed a long triple clearing the bases, and he scored on a bad throw.

That was it for the Indians, who were held scoreless for the last three innings again by Theisen. Kewaskum coach Mike Theiler naturally was disappointed. With champion West Bend East out of the running, he had hoped to go on to state. Maybe this will come true next year when all but three of his players will be back, including all three pitchers.

WISCONSIN 4th IN FISHING HUNTING LICENSE HOLDERS

Wisconsin ranked fourth in the nation in both the number of paid fishing license and paid hunting license holders in 1979 according to figures released recently by the U.S. Fish and Wildlife Service.

There were 1,495,885 paid fishing license holders in the state last year. That number was exceeded only by California which ranked first, Texas second, and Minnesota third just ahead of Wisconsin by about 1,600 license holders. Michigan was fifth. Wisconsin led the nation in the number of non-resident fishing licenses, tags, permits, and stamps issued last year with a total of 409,932.

Wisconsin's total number of paid hunting license holders last year was 756,256 to rate fourth with Pennsylvania first, Michigan second, and Texas third.

\$18 Million Spent On Hunting, Fishing Licenses in State

WASHINGTON, D.C. — People who hunted and fished in Wisconsin last year spent \$18.5 million on licenses, tags, permits and stamps, Congressman Tom Petri reported.

Petri said that figures from the U.S. Department of the Interior show \$9 million was spent in the state for hunting licenses and 9.5 million for fishing licenses.

The total number of Wisconsin hunting license holders was 756,000. There were twice that many who went fishing—1.4 million held a fishing license, he said.

Each state uses the revenues from hunting and fishing license sales to conduct its fish and wildlife conservation programs. The numbers of hunting and fishing license holders are used by the U.S. Fish and Wildlife Service in determining the fund apportioned to each state under federal fish and wildlife programs.

Under these programs, state governments are reimbursed for up to 75 percent of the cost of approved projects. For the current fiscal year, which ends in September, the federal government distributed \$117 million for conservation.
