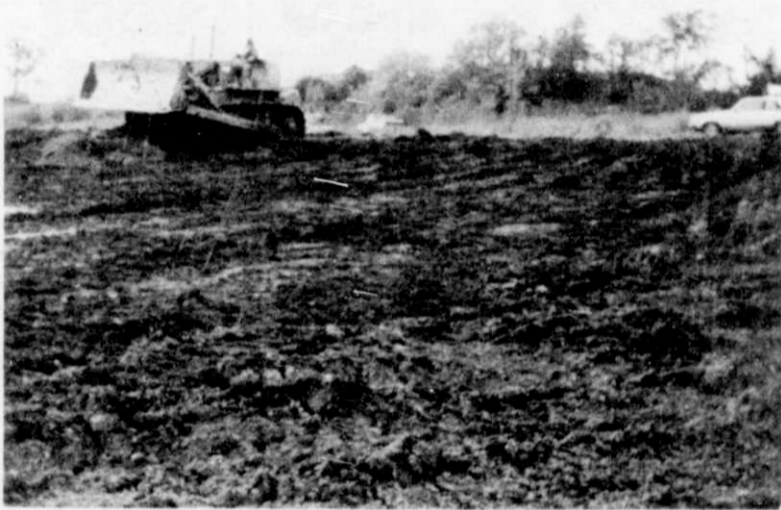

Plan for Kewaskum Cable TV Presented

Bob Schaeffer, Technical Supervisor, from Cablevision, met with members of the Kewaskum Advisory Cable TV Committee Monday evening.

Schaeffer outlined Cable TV service that would be brought to Kewaskum when the village adopts an ordinance and accepts Cablevision's proposal.

Service would be provided to the Village and immediate surrounding residences only and would not go much beyond village limits.

This service would supply approximately 35 channels to subscribers. This would include all network and public channels now available in the area, plus channels from Chicago, Madison and Green Bay, supplemented by cable network channels. Two channels would be provided for use by the schools along with camera, video recorder and lighting if so requested.

All city buildings would be wired free along with designated school buildings. Schaeffer could not give a definite answer regarding parochial schools, but he said if at all possible this would be done.

Cablevision has three movie channels, "Home Box Office" which runs from approximately 5 p.m. to 1:00 a.m., covers both movies and sporting events; "Show Time" runs from 3 p.m.

to 12 p.m. covering plays and "Cinemax," a 24-hour movies only channel.

Cost of the service would be \$7.50 per month for "Basic Service" plus \$8.00 per month for each movie channel. Subscribers have the option of taking 1, 2, 3 or none of the additional movie channels.

This service charge would cover only one TV set in a household. For an additional \$3.00 per month an added set may be hooked to the service and identical programming will be supplied to the second set.

Installation costs would run \$10-\$15.00, however, all customers who subscribe within the first 30 days of availability would receive free installation. Apartment buildings could be hooked up either on an entire building basis or as individual units.

Key units would be available at no extra cost allowing subscribers to lock sets during any programming they did not want children to watch.

Schaeffer stated movies are re-run several times during a month so viewers who missed a segment of a movie could view it at a different time.

A cablevision operating company would be set up in Kewaskum to handle service and billing. Rates are slightly higher than West Bend because of the smaller subscriber per mile ratio. Cable installation costs

approximately \$8,000-\$10,000 per mile.

Schaefer said work could begin as soon as an ordinance is adopted. The only time restriction would be how fast work required, if any, on utility poles is completed to allow stringing of cable. This time has varied from 8 weeks in Antigo to 9 months in West Bend.

Campbellsport which has also been contacted by Cablevision, has adopted an ordinance. Schaefer suggested the committee might wish to use this ordinance as a guide in developing an ordinance since it is much closer to Kewaskum's needs than the West Bend ordinance.

Chairman Joe Harlow said he would set up a meeting next week to work out an ordinance.

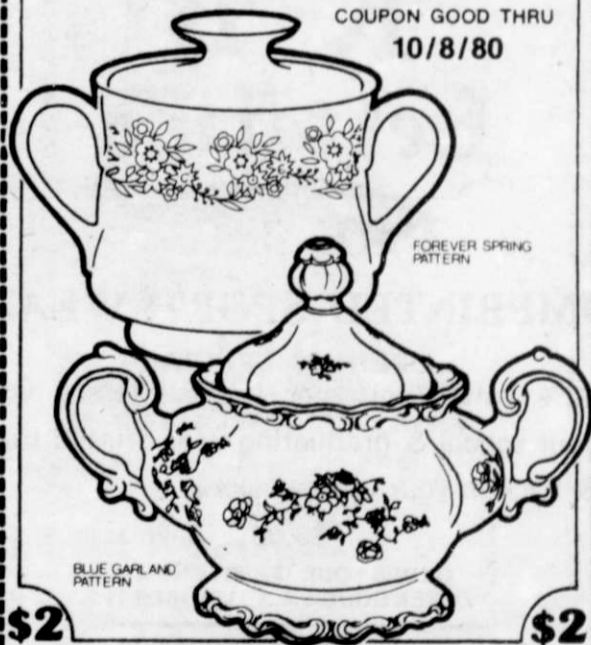

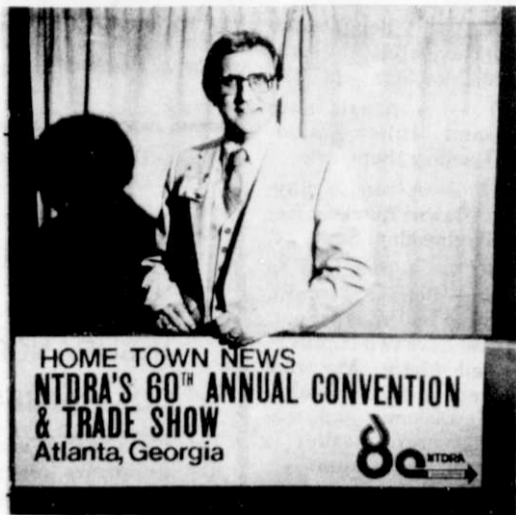

Aroma of Apples and Spices to Tantalize Visitors at Old Wade House October 4 & 5

The mouth-watering aroma of apples and spices cooked over a wood fire will greet visitors at Old Wade House in Greenbush, Saturday and Sunday, October 4 and 5. On that weekend, the restored 1850s Stagecoach Inn will celebrate the harvest with its annual Apple Butter Festival.

Large kettles of apples and spices will be cooked down slowly over an open fire, following a recipe that, tradition has it, was brought to Greenbush by Betsy Wade in the 1840s. Betsy, wife of Sylvanus Wade, who built Wade House and was its first innkeeper, served her apple butter as part of the hearty fare of the inn.

Betsy Wade favored pippins above all other varieties of apples for her apple butter and so the apples that go into the kettle will be locally grown pippins, donated for the event by Waldo Orchards of nearby Waldo.

Visitors will be encouraged to help stir the simmering mixture, and samples will be served inside the Wade House.

Old Wade House Historical Site is owned and operated by the State Historical Society of Wisconsin. The museum also includes Butternut House, a pre-Civil War residence; and the Jung Carriage Museum, containing one of the largest collections of restored horse-drawn vehicles in the country.

Travelers to the Greenbush area can expect fall foliage colors to be near their peak during the Apple Butter Festival. Old Wade House is located at the intersection of State Highway 23 and the Kettle Moraine Scenic Drive, in the Northern Unit of the Kettle Moraine Forest.

The ticket office is open daily 9 a.m. to 4:30 p.m. until October 31 when the site closes for the season. For more information, write Old Wade House, Greenbush, Wisconsin 53026,

OLD WADE HOUSE APPLE BUTTER RECIPE

4 quarts pippins (or other apples)
2 quarts water
1-1/2 quarts raw cider
1-1/2 pounds sugar
1 tsp. cinnamon
1 tsp. allspice
1 tsp. cloves

Wash apples and cut into small bits. Cover with water and boil until soft. Press through a sieve to remove skins and seeds. Bring cider to a boil. Then add apple pulp and sugar and cook until thick, stirring at all times to prevent scorching. Add spices and cook, stirring occasionally, until thick enough to spread, about an hour or two.

Petri Signs Discharge Petition Eliminating 'Marriage Tax'

Congressman Tom Petri has signed a discharge petition to take a bill eliminating the "marriage tax" out of a House committee and force a vote on the legislation.

The bill, which seeks to end tax that penalize working couples, will be discharged from the Ways and Means Committee if 218 legislators sign the petition being circulated by the bill's sponsor, Congresswoman Millicent Fenwick (R-N.J.).

"I do not take this step lightly," Petri said. "I have the greatest respect for the committee process in Congress, but we cannot ask working couples to tolerate another year of this serious tax inequity."

Under current law, the "marriage tax" falls on two-earner couples if the income of one

spouse exceeds 20 percent of the income of the other. The more equal the two incomes, the larger is the tax.

Petri said the tax policy is discouraging marriage and is causing difficulties for wives who have decided to go to work. He is one of over 200 legislators who have co-sponsored Fenwick's bill.

Her proposal would give married couples the option of filing separately as individuals. Using the single person's rate schedules would reduce the rates for the two-earner married couples who choose that option, sponsors say.

"According to the Treasury Department, working couples pay \$8.3 billion more in taxes each year than they would under the Fenwick bill," Petri

said. "The single-earner family would still benefit from filing a joint tax return as they do now. Passage of this legislation is in the interest of the family unit and of fairness to all taxpayers. We must not let the federal tax code discourage either marriage or two-earner families."

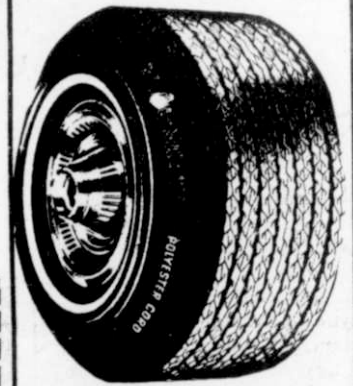

Conservation Tillage Field Day For County Farmers

Farmers in Washington County will have an opportunity to evaluate different methods of conservation tillage on corn. The field day will be held on Wednesday, October 8, from 10:00 a.m. 3:00 p.m. at the following three locations:

Plot 1: Location in the Town of Jackson on the east side of Jackson Drive, 1/2 mile south of Western Avenue. John Brugger is the cooperator. Compares conventional planting with no till in sod.

Plot 2: Located in the Town of Addison on the south side of Highway 33, 1/2 mile east of Highway 175. Sunset Farms is the cooperator. Compares conventional planting with chisel plow in last year's corn stalks.

Plot 3: Located in the Town of Wayne on the east side of Rolling Drive, 1/2 mile north of Highway 28. Robert Melzer is the cooperator. Compares conventional planting with chisel plow in last year's corn stalks.

These plots were established through the cooperation of the cooperating farmers and representatives of the Washington County Soil and Water Conservation district, Soil Conservation Service, Agriculture Stabilization and Conservation Service, UW-Extension and Moraine Park Technical Institute.

Individuals may visit one or all of the plots and observe the growing conditions in the field

as well as receiving information on how the crop was planted and managed. A complete summary with yield results will be provided later in the season, after the completion of the project.

In Fall, Clean up Garden, Prepare Soil for Spring

What you do in this year's garden after harvest can improve next year's crop. Put the soil in good condition by adding organic matter and getting rid of pests and plant diseases that thrive in the recent wet weather.

To avoid overwintering diseases, destroy any diseased plants at the end of the growing season. Clear the garden and bury plant debris in an off garden site, or sent it with the garbage in a big plastic bag.

Many garden soils are low in humus because they have been cultivated for a long time. When humus is used up and not replaced, the soil gets hard, dries out easily and produces poor crops. To build up the garden's humus supply add a 2-3 inch layer of partially rotted barnyard manure, compost or other organic matter in the fall.

Plow or spade the organic matter into the garden to im-

prove the soil's texture and fertility. Fall turning permits the soil to dry out and warm up earlier in the spring and helps get rid of many insects and diseases. If erosion is a problem, use a surface mulch or winter cover crop to hold the soil in place.

Leaves also can be spread on top of the garden at this time, to be mixed in next spring. However, if the leaves are not completely broken down by then, bacteria will use nitrogen in the decomposition process, and an additional nitrogen fertilizer may be needed. Maple leaves break down relatively quickly, but oak leaves take more time.

Another method of supplying organic matter is to plant a "green manure" crop. First plow in any compost and leaves right after harvest. Then sow a legume crop, such as alfalfa, red or sweet clover, soybeans or cowpeas, which will supply nitrogen. Winter rye, oats, barley or buckwheat could also be planted, but the soil may then need nitrogen fertilizer for the following garden season. Plow the green manure crop under as soon as the soil can be worked in the spring.

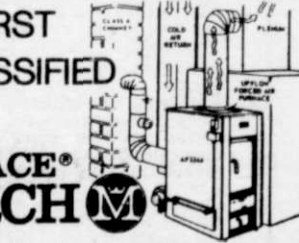

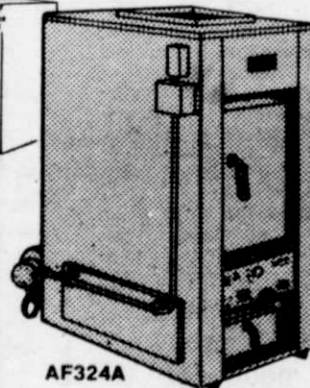

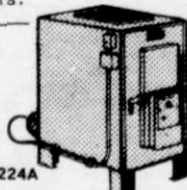

VOTING BY ABSENTEE BALLOT

Any qualified voter, unable to get to the polling place on election day, may ask to vote by absentee ballot. A qualified voter is one who is a U.S. citizen, will be 18 years of age or older on election day, and who has resided in the ward or aldermanic district where voting is desired to be accomplished for at least 10 days prior to the election. 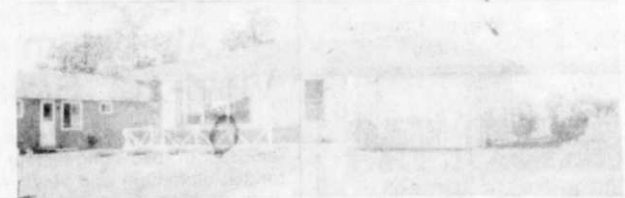
With one exception, the voter who wants to cast an absentee ballot must make a separate application before each election. Voters indefinitely confined to their home or care facility because of illness, age or disability need not file an application before each election; a special statement on the application form can be completed asking that an absentee ballot be automatically mailed to them before each election; if they fail to make and return the ballots sent to them in an election, they must complete another application later on.

Absentee ballots can be voted at home anytime after they arrived in the mail. They can also be voted right in the clerk's office if submitting the application in person. If returning the ballots by mail, the affidavit-certificate must be properly completed and witnessed by two persons. If returning the ballots in person, the affidavit-certificate must be properly completed and subscribed and sworn to by the clerk or the deputy clerk who are authorized to administer oaths. In either case, the marked, sealed ballot must be in the hands of the issuing municipal clerk on or before election day. Any absentee ballot received at the polling place after the polls close or received in incomplete or improper form cannot be counted.



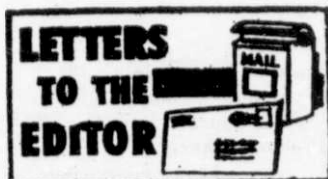

which consists of members whether or not they are entered in the show.

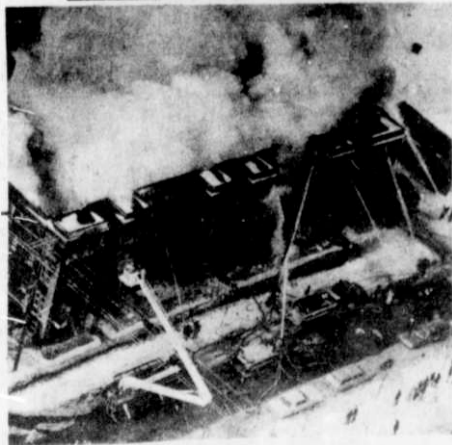

New Holstein Romps to Easy Win Over Indians

New Holstein more than doubled Kewaskum in first downs with 16 to the Indians' 7, outgained Kewaskum in total net yards by a whopping 335 to 105 margin, and simply outplayed Kewaskum in romping to an easy 32-6 victory over the Indians in their second Eastern Wisconsin game here on Parents Night Friday. The loss left the Indians with an 0-2 mark in conference and 1-3 overall.

The Huskies led by only 6 points after the first quarter but a 3 touchdown barrage in the second period put the game out of reach. Dennis Mayer scored 3 touchdowns on runs of 3 and 16 yards and a 13-yard pass from K. J. Dickmann. Dickmann also hit Jack Greuel with scoring strikes of 41 and 2 yards as he completed 7 of 11 passes for 91 yards.

Kewaskum's only touchdown came on a 9-yard burst by reserve Scott Stoltzmann with only 1:54 left on the clock in the last quarter, which prevented a shutout, as New Holstein was using their second string players for much of the third and fourth periods.

The Huskies, big in height as well as weight, played very well and the Indians did not. New Holstein's strong team lost in a double overtime thriller the week before to Sheboygan Falls' No. 1 ranked team in Division III, 35-28.

In the first quarter it appeared the game might be close at the teams traded five offensive opportunities with just one first down. Then Mayer and Bob Lautenschlaeger took turns carrying the ball inside the Indians' 30 yard line. A Kewaskum face mask penalty moved the ball closer to the goal and after a 12 yard completion to 6-4 Wade Turner, Mayer scored his first of 3 TDs from the 3 yard line.

After 3 offensive plays Kewaskum had to give the ball back to the Huskies and then the trouble started. Mayer took

Brian Larsen's punt on the Indians' 40 and 3 plays later Mayer scampered 15 yards for a score.

The Indians, who had just 8 yards rushing in the entire first half, couldn't get a drive going in their next 2 possessions and Holstein got the ball again 5 minutes before halftime. They scored again this time on a 4-play, 55 yard drive with Greuel taking a 43 yard pass from Dickmann. Soph Lautenschlaeger then put the game on ice with a 65 yard punt return with 1:08 left, leaving many would-be Indian tacklers in his wake.

Kewaskum came back with some zip in the second but their offense bogged down again. New Holstein got its final 6 points in the third quarter after moving 50 yards with Mayer taking a pass from Dickmann for the final 10 yards.

The Indians' lone drive in the closing minutes covered 78 yards. Stoltzmann sparked the drive with 48 yards in 4 carries.

Things may not get any easier this Friday when Kewaskum travels to Chilton. Chilton won last week over Plymouth, the team that beat Kewaskum, 20-8, in their opener.
