### Board Accepts River Bend CATV Proposal

## Village Water Rate Hike Approved

At Monday's meeting, Commissioner Bill Martin informed the Village Board that approval had been granted by the Public Service Commission allowing Kewaskum to increase their water rates.

Martin stated the increased rates cannot go into effect until published in the media and approval is given by the board. Rates can go into effect after publication, but Martin suggested that they begin using the new rates at the start of the next quarter April 1. Starting in mid-quarter might cause some confusion as the rates would then have to be pro-rated.

Kewaskum water rates will increase 33% for small residential customers, 32% for

average residential, 31% commercial, 22% public authority, 20% for large commercial users, 25% industrial, 32% large industrial and 53% public fire protection (annual charge).

Martin noted Kewaskum's last increase was in 1977. The PSC suggested from here on, Kewaskum apply annually for rate increases as this is becoming the general procedure throughout the state. In this manner rates would not increase so drastically. President Gerald Stollenwerk went on record saying he was for annual application to the PSC.

Martin stated Dr. Raymond Kipp represents Kewaskum at the PSC and has done an excellent job in handling the village's applications. Kipp is also President of the Milwaukee Public Sewerage Commission.

In other action, on recommendation of the Cable TV Committee, the board approved the proposal of River Bend Cablevision to supply cable TV

Police Chief Donald Hlavaty stated Tuesday morning that six juvenile males have been apprehended in connection with the December 21 break-in at Rosenheimer's Grocery and Department Store.

## School Energy Study Apparently Dead

For lack of a second, a motion by Board Member Gerald Secor to approve an energy study contract with Bray & Associates died Monday.

At December's meeting, Bray representative, Walter Lau, had presented his company's proposal for an energy conservation study covering the Kewaskum High and Elementary Schools. Half of the initial \$9,000.00 cost would have been paid by matching federal government funds. However, two board members, Jean Goeden and Richard Thuesch, felt the district itself could accomplish quite a few of the projects with the \$9,000.00 that would have been paid for the study.

Thuesch recommended a committee be set up for further study. Secor told Thuesch the district would only have had to pay \$4,500.00, but Thuesch countered that the \$9,000.00 would come from the taxpayers no matter which way you looked at it.

Citizens in the audience again mentioned an idea that had

been brought up at December's meeting. That of having utilities or state inspectors help with such a study. School Superintendent Floyd Brenholt explained state inspectors do not make recommendations. School Board President John Tessar said he had not received a good answer as to why the utilities could not do the work when he had first brought up the question.

The board's biggest concern was the additional engineering costs that would be involved later and the fact that only 20% of the requested energy projects for schools had been approved.

Business Manager Bob Borch and Brenholt were in favor of the study because a "payback schedule" would be included which would show how projects would eventually pay for themselves in the long run through energy savings.

After some discussion, Tessar said he would bring the energy study question up again at February's meeting.

The board took no definite action on the Athletic Activities program, but will review it at a future meeting.

## Fund Goal Set At \$4,500,000

This year the Catholic Stewardship Appeal will seek \$4,500,000 in funds in order to meet at least the minimum needs of the Archdiocese of Milwaukee.

Archbishop Rembert G. Weakland announced the goal this week. The 1981 appeal will be from March 1 to March 31. It is the major source of income for the services offered by the agencies and offices of the archdiocese to parishes and individuals.

This goal represents only a 7% increase over last year's \$4,200,000 figure. The 1980 campaign raised \$4,275,651 in pledges and has already received \$4,178,852 in cash pay-

ments.

Archbishop Weakland pointed out that the 1981 goal does not reflect the inflation rate which has severely affected the budgets of the various departments. "We hope that we will be able to surpass this \$4,500,000 goal so that important services to the people of the archdiocese will not have to be curtailed," he said.

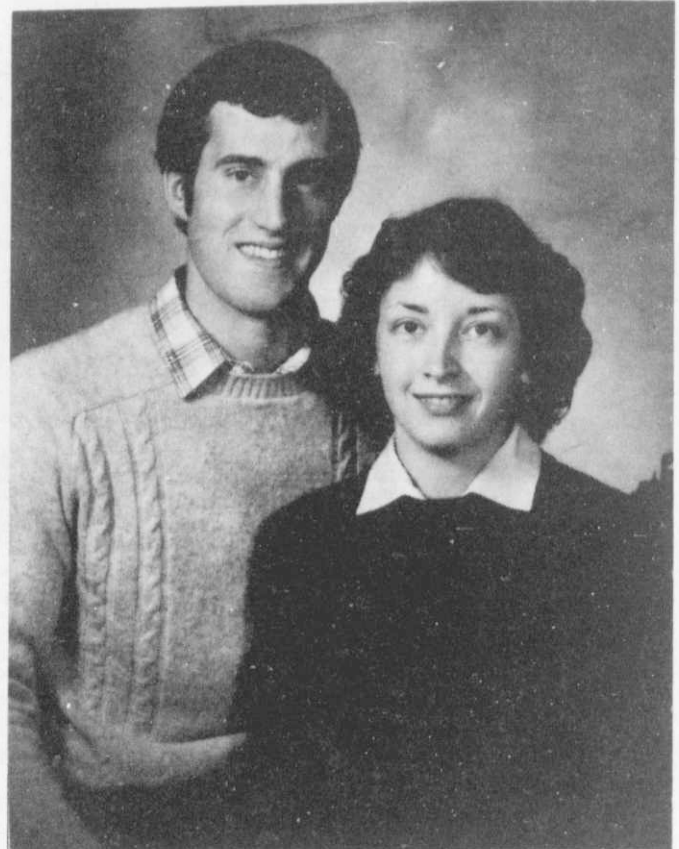
Following the ceremony, a dinner reception and dance was held at Old Fort Silver, Silver Creek where guests were entertained by Normie Dogs and His Musical Lads.

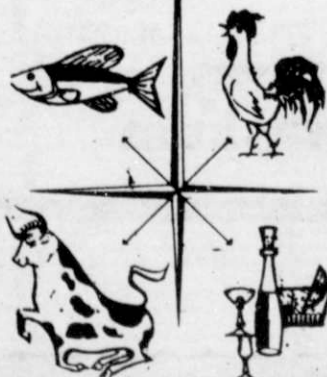

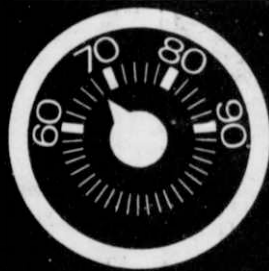

## Interest Paid to Savers Increases 23.3% at West Bend Savings and Loan

West Bend Savings and Loan Association announced year-end 1980 results Friday. Richard A. Larson, association president, indicated that 1980's operating results were a combination of both good news and bad news. In view of the unusual economic conditions of 1980, the drastic fluctuations in interest rates throughout the year, and the unique and unusual challenges during the year, West Bend Savings fared better than most thrift organizations.

Interest paid to savers on their insured savings accounts and certificates increased 23.3% over 1979 to a new record total of \$6,097,081 which was over 1 1/2 million dollars more than the previous year. On the other hand, interest income earned on mortgage loans increased only 14% over the previous year to just under 7 million dollars. Larson said that despite higher interest rates and despite the fact that the association had adjusted older existing loans upwards during the year, the dramatic increase in the cost of money paid to savers who were transferring into the new higher yielding accounts and depositing new funds in the popular high rate money market certificates, far outstripped the more gradual increase in interest income on loans.

The association earnings decreased 42% compared to 1979.

Larson said, and while West Bend Savings earnings of 7.2% on net worth was above the industry average and above the national average, it was a substantial decrease and reflected the unusual economic conditions of the country.

Larson said the association is optimistic about 1981. Interest rates will probably stay in a high range and in fact, the association is projecting a 27% increase in savings costs for 1981 or almost 4% higher than the current year. However, a number of new customer services including interest bearing checking accounts, VISA and Master Card services, TYME Card service and broadened consumer lending, will increase the association's customer base and profit potential.

The association's lending outlook is optimistic and with the development of several new mortgage programs, the association expects to increase mortgage lending in 1981 by over 100%. Larson said that the overall financial market is entering a new era with much greater competition and a need for more services. West Bend Savings expects to be a vital and growing part of that market.

Within a year Cable TV will be in many West Bend homes. We don't interfere with a homeowner's right to have it, but we have a right to inform the public that obscenity is increasing on ordinary television as well as Cable TV, and that the U.S. Supreme Court left it up to the people in every community, including those in West Bend, to decide how much obscenity they will tolerate.

The recent revelation in the West Bend News about sexual attitudes and sexual conduct of high school students should have opened a lot of eyes, but public tolerance still continues. The costs and anguish of immorality are staggering and senseless.

Seventy-seven percent of the public are SILENTLY opposed to obscenity, but only 1% or 2% stand up PUBLICLY and say so. That's why obscenity and sex crimes continue to increase almost daily.

We are proud of our efforts to substantially reduce the number of porno outlets in West Bend, but if public tolerance continues we may not be able to control another invasion. We invite and implore other organizations, especially churches and church-affiliated groups, to

mobilize against crime-inciting obscenity. We owe it to God and our children to bring back decency and moral sanity.

## Wisconsin NFO Board of Directors Holds January Meeting

The Wisconsin National Farmers Organization's board of directors held its January meeting at the Mead Inn in Wisconsin Rapids. New members of the board are Arthur Wedig, Cuba City, who is also a new member of the National Board of Directors; 6th district President Herbert Popp Jr., Chilton and 9th district President Michael Strauss, Belgium.

President Steve Pavich, Mason, said that the increase in membership and participation in the commodity programs was very substantial during the past year and that prospects for 1981 looked even better. Pavich listed some of the organization's statewide priorities for the coming year which included the development of more farmer muscle in the marketplace, preservation of the individually owned and operated farm and the protection of the Wisconsin Corporate Farm Act. He noted that in 1980 Wisconsin experienced virtually no drop in the number of farms and board members agreed that the Wisconsin law governing corporate activity in agricultural production had been instrumental in avoiding the trend toward corporate and vertically integrated farming. Pavich said that there had been attempts to circumvent the law and that all farm organizations had better be united in efforts to prevent changes in it. Legislative Director, John Gasser, said that Assembly Bill 342 which was passed last session would probably be introduced again in an effort to get around the act.

In other actions the board reaffirmed organizational policy in regard to the federal price support system for dairy products. It includes retention of

the current 80% dairy support price, backs the proposal to limit casein imports and asks that the buy back price for dairy products in CCC storage be raised to 118% of the purchase price, up from the 105% figure at the present time. The policy statement notes that the 105% figure actually encourages processors to use the CCC for storage purposes and that the public is led to believe that the purchase price is the net cost to the taxpayer and that little or nothing is mentioned about the product bought by industry or by non-commercial agencies. Vice President Henry Krueger, Denmark, suggested that efforts be made to fully inform the public as to the real cost and the ultimate disposition of product.

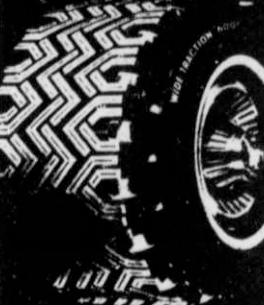

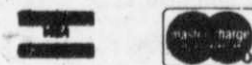

## Kewaskum Graduate Competing in Cross-Country Ski Races in Europe

Dennis Vetter, of Ashland, son of Mr. and Mrs. Leland Vetter, Route 1, Kewaskum, is an avid runner and cross country skier, who said that these sports have become a natural part of his life.

He runs in road races and marathons and competes in cross-country ski races. Dennis sticks to his training program.

Between running and cross country skiing, he averages 1500 to 2000 miles a year. In competition he usually sets a certain time as a goal and endeavors to achieve it. Improving his performance is important to him.

Dennis has been using roller skis for training and conditioning purposes when there is no snow. His ski shoes lock into a special binding on the skis. He explained that roller skis cannot be used on snow or ice because the wheels slip.

These skis simulate dry land cross country skiing. "They work basically the same way as cross country skis," said Dennis. "I use ski poles with special carbide tips."

Dennis said in the beginning it was a matter of learning how to keep the roller skis in a straight line in the direction he was skiing while going fast. He has built up his speed with them, now averaging about six minutes per 1500 meters.

Part of his training has involved running for five miles in the morning, and roller skiing 10 to 15 miles in the afternoon. Some of the roller skiing has been going up the hill by the White River Dam.

Many skiers in this country, including Olympic skiers, use roller skis in the summer as part of their training. Roller skis are also very common in Europe.

In competition, Dennis uses lightweight, narrow, cross country racing skis. On January 15, he left for Europe to compete in three cross country races in the World Loppet. There are a total of 10 races in this ski series.

The World Loppet is two years old, and serves as the "Olympics" for the citizen skier. It was established for two reasons:

1. To give the citizen skier anywhere in the world a chance to compete on an international level against similar skiers - each one seeking to complete all World Loppet races sometime in his or her lifetime and earn the World Loppet medallion.

2. To give the world's outstanding international class racers an alternative to standard international competitions - especially when retiring from active national team racing.

Dennis related that the World Loppet concept was first introduced on February 24, 1978, in a meeting at Mount Telemark, Cable, with officials present from a number of countries.

It was officially formed on June 10, 1978 in Uppsala, Sweden, "to honor the dedication and enthusiasm of a unique

breed of athlete - the citizen skier."

On January 18, Dennis competed in the 60 kilometer Dolomitenlauf Race in Lienz, Austria. On January 25, he will be in the 70 km Marcialonga Race in Moena-Cavalese, Italy; and on February 1, he will be in Oberammergau, West Germany, competing in the 90 km Konig Ludwig Lauf Race.

Dennis said that each race in each country has its own distinct type of medallion for finishers. Also, there is a special passport for the World Loppet in which markings include the official seal of each race and the position in which a participant finishes.
