## Two Kewaskum High School Girls, Both 16, Die of Crash Injuries

Two 16-year old Kewaskum girls, both juniors at Kewaskum High School, died over the weekend as a result of injuries they sustained in a one-car auto accident in the Town of Auburn, Fond du Lac County, about four miles north of Kewaskum.

Sue Ann Mrstik and Tracy L. Neitzel, both 16, died after the car in which they were riding skidded off U.S. Highway 45 shortly before 10 p.m. and struck a power pole seven-tenths of a mile south of County Trunk Y, according to the Fond du Lac County Sheriff's Department.

Mrstik of 9202 Mill Road, Kewaskum, was dead on arrival at St. Agnes Hospital, Fond du Lac. She sustained severe head

and neck injuries. Miss Mrstik was thrown from the auto.

Miss Neitzel of 1310 River-view Drive, Kewaskum, was taken to St. Agnes Hospital with two broken legs, according to the accident report. She was initially admitted to an orthopedic section of the hospital and later transferred to intensive care, where she died at 6:10 p.m. Sunday of complications resulting from the accident.

The driver of the northbound car was Martin H. Tackes, 18, of 9242 N. Mill Road, Kewaskum. He suffered lacerations and fractures to his left ankle and knee, and possible internal injuries. He was ticketed by Fond du Lac sheriff's deputies.

Another passenger, Todd M. Stern, 15, of 817 Pleasantwood Drive, Kewaskum, suffered a broken right leg. He was listed in stable condition at St. Agnes Hospital, where both were taken.

According to the Fond du Lac County Sheriff's Department report, the accident occurred when Tackes' car passed a car which had just passed another car before Tackes attempted to pass it. While passing, Tackes lost control of his car, which skidded off the roadway and struck a power pole roadside with the passenger's side be-

fore spinning around and coming to rest.

The accident report did not indicate who was driving the other two cars.

The four were taken to the hospital by Campbellsport and Kewaskum rescue squad ambulances.

Miss Mrstik and Miss Neitzel became Fond du Lac County's third and fourth traffic fatalities of 1981.

## Plan Commission Evaluates TIF Project List Selections

The Kewaskum Plan Commission Tuesday evening reviewed its TIF "Proposed Projects List" in an effort to align its priorities with an eye on importance and need as well as cost.

The Preliminary list of 21 projects was developed over several meetings through the joint efforts of the Plan Commission and the Village Board. Tuesday's meeting resulted in

selection of eight major projects which the commission feels would best benefit and improve the village.

Highest on the priority list is the extension of Regal Drive approximately 3,000 feet north, which would include portions of old Fond du Lac Road. A price tag of \$754,000.00 covers black-top, curbing, hydrants, culverts and signs.

The second project would be connection of a new waterline from Milan Drive to Roseland

## Tuesday Is Election Day

Tuesday, April 7, is Spring Election Day in the State of Wisconsin.

Locally, voters will cast their ballots for school board members, village and township officials, State Superintendent of Public Instruction and five referendum questions.

Five candidates are vying for the three Kewaskum School District positions as School Board Members to succeed incumbents Dr. Charles Ogi,

James Oelhafen and Jean E. Goeden. Goeden is seeking re-election, while Oelhafen and Ogi are not candidates, although there is a write-in campaign being conducted for Ogi. Other candidates are newcomers Thomas John Brigham, Richard David Schlice and Ralph Horner, together with Margaret McFadden, who is making her third attempt for a school board seat.

## Local Residents Share in National Shock of Assassination Attempt

As the country recovers from the national shock of Monday's attempt on the life of President Reagan, local residents share their feelings and views on the shooting.

Mrs. Helen Horwitz, a housewife and senior citizen, commented "I think it's nuts. They're talking about gun control and after this shooting is over, they've got all kinds of excuses for not taking care of

it." Reverend Darrell Joiner, pastor of Peace Church, stated "I was very distressed. It reminded me of when my wife and I were living in California and we heard that afternoon that Kennedy had been shot. I have always been somewhat against gun control, but I think they should keep guns out of the hands of kooks. It has made me seriously reconsider my thoughts of gun control, especially handguns. Let me say, however, our first thoughts

were, all those who had been shot had our prayers and we still pray for them."

A Kewaskum dairy farmer who wished to remain anonymous said, "I hope he thinks about the dairy support, how easy it is to be killed. You don't have to be physically killed with a bullet. His signing the dairy bill can, and probably will kill, financially, a lot of dairy farmers."

Dan Schmidt, Village Administrator's comments were:

"I feel the same as everyone else. It sort of corks you. I think they should string him up and hang him. I don't think gun control would have prevented it. I think people should be punished for their crimes."

Ron Reigle, Executive Vice-President, Regal Ware, seemed to sum it up in his statement. "It's an absolute tragedy that the President can be gunned down in the Nation's Capitol and on national television, a real tragedy."

### Student Government's 4th Annual Carnival at High School Friday

Ping pong, tug-of-war, volleyball, pie throwing, arm wrestling, H-O-R-S-E, and eating contests will highlight the Kewaskum High School Student Government's fourth annual carnival Friday, April 3, at the high school.

Following the carnival, the pom-pon squad will be sponsoring a dance from 7 to 10 p.m. featuring live music by the KHS Jazz Band and Swing Choir. Senior Katie Lightner will serve as disc jockey, playing records during the band's and choir's breaks. Cost for the dance is \$1 per person.

To the Editor:

I was one of the many people who attended the Kewaskum School Board meeting of Monday, February 23, 1981. It was at this meeting that each committee member had separate suggestions concerning staffing changes that were to be acted on. I presume this was the same meeting Mr. Theusch discussed at the Wayne Town Board meeting, in which Mr. Theusch (according to the West Bend News of Mar. 24), stressed "other school board members were at a disadvantage when the personnel cuts were to be acted upon because it was the first time some of them had heard some of Ogi's ideas."

How can this be so? A flyer with the committee's ideas was sent along with the published agenda. Dr. Ogi's 8 suggestions were on that flyer along with the other committee members. This flyer was sent from the district office Feb. 13, 1981. The meeting of Feb. 18 was published in

the Kewaskum Statesman of Feb. 20, and that had the list of recommendations also.

At this time I would like to be able to express my opinion on these suggestions. Concerning No. 4 of Dr. Ogi's suggestions: "Cut athletic program to 6 for boys and 6 for girls, etc." Why not eliminate it altogether? You will save on bus fees, insurance fees, coaching, uniforms, referee fees, official referees and the cost of maintaining playing areas, (heat, lights, etc.) I have read in a magazine and heard it talked about on T.V., that where football is concerned high school boys are really not grown mature enough in body to go through the rigors of football without injury of some kind. I know this could be called a "sacred cow" but maybe it has to be the "sacrificial lamb" for everyone's benefit. As far as these competitive sports are concerned, I personally feel that there is just too much going on at the high school level. Some parents don't get to see their youngsters until Sat. and sometimes Sun. because of the time demanded at school. As far as their religious instructions are concerned it seems the school cares less. The youngsters are encouraged to have no time for God and family. And besides, if these activities were curtailed the teacher/coaches could have more time for their families too.

No. 1 of Dr. Ogi's suggestions: "Eliminate business manager, etc." I can not go along with the school board's way of thinking. Mr. Brenholt claims he has saved the taxpayers money by not having one before when the enrollment was at its peak; since the enrollment is declining and he has that expensive computer, why does he need this business manager now, especially since he himself received an enormous raise in pay earlier this year?

As for No. 2 of Dr. Ogi's suggestions: "Eliminate elementary guidance," I would not, if the person in that position was performing his duties in the right capacity.

Dr. Ogi's suggestion No. 5: "Drop separate freshmen teams, etc." would be taken care of if you eliminate the athletic program as I suggested previously.

Number 6 of Dr. Ogi's suggestions "Cut one teacher aide." If a teacher aide is needed, I would not eliminate it. What does one aide cost compared to the other costs? Maybe we have some interested parents who are eager to donate their services in that capacity, then we wouldn't need any paid aides at all.

Dr. Ogi's suggestion: "Eliminate 2 special ed positions," these will have to stay until something better comes along. Wasteful spending in these areas could be checked out and put to more useful and fruitful purposes.

I would not eliminate phy ed as suggestion No. 7 recommends, although it would not

have to be so demanding and so competitive.

I agree with number 8 of Dr. Ogi's suggestion: "Eliminate one secretary position." Two at the high school would be sufficient. Students in the secretarial course could help out in that area as part of their instruction. How else can they gain experience?

As for Richard Theusch's suggestions: "Tentatively eliminate one additional elementary position, etc." What would it cost to keep Beechwood open? Total figure per year and per child? What does it cost likewise at the other area elementary schools? What would be the maintenance cost if the school was closed? I'd like to see the figures in print. Although I am in favor of the "neighborhood school" could these youngsters attend closer school in other districts?

Are there closer schools in other districts? If this were possible maybe these parents would prefer it. Then we'd have no bus expense to worry about either.


Mr. Theusch's second recommendation: "Eliminate assistant principal at the high school" should have been explained more thoroughly. If anyone else other than Mr. Esser had held that position, it would have been eliminated.

When one says, "make no further staff changes" I suggest they go into the area schools, look around, ask questions, talk to the students, parents, teachers. Find the wasteful spending and do something about it, IT IS THERE! A citizens Advisory Committee could have been useful in that capacity.

I, myself, do not see the need for a separate reading class at the seventh and eighth grade levels. Reading and English went together before, why not now? If any student needs help in reading, there is a program for that.

I also feel personally that eighth grade industrial arts and home ec. is a "frill." Many of these youngsters have more of this training before they even enter 8th grade, through 4-H, Boy Scouts, and Girl Scouts. If they haven't had some training in this area, it is offered at the high school. I'd like to see this time utilized in more academic

Drive, forming a loop. Preliminary figures show a cost of \$103,150.00 for this construction.

Construction of Well No. 3, with watertower, pumphouse and equipment on the south side of the village is projected to cost approximately \$615,000.00.

Remodeling and an addition to the Municipal Building and Library has a projected cost of \$172,350.00.

Three interceptor sewers located at Knights Avenue, Regal Drive and Main Street, plus required manholes are anticipated to cost approximately \$367,100.00.

Development of Fond du Lac Avenue south, including storm sewer, curb, sidewalk, and parking lane would run \$56,392.00 per side, or a total of \$112,784.00 if work is done on both the east and west sides of the road.

Highway 'H' west development would run approximately \$73,817.00.

Development of a Main Street or downtown parking lot has three price tags. Final costs would depend on which plan was adopted. Purchasing one parcel of land providing 20 stalls would cost approximately \$80,000.00, two parcels for 45 stalls, \$150,000.00 or purchase of one parcel in conjunction with seven land easements would provide a 75 stall lot for \$100,000.00.

The above projects would result in a Tax Incremental Financing program of approximately \$2,400,000.00. Village President Gerald Stollenwerk noted "these are intended to be ballpark figures to work with. The purpose of putting price tags on these projects is to allow the Commission and Village Board to see just what expenditures are within the abilities and resources of the village.

Village Administrator Dan Schmidt also provided construction figures for several other projects whose priorities rated them lower on the project list. Commission member Charles Miller felt, however, for the present the eight top items be considered the cut-off point for recommendations as far as the TIF Feasibility Report goes.

The proposed projects are strictly that. They are items which the commission would like to see accomplished throughout the use of TIF

funds. This does not mean every project will be done or is it being considered for the near future. These projects would, if TIF is adopted, be developed over an extended period of several years, and then not all may be accomplished.

The commission is keeping in mind an earlier comment regarding the TIF program. It is easy to drop an item or project, but almost impossible to add a project once the program goes into effect.

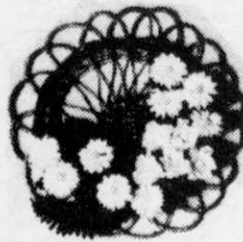

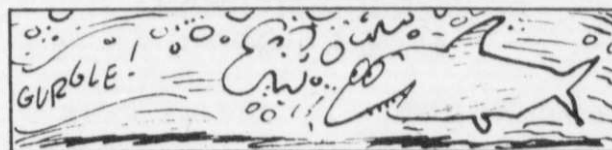

NOTICE OF REFERENDUM ELECTION APRIL 7, 1981

NOTICE IS HEREBY GIVEN, that at an election to be held in the several towns, wards, villages and election districts of the State of Wisconsin, on the first Tuesday of April, A. D., 1981, being the Seventh day of said month, the following proposed amendments to the Constitution of the State of Wisconsin, having been approved by two successive legislatures, will be submitted to a vote of the people pursuant to law:

1981 Senate Joint Resolution 2 Deposited February 20, 1981 Published March 3, 1981

ENROLLED JOINT RESOLUTION 6

To amend section 12 of article XIII, and to create section 12(4) (a) to (c) of article XIII of the constitution, relating to primaries in recall elections (2nd consideration).

Whereas, the 1979 legislature in regular session proposed an amendment to the constitution by 1979 Senate Joint Resolution 5 (Enrolled Joint Resolution 41) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION : 1. Section 12 of article XIII of the constitution is amended to read:

[Article XIII] Section 12. The qualified electors of the state or of any county or of any congressional, judicial or legislative district or of any county may petition for the recall of any incumbent elective officer after the first year of the term for which he the incumbent was elected, by filing a petition with the filing officer with whom the petition for nomination petition to such the office in the primary election is filed, demanding the recall of such officer the incumbent. Such

(1) The recall petition shall be signed by electors equal in number to equaling at least twenty-five per cent percent of the vote cast for the office of governor at the last preceding election, in the state, county or district from which such officer is to be recalled the incumbent represents.

(2) The filing officer with whom such the recall petition is filed shall call a special recall election to be held not less than forty nor more than forty-five days from for the Tuesday of the sixth week after the date of filing of such the petition or, if that Tuesday is a legal holiday, on the first day after that Tuesday which is not a legal holiday.

(3) The officers against whom such petition has been filed incumbent shall continue to perform the duties of his the office until the result of such special recall election shall have been results are officially declared.

(4) Unless the incumbent declines within 10 days after the filing of the petition, the incumbent shall without filing be deemed to have filed for the recall election. Other candidates may file for such the office may be nominated in the manner as is provided by law in primary elections for special elections.

(5) The candidate person who shall receive receives the highest number of votes in the recall election shall be deemed elected for the remainder of the term. The name of the candidate against whom the recall petition is filed shall go on the ticket unless he renounces within ten days after the filing of the petition.

(6) After one such petition and special recall election, no further recall petition shall be filed against the same officer during the term for which he was elected.

(7) this article section shall be self-executing and all of its provisions shall be treated as mandatory. Laws may be enacted to facilitate its operation, but no law shall be enacted to hamper, restrict or impair the right of recall.

SECTION : 2. Section 12(4) (a) to (c) of article XIII of the constitution are created to read:

[Article XIII] Section 12 (4) For the purpose of conducting elections under this section:

(a) When more than 2 persons compete for a nonpartisan office, a recall primary shall be held. The 2 persons receiving the highest number of votes in the recall primary shall be the 2 candidates in the recall election, except that if any candidate receives a majority of the total number of votes cast in the recall primary, that candidate shall assume the office for the remainder of the term and a recall election shall not be held.

(b) For any partisan office, a recall primary shall be held for each political party which is by law entitled to a separate ballot and from which more than one candidate competes for the party's nomination in the recall election. The person receiving the highest number of votes in the recall primary for each political party shall be that party's candidate in the recall election. Independent candidates and candidates representing political parties not entitled by law to a separate ballot shall be shown on the ballot for the recall election only.

(c) When a recall primary is required, the date specified under sub.(2) shall be the date of the recall primary and the recall election shall be held on the Tuesday of the 4th week after the recall primary or, if that Tuesday is a legal holiday, on the first day after that Tuesday which is not a legal holiday.

Now, therefore, be it resolved by the senate, the assembly concurring, That the foregoing amendment to the constitution is agreed to by the 1981 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday of April, 1981; and, be it further

Resolved, That the question concerning ratification of the foregoing amendment be stated on the ballot as follows:

"Primaries in recall elections. Shall section 12 of article XIII of the constitution be amended to authorize and require that a separate primary and election be held for the recall of any state, congressional, judicial, legislative or county official whenever more than one person is a candidate for a political party nomination for a partisan office, or whenever more than 2 persons are candidates for a nonpartisan office, unless one of those persons receives a majority of the votes cast at the primary?"

EXPLANATION

Effect of ratification.

Under present provisions of the Wisconsin Constitution, elective officers of any county, congressional, judicial or legislative district may be subject to removal by a recall election upon the filing of a proper petition. There is, however, no provision for a subsequent primary election. Thus, the winner of such an election where there were three or more candidates could be one who received less than a majority of the votes.

As to nonpartisan office, the proposed amendment would require a recall primary election when three or more candidates compete. The two candidates receiving the highest number of votes would be the candidates in the recall election except that if any candidate should receive a majority of the votes in the primary, that candidate would assume the office for the remainder of the term. As to

partisan office, the proposed amendment provides for a recall primary for each political party entitled to a separate ballot for which more than one candidate competes for the nomination.

The amendment further provides for the dates of the primary and recall election and clarifies the text of other provisions dealing with recall.

1981 Senate Joint Resolution 5 Deposited February 20, 1981 Published March 3, 1981

ENROLLED JOINT RESOLUTION 7

To amend section 3 of article XI of the constitution, relating to indebtedness for sewerage collection or treatment systems in counties, cities or sewerage districts over 150,000 population (2nd consideration).

Whereas, the 1979 legislature in regular session proposed an amendment to the constitution by 1979 Senate Joint Resolution 28 (Enrolled Joint Resolution 43) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION 1: Section 3 of article XI of the constitution is amended to read:

[Article XI] Section 3. (1) Cities and village organized pursuant to state law ~~are authorized~~ may determine their local affairs and government, subject only to this constitution and to such enactments of the legislature of ~~state-wide~~ statewide concern as ~~shall~~ with uniformity shall affect every city or every village. The method of such determination shall be prescribed by the legislature.

(2) No county, city, town, village, school district, sewerage district or other municipal corporation may become indebted in an amount that exceeds an allowable percentage of the taxable property located therein equalized for state purposes as provided by the legislature. In all cases the allowable percentage shall be ~~five per centum~~ 5 percent except as follows specified in parts (a) and (b):

(a) For any city authorized to issue bonds for school purposes, an additional ~~ten per centum~~ 10 percent shall be permitted for school purposes only, and in such cases the territory attached to the city for school purposes shall be included in the total taxable property supporting the bonds issued for school purposes.

(b) For any school district which offers no less than grades one to ~~twelve~~ 12 and which at the time of incurring such debt is eligible for the highest level of school aids, ~~ten per centum~~ 10 percent shall be permitted.

(3) Any county, city, town, village, school district, sewerage district or other municipal corporation incurring any indebtedness ~~as of record~~, under sub. (2) shall, before or at the time of doing so, provide for the collection of a direct annual tax sufficient to pay the interest on such debt as it falls due and also to pay and discharge the principal thereof within ~~twenty~~ 20 years from the time of contracting the same; ~~except that when such~~

(4) When indebtedness under sub. (2) is incurred in the acquisition of lands by cities, or by counties or sewerage districts having a population of ~~one hundred fifty thousand~~ 150,000 or over, for public, municipal purposes, or for the permanent improvement thereof, or to purchase, acquire, construct, extend, add to or improve a sewerage collection or treatment system which services all or part of such city or county, the city or, county or sewerage district incurring the ~~same~~ indebtedness shall, before or at the time of doing so, provide for the collection of a direct annual tax sufficient to pay the interest on such debt as it falls due, and also to pay discharge the principal thereof within a period not exceeding ~~fifty~~ 50 years from the time of contracting the same.

(5) an indebtedness created for the purpose of purchasing, acquiring, leasing, constructing, extending, adding to, improving, conducting, controlling, operating or managing a public utility of a town, village, city or special district, and secured solely by the property or income of such public utility, and whereby no municipal liability is created, shall not be considered an indebtedness of such town, village, city or special district, and shall not be included in arriving at ~~such~~ the debt limitation under sub. (2).

Now, therefore, be it resolved by the senate, the assembly concurring, That the foregoing amendment to the constitution is agreed to by the 1981 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday of April, 1981; and, be it further

Resolved, That the question concerning ratification be stated on the ballot as follows:

"Metropolitan sewerage debt. Shall section 3 of article XI of the constitution be amended so that sewerage districts and counties over 150,000 population, and all cities, issuing bonds for sewerage collection and treatment systems may retire such indebtedness within 50 years rather than the present limit of 20 years?"

EXPLANATION

Effect of ratification.

Article XI, section 3, of the Wisconsin Constitution, presently establishes a debt limit for counties, cities, villages, school districts and other municipal corporations. It also limits the debt repayment period of 20 years except that debts incurred for the acquisition or permanent improvement of lands by cities or counties having a population of 150,000 or more has a 50-year limit.

This proposed amendment would extend the application of the permissible 50-year debt repayment period to sewerage districts with a population of 150,000 or more and would enlarge the debt purposes to which the 50-year limit would apply to include the purchase, acquisition, construction, extension, adding to or improving a sewerage collection or treatment system.

1981 Assembly Joint Resolution 5 Deposited February 20, 1981 Published March 3, 1981

ENROLLED JOINT RESOLUTION 8

To amend section 8 of article I of the constitution, relating to revising the right to bail and authorizing the legislature to permit circuit courts to deny release on bail for a limited period to certain accused persons (2nd consideration).

Whereas, the 1979 legislature in its June 1980 special session proposed an amendment to the constitution by Assembly Joint Resolution 9 of the June 1980 Special Session (Enrolled Joint Resolution 76) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION 1: Section 8 of article I of the constitution is amended to read:

[Article I] Section 8. (1) No person shall be held to answer for a criminal offense without due process of law, and no person for the same offense shall be put twice in jeopardy of punishment, nor shall be compelled in any criminal case to be a witness himself or herself.

(2) All persons shall before conviction, be ~~eligible by sufficient evidence except for capital offenses when the proof is evident or the presumption great~~ and shall be eligible for release under reasonable conditions designed to assure their appearance in court, protect members of the community from serious bodily harm or prevent the intimidation of witnesses. Monetary conditions of release may be imposed at or after the initial appearance only upon a finding that there is a reasonable basis to believe that the conditions are necessary to assure appearance in court. The legislature may authorize, by law, courts to revoke a person's release for a violation of a condition of release.

(3) The legislature may by law authorize, but may not require, circuit courts to deny release for a period not to exceed 10 days prior to the hearing required under this subsection to a person who is accused of committing a murder punishable by life imprisonment or a sexual assault punishable by a maximum imprisonment of 20 years, or who is accused of committing or attempting to commit a felony involving serious bodily harm to another or the threat of serious bodily harm to another and who has a previous conviction for committing or attempting to commit a felony involving serious bodily harm to another or the threat of serious bodily harm to another. The legislature may authorize by law, but may not require, circuit courts to continue to deny release to those accused persons for an additional period not to exceed 60 days following the hearing required under this subsection, if there is a requirement that there be a finding by the court based on clear and convincing evidence presented at a hearing that the accused committed the felony and a requirement that there be a finding by the court that available conditions of release will not adequately protect members of the community from serious bodily harm or prevent intimidation of witnesses. Any law enacted under this subsection shall be specific, limited and reasonable. In determining the 10-day and 60-day periods, the court shall omit any period of time found by the court to result from a delay caused by the defendant or a continuance granted which was initiated by the defendant.

(4) The privilege of the writ of habeas corpus shall not be suspended unless ~~when~~, in cases of rebellion or invasion, the public safety ~~may require~~ requires it.

Now, therefore, be it resolved by the assembly, the senate concurring, That the foregoing amendment to the constitution is agreed to by the 1981 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of people at the election to be held on the first Tuesday of April, 1981; and, be it further

Resolved, That the question concerning ratification of the foregoing amendment be stated on the ballot as follows:

"Bail and other conditions for release of accused persons. Shall section 8 of article I of the constitution be amended so that the legislature may permit courts to deny or revoke bail for certain accused persons; and so that courts may set conditions, including bail, for the release of accused persons to assure appearance in court, protect members of the community or prevent intimidation of witnesses?"

EXPLANATION

Effect of ratification.

The Wisconsin Constitution presently provides that all persons accused of committing a felony shall, before conviction, be able to be released from custody by providing sufficient financial or other assurances. The only exception is for capital offenses when the evidence strongly indicates that the accused is guilty.

The proposed amendment would permit the Legislature to authorize:

(1) courts to revoke a person's release for violation of a condition of release.

(2) courts to deny release for not to exceed 10 days prior hearing to a person accused of:

(a) committing a murder punishable by life imprisonment or accused of sexual assault punishable by a maximum imprisonment of 20 years, or

(b) accused of committing or attempting a felony involving serious bodily harm or threat of serious bodily harm where such person has a previous conviction for committing or attempting such a felony, and

(3) courts to continue to deny release to accused persons for not over 60 days following the hearing if such legislation requires that there be a finding by the court based on clear and convincing evidence presented at a hearing that the accused committed the felony, and that available conditions of release will not adequately protect members of the community from serious bodily harm or prevent intimidation of witnesses. The proposed amendment would provide that in determining the 10-day or 60-day period, the court omit any time found by the court to have resulted from a delay caused by the defendant or a continuance granted which was initiated by the defendant.

This proposed amendment would provide that all persons accused of committing a felony be eligible for release under reasonable conditions designed to assure their appearance in court, protect members of the community from serious bodily harm or prevent the intimidation of witnesses. It would permit the imposition or monetary conditions on release (bail) only upon a finding by the court that these conditions are necessary to assure appearance in court.

The proposed amendment also clarifies and reorganizes Art I, sec. 8, of the Wisconsin Constitution.

1981 Assembly Joint Resolution 13 Deposited February 20, 1981 Published March 3, 1981

ENROLLED JOINT RESOLUTION 9

To amend sections 1 and 4 of article XI of the constitution, relating to removing obsolete provisions of the constitution regarding corporations and banking (2nd consideration).

Whereas, the 1979 legislature in regular session proposed an amendment to the constitution by 1979 Assembly Joint Resolution 53 (Enrolled Joint Resolution 21) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION : 1. Section 1 and 4 of article XI of the constitution are amended to read:

[Article XI] Section 1. Corporations without banking powers or privileges may be formed under general laws, but shall not be created by special act, except for municipal purposes, ~~and in cases where, in the judgment of the legislature, the objects of the corporation cannot be attained under general laws. All general laws or special acts enacted under the provisions of this section may be altered or repealed by the legislature at any time after their passage.~~

Section 4. The legislature ~~shall have power to~~ may enact a general banking law for the creation of banks, and for the regulation and supervision of the banking business, ~~provided that the vote of two-thirds of all the members elected to each house, to be taken by yeas and nays, be in favor of the passage of such law.~~

Now, therefore, be it resolved by the assembly, the senate concurring, That the foregoing amendment to the constitution is agreed to by the 1981 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday of April, 1981; and, be it further

Resolved, That the questions concerning ratification of the several separable issues contained in the foregoing amendment be stated on the ballot as follows:

QUESTION 1: "Creation of corporations under general law. Shall section 1 of article XI of the constitution be amended to remove an obsolete reference to the creation of corporations by special act of the legislature?"

QUESTION 2: "Enactment of banking laws by regular law. Shall section 4 of article XI of the constitution be amended to remove the requirement that banking laws be passed by the legislature by a two-thirds vote?"

**EXPLANATION**

Effect of ratification:

**QUESTION 1:** The Wisconsin Constitution presently provides a definition of a certain type of corporate legislation that another section of the Constitution prohibits altogether.

The proposed amendment eliminates the narrow definition and prohibits such special corporate legislation, except for cities, completely.

**QUESTION 2:** The Wisconsin Constitution presently provides amendments to the banking law can only be made by a two-thirds vote of each house of the Legislature.

This proposed amendment would remove the two-thirds vote requirement and allow such to be made as any other legislation.

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two ballot clerks must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate for whom to vote.

At a nonpartisan election, the elector shall place a cross or other mark in the square at the right of or depress the button or lever next to the candidate's name for each office for whom he or she intends to vote, or insert or write in the name of his or her choice for a candidate.

On referenda questions, the elector shall make a cross or other mark in the square at the right of or depress the button or lever next to the answer which he or she intends to give.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two ballot clerks or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in making his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is marked, it shall be folded so the inside marks do not show but so that the printed indorsements and ballot clerks' initials on the outside do show. After casting his or her ballot, the elector shall leave the machine or booth, and where paper ballots are used, give his or her name to the inspector in charge of the ballot box, hand the inspector his or her folded ballot to be placed in the ballot box, deposit any unused ballots in the blank ballot box, and shall leave the polling place promptly.

An elector may be assisted by two election officials of different political parties in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to physical disability is unable to cast his or her ballot. Gerald and Ray Van Beek and Gordon Darmody, Town of Wayne; Fred Wilkens, Town of Farmington and Art Ciriacks, Town of Trenton, became new soil and water conservation district cooperators recently. These farmers requested SCS assistance in developing a conservation plan for their farms. These plans include contour strip cropping, grass waterways and terraces. Also, Van Beek brothers and Fred Wilkens plan animal waste management systems which consist of diverting the water above and below the barnyards. Leo Beck and son Dave, Town of Wayne, a cooperator for several years, also plan to lay out about 40 acres of contour strips. All have recognized the seriousness of topsoil loss from their land and the water and costly fertility that goes with it. In addition to planning conservation for cropland, woodland and wildlife, land plans are also being considered on some of the farms.

For an example, the Van Beek brothers plan on planting a 75 foot wide strip of red pine trees on a short hillside, too steep to farm. This plantation will be sandwiched between contour strip cropping above and below.

Soil erosion comes like a thief in the night robbing the farmer of his productive top soil. Farm technology has provided farmers with the best of seed, fertilizer and pesticides to produce top yields. This technology will work for a while until the topsoil is gone. Then even the best seed, fertilizer and pesticides will not help and a point of no return is reached. These inputs are very costly and if low yields result, the margin of profit will suffer. Sheet and rill erosion goes unnoticed sometimes and soil conservation practices help keep the soil, water and fertilizer on the slopes to be used by the crops.

**Multifaceted Program to Combat High Blood Pressure**

WEST BEND — Professional education, public awareness and community service efforts in detecting the prevalence of high blood pressure are features of a 12-county high blood pressure control program being administered through the American Heart Association of Wisconsin during 1981. Program funding comes from a grant by the Wisconsin Department of Health and Social Services, Division of Health.

Two consortia, serving the northeast and southeast regions of Wisconsin, have received \$107,000 and \$120,000 respectively, from January 1, 1981 through December 31, 1981. The Heart Association, serving as fiscal agent for the grants, will collaborate with existing resources in the regions, including Washington County Community Health Nursing Service, in providing free public blood pressure detection services.

High blood pressure is a major health risk factor, and if left uncontrolled can lead to heart attack or stroke. In most cases, it causes no symptoms,

and detection often becomes the first step to controlling it.

The Heart Association, in conjunction with Washington County Community Health Nursing Service, seeks to recruit, train and certify nurse instructors, who in turn would train volunteers in precision blood pressure screening. Free screening for the general public, follow-up for persons identified as having an elevated blood pressure measurement, and continuous public awareness efforts are among other program objectives. Data will also be compiled on the number of persons screened for high blood pressure, and in what ways they have received medical treatment for the condition.

Information about blood pressure screening sites or requirements for volunteers may be obtained by calling Joyce Wujcik, R.N., blood pressure coordinator, at the Washington County Community Health Nursing Service office - 338-4462 - Monday through Friday, between 1:00 and 5:00 p.m.

## 50 Years Ago

April 3, 1931

As the result of a heavy snowstorm Thursday night and Friday night, the month of March came in like a lamb and passed out like a lion. The snow commenced to fall early on Thursday morning, during which time about three inches fell. On Friday, flurries of snow fell until Friday evening when a strong northeasterly wind swept down accompanied by a heavy snow fall covering the ground with a white blanket about nine inches deep by Saturday morning.

Nicholas Rimmel, for sixty years a resident of this village, died here Monday morning within an hour after he was stricken. He was 79 years old. He was at one time in partnership with his brother Math at the blacksmith trade and later, breaking away from that trade, he established a machine shop and was in that business nearly 50 years. Surviving him are four daughters namely: Helen A. and Mary at home; Rose (Mrs. Don Harbeck) and Lorena (Mrs. Louis Bath), of Kewaskum.

The fire department was called out Tuesday evening to put out a fire on the roof of Roman Smith's house. The fire is believed to have started from a spark from the chimney.

The body of a slain infant,

deeply hidden in a culvert was found early Saturday afternoon by John Schneider, Willow Creek farmer. Mr. Schneider saw two men park their car, directly in front of the farm's entrance, and then quickly dispose of the body in the culvert a short distance off. Mr. Schneider hurried to the culvert, unwrapped the package and found the dead child. He immediately called County Coroner Reinders of this village, who took the body to the West Bend Clinic, where Dr. Driessel, on examination reported its skull crushed. Attempts have been made to find the slayers but as yet no new definite developments have been reported.

## 75 Years Ago

April 7, 1906

One hundred and seventy-two votes were cast in the village election last Tuesday. The regular nominated ticket was elected with the exception of Henry Schneider for treasurer, who was defeated by John Marx by seven votes; L. D. Guth for justice was defeated by W. S. Olwein by five votes and

Lay; assessor John Andrea; justice of the peace, W. S. Olwein; constable, Mike A. Johannes Jr.

and Martin Rimmel were appointed a committee to secure a field to play in and to purchase new uniforms.

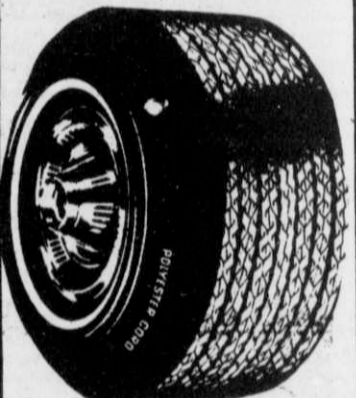

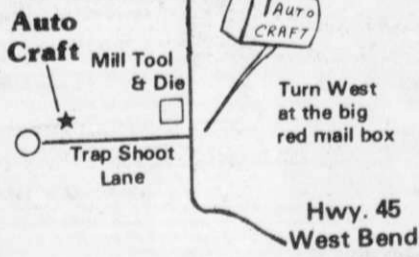
