Primary Polling Places Set

High School Computer Course Gets Green Light

Monday night's school board meeting was highlighted by the unanimous vote of the members to include a high school computer course in the 1982-83 curriculum.

Approximately 25 residents attending the meeting heard the presentation on the proposed program. Mitchell Gebheim spoke in favor of the course, noting Kewaskum should get going on it.

Several area school districts have already implemented some type of computer course within their class program either as part of their science, math or business departments. The meeting was informed that Title IV funds can be used for purchase of the approximately \$8,000 in equipment which would be needed. Principal Clark Pearson said the additional \$10,000 to cover salaries, etc., appeared to be on the high

side and he felt costs would not be quite that great.

Mrs. Joan Rosenberger spoke to the board about the possibility of having a late bus-run reinstated for next year. Mrs. Rosenberger said she would like to see a committee consisting of coaches, parents and school officials set up to look into the problems and possibilities of getting the late bus in operation again or holding extra curricular activities during the last hours.

Parents of children using the late bus this year had purchased passes to cover the cost of the added run.

In other action, Superintendent Brenholt asked the board to consider the possibility of the district going to an "in-house" data processing system, rather than lease these services from the CESA district.

Brenholt stated, "CESA costs to the district are \$25,000 a year." He feels that by having its own equipment to handle

Snow, Cold, Snow, Colder 29 Degrees Below

Ever since the start of the new year this winter has been developing into a worse one than the old fashioned winters they used to talk about. Almost the entire month of January so far has been either snowy or cold. Here is the weather report for the past week.

Thursday it snowed.

Friday it was fairly decent with snow and cold during the daytime but during the night it turned bitterly cold with winds up to 70 miles per hour and drifting snow.

Saturday was extremely cold with temperatures well below the zero mark.

Sunday, for the second deep-freeze weekend in a row, temperatures dropped to a record or near record 29 degrees below zero. The low temperature was two degrees below that of the previous weekend but the wind chill was not as severe. The high winds also caused considerable drifting in the afternoon.

Monday saw snow flurries again in the morning but the temperature got all the way up into the teens.

Tuesday it was cloudy in the morning but sunny in the afternoon with a comparable "heat wave" as the temperature soared all the way up to the high 20's.

Wednesday another storm warning was issued with a forecast of between 1 and 6 inches expected, depending on whether the storm stayed to the south of us or hit headon. The snow was forecast to continue Thursday and Friday.

Floyd Brenholt, superintendent of the Kewaskum Schools, was recently elected to the board of directors of the Wisconsin Association of School District Administrators. He will represent the districts of CESA 16 located in southeastern Wisconsin. Brenholt will complete the term of Robert Kreuser, former superintendent at Muskego - Norway School District. The term expires in June of 1984.

A major purpose of the WASDA is to be sure people understand the needs, problems and achievements of the public schools. It also deals in inservice programs, particularly for administrative staff, and is actively involved in legislative matters. Membership includes chief administrators of local school districts or administrators of CESA districts.

Cable TV Possible by Mid-April

Recommendations for Park Presented to Village Board

At Monday night's meeting, Village President Gerald Stollenwerk presented the board with the latest updated information regarding cable TV in the village.

Stollenwerk stated he had spoken with Bob Schaeffer, of Cablevision, inquiring into the status of Kewaskum's cable TV. Schaeffer said the power company had completed their work, however, the telephone company has to re-arrange some poles. This work will take about ten days. When this work is complete, Cablevision will begin hanging their cable. Anticipated work time on this is projected to be around four to five weeks. CATV will then

begin splicing, followed by running test signals. All this is expected to take another three to five weeks. Stollenwerk noted, weather permitting, all work should be complete by mid-April, at which time village residents will be contacted for home hook-up. Stollenwerk noted Cablevision is still working within its stated contract time.

In other business, Trustee Jeff Rohrer presented recommendations of the Parks and Recreation Committee. Rohrer asked the board to advertise for bids on operation of the concession stand at the Kiwanis Park. Any interested organization can contact the village. Operation will run May through September, Monday through Friday.

Son of Local Woman Seriously Injured in Car-Train Accident

Charles N. Schmitt, 31, of R. 1, Campbellsport, is listed in improved condition at Mercy Medical Center in Oshkosh after his car collided with a Chicago & North Western Railroad train on Haven Drive, 5 miles north of Kewaskum. The accident is believed to have occurred about 11:00 p.m. Wednesday Jan. 13. Schmitt was apparently traveling east when his auto collided with the southbound train.

The Fond du Lac County Sheriff's Department was not notified of the crash until 7:33 a.m., Thursday morning when Eugene Fleischman of Camp-

bellsport, who was on his way home from work about 7 a.m., Thursday, discovered Schmitt pinned in his car. Schmitt was removed from the car by the sheriff's officers and emergency rescue personnel. He was taken to St. Agnes Hospital in Fond du Lac with head injuries and broken ribs and was reported in critical condition at that time. He was transferred to Mercy Medical Center in Oshkosh late Thursday morning. He was in the intensive care unit but has since been taken out of that unit and is improving.

Mr. Schmitt is the son of Rose Schmitt of Kewaskum.

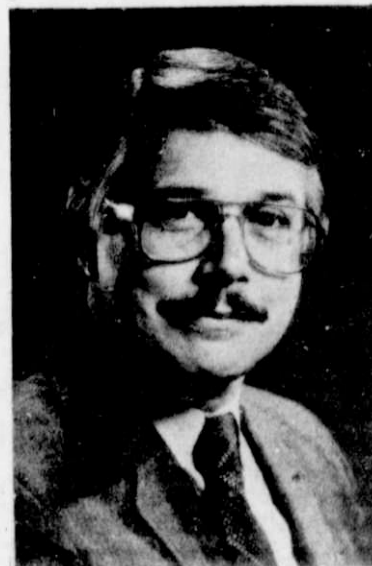
of village employees and officials.

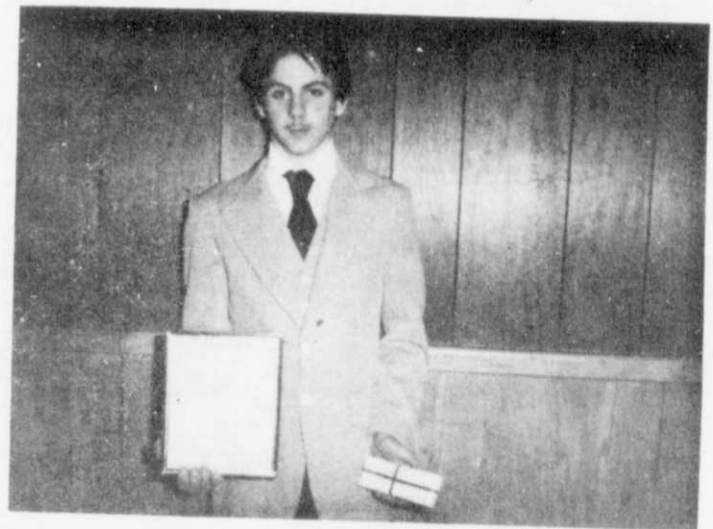

this processing, the district could eventually save \$15,000 a year in processing costs. "CESA will probably tell us we're giving up expertise going this route," said Brenholt. He noted, computer companies contacted said they would work with the district in setting up a system.

The proposed equipment is capable of expansion and the software should last about seven years. Brenholt stated, "there's no doubt over a period of time we'll save money." The district would purchase "canned" programming for much of the needs such as salaries, grading, etc. This means programs would not have to be set up from scratch.

Board member Tom Brigham asked how much this operation would cost. Brenholt said \$70,000 for the hardware (equipment) and software (supplies). Brenholt felt the district could pay \$25,000 the first year (the cost of CESA leasing) and the balance in the second year when the school district would no longer be faced with the large debt retirement payment.

Board member Charles Ogi said, "I'd like to see CESA's statements on why it would be favorable staying with CESA." Business Manager Bob Borch told Dr. Ogi that information would be no problem to obtain since more and more districts are looking into having their own systems and have made this similar request.

Board member Richard Theusch questioned the possibility of used equipment. Mitch Gebheim, who is familiar with computer equipment, was questioned on this aspect. He stated, "yes, used equipment is available, but if you go too far back technology has changed so much that maintenance is greater than the purchase of new equipment."

Brigham said, "if there is a potentiality of saving \$15,000 a year without adding staff, I would like to have them look into it further."

A request by District Reading Specialist George Allmann to apply for Title IV-C funds was approved. Ten grants of \$15,000 each will be awarded for use in the category of computer programs. This money would fund 100% the cost of teachers attending a "computer summer camp" and instructional aids which would "provide teachers with an appreciation of computers and assist them in acquiring some competences in computer programming."

The board unanimously approved seven polling places for

the primary school board election to be held February 16. Polls will be set up in the Towns of Farmington, Kewaskum, Wayne, Ashford, Mitchell, and Barton and in the Village of Kewaskum. Any voter who does not have a polling place in their township may cast their vote at any of the seven specified polls.

A lengthy discussion was held between Town of Wayne resident Carl Holweck and the board regarding use of the Wayne School gym by town residents. Hohlweck stated, "we've asked for years to use the gym for public use. The people in town can use the gyms, the people in our township can't."

Theusch told Hohlweck the gym was open to the public as long as some organization or specific group (PTO, Scouts, FFA, etc.) would be responsible for the gym while it was being used. The gym cannot be open and unsupervised. Private individuals cannot just walk in and shoot a few baskets. Bob Borch stated, "the custodian doesn't have the responsibility to watch what's going on or oversee the use of the gym." Theusch suggested the township form a club, "you can call it Town of Wayne Athletic Club, but somebody would have to be the head or director and be responsible for gym use." Hohlweck said he would pursue this further.

Possible elimination of a track coach position was tabled at the request of board member Jean Goeden who could not attend the meeting. Mrs. Goeden was the board member who had made the recommendation.

Dr. Ogi stated he wanted the board to go on record saying people are free to come here and express themselves as long as they handled themselves as ladies and gentlemen and would be treated as such by the board. Ogi was referring to an incident which occurred at the last meeting.

Jim Schmidt said he was satisfied with Mr. Brenholt's apology. His only feeling was that when he addressed the school board, he expected them to answer his questions rather than have people in administration speak for the board.

One citizen in the audience said bringing up this situation again was like "beating a dead horse," and he hoped the matter was finally closed.

The board then adjourned to closed session.

The committee also asked the board to approve a new fee for week-end tournament use of the concession stand and ball diamonds. Last year's fee was \$25.00 per day for each diamond and \$25.00 per day for the stand, for a total of \$75.00 per day or \$150.00 for the week-end. The new cost would be a flat fee of \$300.00 for the entire week-end. In some cases, this would also include Friday night. Rohrer noted this seemed like a large increase, but noted it really is not since this also includes public works clean-up costs. Trustee Dick Schmidt stated Newburg is now charging \$350.00 plus \$50.00 clean-up cost. Beechwood is charging \$200.00 and they do not have any lighting facilities.

Rohrer also requested the village get bids for a clock to be installed in the pool area, and an answering machine to take phone inquiries when no one is at the park. This would save residents the bother of calling the board members to find out conditions or if the pool is open.

Tom Larsen is also checking into baseball diamond lighting which would probably be installed between the one permanent and third temporary diamond.

Public Works Superintendent Augie Bilgo suggested the village also get bids on a dumpster to be stationed on the north side of the concession stand.

Rohrer said the committee would like to incorporate into the regulations that no "outside beer or food" be brought in during a tournament. This would take business away from the organization running the concession stand for the event.

The board approved all of the Parks Committee's recommendations.

Administrator Dan Schmidt informed the board that the village had received its license for the new radio system. He also stated the village will have an opportunity shortly to purchase three additional radios which can also be used with this system. Schmidt noted the cost will be lower than the village paid for the first units, since they are being offered by an individual who purchased a lot which contains more units than he needs.

The board then adjourned.

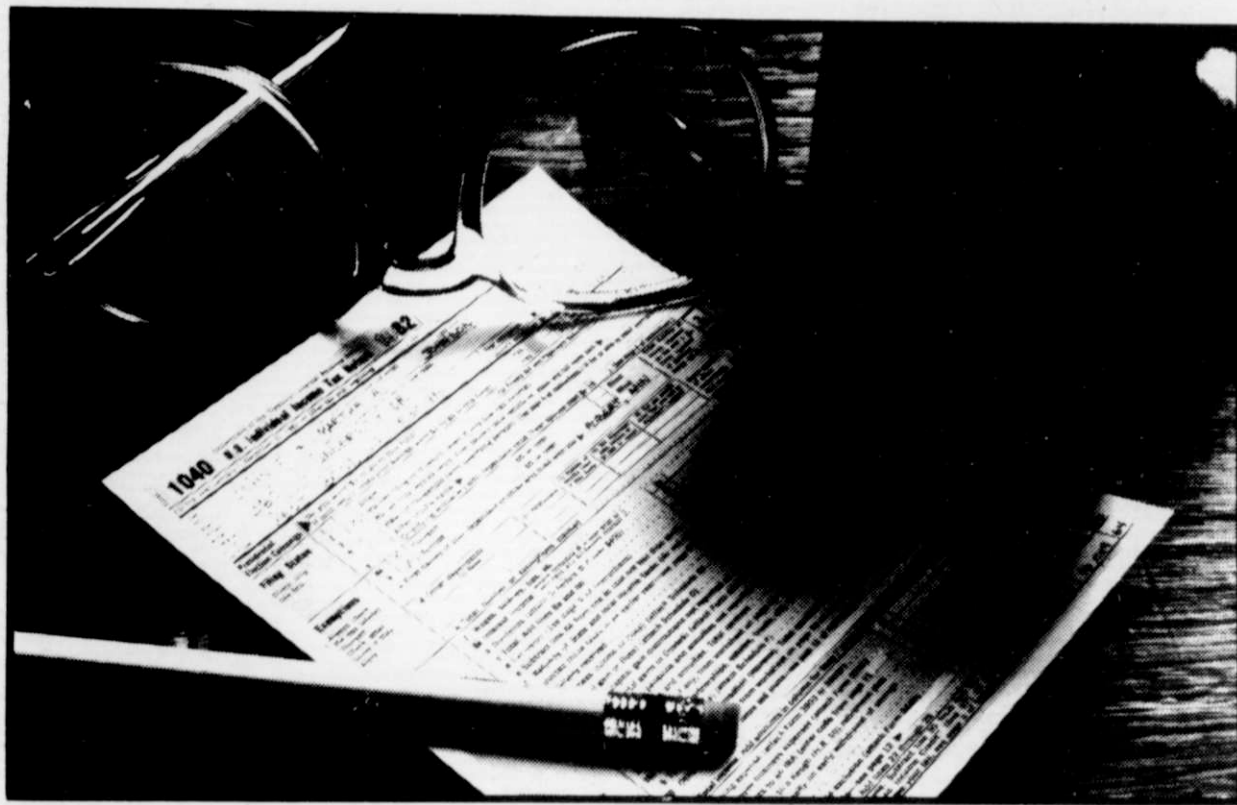

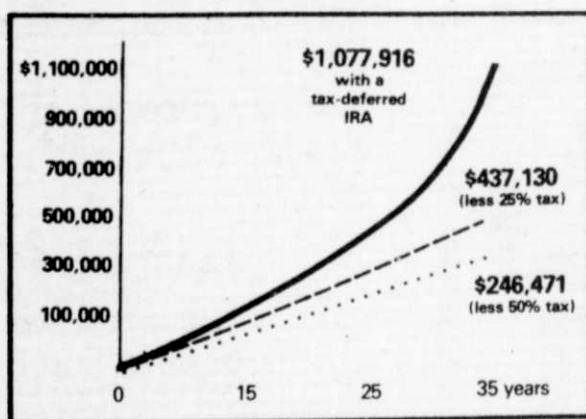

Transportation

Aids Received by Village, Townships

The state department of transportation issued checks Jan. 4 to 1,921 counties, cities, villages and towns totaling \$31 million.

The checks, which represent the second quarter (fiscal year) payments in transportation aids, include \$7.1 million to towns, \$1.9 million to villages, \$12.4 million to cities and \$9.5 million to counties. The 1982 payment is substantially more than the \$25.8 million distributed in January, 1981 in a across-the board seven per cent reduction in transportation expenditures was in force.

The payment to Washington county is \$132,784.77. Payments to area municipalities in Washington county include: Village of Kewaskum, \$6,490.51 and Towns of Kewaskum, \$4,341.01 and Wayne \$5,127.57. The transportation aids are the local governments' share of state motor vehicle revenues, which help pay the costs of constructing and maintaining local roads and bridges.

Distribution is based on the road mileage in each jurisdiction (arterials, collectors and local roads), the relative responsibility shared by state and local governments for each type of roads, and the actual, as well as legislatively-estimated costs of construction and maintenance.

In addition to returning a share of state motor vehicle revenues through these aids, the department of transportation also distributes federal and state aids to local units of government for eligible transportation projects and programs, including highways, airports, buses, rails and harbors. Also, all 72 counties are reimbursed by the state for their costs of maintaining the state trunk highway system.

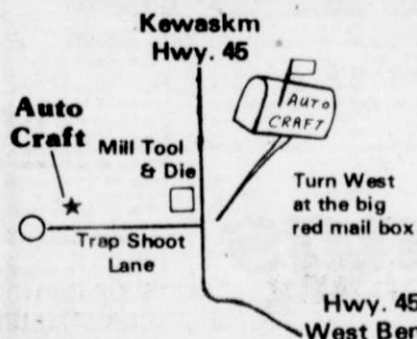

Hephner Upset Over Inaction by State for More Security After Another Escape From Kettle Moraine Correctional Institute

(MADISON) — State Rep. Gervase Hephner (D-Chilton) expressed disbelief at the Governor's and the Department of Health and Social Service's inaction after another serious escape from the Kettle Moraine Correctional Institute.

Improved protection for citizens living around the institute has been toyed with long enough, according to the lawmaker. Pointing to more than five years of fighting to obtain better security measures at the prison, Hephner said, "It's about time these people feel safe in their homes and communities."

"The escape of four inmates on Christmas is the last straw," Hephner argued. The prisoners drove a stolen car through the prison fence and later threatened Plymouth restaurant owner, Tom Larson, with a hatchet, and stole his wallet, 16-gauge shotgun and 1981 station wagon. The convicts are still at large.

"What's worse," Hephner observed, "this is not just an isolated incident." Last year, two escapees terrorized a Town of Mitchell couple, holding them at gunpoint, robbing them and killing the family dog. After the Christmas break-out, Hephner and State Rep. Calvin Potter (D-Kohler) again contacted the Governor asking for adequate security at the Kettle Moraine facility. They pointed out that although the budget included \$2.5 million for

a much needed double fence, the Governor vetoed the provision — leaving the citizens of the area in danger.

The Kettle Moraine facility has a higher escape rate than the state's other medium security prison, the Fox Lake Correctional Institute. The only real difference between the two facilities is that the Fox Lake facility has a double fence, Hephner explained.

He told the Governor that prison officials claim, "A double fence around the institution would almost ensure that escape in this manner would be impossible."

Dismayed that the Governor has not responded to the requests for a double fence and uniform allowances at the institution, Hephner said, "Another violent escape episode must not be allowed to happen again. It is up to the state to guarantee public safety ... at any cost."

PSC Urges Heating Fund Applications

The Wisconsin Public Service Commission is urging eligible state residents to apply for funds under the 1981 Energy Assistance Program (EAP).

From \$48 to \$63 million will be available under the state program to help Wisconsin residents heat their homes over the 1981-82 winter season, according to EAP program officials.

Under current guidelines, about 193,000 Wisconsin families can qualify for the program.

Eligible applicants can receive two checks totaling \$344 if their homes are heated by fuel oil and \$252 if heated by other means. Emergency funding is also available.

Program applicants must have a gross income below 150% of the nationally set poverty level, which at current levels would be \$883.75 a month for a family of three or \$1056.25 for a family of four. The applicant must also have net assets of less than \$12,000, excluding house and car.

Wisconsin residents who think they may be eligible for the program are urged to contact their county social service office before January 31. They may also call the EAP hotline toll free at 1-800-362-3027 outside of Madison, or 267-9544 in Madison.

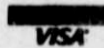

Goose Flock Has Left State

HORICON, WI — The remainder of the Canada goose flock, including the 4,000 birds that were on Big Green Lake last week, has now left Wisconsin, according to Glen Eveland, DNR Horicon Area wildlife manager.

Eveland said that an aerial survey on Tuesday, January 12, showed that the 4,700 birds remaining on Big Green Lake, the Horicon National Wildlife Refuge and the Grand River Marsh dam after the New Year's weekend snowstorm have departed. Big Green Lake is now frozen over, he noted.

The departure of the geese removes the possibility of another dieoff now from lead poisoning such as occurred last year. About 3,100 Canadas died last February when 20,000 of the birds overwintered in south central Wisconsin because of the mild, relatively snow-free winter last year.
