1982-83 Proposed School Budget of \$4,842,680 Approved at Annual Meeting

On a two to one ratio, Kewaskum School District taxpayers voted, during the Annual Meeting Monday night, to approve the proposed budget of \$4,842,680, for 1982-83.

After a brief run-through of the budget by acting superintendent Robert Borch and clarification of citizen questions, a written ballot was cast. The secret ballot had been requested by Town of Scott resident Clara Trapp. With 107 people present, the vote was 68 for acceptance, 30 against, 3 abstaining and 5 blank ballots.

Borch told the meeting the budget being presented was still not final. One major hold-up in finalizing figures for 1982-83, is the fact that no decision has been made by the arbitrator in contract negotiations between the district and

teachers union. A decision on the 1981-82 contract could affect both the 1981-82 and 1982-83 budgets depending upon whether or not a one-year or two-year contract is approved.

Negotiations of the 1981-82 teachers contract has been in arbitration since December, 1981, approximately eight months.

Other large increases noted in the proposed budget included anticipated deregulation of natural gas used for heating. This could result in a substantial increase in district costs. Increased telephone costs, should the Public Service Commission grant the telephone company another rate hike, are being taken into consideration. Borch noted increased phone rates would be reflected in the district's long distance service which includes computer terminal service to

the CESA computer in Waukesha. Borch noted some Milwaukee schools are looking at increased telephone costs ranging from 100% to 500%. Borch felt, however, Kewaskum would not see such drastic increases.

Another utilities increase came in the form of a 45% rise in the cost of sewer services. This is the result of a new sewer rate established by the village this year.

The 1982-83 proposed total tax levy is \$2,836,695.00, \$2,519,695.00 general fund levy and \$317,000 debt service levy, an increase of 3.9% over 1981-82, with an estimated equalized value at \$280,016,727.00, up 2%, resulting in an estimated levy rate of 10.1304 mills, up 1.9% over 1981-82.

The final budget will be presented to the school board during its first meeting in October.

Kindergarten Busing Question Settled

High School Air Conditioner Repairs Approved

The regular meeting of the Kewaskum School Board was held after the close of the Annual School District Meeting Monday evening.

Board member Ralph Horner and Kewaskum Elementary Principal Richard Zarling presented their findings regarding a third alternate choice for busing of kindergarten students during the 1982-83 school year.

Horner noted, after meeting with Johnson Bus and reviewing the routes, Alternate No. 2, as recommended by Zarling at the last meeting would be the most feasible. This would result in the least amount of time (approximately 35 minutes) being spent on the busses by students. Alternate No. 1 would have had 50-55 minutes of riding time, Horner's Alternate No. 3, approximately 48 minutes. The

board approved the Alternate No. 2 route on a unanimous 7-0 vote.

Acceptance of this route will result in 25 students attending Beechwood, 26 at Farmington, 70 at Kewaskum and 28 at Wayne.

In other action, the board approved the purchase of a rebuilt compressor for the high school air conditioner. The order, at a cost of \$11,228.00, was given to Commercial Industrial Services. At a previous meeting, board member John Tessar had questioned the possibility of purchasing a new, rather than rebuilt unit for just a few thousand dollars more. Superintendent Bob Borch said all the companies contacted felt a rebuilt unit was better than a new unit. Rebuilt units carry a one-year warranty on parts and labor, whereas new units only have a 90-day warranty on parts.

The Citizens Advisory Committee to hire a superintendent held its first meeting during a break between the Annual and School Board meetings. The members of the committee met in closed session with the school board.

President Charles Ogi read a letter submitted by John Tessar stating he was resigning from the Board's Committee to hire a superintendent.

Sr. Mary Aquin Miller To Observe 50th Jubilee

Sister Mary Aquin Miller, the former Isabella Miller of Kewaskum, will celebrate her 50th jubilee of religious profession on Sunday, August 1, at a 2 p.m. liturgy at the Archbishop Cousins Catholic Center, Milwaukee. A reception will follow on the grounds of St. Francis Convent.

Sister Mary Aquin entered the Congregation of the Sisters of St. Francis of Assisi, Milwaukee, in 1929 and took her first vows on August 12, 1932. During her years of religious

life, Sister earned her Master's degree from Marquette University, Milwaukee, and her doctorate from Catholic University of America in Washington, D.C. Sister Aquin taught on both the high school and college levels before becoming President of Cardinal Stritch College, Milwaukee, in 1955. She was President of Cardinal Stritch through 1974 and on resigning her position as President, Sister Aquin became the Director of Institutional Research at Cardinal Stritch.

In addition, Sister Aquin was treasurer of the Wisconsin Foundation of Independent Colleges from 1969 to 1974, received the Cardinal Stritch College Medal of Meritorious Service in 1976, was a member of Delta Epsilon Sigma Honor Society, received the Pioneer Award from the Wisconsin Society for Brain-Injured Children, and was a member of the Administrative Council of the Sisters of St. Francis of Assisi from 1955 to 1967. Sister Aquin is presently residing at St. Ann's Health Center, Milwaukee.

Sister Aquin is the daughter of the late Edward and Margaret Miller and the sister of Edward, Joseph and Fred Miller, all of Kewaskum, and the sister of Margaret Mehring of Long Lake, WI.

Early Farm Days in Kewaskum

On August 7 and 8 area residents and summer visitors are invited to take a trip through "memory lane" at the 8th Annual Early Farm Days event sponsored by the Kewaskum Historical Society.

Beginning at 10 a.m. on both days, visitors will be able to view the antique farm machinery displays, some of which will be in action. Items to be included are gas and steam engines in operation, steam traction, oil pull, old tractors, old cars, lots of old time farm equipment and antiques on display, threshing and old farm operations.

The display will be located on the beach side of the river on Parkview Drive in the village. Admission will be \$1.50 for which you will receive a 1982

Historical Society collector's button. If anyone has already purchased and is wearing the 1981 button, you will be admitted free. There will be no charge for children under 12.

Older visitors will enjoy seeing and remembering and the younger set might be interested in how things used to be done. There will be lunch, refreshments and a corn boil as well as homemade pie and desserts on both days.

The log house and museum on Parkview Drive will be open on both days.

All proceeds from this event will be used to further the reconstruction of the log home on the society's museum site.

From the School Board President's Desk....

What exactly are the duties and responsibilities of the school board members? What can we voters expect from you? As I see it, there are four responsibilities of the individual board members.

The first duty is to attend the school board meetings. One really cannot serve in absentia. The second responsibility is to become knowledgeable on issues facing the district. Another way of putting that is that we have to do our homework. There is a large amount of material the Board must understand in order to make intelligent, responsible decisions. Does that mean we are all experts? No, it means that we rely on district personnel and citizens who are knowledgeable in the area under discussion. This leads to the third responsibility, that being our responsibility to communicate with the people in the district. We cannot rely alone on the news media to present an accurate reflection of all that occurs at Board meetings. There must be avenues of communication set up so that someone who is aware of a problem can bring it to our attention or so that anyone with a solution to a problem can present it. The Board has the obligation to provide district children with the necessary education and taxpayers with a sensible budget.

The fourth duty of Board members is to serve on committees. While the general philosophy of the district is determined by the Board as a whole, the specifics are arranged in committees, and the committees report to the entire Board. We have two types of committees—standing (permanent) and temporary (one issue). We have four standing committees with each one comprised of three Board members appointed by the Board president to a one year term. The four committees and those who have been willing to serve on them are 1) Transportation: John Spoerl (chair), Ralph Horner; 2) Professional Staff Salaries and Negotiations: Tom Brigham (chair), Dr. Ogi; 3) Support Staff: Ralph Horner (chair), John Tassar; and 4) Grievance: John Tassar (chair), Tom Brigham, John Spoerl. Temporary committees are short term, one issue study groups that dissolve as soon as their issue is resolved.

These four—meeting attendance, homework, community communication, committee service—are our duties/responsibilities to you. It is the only way a school board can function. questioned the fee schedule submitted by consultant Dik Buntrock. Goeden noted, "it would seem awful fishy to me that half of the items are no charge." Ogi told Goeden, Buntrock had explained his fees during the presentation at a previous meeting. Goeden was absent at that meeting.

After reviewing anticipated per candidate costs, Goeden motioned to set a spending limit of \$2,000.00 for consultant fees at this time. The motion was approved 5 to 2, with Ogi and Spoerl voting no. Goeden noted the committee could come back to the board if additional funds are necessary. Resident Gerald Buchel felt the \$2,000 limit was a good idea since it would keep the board more closely informed. Advisory Committee member Jan Hubbell felt there was no need for such a restriction since the board would be receiving a report at every meeting and the board had already accepted Buntrock's anticipated fee of \$5,000 or less. Board member Tom Brigham noted the board had not necessarily voted for a figure, "we were just deciding that night on the individual."

Borch was questioned on the response to the superintendent vacancy. Eighty application requests have been sent out with 28 applications returned.

The board was questioned as to whether or not the position of business manager would be dropped. Ogi stated all personnel for the 1982-83 school year had been hired including the business manager.

The Board was informed by Superintendent Borch that it had received a grievance letter from the Kewaskum Education Association concerning the athletic director position. The matter will now go into arbitration and Borch asked permission to hire Ken Cole as counsel to represent the district during the arbitration hearing. The board approved the request.

Today's Medicine

IMMUNIZATIONS FOR SCHOOL By Dr. Richard Edwards

In 1932 when I began my practice in Kewaskum there were epidemics of chicken pox, measles, mumps, scarlet fever and whooping cough, and the health officer had to placard every house to warn people to stay away on account of contagion. How long since you have seen such a poster? Over 30 years! Why? Because of their immunization programs with which most of our inhabitants cooperate. Milwaukee now has a law enforcing in school children to be immunized prior to entrance in school. This is good and should be adopted by all 50 states.

SMALL POX has disappeared from the face of the earth and no longer need you be given a vaccination on your left arm which leaves a permanent scar. SCARLET FEVER has been prevented by the use of antibiotics. The germ STREPTOCOCCUS is still with us but now a few doses of the correct drug cures at once and avoids the spread to others. The last POLIOMYELITIS outbreak was in 1955 at which time many died and thousands were left crippled in varying degrees. No cases at all for the past several years. Why? Because of these polio prevention programs.

MEASLES and WHOOPING COUGH are now quite rare but do still occur because every one is not immunized. We have no vaccine for CHICKEN POX but we do have good prevention for MUMPS, the disease which makes so many men sterile.

GERMAN MEASLES causes deformities to nearly all fetuses in mother if other children get the disease. Hence, be sure to have all girls especially protected by this vaccine now, for it may be dangerous for older girls to receive later.

TUBERCULOSIS is now curable with new medication so the sanatoria are all being converted into homes for senior citizens.

Yes, you will say, but they are too dangerous! And you are wrong because, by comparison to death or mental disorder caused by any one of these diseases, these possible dangers are so remote, so mild and so unlikely to occur to your child that you are illogical to hold such an opinion.

Of course each child is illogical to be checked with the mother by a doctor or nurse to learn if any allergies exist, or what kind of a reaction occurred with the previous inoculation.

Your child's immunization record is a must for every parent to keep safely until age 25 at least.

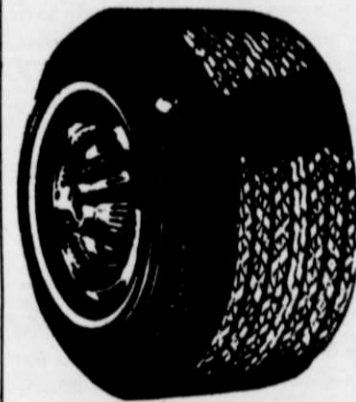

Ag Official Speaks at County Holstein Meeting

Speaking to the Washington County Holstein Association Twilight meeting in Slinger Tuesday evening, Russ Weisensel, Executive Director of the Wisconsin Agri-Business Council, disputed a recent report linking animal products with cancer. That report released in June by the National Academy of Sciences indicated that certain foods appear to increase the chance of getting cancer. The Academy recommended reduction of "fatty" foods, such as meat and whole milk dairy products.

Reviewing overall cancer, and food consumption patterns in the US, Weisensel indicated the report was unwarranted and unrealistic.

Said Weisensel "HEW statistics from 1930 to 1970 show that cancer mortality rates, when adjusted for age, have dropped or remained

stable since 1940 in all instances except for lung cancer. For example," he noted, "while there's been a two-thirds decrease in deaths from stomach cancer, in both males and females, lung cancer for males has increased nearly twenty-fold."

What makes the National Academy of Sciences report suspect," he continued, "is that during this same time period beef consumption, according to USDA figures, more than doubled: from 52 pounds per person in 1933, to 78 pounds in 1953, and 109 pounds per person in 1973. Looking at this data," stated Weisensel, "makes it unrealistic to draw any correlation between increased consumption of meat and cancer risk — unless, of course, we're inhaling the meat!"

County Treasurer Advises Last Minute Taxpayers

WEST BEND....Last minute property taxpayers should take note of several important items, County Treasurer, Fredric A. Seefeldt, advised.

One, the courthouse is not open on Saturdays and will not be open on Saturday, July 31. "Because July 31 is not a normal business day, the Wisconsin Attorney General has ruled that walk-in payments on Monday, August 2, must be considered as timely," Seefeldt reported.

However, payments being

made by mail must carry a July postmarked to avoid an 8½% late payment penalty. "Since mail service is available on Saturday, the July 31 deadline still applies," Seefeldt pointed out.

Two, those people who find that they have not accumulated the full amount of their second payment should pay what they can on their account," he advised. "The interest is figured on the unpaid balance, so the prudent thing to do is to reduce that amount if possible," Seefeldt said. "We are authorized by State law to accept partial payments and this may be of real help to people experiencing economic distress," Seefeldt stated.

Property Tax Is Regarded Most Burdensome, Panzer Survey Shows

MADISON...More than two of every three area residents responding to a recent opinion survey say they believe the property tax - the tax that pays for schools, police and fire protection and most local government services - is the most burdensome for Wisconsin citizens, according to State Representative Mary Panzer (R-West Bend).

Panzer surveyed Dodge, Fond du Lac and Washington County constituents by mail and received more than 900 responses. The "most burdensome" tag was given to the property tax by almost 68 per cent of those responding. Just under 40 per cent called the income tax most burdensome, while the sales tax trailed far behind, cited by fewer than eight per cent.

"It shows that we've been in tune with public sentiments by searching for ways to relieve the property tax, but, unfortunately, it doesn't show that we've been terribly successful so far," Panzer said the survey response.

Many apparently find the property tax so oppressive they would be willing to pay considerably higher taxes in other areas in order to relieve it. Slightly over 61 per cent of respondents said the cost of primary and secondary education should be shifted to either the state sales or income tax, with those indicating a preference choosing the sales tax by 59 per cent to 40 per cent.

Panzer pointed out that Governor Lee Dreyfus had set the stage for just such a shift earlier this year with the sales tax increase incorporated in the most recent budget adjustment bill.

"The Governor proposed a five per cent sales tax with the understanding that the additional revenue would be used for property tax relief once the current budget is balanced," Panzer noted, "and the challenge for the 1983 session will be to make sure that money really does go to property tax relief instead of being spent on something else."

Panzer co-authored two constitutional amendments during the past session which would have earmarked one dollar in every five collected through the state sales or use taxes for school property tax relief. Two similar amendments were offered in the Senate, but none of the four was approved. A constitutional amendment must pass two successive sessions of the legislative and be approved in a statewide referendum before becoming law.

"We shouldn't have any illusions about how easy this is going to be," Panzer said. "There are a lot of spenders in the legislature who'd love to use that money to fatten up the budget and disregard the people who bought a sales tax increase thinking it would mean property tax relief later on. It's going to take a lot of public pressure to line up the votes we need to give the people what they thought they were paying for," she warned.

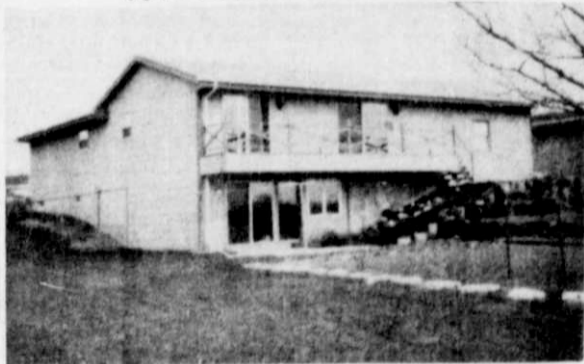

Hunting Licenses Available August 2

Hunting licenses will be available at Department of Natural Resources' offices, and the offices of County Clerks on August 2nd according to Doug Poole, Chief of the DNR License Section.

He noted that they should also be available by the date at most sporting goods stores, and other license outlets.

"There are a number of deadlines for filing applications for permits that we would like to call to the attention of hunters," Poole said, "including the wild turkey hunting permit which is new this year"

Applications for a permit for the wild turkey hunt, which will be held in the spring of 1983, must be postmarked on or before this October 1st. Landowners, who own 50 or more acres in the wild turkey hunting zone, will be given preference.

Applications for hunter's choice permits must be postmarked no later than October 1st. Preference will be given to hunters who applied for a permit last year and did not receive one.

Applications for a Canada goose hunting permit for the Horicon and Central zones must be received by the Department prior to September 10th. No applications will be accepted after September 10th.

The application for the hunter's choice permit is a part of the license. Applications for Canada goose permits and the wild turkey permits will be available at outlets where you purchase your hunting license.
