

Razing Started on Feed Mill

Workers have begun razing a village landmark, the building which formerly housed the F-S Feed Mill on Railroad St., and in recent years, Kewaskum's Halloween Haunted House.

The building was erected as an elevator by A. G. Koch around the turn of the century. Following Koch's death in 1913, it was remodeled into a feed mill and was then operated by Koch's sons, Arthur and Ervin Koch.

The property was recently purchased by the Village of Kewaskum and the building is being torn down to provide

room for approximately 25 parking places. The additional spaces' are part of a plan for future remodeling of the Municipal Building. In that plan, the Police Department's area will be remodeled and expanded. A new Community Room is also planned.

Village Administrator Dan Schmidt said the additional parking will be needed when residents begin using the Community Room. The new parking will also replace some slots which will be lost along the Municipal Building's west side when remodeling in the garage area is done.

The victim, Hartwell (Jim) Paul, owner and operator of Paul Auction Co., was rushed by the Kewaskum rescue squad to St. Joseph's Community Hospital, West Bend, for treatment. The shooting incident occurred inside the Paul Auction facility located along County Trunk S in the Town of Auburn, two miles north of Kewaskum.

Following initial treatment at the West Bend medical facility. Paul was transferred to St. Joseph's Hospital, Milwaukee., where he submitted to surgery on Tuesday. Paul is expected to be released from the hospital this weekend.

Paul was walking through a doorway with the doublebarrel shotgun and about to show it to Naegele when the shotgun somehow dropped to the floor and discharged, with the blast striking Paul in the right hand, authorities said.

The sheriff's department was notified of the shooting through Washington County authorities at 7:38 p.m.

Naegele said it appeared the shotgun slipped out of its case and fell to the floor.

Questioned by authorities at the West Bend hospital, Paul said he was walking when either the shotgun or the whole case slipped out of his hand.

The idea of a park shelter for Threshold received support and donations from the Wausaukee Aid Association for Lutherans. The Local Branch #3743 of A.A.L. is one of eight locals who belong to this group. They raised funds at their summer picnic. The Kohlsville Local #1657 contributed \$400.

The Aid Association for Lutherans, Local Branch #3743, raised \$4000 which paid for the materials and stain. Under the chairmanship of Paul and Janet Techtman, they held a pizza sale and rummage sale in 1983. The funds raised were matched by the A.A.L. home office in Appleton, Wisconsin. Paul and his volunteer crew also installed the footings for the shelter and did other preliminary work prior to actual finalized construction.

We don't want to alarm you, but no community is immune from tornadoes or other possible disaster.


Kewaskum does test it's warning system the first Thursday of the month at 10:30 a.m. by blowing the siren from 3 to 5 minutes.

So what should you do if a disaster takes place? Take shelter and listen to your local radio station.

The fire siren will be sounded on Thursday, June 7, at 10:30 a.m. to acquaint residents with the tornado or other disaster signal. It will be sounded at a steady pitch for three minutes.

In the event of a tornado or other impending disaster take precautionary measures.

The alerts will be held throughout the year on the first Thursday of each month.

AFTER THE STORM -WHAT DO YOU DO?



If a tornado should hit, remain calm - panic never helps. Most tornados are shortlived, lasting only four or five minutes and travelling on the ground for two miles, on the average, according to the Wisconsin Division of Emergency Government.

If you have extensive damage, contact your insurance company immediately. In the meantime, secure your property from further damage or theft. Heavy rains often follow a tornado.



Paul Cypher, treasurer of the Belle Albright Memorial Fund presented cash awards to the participants in the program.






