Levy Goal Set

Board Approves Beechwood School Closing, Teacher Layoffs, Cutbacks

In its efforts to reduce spending for the coming year, the Kewaskum Board of Education voted, Monday night, to set a levy limit goal of 3.5% over 1985-86 and a balanced budget. It also voted to close Beechwood Elementary effective this fall and to lay off or reduce the hours of thirteen district teachers for the 1986-87 school year.

In approving the limit for the

levy, board member Jean Goeden noted that the figure was not set, rather a goal to which the board would work.

After the board's decision to close Beechwood, a majority of the approximately 160 people attending the meeting walked out. Director of Instruction Julie Backus said she felt the exodus deserved to be noted. We've been criticized for the things we've been doing and it's interesting that a large block of people left after this vote, including a school board candidate (referring to Clara Trapp who had cut her vacation short to attend the meeting). That reflects the interests of people in only single issues, said Backus. She noted that there were still several important issues to be addressed by the board, however, this group, mainly Beechwood area residents, did not remain for the balance of the meeting.

The decision to close Beechwood came after a lengthy discussion and despite the objections of several area resi-

dents. Leonard Peter, Town of Wayne, asked the board what would happen if part of the district decided to go with another district. District Administrator Penny Kleinhans said that would cause severe financial consequences. She noted, however, that an area could not do that without district approval and it also was not legal to secede to create its own kindergarten through eighth grade district. Kleinhans said she had been in contact with people in the Random Lake School District and indicated that, contrary to popular belief, Random Lake is not really interested in taking over another at this time.

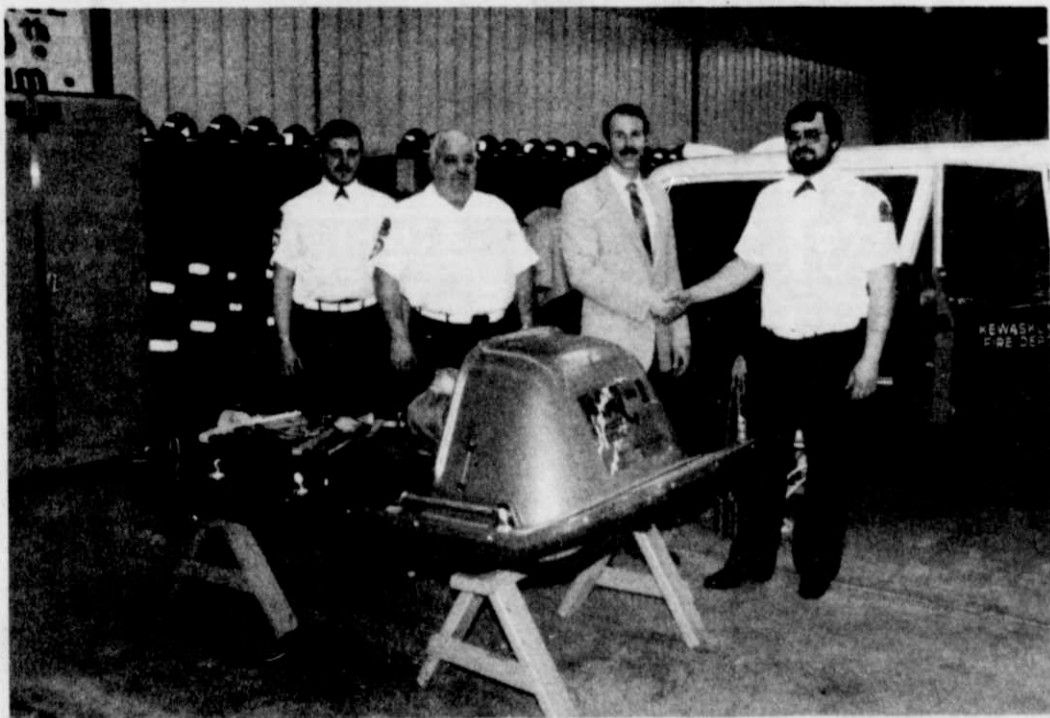
Carl Hohlweck, Town of Wayne, told the board, "we're not that young that we don't know what's going on." First you'll close Beechwood, then down the road it will be Wayne and Farmington. Then you'll tell us you need a bigger building in Kewaskum and the people in the rural areas will be

Rich's Super Savings Going Out of Business

Competition from large supermarket chains and the lack of support in town will force the closing in a few weeks of Rich's Super Savings in Kewaskum.

Richard Bechler, operator of Rich's, said this week, people going out of the area to shop rather than patronizing local businesses make it necessary to charge more for goods. I know we were a little high but not really out of line, noted Bechler. If the people had shopped our store more, the volume would have been there allowing us to lower our prices and be more competitive.

Since we opened, the store never met its projections. "The numbers just weren't there to keep the store operating profitably," Bechler said. "Lem" Rosenheimer, owner of the building, worked with us and gave us all the help he could.

The store will close around March 15th. We'll be running a couple weeks of markdowns before that, said Bechler.

The future is very uncertain for Rich. "There are no jobs in the offering but I'm looking into a few things," he said. "We hope to stay in Kewaskum but if that's not possible I'll have to go where the work is."

No New Information In Shooting Deaths

"Contrary to the Milwaukee Journal's reports," stated Detective Jack Theusch, "the Washington County Sheriff's Department nor the District Attorney's office have received any formal report on the findings of tests being conducted by the State Crime Laboratory in connection with the February 12th shooting deaths of Allen Guenther and Lee Luebke." The shooting deaths took place in the Town of Farmington.

Theusch indicated the department had received some preliminary data but no formal results in any of the tests run so far. The lab still has to make some further tests and we expect it will be several more days before all the results on

the two victims are compiled and a report forwarded to us.

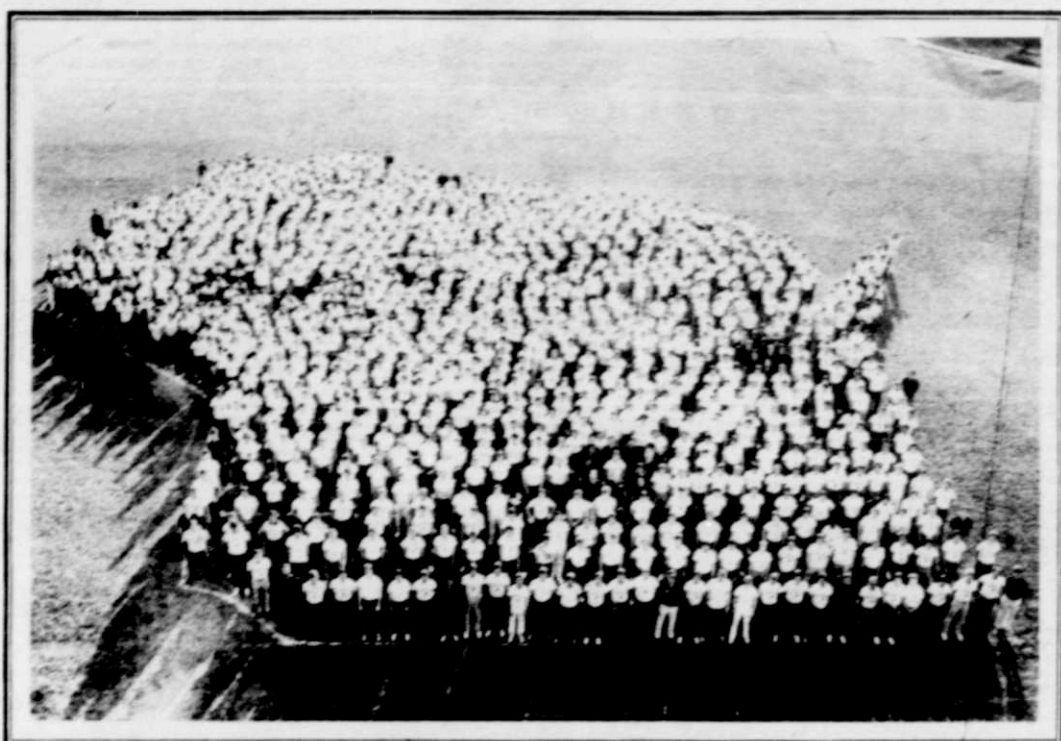
Since the original release of information on the shootings, the department has declined to make any comments on the incident. Affidavits and interviews from witnesses only seem to add more mystery and confusion to the circumstances surrounding the two deaths.

The department declined to confirm or deny whether details provided to a Milwaukee newspaper by one witness who is being held in custody in another unrelated case coincide with the department's findings in their investigation thus far.

A John Doe hearing or Coroner's Inquest may be held before possible charges are filed in the deaths.

approved transferring the local Vocation Education Coordinator duties from the assistant high school principal position to a vocational teacher. Backus' report indicated, "the growing responsibilities of the position can be best met by assigning the role to a vocational teacher. There has been an increased need for vocational training as reports indicate more than 60% of the students who enter as freshmen either drop out before graduation or enter the work force as soon as they receive their diplomas."

The board also approved the hiring of a half-time social worker at an approximate cost of \$20,000. Both Kleinhans and high school guidance counselor David Wiator felt the position was necessary to work with the school and parents in such programs as suicide prevention, protective behaviors and drug and alcohol abuse.

Wiator said all of these programs would be state-mandated by 1988 and would require a qualified individual to oversee them.

In other business, the board accepted the resignation of the middle school music teacher effective June, 1986, and the assignment of Robert Sobolewski and Mary Holfeltz to the Middle School intramurals program.

The board also approved transferring of the athletic director position back to the bargaining unit in 1986-87.

the ones who will have to pay for it. Board President Tom Brigham told Hohlweck his comments were incorrect. "We have never at any time, in any open or closed smoke-filled meetings talked about closing Wayne or Farmington."

Ralph Buchel of Beechwood told the board, "I can see we're going to be in the same position this year as last, so you better leave some time for court."

When the school board made its original decision to close the school in 1985-86, the issue became the focus of a lawsuit. The court, however, ruled in favor of the school board, upholding their right to close Beechwood. The board then reversed its own decision and kept the school open.

The closing, including staff, maintenance, and other related costs, is anticipated to reduce the budget by approximately \$76,200. With the consolidation of Beechwood students with Farmington and Kewaskum Elementary, the need to shuttle learning disabled students could also be eliminated, saving another \$4,036. Changes in the elementary band program could save another \$2,348.

In discussing teacher lay-offs, statements of several parents, some very emotional, helped to pull the Kewaskum Elementary remedial reading teacher's job out of the fire. The admini-

stration had recommended that the position be eliminated and replaced with a half-time Chapter One position. One woman told the board, "my son has a learning disability and I was told by everyone, including the reading specialist George Allmann, that my son was a 'non-reader', well, Mrs. Taddey has my son reading at a second grade level." She told the board help like this should not be taken away from those children who really need it.

Several similar statements persuaded the board to retain the position, however, as a compromise the position's ser-

vices will be made available to all the outlying elementary schools as well as Kewaskum Elementary.

The staffing reductions at the high school, which equal four full-time positions, represent a minimum budget reduction of \$64,550. The savings in that area could be larger depending upon projected unemployment costs noted Backus. If a teacher acquires another position, that figure could be reduced.

Because the remedial reading position was retained, the anticipated budget reduction of \$24,340 was voided.

In other action, the board

approved the administration's recommendation to create a Middle School concept which will include bringing all sixth grade students into Kewaskum, housing them with the seventh and eighth grades at the Middle School building. The change is expected to reduce the budget by approximately \$20,875.

The administration's projected cost savings through the recommendations represents reduction in the budget of between \$183,000 and \$262,350.

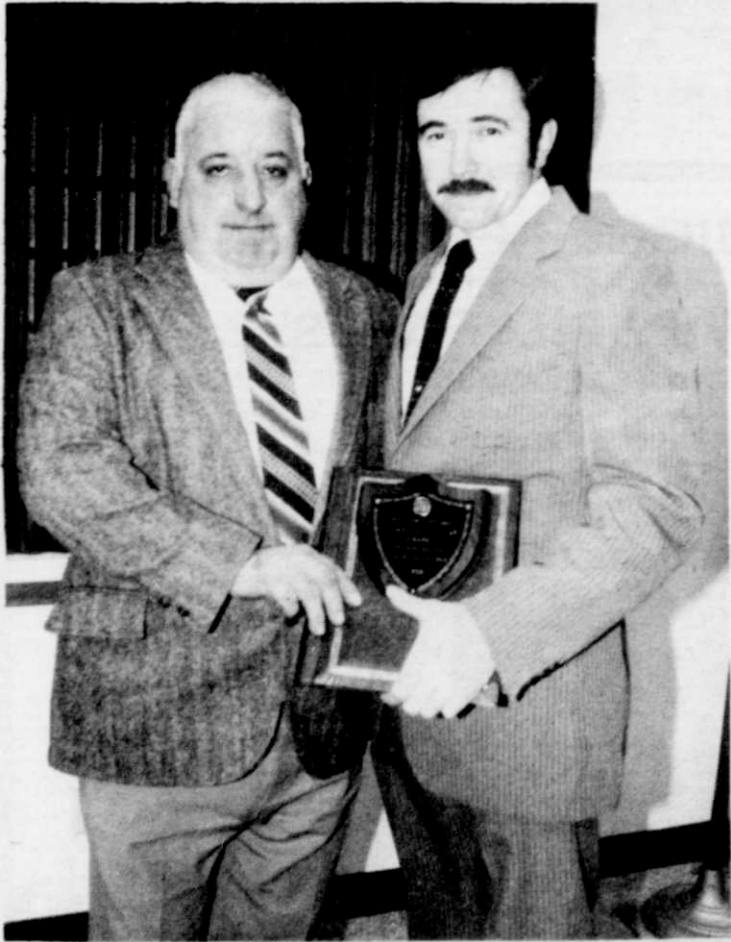

Area Delegates Attend FUMMC Member Meeting

Elmer and Carol Retzlaff, David and Jane Resch, and John and Linda Spoerl of Allenton were among more than 500 delegates attending the Farmers Union Milk Marketing Cooperative's (FUMMC) 14th Annual Member Meeting Saturday, February 22 at Madison.

Delegates called on Congress and the Administration "to immediately approve a workable, fiscally sound dairy supply management program to correct serious flaws in the Food Security Act of 1985... We reject the flawed argument that the dairy supply problem can most effectively be controlled through price reductions.

"We find major provisions of (the new farm bill) to be

seriously flawed," the FUMMC delegates said. "The bill is totally inadequate in dealing with the serious income and production problems facing the dairy industry."

FUMMC President Stewart G. Huber called for changes in the U.S. Department of Agriculture's rules for the whole herd buyout program which currently penalize producers who took part in the Milk Diversion Program. "This unprecedented decision to penalize those dairy farmers who took part in the diversion program in good faith will discourage future participation in needed supply management programs," he said.

Jim Nichols, Minnesota Commissioner of Agriculture, told delegates how the 1985 Farm Bill will affect dairy and other commodities in his state and joined FUMMC in calling for major changes in the new legislation.

Delegates also passed a special order of business condemning provisions in the new dairy law which depress farm milk prices in the Midwest while guaranteeing higher prices and attracting foreign

dairy investment in the Southeastern U.S. Petitions calling for the repeal of the legislated Class I milk price changes were signed and circulated.

Members who made significant contributions to FUMMC membership recruitment efforts during 1985 were honored at a special Five Star Club Awards Banquet Friday evening, February 21.

The Farmers Union Milk Marketing Cooperative is a Madison, Wis.-based organization representing more than 7,700 family dairy farmers in seven Midwest states.

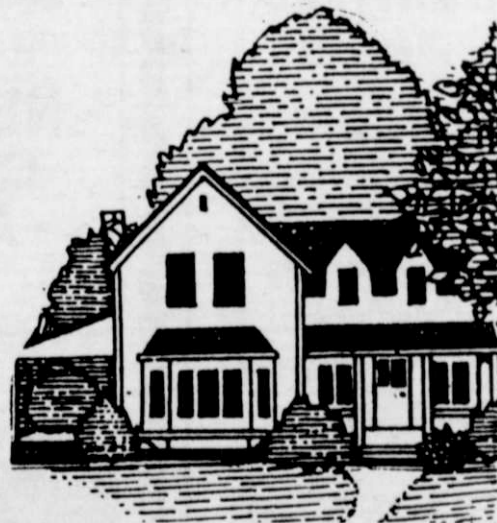

SELF-EMPLOYED TAXPAYERS MUST FILE INCOME TAX RETURN

[Second in a series]

Taxpayers who are self-employed must file a federal income tax return if they had net earnings from self-employment of \$400 or more, the Internal Revenue Service says.

Self-employed persons should use Schedule SE (Form 1040) to figure their self-employment tax. The self-employment tax rate for 1985 is 11.8% of the first \$39,600. Self-employment applies to taxpayers who carry on a trade or business as a sole proprietor, a member of a partnership, or as an independent contractor.

For more information, you can obtain free IRS Publication 533, "Self-employment Tax," by calling your local IRS office. In addition, many libraries carry a reference set of IRS publications.

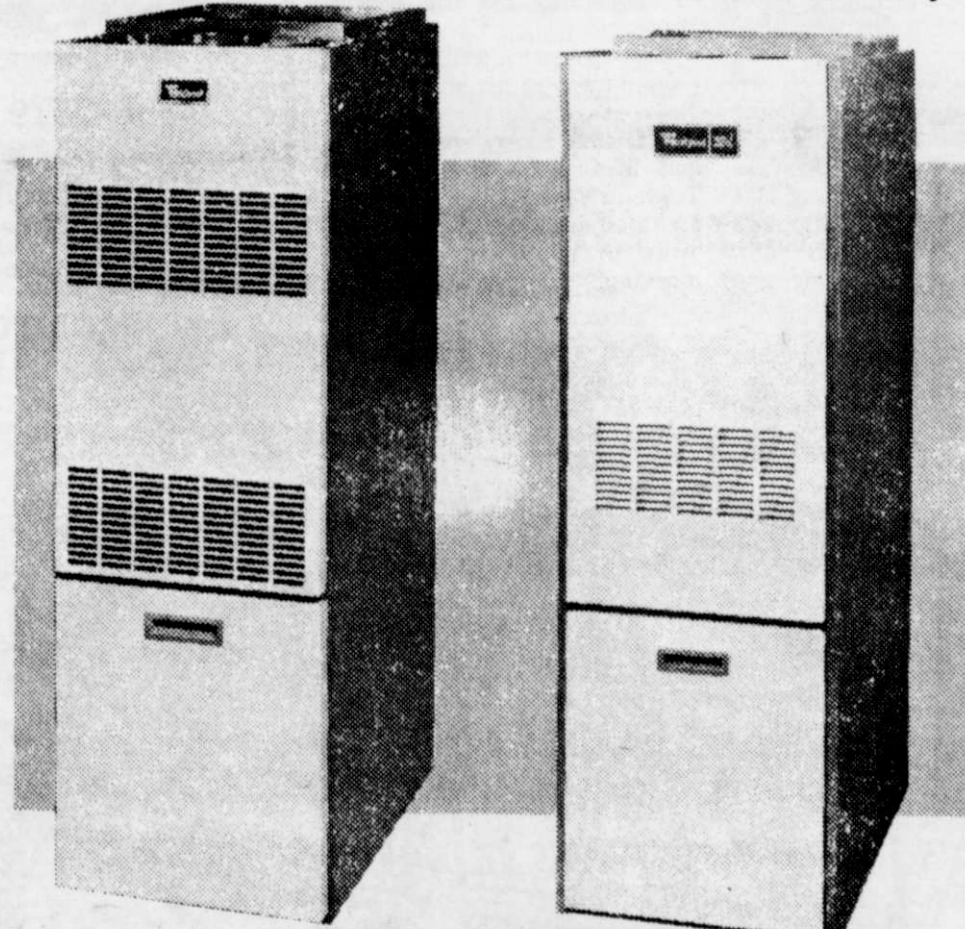

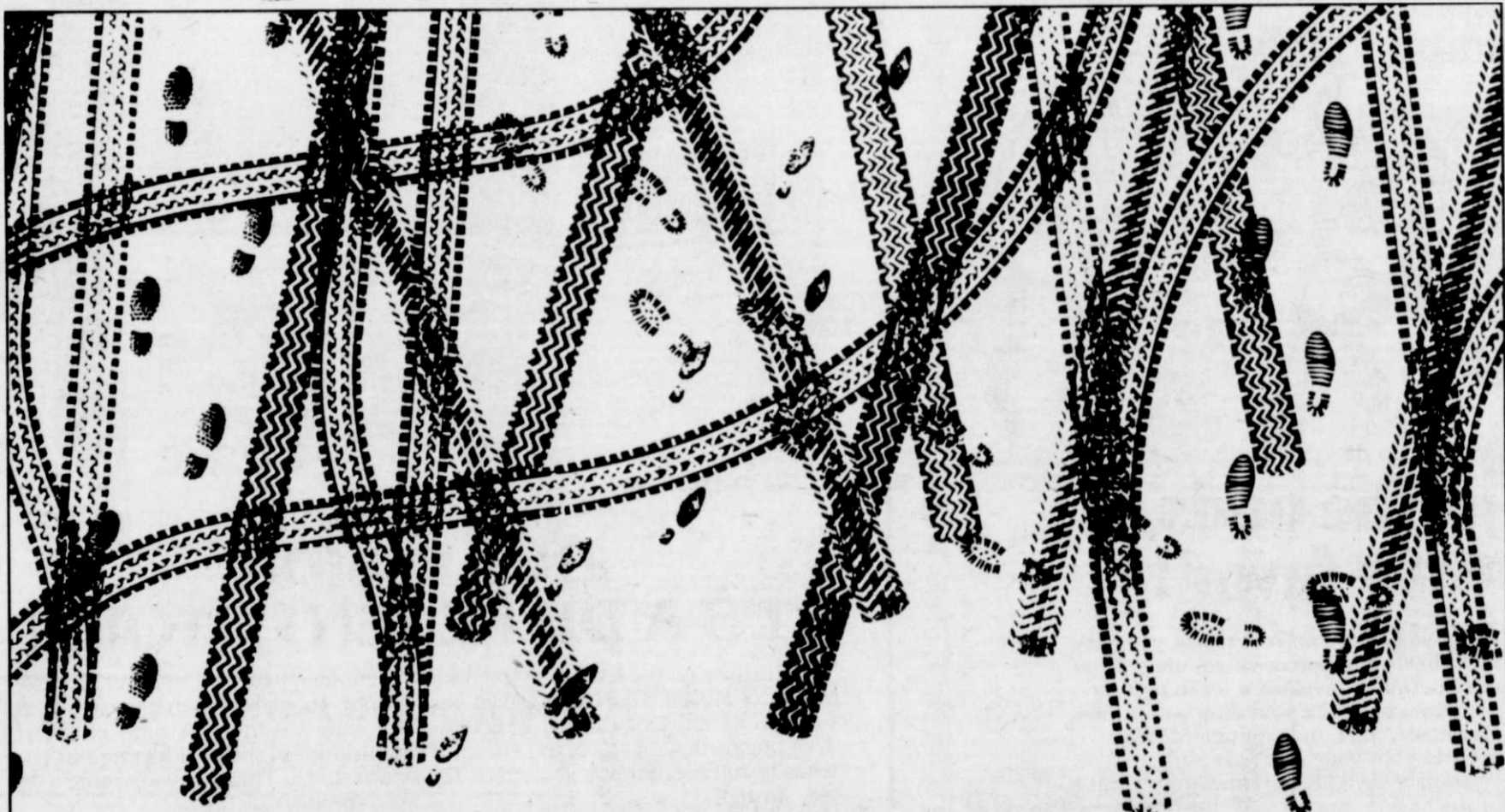

Pesticide Program Offered in County

Recent changes in registration of many pesticides as "restricted use" will require users of these products to be trained and certified. Most of the corn rootworm insecticides and other products are now classified as "restricted use." Individuals who were certified in the past and have allowed their certification to expire will need to be recertified.

Washington County Cooperative Extension Service, in cooperation with the Wisconsin Department of Agriculture, Trade and Consumer Protection, will be offering a Pesticide Applicator Certification and Recertification Program. The session will be held on Tuesday, March 18, at the Knights of Columbus Hall, Lighthouse Lane, West Bend. Registration will start at 8:30 a.m., with the program starting at 9:00 a.m. to about 4 p.m.

This program will be for private applicators, not commercial applicators. A private applicator is an individual who applies pesticides on land owned or rented by himself and on an agricultural crop.

Growers who do not become certified will not be able to use "restricted use" products, as dealers will be prohibited from selling "restricted use" products, unless the certification

card is shown. Growers are encouraged to participate in certification programs early in the year to allow adequate time to receive their certification before they need to purchase their products for the 1986 growing year.

Individuals who would like to register for the March 18 session should contact the Washington County Cooperative Extension Service no later than March 10, 1986. Registration for this program will be limited to the first 100 persons. Additional sessions will be held if needed.

Individuals having questions about the need to become certified or the Pesticide Certification Program can contact the Washington County Cooperative Extension Service.

IRS Announces Taxpayer Services

The Internal Revenue Service stands ready to help with many types of taxpayer assistance, according to L. M. Phillips, IRS director in Wisconsin.

One convenient method of obtaining answers to tax law questions and some tax refund information is Tele-Tax. The Tele-Tax information service provides recorded tax information on approximately 150 tax topics, which are listed in the tax instruction book. In the past, this service has only been available to taxpayers in major cities; but now it is offered to everyone through a toll-free number, 1-800-554-4477. Taxpayers with tone-signaling push-button telephones can reach Tele-Tax 24 hours a day, seven days a week, while others can call during normal business hours, 8 a.m. to 4:15 p.m.

Information about refunds will be available through Tele-Tax approximately ten weeks after a tax return is filed, according to Phillips.

The IRS will continue to offer its live telephone service. The number is 1-800-424-1040. And personal assistance will be available at the Oshkosh office at 128 State Street every Monday, Tuesday, and Friday from 9:00 a.m. to 3:15 p.m.

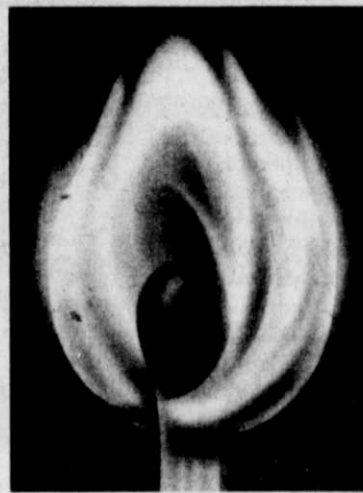

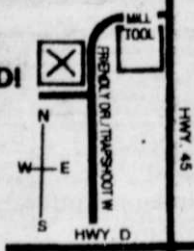

Mid-Monthly Meeting
February 17, 1986
8:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin met in Mid-Monthly session in the Council Room of the Municipal Building, 204 First Street.

President David Nigh presided. All Trustee Members were present.

On a motion by Trustee Richard Schlice, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board approved the minutes of February 3, 1986.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Paul Blumer and unanimously carried by voice vote, the Board authorized the advertising for a summer intern part-time employee for the Water Pollution Control Department.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Richard Schlice and unanimously carried by voice vote, the Board authorized the advertising for a summer part-time employee for the Department of Public Works.

Administrator/Clerk Daniel S. Schmidt appointed Colleen McKay and Gerald Stollenwerk to serve on the Board of Canvassers with him.

Administrator Daniel Schmidt reviewed some correspondence with the Board and some general information.

Trustee Thomas McElhatton, Chairman of the Park and Recreation Committee, presented his Committee's recommendation for providing the four portable toilets at the parks for the summer of 1986, that being A-1 Service Company at a cost of \$50.00 for the first unit and \$45.00 for all units thereafter per month. On a motion by Trustee Mary Krueger, seconded by Trustee Paul Blumer and unanimously carried by voice vote, the Board authorized the signing of the contract for portable toilet service from A-1 Service Company as recommended by the Committee.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board approved the construction/installation of a new ball diamond northeast of the existing north diamond by Village personnel and converting the north diamond into a little league diamond as recommended by the Park and Recreation Committee.

On a motion by Trustee Paul Blumer, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board authorized the engineers to prepare specs, plans and bids for the KKCP Shelter Building as recommended by the Park and Recreation Committee. It was noted the Kewaskum Kiwanis Club has agreed to help cover some of this building cost.

On a motion by Trustee Mary Krueger, seconded by Trustee Howard Laubenstein and unanimously carried by voice vote, the Board authorized the purchasing of a KKCP sign for on the corner of Fond du Lac Avenue and Clinton Street from Cochran Sign Company, West Bend, WI at a cost of \$377.00 as recommended by the Park and Recreation Committee. Included in the price is the sign,

bracket and installation of the sign.

On a motion by Trustee Paul Blumer, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board authorized signing a contract with Power Vac, Milwaukee, WI, at a cost of \$79.00 an hour for the cleaning of the deep portion of the swimming pond, as recommended by the Park and Recreation Committee.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Paul Blumer and unanimously carried by voice vote, the Board approved the advertising for summer part-time swim program employees (16 employees) as recommended by the Park and Recreation Committee.

On a motion by Trustee Mary Krueger, seconded by Trustee Paul Blumer and unanimously carried by voice vote, the Board approved the maintenance resurfacing and stripping of the tennis courts by Athletix, Menomonee Falls, WI, at a cost of \$8,000.00 as recommended by the Park and Recreation Committee.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board approved purchasing a 5 row 15' aluminum bleacher for the KKCP at an estimated cost of \$900.50 as recommended by the Park and Recreation Committee.

On a motion by Trustee Richard Schlice, seconded by Trustee Donald Mlodzik and unanimously carried by voice vote, the Board granted Mr. Fred Robertson a one-year extension on his Conditional Use Permit No. 84-CUP-01.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board authorized proceeding with the Capital Improvement Sidewalk Extension Program engineering and construction timetable.

On a motion by Trustee Richard Schlice, seconded by Trustee Thomas McElhatton and unanimously carried by

voice vote, the Board directed the Administrator to send a letter to the Washington County Board of Supervisors advising them that the current dispatching of the Village Fires, Rescue and Police should remain as is with no change to the Municipalities.

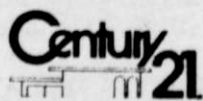

Athletic Clinics Offered to Kewaskum District Students

Not only do Ms. Sue Paul-Kenfield, John Nell and Perry Koth instruct physical education at the Kewaskum High School and coach gymnastics, wrestling and basketball respectively, but they are also offering free instructional clinics in their respective areas.

Ms. Kenfield is conducting two sessions of gymnastics for boys and girls ages 7-14. Approximately 150 students are currently participating in the clinic. Students receive experience on gymnastics apparatus (balance beam, floor exercise, uneven parallel bars and vaulting) plus practice balancing, leaps, turns and some dance. The purpose of the sessions is to give the students an exposure to the basics of gymnastics, orientation to apparatus and experience with body movement, coordination, flexibility, strength and balance. The clinic is held every Wednesday beginning January 15 through March 5th. Students 7-9 meet from 6:45 - 7:45 and the 10-14 group meets from 8-9 p.m. The gymnasts, under the direction of Ms. Kenfield do the teaching voluntarily.

The wrestling clinic is supervised by varsity wrestling coach

John Nell. Students from grades 1-8 are encouraged to participate. During these clinics students learn various skills relating to amateur wrestling. Take downs, escapes, reversals and pins will be covered. Students will also have the opportunity to wrestle other individuals of their approximate weight. Clinic dates run from February 13th, 18th, 27th through March 6th, 13th, 20th and 27th. The clinics run from 7-8 p.m. at the high school in Kewaskum and are free to all students in the Kewaskum School district.

Finally, the third clinic is the basketball clinic run by coaches Perry Koth and Neal Weltzen. This clinic is offered to students in the 4th, 5th and 6th grades. The fundamentals of basketball and a taste of competition highlight the clinics contests, culminated on Friday, Feb. 28, when participants will put on a demonstration during the half time of the varsity boys basketball game. The clinics will be held at the high school on Feb. 24th and 27th from 6:30 - 8:00 p.m. and Feb. 21st from 5-6 p.m. The varsity players assist in the presentation of these sessions.

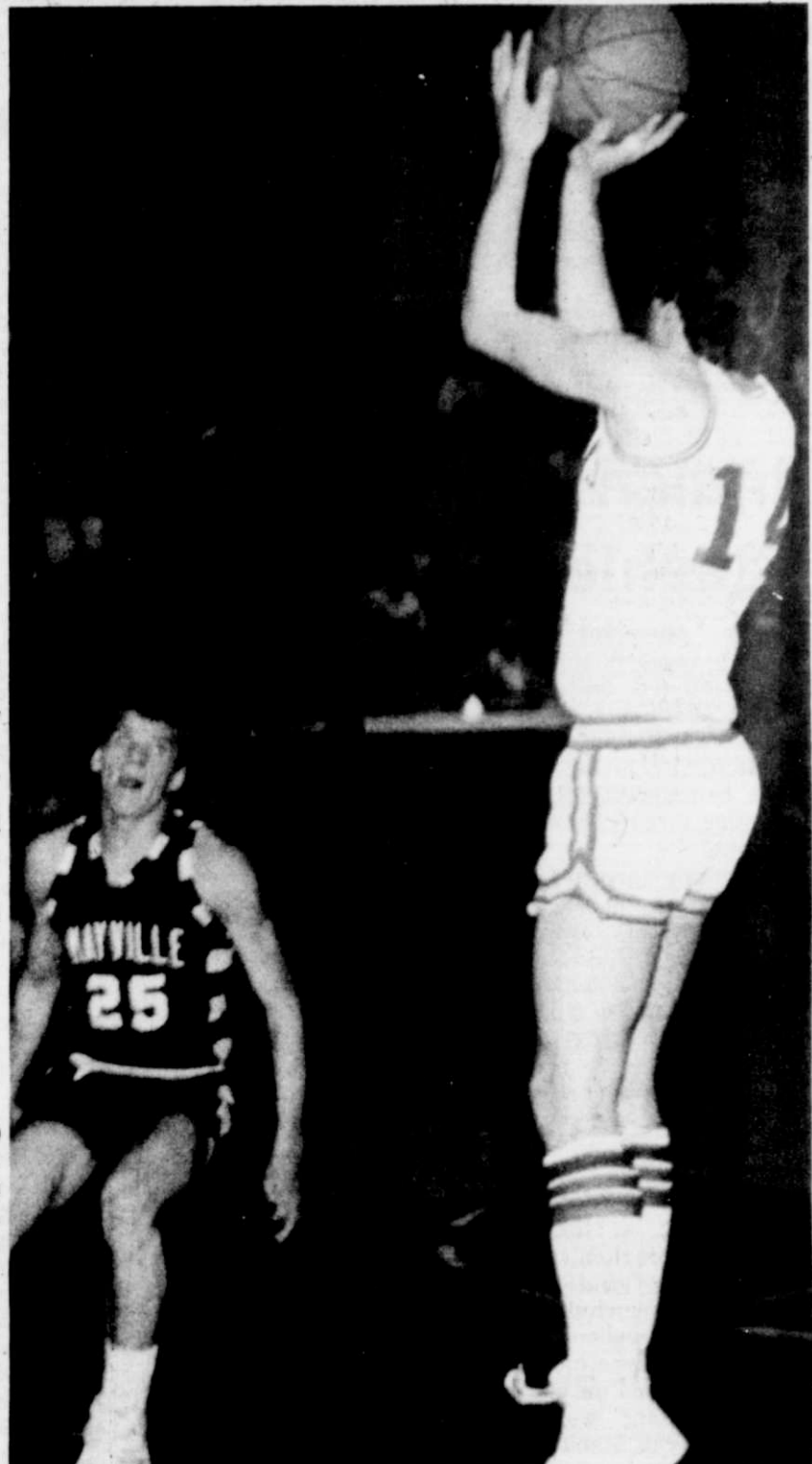
