Preliminary 1986-87 Budget of \$6,688,259

School Board Okays Middle School Remodeling for 6th Grade Classrooms

The Kewaskum School Board, Monday night, approved spending \$4,791.99, for remodeling work at the Middle School which will result in the creation of five classrooms to house the district's entire sixth grade student population along with the present seventh and eighth grade student body. The money involved covers the cost for moving two existing walls, the addition of two new walls, and related heating, ventilating and electrical work.

The action was taken in conjunction with the board's earlier decision to move all the sixth graders from the elementary schools into the Middle School. With the transfer of the sixth graders, it was felt enough classroom space at Farmington and Kewaskum Elementary Schools would become available so that the balance of Beechwood Elementary's students could be transferred making it possible to close Beechwood next fall.

After looking into student

numbers and space, the administration felt it could go along with a parent's earlier request that all the Beechwood students move to Farmington rather than be split up between Farmington and KES. Board member Jean Goeden, however, asked whether parents would have the option of sending their children to KES rather than Farmington. Goeden indicated her reason for asking was that some families were located closer to Kewaskum's boundary and some of the kindergarteners are already attending Kewaskum. District Administrator Penny Kleinhans said the administration would rather stay with one school.

Elementary School Principal Tom Larsen said Farmington could accept all the BES students without any inconvenience, noting projected enrollment for 1986-87 would total approximately 274 students. Each grade, K-5, would have two classes, averaging between 21 and 26 students per class.

In other action, the board

approved the purchase of two copy machines at a cost of \$6,550. One unit will go to the administration office and one to Kewaskum Elementary. The present administration unit will be moved out to Farmington and one of KES' present copiers will go to Wayne Elementary giving it two machines.

The board also approved the request of Coach David Drexler to purchase a new pit for the track program. Drexler told the board, he and his coaching staff were concerned about the liability factor, especially in hosting meets, because of the deteriorated condition of the present pit and its cover which is approximately ten years old. The board approved a low bid of \$4,605.00 for a new pit and weather cover.

Business Manager Cherna Gorder presented the board with an update on tax collections. To date, 59.3% of the district's taxes have been received. Gorder noted that visiting the townships had proven beneficial to both herself

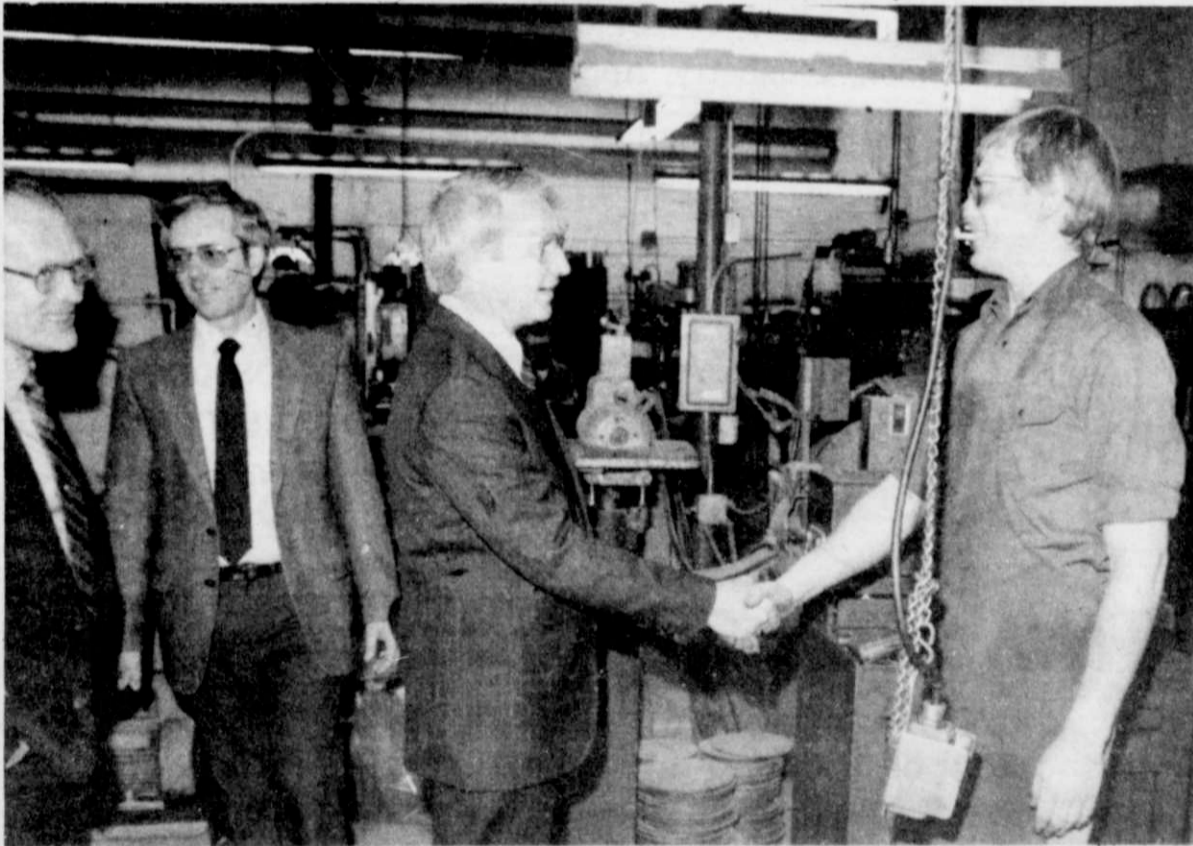
EF exchange students have the opportunity to reap many rewards. Participants gain fluency in a foreign language, develop independence, flexibility and social skills. In

Peer Listening Program Is Planned for KHS

In an active effort to counteract the effects of peer pressure in the lives of teens through public education, a teenage peer listening program in conjunction with the Council on Alcohol and Other Drug Abuse of Washington County is planned for Kewaskum High School.

The peer group concept functions on the fact that kids go to other kids first rather than adult figures when looking for direction with drug and alcohol decision making. The group then serves as a positive resource by training peers to intervene and talk them into healthy chemical-free lifestyles.

Five or six of these "peer listeners" in the student bodies of various schools have proven effective in bringing independence and reason into young lives distorted by peer pressure, according to statistics supplied by Mr. Baitinger.

Underclassmen selected for the intensive July 21-27 training sessions will be chosen on basis of interpersonal skills. 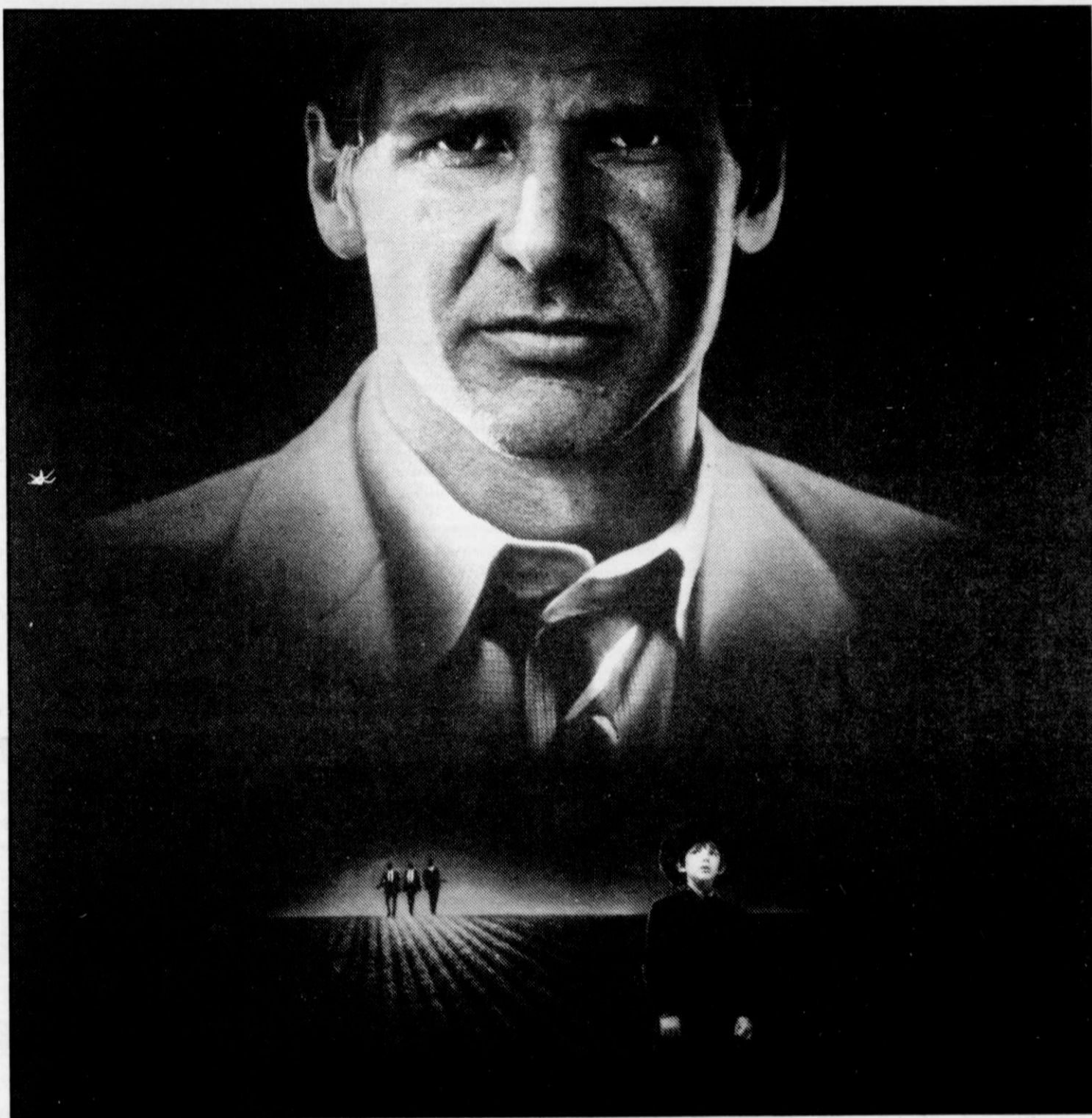

and the township treasurers. She indicated that there had been some minor problems, ranging from computer breakdowns to misunderstanding of the statute and formula, however, everything had been worked out satisfactorily for everyone.

Broken down by municipality, the Village of Kewaskum has turned in 63.09% of its tax share, Town of Kewaskum 58.96%, Town of Wayne 54.06%, Town of Farmington 60.80%, Town of Barton 64.63%, Town of Auburn 62.06%, Town of Ashford 57.83%, Town of Mitchell 59.58%, and Town of Scott 51.24%.

Gorder also presented preliminary projections on budget revenues and expenditures for 1986-87. Trying to maintain the 3.5% increase ceiling suggested by the board, Gorder projected expenditures of \$6,688,259 for the coming school year, up approximately \$121,000 over 1985-86 estimated actual figures.

"For every 1% increase in salaries, approximately \$35,000 will need to be added to the budget," Gorder's report stated.

Projected revenues for 1986-87, including local levies along with state and federal aids and other sources, are anticipated to total \$7,034,419. This includes a gross levy of \$4,132,590. As a result of the state's budget repair bill noted Gorder, the district lost \$16,000 in revenues.

Director of Instruction Julie Backus presented evaluation recommendations for the Social

Studies, Health and Physical Education, and Vocational Education programs of the district.

The restructuring of the Social Studies curriculum will eliminate both overlapping and gaps between the various courses offered on the kindergarten through 12th grade level.

Approximately \$25,000 will be needed for textbooks and teaching materials such as maps, etc. Backus noted new texts cost between \$15 and \$20 each for some of the high school courses.

Social Studies teacher Dale Squier told the board that most books from the kindergarten through eighth grade levels have copyright dates of 1976.

Another change being implemented is, with the incoming freshmen, (class of 1990) all students will be required to have three credits in Social Studies for graduation.

The Health and Physical Education report recommended a curriculum committee be set up to develop a K-12 resources guide as to what should be taught, at what grade in what course, and by whom.

In-service programs would be set up to help teachers determine student needs. The district would also tap the resources of outside health care professionals in providing programs on various subjects such as health, nutrition, and hygiene.

The report also recommended the board again consider the development of a drug and alcohol abuse program. Under the guidance of the social

worker that is expected to be hired shortly, staff members would work with that individual to set up an appropriate program.

Backus' report on the Local Vocational Education programs included a two-year plan which would assess and evaluate the needs of all the district's students including exceptional needs and "children-at-risk."

Another goal will be to evaluate and develop new programs, or rewrite and improve present programs to reflect local employment and student needs.

Backus informed the board that in direct relations to the LVE programs, she had applied for several grants which would help the district recoup funds for this plan and programs, much of which has already been included in budgeting. Before we went through all the work of

making these recommendations and proposals, I checked with sources on the state level, noted Backus, and I'm 98% sure we will be getting grant money.

As part of the vocational program recommendation, the board approved Backus' request to purchase fifteen Apple 2e computers and six printers which will be placed in the Middle and High Schools.

Six units will go into the Business Education program which will replace some of the standard electric typewriters now being used. Backus noted that if these units were not approved, the district still would have had to purchase new typewriters for normal replacement.

Dan Wangerin, the new local vocational education coordinator, will also work closely with local business and industry to get a better perspective of employment trends and the possibilities of developing cooperative programs starting in 1987-88. The LVE plan will effect several curriculums including the areas of agriculture, business education, and home economics.

Policy Committee Chairman Neal Weare presented three policy revisions for reading along with the LVEC job description. He also recommended that all job descriptions be placed in one new section at the end of the Policy Manual rather than scattered throughout the book. The board approved the recommendation.

Finance - Transportation Committee Chairman Perry Ankersen informed the board that his group's next meeting is scheduled for April 28, at 7:30 p.m., in the High School Library. The agenda will be the same as last month, with the addition of discussion on bus routes.

Buildings Superintendent

Fred Boehlke informed the board that the evaluation of the Wayne Gym ceiling had been completed and found to be satisfactory. Boehlke noted there had been a change of only 1/10th of one-inch since the last inspection was made six years ago.

The board approved an administrative recommendation to set the Annual Meeting date for Wednesday, September 3rd. Kleinhans said the additional time would allow the administration to gather more budget information for more complete and accurate reports.

Kleinhans also asked the board to read over a letter from the Campbellsport School District, asking Kewaskum, along with other area school districts, to join in a united effort in holding to a 5% limit in teacher contract negotiations for 1986-87.

The board then adjourned to closed session.

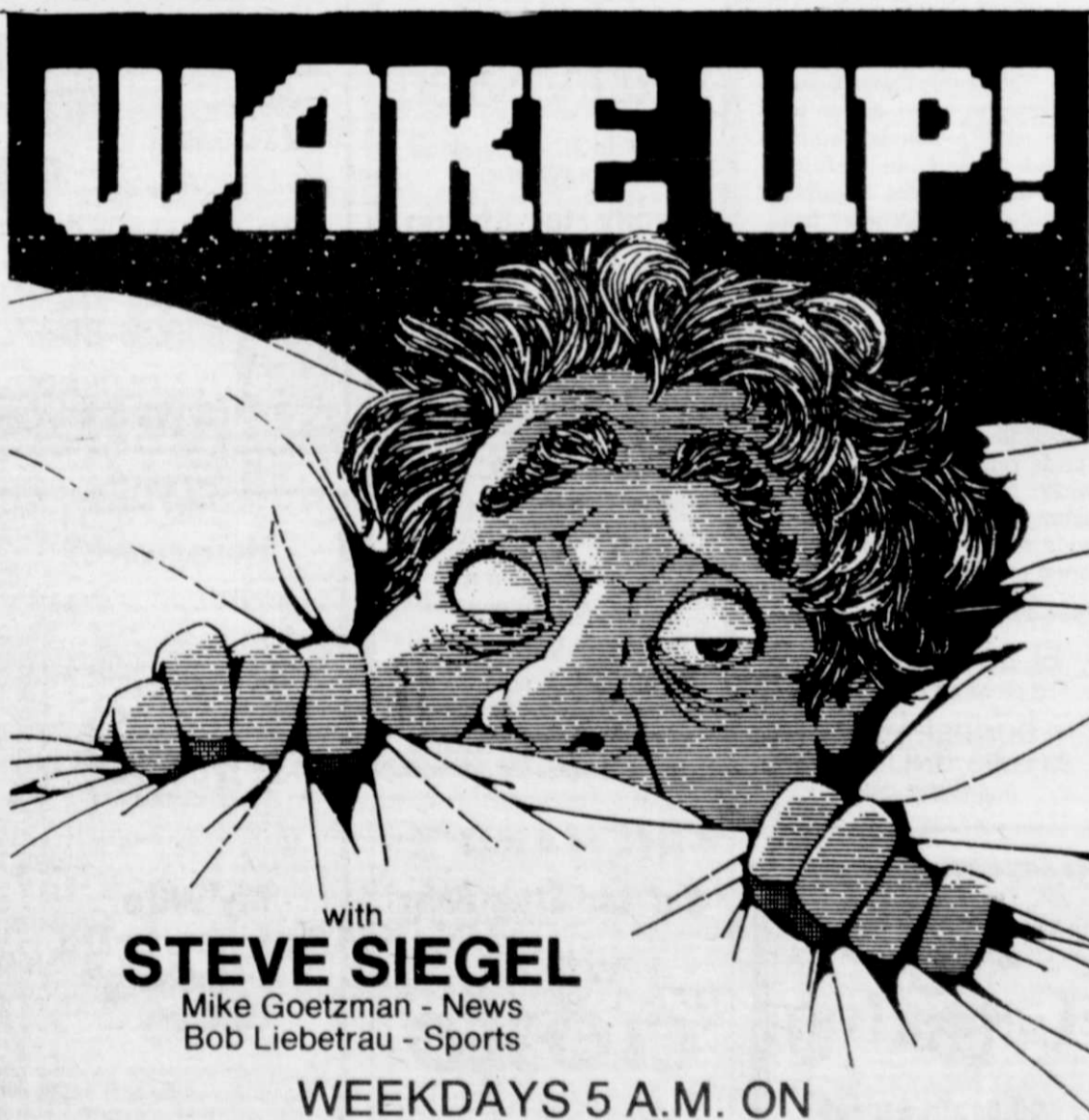

Can Certain Foods Help Prevent Cancer?

The best scientific evidence today shows that although no one food can keep a person from developing the disease, a sensible lifestyle, including a balanced, varied, moderate diet, may reduce cancer risk.

According to Michael Sheppard, President of the Washington County Unit of the American Cancer Society, enough evidence exists that some types of food may promote cancer, and others may inhibit its development.

"It's exciting to think that anything so familiar as the food we eat could have an impact on our risks of cancer," Sheppard said. "Even though we don't have all the answers we would like to have about the ways nutrition can increase or decrease our risk, we know that an anti-cancer way of life should include a reasonable approach to food, and our nutrition guidelines reflect this knowledge."

He said that eating more vegetables, fruits, and whole grains instead of fatty foods is the one way to reduce cancer risk and still have a satisfying diet. Furthermore, whole grains, fruits and vegetables contain a number of substances that may help reduce a person's chances of developing certain forms of cancer.

Fiber is a catch-all term for a number of substances that give shape and texture to foods that come from plants. According to Sheppard, there's fascinating evidence that in countries where the diet includes more total fiber, the incidence of cancer of the colon is reduced. Scientists disagree on just how much fiber may help prevent colon cancer, but many authorities consider the data convincing enough to recommend that Americans eat more high-fiber foods. Whole grains, crisp vegetables such as cabbage and spinach, and firm-textured fruits, such as pineapple, are good sources of fiber.

"Just how much fiber a person should eat to reduce his or her cancer risk has not yet been determined," said Sheppard, "since there are at least a dozen different kinds of fiber, which may have different effects. Different people may have different requirements."

"The point is simply to make sure you include sources of fiber in your daily diet," Sheppard said. The American Cancer Society is sponsoring extensive research in nutrition and the effects of various food constituents on cancer risk.

The American Cancer Society's dietary guidelines are as follows:

1. Avoid obesity: Obesity has been linked to risk of uterine, gall bladder, breast, and colon cancers.
2. Cut down on intake of fats: A high-fat diet increases risk of developing breast, colon, and prostate cancers.
3. Increase intake of fiber: A high-fiber diet may reduce the risk of developing colon cancer.

4. Add foods rich in vitamins A and C: These vitamins may help prevent cancers of the esophagus and stomach. Citrus fruits and green, leafy vegetables, especially those from the cabbage family — brussels sprouts, broccoli, kale, cauliflower, and cabbage — will provide these vitamins, as well as some fiber.

5. Drink alcoholic beverages in moderation: The risk of liver cancer may be reduced by drinking in moderation.

6. Limit amounts of salt-cured, smoked, and nitrite-cured foods: Cancers of the stomach and esophagus are more common in people who consume large quantities of these foods.

"Switching to a cancer risk-reducing diet doesn't necessarily mean beginning a life of self-denial," Sheppard said. "Just be aware of what you eat. Instead of having a piece of cake for dessert, have fruit. It will satisfy your craving for something sweet and will reduce your intake of fats and increase your intake of fiber and vitamins in the bargain."

"Simple things, like switching to low-fat or skim milk, eating leaner cuts of beef or adding more chicken and fish, can make a big difference," he added.

Sheppard said smokers should take one additional step to reduce their cancer risk. "Quitting smoking should be the first thing smokers do if they want to help prevent cancers. Unlike the debate about nutrition, there's no question about the link between tobacco and a number of cancers."

The American Cancer Society's free nutrition pamphlet, "Eat To Live" includes the Society's recommendations, as well as recipes based on these guidelines. The "Eat To Live" pamphlet will be distributed by volunteers to all households in Washington County during this year's Cancer Crusade beginning Sunday, April 20th. Or, you may get a free copy by contacting the Washington Unit of the American Cancer Society by calling [414] 784-6669.

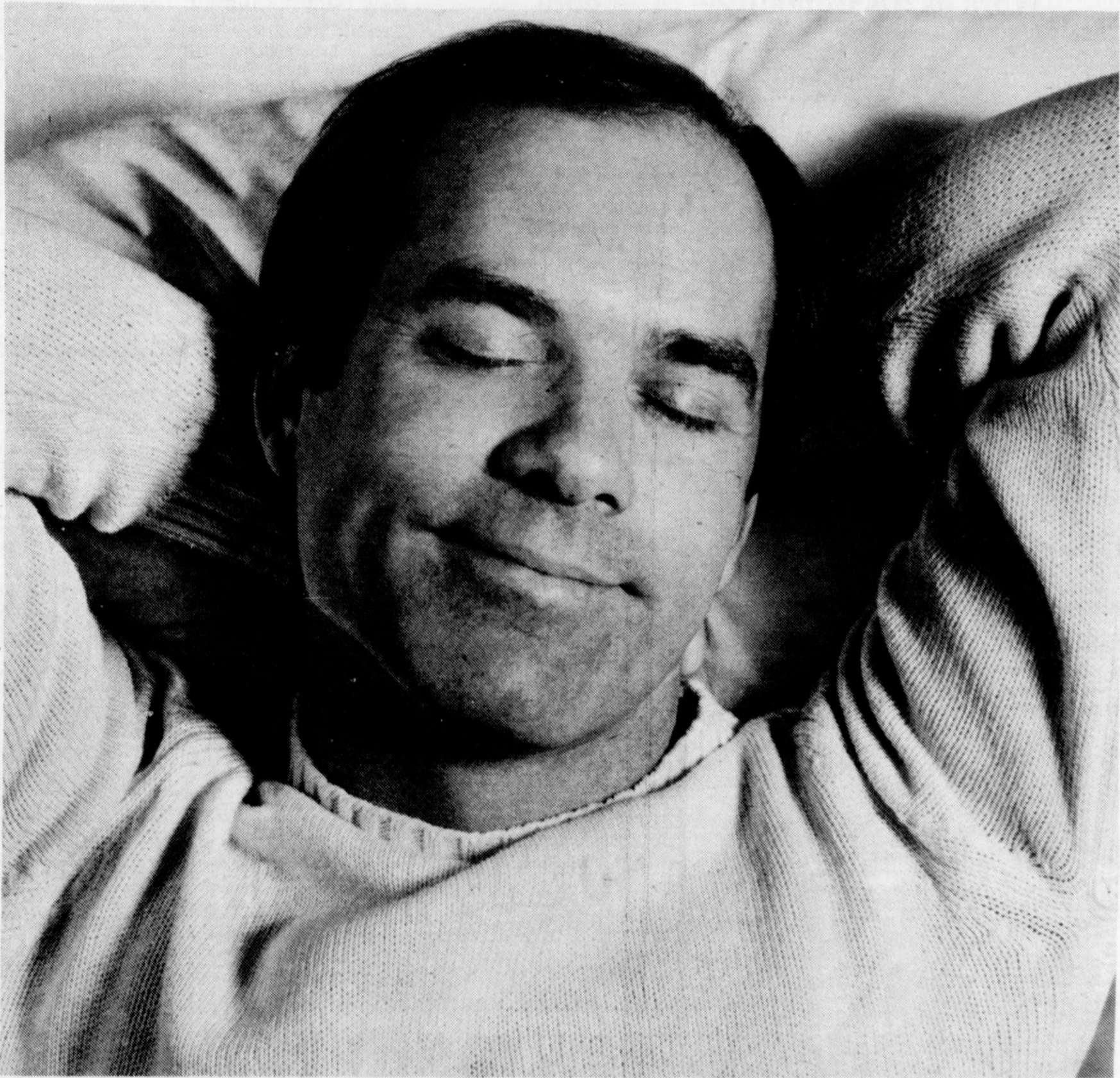

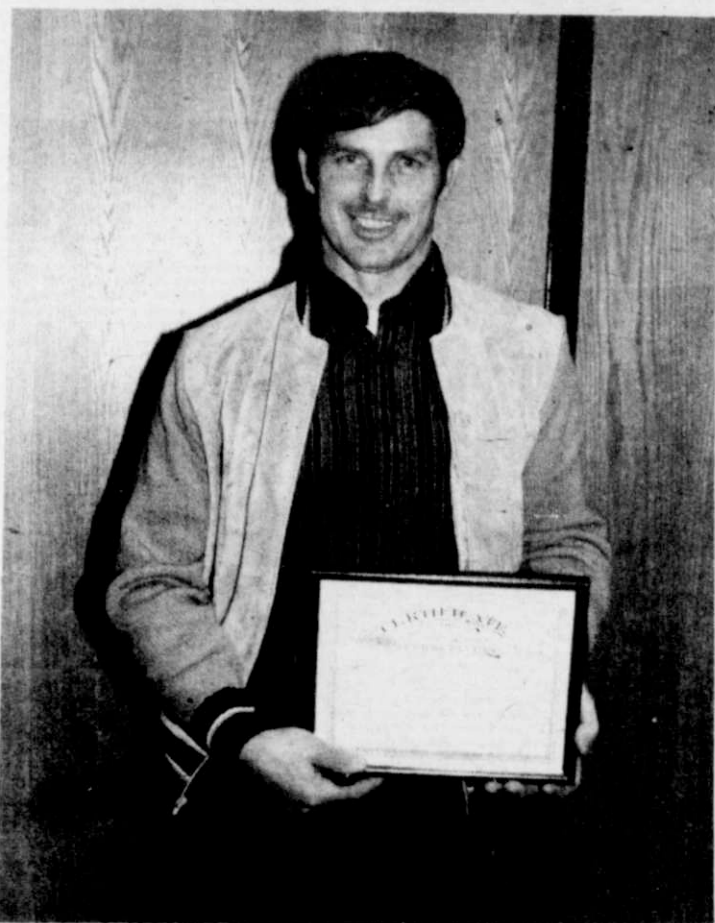

Finnish researchers divided couples with hypertension into three dietary groups: 1. a low-fat diet with high ratio of poly-unsaturated [vegetable] fats; 2. a low-salt diet; 3. their normal diet. 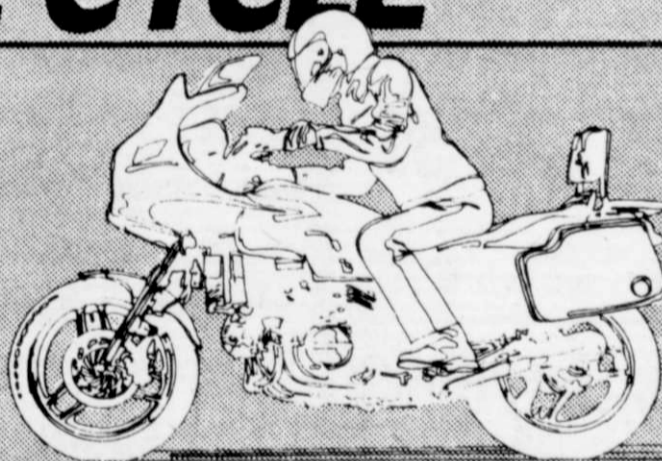

Trout Stocked in 21 Southeastern Wis. Ponds, Lakes

Trout stocking in municipal park ponds, a program that began last year, has been expanded this spring to 21 ponds and lakes in six counties of southeastern Wisconsin, according to the Department of Natural Resources.

The program is geared to providing quality recreation to groups that often lack mobility to seek out good fishing spots away from home, explained Ron Piening, Southeast District DNR fisheries biologist.

"The objective is to provide recreational fishing for juveniles under 16 years of age, the handicapped, senior citizens, and others who might lack mobility," he said.

About 300 rainbow trout per acre, sized at or over the legal limit of nine inches, are being released in the selected ponds after ice melts. Piening expected stocking to take place the last week of March, before urban schools recessed March 28 for Easter. Stocking is done through the cooperation of DNR and participating municipalities.

Last year's experiment stocking rainbow trout in 12 ponds was highly successful, Piening reported. Creel censuses showed heavy fishing pressure, especially by boys and senior citizens, with the result that almost no trout remained in the stocked lagoons after mid-May. A cold-water fish, trout don't survive when mellowing weather warms their waters.

Fishing begins immediately after stocking, Piening reported. The daily bag limit is five legal-sized trout.

Piening reminded anglers that those between the ages of 16 and 65 need a fishing license and a trout stamp. Persons over 65 and certain handicapped persons can receive a free license at DNR offices and county courthouses where licenses are sold.

Washington County: Hartford millpond.

Waukesha County: Minooka and Muskego Park ponds.
