## School Board Approves 8 Period Day

On a 5-2 vote Monday night, the Kewaskum School Board approved the implementation of an eight-period day at the Kewaskum High School beginning with the 1987-88 school year. Board members Ralph Horner and Clara Trapp cast the two dissenting votes.

While Horner said he was basically in favor of the eight-period day, he had some concerns about the "5-1-1" concept. That schedule would mean a teacher's day would consist of five classes, one professional contact period, one preparation period and one supervision period. The class periods would be normal teaching schedules. For the professional period, teachers would be assigned to various tutorial labs, and/or use the time for committee or

curriculum development work. Each teacher would have one supervision period and one preparation period.

Horner said he was afraid this would filter down to the middle school. "How are you going to say its okay for the high school, but you middle school teachers must keep your present schedule. Also, how will this affect the district fiscally?"

Trapp asked Director of Instruction Julie Backus, "can you guarantee this program will benefit the kids?" While it could mean a six-class day for students on the sophomore through senior level (freshmen are required to take six), the taking of an additional course or participation in labs will be voluntary on the students' part. There was concern expressed at last month's meeting that some

students may not put the extra period to the use for which it was intended. Instead of taking an additional credit or seeking extra help in a lab, the time could just become a third study hall. At that meeting, one of the board members told Backus, you can't twist a kid's arm to go to a lab for extra help.

While the board was under the impression that this proposal had the full support of the high school faculty, there were apparently some reservations and questions which some of the teachers felt had not been addressed to their satisfaction.

Denise Leong, one of the teachers who served on the committee which prepared the "Working Papers" including the eight-period plan, told the board the proposal presented Monday night was not

Kindergarten, Busing Recommendations Heard

## Meeting Date Set for Beechwood School Decision

The Kewaskum School Board has scheduled Monday, January 19th, as the date to hold a Special Electors Meeting to vote on the sale of the Beechwood Elementary School which was closed earlier this year.

The meeting will be held at 8:00 p.m. in the commons area of the high school. At that time the district's residents will have the opportunity to hear the recommendation and vote on whether or not to give the school board the power to sell the property.

The recommendation is the result of several meetings and a study by the Beechwood School Disposition Committee which looked into the options as to what could be done with the facility.

Over the past year there have been disputes between the

board and Beechwood area residents regarding the enrollment and the need to keep the school open. Residents say the enrollment has remained constant or risen slightly while the administration has contended the enrollment has, and would continue to decline at the school making it economically unsound to continue operation of the school.

In other action, the board heard readings on several policies and job description recommendations from the Policy and Legislation Committee. Among the changes is a recommendation to increase the length of kindergarten classes by 20 minutes to meet new state requirements approved last summer. The new standard states kindergarten students must receive 525 hours of direct instruction.

The length of the morning

## Teacher Contract Negotiations Stalled

After several weeks of bargaining, contract talks between the Kewaskum School District and Kewaskum Education Association "have come to an impasse" according to school board Negotiations Committee Chairman Perry Ankerson.

Ankerson informed the school board Monday night that the two sides could not come to an agreement so the next step will be arbitration. He noted that, at

the present time, neither a date or arbitrator has been selected to continue the negotiating process.

According to Ankerson's report, the district's final offer was a package containing a 5% total increase for 1986-87. That offer would represent an average per teacher increase of \$1,125 in salary only, \$1,513 including both salary and fringe benefits. Under the district's offer, the average teacher's wages would be \$32,433 plus fringes.

The KEA is asking for a 8.5% raise. Under its proposal, the increase would mean an average salary only increase of \$2,050, including salary and fringes that would equal a hike of \$2,626. This would bring the average teacher's wages to \$33,546 plus fringe benefits.

Along with the wage proposals were some changes in contract language relating to health insurance, sick day usage, personal days and promotion credit requirements.

KEA representative David Wietor, on behalf of the union, asked the board to implement its 5% increase offer effective immediately. District Administrator Penny Kleinhans said that would mean, if the contract were settled in favor of the district's proposal, salaries would already be in places according to the 1986-87 schedule with minor adjustments. When the contract was settled, and if it went in the KEA's favor, the district would then have to go back and make up the difference between the 5% and 8.5%.

The motion to put the district's contract proposal into effect immediately died for lack of a "second" to the motion. The teachers will continue to work under the 1985-86 schedule until negotiations are settled.

Ankerson told the board the next steps will be for the two parties legal representatives to select an arbitrator and schedule a meeting date.

The Kewaskum High School's Music Department will present a Christmas concert on Sunday, Dec. 21, at 7:30 p.m. in the high school auditorium.

Each of the school's four performing groups will participate. The Concert Band will perform "Holiday For Bells," "Variations on an Echo Carol," "We Three Kings of Orient Are," and "A Christmas Medley." The Treble Choir's selections include "Shepherds Awake," "Star," and "Lo, I Bring You Tidings." The Symphonic Band has "God Rest Ye Merry Gentlemen," "A Norwegian Christmas Overture," and "The Christ-

mas Suite" on its program. Among the Concert Choir's pieces are "Troika," "Joy" and "Gesu Bambino."

A highlight of the evening will be the Symphonic Band's rendition of "How the Grinch Stole Christmas" narrated by Leighton Peterson and sung by Jackie Schoofs.

As in years past, the concert will close with the singing of the "Halleluiah Chorus" from Messiah by G. F. Handel. Anyone in the audience is welcome to participate.

The KHS Swing Choir will provide pre-concert music beginning at 7:00.

## Lomira Area Couple Killed In Town of Auburn Accident

A Route 1, Lomira, couple were killed early Saturday morning when the car they were riding in left the roadway at a curve and struck a tree.

Both dead after suffering massive bodily injuries were Donald L. Waehler, 55, and his wife, Joyce M. Waehler, 53.

According to the Fond du Lac County Sheriff's Department, the car, driven by Donald, was westbound on Highway 67, approximately one-half mile west of Highway 45 in the Town

of Auburn when the accident occurred.

The accident happened at 12:20 a.m. along a dark curve. Cause of the accident was not immediately determined.

Funeral services for Mr. and Mrs. Waehler were held at 10:30 a.m. Tuesday at Immanuel - Trinity Lutheran Church, Fond du Lac, with burial in Rienzi Cemetery. Friends called at the Kietzer Funeral Home, Lomira, from 3 to 8:30 p.m. Monday.

formulated by the committee. "There are still some issues such as the 45-minute class period which some teachers feel is too short, also the definition of what a professional period is." Leong told the board, "what I object to is, toward the end of the process we were not involved."

District Administrator Penny Kleinhans told Leong she was personally very upset that nobody came and approached her on this before the meeting. She noted the agenda had gone out on December 3rd listing the proposed recommendation of the eight-period day. The committee could have met prior to Monday's meeting, she noted. Backus said she would accept the blame in not arranging a committee meeting when Leong brought her concerns to her.

Kleinhans indicated she could not understand why there should be any problems. This recommendation is exactly the way the committee presented the proposal in its working papers, she noted. Leong said she thought the proposal would go back to the committee for further work on the points she had mentioned. No one had expected the recommendation to be approved so quickly.

High School Principal LeRoy Kopecky, who wrote up the final recommendation, said, "I think what I've heard are the concerns that the 5-1-1-1 schedule is not included in the contract."

Board member Kim Peterson asked Leong, "do you agree with the proposal outside of the fact that some toes were stepped on?" Leong said, with the proposal itself the teachers are concerned with the shortened period and the negotiations portion.

Peterson then asked if going to a 50-minute period had been considered. Kopecky indicated that would present several complications. "If we go past the cutoff time we would have to alter bus schedules and we would have to delay middle school students who leave at the

same time. Also, teachers teaching at the middle school would not be able to continue there because some of their time is shared with the high school."

Trapp told the board the eight-period day apparently did not have the full support of the faculty because she had received calls from two teachers who were afraid to talk against it without receiving criticism. Gerald Gosa, of the Science Department, said he had gone on record as being opposed to the plan, not because of the proposal itself but the fact that a 45-minute class would be difficult to work with in setting up and running experiments. Howard Zemlicka also indicated set-up time in shop classes would also result in less work time for students.

After listening to the exchange between Leong and the board, board member Perry Ankerson said, "the administration is looking around asking what the He — happened, now we're damned if we do and damned if we don't approve this recommendation."

session will change from 9:05 to 11:45 a.m. to 9:05 to 12:00. Afternoon classes which now start at 1:05 and run until 3:40 will begin at 12:45. The time changes will have no effect on bus routes.

The board also heard a recommendation from the Finance-Transportation - Buildings and Grounds Committee that the district not become involved in busing arrangements for students attending Kettle Moraine Lutheran High School. Because the school is outside the district's busing boundaries, it is not required to provide transportation.

KML was advised to contact Johnson Bus Company and make its own arrangements rather than go through the district.

Assistant High School Principal Roy Esser advised the board he is working with the area parochial schools in updating their boundary lines in

determining the district's busing responsibilities to them. There was some question that some students may be being bussed to areas outside the district's boundary.

Buildings Superintendent Fred Boehlke advised the board on the status of the Wayne well, completion of the high school track repair, Kewaskum Elementary School roof repair, and the pipe problems at the middle and high schools.

The board again discussed the proposal of a cooperative class-work experience program. However, as a result of board member Ralph Horner's objection that the item had not been placed on the agenda by a member of the majority who had originally voted against it, no action could be taken other than discussion.

Following the discussion, board member Perry Ankerson

moved to place the item on next month's agenda as an action item.

Food Services Supervisor Barbara Niehaus reported to the board on the DPI's audit of the district's food services. She said three changes were made to comply with the report. They included a change in the method used to determine free and reduced meals, recording of bread and daily production records, and the covering of lights in the Wayne School kitchen area to prevent glass from falling into food if a light were broken.

There was a discussion by board member Kim Peterson concerning the activities of board member Clara Trapp with respect to executive sessions. He asked Board President Tom Brigham what disciplinary

action could be taken against, as he put it "a member who talks out of school, so to speak." Brigham said he would not entertain any motion for censure, noting the only reason he had censured Trapp earlier this year had been to protect the other board members from possible lawsuits from two other school districts.

In reply to Peterson's comments, Trapp said they were lies and she was tired of being harassed by other members of the school board. Trapp noted that Peterson had no one at the meeting who could back up his comments about her divulging information from closed sessions.

The latest incident concerned a closed meeting in which the

**Stephen R. Portch**

WEST BEND — The new chancellor of the University of Wisconsin's 13 two-year centers will make his official get-acquainted visit to Washington County on Dec. 12.

Stephen R. Portch, 36, will meet with county and campus leaders during a series of afternoon meetings at the UW Center-Washington County. His visit will focus on future UW plans for maintaining quality education in the face of rising costs.

Portch began his new duties on Nov. 1 after serving at UW centers for 10 years, first as an English professor and later as an executive dean.

At the time he was named chancellor, he had been dean of the UW Center-Marathon County in Wausau for five years. From 1976 through 1981, he was an assistant professor of English at the UW Center in Richland Center.

In recommending Portch for the chancellor's post, UW System President Kenneth A. Shaw called him "an outstanding scholar, teacher and administrator." Shaw said, "He brings to his new position imagination, intellectual vigor, dedication to the mission of the UW Centers and a fine sense of humor."

A native of England, Portch graduated there in 1973 from the University of Reading, where he majored in English literature and language. He began his teaching career in the Junior School of St. Lawrence College in England.

Portch received his MA and Ph.D. in English and higher education from the Pennsylvania State University, where he was a graduate assistant.

In 1979, Portch received the UW Centers Chancellor's Exceptional Merit Award and, last year, the UWMC Faculty Recognition Award for Support of Professional Development.

He is a tenured associate professor of English and serves as a North Central Association accreditation consultant-reviewer and an international baccalaureate oral examiner.

Portch succeeds Lorman Ratner, who resigned in July as executive dean of the UW Centers to become dean of liberal arts at the University of Tennessee-Knoxville.

The new chancellor was appointed Oct. 10. He receives an annual salary of \$73,000.





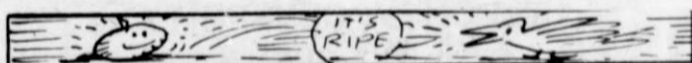

The Village Board of Kewaskum, Washington County, Wisconsin met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President David E. Nigh presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

The basic news was favorable with the gross rate to be required increasing 2.9% or 78c per thousand of assessed value. The net rate would be even more favorable with an increase in the state tax credit the increase equals a .5% or 12c increase per thousand assessed value.

Copies of the three year audit proposals received were distributed for the Board to review. Action will take place at the December 15, 1986, meeting regarding the selection of an accounting firm.

## ORDINANCE NO. 86-8

ORDINANCE TO AMEND A SUBSECTION OF CONDITIONS TO DISCHARGE INTO TREATMENT SYSTEM IN THE VILLAGE OF KEWASKUM, WISCONSIN

The Village Board of the Village of Kewaskum, Wisconsin do ordain as follows:

That Section 13.50 (7) of the Municipal Code of the Village of Kewaskum, Washington County, Wisconsin, is hereby repealed and recreated as follows:

(7) Any person owning or controlling property within the corporate limits of the Village which is improved with one or more residences, houses, buildings or structures for or intended for human use, occupancy, employment or any other similar purpose whatever, and abutting on any street, alley or right-of-way in which there is located a sewer within 100' from the nearest property line shall, within 90 days after such sewer is in service, at his expense install suitable toilet and waste disposal facilities in the residences, houses, buildings or structures and connect the facilities with the sewer in accordance with the terms and provisions of this chapter. Such person shall apply for and obtain permission for the installation from the Village Board. A permit fee of \$200.00 for each living unit contained in said building shall accompany the application for such sanitary sewer connection. In the case of a hotel or motel, each unit shall be considered as a living unit. In the case of a rooming house, guest house, nursing home, or other similar structure, each service unit shall be considered as a living unit.

This ordinance shall take effect the day after passage and publication as provided by law.

Such registration shall be non-expiring during the ownership of the bicycle by the licensee. Such registration shall be serially numbered and kept on file by the Chief of Police or his designee in the Police Department as a public record.

# New Snowmobile Map and Winter Guide Available Free

MADISON — Snow time is here. Skiers are waxing, snowmobilers tinkering, skaters sharpening. And all are looking for new and exciting places to enjoy their sport.

The Wisconsin Division of Tourism has the perfect answers in two publications just off the presses. One is a "first." The Wisconsin Snowmobile Trails Map will be as helpful to snowmobilers as the official Wisconsin Highway Map is for motorists.

The other is the Wisconsin Winter Recreation Guide, a tabular guide to downhill and cross-country ski resorts and trails, and snowmobile trails. It lists length of runs and trails, vertical drop of ski hills, and facilities available at resorts and trail heads.

The snowmobile map was published by the Wisconsin Department of Development Division of Tourism with the aid of the Wisconsin Department of Natural Resources, the Wisconsin Department of Transportation, the Association of Wisconsin Snowmobile Clubs, and the Governor's Advisory Council on Snowmobiling. It was produced at the U.W. Cartographic Laboratory.

The map illustrates numbered snowmobile routes. It splits the state into two halves, with the southern half on one side and the north on the other. The scale is 1-inch equals 8.4 miles. Various colors are used to delineate north-south trails, east-west trails, "self-funded" public trails, and snowmobile club trails "believed" to be available to the public.

"The Winter Recreation Guide is an updated listing we've offered winter sports buffs for years, along with our ski run and trail condition report each week," said Milt Strauss, Administrator of the Division of Tourism. "But the snowmobile map is a long-awaited first that should fill a big void. Until now snowmobilers had to rely solely on trail maps produced by each county, meaning they needed 72 documents. Now all the

pertinent information is available in one source that can be folded small enough to fit into a snowmobile suit pocket."

"Publication of the snowmobile map is another example of how we try to meet growth and changes in Wisconsin's tourism industry," Strauss said. "Through cooperation among several state agencies and the private sector, a long-felt need has been met."
