Action to Remove Fellow Board Member's Agenda Items Illegal

## No Conflict of Interest Says School Board

Try as he might, school board member Perry Ankerson could not muster any support from fellow board members to at least approve his motion that board member Clara Trapp has a conflict of interest which is in direct violation of the board's newly adopted code of ethics.

In making his motion Ankerson told the other board members he was not asking them to seek Trapp's resignation but to at least acknowledge

that she did have a conflict of interest. He read verbatim from the board's new ethics policy. "I must avoid all conflicts of interest — both pecuniary and nonpecuniary."

"I think we are currently faced with a board member that is in serious violation of that code and I think to sit idly by and do nothing about it only mocks our code of ethics and mocks our policy book. I think it is appropriate that we take a stand and I think we should all look within ourselves and ask

ourselves the question of whether or not she has a conflict of interest in certain matters that have come before this board and may come before this board." He admonished the board to do something to express its concern.

In referring to Mrs. Trapp's several abstentions in voting at a recent Policy Committee meeting, in relation to policies concerning the administration, Ankerson asked the board, "If Mrs. Trapp felt she had a conflict, how can we sit here and pretend she doesn't have one?" We are making fools of ourselves, we have no principles," stated Ankerson.

Board member Ron Theusch told Ankerson he would second the motion, "only for the sake of discussion." Theusch told Ankerson he did not agree with him or his interpretation of the code of ethics. "Mrs. Trapp should be allowed to handle her responsibilities as a board member," said Theusch. He felt that Trapp would, on her own, decide to abstain from voting on any issues in which she felt there was a conflict of interest. "Our attorney said issues could be handled by her (Trapp) simply not voting on it," said Theusch.

Theusch admitted, "In some narrowly defined areas Mrs. Trapp has some conflict of interest." Ankerson replied "I contend she has not avoided all conflicts of interest."

A board member noted Mrs. Trapp was not directly a part of her husband's suit. "She is not, 'not' part of the suit," said District Administrator Penny Kleinhans, "she is a part." With that, Kleinhans read a portion of the suit in which Mrs. Trapp's name was mentioned more than once.

Theusch told Ankerson, "I don't know where we'd go from here even if we recognize it (the conflict)." "Then I would have asked what you are going to do about it" said Ankerson.

Kleinhans told the board, people are to be held to the standards in the policies and if that is not done, she asked, "then why are we adopting codes of ethics?"

"As far as discussion of the school board," said Ankerson, "when someone comes up to me and says you know you've got a real problem on that board as far as conflict of interest, I can say, I know I brought it up. If someone comes up to me and says you had no business persecuting Mrs. Trapp, she has no conflict of interest, I'd say I think you

A week-long grand opening celebration will mark the formal introduction of the General Store Antique Mall to the Kewaskum area.

The mall, which had its unofficial opening this summer, houses the antiques and collectibles of thirty-two dealers from throughout the state.

Jeanne Griep, owner of the mall, said she and her staff of four employees handle all the sales for the dealers who display their wares in space leased from her.

Although Griep herself is interested in antiques, she does not sell any of her own items. "I don't think it would be proper to compete with the other dealers," she said.

"Business has been very good" stated Griep. In fact, all of the building's first floor space is filled. "Right now

we're in the process of remodeling the second floor." Griep said she already has a waiting list of eighteen more dealers for the upper level when it's completed.

"We're drawing customers from all over and quite a bit of our business comes from the Chicago area" said Griep.

Griep said the mall's grand opening will run from November 14th through the 22nd. There will be daily drawings for gift certificates and many in-store specials.

### Kewaskum FFA Officers Selected To Attend National Convention

Kewaskum FFA officers Dave Steger, Dallas Wodsedalek, Bob Friedmann, and Dave Schmidt were selected to attend the 60th National FFA Convention in Kansas City, Missouri, November 12 - 14.

They joined more than 22,000 FFA members, advisors, supporters and guests representing all fifty states, the District of Columbia, Puerto Rico and the Virgin Islands at the world's largest annual student gathering.

The 60th anniversary convention features keynote addresses from Vice President George Bush, Chrysler Corporation Chairman Lee Iacocca, Secretary of Education William Bennett and former Dallas Cowboys quarterback Roger Staubach. Along with these speakers, the officers have the opportunity to hear FFA's finest during public speaking contests and when the retiring national officers give their farewell addresses.

FFA was founded in Kansas City in 1928 at the old Baltimore Hotel, located just a few blocks from the municipal auditorium where the convention currently resides. Since then, the gathering has grown from fewer than fifty students to the world's largest annual youth gathering.

During the convention, high school agriculture students challenge themselves and honor FFA's highest achievers and strongest supporters.

Other highlights include the naming of top FFA members in 29 agricultural proficiency areas and in ten national career skill competitions, as well as the Agriscience Teacher of the Year award. Top chapter programs in safety, community development and overall activities are also recognized.

Thursday evening at the convention, the Star Farmer and Star Agribusinessman of

America, the two FFA members with the most outstanding production and agribusiness programs respectively, were announced. At the Friday afternoon session the highest degree awarded to FFA members, that of American Farmer, will be presented to 728 recipients. Roy Esser, Vice Principal at Kewaskum High School will be receiving this award. Of those 728 members this is only the top two-tenths of one percent of the organization's 416,000 members.

"The convention is an excellent opportunity to motivate members and train them for their futures in the ever-changing agricultural industry," said Kevin Eblen, national FFA president from Creston, Iowa. "It is also an occasion for recognizing individual members, chapters, advisors and alumni for outstanding achievements in the FFA."

The convention introduces the national FFA theme for 1987-88, FFA-Agricultures New Spirit, which emphasizes FFA's contribution to the agricultural industry.

"There's no doubt agriculture is facing some major challenges today," said Dr. Larry Case, national FFA advisor. "But if your looking for the future of this industry, it will be found at the national FFA convention. These young people represent the new generation of leadership that will carry American agriculture into the 21st century."

The national FFA Alumni Convention and the National Agricultural Career Show were scheduled in conjunction with the convention and are held in H. Roe Bartle Hall, located next door to the municipal auditorium and the National FFA Convention.

should talk to Ron Theusch because he has the same opinion as you do on that matter."

"I don't apologize for bringing it (the conflict) up, and if it would have happened to Ron I would have brought up the same thing and I would call him in violation of our code," Ankerson told the board, "I'm not attacking Mrs. Trapp. I am attacking the fact that someone is in violation of a code of ethics that we just passed and we choose to do nothing about it. That is what I think is so immoral. That is what bothers me so much."

In reply to Ankerson's comments, Theusch stated, "I am sure there will be a perception that we have done nothing about this."

The vote on Ankerson's motion to recognize Trapp's conflict of interest with the code of ethics was six to one, against the motion. On a motion which specifically concerned her, Trapp not only "did not abstain" from voting, she cast one of the six votes that defeated the motion.

A second item placed on Monday night's agenda by Ankerson was a request for a written legal opinion regarding action to remove agenda items placed by board members.

That issue concerned board member Ruth Schmitt's motion to remove an item placed on the October 26th meeting agenda by Ankerson concerning "discussion and possible action relative to the lawsuit initiated by Charles Trapp against Superintendent Kleinhans."

Attorney Michael Spector's opinion was that the action

taken at the October meeting was not legal in that the only person who may remove an item is the board member who placed it on the agenda.

In asking for the opinion Ankerson said "It is not so important that it was done to me, it's important that it can be done to anyone." You talk about setting up a precedent; that would be a terrible precedent to set up." Ankerson said, "it was a violation of my rights, you voted literally to strike the item from the agenda, not move it to a closed session." "It was a power play to shut me up," said Ankerson. "It was very obvious to me that it just didn't pop into your mind the night of the meeting and it was obvious to me the vote was going to be 4 to 3, as soon as I heard the motion. That's why I asked for a legal opinion on whether you could do that. The bottom line here is it is not legal to delete an agenda item."

In trying to justify her action Schmitt cited past procedures and Roberts Rules of Order, which she said made it legal for her to present such a motion. Ankerson asked Schmitt if she had a copy of Mr. Spector's letter. She said yes. Schmitt again referred to Roberts Rules of Order. Kleinhans interjected that Schmitt was, in fact, improperly interpreting those rules. Kleinhans noted in checking with parliamentarians, the rule Schmitt was using to justify her action did not apply in this situation and went into effect only after a motion had been made and discussion begun.

"Do you understand the difference between objecting to something and voting it off the agenda?" Ankerson asked Schmitt. Schmitt told Ankerson "the only way that you were punished in any way was that

the motion was delayed somewhat until we could receive the information." "Regardless, Ruth, of why you did it, you are still in violation of the law," said Ankerson.

Ankerson said he had been advised of legal steps which he could take. He indicated that he did not wish to take any such action, he only wanted the matter brought to the board's attention so it never happens again.

A short time later Ankerson left the meeting.

In other business the board approved snowplowing contracts for the coming winter and math curriculum changes at the high school.

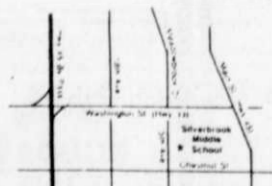

## What Is Fitness?

Overall fitness can be defined as a combination of physical, mental and emotional well-being. Fitness implies a positive outlook on life with enough strength and stamina to perform the daily tasks of living with energy to spare for leisure pursuits. The physically fit person besides having reduced risks of hypokinetic disease, is more likely than his unfit neighbor to feel good, look good and enjoy life. He can work and play more effectively; he is more creative and less likely to suffer from anxiety, depression and psychosomatic illness.

There are five major components (health related components) of physical fitness. The first is Cardiovascular endurance, this refers to the ability of the body as whole to participate in an activity for an extended period of time. This involves the heart, blood vessels and respiratory system. Second is muscle strength, this is the ability to exert a great amount of force in a single effort. Think of this as people lifting hundreds of pounds in one lift. Third is muscle endurance, this is the ability to exert a moderate amount of force over a long period of time without great fatigue. Muscle endurance is greatest in long runs or triathlons. Fourth is flexibility, this is the ability of muscles and joints to move through a wide range of motion. Fifth is body composition, this is the percentage of fat to lean body mass (bone, muscle and other tissues). A fit person has a low percentage of body fat. People with very low body fat are body builders.

People can improve in all components of fitness. Aerobic classes or activities will improve these components. Try exercise, you will love the benefits. Consult your doctor before you begin an exertive program. Be cautious if you are over 40, have high blood pressure, high cholesterol, or are obese.

## Dear Betty Crocker

**Q.** My muffins are often soggy. What's the solution?  
**A.** Remove from muffin cups right away so they don't steam. Muffins are best served warm, anyway. Wrap leftovers tightly and store in refrigerator.

**Q.** Can I use my mixer for kneading bread dough?  
**A.** When you use a dough hook on a standard countertop mixer, the dough will be kneaded enough for satisfactory bread but volume may be lower than those kneaded by hand. Loaves mixed with a heavy-duty mixer will have higher volumes than with a standard model. Follow manufacturer's directions for best results.

**Q.** How can I clean my wooden cutting board?  
**A.** Clean wooden board surface regularly with a solution of one teaspoon chlorine bleach and ½ teaspoon vinegar to two quarts of water. Keep a plastic cutting board on hand to use with raw meat or poultry because the plastic is more easily cleaned.

**Q.** I'd like to know how to make flaky biscuits.  
**A.** Use a pastry blender to cut in the shortening until the mixture resembles fine crumbs. The shortening surrounds particles of flour, creating layers. Then, knead the mixture lightly, ten times, to mix thoroughly.

### Parents' Involvement In Schools Helps Children to Learn

Education doesn't end for the day when children get off the school bus. What parents do to help their children learn at home pays off in the classroom.

But parents also can make a crucial difference by getting involved with their children's schools.

Studies on effective schools shows that the one thing schools with high-achieving students have in common is a high level

of parental involvement. Other studies show that when parents participate in their children's schools, children's attitudes about school improve and their motivation to learn increases.

Researchers have been able to identify some of the elements of good parent-school relationships.

First, parents and teachers must see themselves as part of a partnership. Each should understand the other's goals and values. This enables them to support rather than undermine each other. Frequent communication helps

make this happen.

Second parents and teachers need to recognize the importance of each other's roles. The best relationships are developed when parents are seen as experts at home and teachers as experts at school. When parents and teachers talk, the most productive discussions focus on the student not on whether or not one is a bad teacher or parent.

Based on these findings, the following are suggestions for parents interested in getting involved in schools:

**Keep the lines of communication open.** Find a positive way to get to know your child's teacher early in the school year. Visit the school if you can and talk to the teacher about his or her goals for the year. Don't hesitate to drop the teacher a note. The more communication, usually the better the relationship. If you can't make a scheduled parent-teacher conference, arrange a telephone conference. Make sure the teacher has your number at work and encourage the teacher to contact you about your child's progress.

**Consider volunteering.** Whether it's fundraising, ethnic cooking or coordinating a science fair, you have something to give that can greatly enrich your child's school

experience. But offer no more than you can deliver. It is better to keep a monthly volunteer commitment or take on a special project, than to back out of a weekly commitment.

**Offer suggestions diplomatically.** Describe your idea, suggestion or concern briefly. Specify two or three alternative responses that would be acceptable to you, and leave the way open for the school to offer other ideas. If your requests or suggestions do not elicit the response you had hoped for, be persistent. Find another to describe your idea. You may be ahead of your time, and it may take time for the school to set up a mechanism for responding to your ideas.

**Respect the teacher.** Teachers have prepared many years for their work. They are more likely to be open to parent involvement in education if they know that you respect their training and contribution. Ask teachers for their suggestions of what you can do to help your child learn. Let the teacher and principal know when you are pleased with something one of them has done. Be specific. When you have a complaint, discuss it with someone who is responsible for it, rather than your neighbors.

The "Year of the Family in Education" in Wisconsin

begins with this new school year. Through special activities and events scheduled throughout the school year, all Wisconsin school districts hope to increase parent and community involvement with schools.

The Washington County Extension Office is cooperating with this effort by offering resources to parents of school-age children throughout the next year. We have a variety of publications of interest to parents, including "Getting to Know My Child's School" and Becoming Part of Your Child's School.

## New IRS Ruling Revokes Prior 'Pik-and-Roll'

Farmers will be interested in a recently issued Internal Revenue Service ruling which revokes the prior "Pik-and-roll" ruling.

The new ruling, 87-103, explains the federal income tax consequences of receiving generic commodity certificates, pledging grain to secure loans from the Commodity Credit Corporation (CCC) and using generic commodity certificates held by farmers to pay off loans. Farmers receive these certificates, which come in dollar denominations and are called PIK or payment-in-kind, as part of the government's price and income support program.

A farmer who receives a commodity certificate under a government deficiency and diversion program must include, in income in the same year, the face amount of the certificate.

If a farmer pledges a commodity to the CCC as security for a loan, he or she may elect to include the face amount of the loan in income for that year. If such an election is made, there is no gain or loss when the loan is repaid. There is gain when the farmer later sells the commodity for more than the certificate amount.

If a farmer does not elect to include the loan in income when received and uses the commodity certificate to repay the loan, he or she will recognize income in the year the loan is repaid. The amount of income the farmer includes that year is the amount by which the face of the loan exceeds the amount of the certificate. Later when the commodity is sold, the farmer recognizes gain or the full amount received on the sale.

Revenue Ruling 87-103 will be published in the Internal Revenue Bulletin No. 1987-43, dated October 26, 1987.

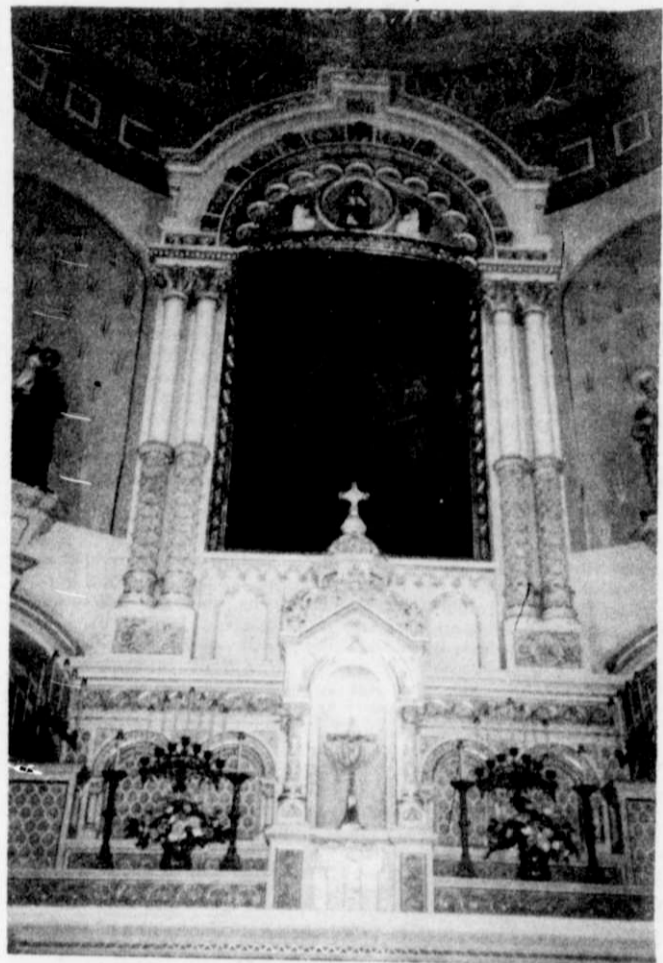

**Tips to Save Time and Trouble With Your Holiday Turkey**

Sometime between Thanksgiving and New Year's Day, turkey will most likely find its way onto your menu. And because time is one thing you don't have much of during the holidays, you'll be looking for shortcuts. The good news is that there are shortcuts you can take without risking an outbreak of food-borne illness.

**The Right Bird** — If finding the right-sized bird is critical, buy a frozen one early and save yourself the trouble of running from store to store Thanksgiving week. Keep the turkey frozen until you're ready to thaw and cook it. To keep food safe, a freezer should register 0 F or slightly lower.

If you don't want a large turkey taking up space in your refrigerator for four or five days while it thaws, order a fresh bird ahead of time and pick it up one-to-two days before cooking.

**Watch Out with Pre-Stuffing** — Many groceries are now offering pre-stuffed fresh, whole turkeys. While these birds will be marketed as a time-saver, from a food-safety standpoint, they can cause problems. A raw turkey and stuffing ingredients are highly perishable. When a turkey is stuffed, incubator-like conditions develop in the cavity, which can promote bacterial growth. In a home refrigerator, it's nearly impossible to keep the stuffing deep inside a pre-stuffed turkey under 40 F — the temperature below which most bacterial growth is halted.

For these reasons the U.S. Department of Agriculture does not recommend purchase of whole, stuffed fresh poultry. For quick and safer alternatives, consider stuffed and ready-to-cook items like boneless turkey breasts, chicken breasts, veal and pork chops. But carefully follow the "best if used by" dating and direction on preparation to ensure food safety and quality.

**Handle Pre-Cooked Birds Carefully** — Of course, the ultimate shortcut is a pre-cooked turkey. But pre-cooked birds must be handled carefully too. The best approach is simply to serve it immediately. Eating it right away also assures the best quality, as cooked meat often develops an "off" or "warmed-over" flavor when reheated.

If you don't want to serve a pre-cooked turkey immediately, then it must be cooled down quickly to below 40 F. It's impossible to rapid-cool a whole turkey in a standard home refrigerator. So, if the turkey is stuffed, first remove the stuffing and place in a shallow container. Remove the meat from the carcass and wrap it in small packages. The meat can be stored in the refrigerator for three-to-four days; the stuffing for one-to-two days.

When reheating, preheat the oven to 325-350 F and plan on 10 minutes per pound so that the meat reaches a temperature of 160 F.

**Low Temperature Cooking: Potential Danger** — Turkey recipes that promote long cooking at a very low temperature (250 F or lower) have been popular recently. This method is not recommended. Because of the low temperature, the turkey and stuffing might take more than four hours to reach a high enough temperature to destroy bacteria. Turkey cooked under low temperatures could therefore be unsafe. The quality of the turkey might suffer too. During prolonged cooking, some areas would tend to become dry.

**Roasting Bags Can Save Time** — A safe way to cut cooking time is to use a commercial roasting bag. This can save you an hour or more, depending on the size of the bird. Plus, you can save an additional half hour of cooking time by not stuffing your bird. Using your microwave to cook the turkey is another time-saver, but don't try to microwave a stuffed turkey — a stuffed bird is too dense for microwaving to assure thorough cooking.

**Serve Food Wisely** — Serving turkey also requires some forethought. Trying to save time at the last minute, you may be tempted to put huge platters of food on the table long before the guests arrive. If these platters then sit out over two hours while the party goes on, bacteria could multiply and create a food-safety hazard.

To play it safe, make up smaller platters of food and keep them in the refrigerator or oven until you need refills for the table. Put your food out just before the guests arrive. You may want to use heated serving units such as hot trays or chafing dishes to keep food hot. These should hold the food at temperatures above 140 F. And remember, even in a heated unit, never leave food out over two hours.

**Keep Leftovers Safe** — When you've just finished eating, the last thing you want to think about is packing away the leftovers. But those cold turkey sandwiches you're looking forward to could be jeopardized if you don't quickly refrigerate the meat.

Follow this drill: Remove the stuffing from the bird and the meat from the carcass. Store them in meal-size portions in shallow containers. Leftover turkey will keep in the refrigerator for three-to-four days. Stuffing and gravy should be used within one-to-two days. Bring leftover gravy to a rolling boil (185 F) before serving.

**REPEALED ITEMS**

The Tax Reform Act of 1986 repealed a number of provisions of prior tax law. Some of the provisions repealed effective for 1987 and later years include:

**Sales Tax** — Under prior law, taxpayers were allowed to take an itemized deduction for state and local sales taxes actually paid during the year, or the amount from the Optional State Sales Tax Tables. Beginning in 1987, these taxes are no longer deductible. However, any sales tax paid or accrued on the purchase of an asset is added to the cost of the property.

**Deduction for a married couple when both work** — Starting in 1987, the new law repeals the special deduction granted to families when both husband and wife work. This deduction was equal to 10% of the earned income of the spouse with the lower income. The maximum deduction was \$3,000. This deduction, called the two earner deduction, is no longer allowed.

**Dividend Exclusion** — Under prior law, an individual could exclude from income up to \$100 (\$200 if filing a joint return) of qualifying dividends. For tax years beginning after 1986, this dividend exclusion will not be allowed.

**Income Averaging** — The general four year income averaging break that was granted to taxpayers to even out an unusually high income during a tax year, is now repealed.

**Capital Gains** — Before 1987, taxpayers could deduct 60% of net long-term capital gain from gross income. This deduction is no longer allowed. For tax year 1987, the full amount of the net capital gain must be included in income. However, the highest tax rate that can be imposed on the gain is 28%.

Short term gains will be taxed at ordinary rates. Taxpayers must still distinguish gains as ordinary or capital, and as either short-term or long-term. For tax year 1988, there will no longer be a distinction between short and long-term gains. Gains will be taxed at a maximum rate of 28%.

**Other Provisions** — Some of the other provisions repealed for 1987 include the credit for

political contributions, residential energy credit, investment tax credit for property placed in service after 1985, the adoption expenses deduction, and the charitable contribution deduction for those who do not itemize their person deductions.

# Snowmobiling Changed My Life

Four years ago while attending a support meeting the subject of snowmobiling came up. We were asked if anyone would be interested in going on the Multiple Sclerosis "500" run. Well, this question changed my life. Because of snowmobiling I have a unique outlook on life - or so I have been told. I would like to share this story with you.

I was the only person at the meeting that was interested in a snowmobile run. I brought the registration forms home to show my husband. We decided to give it a try. We also volunteered to help in any way we could. It wasn't long and someone from Wisconsin National M.S. contacted me about making speeches about the 500 run, to various snowmobile clubs. People around West Bend, Beaver Dam, or Plymouth might remember this. I always ended my presentation with the same comment, "I was diagnosed with M.S. last spring." I felt like people would stare at me to see if I still had all my fingers and toes. Up until I said this they had no idea I had M.S. I was not in a wheelchair or even using a cane. I looked "normal" like everyone else.

They would then ask questions about M.S. such as

insulation protects electrical wires. When any part of this myelin sheathing, or insulation, is destroyed, nerve impulses to the brain are interrupted, or distorted. The result is M.S. We really don't know from day to day how well we will be the next day."

Being able to accept this upon diagnosis is not easy. I was told by a neurologist that I had chronic progressive M.S. and should expect to be of wheel chair status in a year. At this point there is no cure.

Well, back to my story. Because of my 500 speeches I was undergoing an acceptance of my disease. Each group I told that I had M.S. became easier. It wasn't long and I did accept it. Sure, I still have my ups and downs on this but I remember my many friends from the 500 run.

The first year I got out of Froedert Hospital in Milwaukee for treatment of my M.S. That night we slept in Antigo for the start of the first 500 run. The next morning we were ready to go on our trip to Land o' Lakes. The miles were not figured out right for snowmobile trails vs. road miles so a total of about 394 miles were put on in 2 days that year.

Over the years, major improvements have been
