### Board Can No Longer Set Itself Apart from Suit

## Trapp/Kleinhans Lawsuit Already Costing School District Money

Whether it likes it or not, the Kewaskum Board of Education has found itself involved in the lawsuit between board member Clara Trapp's husband Charles and District Administrator Penny Kleinhans. The suit, which is in its preliminary stages and has not even gone to court yet, is making itself a major topic of board discussions.

As issues regarding the suit were discussed at Monday night's meeting Kleinhans told the board members, "keep one thing in mind, I did not initiate this suit." She also told them, "as your district administrator I would like the board to keep in mind you need to be careful about what you do and what you say."

While the board has made every effort to avoid becoming a part of that suit, it appears those actions are what have gotten it into the position of being responsible for close to \$4,000 in legal fees to date, with more bills on the way.

When Kleinhans was initially informed of the suit, she came to the board and asked that the district provide her with legal counsel. She felt the action was directly related to her duties as District Administrator and on those grounds, a lawyer could be provided for her through insurance carried by the school district which covers such situations as suits against district employees.

At that time, several of the board members felt the suit was a private matter between Mr. Trapp and Kleinhans. That feeling also appears to have been backed up by advice from the district's legal firm, Quarles and Brady and specifically, attorney Michael Spector who apparently told the board not to get involved. At the October 26th meeting board president Ralph Horner said, "our attorney feels it is a matter between Mr. Trapp and Ms. Kleinhans."

As a result of the board's declining to take any action, Kleinhans was forced to retain legal counsel on her own so she could respond to the complaint before the court's deadline. When she submitted subsequent bills for those services to the board for payment, her request was denied.

At the November 19th meeting, board member Ron Thesuch moved to submit the bills to the district's insurance carrier with a request for

payment. Business Manager Cherna Gorder did so along with an injury as to whether or not Wausau Insurance would be responsible for legal expenses incurred by Kleinhans. On December 18th, Melanie Musser, Claim Supervisor for Wausau Insurance, responded with the following clauses taken from the district's insurance policy. "You and any other involved insured must: immediately send us copies of any demands, notices, summonses, or legal papers received in connection with the claim or a suit." In addition, "No insured will, except at their own cost, voluntarily make a payment, assume any obligation, or incur any expenses, other than for first aid, without our consent." Musser concluded her letter with the following statement. "Had this lawsuit been sent to us immediately as required by the policy, we would have retained counsel for Ms. Kleinhans, negating the need for her to engage counsel on her behalf. As such, we will not be responsible for any legal expenses of Attorney James Doyle."

### New 60-Bed Psychiatric Hospital Facility to Be Built in Germantown

First Hospital - Milwaukee, the only for profit psychiatric facility in Wisconsin, announced plans to build another hospital, a 60-bed facility, in Germantown.

The announcement was made last week by Ronald I. Dozoretz, M.D., Chairman of the Board of First Hospital Corporation, Norfolk, Virginia.

First Hospital-Milwaukee, 3330 W. Wells Street, is owned and operated by First Hospital Corporation, the largest, privately owned chain of psychiatric facilities in the country with 16 hospitals located throughout the United States and Puerto Rico.

"Due to the tremendous progress made at our current facility during the past six months, we now feel we can extend our programs to serve those people living in an area north, northwest of Milwaukee up to Fond du Lac and Green Bay," Dr. Dozoretz said. "We feel there is a need and we will fill that need much as we have in the Milwaukee area."

Because Wausau refused to pay Attorney Doyle's bill of \$1,903.61, Kleinhans asked the board again at Monday night's meeting to pay that bill. Gorder said it could be paid under another policy which covers errors and omissions. She noted, however, that policy has a \$1,500 deductible clause. That means the district would have to pay the first \$1,500 and the insurance would pick up the remainder of approximately \$400.

Board member Donald Nowak asked Gorder what would happen if the board refused to pay this bill. She replied, "The lawyer said a claim of injury would be issued followed by a lawsuit against the school board for payment." Board member Perry Ankerson asked why this case had not been submitted immediately. Gorder replied, "we were advised by the board's attorney that it was not the board's business to get involved." Kleinhans noted, this was submitted to the board but it was not allowed.

Besides the bill from Kleinhans' attorney, the board

said that during the past six months First Hospital - Milwaukee has been changing its programs and its image.

"We are quietly emerging as a leading mental health treatment center," he said. "We have put together quality staff and quality programs that are accessible to just about everyone suffering from drug or alcohol addiction problems or general psychiatric disorders."

Kirsch noted that another site for a new hospital was being investigated for several months.

"We began looking for another site several months ago," Kirsch added. "Our research showed that the area north of Milwaukee was underserved and that psychiatric services were needed as far north as the Fox Valley. To best serve that area, as well as to continue to serve the northern part of Milwaukee, we concentrated our efforts on Ozaukee and Washington Counties."

"Within the next few months, we will begin construction," Kirsch continued. "We expect to have the new hospital completed by the end of this year."

## Board Goals and Objectives Again Topic of Discussion

The Kewaskum School Board again spent a considerable amount of time Monday night discussing its goals and objectives for the coming year. However, after all was said, little was done.

The board again went over the same issues including updating of curriculum, expanding early childhood programming, summer school and development of next year's budget. The only person who seemed prepared and ready to set some goals was board member Perry Ankerson.

District Administrator Penny Kleinhans told the board the administration has been working on curriculum right along, has begun work on a summer school proposal, and has started putting the budget together. She told the board her office was hard pressed to put together information for them without some ideas as to what programs it seriously plans to implement. She indicated it would be a waste of time putting figures together for goals the board would not follow through.

Board member Ruth Schmitt said she would like to see some dollar figures for some of the programs as well as fixed costs such as electric, gas, etc.

Ankerson said one goal he would like to see is the board taking a stand on fiscal issues,

specifically the district's fund equity level. "If we set up fiscal constraints it will be much easier to set up a budget," stated Ankerson.

Ankerson said, to have some kind of a figure to start with, he would suggest a 1988-89 budget increase of no more than 4% above the 1987-88 budget. "Let's give the administration some guidelines to bring in a

received an outright bill of its own from Quarles and Brady for services related to the Trapp lawsuit during the months of October and November which amounted to \$1,435. Kleinhans informed the board that Quarles and Brady will be sending still another bill for services rendered during December.

Nowak expressed his unhappiness over the situation. "I think this attorney's (Spector's) fees are getting out of line. I would like to see something on the next agenda if there is a possibility of changing law firms." Nowak was upset because he felt the board had acted properly in seeking advice from Quarles and Brady only to find out the advice given is apparently not accurate. "We paid our attorney good money to tell us not to get involved and now another attorney is telling us to pay," said Nowak. Ankerson told him, "you can't say because you're paying the attorney a lot of money he is right 100% of the time." Nowak noted he was not saying anything about the lawyer as a person, just that he thought the board should be looking into another law firm.

Nowak said he still thought the suit was a personal thing. Theusch disagreed saying "The telling thing is, Wausau Insurance said they would have represented Ms. Kleinhans from the beginning." "There's just no doubt anymore, we're involved in this lawsuit," said Theusch.

Kleinhans informed the board that, after notification, Wausau Insurance did take over her case and appointed their own lawyer to represent her.

Ankerson asked that Kleinhans' request for payment of her former attorney's fees be placed on the next board agenda for action. He also asked Kleinhans if she had an idea of the time element as to when the suit would come to trial. Miss Gorder and I have both spent two or three days with investigators going through files and gathering information, she noted. The taking of depositions is expected to be completed within the next sixty days. "The lawyer said its going to be a very involved, complex trial" stated Kleinhans.

One board member's comment was, "where do the bills end for something that should never have happened in the first place." Ankerson noted this was just what he had been trying to avoid when he asked the board last year to discuss the issue and take some kind of stand.

Board member Clara Trapp did not attend Monday night's meeting. She called and informed the administration office Monday afternoon that she would be absent because her husband was ill with the flu.

budget. If they can't make the 4%, at least they have some figures to work with. I'm just asking the board to determine how much we're going to have and how we're going to spend the money so its done wisely." Ankerson told fellow board members it was easier for him to live within a budget than look at programs first and then try to fit a budget around them.

Ankerson told Kleinhans he would like to have one entire meeting directed at discussing curriculum, discussing mandated programs, future programs and looking at what may be becoming outdated.

In other business, action on a grant proposal which would have provided 100% funding for a Learnfare-Daycare program died due to a lack of a second to approve the request to apply for the grant. Kleinhans and Director of Instruction Julie Backus said the grant could have provided the \$8,500 needed to set up a daycare and parenting program which would allow students who have dropped out of school to take care of their children the opportunity to return to school.

Kleinhans said there would have been no cost to the district and the program could be discontinued at any time. She indicated that eventually the program could have become profitable through a co-op effort and allowing teachers to use the service at a fee, on an as-space-available basis.

Kleinhans was disappointed that the proposal was not approved. She said this was a program designed to help at-risk students to not only get an education, but get jobs that would keep them off and get them off the welfare and AFDC roles.

In other action the board approved the wording for two advisory referendums to be placed on the spring ballot. The first referendum is: Should Beechwood Elementary School be re-opened (yes or no). The second referendum is: Should the sixth grade students leave Kewaskum Middle School and return to the elementary schools, (yes or no).

Board member Ron Beimborn expressed some concern over the wording of the Beechwood referendum. He wondered if the question could be clarified more so that the voters clearly understood that approving the

referendum 'did not' mean Beechwood would be immediately re-opened. There still is a five-year moratorium, he noted.

The board approved a request by the high school ski club to take a trip to Austria, from March 31st to April 8th. The board also approved the contract of John Baitinger as KHS guidance counselor, replacing David Wieter.

The board publicly commended Ms. Linda Bastable for being named the Jaycee's Outstanding Young Educator.

The board then adjourned to go into closed session for the purpose of discussing progress in the KEA and KAP contract negotiations. There was some confusion among the board members however, when after a short break, board president Ralph Horner announced a motion to adjourn the closed session, called for the vote and adjourned the meeting. One member had not even returned to the commons area before the vote was taken. Some of the board members were upset because cancelling of the closed session is expected to hamper further negotiation talks with the two unions.

## Richard Cleek Chosen for London Summer Session

An area faculty member at the University of Wisconsin Center - Washington County is among four leaders picked for the first London Summer Session of the 13 UW freshman-sophomore centers.

Richard Cleek, Kewaskum, an associate professor of geography, will teach Geography 297, "The Urban Landscape," a three-credit course, as part of the June 10 to Aug. 6 program. Participants can earn 5 to 8 UW credits during the experience which is a joint venture between the UW Centers and the American Institute for foreign Study (AIFS).

Enrollment is open to any UW student in good academic standing who registers for the 1988 UW Center summer session, including new freshmen, community members and students from other campuses. Classes will be taught in the Bloomsbury area of London using AIFS and University of London facilities.

Participants will be housed in apartments in a residence hall, have five meal tickets a week for the University of London Union and be provided with free bus and tube passes for attending classes. Classes are on a Monday through Thursday schedule to allow for long weekend travel experiences.

An AIFS fee of \$2,825 covers round-trip air fare, medical insurance, passes, student union meals and weekly social and cultural events. In addition, students will pay normal UW Centers summer tuition: \$265 for five credits or \$318 for eight credits.

An optional part of the program is a week-long tour of Europe before the regular program begins, at a cost of about \$350.

Cleek's course is a field study course that involves careful

observations, record-keeping, description and analysis of phenomena. During a series of walking tours of London and surrounding towns, students will keep detailed notebooks. The notes and related readings will be the basis for discussions and papers.

## KHS Social Problems Class Views Prison Life First Hand

Kewaskum High School's social problems class taught by David Rhode, capped the semester by participating in the Project Aware program conducted by the inmates of the Kettle Moraine Correctional Institute.

The class studies corrections, prisons, civil and criminal justice. The students, juniors and seniors, learned how the state holds people accountable for not obeying the law. In addition to the trip to Kettle Moraine, the class also visited "inside the wall" at Waupun State Prison where it received an "extremely graphic and realistic view of the life-style of inmates at a Wisconsin maximum security prison.

Rhode pointed out that the value of the class is that it "gives students a graphic realization of society before turning them loose on society."

Faragher states that on Wednesday, January 6, he spoke to Kevin Kennedy of the State Elections Board. Mr. Kennedy informed him that, although there appeared to be no ethical or election law violation, recent changes in the Lawyers Code of Professional Responsibility may prompt a more cautious approach.

Mr. Faragher requested assistance from the Wisconsin Bar Association Ethics Committee. He was advised that no current ethics decision would require him to withdraw from the Republican Party. Mr. Faragher is preparing a formal request to the Ethics Committee for a determination. In the meantime, as a precaution, he has chosen to take leave from partisan politics for the duration of the campaign.

Mr. Faragher expressed great regret that this decision was necessary. He stated that he continues to enjoy his participation in the Republican Party and the many friendships he formed in the party. It is Mr. Faragher's earnest hope that the State Ethics Committee will permit him to resume his duties as Chairman of the Washington County Republican Party as soon as possible.

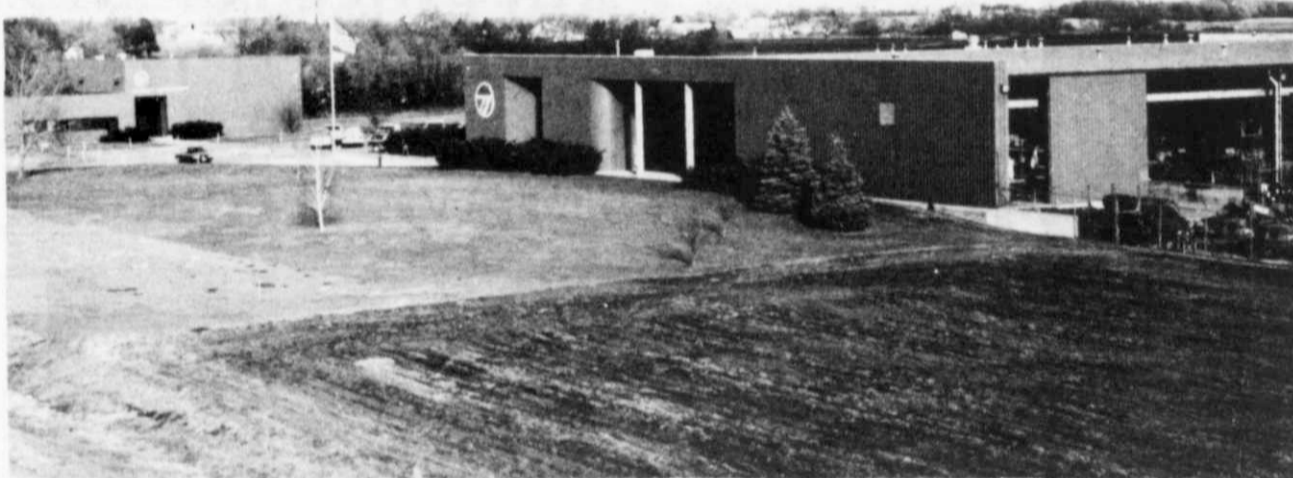

## 75 Years Ago

January 11, 1913

The first real snowstorm of the season swept over this village and the entire state Tuesday, piling snow in drifts and causing much discomfort to travelers obliged to be out of doors. The snow served to bring out sleighs and cutters. Owners of sidewalks were busy the following morning.

Nicholas Bianco, 36, employed by the Union Lime Company at Marblehead, met instant death in a horrible manner at the quarry on Tuesday morning. After being lifted fifteen feet in the air by the premature explosion of a charge of dynamite, Bianco was hurled to the bottom of the quarry, a fall of 90 feet. At the time of the accident, Bianco was loading a hole for a blast. One stick of dynamite weighing perhaps a pound and a half, became lodged in the hole, a short distance from the surface. Bianco sought to force the charge into the hole and when the charge was struck a blow it exploded, the force being exerted upward. Bianco in the act of forcing the charge was leaning directly over the dynamite and therefore received its force.

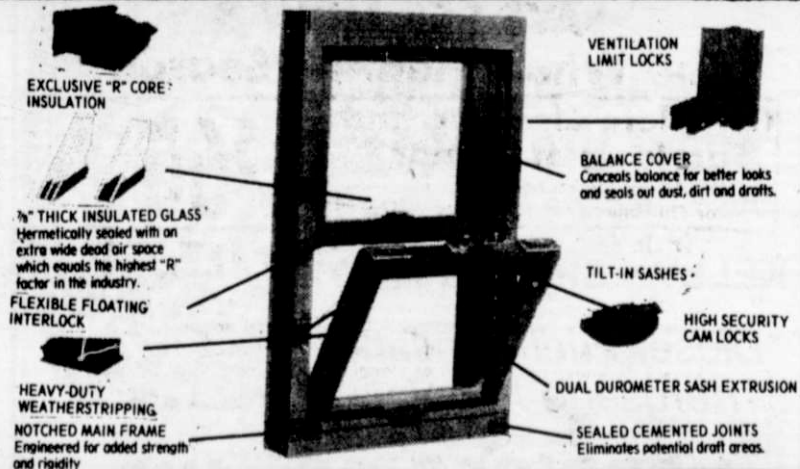

## New Snowmobile Law Makes Registration Of Machines Quicker

A new law which became effective on December 8, 1987, shortens snowmobile registration time and the ability to use that machine, Gary Homuth, recreational vehicle safety officer for the Department of Natural Resources said.

"Snowmobilers that want to register a snowmobile can now do it in person at any of the six DNR District Offices or any area office," Homuth said. "The new law allows operation of the snowmobile using a Department validated registration form."

The law previously held that the registration decal had to be displayed before the snowmobile could be operated. The Department also didn't provide the walk-in registration service. All registration was handled through the Madison office.

"What the Department will do now is mail in the application with the \$20 two-year payment and validate the applicant's copy of the registration form which will allow operation of that snowmobile until the decals are received by mail," Homuth explained. "This registration transaction must be done at either a District or Area Office and not a local DNR Ranger Station."

People who buy new, or used machines from dealers will still be able to operate those snowmobiles on the registration application receipt issued to them by the dealers. It's valid until decals are received in the mail from the Department. Nonresidents that buy snowmobiles in Wisconsin and wish to register them here can also do it at District or Area Offices, but they must provide proof that sales tax has been paid.

**VOTING BY ABSENTEE BALLOT**

Any qualified elector, unable to get to the polling place on election day for any reason, may ask to vote by absentee ballot. A qualified elector is a person who is a U.S. citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where the person wishes to vote at least 10 days before the election. If the voter resides in a municipality which requires voter registration, then registration is also required for the voter to receive an absentee ballot.

To obtain an absentee ballot, the voter should contact the clerk of the city, village or town in which the voter resides. A written request must be made by the voter for the absentee ballot. If the voter contacts the clerk by telephone the clerk will send the application form to the voter. If the voter requests an absentee ballot by mail, a written request, signed by the voter which indicates that the voter resides within the municipality, will be honored. Written requests may be made beginning six months before the primary election. The deadline for receipt of the written request by mail is 5:00 p.m. on the Friday before the election. If the voter goes to the clerk's office to complete a written request, the request must be made no later than 5:00 p.m. on the day before the election.

If the absentee voter resides in a nursing home, the absentee ballot will be delivered to the nursing home by two special voting deputies appointed by the municipal clerk. The special voting deputies will present the absentee ballot to the voter and provide assistance in marking or punching the ballot if necessary. At the request of an absentee voter a relative may provide the assistance. After voting at the nursing home is completed, the special voting deputies will return the absentee ballot to the municipal clerk.

With two exceptions, the voter who wants to cast an absentee ballot, must make a separate written request before each election. If a voter is indefinitely confined to his or her home or a care facility because of illness, age, or disability, or if the voter is in the military, the voter need not make a request before each election. There is a special statement on the application form which is provided by the municipal clerk which can be completed asking that an absentee ballot be automatically mailed to the indefinitely confined or military voter before each election. If the voter fails to vote and return the ballot sent to the voter, a separate written request for the next election must be made before the voter can obtain a ballot.

A voter who is hospitalized on election day may obtain an absentee ballot by designating another person as the agent for the voter. There is a statement on the application form for this purpose. An application by agent for a hospitalized elector may be made in person at the municipal clerk's office no earlier than 7 days before the election and no later than 5:00 p.m. on the day of the election.

If a voter requests an absentee ballot stating the reason that he or she is a sequestered juror, the application can be made no earlier than 7 days before the election and no later than 5:00 p.m. on the day of the election. If the application from a sequestered juror is received by the municipal clerk after 5:00 p.m. on the Friday immediately preceding the election, the municipal clerk or the clerk's agent will deliver the absentee ballot to the court and the judge will call a recess to allow the voter to cast his or her vote.

The municipal clerk will send the absentee ballot to the voter once the request is received and the ballots are prepared. Absentee ballots are available twenty-one (21) days before the spring primary and spring election. The municipal clerk keeps a public record of all individuals requesting an absentee ballot indicating when the ballot is requested, sent, and returned to the municipal clerk.

An absentee ballot can be voted at home any time after it is received in the mail. An absentee ballot can also be voted in the clerk's office if the voter appears in person and fills out the written request. The voter should make sure that the certificate-affidavit is properly completed and witnessed by two persons or a person authorized to administer oaths. The voter and the witnesses must sign the certificate on the absentee ballot carrier envelope. If the absentee elector receives assistance in marking the ballot, the person providing the assistance must sign the statement on the back of the ballot which provides that the person giving assistance marked the ballot as directed by the absentee voter. The municipal clerk will make sure that the certificate-affidavit is properly completed by the voter when the absentee ballot is voted in the clerk's office.

The completed absentee ballot must be in the possession of the issuing municipal clerk in time for the clerk to deliver the ballot before the polls close on election day. Voted absentee ballots may be delivered in person to the municipal clerk. Any absentee ballot received after the polls close or any absentee ballot where the certificate-affidavit is not properly completed can not be counted.

# Collapse in Fourth Quarter Indian Girls Top Raiders

The Kewaskum Indian Boy's Basketball team used more cold shooting and a fourth quarter drought in route to a 66-49 loss at Kiel last Friday night. The loss was the Indians fifth straight in conference, and seventh straight loss overall. Poor outside shooting was again the downfall for Kewaskum. The Indians connected on only 33% of their field goal attempts, including 0-13 on three pointers. Kiel, on the other hand, fared a bit better shooting 25-52 from the field for a 48% clip.

The Indians were also plagued by an old nemesis of theirs, a slow start. Once again, Kewaskum found themselves behind early in the ballgame and they had to scrap just to stay in the game. They pulled to within nine, at 20-11, at the end of the first frame.

Foul trouble gave the Indians problems also as their big men, Joel Fleury and Ted Anderson picked up two fouls each in the first quarter.

The Indians roared back in the second frame however. Behind a full-court pressure defense the Indians forced Kiel into numerous turnovers and bad passes. A steal and layup by Fleury tied the score at 28-28. Kiel eventually regrouped and got its composure back to regain the lead and hold a 36-32 advantage at intermission.

The two teams played each other relatively even in the third period and after three quarters, Kiel held on to a slim, 48-43 lead.

In the fourth quarter, however, the Indians were ice cold, hitting on only three of 16 shots, after Kiel switched to a zone defense. Their shooting performance included 0 for 8 shooting from three-point land in the quarter. Kiel outscored the Indians 18-6 in the frame and coasted to the victory.

"The score was not indicative of how we played," Head Coach Dale Schatz noted. "A lot of their points came in the final two minutes after we'd started fouling them. I was pleased with our effort."

Joel Fleury led the Indians with 22 points and five rebounds. "Fleury had his best game of the year, by far! I was real pleased that we were getting the ball inside more. We

need that." Steve Johnson also added eight rebounds for Kewaskum, to go along with eight points.

Dave Lepisto led Kiel with an 18 point effort and also added seven assists. Brad Schmitz also added 15 points and seven rebounds for the Raiders.

The Indians will try to get back on the winning track this Friday, as they host Sheboygan Falls, here, with J.V.'s starting at 6:15 and the varsity following immediately after.
