Insurance Carrier Refuses to Pay Legal Fees Mark Groeschel Named Fireman of the Year

The Kewaskum School Board has been informed its insurance carrier will not pay almost \$2,000 in legal fees incurred by District Administrator Penny Kleinhans prior to the firm's taking over as her legal counsel in the Charles Trapp lawsuit.

The board also received another request for payment of an additional \$270 in legal fees from attorney James Doyle for the preparation and delivery of a Notice of Claim for payment of those fees by the school district.

Kleinhans indicated the district's lawyer Michael Spector had been unsuccessful in working out an agreement to get at least a portion of attorney Doyle's original bill paid by Wausau Insurance. Kleinhans noted that, according to both attorneys, that left no alternative but to file the notice seeking payment of those fees by the district.

After some discussion, board member Perry Ankerson asked that the "Notice of Claim" be placed on the next agenda for discussion and action.

In other business, the board discussed a letter it had received from Buildings and Grounds Superintendent Fred Boehlke regarding comments made by board member Clara Trapp at the board's last meeting.

In the letter Boehlke expressed his concern over a remark at

that meeting and how it would reflect on his professional reputation. In a reply, the district's legal counsel Michael Spector said it was an unfortunate and regrettable incident.

Ankerson asked Boehlke, who was in the audience, if he had any comments. "I would rather not discuss it at this time," said Boehlke.

In other action, the board heard the recommendations of the Finance - Transportation - Buildings and Grounds Committee regarding the district's oil storage tanks.

While the district has had no leakage problems, a tank inspector indicated that the probability of any tank over twenty years old to begin creating problems was very possible. Kleinhans noted that, should any leaking occur, the district would be liable for all tank cleanup work.

The district presently has five oil storage tanks that are between 20 and 35 years old, one at each of the schools. The board was told two of the tanks, at the high school and Kewaskum Elementary, were standby units and the district should consider abandoning them. The cost to do that was estimated at \$1,500 to \$2,000 per tank, plus inspection fees.

The committee also recommended the district begin considering replacing the tanks at the three outlying schools,

Farmington, Wayne and Beechwood. The cost for that work was estimated at \$7,000 to \$10,000 per tank, plus installation, inspection, and monitoring equipment.

Supervisory Training Series at Regal Ware

Moraine Park Technical College's Economic Development Services continues its work with area companies through the Supervisory Training series at Regal Ware. On Dec. 21, "Managing for Quality and Productivity," led by Sud Ingle, culminated with quality and productivity presentations by class members to Regal Ware's executive committee.

As a result of the class presentations, at least one committee has already been established to address a productivity problem. It is anticipated that other groups will be formed to address unique quality/productivity problems as they are identified.

Training at Regal Ware has been going on for the past three years. "There is no doubt that our folks have learned a lot," says Jim Moran, vice president for human resources at Regal Ware. "Most of the employees have earned 30 credits and are halfway through the program; they have about four more years to go."

"About 25-30 people are taking the course because it is required for their employment," Moran continues, "another 15 or so are taking it on their own. The program is offered with the intention of bringing people up to the associate degree level."

"We run the program internally for our employees, under the auspices of Moraine Park," says Moran. "We can't make it any easier for them. We pay for it, give those that are required to take the series the

time off from work and hold it in our facilities so they don't have to travel."

The next course in the series, Math for Business Analysis, began Jan. 14 with Instructor Judy Brown.

Holy Trinity Students Win County Literary Contest



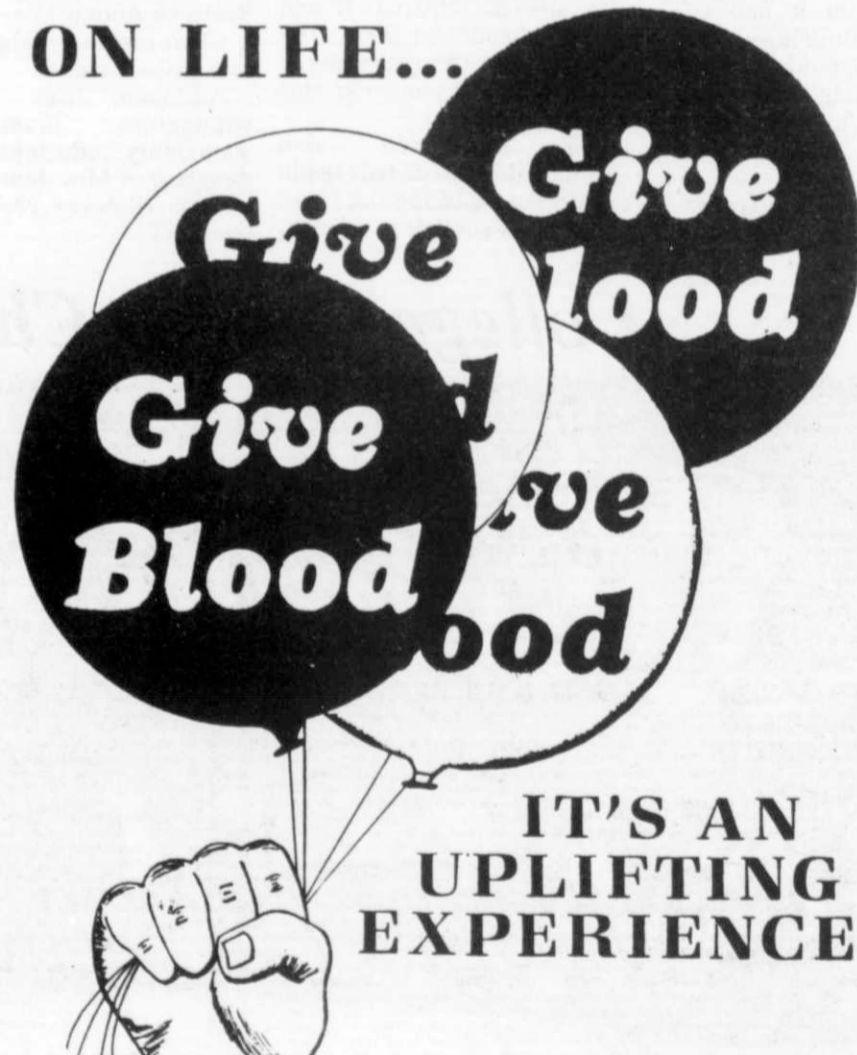

Kleinhans said she seriously questioned the spending of \$10,000 to replace the tank at Beechwood since the building is no longer being used by the district. She felt that money could be better directed to other uses such as instruments for the band.

The committee did not make any specific recommendation as to how, when or in what order the work should be done. It just wanted the board members to be aware of the situation and consider what action they may want to take.

The board had the opportunity to meet the new Gifted and Talented program coordinator Carol Zoerb. She explained to the board what her plans for the program were. She told the board she would like to expand the committee to allow for more parent volunteers and community involvement.

After hearing her comments, the board approved her request to recruit additional committee members to work with the program.

The board also heard high school principal LeRoy Kopecky's report on staffing for 1988-89. The major change would be the elimination of one math position since some courses will be transferred to the Business Education Department. One Spanish language position will be increased 25%, and an English position increased 37%. Kleinhans noted overall, there would still be about an 80% reduction of one teaching

position.

The board approved policies regarding foreign exchange students, the secondary guidance counselor job description, and full time student definition. Policy #2700, on smoking was approved with one change. That change completely bans all smoking in or on school property, including during all school activities by anyone, students, staff, parents, etc., thereby creating a total smoking ban for the district.

The board also approved the 1988-89 school calendar. Classes will begin on August 25, 1988, and school will leave out on June 2nd, 1989. The board has decided to remain with the pre-Labor Day school opening schedule.

Board member Ruth Schmitt was appointed legislative liaison with the Wisconsin Association of School Boards. Her responsibility will be to keep the board updated and informed of all current legislation involving the schools and students.

The board concluded its meeting with a curriculum updated by Director of Instruction Julie Backus and some of the district staff.

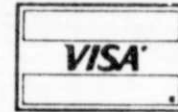

Pearls of Knowledge Gleaned From Two Hour Lecture Here

On Monday evening, Feb. 15th, Charles Engelhardt, who lives on the west shore of our nearby Long Lake, spoke for two hours to a spell-bound audience on the USE AND ABUSE of Alcohol, Nicotine and related illegal drugs. Mr. Engelhardt is a reformed alcoholic who is proud to be free from his slavery to alcohol and to nicotine. He is a special correspondent to our University of Wisconsin at Green Bay and is in great demand by schools, large and small, and by many of the large business corporations in America to help others to become free of this terrible habit which kills so many young and old people annually.

Now I will list a few of his Pearls of Knowledge.

A heavy drinking father can father a sterile male child even though the mother used no chemicals at all.

People who drink the most know the least about alcohol and the damage it does to them.

Likewise the kids who smoke the most marijuana know the least about the drug and its

poisonous action.

A ten year research project in the University of Tennessee reveals that alcohol is a severe irritant to the stomach; that nicotine is also a severe stomach irritant; then you take aspirin to ease your distress which is another severe stomach irritant; hence, alcohol, nicotine and aspirin are the chief causes of ulcers of the stomach.

Women are now beginning to die of Cancer of the lung at the same rate that men do, thanks to "Virginia Slims." (Nicht wahr Patty?)

The only declared war in America today is the War on Drugs - 1.2 billion tax dollars are being spent to hopefully win this war.

When you treat a cocaine addict to become cured, what do they do after their release? They at once go back to alcohol and nicotine, then back to cocaine.

Kids in the sixties who smoked marijuana were of an average age of eighteen years old but now the kids are of the average age of thirteen years old and, because of an improved product, they are smoking marijuana five years younger and the product is fully five

times more potent.

To ban the most dangerous and damaging drug on the market which one should it be?

The one that kills the most people?

The one that harms the most people?

The one that does the most damage to society?

The one that cost the most money to industry and business?

The answer is that cocaine killed 585 people in 1986. This same year, 1986, 98,000 people died due to the use and abuse of alcohol.

Most people who drink do not know that the blood alcohol content rises for two hours after they leave the tavern to go home. Now you should realize why so many fatal accidents occur when the victim is on the way home.

Nicotine has by far the strongest and the most deadly addiction power over the user than any other drug, and is the most difficult one to overcome.

Then Chuck Engelhardt said this factual statement. Do you know a teenager that doesn't drink; that doesn't smoke; that doesn't chew tobacco? If so, then you know a teenager who will not use marijuana; will not use cocaine; nor any of the other illegal drugs.

Now Chuck broke his long held spell over his audience, and after answering several questions for some individuals, he said good-bye, and drove

immediately up to Shawano to get a few hours sleep before spending another full day of lecturing to this city's students like he did for over 1,000 of our Kewaskum children including both parochial schools.

Hospitals Sponsor Women's Health Series In Campbellsport

St. Agnes Hospital in Fond du Lac and Waupun Memorial Hospital are sponsoring a Women's Health Series in March. Programs will be held in Campbellsport and five other surrounding communities: Mayville, Markesan, Mt. Calvary, Green Lake and Fond du Lac.

The series consists of four different programs, all offered in the six communities. Valerie Graczyk, Director of the Women's Health Center for both hospitals, explains the purpose of the regional program series.

"Women are aggressively looking for more information about their health," Graczyk commented. "The Women's Health Center wants to make it easier for individuals to attend educational programs by offering them closer to home. We held a regional health series last fall that covered a different set of topics and it was well received by women."

The March series will present four different topics. "Beyond Assertiveness" and "The Question of Caring & Nurturing Yourself" are both instructed by a women's communication specialist who will discuss ways to better express yourself and why it's so important to care for yourself as well as others.

"The End to Dieting" is presented by a registered dietitian and explains how healthy, nutritional eating habits can be much more effective in controlling weight than a lifetime of fad diets.

"Staying Mentally Fit" is presented by a counseling specialist who will talk about ways to avoid depression and how to cope with daily tensions and anxieties.

The women's series in Campbellsport will be held at the Public School, on Tuesdays from 6:30 - 8:30 p.m., March 1-22.

The cost for the entire four-part program is \$15 per person or \$25 for two if individuals sign up together. Persons should pre-register by calling the Women's Health Center at 929-1414 or toll-free 1-800-458-8182.

Area Students Increase Awareness Of Smoking Risks

Where there's smoke, there's fire.

That's the message West Bend West high school students are communicating to 522 West Bend area fifth and sixth graders throughout March. The smoke, they say, is from cigarettes, and the fire many be lung cancer, emphysema, chronic bronchitis, or a host of other diseases caused by smoking.

The older students' classroom visits are part of the American Lung Association of Wisconsin's three-day Students Teaching Students (STS) smoking prevention program that has been presented to nearly a quarter million fifth and sixth graders statewide since 1975.

Because surveys show that 25 percent of Wisconsin's sixth graders have experimented with smoking, this program is designed to change students' attitudes about smoking, according to state Lung Association Executive Director James E. Pender.

"In just three seconds, inhaled smoke makes your heart beat faster and raises your blood pressure," Pender said. "And those same three seconds can be the beginning of a lifetime of smoking. The volunteer STS teachers help increase awareness of persuasive advertising and peer pressure, and they convey an enthusiasm for life that will not be snuffed out by smoking."

To reinforce their warnings about smoking, the volunteer STS teachers will show slides on the health effects of smoking, use foam lungs to demonstrate how cigarette tar can accumulate in the lungs, share their own reasons for not smoking, and discuss ways to resist pressure to smoke from

advertising and the example of smoking family members and friends.

Students presenting the program are Lori Hahn, Jason Coulter, Kevin Schulteis, Kerri Greminger, Brian Westra, Tony Spaeth, Cathy Baer, Glenn Kutschera, Cindy Skadah, Ann Kutschera and Paula Luepnitz.

The Students Teaching Students program is available free to all Wisconsin elementary schools. It is funded by Christmas Seal contributions and special gifts and grants from individuals and corporations.

UWWC Ambassador's Goal Is To Expand Awareness of Campus

Being "an ambassador" for the University of Wisconsin Center - Washington County can turn people into tour guides - and a whole lot more.

UWWC has 13 ambassadors, known more formally as members of the University Council. When Dean Robert O. Thompson arrived here in 1973 at the freshman - sophomore center, he found that a council had been formed but was not meeting.

The group was re-activated in the spring of 1979 and has been meeting monthly ever since.

Thompson said, "The chief goal of the Council is better communication between the county community we serve and the University. Council members are really ambassadors for the University who expand awareness of our campus."

"They let me know when the needs of community are not being met. I let them know the needs of University."

According to Thompson, the current project for the Council involves "helping inform county and city officials about the space needs of our campus."

The city and county are looking at preliminary expansion plans that have a tentative price tag of \$2.1 million.

On Dec. 8, the Council planned and hosted their first annual campus visit by Washington County officials. Plans call for a repeat of the tours for City of West Bend aldermen and other officials.

Past Councils are no strangers to UWWC space needs. The Council handled details of the groundbreaking and dedication for the last building project in the early 1980s, including the preparation of a campus brochure.

In addition, the Council has:
- Sponsored an annual benefit to support UWWC's summer theater;

- Organized a speakers' bureau and slide show to tell the University story to community groups;

- Invited faculty and staff to

Council meetings to learn more about UWWC;

- Hosted receptions when dignitaries such as the president of University and chancellor of the UW Centers visit.

February 22, 1963

The Village Board of Kewaskum met in adjourned session with President Reigle presiding and all board members present except Trustee Eberle. Legislation to Repeal 'Unfair' Farm Tax Regulation Introduced by Moody

U.S. Rep. Jim Moody is co-authoring legislation in the U.S. House to overturn a tax provision which will affect farmers who buy diesel fuel to run their off-road farm equipment.

Moody, a member of the House Ways and Means Committee, said Rep. Byron Dorgan (D-N.D.) and Rep. Hal Daub (R-NEB), both members of the committee are the co-sponsors.

On April 1, the Internal Revenue Service will begin requiring farmers to pay the federal excise tax on diesel fuel when it is purchased. Then they will have to apply for a refund later.

"That simply doesn't make any sense," Moody said. "It means the average Wisconsin farmer will shell out up to \$500 each year in what amounts to an interest free loan to the government and then wait months or even a year for a refund."

"It just promotes a lot of stupid paperwork for both overburdened farmers and the government. It would also cause real financial hardships for many farmers already facing very light cash flow situations."

Moody's legislation would reinstate a previous tax law which allows farmers to buy diesel fuel without paying the federal excise tax.

"Farmers have always been exempted from the federal tax because the fuel is used for farm equipment and not used on public roads," Moody said. "The Wisconsin Farm Bureau has also complained that state and local governments were exempted for their off-road equipment while farmers were not. It's sort of typical — one unit of government takes care of another and forgets the tax-paying citizen."

Moody said he, Daub and Dorgan will be pressing for a quick hearing on the bill.

Gov. Thompson Says More Hay Donations Are Needed

Governor Tommy Thompson said that more donations of hay and money are needed to help northern Wisconsin farmers feed their cattle and livestock through the spring months.

Thompson said, "Without help, some farmers will exhaust their supplies beginning in March."

Since last summer, over 420,000 bales of hay have been delivered, but an additional 175,000 bales are now needed. Approximately \$47,000 is also needed to cover the expenses of transporting the donated hay to northern counties.

The Governor said, "People have been very generous with their donations, but we still need more help. If farmers have unneeded hay available, now is the time to donate it. Money is also needed to cover transportation costs."

Bill Enhances Textbook Loan Program

Last October, a measure was introduced in the State Senate which would direct the state superintendent of schools to develop a list of textbooks that would be available to loan to public and private schools.

Current law allows each school board to purchase textbooks for public schools in the district and to sell them to pupils at cost, loan them to pupils, or rent them to pupils. Senate Bill 366 essentially extends this privilege to private schools. As expected, there has been a great deal of interest in this legislation from persons involved in parochial education.

The legislation's intent is to create an improved state list of textbooks for public and private schools so that local districts have the ability to select from a broader range of books. It also allows school districts throughout the state an equal chance to receive the books.

In the bill, the Department of Public Instruction would be charged with administering the enhanced textbook loan program. However, this would generally erode the control that should be given to private and parochial schools in this matter. Therefore, in its first draft, the bill presents problems.

A substitute amendment has been proposed which would create greater local control over the program. Under the amendment, a committee of parents would be created to oversee the Department of Public Instruction's selection of books available for loan. This modification to the bill insures local input and should give the many

different school districts across the state equal choice and self-control.


Currently, the bill is in the Senate Committee on Education. It received a public hearing last November, and is therefore eligible to be reported out of committee and sent to the Senate floor for action before the end of the legislative session on March 25th.

In that the Legislature is conducting work on the 1988 annual budget, a property tax relief proposal, pari-mutual gambling legislation, family leave bills, obscenity measures and possibly a pension reform proposal, the textbook loan bill may have an uphill battle. If it is not passed this year, a new textbook loan measure will need to receive action when the next Legislature convenes in January, 1989.

Disabled Vets to Receive 4.2% Cost of Living Increase

The Veterans Administration has announced a 4.2 percent cost-of-living increase in VA disability compensation payments.

According to Jack G. McReynolds, Director of the VA Regional Office in Milwaukee, this increase will benefit some 43,000 Wisconsin veterans and their dependents. McReynolds said this increase also applies to Dependency and Indemnity Compensation (DIC) paid to spouses and children of service personnel who died on active duty and of veterans who died from service connected illness or injuries.

The rate boost, effective December 1, 1987, will be reflected in VA checks issued March 1, 1988. These checks will reflect the new rate plus the retroactive adjustment for December, January, and February.

Sign Up Period for Feed Grain Period

Producers in the area need to make decisions about participating or not participating in the 1988 Feed Grain Program. The sign up period for the program ends on April 15. However, participants that wish to consider the 0/92 provisions must apply by March 11.

The Agricultural Stabilization and Conservation Service (ASCS) is the agency designated to handle sign up and administration of the program. The Washington County ASCS office has asked farmers that are interested in finding more about the program and are planning on signing up to schedule an appointment with their - office.

The programs provide price protection for producers of feed grains. There are three major program provisions. The first is a 20% set aside, where 20% of the base acreage is taken out of production, and participants are then eligible for the loan program and deficiency

payments. The second provision is to divert an additional 10% of their base acreage from production. A payment will be made based upon the ASCS yield for those diverted acres. The third provision is the 0/92; under this provision the participant may choose to idle up to all of their permitted acreage and still receive 92% of the deficiency payment.

Decision not to participate in the program or to participate and at which level should be made based on a thorough understanding of the program details, payments and limitations. Producers should calculate their expected profits with no participation and participation under the various alternatives. Other items need to be considered such as, the need for grain by the producer, cost of producing various grain crops, expected crop yields, and how the program fits into the general operation of the farming business.

Producers in Washington County will have an opportunity to learn more about the feed grain program, the local watershed programs, farmland preservation program and conservation requirements for all programs at 2 educational sessions. The sessions are scheduled to be held on Thursday, March 3, 1988, at 1:00 p.m. at the Addison Town Hall in Allenton and Tuesday, March 8, at 1:00 p.m. at the Jackson Town Hall located east of Jackson.

Representatives of various agencies including ASCS, SCS, UW-Extension and Land Conservation Department will be conducting the programs and providing information for producers.

New Dairy Youth Program Specialist at UW-Madison

Chuck Sattler, a native of Malone, Wisconsin has been named the new dairy youth specialist at the University of Wisconsin - Madison. Sattler will coordinate dairy activities for 4-H, FFA and junior breed organizations.

His duties will include working with the counties to set up the four District Dairy Days, which attract about 250 participants each June; and organizing the FFA and 4-H state dairy judging contests, which involve about 200 youngsters. He will also work on the National 4-H Dairy Conference, an annual event involving about 100 people from the United States and Canada.

Sattler grew up on a registered Guernsey farm, and is the third Sattler brother to study dairy science at the UW-Madison. He competed on the UW dairy-judging team in 1983 and 1984, and was assistant coach as a graduate student. His master's thesis examined the relationship between herd life and milk yields in Wisconsin dairy herds.

Chuck Sattler has a strong production and applied background and plans to emphasize the value of 4-H and other youth programs such as the development of life skills, responsibility, speaking and communication skills, and the ability to interact with others.

Plan Farm Business Counsel Sessions

Farm families in Washington County will have an opportunity to participate in individual farm and family counseling sessions. These sessions can be arranged by contacting the Washington County Extension office. Sessions can be arranged to meet the schedules of farm families.

This is the time of the year that farm families are actively involved in working with their record system to prepare for income taxes. This provides an opportunity to spend some extra time evaluating the performance of your farm business and the family living budget. Most record systems provide the information needed for tax return but spending a little extra time with the information, individuals can obtain additional information about their family and their business. Counselors for the sessions

will either be the Extension Agricultural Agent, Extension Home Economist or volunteers that have been trained to work with farm families. The amount of time spent will depend upon the needs of the farm family.

The sessions will be able to help farm family review their record systems, evaluate the strengths and weaknesses of their business, help them prepare financial statements for lenders and help evaluate business profitability and cash flow. Counselors are also trained to discuss other concerns and to make referrals if helpful.

There is no cost for farm families to participate in this counseling service. All counseling sessions and information will be confidential between counselors and families.

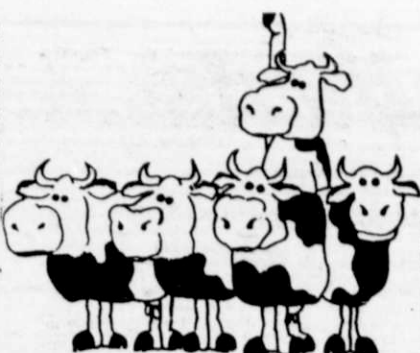

Dairy Farmers Urged To 'Come Be Herd'

Dead Battery? Here's How to Safely Jump-Start Your Car

The National Society to Prevent Blindness - Wisconsin Affiliate reports that battery-related accidents are a leading cause of serious eye injuries. "Many of these injuries resulted from incorrect jump-starting procedures," said Dick Anderson, Chairman of the Eye Safety Committee for the society. Anderson warns that batteries produce explosive gases. If these gases are accidentally ignited by a spark or open flame the explosion could send battery fragments and battery acid into the eyes. The result can be severe eye damage and vision impairment. According to the Consumer Product Safety Commission, over 8,000 battery-related eye injuries occur each year. The recommended procedures for jump-starting a battery safely are:

Before attempting to jump-start:

1. Review the car owner's manual for instructions.
2. Do not jump-start a battery if the battery fluid is frozen.
3. Wear chemical splash goggles.
4. Keep sparks, flames and cigarettes away from batteries.

Before attaching cables:

1. Be sure the vehicles are not touching.
2. Be sure the electrical systems of both vehicles are the same voltage.
3. Make sure the vehicles are in neutral or park, that the ignitions of both vehicles are off and that the emergency brakes are set.
4. Be sure vent caps are tight and level. If available, place a damp cloth over vent caps.

Attaching the Cables:

1. Clamp one jumper cable to positive (+) terminal of discharged battery wired to starter or solenoid. Do not allow positive cable clamps to touch any metal other than battery terminals.
2. Connect other end of positive (+) cable to positive (+) terminal of booster battery.
3. Connect negative (-) end of second cable to negative (-) terminal of booster battery.
4. **Make final connection on engine block of stalled engine (not to negative post) away from battery, carburetor, fuel line and any tubing or moving parts.**
5. Stand far back from both vehicles. Start the car with the good battery, then start the disabled car.
6. Remove cables in reverse order of connections beginning by first removing cable from engine block or metallic ground.

Should an accident occur and battery acid gets into the eyes, immediately flush them with water for at least 15 minutes. Seek emergency medical assistance.

The National Society to Prevent Blindness - Wisconsin Affiliate offers a 4" by 8" vinyl sticker listing step-by-step instructions for safely jump-starting dead batteries. The sticker can be affixed to any clean, dry surface under the hood or kept inside a car's glove compartment.

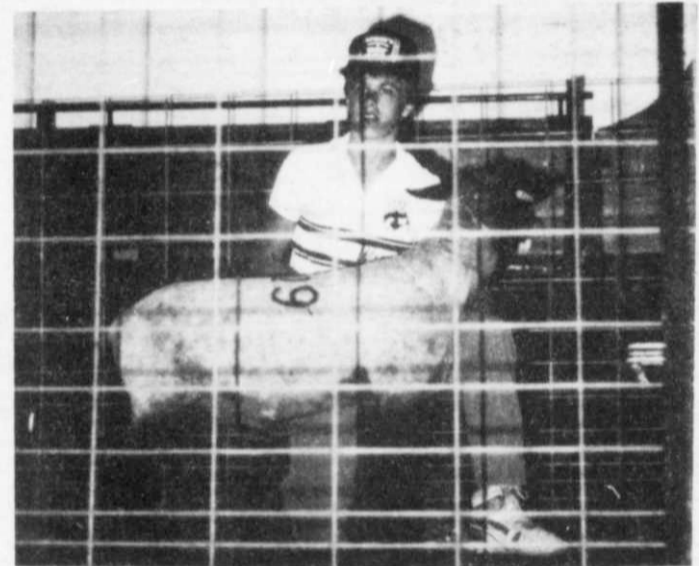

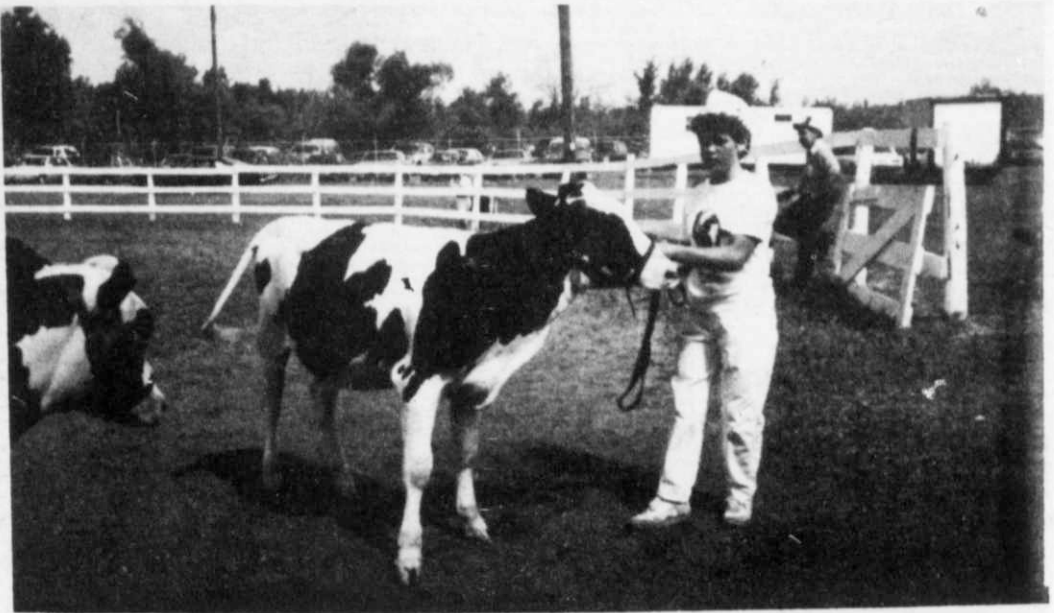

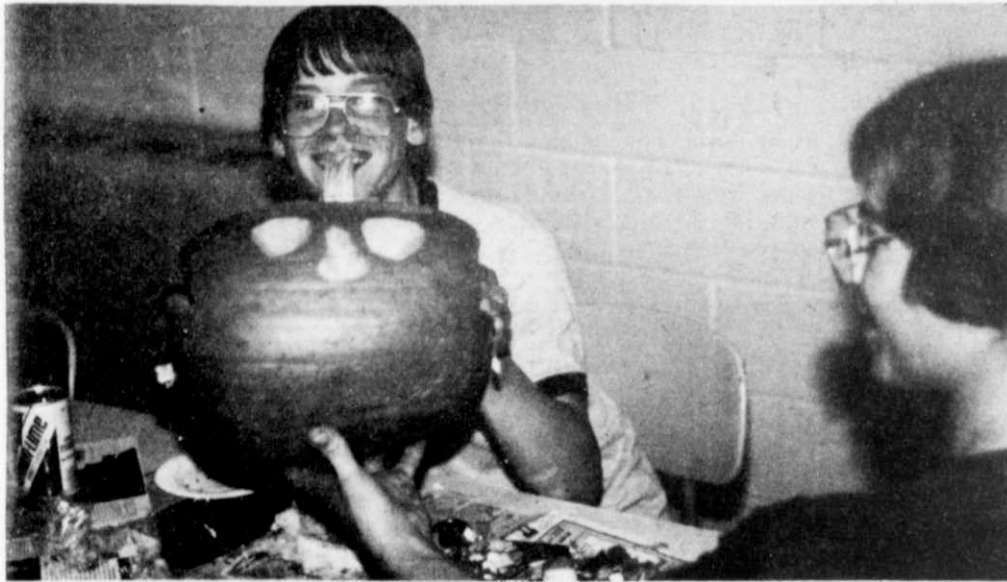

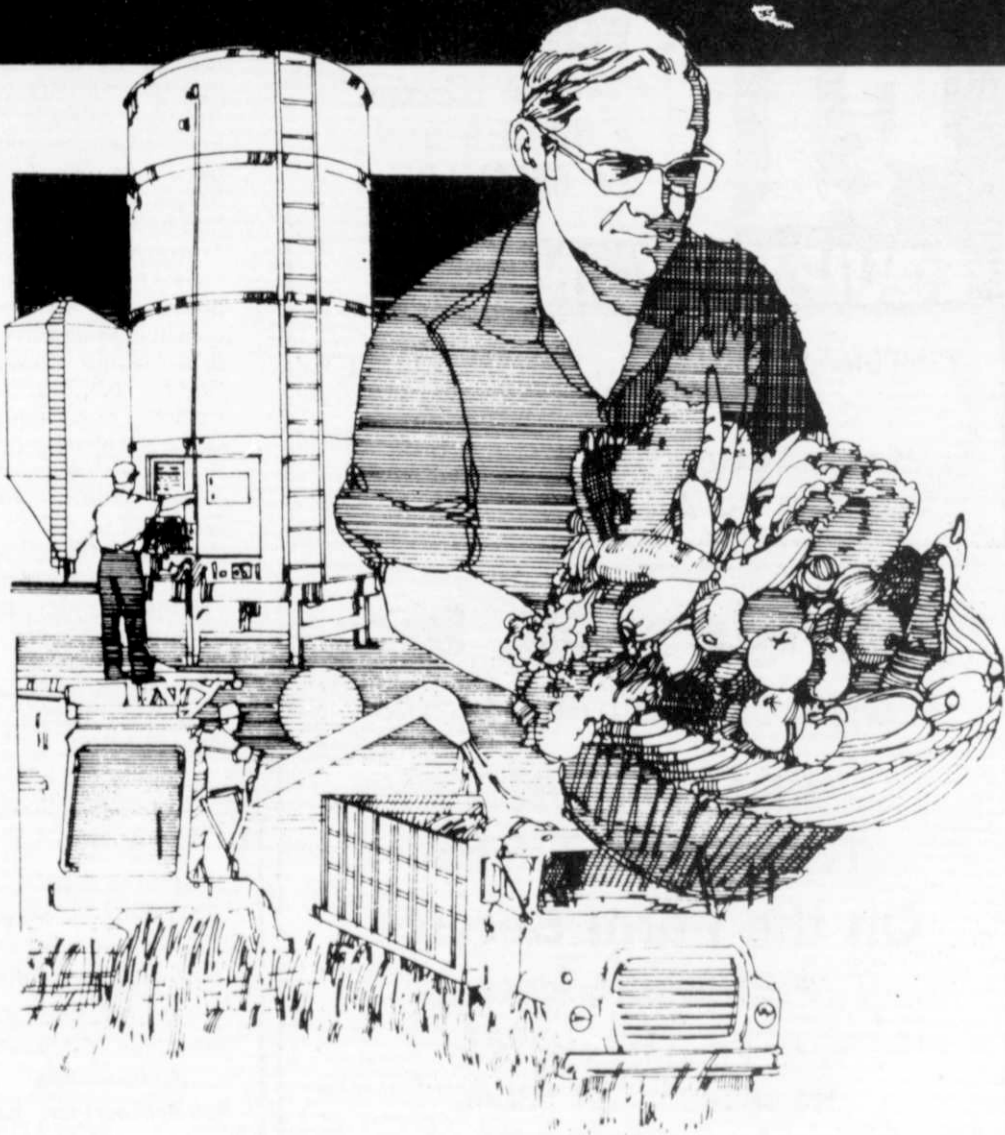
