Pamela Krahn Is Top Graduate of Lakeland College

Sheboygan, Wis. — Pamela Krahn of Adell, who majored in biology and medical technology and maintained a 4.0 grade point average throughout her college career, was Lakeland College's top graduate among the 221 receiving degrees at commencement exercises on the campus on Saturday, May 21.

Krahn, daughter of Sylvester and Jean Krahn of Rt. 1, Adell, headed a list of 40 students graduating with honors. Thirteen students, including Krahn, received summa cum laude recognition (3.8 to 4.0 grade point averages). Twelve graduated magna cum laude (3.6 to 3.79) and 15 cum laude (3.5 to 3.59).

Krahn is a graduate of Kewaskum High School. She is currently completing a year-long internship at Swedish American Hospital in Rockford, Ill. The internship ends in June.

"Pamela is the most outstanding student I've had in my over 30 years of teaching at Lakeland," said Allen Wangemann, professor of biology and chairman of the department. "I can't imagine a better student. She had an excellent high school background."

Lakeland's commencement speaker was U.S. Senator William Proxmire of Wisconsin, who is retiring after serving in the Senate for more than 30 years.

Rising Insurance Costs a Major Concern

'88-89 School Budget Reviewed

At a special meeting Monday night, the Kewaskum School Board reviewed the proposed budget for the 1988-89 school year. The preliminary budget, of \$7,366,087, carries a 5.81% or \$405,087 increase over this year's budget of \$6,961,000.

Business Manager Cherna Gorder reported to the board that projected revenues, while formulated purely on a guesstimate basis, should be approximately \$7,103,480. Gorder advised the board a more accurate calculation of anticipated revenues could not be made until state aid formulas are released in late fall.

In reviewing the four-page budget, board member Perry

Ankerson questioned several areas of the report. One of his big concerns was with the big jump in health insurance costs. The report showed a 19.5% increase, from \$322,713 in 1987-88, to \$385,759 for 1988-89. Ankerson told fellow board members, "\$385,000 is a significant figure in this budget and I would like us to pursue other avenues (ways to provide the coverage) with the teachers' cooperation." "I think we should take the position that we are going to reduce this cost."

Ankerson emphasized that he "did not" mean reducing employe benefits. He said the district should look for more economical alternatives of providing that coverage and

possibly the district should consider self-insurance.

Gorder indicated she thought it would be difficult to meet or beat the price and coverage which is being furnished through the Wisconsin Education Association (WEA). Both Gorder and District Administrator Penny Kleinhans noted that the item of health insurance was costly. Kleinhans told the board the district probably doesn't do a good enough job in telling the people that beside a teacher's salary, the district pays out large monthly premiums for life, health, dental and other insurance.

Gorder said approximately 140 employees are covered at a cost, per teacher, of \$289 per month for family plan coverage and \$90 per month for singles plan coverage.

Beside the health insurance costs, the district pays almost \$95,000 a year for life, dental and other insurance costs. Ankeron requested that the board take a closer look at all the insurance programs.

Gorder told the board, "with the continually escalating cost of insurance the district's employees may have to make the decision to give up some of their coverage or pay with us (the district) through a co-payment plan, possibly 80% district, 20% employee."

Board president Ralph Horner also addressed some areas of the budget including funds for substitute teachers, clerical aides, extended contracts and various equipment budgets. He said that if the district would maintain a "status quo" approach on these items, approximately \$180,000 could be cut from next year's

budget. Both Gorder and Kleinhans indicated that some of the items Horner had mentioned were already being considered for removal from the budget with some of them being put on the list for consideration as part of a five-year plan for the district.

The board asked Gorder to go over the budget and specifically, the items which had been discussed during the meeting. Ankeron asked that the budget either be placed on a future agenda or that another special meeting be scheduled for its further review.

In other action the board approved the bid of Dehling - Voigt to do roof replacement work on the Kewaskum Elementary School at a cost of \$45,999. The work is scheduled to be done after school is dismissed for summer vacation.

Board member Donald Nowak asked what the status of the Wayne roof project was after reading various media accounts of supposed problems. Horner said because the issue was not an agenda item, he felt there should not be any board discussion.

The board also approved a contract with Chemical Waste Management of Alsip, Illinois, to dispose of hazardous chemicals and materials from the school district at a cost of \$3,750.

Portion of STH 144 Will Be Closed During Construction

Road construction was expected to start the week of May 23, 1988 on the resurfacing of STH 144 between West Bend and the north county line. The work will consist of milling 3 inches of the old surface and placing a new 30-foot wide, 3-inch recycled bituminous pavement.

The work will be performed under the contract let to Edward Kraemer & Sons, Inc. of Plain, Wisconsin, at an estimated cost of \$857,350.00. Financing will be from the State of Wisconsin from funds provided primarily by gas taxes.

STH 144, between STH 84 and CTH "XX", will be closed to through traffic with access only to local property owners for about 4 weeks. It is anticipated that this stretch of STH 144 will be closed during the week of May 23, 1988, and will be reopened June 27, 1988, in order to install a new cross culvert. Traffic is urged to use caution in the construction zone.

A suitable detour will be provided by the State over STH 84 CTH "X" and CTH "XX."

The remainder of the work will be done under traffic with both directions of traffic being routed over a single lane through the construction zone. Motorists are urged to be aware of the flagpersons and use caution in the construction zone.

It is anticipated that this project will be completed by September, 1988.

Every possible effort will be made to provide continuous and safe ingress and egress to all business and residential properties during this reconstruction, but pedestrians and motorists are urged to use caution in the construction zone.

Memorial Day and the Price of Cherished Freedom

My first trip to Arlington National Cemetery. My immediate impression was sorrow. Lines of stark white tombstones stretched across acres of rolling green hills. All too reminiscent of soldiers in formation. Viewing literally thousands of neatly arranged graves, I cried.

I cried for the brave young men and women who rested there. Soldiers who paid the ultimate price for my cherished freedom. And I cried as I remembered eight very special friends. Friends with whom I shared a unique closeness in Vietnam. Friends with whom I'll never share again. I remembered and paid tribute to them, the men who didn't return with me from the jungles of Southeast Asia.

So many names etched in stone. They began to blur as I slowly rolled my wheelchair through the cemetery. But, as I moved, my sorrow began to ease. In its place, a kind of serenity and a deep feeling of pride settled on me.

I'm proud of each and every one of the more than one million men and women who gave their lives in defense of this great country in our many wars. Proud not only of those who died during time of war, but especially proud of those who died in recent undeclared hostilities.

Over 300 have died since the end of the Vietnam War. They died in Beirut, Grenada, the Persian Gulf, Central America. Nor do I forget the numerous men and women who have died recently as victims of terrorist's bombs and bullets.

My freedom — my wife's and my daughter's freedom — was bought with their blood. This is a debt I can never repay.

I am humbled by their sacrifices. I lost the use of my legs in Vietnam, but I came home. For 14 hours I lay bleeding on the jungle floor. For 14 hours I was sure I was going to die. But I was very fortunate and very blessed. God allowed me to live. On this Memorial Day, I ask all Americans to take a moment and reflect on those who did not come home. A moment to honor the true heroes of our country.

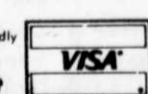

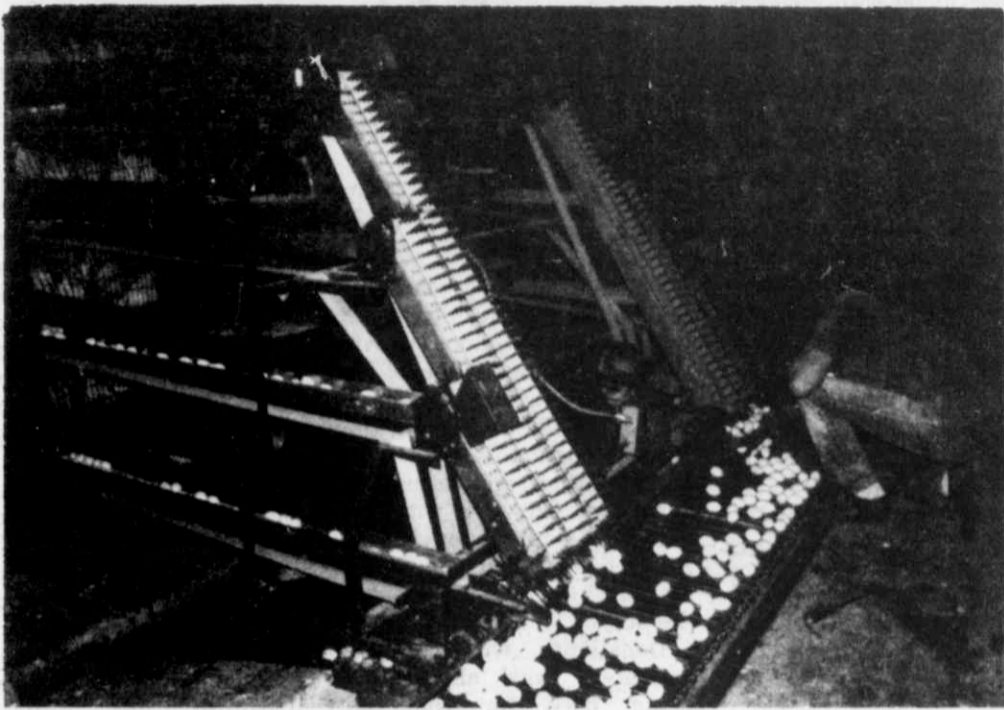

Foreclosure on Kewaskum Egg Farm

First Wisconsin National Bank of Milwaukee has filed a civil suit in Washington County Circuit Court against four controlling partners of the business end of the Kewaskum Egg Farm located at 9249 Wescott Road, in the Town of Farmington. Named were major investors Mark Mueller of Edgerton, James Stoppel of Oregon, Raymond Weiss of Beaver Dam and Dennis Hasenbank of Maquoketa, Iowa. The action is part of a foreclosure move to recoup approximately \$800,000 in loans which the partners have not been able to repay.

Low egg prices, oversupply and health scares are being blamed, in part, for the company's falling on hard times. In an effort to salvage the business earlier this year, the partners tried to attract more investors into a venture they felt could still be profitable as egg prices headed upward.

The operation, one of the largest egg farms in the state with roughly 240,000 chickens, has an average production of 180,000 eggs per day. With producers receiving as low as 22c a dozen for their eggs and the cost to produce that dozen eggs at 38c, the farm was losing approximately \$2,000 a day. Noel Cochrane, the farm's general manager, said the operation produced 51 million eggs last year.

Cochrane noted that this was one of the problems with this type of business. Even if you cut back, it's the kind of operation that can get into full production very quickly. Chickens can begin laying eggs at eighteen weeks of age, and produce for about two years before they are shipped out to other food processors. The Kewaskum Egg Farm has three growing barns where they raise their own birds up to laying age when they are then transferred to one of three laying barns (It takes three growing barns to fill one laying barn).

Cochrane said he realized the business was having severe financial problems when payroll checks for the farm's twelve employees, including himself, as

well as operations checks were being returned due to insufficient funds.

"Everyone of the employees received at least one bad check" said Cochrane. Cochrane and his wife Betty decided something had to be done and fast. "It didn't make any sense to keep issuing checks that bounced," said Cochrane, "and legally the bank could not take over the farm's operation." So we got ourselves incorporated and in a matter of a couple weeks we became the owners of a management company.

The Cochranes contracted with the bank to run the farm and Betty Cochrane became the on-site manager supervising the financial operations.

Cochrane stated in an interview Monday, "We have

roughly 200,000 chickens which have to be fed and watered daily and people who need and expect to receive a paycheck." "I thought it was my obligation to do something to keep the farm operating. I felt we had a commitment to the community as well as the employees." Cochrane said it was a bad situation all around, not only for the employees but for the local businesses who ended up holding some of those bad checks.

Betty Cochrane noted the situation was also very involved. What complicates the situation, she noted, is the fact that the foreclosure is against the business which consists solely of the chickens and the equipment inside the buildings and barns. The barns themselves and the property are

rented from Phoebe Weiss, the owner, who is also the wife of Raymond Weiss.

"The property also has a land contract on it, so you are looking for a buyer that would have to come up with around \$1 million to purchase the operation, birds, equipment and property."

Since the news broke about the foreclosure dozens of rumors have been circulating about the farm's future. Cochrane said the farm would continue operations and there would not be any auctions.

The Cochranes said several interested parties had looked over the operation. But, added Betty Cochrane, there are a lot of egg farms like this one for sale, maybe not right here in Wisconsin but in other parts of the country. Cochrane said he had been informed by the bank that a sealed bid sale for the chickens and equipment was to take place Tuesday morning.

In a phone conversation late Tuesday afternoon Betty Cochrane said she had received word from the bank that the farm had been sold to Oshkosh Foundries, a subsidiary of First National Bank, through a buy-in.

"It looks like our management company will continue to operate the farm for Oshkosh Foundries," said Cochrane.

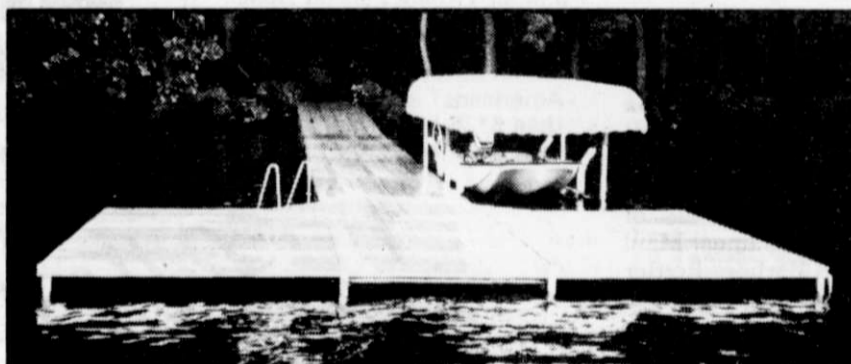

State Patrol Kicks Off "Saved by the Belt" Club

Governor Tommy G. Thompson and Transportation Secretary Ronald R. Fiedler kicked off a statewide "Saved by the Belt" Club for State Patrol, county sheriffs and local police departments at ceremonies at the Capitol, recently. It was inaugurated during National Transportation Week (May 15-21) and just in time for the All-American Buckle Up Week, May 22-28.

"I'm proud to be able to present certificates to these survivors of a life-threatening accident because they were wearing seatbelts," said Governor Thompson. "Seat belts save lives, and here is the proof: Edward Roberts of Wausau, Jerilyn Smith and her children Lindsay and Justin of Racine, Normand Maynard of Minneapolis, Irene and Evan Knupp of Madison, and Rock County Deputy Sheriff Eric Runaas."

Edward Roberts was driving his pickup through Wausau when it was struck broadside by a second pickup truck traveling at an excessive speed through an uncontrolled intersection. Although suffering whiplash, bruises and strained muscles, Roberts managed to escape being thrown from the vehicle or sustaining more serious injuries, according to the accident report.

On March 7, Mrs. Jerilyn Smith and her children Lindsay and Justin were traveling I-94 in Monroe County in her 1984 van when she strayed to the right shoulder of the road. In attempting to return to the pavement, she lost control, rolled the van over and rotated it 180 degrees, coming to a stop on its top in the middle of I-94. When it rolled, the van caused injury to her left hand which was along the driver's door; her wedding band was crushed. State Patrol Sgt. Steven Hanson who nominated the family felt that had they not been belted, the van would have thrown them around inside the van at best, and at worst thrown someone out of the van, which could then have rolled over them.

For Normand Maynard, a cameraman for WCCO-TV in Minneapolis, another vehicle's illegal turn at a cross-over on Interstate 94 near the town of Union in Eau Claire County nearly cost him his life. The other car caused traffic in the faster, left lane to slow down suddenly; Maynard could not stop in time, and he elected to swerve onto the median to avoid hitting the traffic immediately ahead of him. The van rolled over as it continued forward and struck the car making the illegal turn. Virtually every part of the van was damaged, leaving it immobilized.

Mrs. Irene Knupp and her son Evan were driving to school in their family van this winter on an icy day when she lost control and slid the vehicle against a tree. They were both belted and escaped serious injury, although the van sustained \$7,500 worth of damage. Ironically, her husband Ted Knupp runs an advertising agency which had completed production of a public service announcement for DOT just days before — on the subject of the recently passed new safety belt law, and using that very van as one of its demonstration vehicles.

For Rock County Deputy Sheriff Eric Runaas, his "Saved by Belt" episode occurred while he was in the line of duty. He was pursuing a traffic violator on the outskirts of Janesville when a pickup truck pulled out of a private driveway into his path. The squad car plowed under the chassis of the pickup which had been modified to raise it substantially above the typical chassis. The squad was engulfed in flames from the gas leaking from the pickup. A passerby helped Runaas break out a window and escape — all four doors had been jammed shut by the impact. Runaas believes that being protected by the belt prevented him from sustaining serious injury while the vehicles collided — which kept him agile enough to exit through the window.

The Saved by the Belt Club, originated by the Wisconsin Safety Belt Coalition, is being expanded statewide to encourage participation by investigating officers from the Wisconsin State Patrol, county sheriff's departments and local police departments. Those accident survivors who were saved from serious injuries or death because they were wearing belts will be nominated by investigating officers and recognized by the captain of the appropriate agency with certificates, a "Saved by the Belt" lapel pin and a bumper sticker.

The program is sponsored jointly by the Wisconsin State Patrol, the DOT Office for Highway Safety and the Wisconsin Safety Belt Coalition.

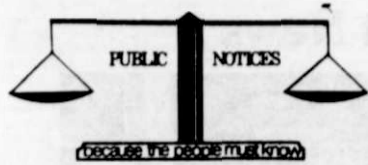

The 1988 County 4-H Camp will be held July 6-9 at Camp Upham Woods near the Wisconsin Dells. Youth 9-14 years of age may enroll in the County 4-H Camp. Registration forms are available at the

Wild Turkey Season Brings Record Harvest

The 1988 wild turkey hunting season produced a record harvest of gobblers, announced Ed Frank, wild turkey season coordinator for the Wisconsin Department of Natural Resources.

The total 1988 turkey harvest was 2,452 through the four hunting periods. A total 11,070 permits were issued, resulting in a hunter success rate of 0.22. "The 1988 turkey season was a tremendous success," said

Frank. "This was only the sixth season we've had in Wisconsin, yet more than 11,000 wild turkey hunters had an opportunity to get their gobbler this year."

In 1987, the total harvest was 1,482 from 6,040 permits issued, giving a hunter success rate of 0.25. Frank attributed this year's lower hunter success rate to bad weather during the early hunting period and hens nesting later than usual.

BUTTERFLY DESIGN CHOSEN AS 1989 PARKS STICKER

The 1989 Wisconsin State Parks sticker design contest has been won by Seymour Community High School senior Donna Jean Demita Cartier. The contest was co-sponsored by the Wisconsin Department of Natural Resources and Laacke and Joys, Inc., a Milwaukee sporting goods retailer.

The winning design will be used as the 1989 admissions sticker purchased annually for entrance into state parks and forests. It will be displayed on more than 150,000 vehicles.

As first place winner, Cartier will receive a plaque from the DNR Bureau of Parks and Recreation and a \$500 post-high school scholarship from Laacke and Joys, Inc. Her design was chosen from a field of 166 entries submitted from across the state.



Second place was awarded to Mara Scheckler of Edgewood High School, Madison and third place went to William Koehnlein of Waukesha South High School, Waukesha. These

winners will receive a plaque from the Bureau of Parks and Recreation.

The department also recognized seven other entries for their designs. Honorable mention certificates went to: Virginia Friske of Milwaukee Technical and Trade High School, Milwaukee; Lawrence Kleme, Jr. of Prairie du Chien High School, Prairie du Chien; Scott Milawski of Muskego High School, Wind Lake; Scott Druzak of Greendale High School, Greendale; Lara Schieffer of Edgewood High School, Madison; Yvonne Vanark of Waupun Senior High School, Waupun; and Kelly Roy of Washburn High School, Washburn.

The 1989 Wisconsin State Parks and Forests Admission Sticker Contest was the first annual contest. High school seniors from throughout Wisconsin were invited to participate.

Sheriff Clarence A. Schwartz announced that Deputies will begin handing the cards out on Memorial Day. The baseball cards act as an incentive for the kids to get to know the officers. They learn the officers are human beings, not merely symbols of "authority" that must be feared.

The Sheriff indicated the cards would be distributed at the rate of two players per week and feature the entire Milwaukee Brewer Baseball Club. Youngsters may flag down squads that pass by and ask the Deputies for the cards.

"We do ask parents to instruct their children not to run out into the road, for obvious reasons. Also, children should not rush to an officer who is on foot unless the officer invites them over, just in case the officer is involved in an investigation or other activity that could present a danger," the Sheriff remarked.

The baseball cards were purchased through donations from area business places. It is the only program for which the Sheriff's Department solicits or invites donations.

May 16, 1988
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Paul Blumer presided. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Charles Boegel, seconded by Richard Schlice and unanimously carried by voice vote, the minutes of the Regular and Special Meeting of May 2 & 3, 1988, were approved as printed.

The public hearing was held on the accuracy of the preliminary wetland maps for the Village of Kewaskum. No one was present to speak either for or against. The Administrator questioned the area just west of Edgewood between Forest and North.

On a motion by Trustee Mary Krueger, seconded by Trustee Kenneth Bonlender to close the public hearing. Roll call vote was 7 "Aye," 0 "Nay," 0 "Absent."

The public hearing was held on the application for a Combination Class "A" Retail Fermented Malt Beverage and Intoxicating Liquor License for the period commencing May 17, 1988 and ending June 30, 1988 for Dennis E. Campbell, 355 Main Street, Kewaskum, WI. No one spoke either for or against. Mr. Campbell's brother, sisters and daughter were present. The Police Chief informed the Board that the Department's recommendation, based upon his investigation, that the application for issuance of the license be denied. The reasons for the recommendation were outlined in a letter given to the Board.

Campbell be denied for the reasons set forth in the recommendation of the Chief of Police as reviewed by the Village Board at the public hearing. Roll call vote was carried unanimously. Roll call was 7 "Aye," 0 "Nay," 0 "Absent."

The public hearing was held on the application for a Class "B" Fermented Malt Beverage License for the period commencing May 17, 1988 and ending October 1, 1988 for the Kewaskum Athletic Club, Bilgo Lane, Kewaskum, WI.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Mary Krueger to close the public hearing. Roll call vote was carried unanimously. Roll call was 7 "Aye," 0 "Nay," 0 "Absent."

Fire Chief Donald Ehner expressed his dissatisfaction with the progress related to the fire house renovation work. Fire Chief Ehner referred to the sidewalk work and other items done incorrectly not caught by the Engineers. Public Works Superintendent Augie Bilgo commented on the siding material selected by the committees and Board. The Board indicated that is why they hired an engineer, for their recommendation and inspections.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Howard Laubenstein and unanimously carried by voice vote, the Board indicated the Engineering firm of Ruckert & Mielke, Inc. should be responsible for the payment of the two sidewalk drain castings and the Department of Public Work's re-landscaping of the west side of the Fire House. The administrator was directed to notify the Engineers.

On a motion by Trustee Charles Boegel, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board approved the Operator's (bartender's) License for Ronald Theusch, Kewaskum, WI and authorized the office to issue the license upon proper payment of fee. The Police Department had no

objection to the application.

On a motion by Trustee Kenneth Bonlender, seconded by Trustee Howard Laubenstein and unanimously carried by voice vote, the Board approved the building permit application of John Gitter, 550 Werner Drive to construct a single family residence. The office was instructed to issue the permit upon proper payment of fees.

On a motion by Trustee Richard Schlice, seconded by Trustee Charles Boegel and unanimously carried by voice vote, the Board approved the building permit application of James Hanson, 1457 Parkview Drive, to construct a garage/shed in rear yard. The office was instructed to issue the permit upon proper payment of fees.

Administrator Daniel Schmidt reviewed a variety of correspondence with the Board.

Trustee Richard Schlice asked the Police Chief to review the intersection of Braatz Drive and Western Avenue for the possible placement of a stop

sign.

Trustee Thomas McElhatton, Chairman of the Park and Recreation Committee reviewed the transactions of the Committee meeting which took place earlier in the evening.

On a motion by Trustee Mary Krueger, seconded by Trustee Kenneth Bonlender and unanimously carried the Administrator was directed to obtain quotes on installing horse shoe pit lighting. It was noted the Kewaskum Kiwanis have pledged \$500 towards the installation of such lighting.

Discussion regarding the Capital Improvements Sidewalk Extension Program was reviewed along with the proposed timetable.

Action was taken on Resolution No. 88-8 as attached hereto:

On a motion by Trustee Howard Laubenstein, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board authorized the advertising of bids for the 1988 sidewalk project. The bids

are to be opened June 6, 1988.

Discussion was held on the wetland maps as reviewed at public hearing earlier in the evening. On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Boegel and unanimously carried by voice vote, the Board authorized the return of the preliminary wetland maps to the DNR with one comment sheet regarding the area just west of Edgewood between Forest and North.

On a motion by Trustee Richard Schlice, seconded by Trustee Thomas McElhatton, the Board approved the following application for a Class "B" Fermented Malt Beverage License for a period commencing May 17, 1988, and ending October 1, 1988, upon payment of the required fees. The Police Department didn't have any objections and the office was authorized to issue the proper license.

Kewaskum Athletic Club, Bilgo Lane, Kewaskum, WI

Action was taken on Ordinance No. 88-3 as attached hereto:

It was noted to add the rinsing of steel cans and the inclusion of batteries. On a motion by Trustee Richard Schlice, seconded by Trustee Kenneth Bonlender and unanimously carried by voice, the Board authorized advertising for two recycling site managers.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board

approved the Village of Kewaskum - Recycling Policy as attached hereto:

On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Boegel and unanimously carried by voice vote, the Board authorized the hiring of Jennifer Koepke as Secretary at the rate of \$5.74 per hour. It was noted 22 applications were received of which 7 were Village residents.

A discussion was held on the Village's Emergency sirens. It was noted their range and effect depend greatly on the weather. The siren helps those individuals driving and outside a lot easier than those inside. It was mentioned that if someone wishes greater protection a weather radio for in the home is a real asset. In conjunction with the discussion, Administrator Schmidt suggested the possibility of the replacement of the siren on the Municipal Building or possibly the placement of another new one on the northwest side of the Village. The consensus of the Board was to have the Administrator check into the matter.

ORDINANCE NO. 88-3

AN ORDINANCE AMENDING SECTION 14.09 OF THE MUNICIPAL CODE OF THE VILLAGE OF KEWASKUM RELATING TO GARBAGE AND REFUSE DISPOSAL

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM DO ORDAIN AS FOLLOWS:

SECTION 1: Section 14.09 (1) Definitions (a) thru (p) Insert alphabetically.

() **Collector/Vendor.** The person or persons specifically authorized by the Village Board to collect garbage, rubbish and recyclable materials and dispose of the same.

() **Non-Recyclable Material.** All pyrex glass, window glass, light bulbs, mirrors, broken glass and china, all styrofoam and melamine type plastics, all waxed paper, waxed cardboard, envelopes with gummed labels, glossy paper, magazines and envelopes with plastic windows and all other paper, garbage and rubbish, telephone directories, etc., not defined as recyclable materials.

() **Recyclable Material.** Newspapers; cardboard; plastic containers; brown, green and white container glass; motor oil; aluminum cans; steel cans; batteries; heavy metal objects; grass clippings and leaves.

() **Recycling Center.** The location designated as the delivery site for the recyclable materials. The Village Recycling Center will be an area adjacent to the Municipal Garage, 1002 Fond du Lac Avenue.

Section 14.09 (15) **Items Subject to Recycling.** The following items of rubbish and garbage may be delivered to the Recycling Center on condition that the resident or property owner complies with the preparations hereinafter indicate recycling is not mandatory.

- (a) Plastic milk jugs, soda bottles, and ice cream containers — remove caps, rinse, flatten if possible.
- (b) Newspapers — separate from magazines and colored advertising, bundle securely.
- (c) Cardboard — flatten cartons.
- (d) Aluminum cans — separate from steel cans, flatten if possible, labels may be left on.
- (e) Steel cans — separate from aluminum cans, flatten if possible, labels may be left on, and rinsed.
- (f) Glass — sort by color (clear, green or brown), labels may be left on, no window glass, light bulbs or ceramics. Please do not crush. Remove all metal neck bands.

Section 14.09 (16) **Items Not Picked Up.** The following items will not be picked up by the Village in connection with its regular weekly garbage collection, but will be accepted for disposition by the Village Recycling Center on condition that the following preparations are made by the owner or resident generating such items of waste:

- (a) Miscellaneous metal — sort by content, if possible, remove all non-metal attached.
- (b) Major appliances — place in the designated area at the Center, or call for arranged pick-up.
- (c) Waste oil — pour into a tightly closed container.
- (d) Tires — refer to Section 14.09 (5)(c)
- (e) Grass clippings and leaves — place in the designated area (compost pile).
- (f) Nonrecyclable materials (furniture, carpeting, etc.) — check with Recycling Center staff and D.P.W.
- (g) Batteries — place in designated area at center

Section 14.09 (17) **Recycling.** The Village of Kewaskum shall maintain a recycling center at or near the Municipal Garage. The hours for the reception or acceptance of recyclable materials shall be set by the Village Board and posted at the entrance to the recycling center. The purpose of the recycling center is to establish a place for the collection of recyclable materials. A vendor will be designated by the Village Board of the Village of Kewaskum to transport the recyclable materials from the recycling center to the place of processing.

Section 14.09 (18) **Prohibited Activity.** No person, firm, or corporation shall remove or rearrange any materials in the recycling center without the permission of the operator of the recycling center. Only Village residents are allowed to deposit their recyclables at the Village Recycling Center.

Section 14.09 (19) **Limitations.** All conditions and requirements established by the Village Board must be adhered to by the users of the recycling center. Failure to adhere to this norm shall result in the refusal and nonacceptance of the items offered.

Section 14.09 (20) **Items to be Disposed of Privately.** Construction materials, demolition materials, sod, dirt or stone must be disposed of privately and will not be picked up or accepted at the recycling center.

SECTION 2: Section 14.09 (15) Penalty - to be changed to Section 14.09 (21)

SECTION 3: All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

SECTION 4: This ordinance shall take effect the day after passage and publication as provided by law.

2. The public improvements shall be the installation of sidewalk on Prospect Drive, Riverview Drive and Werner Drive to meet the specifications in the Village of Kewaskum and other related specifications contained in Section 8 of the Municipal Code of the Village of Kewaskum and under the Village Engineers specifications for sidewalk and curb and gutter installation.

3. The total amount assessed against the properties in the defined assessment district shall not exceed 100% of the total cost of the improvements. The Village Board determines that the improvement constitutes an exercise of police power and the amount assessed against each parcel shall be based on the lineal footage of said parcel abutting on Prospect Drive, Riverview Drive and Werner Drive.

4. The assessment against any parcel may be paid in cash or in annual installments the number of which shall be determined at the public hearing on the proposed assessment.

5. The Village Engineer shall prepare a report which shall consist of:

- a. Preliminary or final plans and specifications for the improvements.
- b. An estimate of the entire cost of this proposed sidewalk and curb and gutter improvement.
- c. Schedule of proposed assessments against each parcel.

6. When the report is completed, the Village Engineer shall file a copy of the report with the Village Clerk for public inspection.

7. Upon receiving the report of the Village Engineer, the Clerk shall cause a notice to be given stating the nature of the proposed improvements, the general boundary lines of the proposed assessment district, the time and place at which the report may be inspected, and the time and place of the public hearing on the matters contained in the preliminary resolution and the report. This notice shall be published as a class 1 notice and a copy shall be mailed, at least 10 days before the hearing, to every interested party.

8. The hearing shall be held in the Kewaskum Municipal Building, 204 First Street, at a time set by the Clerk in accordance with Sec. 66.60(7), Wisc. Stats.

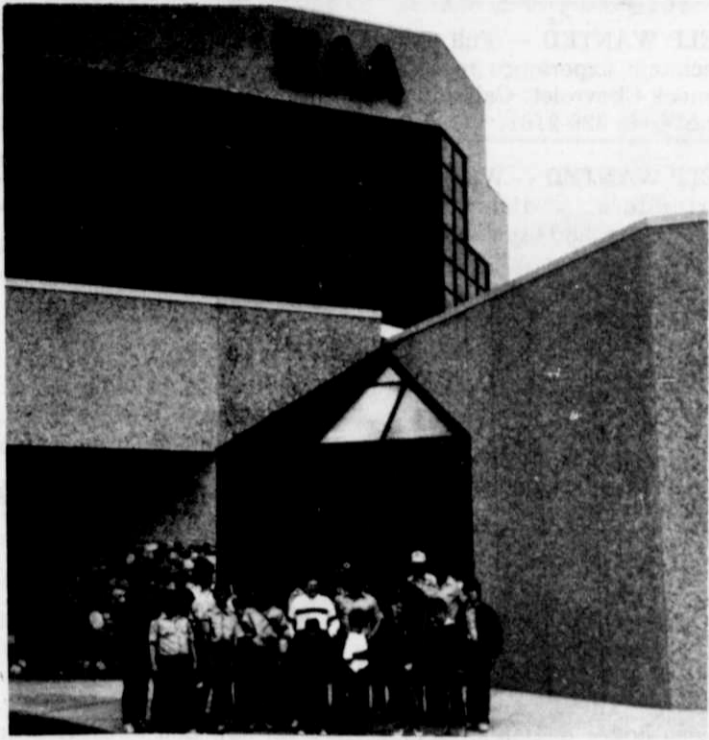

New Rustic Roads Map Available

Wander through the backroads of Wisconsin. Enjoy a retreat in time and place through the Rustic Road System promoted by the Department of Transportation. And just in time for the summer tourism season, DOT has published a new edition of its Rustic Roads brochure containing small maps of all 50 routes throughout the state officially designated as rustic roads.

Rustic roads are back-country or side roads where traffic volume is low, but historical, cultural and scenic values are high. In 1987 four new rustic roads in Waushara, Sauk, Adams and Pierce counties were added to the system.

The 50 rustic roads pictured in the brochure are located in 30 counties and range from 2 to 26 miles in length. Some roads pass through thickly wooded lake country, abounding with wildlife. Others wind through open farming areas, offering pleasant agricultural vistas. There are gravel roads, but most are paved. Some curve, some follow hills and dales and some flow through prairie vistas; but all of them offer enjoyable sights for the leisurely traveler.

The roads are identified by brown and yellow signs with a one-to-three digit identification number prefixed by the letter "R," assigned by the State Rustic Roads Board. The maximum speed on any rustic road is 45 mph.

Wisconsin's Rustic Roads System was created by the 1973 state legislature to preserve what remains of the state's scenic, lightly traveled country roads for the leisurely enjoyment of bikers, hikers and motorists.

Indian Boys 5th, Girls 6th at EW Conference Track Meet

TWO RIVERS — Although the Kewaskum boys' track team had no individual winners in any event at last week's Eastern Wisconsin Conference track meet, the Indians did manage to accumulate enough points to place fifth; only five points behind fourth place Kiel.

As expected, Two Rivers dominated the meet (132 points) winning six events and placing second in four more. Sheboygan Falls was the runner-up with 85 points, followed by New Holstein (78), and then Kiel (68), Kewaskum (63), Plymouth (40), and Chilton (30).

Between them Two Rivers' Shawn Thomas and Ross Henrickson combined for 52 points; Thomas won the 100 (11.2) and 200 (22.5) meter dashes and helped his team's 400 meter relay place second, while Henrickson won both the 800 (2:02.7) and 1600 (4:31.2) meter runs and still had enough left to place fourth in the 3200 meter run (10:10.6).

Mary Schulteis and Ryan Degnitz placed in both the 110 meter high hurdles and the 330 meter intermediate hurdles. Schulteis placed second in the 110 highs (15.9) while Degnitz placed sixth (17.3). In the 330 meter lows, Schulteis again rebroke his own school mark (41.1) as he placed third in the event. Degnitz also ran well, taking fifth with a fast time of 41.6.

Freshman Chris Donath ran impressively, taking second place in the 880 meter run which he led until the final 100 meters. His time of 2:04.02 is less than two seconds slower than the Kewaskum High School record set back in 1985 by Monty Shaw.
