## William J. Harbeck, Former Editor, Publisher of Kewaskum Statesman Dies



William J. Harbeck

William J. Harbeck, 74, passed away at his home, at 1275 Brooklane Dr., Kewaskum, on Wednesday, August 10, 1988.

He was born May 5, 1914, in Kewaskum, a son of the late Donald J. and Rose C. (Rommel) Harbeck.

He married the former Marcella Heisler in Holy Trinity Catholic Church, Kewaskum, on May 28, 1938. They recently observed their 50th wedding anniversary.

Mr. Harbeck was the former owner, editor and publisher of The Kewaskum Statesman. He purchas-

ed the business from his father in 1954. Mr. Harbeck began his career in the newspaper business in 1934, and became editor in 1951. He worked in that capacity until illness caused his retirement in 1987. He then sold the newspaper business to his daughter Lana, who became the third generation of the Harbeck family to own and operate the Statesman.

Mr. Harbeck celebrated his fiftieth anniversary in the newspaper business on April 23, 1984. He was recently honored by the Wisconsin Newspaper Association for his 50

year membership. He was also a member of the National Newspaper Association, Kewaskum Chamber of Commerce and a retired member of the Kewaskum Fire Dept. having served 36 years. Mr. Harbeck was an usher for Holy Trinity Church for over 50 years, and a member of their Holy Name Society. Bill was also an avid sports fan and was a former player in the Badger State and Land O' Lakes baseball leagues.

Survivors include his wife, Marcella, and three daughters, Carole and her husband Henry Timblin, Kewaskum, Sheri and her husband Don Baldikowski, Milwaukee, and Lana and her husband Dennis Kuehl, Kewaskum; eight grandchildren, Tom (Debbie) Timblin, Kewaskum, Todd Timblin, Eden, Tami Timblin, Kiel, Trev Timblin, Kewaskum, Staci Baldikowski, Milwaukee, and Andrew, Dustin and Ross Kuehl, all of Kewaskum; four great-grandchildren; one sister, Helen and her husband Frank Felix, Kewaskum, one brother-in-law, Frank and his wife June Heisler, Fond du Lac; nieces, nephews, other relatives and friends.

Funeral services will be at 8 p.m. Friday, August 12, at Holy Trinity Church, Kewaskum. Father Robert Berghammer will officiate. Burial will be in Holy Trinity Cemetery.

## Knoebel Is New Police Chief

At a special meeting last Thursday evening, the Kewaskum Village Board formally approved the selection of Richard Knoebel as its new police chief, replacing Donald Hlavaty who will be retiring at the end of this month. By a unanimous vote, the board accepted the Police and Fire Commission's recommendation to hire Knoebel as Hlavaty's successor.

Knoebel, 38, has been an officer with the Kewaskum Police Department since February 1, 1973. He has been the department's Juvenile Officer and senior officer for ten years. Knoebel has also worked the past three years as an instructor in the DNR's Hunter Safety Training program.

A native of West Bend, Knoebel attended the University of Wisconsin at LaCrosse and Stevens Point where he had intended to pursue a career in

the natural resources field. Knoebel said plans for his future changed in 1973 when he applied for a position as patrolman with the Kewaskum Police Department during a school semester break. I passed the test and was offered the job, said Knoebel, so I decided to take it.

Knoebel will officially begin his duties as chief on September 1st, at a beginning annual salary of \$26,244, which will increase to \$26,787, after 120 days. He will head the department which consists of three full time and five part time patrolmen. Knoebel resides in Kewaskum with his wife Cindy and daughter Kelly, 8.

Beside Knoebel, two other individuals from the department applied for the chief's post. In the next month or so, the village will begin searching for an individual to fill the patrolman vacancy created by Knoebel's appointment.

## Middle School Principal Contract Approved

With only a simple majority present at its meeting Monday night, the Kewaskum Board of Education approved the hiring of Steven King as the new Middle School principal. The board approved a 240-day, two year contract with a beginning salary of \$38,000 plus fringe benefits. Board members Ralph Horner, Clara Trapp and Ruth Schmitt were absent from the meeting.

King resides in Jackson but has been working for the Port Washington School District

where he served as assistant middle school principal. He will be replacing Julie Backus who resigned at the end of this past school year to accept a position with another school district.

Backus had served as both middle school principal and director of instruction. The board as yet, has not taken any action to fill the director of instruction vacancy.

In other staffing related business, president pro-tem Ronald Beimborn said the search for a new district administrator had been narrowed down to three

candidates from a field of eight semi-finalists. He said board members had traveled to the communities of the three finalists and they, in turn, have been invited to return next Wednesday and Thursday for final interviews. Beimborn said the board expected to deal with making the final selection on Thursday.

The board also discussed the possibility of a self-insurance program for the district in the areas of health and dental

# Milwaukee River Watersheds Program To Start With Area East-West Branches

For the past two years state and local government bodies have been working together on a Milwaukee River Priority Watersheds Program. The purpose of the project is to improve and protect the Milwaukee River Basin's natural resources and improve its water quality.

The basin is unique in that it covers land in seven south-eastern Wisconsin counties beginning at its northernmost points in Fond du Lac and Sheboygan Counties, traveling south to its Lake Michigan outlet and still farther south to Greendale in Milwaukee County.

The basin includes five different watersheds in those counties, encompassing 830 square miles in portions of 30 townships, 12 cities and 24 villages including Kewaskum.

Kewaskum and the surrounding area are part of the East-West Branches Watershed which is the largest of the five watersheds, covering approximately 265 miles and containing roughly half of the basin's major lakes.

Because the East-West Watershed contributes 40-50% of the stream flow, sediments and nutrients into the Milwaukee River Basin, it has been targeted as the first phase in a major and massive cleanup effort of the basin. Both short and long range efforts are being directed at several issues including nonpoint source pollution, point pollution and solid waste disposal.

Nonpoint source pollution, both rural and urban, is estimated to contribute more than 80% of the sediment and nutrients going into surface water. It is estimated that 29 tons of soil per year are being eroded into streams and tributaries which feed the Milwaukee River.

Rural pollution sources include such things as fertilizer run-off from fields, animal waste run-off from cow lots on or adjoining waterways, and soil erosion due to the breakdown of stream banks.

Urban sources of pollution are water run-off from construction sites which washes soil down into storm sewers, toxic materials from streets and parking lots, the dumping of drain oil and grass, leaves and

fertilizers from lawns.

Point source pollution is identified as specific areas such as treatment plants which do not provide sufficient treatment to meet surface or ground water quality standards.

The participating counties and Department of Natural Resources have recently completed two plans for the clean up of the East-West Watershed. The first, called the Integrated Resource Management Plan: 2000, identified the major management and environmental protection issues and strategies for action. The second called the watershed's nonpoint pollution control plan, identifies the land management practices needed to protect the lakes and streams and describes the cost sharing money and technical assistance that will be provided to landowners and local governments who participate in the program.

In a recent update on the program's progress, Sharon Gayan, DNR Program Planning Analyst Coordinator for the program and Dan Wilson, Washington County, University of Wisconsin Extension Agent, said the Integrated Resource Management Plan had received approval in August. The Nonpoint Pollution Control Plan, recently completed, was expected to receive approval by September. Public hearings will be held to review the findings and the long range plan.

Gayan said people and municipalities should be aware of the fact that both financial and technical assistance is available for the implementation of conservation and management practices for the Milwaukee River's cleanup. "Between \$20 and \$50 million will be spent on the project," said Gayan. Financial assistance to landowners who participate in the program will range anywhere from 30% to 70% of their costs. She cautioned, however, some programs may fall under the 1985 farm bills or farmland preservation act.

Gayan noted that landowners have a three-year time period in which to sign up for the program. That time frame is strictly for sign-up and does not require completion of the project within that time span. Implementation of the watershed program will be carried out over a twelve-year period

until the year 2000.

Wilson noted cooperation from local landowners has been very good so far. People are concerned and willing to work with our specialists in finding solutions to correct their problems.

Gayan and Wilson said the program will also link water quality improvements with the improved management of other resources as well as coordinate management and conservation programs to avoid and eliminate duplication of efforts by the various state and county agencies.

Gayan noted that while there had been excellent cooperation on the program for the East-West Watershed, the real challenge will be ahead when the program is taken to the metropolitan Milwaukee area. "We will have to educate urban residents in conservation and changing their habits to eliminate pollution." People in the city do not realize that grassclippings and animal feces down the sewer are just as polluting as run-off from farmyards and fields, she noted.

not knowledgeable, nor did he expect the administration to be experts, however, he felt the issue should still be pursued.

Interim Superintendent Ray Kinziger said every school district has been facing the same dilemma. He suggested the board contact an independent insurance advisor who could review the district's insurance program and needs and advise it which route was the best for Kewaskum.

Board member Neal Weare said he too, would like to know what the risk factors and benefits would be if the district would go to a self-insurance plan.

The board directed Kinziger to bring in such an expert, either from the Wisconsin Association of School Boards, or another independent consultant to talk to it about the pros and cons of a self-insurance plan.

The issue of a rate increase for on-call substitute cooks was turned over to the Negotiations Committee for review and a recommendation.

The board approved the appointment of Roy Esser as a delegate to the county's Truancy Committee, the appointment of Jim Westphal and Perry Koth as assistant high school football coaches, and a 50% language arts contract.

The board also confirmed the date of August 16th, for the district's Annual Meeting and approved resolutions to be presented at that meeting.

insurance. Board member Perry Ankerson said his concern over the steadily rising costs in these areas prompted him to ask that it be placed on the agenda for discussion.

Business Manager Cherna Gorder told the board that, after looking into the matter and gathering information as requested by Ankerson, she found it to be much more involved than anyone had anticipated. Among the things she had discovered was that it would take a lot of paper and accounting work for the district to run its own system. "We would also need a separate audit among other things," she said.

Gorder also noted such a plan required study and investigation of such a proposal by an individual who had a more extensive knowledge in the area of insurance than she possessed.

Ankerson admitted he was

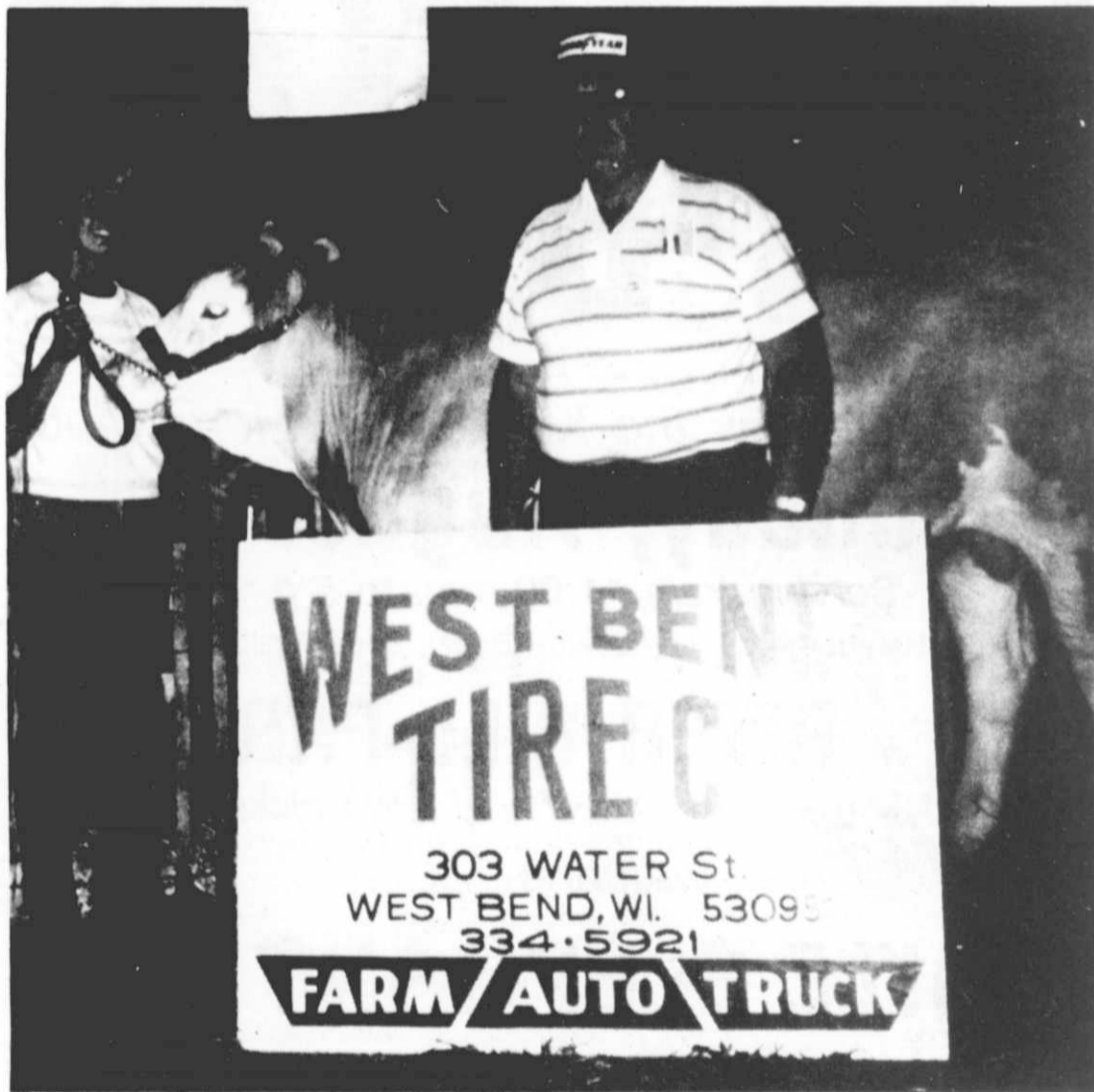


## KHS Class of 1936 Holds 52nd Reunion

## Army Recruiter Notes Anniversary Of Volunteer Army

Today's Army is more qualified and educated than ever before, and it's an "All Volunteer" Army.

This summer, the Army celebrates its 15th anniversary of the All Volunteer/All Recruited Army, according to SSG Martin J. Kasper, local Army recruiter of the West Bend Army Recruiting Station.

Previously, volunteerism had always been the backbone of the U.S. Army, with the drafting having been in effect for only some 35 years, mainly during times of war and for a period of 20 years following the conflict in Korea. The last draftee entered the Army in 1972. The only time conscription completely replaced volunteerism was during the latter part of World War II.

Soldiers of today are high school graduates with over 90 percent scoring in the upper half of the Army's eligibility test. "High school graduates make good soldiers because they finish what they start. ### Grover Announces AOD Grants To School Districts

MADISON — More than 145 Wisconsin school districts will share nearly \$1.7 million in expanded alcohol and other drug (AOD) grants administered by the Department of Public Instruction. Kewaskum School District will receive \$11,000.00.

State Superintendent Herbert J. Grover has awarded 82 grants that will help school districts, cooperative educational service agencies, and school consortiums expand or implement programs to prevent drug or alcohol use among students or to assist students who have problems with alcohol or drugs.

More than 120 schools and school groups applied for grants. A team of members of the State Superintendent's AOD Advisory Council and other AOD experts evaluated the grants. Proposals were judged on the perceived need, appropriateness of the plan to meet the need, school and community involvement, and the plan's integration with current AOD efforts.

"The 1987-88 Legislature expanded the funding available for AOD education programs through Wisconsin Act 339. That \$740,000 combined with the penalty assessment already targeted to drug and alcohol prevention education, allowed the DPI to double the number of school districts receiving AOD prevention grants," Grover said.

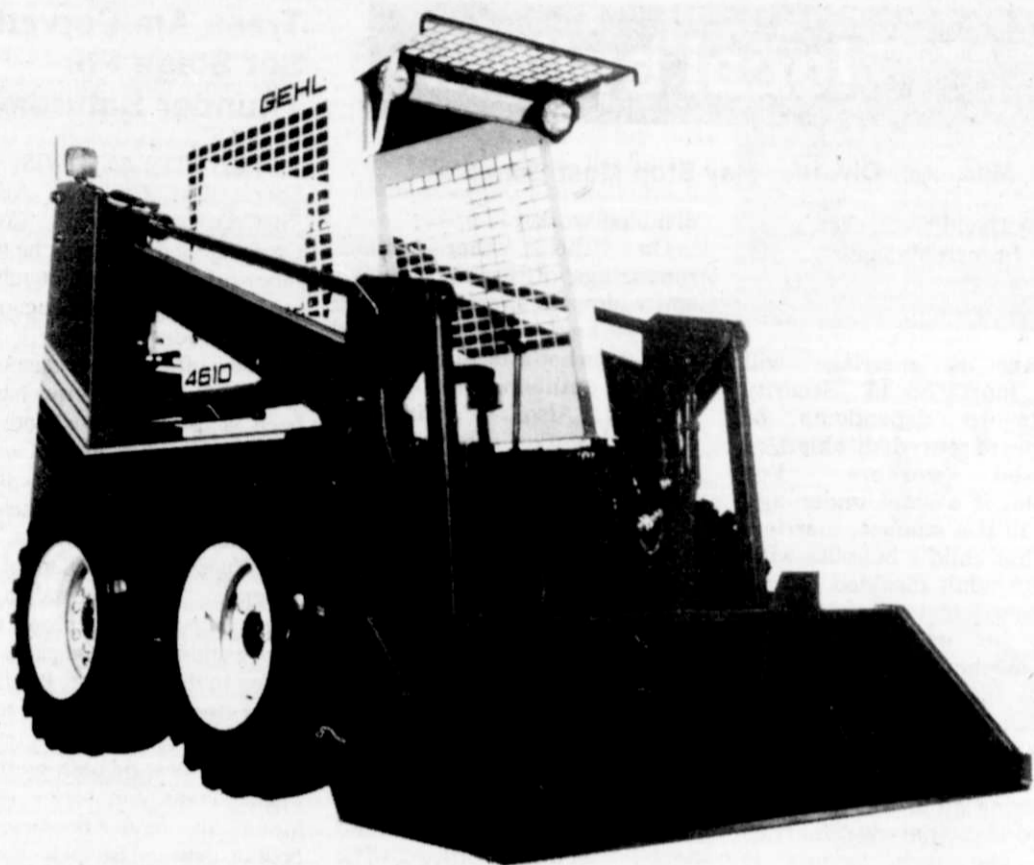

## Gehl's Skid-Steer Loader — A Mobile Power Unit



(West Bend, WI) — The name "skid-steer loader" offers just a glimpse of what this powerful and versatile machine can deliver. First of all, it's a loader. It loads and unloads materials at construction sites, farms, nurseries, or anywhere else it's needed. The "skid-steer" part of its name comes from its ability to lock its wheels on either side, allowing the machine to skid and turn. This characteristic enables it to turn within the length of its own wheelbase. But that's just the beginning...

Most sophisticated skid-steer loaders, like the Gehl skid loader, not only work well as loaders with buckets, but they accept multiple attachments, too. Available attachments include various-size buckets, cold planers, hydraulic augers, sweeper brooms, backhoes, pallet forks, concrete breakers, tree spades, trenchers, industrial grapples, and snow blowers. In most cases, changing attachments simply involves pulling an over-center clamp, removing two pins, and backing away.

Available options include tracks, flotation tires sets, solid rubber tire sets, all-weather enclosures, heater/defroster kits, hydraulic reservoir heaters and beacon lights.

Because skid-steer loaders are small and maneuverable, they work

exceptionally well in tight, confining spaces where larger machines can't operate. They're also able to work indoors. For highway road repair, these machines are small enough to work on one side of the road, leaving one lane open for traffic. Transportation from one job site to another is handled easily with tandem-wheel trailers that take only minutes to load and unload.

### Veterans Can File New Disability Claims

Recent discovery of duplicate military medical records by the National Archives will enable thousands of World War II and Korean Conflict Army and Army Air Corps veterans to file for Veterans Administration disability compensation payments.

To speed these claims, the VA has introduced special procedures, collectively called Project Expedite, which involves a massive cross-checking of files to determine cases that can be reopened.

Using the new records, VA benefits counselors now hope to assist many veterans whose claims had been denied because no record was available to confirm medical disabilities that occurred during military service.

Veterans and survivors unsure whether their disability compensation claims are affected should contact the nearest VA Regional Office is listed in the Federal Government section of telephone directories.

The National Archives and Records Administration on June 15 advised the VA that it had located a collection of computer tape containing some 10 million Army medical records that partially fill a gap created when a 1973 fire destroyed millions of military files at a federal warehouse in St. Louis. The newly found records cover the years from 1942 to 1945 and from 1950 to 1954.

For certain veterans whose claims for disability compensation were denied since the fire, the VA may now be able to establish documentary evidence to support their claims.

The St. Louis fire destroyed or seriously damaged some 18 million service records, making future disability claims difficult and, in some cases, impossible to process. The newly found medical records were provided to the National Archives by the National Research Council, a private organization that had been engaged in analysis of Army hospital records in the 1950s. The computerized

information reflects battle injuries treated in Army hospitals and a sample of hospitalizations for other reasons. The records cover personnel who served in the Army and Army Air Corps.

### Record Registration Expected at UWWC

Fall semester registration is proceeding at a record-setting pace at the University of Wisconsin — Washington County Center.

By Aug. 5, at the end of a three-day registration period, 685 students were registered for fall, up 25 from the same date last year. A final fall registration day is Aug. 31, from 10 a.m. to 7 p.m.

Fall classes begin on Sept. 6. UWWC has set enrollment records each of the last two falls — 784 last year and 777 in 1986. Mike Murphy, director of student services, said that the current pace of registrations and applications point to the school's first 800-plus semester in history.

According to figures released by Murphy, 363 of those currently enrolled for fall will be attending UWWC for the first time, including 282 new freshmen; 322 registrants are returning sophomores and freshman.

Last fall 291 new freshman entered UWWC, down from the record 344 in 1986. Freshman applications have been running about 60 percent above 1987 rates for most of this year.

Murphy said applications are still coming in. He said that many students who have applied for admission as freshmen are in the process of completing their registration. A number of applicants are expected on campus for freshmen placement testing in mathematics and English, at 9 a.m. and 5 p.m., Aug. 29, and for program planning sessions at 5 p.m., Aug. 30.

## Valley Bancorporation Reports Earnings Growth

Valley Bancorporation reported net income for the quarter ended June 30, 1988 of \$5.975 million compared with \$5.511 million in 1987, an 8.4% increase. Applicable 1988 earnings per share amounted to \$.55, up from the \$.51 reported in the second quarter of 1987. Year to date earnings for 1988 totaled \$11.550 million, a 6.3% increase over the \$10.869 million recorded in the first six months of 1987. 1988 earnings per share amounted to \$1.06 compared with \$1.00, in 1987. Weighted average shares outstanding totaled 10,933,326 in 1988 and 10,886,923 in 1987.

At June 30, 1988, Valley reported total assets of \$2.619 billion, an increase of 3.3% over the \$2.536 billion recorded June 30, 1987.

Shareholders' equity totaled \$194.8 million, an increase of \$13.4 million over the \$181.4 million on June 30, 1987. At June 30, 1988, book value per share was \$17.78 compared with \$16.65 per share at June 30, 1987.

In July, Valley applied for regulatory approval to acquire Colonial Bancorporation, Inc. Colonial, headquartered in Thiensville, Wisconsin, had assets of approximately \$150 million at June 30, 1988. Colonial owns three banks that serve the rapidly growing suburban Milwaukee markets of Thiensville, Port Washington and Richfield with additional offices in Wauwatosa at Capital Drive and 124th Street, and in Saukville and Jackson. After the transaction is consummated in October, Valley's total number of banking offices will increase from 88 to 95. This transaction is also subject to Colonial shareholders approval.

At their recent board meeting, the Valley Board of Directors declared a per share dividend of \$.22 (\$.88 annualized). This dividend is payable September 2, 1988 to shareholders of record August 26, 1988.

## Marriage, Divorce, May Stop Most Benefits

Divorce or marriage will affect most Social Security benefits to dependents or survivors of retired, disabled, or deceased workers. For example, if a child under age 18, or 19 if a student, marries, his or her child's benefits will stop. An adult disabled child's benefits will end upon marriage unless he or she marries someone who is receiving some type of disability benefits or retirement benefits. Checks for a widowed mother or father getting benefits because she or he is caring for an entitled child will end if the parent remarries unless the new spouse is receiving benefits as a retired or

disabled worker.

On the other hand, remarriage of disabled widows and widowers age 50 to 59 and widows and widowers 60 and older does not affect the amount of or entitlement to their benefits. Also, a retired or disabled worker's benefits are not affected if he or she marries or divorces. But, checks to a spouse getting benefits on the record of a retired or disabled worker will end if the marriage ends in divorce unless the spouse is 62 or older and the marriage lasted 10 years or more.

## Quality Day Care Makes a Difference

High quality day care does more than keep children safe and healthy. It can affect their intelligence and social skills. Surprisingly, researchers have just completed research to support this belief according to Dave Riley, extension child development specialist at the UW-Madison.

An important study was conducted by American researchers with support from the government of Bermuda. Bermuda is a good place to study day care: 84 percent of Bermudan two-year olds spend most of the work week in day care. The kind of day care centers studied reflect the real child care choices available to most families, both in Bermuda and the U.S.

The children were three years of age at the time of the study, and their average age of entry into day care was 19 months. The researchers observed and measured the quality of each day care setting, and the level of social, intellectual and language development of 166 children.

They found that the quality of day care does matter. According to Riley, "The children in the high quality centers scored higher in language and intellectual development. These children were more task-oriented: they were more likely to stick to a task until it was finished. Their day care teachers also rated them as more considerate of others and more sociable."

Other studies have similar findings. Children develop best in day care programs with fewer children

per adult, smaller group sizes, more teacher training, less staff turnover, and active involvement of parents in the program. In settings such as these, children are likely to be more cooperative, less impulsive, more persistent on assigned tasks, and they scored better on reading readiness tests.

These benefits appear to last. Another study observed four-year olds in day care, and then observed them again when they were eight-year olds. Compared to those in low quality care, the eight-year olds who had experienced high quality day care were: more socially competent with peers, more compliant with adults, and less easily frustrated.

"These findings demonstrate the wisdom of day care regulations here in Wisconsin," says Riley. "There is a good reason for the state to enforce a limit on the number of children per provider. It makes high quality adult-child interaction more likely. The course work required for licensing, and the continuing education requirement, can also be seen as part of the state's commitment not just to children's safety and health, but also to children's intellectual and social development."

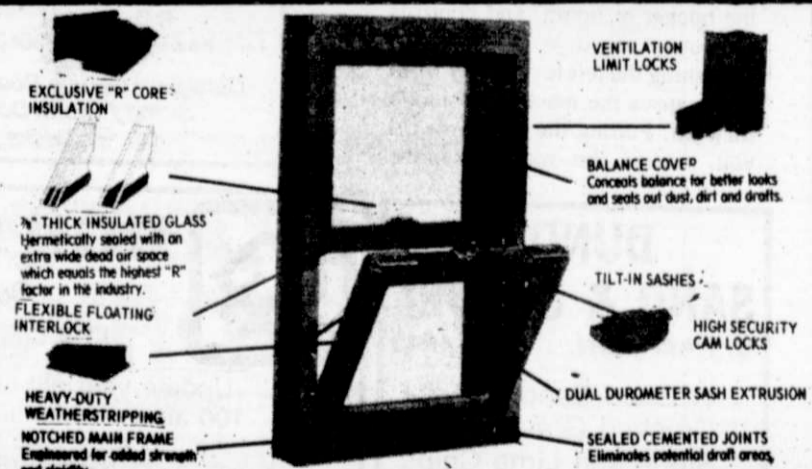

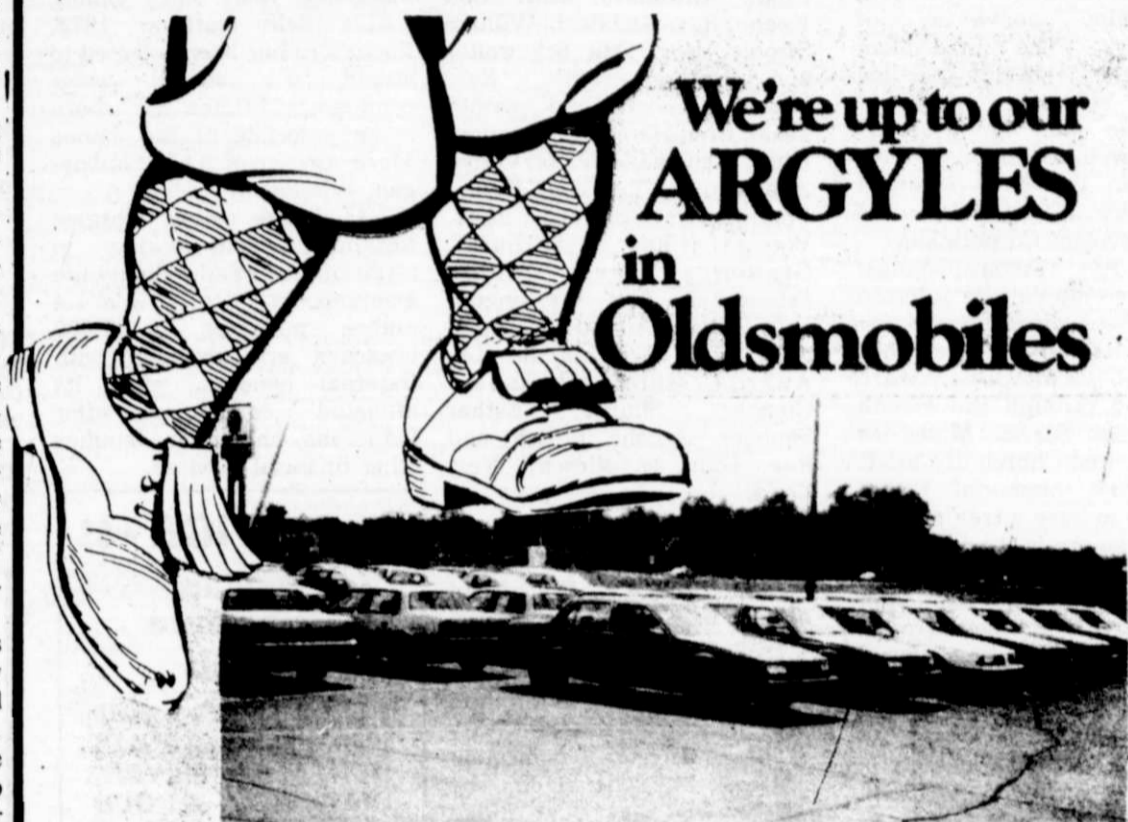

### VOTING BY ABSENTEE BALLOT

Any qualified elector, unable to get to the polling place on election day for any reason, may ask to vote by absentee ballot. A qualified elector is a person who is a U.S. citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where the person wishes to vote at least 10 days before the election. If the voter resides in a municipality which requires voter registration, then registration is also required for the voter to receive an absentee ballot.

To obtain an absentee ballot, the voter should contact the clerk of the city, village or town in which the voter resides. A written request must be made by the voter for the absentee ballot. If the voter contacts the clerk by telephone the clerk will send the application form to the voter. If the voter requests an absentee ballot by mail, a written request, signed by the voter which indicates that the voter resides within the municipality, will be honored. Written requests may be made beginning six months before the primary election. The deadline for receipt of the written request by mail is 5:00 p.m. on the Friday before the election. If the voter goes to the clerk's office to complete a written request, the request must be made no later than 5:00 p.m. on the day before the election.

If the absentee voter resides in a nursing home, the absentee ballot will be delivered to the nursing home by two special voting deputies appointed by the municipal clerk. The special voting deputies will present the absentee ballot to the voter and provide assistance in marking or punching the ballot if necessary. At the request of an absentee voter a relative may provide the assistance. After voting at the nursing home is completed, the special voting deputies will return the absentee ballot to the municipal clerk.

With one exception, the voter who wants to cast an absentee ballot, must make a separate written request before each election. If a voter is indefinitely confined to his or her home or a care facility because of illness, age, or disability, the voter need not make a request before each election. There is a special statement on the application form which is provided by the municipal clerk which can be completed asking that an absentee ballot be automatically mailed to the voter before each election if he or she is indefinitely confined. If the indefinitely confined voter fails to vote and return the ballot sent to the voter, a separate written request for the next election must be made before the voter can obtain a ballot.

The municipal clerk will send the absentee ballot to the voter once the request is received and the ballots are prepared. Absentee ballots are available thirty (30) days before the fall elections and three weeks before a special or the spring elections. The municipal clerk keeps a public record of all individuals requesting an absentee ballot indicating when the ballot is requested, sent, and returned to the municipal clerk.

An absentee ballot can be voted at home any time after it is received in the mail. An absentee ballot can also be voted in the clerk's office if the voter appears in person and fills out the written request. The voter should make sure that the certificate-affidavit is properly completed and witnessed by two persons. The voter and the witnesses must sign the certificate on the absentee ballot carrier envelope. If the absentee elector receives assistance in marking the ballot, the person providing the assistance must sign the statement on the back of the ballot which provides that the person giving assistance marked the ballot as directed by the absentee voter. The municipal clerk will make sure that the certificate-affidavit is properly completed by the voter when the absentee ballot is voted in the clerk's office.

The completed absentee ballot must be in the possession of the issuing municipal clerk in time for the clerk to deliver the ballot before the polls close on election day. Voted absentee ballots may be delivered in person to the municipal clerk. Any absentee ballot received after the polls close or any absentee ballot where the certificate-affidavit is not properly completed cannot be counted.

## 1988 Hunting and Trapping Licenses Available

MADISON, WI — The 1988 hunting and trapping licenses are now available, according to Department of Natural Resources licensing section chief Doug Poole.

Licenses can be purchased at most DNR offices, from county clerks, or by mailing a DNR license application and fees to: Wisconsin DNR, Box 7924, Madison, Wisconsin 53707.

Hunters currently possessing a sports license or a conservation patron license are reminded that these licenses expire on August 31.

The sports license includes fishing, gun and bow small game hunting and gun deer hunting.

The conservation patron license includes small game hunting, bear license privileges, gun and bow deer hunting, fishing, sturgeon spearing, trapping, a one-year subscription to the Wisconsin Natural Resources magazine and admission to state parks, forests and recreational areas. Additional federal waterfowl and turkey stamps are required. However, state fishing and waterfowl stamps are not required.

Other Wisconsin resident licenses include:

The senior citizen recreation card, which permits lifetime small game hunting and fishing rights, and state park and forest admission to residents 65 years old or older.

The deer license, which

allows gun deer hunting statewide.

The small game license covers gun and bow hunting of small game and other unprotected species. This license is required to hunt waterfowl. However, federal and state waterfowl stamps are also required to hunt ducks and geese.

The archer license covers bow hunting of small game, deer and other unprotected species during the specified seasons.

Anyone 12 years of age or older who hunts during any of the 1988 seasons must have a valid Wisconsin hunting license. Children between the ages of 12 and 14 must also be accompanied by a parent or guardian. In addition, anyone born on or after January 1, 1973 must have completed a hunter safety course.

Deadlines for special permits are: August 31 for Apostle Island deer; September 9 for Canada geese; September 30 for a hunter's choice permit, Sandhill Wildlife Area deer, and bobcat, fisher and otter hunting and trapping; November 4 for the 1989 spring turkey season; and January 13 for the 1989 fall bear season.

For more information refer to the 1988 Wisconsin Hunting and Trapping Regulations, the 1988 Wisconsin Migratory Bird Regulations (available in late September), or contact your local DNR office.

## Bear Harvest Permits Increased for 1988 Season

MADISON, WI — A total of 2,070 bear harvest permit winners were picked from a total of 10,586 applications for the 1988 season, Department of Natural Resources license figures show.

"Based on the last two seasons' harvest success figures, we could see a harvest of about 1,000 bears this fall," Frank Haberland, Department big game specialist said.

A total of 1,580 permits were selected from Zone A. Zone A counties are in northwestern Wisconsin west of Highway 51 and the Wisconsin River in Marathon County and north of Highways 64, 27 and 8. There were 7,623 total applicants for the Zone A permits.

In this third year of the new permit and continuous preference system, of the total unsuccessful applicants in Zone

A there are 857 individuals that have three years of continuous preference after three straight years of application, 2,310 with two years of preference after two straight years of application and 2,876 first-year applicants.

"If the hunters in Zone A apply again for the 1989 season and the number of harvest permits available remains the same as this season, all of the applicants who next year will have applied for four straight years for Zone A should be eligible for a harvest permit," Doug Poole, chief of the licensing section, said. "Even some of those 2,310 two-year preference holders, who next season will have three years of preference, will also be offered a harvest permit."

Chances are not nearly as good for Zone B applicants. There were 2,653 total

applicants in 1988 for 300 harvest permits. Zone B counties are in northeast Wisconsin, east of Highway 51 and the Wisconsin River in Marathon County and north of highways 64, 45, 47, the northern Menominee County line, AA, 32, 64, 141 and 180.

There are 617 three-year continuous preference holders who didn't receive harvest permits this season. If harvest permit numbers remain the same in 1989, there still will be 317 individuals not getting harvest permits.

"In fact, there will be hunters in Zone B who will not get a harvest permit until the fifth straight season of application and a possibility of 17 who won't get a permit until the sixth straight year of application," Poole stated.

Zone C is made up of all the counties not included in Zones A or B and 190 harvest permits were allowed this season. There were 310 applicants for those 190 permits. Because of the low demand in Zone C, 21 of the permits went to first-time applicants and 10 went to individuals that had harvest permits in 1987.

The bear hunting season was restored in 1986 following a one-year closure. DNR issued 860 harvest permits randomly selected from 8,300 applicants. The harvest was 503 bears.

Research data indicated the 1987 fall bear population was close to the 5,500 population goal set by department wildlife managers. In 1987 a bear harvest quota of 1,000 was set and 1,730 harvest permits were issued; 824 bears were harvested.

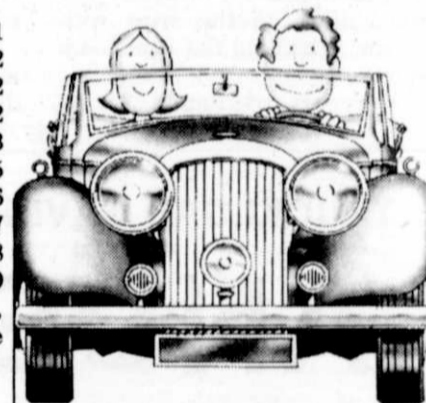

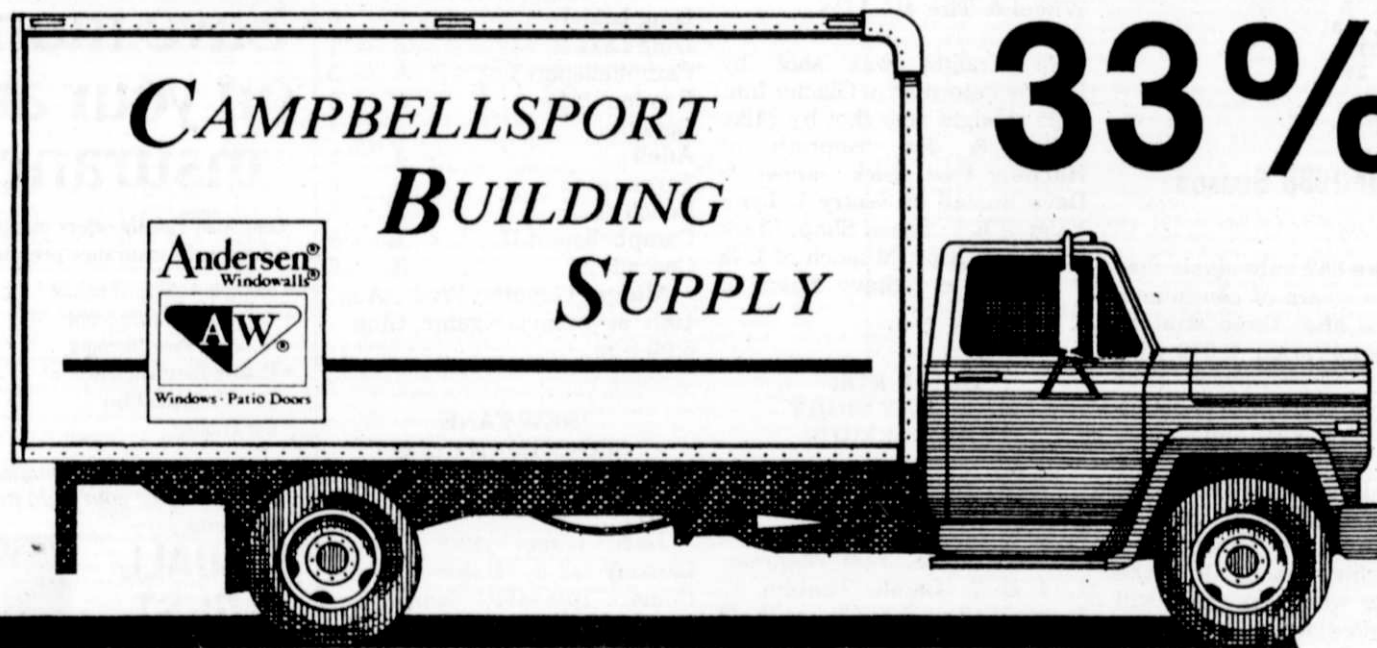
