### Kohl Defeats Engeleiter

## Bush Wins Big, But Not In Wisconsin

Until the last week both presidential candidates knew it was still a toss-up as to which way Wisconsin would go in the election. The national polls showed the percentages between Republican George Bush and Democrat Michael Dukakis so close that both men made last ditch efforts last Tuesday to win over Wisconsin

As the old saying goes, Dukakis "won the battle but lost the war." Unofficial tallies show he won the Wisconsin vote by a 52% to 48% margin. Bush, however, won the war by claiming victory in 40 states to give him 426 electoral votes and

a landslide victory to the presidency.

True to past performances, however, Washington County went Republican, giving its votes to Bush 24,328 to 15,907 for Dukakis.

In the statewide race for the Senate. Democratic challenger Herb Kohl defeated veteran Republican campaigner Susan Engeleiter by a 52% to 48% margin to win the seat being vacated by retiring William Proxmire.

Incumbent 9th District U.S. Representative J. James Sensenbrenner warded off the challenge of Democrat Thomas Hickey 75% to 25%.

Incumbent Republican State Senator Carol Buettner of the 18th District defeated her Democratic opponent Mary Gropp by a 69% to 31% margin. Incumbent Republican State Senator Donald Stitt of the 20th District claimed victory over his Democratic rival Rita Liesiefsky 63% to 37%.

For the 59th State Assembly District. Republican challenger Michael Lehman defeated Democratic challenger Todd Bodden 59% to 41%, for the seat being vacated by Dwight York who did not seek reelection. Republican Richard Ruth, who was defeated by Lehman in the September primary, mounted an unsuccessful write-in campaign to win York's post.

## 1989 Village Budget Increase Less Than 3%

The Village of Kewaskum's proposed 1989 general budget was presented to the trustees at Monday night's Village Board meeting. It carries an increase of less than 3% over the 1988 budget.

Village Administrator Dan told the board Schmidt members that the final budget proposal, however, did not come easy. "There were a lot of departmental budget revisions, noted Schmidt, "some of them were reworked four or five times before their final drafts were prepared." He thanked bookkeeper Janet Knop and all the department heads for their hard work and efforts to keep budget increases as low as possible.

The 1989 budget of \$1,073,-637, represents an overall 2.6% or \$26,832 increase over the 1988 budget of \$1,046,805. It will result in a 1989 village tax levy of \$421,161, up 2% or \$8,209 over 1988's levy of \$412,952.

Schmidt noted, however, that

because of a slight drop in the village's assessed valuation, the tax rate will increase 3.1% or 22c per \$1,000 of assessed valuation. That figure will go from this year's \$7.083, to \$7.305 for 1989. "On a \$50,000 home," said Schmidt, "that would represent an increase of \$11.10, on a \$60,000 home \$13.32, and on a \$70,000 home \$15.54." He reminded the trustees that this rate represents "only the village's portion" of the total tax bill.

A public hearing on the proposed budget has been scheduled for Monday, November 28th.

Schmidt also went through several departmental budgets, advising the trustees of significant changes, either up or down, and explaining the reasons for the variations.

The Administration budget had minor changes increasing 2.6% or \$1,896, from \$71,877 for 1988 to \$73,773 for 1989. The Library's budget increased from \$29,119 to \$37,920. Schmidt noted that while this

appears to be a large increase, it actually is not. While expenditures have been increased, revenues for the library will also be up by approximately \$15,000. The end result, noted Schmidt, is a 'wash' with little or no actual change from the 1988 budget.

The Municipal Building budget is going up 4.2% or \$761, from \$18,294 in 1988, to \$21,455 for 1989. Parks and Recreation is up 3.1% or \$1,920, from \$62,748 to \$64,668 for 1989. The Public Works Department budget is up 2.2% or \$6,442 to \$304,695 for 1989.

In other business the board approved the awarding of a contract in the amount of \$22,221, for the remodeling of the Fire Department's Telesquirt truck cab from three to six passengers. The renovation is necessary because of recent changes in state and insurance requirements which prohibit firefighters from riding on the rear portions of fire trucks.

The trustees also approved the purchase of a computer and printer for the library at a cost of \$3,275. Head Librarian Kitty Hlavaty advised the board the equipment was needed to replace a computer which Kewaskum had been using on loan for the past year from the County Library System.

While none of the trustees had any objections or reservations about the need for the computer, Mary Krueger and Ken Bonlender objected to being, in a sense, dictated to by the county system on how the village's library should operate. 'It seems more and more the county is telling you how to run your library," said Krueger, turning into bureaucracy." She told her fellow board members that the system was getting away from the original idea of what it was meant to be."We're losing our anonymity and our right to run our library as we see fit," she noted. "I think we're losing sight of what this library system was supposed to do and that is get books to people who did not have library service.'

Bonlender was in general agreement with Krueger's comments. He told the board the village's contract comes up for renewal next year. Bonlender suggested the village take a long hard look at the program and where it's going before committing itself to another contract agreement.

In other action the board opened five bids submitted for a replacement squad for the Police Department. Ewald

Chevrolet of Oconomowoc submitted the apparent low bid of \$13,345 for a 1989 Chevy Caprice, Schwartzburg Chevrolet of West Bend, \$13,826, Meyer Ford Campbellsport, \$14,090 for an '89 Ford Crown Victoria, and Royal Ford of West Bend \$14,215.83 for a Ford CV. Russ Darrow Chrysler/Plymouth declined to bid due to a model change. The bids were turned over to Chief Richard Knoebel for review and a recommendation.

The board also approved the hiring of three part time officers for the department. candidates approved Robert Konztanz, Alan Ratzel and John Schmitt. Knoebel noted the hiring of three individuals would provide more flexibility and a cushion in scheduling in the event one or more part time officers were to

The board also accepted the offer of James Wessing to purchase the remaining 7-acre parcel of land, formerly known as the Ideal Subdivision, on the northwest side of the village. The village had put the land up for sale after retaining a portion of the property for the installation of a lift station and sewer and water mains to service that section of the village. The sale price was \$42,400.

The board also voted to terminate its agreement with Mr. Al Voigt for the pick up of recyclable materials from the recycling center. The village will use the services of Zahn's Disposal which has now begun collecting recyclable materials.

The trustees, on the recommendation of Chief Knoebel, approved the installation of two additional street lights on LinDe Lane. A building permit request for Michael Geidel to construct a home at 1136 Roseland Drive was also approved.

The board then adjourned to closed session.

## Sheriff's Dept. Lists Passing As Cause Of Fatal Crash

An investigation by the Washington County Sheriff's Department has revealed that a fatal accident which claimed two lives last Tuesday was caused by one of the drivers passing in a posted 'no-passing' zone.

Fatally injured in that crash were Brian S. Gundrum, 19, of rural Campbellsport, and Annette M. Maechtle, 42, of 1022 Highway A, West Bend. Both victims were alone in their cars.

According to the report, witnesses stated Gundrum, who was westbound, was seen passing cars at an excessive rate of speed on a hilly section of Highway A, which is posted and highway-lined as a 'nopassing' zone. The Gundrum car collided with the eastbound Maechtle vehicle killing both

## A Major (Messy) Project




For youngsters, being in the mud would be fun, but for employees of Zunker Construction of Fond du Lac, it's all in a day's work.

### An American Education Week Message From Superintendent Herbert J. Grover

This year American Education Week calls on all of us to invest in our schools as Wisconsin joins the nation in a week-long focus on the importance of education. The theme for the Nov. 13 to 19 observance is "America's Schools: Invest in Your Future.

The Department of Public Instruction recently took stock of one portion of its investment in elementary and secondary education by analyzing educational reform Wisconsin during the five years since the "Nation AT Risk" report criticized the "rising tide of mediocrity" in our nation's schools. "Educational Reform in Wisconsin' looks at the wide range of state-level activities undertaken between 1983 and 1988 that helped local districts tailor reform activities to their communities' needs.

A sampling of Wisconsin's educational reforms described in the 16-page booklet includes the 20 educational standards, which set minimum expectations for each school district's educational program. Students face tougher graduation requirements due to the reform movement and receive assistance in meeting the rigors of education through a number of programs. The Wisconsin Developmental Guidance Model is among these. The nationally recognized model guides teachers and counselors in working to help students develop a strong self-concept, a pattern of academic success. and a desire to make plans for the future.

Reform over the past five years also took aim at teachers and administrators. Tougher requirements for teacher training and additional opportunities for developing administrative skills are among activities Wisconsin pursued.

The list of reform activities

extends much further. But as we look back at what we've accomplished to ensure that all children have equal access to a quality educational experience, we also must push ahead. Wisconsin has been a leader in education because it has never been content with mediocrity.

The framework for Wisconsin's continued progress in education is contained in the DPI's 1989-91 budget request. Among the items in that budget is a call for increased state support of our educational investment to 50 percent of school costs with an ultimate goal of two-thirds state support. The budget promotes state assistance with the problem of repairing or replacing unsafe schools. It also proposes incentive grants for local districts to implement school improvement activities in the areas of gifted and talented education, early education-day care, family involvement, distance learning, and teacher development

While financial investment is a necessity to education, money alone will not educate children. Education has its foundation in the homes and communities where our children live; it thrives in the hands of dedicated teachers and blossoms in the minds of students who understand that education is their key to the

Yes, we invest in the future when we invest in our schools. I encourage you to invest in tomorrow's parents, teachers, politicians, and doctors by visiting your local schools during American Education Week, by participating in the governance of schools, and by volunteering your time and talents throughout the year. Education flourishes when we are a part of it. We invest in all of our futures when we invest in our schools.

How well a child does in school depends in a large part on the child's study habits. There is no substitute for hitting the books, and no short-cuts to getting an education.

Yet many students do not believe that the hours spent studying or amount of work they do will make the difference between success and failure. It's far easier to blame failure on unfair teachers, or distracting classmates, or bad luck or twenty other reasons, rather than admit they just didn't do

the work.

Many young people claim there are not enough hours in the day to do all the things they want to do - and study too. There may be some truth in that, but most often there is not a shortage of time, but a lack of planning. To encourage better use of time, have your school agers draw up a weekly schedule. 
