WHITE COOKIES

1 c. powdered sugar
1 c. white sugar
½ c. shortening
½ c. butterup
1 c. salad oil
½ tsp. salt
2 eggs
2 tsp. vanilla
¼ tsp. almond flavoring
4 ¾ c. flour
1 tsp. soda
1 tsp. cream of tartar

Cream sugars, shortening and butterup. Add eggs. Mix well. Add salt, cream of tartar, soda, vanilla and flavoring. Mix well. Alternate adding oil and flour. Dough should be soft. Shape into balls. Roll in sugar. Press down with glass. Bake at 375° for eight minutes.

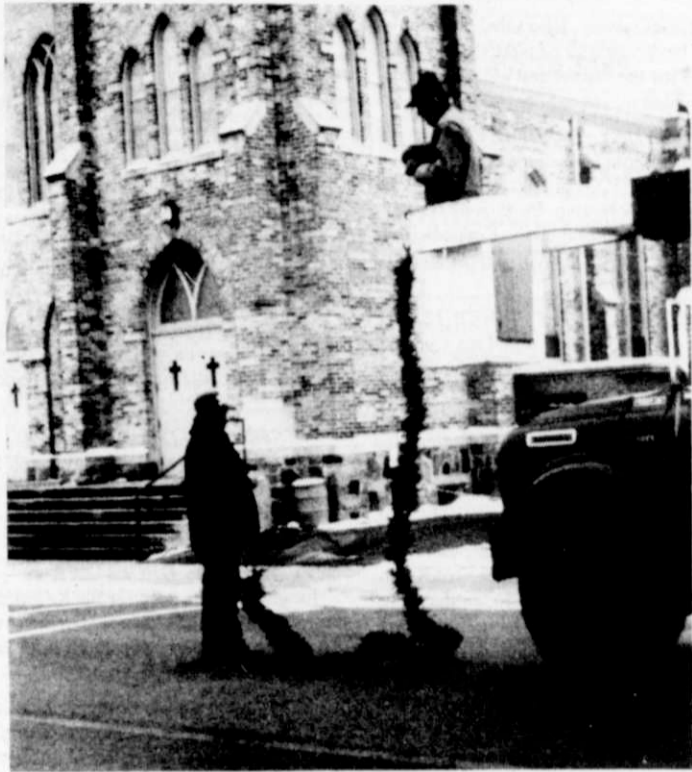

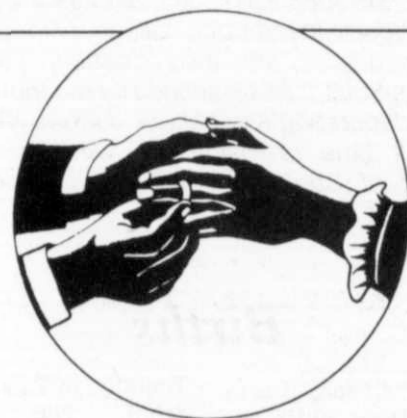

Following the program and the lighting of the tree by Village President, Paul Blumer, and audience will join the choirs in a Christmas sing-along around the lighted tree.

UW Interim Short Course Enrollment Deadline Dec. 15

The enrollment deadline for one-week agricultural interim short courses offered by the University of Wisconsin - Madison is Dec. 15.

These Farm and Industry short courses, to be offered Jan. 9-13, are open to anyone interested in the three course topics, according to Richard Daluge, assistant dean and director of the short courses. The enrollment fee for each course is \$50.

This year's interim short courses include:

Apple Production and Orchard Management: Designed to meet the needs of commercial apple growers and their employees, this course will cover plant growth, anatomy, fruit set, growth regulators and chemical thinning, weed, insect and disease control, spray application, pruning, mineral nutrition, and record keeping.

Dairy Herd Management Update: This course will present the latest recommendations and research results in dairy-cattle nutrition, mastitis control, breeding, reproduction, milking and record keeping.

Turf Management: This course will deal with management of cool-season turfgrasses found in the upper Midwest. It will emphasize establishing the right grass for a particular environment or use. Mowing, fertilization and irrigation are covered, stressing correct timing to benefit grasses

and discourage pests. Pest identification, prevention and control, with an emphasis on integrated pest management, are discussed as well as pesticide applicator safety.

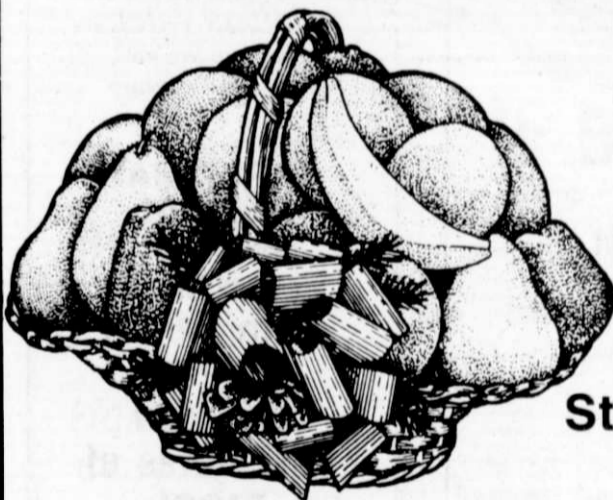

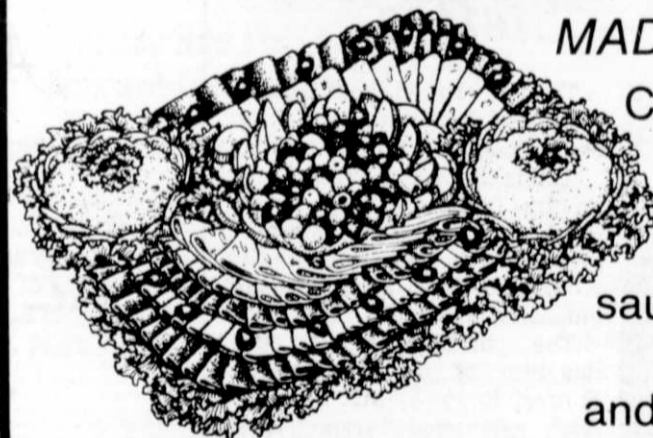

Since accidents are not an every day occurrence, many people become confused when involved in a collision.

According to John Patton, Casualty Claims Director for American Family Insurance, "First seek help for anyone injured and phone police or state patrol, then write down everything that happened. That way you can keep it fresh in your mind."

If the following list is too long to remember, request a free pocket-sized automobile accident checklist by writing to the Corporate Communications Department, American Family Insurance, Box 7430, Madison, WI 53783.

WHAT TO DO AFTER AN ACCIDENT:

- Stop immediately and stay calm.
- Help the injured but don't move them unless it's necessary.
- Call the police or state patrol.
- Don't stand in the roadway or between the vehicles, they may be struck again.

WRITE DOWN THIS INFORMATION:

- Date, time, place and a brief account of the accident.
- Names, addresses and telephone numbers of all drivers involved, their insurance companies and agents; all passengers and where they were seated, any witnesses.
- Make, model, year and license numbers of all cars involved in the accident.
- Your speed and the approximate speed of the other car when the accident occurred.
- Weather and road conditions.
- Evidence of injury to anyone involved in the accident.
- Location of the cars (across the lane, on the divider, on the shoulder of the road, etc.)

REMEMBER:

- Do not indicate how much coverage you have.
- Don't admit negligence and don't sign anything.
- Call your insurance agent and report the accident, even if the damages are minor and you intend to pay for the repairs yourself. Your insurance company may require reporting all accidents within a certain period of time.
- After leaving the scene of the accident, refer any inquiries from others involved in the accident to your insurance agent.

American Cancer Society Offers Many Services to Area Residents

The Washington County American Cancer Society does much more than raise money for cancer research. It offers support and guidance to cancer patients and their families, and provides them with valuable services. The ACS is also a source of cancer information and education materials. These services and materials are available to all Washington County residents.

"I Can Cope" is an educational program for people recently diagnosed with cancer. Through this program, patients and their families learn about cancer and how to live with it.

"Road to Recovery" is a program staffed with volunteers who transport cancer patients to medical treatment centers in the area. This program is designed for patients who do not have relatives or friends to take them.

"Living with Cancer" is a support group for cancer patients at any stage of the disease. Patients meet each month to give and receive support. Their spouses or other support persons are also encouraged to attend.

"The Ostomy Program" is for patients who have had a colostomy or ileostomy. These patients have special needs and require special supplies. Volunteers who are trained to address those needs visit patients regularly. Some supplies are also available to these patients.

"Reach to Recovery" is a program for women who have recently had mastectomies. This program helps women come to terms with the disease and the surgery. Women who have already had mastectomies offer support and guidance to those still recovering from the surgery by visiting them regularly while they are in the hospital.

"Cansurmount" is a visitation program for patients with all types of cancer. Like the "Reach to Recovery" program, the visitors are also cancer patients who offer support to those still in the hospital. The program tries to match visitors with patients who have the same type of cancer.

The American Cancer Society provides cancer patients with supplies like unsterile dressings, wigs and other loan closet items for patients who are confined to their homes. There is no charge for these services.

Moraine Park Offers GED

According to census figures, approximately one-third of the adults 25 years of age or older who live in the Moraine Park Technical College District do not have a high school diploma.

During 1987, 555 persons did something about that statistic by taking one or more of the GED tests at the three test sites operated by Moraine Park. Applicants can test on the Fond du Lac and West Bend campuses and at the Berlin instructional center. Tests are also available at Beaver Dam High School. Three hundred sixty-five persons completed all five of the tests with passing scores and received their high school equivalency diplomas.

Applicants in 1987 ranged in age from 17 to 60-plus. New regulations, however, require persons to be 18 years 6 months of age. Persons whose high school class has graduated are also eligible.

Many of these area adults obtained their equivalency diplomas because they wanted to qualify for new work for further education. Others completed the program because they wanted to set a good example for a younger relative, and some did so simply to satisfy a personal goal.

Nationally, the GED testing program has enabled over six and a half million adults to obtain formal recognition of their educational development through their attainment of a high school equivalency diploma. Annually, one of every seven high school diplomas in the United States is based on results from the GED tests. These credentials are accepted by more than 90 percent of U.S. colleges and universities and by

most employers to satisfy requirements for a secondary education diploma.

At Moraine Park, adults can earn an equivalency diploma in several ways. The most popular option is based on the GED tests. These are a series of five tests in the areas of writing skills, social studies, science, literature and the arts and mathematics. A student who receives a poor score on one part can make up for it by doing well on others.

The college provides an orientation to the options available as well as to the necessary procedures for writing the tests. Adults can attend special classes to help prepare for the examinations. There is no charge for any of these services.

Fewer and fewer jobs are available to the uneducated. In addition, a government study has shown that high school equivalency diploma holders earn about \$800 more each year, \$34,000 in a lifetime, than do non-diploma employees.

State High Schools Receive Grants

Two Lutheran high schools in Wisconsin have been awarded special AAL grants totaling \$9,650 to develop alcohol and drug awareness programs for local Lutheran schools. Kettle Moraine Lutheran High School, Jackson, and Shoreland Lutheran High School, Somers, are two of only 14 Lutheran high schools across the United States chosen to receive grants totaling \$74,490.

Kettle Moraine Lutheran High School will use a \$5,000 grant to teach students about the hazards of alcohol and drug misuse. These students will then form Help and Information for Teens (HIT) teams, and will speak to area elementary school children.

According to the Rev. Don Thompson, a counselor and HIT team advisor, "There is a lack of knowledge, both on the student and parent level, about the hazards of drug and alcohol use and misuse. Through parent education programs and the HIT teams, we hope to bring about an awareness that will last a lifetime."

Shoreland Lutheran High School will use a \$4,650 grant to develop a four-stage program that will be initiated in the high school through the development of a HELP team. Phase I will include development of the HELP team and presentations at the high school level. Phase II will send trained student speakers to area elementary schools to talk with students about substance use and abuse. Adult groups will be the focus of Phase III, and Phase IV will be a coordinated effort to reach other church and school leaders in the area.

Pari-Mutuel Track Proposed for Jackson

The Anvan Development Corporation has announced that the company is representing the Jackson Racing Group, Inc., an investment group interested in locating a pari-mutuel track at Jackson with a resort hotel complex and commercial facilities.

The Anvan Development Corporation, on behalf of the Jackson Racing Group, Inc., filed a request with the Village of Jackson asking the Village of Jackson to approve a resolution supporting such a facility in the Village of Jackson. The property is situated in the southwest quadrant and adjacent to the intersection of U.S. 45 and Wisconsin Route 60. It is located approximately 16 miles from Milwaukee County, 10 miles from Waukesha County and 12 miles west of Interstate 43.

With the approval and passing of such a resolution, the Jackson Racing Group, Inc. will then apply to the State of Wisconsin Racing Board for a license to operate a year round pari-mutuel racing facility for thoroughbred, harness, quarter horse and greyhound racing events.

Greyhound racing would be from February 15 - November 30, with horse racing (thoroughbred, harness and quarter-horse) from April 1 - November 30.

The main building would be of traditional design on two levels in a totally enclosed building which would be heated and air conditioned.

A 3/4 mile horse track with a slightly elevated greyhound track would be located inside the horse track.

The site size is approximately 85 acres with additional acreage to be acquired (the Dubuque Greyhound Track was built on 46 acres).

Seating capacity for the facility would be approximately 5,600 (75% table seating and 25% theatre seating), with parking for 4,000 cars.

The estimated cost would be \$35,000,000 (the Dubuque track cost \$10,500,000 four years ago).

Preliminary studies indicate that any environmental concerns, initiating from Cedar Creek, can be managed.

Water and sewer service will be furnished by the Village of Jackson. Storm water management will be controlled on the site. Preliminary engineering investigations have been made for all of the above, and utility services are all obtainable.

Preliminary traffic studies indicate that most traffic to the track will enter and exit from Highway 45 with some traffic from Highway 41 and Interstate 43 utilizing Highway 60. Final traffic studies are forthcoming.

Economic benefits are as follows:

- 1) 600-750 new jobs at the racetrack alone.
- 2) \$788,000 estimated for the first year in admissions tax from the track, one-half to Washington County, and one-half to the Village of Jackson, increasing 5% per year thereafter.
- 3) Additional property tax benefits to the local taxing governmental units (county, school districts, etc.).
- 4) Annual economic impact to Washington County is expected

to be \$96,000,000 during the first year of track operations, increasing to \$133,000,000 during the fifth year.

5) Hotel room tax revenues to the Village of Jackson would be approximately \$50,000 the first year with increase of approximately 25% the second year the track is open.

6) It is estimated that the development of this facility will provide construction employment of over 300 jobs during the period that it will be built.

The ANVAN Development Corporation is affiliated with the ANVAN companies whose affiliates operate The Abbey on Lake Geneva, Lake Lawn Lodge and Interlaken Resort and Country Spa, all in Walworth County.

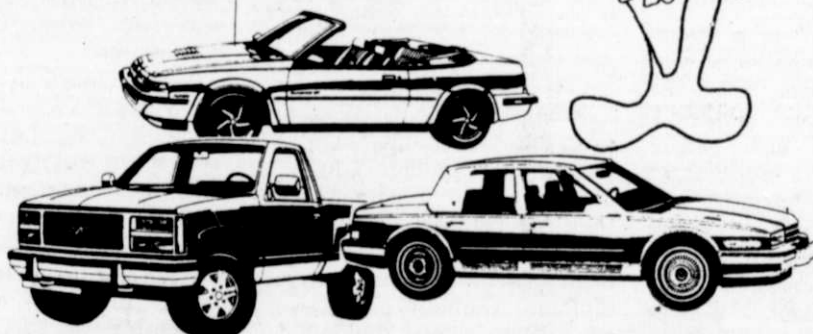

Study Finds Wisconsin Deaths and Injuries Down After Seat Belt Law

Since Wisconsin's seat belt law went into effect last Dec. 1, more people have been in crashes in vehicles covered by the law but fewer have been killed or injured, according to the state Department of Transportation.

The number of people involved in accidents in vehicles covered by the law increased by 5.6% in 1988 over the same eight months of 1987, but the death rate was down 7% and severe injury rate down 14%.

David Cipra, DOT traffic accident analyst, said there were 173,420 occupants of cars and light trucks in accidents during the first eight months of 1988 compared to 164,175 in the same period of 1987.

Despite the fact that there were 9,200 more people involved in accidents in 1988, there were 7 fewer deaths, 403 fewer severe injuries and 949 fewer moderate injuries in vehicles affected by the safety belt use law.

When translated into a rate per 1,000 occupants, there was a 7.3% drop in the death rate,

14.3% drop in severe injuries and 13.8% drop in moderately severe injuries, Cipra said.

There were 133,991 people in injury accidents who received no injuries at all in 1987, and 144,758 who escaped injury in 1988 crashes.

Even though there was a slight increase overall in traffic deaths this year, the increase was in the number of pedestrian deaths, Cipra said. The number of driver deaths dropped by 28 during the first eight months of the year.

A survey of seat belt use on the 1988 accident reports showed that 53% of all passenger car or light truck occupants in the more severe collisions were wearing seat belts. A year earlier, only 19% were said to have been using belts. "The overall preliminary study indicates that the Wisconsin safety belt use law is working, and that as more drivers and passengers comply with the law, the number and severity of injuries will drop," he added.

Wisconsin Lottery Means Wins and Losses... and Taxes

Now that Wisconsin has joined the list of states that have a lottery game, people who enjoy playing the lottery may wonder about the money they spend on tickets and the money they win. How much is taxable? How much is deductible?

If you win money playing the Wisconsin lottery, you must report your winnings as income on line 22 of your tax form 1040. Lottery winners cannot use form 1040A or 1040EZ.

Can you deduct any of the money that you spend to buy lottery tickets? Yes — but only if you win and only up to the amount you win. If you itemize your deductions, you may claim the cost of your winning and losing lottery tickets on line 25 of Schedule A. This is important: the amount you deduct cannot exceed the amount you report as winnings on form 1040.

Many lottery winners will receive a form W-2G from the State of Wisconsin. This form works much like other types of W-2 forms; it reports the amount of winnings to both the winner and the IRS.

Form W-2G must be given to

anyone who wins \$600 or more. It can also be used voluntarily to report smaller jackpots. If the winnings (minus the cost of the ticket) are over \$5000, tax must be withheld from those winnings at a rate of 20%.

If you win, you should also furnish the State with your social security number so state officials can properly complete your form W-2G. If you don't, the 20% withholding tax will apply to winnings of \$600 or more.

SKI THEFTS

Washington County Sheriff Clarence A. Schwartz has issued an alert to ski enthusiasts to take steps to protect themselves from being victimized by thieves this winter.

"Each year, thousands of dollars worth of ski equipment is stolen from persons using ski hills in Washington County," the sheriff stated. "Without exception, these thefts could have been avoided if the owner had taken the time to secure the ski equipment before leaving it."

The sheriff explained that many simply leave their skis, bindings and poles outside the ski hill's lodge, or in an unlocked vehicle, while taking a break. It is a simple matter for a thief to remove the equipment and vanish.

"There is a simple solution: lock the equipment using the lockers at the hill, or inside, and out of sight, in a locked vehicle," the sheriff stated.

Skiers should also record the complete description and serial numbers from equipment at the start of the season. Insurance companies will require this information, and if stolen, the numbers can be entered on the nation-wide FBI computer. If recovered by another agency, they can be traced back to the owner.

Mid-Monthly Meeting
November 28, 1988
8:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Paul E. Blumer presided. Trustee Thomas McElhatton asked to be excused and was absent. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Mary Krueger, seconded by Trustee Richard Schlice and unanimously carried by voice vote, the minutes of the November 7, 1988 meeting were approved as printed after one name change being noted.

The public hearing was held on the proposed budget for 1989. It was noted that there was no one present for the public hearing, other than two reporters. The Board reviewed the proposed budget and its impact on the tax rate.

On a motion by Trustee Richard Schlice, seconded by Trustee Kenneth Bonlender and carried by the majority by roll call vote, the Board closed the public hearing. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent."

The public hearing was held on the proposed TIF/CIP budget for 1989. No one was present to speak either for or against.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Charles Boegel to close the public hearing. Roll call vote was carried by the majority. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent."

The public hearing was held on the proposed Special Revenue Fund Projects budget for 1989. No one was present to speak either for or against.

On a motion by Trustee Mary Krueger, seconded by Trustee Richard Schlice to close the public hearing. Roll call vote was carried by the majority. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent."

The public hearing was held on the proposed Debt Service Fund budget for 1989. No one was present to speak either for or against.

On a motion by Trustee Kenneth Bonlender, seconded by Trustee Charles Boegel to close the public hearing. Roll call vote was carried by the majority. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent."

Administrator Daniel Schmidt reviewed some brief correspondence with the Board, along with the Balance Control Sheets for month ending October 31, 1988; also, the Water and Water Pollution Control Department Budget Control sheets for the third quarter.

A brief discussion was held on Erosion Control and Storm Water Control and their effects on the Village.

On a motion by Trustee Charles Boegel, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board hired Craig Knops as the Winter Recreation Director at \$5.15 per hour. The program hopefully can begin in January.

The Kewaskum Softball Association has inquired as to the use of the new diamond for 1989 at no cost and the possibility of constructing a concession building near the backstop of the new diamond. The Board was willing to work with the Association to promote the park and village.

Trustee Howard Laubenstein the Board's Plan Commission member informed the Board of the Public Hearing on the proposed new zoning Ordinance on December 12, 1988, also of a tentative Commission meeting scheduled for December 13, 1988.

Administrator Daniel Schmidt informed the Board that the 1988 sidewalk billing would be mailed on December 1, 1988. Also, the Water and Sewer contractor is encountering some problems with the railroad crossing permit, but hopefully, that will be resolved by the end of the week.

It was noted the DNR has contacted the Village and Engineers informing us of a need for an additional portable generator at the new lift station or to submit an "Emergency Maintenance Operation Manual." The cost of such a manual is estimated at \$3,000 to \$5,000 and would not necessarily eliminate the need for another one to two portable generators. The cost of a new generator would be approximately \$72,000, but it was noted a used 45 KW portable generator has been located with only 8 hours on it at a cost of \$5,000.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Kenneth Bonlender and unanimously carried by voice vote, the Board authorized the purchase of the aforementioned used portable generator at a cost of \$5,000 eliminating the need to have a manual drafted.

On a motion by Trustee Richard Schlice, seconded by Trustee Charles Boegel and unanimously carried by voice vote, the Board authorized the purchase of 1989 Chevrolet Caprice squad car from Ewald Chevrolet & Buick, Oconomowoc, WI, the low bidder at a cost of \$13,345.00. This is as recommended by Police Chief Richard Knoebel.

Final discussion was held on the proposed 1989 Budget, which had been presented at the public hearing. On a motion by Trustee Mary Krueger, seconded by Trustee Charles Boegel and unanimously carried by voice vote, the Board approved the 1989 budget as presented. The Village tax rate would reflect a 3.1 percent increase or 22c per \$1,000 of assessed value.

On a motion by Trustee Kenneth Bonlender, seconded by Trustee Howard Laubenstein and unanimously carried by voice vote the board approved the TIF/CIP 1989 budget as presented at the public hearing.

On a motion by Trustee Richard Schlice,

seconded by Trustee Howard Laubenstein and unanimously carried by voice vote the Board approved the Special Revenues Fund Project 1989 budget as presented at the public hearing.

On a motion by Trustee Charles Boegel, seconded by Trustee Mary Krueger and unanimously carried by voice vote the Board approved the Debt Service Fund 1989 budget as presented at the public hearing.

The following Resolutions as attached hereto were then introduced, discussed and then acted upon: No. 88-19 & No. 88-20.

On a motion by Trustee Richard Schlice, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board switched the Village Board meeting dates for December and January, 1988 & 1989. The dates of December 12, 1988 and January 3, 1989 were selected as the meeting dates for the Village Board.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Charles Boegel to adjourn closed session under Chapter 19.85(1)(c) of the Statutes to discuss employment, promotion, compensation, and performance data of Village employees over which the governmental body has jurisdiction. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent." The motion was passed by the majority.

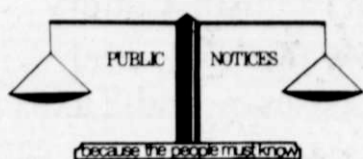

Every Tree Belongs To Someone

MADISON, — Deer hunters and other outdoors lovers who take to the woods this season planning to leave with a freshly cut Christmas tree had better be ready to provide a receipt or other proof of purchase for the tree.

Earl Meyer with the Department of Natural Resources Bureau of Forestry reminds Christmas tree cutters that "every tree growing out there belongs to someone."

And while the U.S. Forestry Service, some county forestry agencies and some private landowners are willing to sell live evergreen trees for Christmas trees, the State of Wisconsin does not sell Christmas trees and prohibits the cutting of live trees on all state-owned lands, including forests, parks and public hunting grounds.

"Anyone cutting a tree on state land, or any land without the consent of the landowner, could face up to a \$260 fine and still not get the tree," Meyer cautioned, adding "it's not really in the spirit of Christmas to celebrate with a stolen tree."

DNR forest rangers and conservation warden who will be out checking hunters are also authorized to issue citations for illegally cutting trees, Meyer said.

If you have paid for cutting a tree on national, county or private forest land, Meyer recommends you have a written receipt for the tree with you while removing it from the woods and transporting it.

Rights and Liabilities of Landowners and Snowmobilers

At the county level, clubs work together to build a network of trails that connect one club's systems with another's. Then club representatives contact individual landowners to seek their permission to route a trail across a particular piece of land. The exact location of the trail is worked out with each property owner, and routing is made to keep the trail a reasonable distance away from homes or any other sensitive areas.

Since the marking of the trails is done by members of the local snowmobile club, the landowner does not have to do anything other than provide permission, either verbally or by signing a standard permission form provided by the club.

Under Wisconsin law, specifically Chapter 350, Section 29.88, landowners are not liable for any injury occurring on their property when they have granted permission for snowmobiling, nor does the owner have any responsibility to keep his property safe for such activity. A copy of the Wisconsin snowmobile laws is available through the snowmobile clubs or the DNR.

Snowmobile clubs exist to promote responsible snowmobiling and to prevent problems from occurring. Since snowmobilers are the guests of landowners, your local club will work with you if you have any specific concerns. Each club has a trailmaster or trail committee who respond to any problem that might arise. Landowners have the right to prosecute anyone on their land operating anything other than a snowmobile, such as an ATV, or anyone operating off the trail on their land or a road, including snowmobilers.

Wisconsin's snowmobilers

are proud of the statewide trail system that ranks with the best in the nation. This trail network would not be possible without the generosity of thousands of landowners, and that's why snowmobilers appreciate the cooperation of landowners so much. By allowing trails to be set up, the landowners are helping clubs to promote responsible snowmobiling, and that's to everyone's benefit.

Snowmobilers are especially proud of the fact that they pay for the maintenance of their system of local, county and state trails without government subsidies. Registration fees and gas taxes paid to the state, come back to fund trail development (cost of signs, bridges, etc.) and trail grooming, (operation of machines to smooth the trails). Landowners allow the free use of their land, and snowmobilers themselves donate countless hours of labor through local clubs to set up, mark and maintain the trails in their area. Many businesses also contribute to the effort.

Hwy. 33 Added to Governor's Corridors 2020 Plan

Highway 33 through West Bend has been added to the Corridors 2020 plan - Governor Tommy Thompson's initiative to develop key highways essential to Wisconsin's economic development.

State officials are adding the segment of Highway 33 from US 41 through West Bend to I-43 in Ozaukee County.

Also, officials are upgrading Highway 23 from Sheboygan to Fond du Lac to a multilane connector as part of the Corridors 2020 proposal.

After listening to testimony at a series of public meetings this fall, Transportation Secretary Ronald Fiedler and Development Secretary Bruno Mauer decided that adding some key connector routes like Highway 33 would better link Wisconsin's trade centers.

The revised Corridors 2020 network now has 1,650 miles of multi-lane backbone highways and 1,550 miles of connectors crisscrossing the state.

All of the backbone highways will be multilane, divided highways. They will interconnect all regions and major economic centers of the state and tie them into the national transportation network.

Some of the connectors will be multilane, while others will be 2-lane roads that can be expanded when the traffic warrants. The connectors will link other significant economic and tourism centers to the backbone system.

Nearly all cities and villages

with a population of more than 5,000 will be within five miles of either a backbone or connector route.

649 Registered In County Wisconsin Gun Deer Hunters Bag 254,687 Whitetails in '88

Preliminary figures on the 1988 Wisconsin gun deer hunting season show hunters bagged 254,687 whitetails, the Department of Natural Resources announced.

Overall, the preliminary total shows a two percent increase over 1987, when 250,530 deer were taken.

"The numbers in our preliminary total are based on actual registration figures in some districts and estimated totals using deer populations and past deer registration figures in others," Frank Haberland, DNR wildlife biologist said. "The final deer season total will be made after all the registration stubs have been counted by hand. If our preliminary figure changes, it will more than likely increase."

According to Bill Ishmael, wildlife manager at Pike Lake State Park, 649 deer were registered in Washington County during the nine day season. Of the total, 344 antlered bucks and 305 antlerless deer, were registered at the county stations. Last year a total of 538 deer were shot, including 295 bucks and 243 antlerless deer.

Northern Wisconsin hunters enjoyed the results of the past two mild winters, which allowed for an increased deer herd and liberal Hunter's Choice permit numbers. All three of the DNR's northern management districts reported increased deer registrations.

The Northwest District reports a 21 percent increase, estimating a registration total of 47,500 deer this season compared with 39,410 in 1987.

The Lake Michigan District has the highest 1988 registration with 58,791 deer harvested, a 10 percent increase over 1987's total of 53,508. Lake Michigan District wildlife specialist Jim Raber reported that the harvest increase was due to a larger deer herd, increased Hunter's Choice permits, and heavy mid-week hunting.

"Registrations during the week at many of our stations were almost double that of previous seasons," Raber said. "District law enforcement personnel reported heavy hunting activity during the week and observed many more hunting camps in several areas."

The North Central District reports a nine percent increase this year, up to 52,781 compared with 48,364 in 1987. The Woodruff Area, including Forest, Oneida and Vilas counties, registered 16,000 deer.

"Almost all counties north of Highway 64 showed increased deer registrations because of the large herd size following the past mild winters," Haberland noted. "In the southern part of the state hunters had good success, but the harvest totals there were lower by management design this year when compared with totals in previous hunting seasons."

The Southern District shows an estimated 1988 total of 35,200 deer harvested this year compared with 44,342 in 1987. The harvest this year presents a 21 percent decrease.

Last season's DNR district deer registration leader, the

Western District, is down seven percent for 1988 with an estimated total of 57,500. It was number one in 1987 with 61,651. The reduction was anticipated because of fewer Hunter's Choice permits made available based on a slightly reduced deer herd.

The Southeast District is down 10 percent to 2,915 compared with 3,251 in 1987.

The 1988 deer hunting season will rank as one of the safest gun deer hunting seasons in the past four decades, with 20 reported shooting accidents including two fatalities. The same total of accidents was reported in 1940, but that also included seven fatalities.

Ripon Men's Team Loses 2

The Ripon College men's basketball team fell to 1-2 on the season with a pair of tough nonconference losses in a Thanksgiving weekend trip to Northern Michigan University last Saturday and at home against Marian College on Monday. The Redmen lost to Northern Michigan 74-70 and to Marian 64-60. In both contests the Redmen were done in by a combination of good defensive pressure against them and by their own uncharacteristically poor shooting at crucial times.

Against Northern Michigan the game was close throughout. The lead changed hands nine times, and the score was tied eight other times. The Redmen led 65-58 with 7:50 left in the ballgame but went into a shooting freeze that saw them score only five points the rest of the way. According to Ripon head coach Bob Gillespie, "We played well in spurts but just could not seem to sustain any momentum long enough to put them away for good."

Among the team leaders for the Redmen at Northern Michigan U. were Tyrone Kleinhans, formerly of Kewaskum, 15 points-nine rebounds.

Against Marian, a team which is rapidly developing into an intense local rival, the pattern was similar. The game was close throughout. The lead changed hands and the score was tied numerous times. 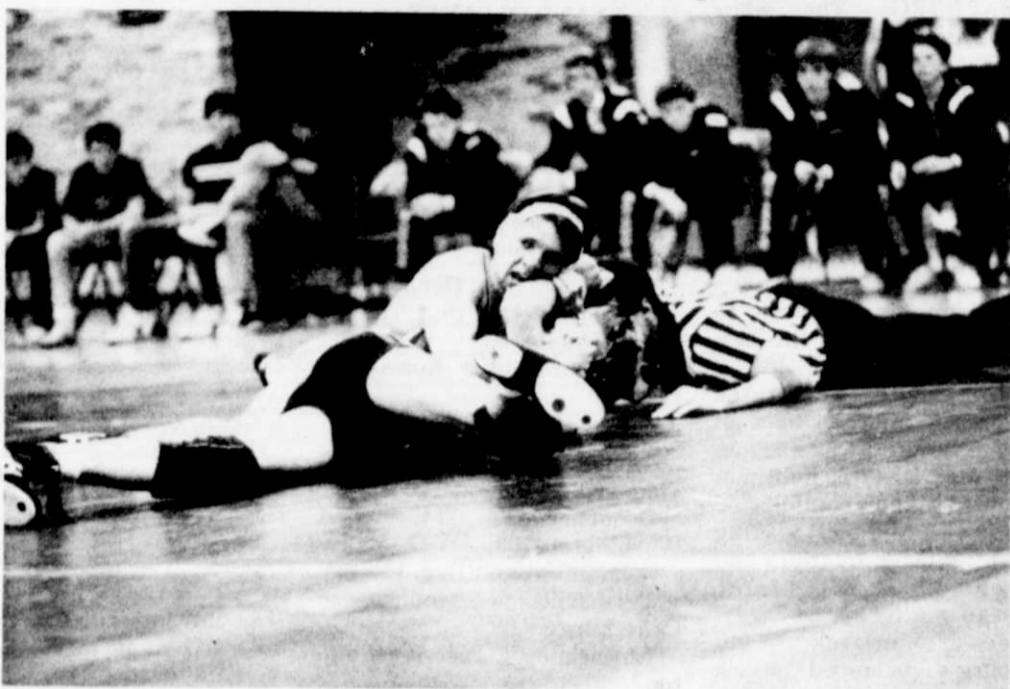
