Pledges in Excess of 160% of Goal **Cancer Society's Jail and Bail Tops All Expectations**

It was a "first-time" effort for many of the individuals involved in last week's Jail and Bail fund drive to raise money for the American Cancer Society, but that effort and dedication paid off beyond anyone's most optimistic hopes. The 57 culprits who were 'arrested' during the two-day

event managed to come up with over \$16,500 in pledges for the society, well over the set goal of \$10,000.

Kewaskum men, Two Mitchell Ogi and his brother Dr. Gregory Ogi, took on the task of co-chairing the committee to organize and hold the first Kewaskum Jail and Bail fundraiser. "It was a lot of hard work but we had fantastic cooperation and help from the other members of our committee and that's what

made it a success and fun," said Mitch. We were just hoping to reach our goal but we've surpassed that by almost \$7,000 and the pledges are still coming in, he noted.

Working with the Ogi's were Nicole Condon, ACS Area Executive Director, Jean and Jim Stoffel and Bob Sparks. These people put in a lot of long hours before the event actually took place. They helped with the initial work, setting the dates, securing a "Jail" location, advertising, lining up donations of food and refreshments for the event, putting together lists of potential criminals to be arrested, securing the assistance of the Kewaskum Police and

Washington County Sheriff's Departments volunteers to make the arrests and all the other countless details that had to be taken care of.

The cooperation and participation of the community as a whole is really what made the event the success that it was, noted Ogi.

Two of the men who seemed to enjoy their roles the most were "Judge Gentlemen Jim" Schaub and "Judge Hardhearted Jerry" Kiefer. Not mentioning any specific names, one wielded a stern gavel setting some mighty stiff bails while another individual "seemed" to show a little more lenient disposition toward the accused. 
In keeping with this winter's pattern temperatures are expected to rise into the high 40's by Friday.

Kewaskum Committed To Incineration Project

Members of the Village Board unanimously agreed Monday night that Kewaskum is committed to the plan to construct an incineration plant in Washington County.

Trustee Mary Krueger, who represents the village on the Joint Incineration Committee, told fellow boardmembers, "we have to come to some conclusion within the next month or so." Krueger said, "if we're not going to commit ourselves to the project I don't want to waste my time attending meetings."

Board president Paul Blumer said from his point of view, "we (the village) don't have much choice." The other trustees agreed.

Krueger reminded the board that the village's formal backing will mean additional financial support. You've gotten all the information there is to get, from here on in, it's going to be planning and actual construction of a facility, she noted.

After listening to the board's comments Krueger said, then what you're saying is that I can go back to the committee and tell it Kewaskum is formally committed to the plan to build an incinerator.

In other business the board discussed the problem of unshoveled sidewalks and individuals who snowblow the snow back into the streets.

Public Works Superintendent Augie Bilgo told the board most of the homeowners have been very conscientious about cleaning up their sidewalks and there really hadn't been any problems. He did note, however, that it would be easier for the Police Department, on its routine patrols, to take down the addresses of those people who have not even made an attempt to clean their walks.

The board asked if letters were sent out to the propertyowners telling them to correct the situation. Bilgo indicated no, the village, in most cases, would clear off the walks and charge the cost to the tax bill. He said, however, such incidents were relatively few.

Bilgo told the trustees, "the bigger problem is those individuals who clean off the sidewalks by blowing the snow back into the street." There's an ordinance against it, he said. Bilgo felt those people seen blowing the snow back into the street should be given a ticket "right then and there." He said there was no reason why those using snowblowers could not direct the snow onto their lawns or at the snowbanks along the curb. He stressed that throwing snow back into the street is illegal.

Bilgo said he can understand the people's frustration when the village plows and the snow goes into their driveways. We have to push it some place until we can come around and clean it up and haul it away, he noted, but it doesn't help to have somebody blow the snow back into the street five minutes after we've plowed.

The board agreed that if the village has ordinances they should be enforced or it doesn't pay to have them on the books. In other action the board

approved the issuance of a building permit to David and Irene Stradtman for construction of a new home on Werner Drive and a dance hall license to Somethin-Ta-Do.

Action on a computer services contract for tax bill preparation with Washington County was tabled until the board's next meeting.


WAYNE CADETTE GIRL SCOUTS PLAN LUNCH WITH EASTER BUNNY

Village of Kewaskum NEWS NOTES REMINDER

Pursuant to Section 174.052, Wisconsin Statutes, notice is hereby given to all owners of dogs in the Village of Kewaskum that rabies vaccinations and dog licenses are required under the Statutes.

The same applies to cat owners under Chapter 12.04 of the Kewaskum Municipal Code.

Vaccination by a veterinarian against rabies is required (Section 95.21(2) within 30 days after the dog reaches 5 months of age and revaccinated within one year after the initial vaccination. Older vaccinated pets must be revaccinated when the certificate expires or within three years of the previous vaccination. Certificates of current vaccination must be presented when obtaining licenses.

All dogs/cats. 5 months of age or older, require a license. The minimum dog license for neutered males or spayed females \$2.00, is upon presentation of evidence attesting to the same and \$4.00 for the unneutered male or unspayed female dog. The minimum cat license for neutered males or spayed females is \$5.00, upon presentation of evidence attesting to the same and \$8.00 for the unneutered male or unspayed female cat.

All dogs and cats are not to run at large or cause damage to other peoples property. As per Chapter 12.02 of the Kewaskum Municipal Code and State Statutes Chapter 174.02. The owner or keeper of any dog or cat licensed or unlicensed, shall not permit the same to run at large in the Village. The owner. or keeper of any dog or cat licensed or unlicensed, shall not permit the same to cause damage (leave body waste) on others property. These matters are also redefined in both Chapter 9, Peace and Order, and Chapter 10, Public Nuisances, of the Kewaskum Municipal Code.

MADISON - A bill that would require judges to determine the "best interest of the child" is being introduced in the State Legislature, in response to child abuse cases like the Joshua DeShaney case, State Senator Carol Buettner (R-Oshkosh) said recently.


The bill, of which Buettner is a co-sponsor, provides that in child abuse and neglect cases, judges must use the "best interest of the child" standard when making a decision of whether or not a child should remain in or be returned to the home. Under current law, when court exercising jurisdiction under the children's code makes a dispositional order, the court must ensure that the order employs those means necessary to keep children in their homes whenever possible, and also. employs the least restrictive means of the rights of the child


by current law to send many of these kids back into the home, even though there may be signs that abuse is taking place," Buettner said.

"The original intent of the requirement was well-intentioned, but it has led to too many situations where children were being sent back into the custody of abusive family members, only to be abused again,' Buettner said.

The bill was introduced at the request of Channel 6, WITI - TV in Milwaukee after they ran an investigative series on child abuse.



Wisconsin's School Lunch Heart Week: **Tasty Lessons In Good Nutrition**

Students at more than 350 elementary schools in Wisconsin will discover that foods that are healthy for their hearts don't have to be boring during School Lunch Heart Week, March 13-17.

The cooks in their school cafeteria will serve them appetizing lunches that are low in fat, salt and sugar, and their teachers will conduct classroom activities on the importance of heart-healthy eating habits.

School Lunch Heart Week is held during March - which is National Nutrition Month - to help children avoid obesity, high cholesterol and high blood pressure, problems which will increase their risk of heart disease as adults.

The statewide program is sponsored by the American Heart Association of Wisconsin in cooperation with the Wisconsin School Food Service Association and the Department of Public Instruction Nutrition Education and Training Program.

It was developed because the growing incidence of obesity in American children is becoming a major health problem. The number of 6- to 11-year-olds who are obese has grown 54 percent in the last 15 to 20 years, according to the National Center for Health Statistics.

High blood cholesterol levels have also been found in schoolage children, particularly those whose diet includes large amounts of saturated fat and dietary cholesterol. And some children have blood pressure readings which are considered high for their age group.

Sample menus for Wisconsin's 1989 School Lunch Heart Week follow the American Heart Association's dietary guidelines for healthy persons over age two and the USDA guidelines for the National School Lunch Program.





The preliminary meeting for the proposed Highway 41 project was held March 7th at Waukesha. Further public meetings are anticipated.



Fond du Lac County Turkey Population Update Ripon College

HORICON - The reintroduction of the wild turkey throughout southern Wisconsin continues at a steady pace. This is due to the Department of Natural Resources' transplant program. The last of Wisconsin's wild turkeys disappeared around 1885, due to nonregulated hunting, deforestation, and diseases. In 1976, the first reintroduction took place when turkeys from Missouri were released into southwestern Wisconsin. From the original 300 plus turkeys, their toms and jakes (immature population has grown to more than 40,000 birds today.

The spread of the turkey continues as birds are trapped in winter and released into new areas. In 1985, 46 birds were introduced into the Northern Kettle Moraine State Forest. That population has grown to nearly 500. On February 27, 19 turkeys were released on private land in the drumlin region between Campbellsport and Eden. Once a population has become well established, a limited hunting season will be opened, as in the southwestern corn stubble until spring will part of the state. Usually, a hunting season can open as early as six years following initial stocking if population turkey doing so well in Wiscongrowth is steady.

to life in the wild. One of the greatest threats to the restoration program is the releasing of pen-reared birds in an attempt to "help the population." These game farm birds can infect the wild population with any of a number of dieases. Game farm turkey and wild turkey interbreeding can reduce survivability in the resulting offspring.

All released turkeys are marked with colored wing tags - red for hens and vellow for males). This aids in identification and tracking their movements. Some of the ways people can help the wild turkey is by reporting sightings of these birds. Make note of the location, date, number of birds sighted, and the colors and numbers on the wing tags. Landowners near release sites can help by practicing good woodlot management, emphasizing mast or nut producing tree species. Regular spreading of manure in winter and delaying the plowing of help provide additional food for turkeys during the winter.



The Village Board of Kewaskum, Washington County, Wisconsin met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

In the absence of President Paul Blumer, Administrator Daniel S. Schmidt called the meeting to order. President Paul Blumer asked to be excused and was absent. All other Trustee Members were present. A quorum was present.

On a motion by Trustee Mary Krueger, seconded by Trustee Charles Boegel and unanimously carried by voice vote, the Board appointed Senior Trustee Howard Laubenstein as President Pro-Tem.

The meeting was opened with a moment of Silence and Pledge of Allegiance.

On a motion by Trustee Richard Schlice, seconded by Kenneth Bonlender and unanimously carried by voice vote, the minutes of the February 6, 1989 meeting were approved as printed.

A brief review of the Facility Plan Amendments for the WWTF was discussed.

Chief of Police Richard Knoebel informed the Board of the Severe Weather Seminar scheduled for March 1, 1989 at 7:00 p.m. at the Kewaskum Fire Station.

Superintendent of Public Works, Augie Bilgo, brought up for discussion section 14.09 of the Municipal Code pertaining to "Garbage and Refuse Disposal." Primarily inappropriate containers or those with excessive amounts of garbage and refuse. A news note will be placed in the paper and letters sent to all appropriate parties.

On a motion by Trustee Charles Boegel, seconded by Trustee Richard Schlice and unanimously carried by voice vote, the Board authorized the requesting of SEWPC to do a hiking and biking survey plan for the Village of Kewaskum at no cost.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board granted Mr. Fred Robertson a one-year extension on his Conditional Use Permit No. 84-CUP-01.

On a motion by Trustee Kenneth Bonlender, seconded by Trustee Richard Schlice and unanimously carried by voice vote, the Board authorized the signing of the Memorandum of Agreement with the Softball Association contingent upon their signing of the agreement.

On a motion by Trustee Charles Boegel, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the Board authorized the Village Attorney to prepare a contract for the Softball Association in reference to the use of the NE Diamond and Concession Building. NOTE: The Miller Et.A1. Petition for Annexation was not discussed due to the petitioners attorney withdrawing the petition to make some needed corrections.

On a motion by Trustee Dick Schlice, seconded by Trustee Kenneth Bonlender to adjourn to closed session under Chapter 19.85(1)(e) of the Statutes to deliberate and negotiate the disposition of public lands. Roll call vote was 6 "Aye," 0 "Nay," 0 "Absent." The motion was passed by the majority.



ORDINANCE NO. 01-02-89

AN ORDINANCE CLASSIFYING TOWN HIGHWAY AND ESTABLISHING SPECIAL AND SEASONAL WEIGHT LIMITATIONS THEREON

THE TOWN BOARD OF THE TOWN OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN, ORDAINS AS FOLLOWS:

Section 1. Class "B" Highways Designated. Pursuant to SS 348.16, Wis. Stats., the highways maintained by the Town are designated Class "B" pursuant to highways, SS349.15, Wis. Stats. No person shall operate any vehicle or combination of vehicles imposing wheel, axle, group of axles, or gross weight on any Town highway which exceeds 60% of the weight limitations for Class "A" highways as set forth in SS348.15(3)(c).

Section 2. Special and Seasonal Weight Limitations.

(a) The Town Chairman is empowered to exercise the authority granted by SS349.16(1), Wis. Stats., to impose temporary seasonal special weight limitations on any Town road or portion thereof which, because of weakness of the roadbed due to deterioration or climatic conditions or other special or temporary condition, would likely be seriously damaged or destroyed in the absence of such special limitations.

(b) Imposition of the special weight limitations authorized by sub. (a) above shall be done by erecting signs on or along the highway on which it is desired to impose the limitation sufficient to give reasonable notice that a special weight limit is in effect and the nature of that limitation.

(c) The Town Chairman is further empowered to exercise the discretion authorized by SS349.16(3), Wis. Stats., to vehicles exempt carrying certain commodities such as construction materials and fuel from the limitations imposed by sub. (a) above or to set different weight limitations than those imposed by sub. (a) above for vehicles carrying such commodities if, in the judgment of the Chairman, the exemption or limitation is reasonable and necessary to promote the public health, safety and welfare.

Section 3. Penalty. Any person violating this ordinance may be penalized as follows:

the costs of prosecution, and, upon the second and each subsequent conviction within a 12 month period, a forfeiture of not less than \$100.00 nor more than \$200.00 plus the costs of prosecution.

(b) If the weight exceeds by more than 1,000 lbs. the maximum set forth in said ordinances and posted as provided therein, the forfeiture shall be computed according to the following schedule:

1. For the first conviction, a forfeiture of not less than \$50.00 nor more than \$200.00 plus an amount equal to: 1c for each lb. of total excess load when the total excess is not over 2,000 lbs; 2c for each lb. of total excess load if the excess is over 2,000 lbs. and not over 3,000 lbs; 3c for each lb. of total excess load if the excess is over 3,000 lbs. and not over 4,000 lbs; 5c for each lb. of total excess load if the excess is over 4.000 lbs. and not over 5.000 lbs; 7c for each lb. of total excess load if the excess is over 5.000 lbs.

2. For the second and each subsequent conviction within a 12 month period, a forfeiture of not less than \$100.00 nor more than \$300.00, plus an amount equal to: 2c for each lb. of total excess load when the total excess is not over 2,000 lbs.; 4c for each lb. of total excess load if the excess is over 2,000 lbs. and not over 3,000 lbs.; 6c for each lb. of total excess load if the excess is over 3,000 and not over 4,000 lbs.; 8c for each lb. of total excess load if the excess is over 4,000 lbs. and not over 5,000 lbs.; 10c for each lb. of total excess load if the excess is over 5,000 lbs.

Section 4. Severability. If any provision of this ordinance is determined to be invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality will not affect the other provisions or applications of this ordinance which can be given effect aside from the invalid or unconstitutional provision or application.

Section 5. Effective Date. This ordinance shall, in accordance with sec. 60.80(2), Stats., take effect the day after its publication as a Class 1 notice under ch. 985, Stats. Dated this 20th day of February, 1989.





APRIL .4, 1989

NOTICE IS HEREBY GIVEN that at an election to be held in the several towns, wards, villages and election districts of the State of Wisconsin, on the first Tuesday, of April, 1989, being the Fourth day of said month, the following proposed amendment to the Constitution of the State of Wisconsin, having been approved by two successive legislatures, will be submitted to a vote of the neople pursuant to law: people pursuant to law:

QUESTION: "Tax credit or refund for property or sales taxes. Shall section 1 of article VIII of the constitution be revised, and shall an additional provision be created in that section, to allow the State of Wisconsin to provide by law property tax relief or sales tax relief, or both, to the citizens of the state, subject to reasonable classification and progressive effect on the tax system, by means of credits or refunds for taxes due under property or sales taxes in this state, to be credited against or refunded from taxes imposed by this state on income, privileges and occupations?"

This referendum is a result of 1989 Enrolled Joint Resolution 2, which was adopted by two successive legislatures. A copy of Enrolled Joint Resolution 2 can be obtained from the office of the county clerk, or the Legislative Documents Room in the State Capitol.



UWWC Cagers and Coach Take All-Conference Honors

Two University of Wisconsin Center — Washington County women freshmen basketball players and their coach were selected by coaches from the Wisconsin Collegiate Conference for all-conference honors this week.

UWWC cagers Tammy Becker and Kelly Koller, who led the Wildcats to a WCC championship title last week, were chosen as members of the All-Conference team. The conference is made up of teams from the 13 UW freshmansophomore centers.

Becker, a 5' 10'' center and forward from West Bend East, was also named to the All-State Junior College basketball team by basketball coaches from all two-year colleges and vocational/technical colleges in the state.

Koller, a 5' 6'' point guard also attended West Bend East.

Wildcat coach Tom Brigham was voted Coach of the Year for the eastern division of the conference.

Brigham's team finished the 1988-89 season with a 13-6 record.

Both Becker and Koller were instrumental in leading the UWWC cagers to victories this season, usually alternating as high scorers for the team from game-to-game, Brigham said.

After clinching the Eastern Division conference title by defeating UWC-Fond du Lac, the Wildcats went on to take the UWWC championship on Feb. 18 by beating UWC-Marathon County. It is the first conference championship for the UWWC women since 1981.

The coach also commended

the other members of his team for their outstanding play on the court this season, including Deb Gerner of Newburg and five West Bend women: Tisha Warda, Patricia Dorn, Melissa Gundlach, Amy Tousey and Chris Reth.

Brigham had special praise for Becker and Koller and the way they worked together. He cited their unusual ability to "ad lib" off Wildcat patterns, crediting four years on the same high school team under Rick Riel, described by Brigham as "one of the premiere high school coaches of the state."

In recapping the season, Brigham called Becker "the dominant force inside for the Wildcats, regardless of how big her opponents were." Koller, he said, could shoot from outside and was a good ballhandler able to "penetrate through the seams" of opponents' defenses.

"Both players possess triple threat ability," he said, showing the ability "to pass the ball, drive with the ball and shoot with the ball."

Brigham also received Coach of the Year awards in women's basketball for the 1981-82 and 1982-83 seasons. In 1984, he received the honor in soccer.

The coaching awards share the limelight on Brigham's office bulletin board with another honor. He received it last year from his daughter Jennifer, a freshman at Kewaskum High School. The award reads: "Number One Daddy in the World."

"Guess which award I like best," Brigham said.

Kewaskum will take on the tail ender Thiensville-Mequon Ferrantes Sunday at Homestead


