## **Board Approves One Conditional Use Permit, Denies Another**

Two similar items on the Kewaskum Village Board's agenda Monday night received different reactions and actions from the trustees.

Before the board, under new business, was the request for a conditional use permit from The Herro Company to allow for an exception to establish a Community Based Residential Facility (CBRF) on vacant land directly behind the Sison Medical Clinic at 1040 Fond du Lac Avenue.

During a public hearing on

the request at the beginning of the meeting, there was no one speaking for or against the request. The property, which has already been rezoned R-4 residential, would require the permit since the company proposes to construct two 15unit buildings adjacent to one another on the property. According to state statutes unless an exception is granted, there must be a minimum of 2,500 feet between institutional type facilities such as the CBRF and the Exodus House which also falls into that same category.

CBRF's are designed to provide a family/communal type living arrangement for people who do not require a nursing home setting and want to live with some degree of independence while needing some assistance with daily routines such as cooking, laundry, bathing, etc.

On a roll call vote the board approved the granting of the permit which will now allow the company to proceed with license applications and construction plans.

Under unfinished business, the board again addressed the requests of Wisconsin Elder Care for both a rezoning request and a conditional use permit which would allow it to also establish a CBRF. Elder Care's request, however, pertained to an existing structure, the former Thee Avenue restaurant property also located on Fond du Lac Avenue.

At a public hearing on those requests May 1st, several of the trustees expressed their reservations about granting the rezoning which would have changed the property from commercial retail to institutional. Trustee Ken Bonlender stated at that time he felt the property should be given the opportunity to become successful again as a retail business establishment.

No action was taken on the requests at the May 1st meeting since two trustees were missing and it was felt their two votes might affect the outcome of a vote.

At Monday night's meeting members of the Hayes family, which operate a CBRF in Fillmore, refuted the board's comments saying their facility would be an asset both financially and in meeting the needs of senior citizens in Kewaskum. The Hayes' noted several businesses had attempted to operate on the property but had unsuccessful. They been questioned whether the village wanted the building to stand empty for another year. Trustee Mary Krueger noted the operated property had successfully for many years as a supper club. Krueger and Bonlender both said they had no problem with Elder Care's proposal to create a CBRF, however, they did not the proper location for such a facility. When the board voted to deny Elder Care's rezoning request it, in effect, also killed the need to act on the

Two separate accidents last Thursday claimed the lives of two people, raising Washington County's highway death toll for 1989 to sixteen as compared to only one fatality for the same period of time last year. The toll for the entire year of 1988 was eleven.

The first accident claimed the life of a 38-year-old Slinger According woman. to authorities, Marlene Ε. Gochenaur swerved in front of a passing truck when she apparently diverted her attention to her two-year-old granddaughter, Natasha Henninger of Hartford, who was a passenger in the Gochenauer car. The woman was pronounced dead at the scene of the accident which occurred at about 2:50 p.m. on Mayfield Road in the Town of Polk. The Henninger child was transported to Milwaukee Children's Hospital.

The second accident occurred just an hour later at about 3:50 p.m. on Oak Road, just north of Highway H, in the Town of Kewaskum. The victim in that one-vehicle accident was Clifford T. Niemi, 47, of 324 Barbie Drive, West Bend, who was riding alone on his motorcycle. According to a witness and Sheriff's Department report, Niemi was northbound on Oak, when he passed a car along a winding section of the road. After passing the car Niemi **Beauty Salon** 114 Main St., Kewaskum Lower Level Featuring Family Hair Styling Phone 626-4455

apparently rounded a curve leaving the road for a short distance, when he returned to the road Niemi lost control and the cycle overturned coming to rest in the southbound lane.

Niemi, who was not wearing a helmet, sustained head and

other injuries. He was taken to Joseph's Community St. Hospital, West Bend, by the Kewaskum Ambulance and then transported by the Flight for Life to Froedtert Memorial Hospital, Milwaukee, where he died at 7:25 p.m.

## Village of Kewaskum **NEWS NOTES**

The Village Board would like to remind the residents of the Village of a topic covered in the Village's Municipal Code. The topic is covered in Chapter 10. Public Nuisances and Chapter 14, Public Health and Welfare; we shall refer to this problem as a health hazard. The Village has undertaken several steps to improve the clearwater (storm water) discharge in the entire community, but yet people are not cooperating. We find that people cut their grass, discharging it on to the street or catch it just to jump it in a designated clearwater collection point to help plug up and eventually cause water to back up during certain times of the year. The Village would ask that all residents keep their grass clippings and leaves away from the catch basins in the curb area. Also to refrain from dumping their grass clippings and leaves in ditched areas.

If anyone is caught discharging or dumping these materials as mentioned above, they will be cited and fined appropriately as specified in the

Village's Municipal Code, Chapter 24, Administrative Review Procedure.

## Senior Watch


The second in a series of "Senior Watch'' crime prevention information sheets has been released by the sheriff's department, this one dealing with home security lighting.

"Senior Watch" is distributed at the county's libraries, through the Office on Aging, and at the front lobby of the sheriff's department in West Bend.






### Recount Verifies Tax Referendum Is Dead

An official recount, certified by the Board of State Canvassers last Wednesday, confirms the fact that state voters rejected the proposed constitutional amendment on property taxes as presented to the electors in the April 4th spring election.

Recount results showed the referendum was actually defeated by 448 votes more than the original count figure. The recount came up with the proposal being defeated by 1,098 votes. The original count showed the proposal being defeated by 650 votes, with 406,154 ballots against and 405,504 for.

The recount found an increase of 970 votes from the original count of 811,658, as reported by Wisconsin's 72 counties. The number of 'yes' votes rose by only 261, while the number of 'no' votes increased by 709.

The proposed amendment would have changed the State Constitution's uniform tax clause to permit lawmakers to direct property tax rebates to select taxpayers.

The vote was noted as being one of the closest in recent years in a statewide contest.

almost After a week. authorities still have not determined the exact cause of a grassfire which burned approximately twenty acres of state forest and private land along Youth Camp Road and Highway DD, in the Town of Wednesday Auburn last afternoon.

Walt Adams, Superintendent of the Northern Kettle Moraine State Forest, said Tuesday afternoon, the fire was still under investigation and interviews of several individuals were being conducted. "We do know that the fire started at seven, possibly eight different locations within a two-mile stretch. We hope to come up with at least a probable cause.

"It was a very unusual fire" said Adams, "but we've seen this type before caused by trains throwing sparks along railroad tracks and occasionally diesel trucks or other equipment along roadways. The two causes we're considering right now are either the fire was intentionally set or a piece of equipment was the cause, he noted.
