Board Approves Hiring Jones for Another Year

The Kewaskum Board of Education unanimously voted Monday, to hire David Jones to serve as Kewaskum Middle School principal for one more year.

The district had originally hoped to hire both Jones and his wife Suzanne, who would have worked as a part-time social worker for the district, as a two-for-one salary package. According to Dr. Heather, Mrs. Jones has apparently changed her mind about the position. Because of that, Heather noted, Mr. Jones alone will be hired with his salary being deferred so as not to jeopardize his pension.

In other action the board approved the administration's recommendation to leave the fifth grade at Wayne Elementary School for the 1990-91 school year. Dr. Heather indicated he felt such action would provide better utilization of the building. He did note, however, that having the fifth grade in Kewaskum this year had worked out well.

Heather also addressed the issue of boundaries. He thought the changes should be made, however, he did not feel they were critical to the operation of the Farmington and Wayne schools for the next year or two. Heather suggested the district

leave the boundaries status quo but continue to monitor the situation. He said it is an ongoing problem which will need to be addressed in the future.

Board member Ruth Schmitt said what she had gathered from the various boundary discussion meetings was that, if it is to happen, parents would like to see it eased in starting at the kindergarten level.

The board also approved a three-year transportation contract with Johnson Bus Company. While there will be a 20% or \$90,000 increase for 1990-91 over this year, Heather advised the board that was due to the fact that the district will no longer be furnishing the gasoline as it has in the past.

Johnson will now be purchasing their own fuel. Had the district opted to continue buying the gas, the increase would have been adjusted accordingly and would have reflected only a 4% increase. The remaining two years of the contract will reflect 3.5% increases.

The district presently includes \$75,000 in its budget for gasoline. Heather said with the fluctuating fuel prices, he would like to see the district "get out of the petroleum business and let the transportation contractor take

the risk."

The board also approved the hiring of two additional Exceptional Education Needs teachers for the 1990-91 school year, due to the need created by increasing enrollments. The staffing was required to meet state guidelines, Richard Zarling, Designee for the Special Education program, advised the board. Zarling said the district had, already this year, exceeded the student/teacher ratio limits as set down by the state due to more students moving in the district during the school year.

In other business, Dr. Heather advised the board that the district is "very much into the budgeting process" for 1990-91, and all departments were held to a "zero increase" over 1989-90, with most of the departments complying.

Heather noted while it was too early to give any accurate figures he wanted the board to know what it would be facing. Without any capital equipment or major expenditures other

Election Results Official

Following verification by a Board of Canvassers, the results in both the Kewaskum School Board and Kewaskum Village Board races are now official.

In the Board of Education election, final figures show incumbents Ronald Beimborn receiving 1,184 votes and Ruth Schmitt 1,159, followed by write-in candidate Janet Wolfenberg getting 886 and former school board member Clara Trapp garnering 415.

Broken down by townships, the results were as follows: Village of Kewaskum, Beimborn 395, Schmitt 388, Wolfenberg 321, Trapp 109.

Town of Kewaskum, Beimborn 148, Schmitt 141, Wolfenberg 107, Trapp 45. Town of Farmington, Beimborn 277, Schmitt 255, Wolfenberg 245.

Broken down by townships, the results were as follows: Village of Kewaskum, Beimborn 395, Schmitt 388, Wolfenberg 321, Trapp 109.

Town of Kewaskum, Beimborn 148, Schmitt 141, Wolfenberg 107, Trapp 45. Town of Farmington, Beimborn 277, Schmitt 255, Wolfenberg 245, Trapp 98. Town of Auburn, Beimborn 61, Schmitt 61, Wolfenberg 42, Trapp 26. Town of Scott, Beimborn 105, Schmitt 100, Trapp 61, Wolfenberg 42. Town of Wayne, Schmitt 161, Beimborn 152, Wolfenberg 107, Trapp 59. Town of Barton, Schmitt 52, Beimborn 46, Wolfenberg 21, Trapp 17. Town of Ashford, Schmitt 1, Wolfenberg 1, Beimborn and Trapp, 0. No school board votes were cast in the Town of Mitchell.

In the Village Board election, the results remained unchanged with incumbent Larry Williams receiving 436, incumbent Tom McElhatton getting 342, followed by challengers Gary Gavin 295 and Joseph Gitter 279.

By a margin of 16 votes, Gavin won the third open post on the board.

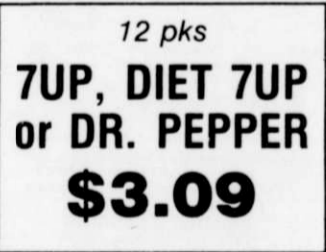

than those needed for the operation of the district, Heather indicated approximately \$688,532 or 8.73% over last year's budget would be needed for Funds 10 and 30 alone. He told the board, "there are not a lot of new things, most of it is replace this, replace that, repair." He noted the board was going to have to look at the budget with an eye to providing funds for things that will have to be done. If not by budgeting, then possibly by a capital improvements loan.

Heather also presented a three-year personnel forecast for the district. "This is my perception of what I feel you are going to need." For 1990-91, he projected \$139,000 for two middle school and two EEN teachers along with a 1/2 time social worker. For 1991-92, one elementary guidance counselor, one elementary teacher and a 1/2 time curriculum coordinator, cost - \$90,000. For 1992-93, a full time business manager, two half time positions in the Gifted and Talented program and a full time alternative learning coordinator, cost - \$151,000.

Heather told the board by the 1992-93 school year, he feels the district will be approaching a \$10 million budget.

In continuing his discussion of the budget, Heather said it was premature to cite levies now, but depending upon equalized value growth and state aids, the mill rate increase could run anywhere from 8.91% to 12.5%.

Heather also advised the board that the 1989-90 budget is short in the salaries and benefits area by approximately \$106,000. (Negotiations with the KEA, were recently completed). He indicated by the fiscal year end the deficit should not be this large, however, it still would be significant.

In discussing other issues,

the board agreed to keep monitoring the district's asbestos situation every six months. Board member Donald Nowak indicated recent information out shows it is safer and better to leave the asbestos alone if it is encapsulated and not causing any problems.

The board also approved Dr. Heather's recommendation to make available medical and accident insurance for the district's students. He said the policy is one where parents would pay the premiums themselves. The district would merely offer the source to obtain the insurance.

On behalf of the Kewaskum School district, board president Neal Weare presented retiring member Donald Nowak a plaque in recognition of his service on the board.

The board also approved awarding of the 1990 first annual Clara Jaehnig Scholarship to Kristine Schinker. The scholarship was made available through a bequest from the Jaehnig estate.

Wisconsin's IRS Extends Its Hours to Help Last-Minute Filers

Each year, the Internal Revenue Service encourages taxpayers to file early in order to get their refunds quickly. But the IRS also realizes that many taxpayers will wait until the last minute to file their tax returns. For those taxpayers, the IRS is offering important information last-minute filing "less taxing."

Normally, tax filing season ends on April 15. But because April 15 falls on a Sunday this year, the deadline is extended until Monday, April 16. In order to assist last-minute filers, the Milwaukee District of the Internal Revenue Service is offering extended hours on Saturday, April 14 and Monday, April 16.

On Saturday, April 14, telephone assistance will be available statewide from 9 a.m. until 1 p.m. In Milwaukee, taxpayers can call 271-3780. Elsewhere in Wisconsin, taxpayers can call 1-800-424-1040.

The IRS office in Milwaukee will also be open during those hours on April 14 to assist taxpayers who have questions or need tax forms. That office is located on the mezzanine level of Henry S. Reuss Federal Plaza at 310 West Wisconsin Avenue.

On Monday, April 16, the Milwaukee IRS office will be open from 8:00 a.m. until 5:30 p.m. In addition, telephone assistance will be available statewide from 8:00 a.m. until 5:30 p.m.

John T. Ader, Director of the Milwaukee District of the IRS, reminds taxpayers that they can designate one dollar of their tax to help fund presidential elections by checking a special box on their tax forms. For a married couple filing a joint return, each spouse may check a box to designate a dollar to the fund. According to Ader, "An early sampling of tax returns filed so far this year indicates that almost 25 percent show designations to the fund. Money in the fund is used in the federal matching program to help finance presidential elections. Designating one dollar to the presidential election campaign fund does not change the amount of tax due or reduce the amount of the refund."

Ader also reminds taxpayers that recorded information on 150 tax-related topics is available on Tele-Tax. The topics are listed in the back of your tax package. In

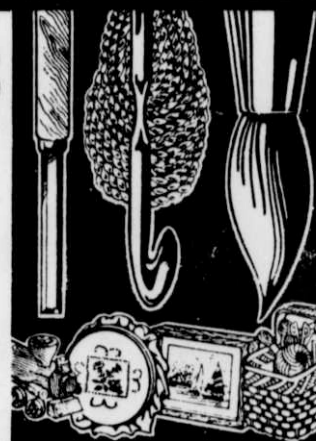

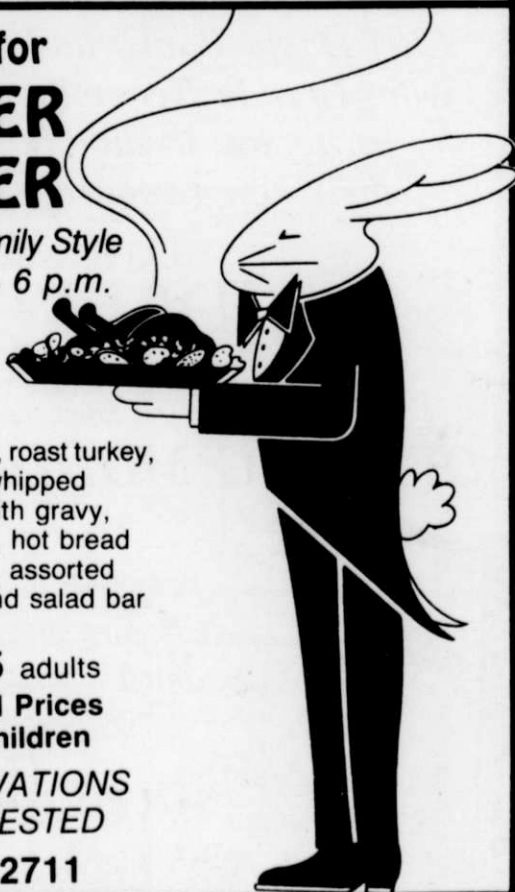

New Solicitation Scheme Could Victimize County Businesses

The Sheriff's Department cautions area business people that yet another law enforcement related solicitation scheme has appeared in southeast Wisconsin, including Washington County.

Telephone solicitors in Milwaukee, working under contract to a New York organization, are calling businesses in an attempt to sell advertising space in a police oriented newspaper. The newspaper is "Police Federated News," but the solicitor may also refer to "Federations of Police" and "The Police Federation."

The organization claims to be a lobbying group for police officers who become members. The newspaper supposedly carries articles written by these members, as well as pictures of missing children.

However, the Attorney General's Office of the State of New York reports that the organization and its owners are awaiting trials as the result of a statewide fraud investigation. According to the latest financial statements provided to that office, the organization took in over \$2 million, yet spent only \$10,000 on lobbying activities, all of which took place in Albany (New York) and Washington (D.C.). The organization is currently the subject of an injunction in New York City, which restricts the methods of its operations.

New York authorities also report that the newspaper

consists largely of advertisements and articles that were copies from other, free sources.

A Washington County businessman was given information concerning the circulation of the newspaper and supposed endorsements by State officials. When asked about these statements, the New York office of the newspaper admitted that the claims were false.

The Sheriff's Department cautions businesses in the County to use extreme caution when asked to donate money in response to a telephone solicitation. The Washington County Sheriff's Department has not endorsed this or any other publication. Anyone who wishes more information about telephone solicitation they have received is urged to contact Sgt. Jed Dolnick at 338-4432 for more information.

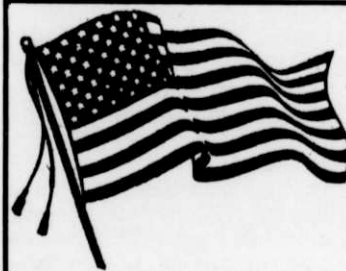

James Kroll, 30, Milwaukee, acquitted Feb. 12, of the first degree murder of a watchman, and Kenneth Meyer, 28, Wauwatosa, who had an eight year sentence after being convicted of armed robbery in 1961, are in custody at the Washington County jail, West Bend, on burglary charges following their dramatic capture outside the A.G. Koch Grocery and General Store at 355 Main St., in Kewaskum early Friday. The capture, as exciting as any movie thriller, took place on Park View Drive near the Koch store, from where the suspects had fled after their car was sighted by officer Kenneth J. Neldner of the Kewaskum Police Department. Officers from Kewaskum, West Bend and the Washington County Sheriff's Department had surrounded the place and swarmed in on the suspects with drawn guns. The men dropped a snub-nosed .38 caliber Smith and Wesson revolver on the floor of their car, then left the vehicle with hands raised with a cordon of police around them.

The Kewaskum Police Department and members of the county department were given a radio description by West Bend after it had been called that the two suspects had tried to start a fight with a West Bend youth. When officer Neldner heard the description, he recalled having seen the car in Kewaskum shortly before. He started a systematic search of the village and found the car parked on Park View near Main St. He notified the West Bend Police and Sheriff's Department and kept the car under surveillance until other officers arrived. The car occupants were in Koch's store and when they saw the squad car of County Deputy Don Mertens pull up in front of the store, they fled from a rear door to their car. At first the suspects tried to break away but their auto got stuck in a snowbank at the curb. The officers drew their guns and orders were given to the men to surrender. The pair first tried to break into the store through a rear door. They broke out the

paneling on the door but ran into a metal guard on the inside and could not gain entrance. They then removed a storm window and gained entrance. The men had knocked the combination off the vault in a futile attempt to rob the safe. The pair appeared before Judge Robert Stoltz on Friday where they had bond of \$10,000 each set. The lieu of the bond they were unable to furnish, each was remanded to jail in West Bend.

Mechanical Cultivation Can Reduce Herbicide Use

Farmers can effectively control weeds through reduced herbicide rates and timely cultivation, says University of Wisconsin-Madison extension weed scientist Jerry Doll.

Although mechanical weed control has always been an option, Doll says, farmers have come to rely primarily on herbicides over the past 30 years. UW-Madison weed scientists have found that farmers can control weeds with two cultivations and using less than the labeled herbicide rate.

Doll recommends an integrated approach to weed control that includes crop rotations, scouting, cultivation and reduced herbicide rates. Such an approach used consistently over the years could have prevented herbicide-resistant weeds from developing, and also probably would have eliminated build-up of hard-to-control annual weeds such as wild proso millet and

woolly cupgrass, Doll notes.

Doll offers recommendations for three different approaches to weed control. If you want to try a no-chemical approach, he recommends at least two rotary hoeings and two or three cultivations. Rotary hoeing sets back weeds early and helps the crop gain a height advantage so cultivation can kill weeds in the row, Doll says.

Rotary hoe five to seven days after you last worked the field and again six to eight days later. Cultivate when the crop is 4 to 5 inches high and again several weeks later, says Doll. Make sure weeds in the crop row are being covered and there is little damage to the crop.

Timeliness is the key to success, especially with rotary hoeing, Doll says. If frequent rains prevent you from cultivating or rotary hoeing, consider applying a post-emergence herbicide when weeds are small.

With a reduced-herbicide

approach, Doll recommends applying one-half to three-quarters the normal pre-emergence herbicide rate and cultivating at least twice. Because reduced-herbicide rates control weeds for a shorter period, cultivate about three to four weeks after the crop has germinated.

Rotary hoeing may or may not be necessary with this approach because the herbicide controls weeds early in the season. You should rotary hoe if it doesn't rain within a week after application, Doll advises.

If you rely entirely on herbicides, calibrate accurately and adjust your equipment to avoid applying too much herbicide. Even if you use a full-herbicide rate, says Doll, cultivation improves yields by aerating the soil and allowing better water infiltration.

"Cultivating row crops is a practice we think ought to be done annually," he says.

Nominating petitions must be returned to the West Bend FmHA County Office by Friday, May 18, 1990.

School Districts to Receive More State Aid

Assembly Speaker Tom Loftus reported today that a number of school districts in Washington County will receive more state school aids if recent legislative changes initiated by Loftus are signed into law.

Under the new formula, school districts in Washington County will receive additional funding as follows: Erin #2 - \$14,633; Germantown - \$115,466; Hartford - \$88,555; Hartford J1 - \$87,428; Kewas-

kum - \$60,981; Richfield J1 - \$31,264; Richfield J11 - \$8,412; Slinger \$90,366; West Bend - \$16,036.

"The debate over school financing reform cannot take place until we take a fundamental first step. That first step is 'truth in labeling' of state funding for public schools," Loftus said. "The equalization fund isn't what we say it is."

The state equalized aid program is the fund which provides direct property tax relief to local school districts. But there are four other programs which are now paid for from the equalization fund - minimum aid, special adjustment aid, aid for children-at-risk programs, and aid to county handicapped education boards.

Under the changes sponsored by Loftus, these four programs will be funded separately and the amount for equalized aid increased.

"Under my proposal, which was adopted by the Legislature, several programs that are growing rapidly and whose value for education and property tax relief are debatable are removed from the formula," Loftus said. "These programs will now be funded separately, but at the same level. The amount of funding in the equalization pot remains the same. The difference is that more of the money in the equalization pot will actually be used for equalized aids to all public schools."

"This is just a first step," Loftus concluded. "Bigger steps will be needed to complete the job of taking a hard look at state support of public schools."

The changes were passed by the Legislature as part of Senate Bill 542, the budget bill awaiting action by the Governor.

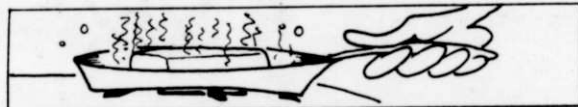

Estimated Tax Payments Due April 16

The Internal Revenue Service reminds people who make estimated tax payments that the first installment for 1990 is due Monday, April 16.

The payment should be sent to the IRS along with the first quarter payment voucher from Form 1040ES, Estimated Tax for Individuals. To be sure that the payment is properly credited to your account, the IRS asks that you write your social security number and the words, "1990 Form 1040ES" on the check.

If you're not sure whether you should be making these quarterly payments, the IRS suggests first checking your 1989 return. If the return shows a balance due of at least \$500, and if you expect your financial situation to stay pretty much the same during 1990, then you probably should be making these payments. Moonlighters and two-wage-earner households should also consider making estimates. The same goes for people who receive significant income on which no tax is withheld such as business profits, rental income, alimony, interest, dividends, capital gains, and unemployment benefits.

Form 1040ES has a worksheet which can help you figure out whether or not you need to make estimated tax payments and, if so, how much. To get this form, call toll free 1-800-424-FORM (3676). You can listen to a quick overview of this subject by calling Tele-Tax, the IRS' automated system of prerecorded tax information. Dial 1-800-554-4477 and request tape number 156.

DNR employes Tom Sheffy and Jack Sullivan team up with local fishing guides to teach the class. Get the latest scientific information on fish feeding behavior, seasonal and daily movement of fish, lake ecology, use of depth sounders, weather patterns, predator-prey relationships and the facts about conserving the fishery resource.

You'll depart the school with the know-how and confidence to catch (and release) musky and

walleye from favorite fishing spots. Anglers will put in 16-hour days, with lectures and demonstrations sandwiched between morning and evening fishing trips on Lake Tomahawk.

The class is limited to 20 anglers each session. Registration is on a first-come, first-served basis, with preference to those who register in pairs. County Park Project Started

WEST BEND — Wisconsin Conservation Corps crew member positions have been filled by eight unemployed young adults from the Washington County area.

The County Land Use and Park Department submitted a proposal this past November to sponsor a WCC crew to do a variety of conservation projects over a one year period. The proposal was approved at the WCC board meeting in February, and the projects are scheduled to begin on April 9th.

The WCC crew will construct new trails at Ridge Run Park, and Glacier Hills Park, build wheelchair access ramps at Glacier Hills Park, and begin development on the County's newest park, Heritage Trails County Park, near Slinger. Various other projects will be completed as well.

The Wisconsin Conservation Corps is a state agency which, in cooperation with sponsors such as Washington County, provides work and job training to previously unemployed young people on conservation projects around the state. Corps members are paid the Federal minimum wage of \$3.80 per hour and can participate in the corps for one year. A successful year of service qualifies WCC members for a completion bonus in the form of either an \$1,800 educational scholarship, or \$500 cash.

While the WCC pays corps members wages and supervises the crew daily work through a crew leader, Washington County will supply transportation, materials, tools, and provide general project direction.

Indian Girls Capture First Place in 39-Team Invite

OSHKOSH — Placing second to West Bend West in the Washington County Indoor meet just wasn't good enough for the Kewaskum girl's track team.

So the Indians went out and captured the top spot in the 12th Annual Titan High School Invitational Track Meet, held at Kolf Fieldhouse on the UW-Oshkosh campus, last Monday.

The meet featured girl athletes from 39 different schools across Wisconsin, from as far away as Green Bay and Wausau.

Kewaskum placed first among the 39-team field with 37 points. Edgewood was next with 30 points, while Mayville finished third with 26. The seemingly low team scores were due to the large number of schools participating.

"Because you have so many teams," Indian head coach Perry Koth said, "You're fortunate to have one or two girls even placing," much less scoring. As evidence of this, 15 out of the 39 teams didn't even score a single point.

The Indians didn't have any problems in scoring points, though, thanks to a couple of record setting performances by Melissa Braun and company. Braun set an Indian record with a 28.6 second dash in the 220 yard run, a time that was good enough to place her fourth overall.

Braun also had a hand in another record set in the 880 yard relay. She ran the first leg in the relay and combined with teammates Kristi Lubahn, Rachel Zuehlke and Kelly Korth to finish in 1:55.6, good enough for first place and another school record.

Lubahn and Braun also helped Kewaskum to a 2-3 finish in the 60 yard dash. The two timed in at 7.4 and 7.6 respectively to give the Indians a double-place in that event, their only double-place of the meet.

Senior Pam Osterbrink, coming off a very successful year in basketball, also got into the act, clearing the 5'0" mark in the high jump, which landed her a tie for second place.

The mile relay team accounted for the only other Indian points when they finished in fifth place with a time of 4:30.3.

"The girls ran really well," Koth said last week. "There were no disappointments," although he did point to a few near misses by his team.

Zuehlke was neck and neck with Michele Ehren of Luxemburg - Casco in their heat in the

440 yard dash. But Ehren nudged ahead of Zuehlke at the finish line, posting a 1:05.3 time just a fraction of a second ahead of Zuehlke. Ehren went on to finish in a tie for 5th in the event.

"They came in and she (Zuehlke) was just a step behind," Koth went on to say. "She just missed it."

Koth also pointed out Korth's effort in the long jump and Tammy Michael's leap in the triple jump also came up just short of placing. Korth jumped 15'8", just short of the sixth place finisher, Misti Schmitz of North Fond du Lac, who jumped 15'9½". Michaels also came up about a foot short of sixth place in her event.

The meet featured five of the seven Eastern Wisconsin Conference teams, with only Plymouth and Two Rivers not taking part. The next closest EW teams were Sheboygan Falls with 11 points, and New Holstein with 10 points, to place 17th and 18th, respectively. Kiel scored a ½ point to tie for 25th place, while Chilton was one of the 13 teams not to score.

New Holstein's Sherry McNamara, EW Player of the Year in girls basketball, won the shot put with a toss of 37'10", while Sheboygan Falls was paced by Lisa Hirsch, who won the two-mile run with a time of 12:26.9.

Slinger also took part and placed 9th with 20 points. The Owls were led by long-distance ace Jessie Feltz, who took first in both the 880 yard run and the mile run.
