Bicycle Safety Clinic, License Sale on June 9

Registrations are coming in fast for the Bicycle Safety Clinic on Saturday, June 9th, 9:00 -11:00 a.m. at the Kewaskum Middle School.

The clinic, co-sponsored by the Kewaskum Police Department and the GFWC Kewaskum Junior Woman's Club, is produced by Modern Woodmen of America. It is intended to encourage and instruct riders how to keep their bicycles in safe riding condition, know and obey traffic laws and regulations and follow safe riding practices.

The clinic, open to kids completing K-5th grade includes a video of major rules of safe bicycle riding, traffic laws and regulations and demonstrates appropriate riding behavior in various situations. Each bicycle will receive a safety inspection checking items including bike size appropriate to the rider, handlebars, frame. seat, spokes, chain, tires and accessories.

Members of the GFWC Kewaskum Junior Woman's Club will administer the written which safety quiz tests knowledge of hand signals for left turn, right turn and stop, riding at night, riding on the street, parts of the bike and general concepts of safe riding practices. A modified test will read to the younger be participants in the clinic.

An outdoor riding skills test, supervised by members of the Kewaskum Police Department and Kewaskum Auxiliary Police includes balancing at slow speed, braking, steering, signaling, riding in a circle and maneuvering.

All participants will receive a Certificate of Participation, a decal, spoke reflector and safety booklet. In addition, several door prizes will be awarded and refreshments served at the conclusion of the bicycle safety clinic.

Kewaskum Police Chief, Dick Knoebel has announced that

bicycle licenses will be for sale in the KMS parking lot during the bicycle safety clinic. Cost of the non-expiring license is \$5.00. According to village ordinance, all bicycles in the village require bicycle licenses. Anyone in the village wishing to purchase a bicycle license is encouraged to look for the Auxiliary Police van on that morning. You do not need to be registered for the clinic to purchase a bicycle license.

SPRING TIME IS BIKE TIME

The Kewaskum Police Department would like to take this time to remind everyone about bicycle safety and laws pertaining to them.

Wis. §346.03(9) Rules of the Road, states: "Subject to the special provisions applicable to bicycles, every person riding a bicycle upon a roadway is granted all the rights and is subject to all the duties which this chapter grants or applies to the operator of a vehicle..." In short, this means that all of the laws pertaining to motor vehicles apply to bicycles, including, but not limited to: riding on the right side of the road, abiding by all traffic signs and signals, riding single file, etc.

Also, Village of Kewaskum ordinances require that all bicycles operated on the streets of Kewaskum to have a current license affixed to them. The cost of these licenses, which are non-expiring, is \$5.00. They can be obtained at the Municipal Building between the hours of 8:00 a.m. and 4:00 p.m. It should be noted that the Kewaskum Auxiliary Police will be selling bicycle licenses on Saturday, June 9, 1990, in conjunction with the Bicycle Safety Clinic that is being cosponsored by the Kewaskum Junior Women's Club and the Kewaskum Police Department.

A few safety tips to everyone operating a bicycle are: keep your bike in good working order, wear bright colored clothing to make it easier for motorists to spot you, put a safety flag on your bike, ride single file, be aware of the area you are riding in and be ready to take evasive action if an obstacle appears and make sure the bike is the right size for the person riding it.

If we follow these rules and safety tips, we should have a safe bicycle season.

Indian Girls Win Sectional; **Advance Nine to State Meet**

ELKHORN - It's on to state for nine members of the Kewaskum girl's track team, as the Indians ran past everyone at the Class B Sectional here, last Thursday.

The Indians added another championship plaque to their ever-growing collection, as they downed 25 other schools in winning the meet. The Indians advanced nine girls in seven different events to the state meet in LaCrosse on Friday and Saturday, as well as setting three school records, and tying another two.

Kewaskum finished with a ripe total of 69, 21 more than second-place Edgerton. The significant gap is another reminder of what Indian head coach Perry Koth has been stressing all season.

"This meet once again showed just how much depth we have this year," Koth said the day after the meet, giving praise to all of the girls on the team. "We just got a great effort from everyone.

In order to advance to the state meet, individuals had to finish either first or second in the sectional. Also, individuals and relay teams with their sectional performance ranking them among the eight best out sectional all the of performances throughout the state also qualify for state. This is to insure that state-caliber athletes are not eliminated just becuase they happen to be in a tough sectional.

Melissa Braun was the beneficiary of the latter circumstance, as she finished third in both the 100 and 200 dashes. Her times of 12.6 and 25.9, respectively, were both school records, and were both among the top eight in the state, therefore allowing Braun to advance to state.

Braun was one of two Indian athletes to qualify in three different events, the other being Kristi Lubahn. Braun and Lubahn teamed up with Kelly Korth and Tina Schwartz to capture first place in the 800 relay. The foursome finished with a time of 1:48.7, just .3 ahead of runner-ups Brown Deer and Whitewater.

Koth simply termed "a great race," Lubahn combined with Rachelle Zuehlke, Laurie Vogt and Nicole Doherty to run a 4:12.4, just quick enough to beat Mayville's 4:12.8. The Indians' time also tied a decade - old school record.

'Mayville took an early lead," Koth said, summerizing the race. "Both Mayville and Waterford were ahead of us. Then Rachelle (Zuehlke) made up a lot of ground, passing the Waterford girl," he went on to say. "Then Kristi got the baton and just shot by the Mayville at the end. It was just a fantastic race.

Despite losing for the first time in the 300 hurdles, Lubahn posted a time of 46.9, breaking her own school record, and placing her second. "She didn't run a real good race," Koth said, which was somewhat surprising because of the time. 'She had a couple extra steps in between hurdles. She can do better," he added.

There were some anxious moments during the meet for Koth, but probably none more than when Tina Weddig scratched her first two throws in the discus competition. "You could say that," Koth responded when asked if that made him a bit nervous. But never fear, coach. The senior Weddig made the most of her final throw, tossing 113'7", good enough to place her second.

The biggest suprise of the meet was a pleasant one for the Indians, as junior Ingrid Ankerson jumped a school-record-tying 33'9'' to finish second in the triple jump, and qualified for state. Ankerson's effort was almost two feet longer than her previous personal best.

Ankerson also cleared the 5'0" mark in the high jump, which placed her in a tie for third. There was a bit of controversy, however, as meet officials moved up the height of the bar in increments of two WIAA inches, not the regulatory one inch.
