Action on Contract Termination Tabled

Board Asks DPI to Reconsider Their Certification Decision

Monday night's special meeting of the Kewaskum Board of Education was more like a two-hour tennis match than a meeting to resolve a difficult situation. The reason being continuous volleys back and forth between two sides, the Department of Public Instruction and the Kewaskum School District.

At issue was the DPI's decision not to extend the emergency teaching certificate of sixth grade Kewaskum Middle School teacher Robin Foerster, which expired January 25th, until the end of the school year.

On one side the DPI team of Monte Hottmann, Assistant

State Superintendent, Division for Instructional Services and Rob Gibson of the DPI's Licensing Division, serving up reasons why the DPI would not and should not continue the emergency license of Mrs. Foerster. On the other side the Kewaskum School Board, Administrators and parents of sixth grade students giving reasons why the DPI should continue the provisional license for just 90 more days, until the end of the school year.

Before the discussion got into full swing, however, State Representative Michael Lehman, who had been asked to attend the meeting, addressed the group. He expressed his concern telling both sides the issue, first of all, should not have drawn media attention. "If this had been Milwaukee, this would not have been heard or read about. This is something that should have been settled between the DPI and Kewaskum School District, instead it has become a statewide issue."

Lehman said the issue had gotten blown out of what is really best for the kids. He agreed that the DPI has rules it has to follow, but he also noted it had not been out of the ordinary for that same DPI to make exceptions to those rules. "The question is," said Lehman, "what is best for the 90 days and what is best for the students involved."

Rep. Lehman felt both Superintendent Herbert Grover and the DPI have enough authority and power to make the right decision for the students. He said the suggestion by the DPI that 25% of the district's state aide may be withheld for violation of state statutes was uncalled for. When you have to threaten communities with the loss of funding you are putting another wedge between the DPI and public, he said. Hottmann and Gibson, several times during the meeting, re-affirmed the department's decision not to extend Foerster's emergency license. Reading from the statutes and saying there was an adequate supply of qualified teachers available to fill the

position, they felt there was no reason for the district not to replace Foerster with a properly certified teacher. Hottmann told the board, 'Mr. Grover is aware of the situation and agrees with the decision.''

Several board members and parents said that certified did not necessarily mean qualified nor did qualified mean certified. One parent who addressed the meeting said Mr. Grover should listen to his own commercials, "put the children first."

Perry Board member Ankerson told Hottmann and Gibson that while he understood their position, he felt the school district, in this instance, was better able to judge Foerster's qualifications to do the job than someone in Madison. "We're not out to break any laws or defy the DPI, we're simply asking for a provisional certificate to allow a teacher to teach our sixth graders.

District Administrator Dr. David Heather told Hottmann followed the DPI's instructions in seeking a replacement for the teacher who is on medical leave." "The post was advertised, we had a candidate who, two days before school started, decided not to accept the position. The post was advertised a second time and by then the applicants had accepted other positions or did not want to teach here, so it became a real emergency. School was beginning and we needed a teacher, KMS principal David Jones then recommended Mrs. Foerster who had substituted at the

Governor Approves Kewaskum Bridges Reconstruction

Governor Tommy Thompson has approved a \$426,000 contract to replace two bridges on US 45 in the village of Kewaskum.

The contract was awarded to Lunda Construction, Inc. of Black River Falls to remove and replace the box culvert spanning a tributary of the Milwaukee River at the north village limits of Kewaskum. The contract also involved the reconstruction of approaches and the removal and replacement of the bridge spanning the west branch of the Milwaukee River, located on US 45 near the Fond du Lac and Washington county lines.

Reconstruction of the box culvert will require US 45 to be closed to traffic for about six weeks. Construction is expected to begin in July.

The second structure, a

single span, 44-foot wide bridge, will be built next to the existing one to allow traffic to remain open on US 45 Construction is expected to begin in March. Traffic may experience occasional lane closure when construction crews reconstruct and realign bridge approaches. Completion is anticipated in July.

"These new structures, with full shoulders, extended beam guard and increased load rate will improve safety and convenience for motorists traveling this important north/south route," said Robert Packee, director of the Department of Transportation's south eastern Wisconsin district, which includes Fond du Lac and Washington counties.

State transportation funds will provide all of the costs for both bridge projects.

Following a meeting last Wednesday evening, members of the Town of Farmington Plan Commission decided to hold off making any recommendations to the town board regarding plans for the luxury spa being proposed by Wes Pavalon and the Rosebush Trust.

Approximately 70 residents again appeared at the meeting noting both concerns and objections to the project.



pro-tem President John Schulte asked Hottmann and Gibson how soon the district would receive an answer on its request that the DPI reconsider its decision. "If Mr. Grover is available tomorrow I will talk to him and get back to Dr. Heather with our decision." After what you have heard tonight in support of Mrs. Foerster we sincerely hope you change your recommendation, noted Schulte.

"Until we hear from the DPI, I think we should table action on terminating Mrs. Foerster's contract and hiring a replacement," said Schulte. Schulte asked Heather, since the license had expired, where that left the district. There will be class as usual, however, Mrs. Foerster will not be teaching, noted

'The Ghost of John Wolf'

Many times in the past years as I drove on Hwy. S, near the north village limits, I saw, or imagined I saw, an old man walking on the road with a jug in his hand. Several times I turned around but when I got to the place I had seen him he had disappeared. A few times I saw him coming out of the Opera House, Saloon, always with a jug. I have always wondered if anyone else has had a similar experience in the area.

Recently I received information from Armond Schaefer of West Bend which convinced me I was not dreaming. He sent me an item from the Kewaskum Statesman of December 1896, "Died-Wolf-Monday, Dec. 7, 1896, at noon on East Water Street, John Wolf, 85 years.

"The deceased was one of the first settlers here and has always resided upon the land where he died and wished to be buried there. His wife passed away about twenty years ago. Since that time he has lived alone in a small cabin near Val Dreher and upon a parcel of land now owned by Dreher as a result of attention and care bestowed upon the deceased by Val Dreher during John's last years.'

"The old gentleman had been failing fast of late and for thirty days prior to his death he partook of no nourishment except wine, which was his favorite drink. He was cheerful to his last day. The funeral took place at 10 a.m. last Thursday with interment in a corner of the land upon which he had lived so long and wanted to be buried on. The simple burial services were conducted by friends of John with naught save charitable inclinations to direct them. The cold winter winds closed a simple Requeim as the last shovel of ground covered his grave. Good Bye, old friend, we will miss you."
