Sheriff Issues Fireworks Warning

Washington County Sheriff Robert H. Schulteis reminds residents that it is illegal to purchase, possess, or use fireworks without a permit issued by their town, city or village. These restrictions apply to firecrackers, rockets, and other devices which explode, fly, are propelled along the ground, or eject objects.

Devices which are not classified as fireworks and which can be purchased and used without restrictions are sparklers, snakes, caps, champagne party poppers, "smokers," "whistlers," punk sticks, and fountains which emit only smoke and sparks. Sparklers, however, may not be used at large public gatherings such as official fireworks displays, because of their

danger in crowded conditions.

Although cities, villages, and townships are empowered to issue permits, they are not required to do so. The permit must describe the fireworks that will be purchased, and the specific time and location that they will be used. The sheriff's department does not issue

permits.

Each summer, sheriff's deputies confiscate hundreds of dollars of illegally used fireworks, and issue \$103 county ordinance citations for violation of the fireworks laws. Additional Federal laws prohibit the possession of larger

firecrackers such as cherry bombs and M-80's. The sheriff points out that fireworks are controlled because of the risk of serious injury and fire by their misuse. The department has also prosecuted retailers who sell fireworks to persons who do not have permits.

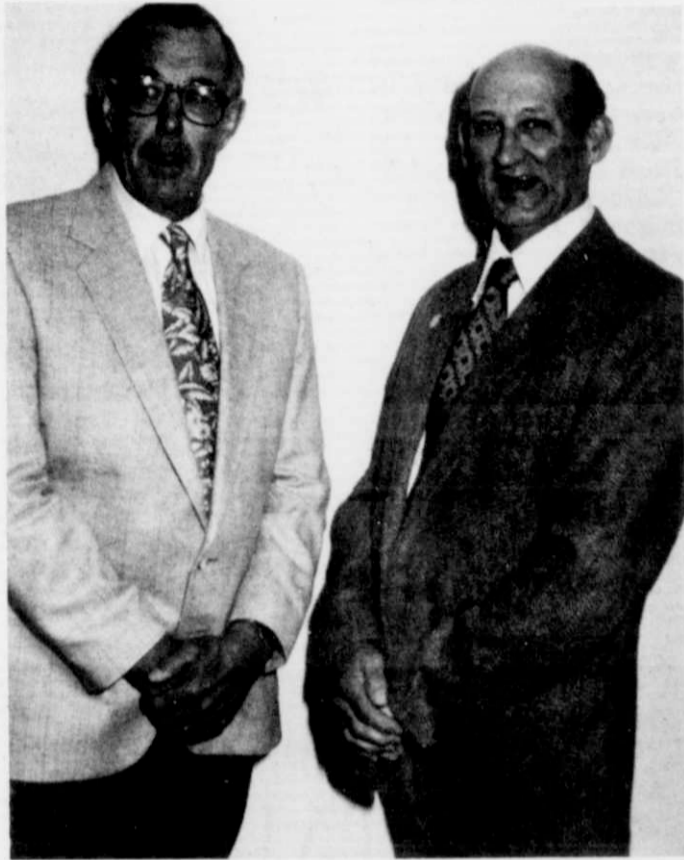

Dear Editor,

In the June 13th edition of your newspaper, you printed an article describing the initial meeting between K.A.P. and School Board representatives. After reading this account we find some discrepancies exist. We wish to take this time to clarify the topics.

As stated, the offers made were the initial proposal. We are confident that you and your readers are aware that first proposals are seldom ratified. More meetings will probably be scheduled before the final agreement is reached.

Two of the topics in your reporting discussed salary and term life insurance. To do justice, we will address each separately.

The first item discussed our salary. In the aforementioned account it was stated that K.A.P. asked for a 6.5% increase the first contract year with a 6.0% addition the second year. This is consistent with our proposal. The longevity increases as presented were a bit misleading. Your understanding may lead a reader to believe an employee with more than 20 years of service can receive an increase of 75 cents over and above contract salary agreements. This is not within the context of our records. The K.A.P. Offer accumulates the step increases so that the same employee will receive no more than a 40 cent increase. Perhaps it is best displayed in the following table.

Years of Service	Statesman Article	K.A.P. Proposal
10	\$.10	\$.10
15	\$.25	\$.15
20	\$.40	\$.15
	\$.75	\$.40

As a matter of interest, the step increase at the 10 and 15 years levels have been a custom at our schools for many years. So the only real issue is the amount for anyone with 20 years of service.

The second topic discussed our term life insurance. As stated in your newspaper we are requesting the School Board to pay 100% of the policy's premium for anyone working more than 18 1/4 hours per week. As written this is an accurate offer. However, what is missing is currently anyone working more than 20 hours per week enjoys this privilege. So we are asking for a very small change. In fact if approved this will mean an additional charge of less than \$120.00 per year.

Thank you for allowing us the opportunity to respond to your article. As in the past, we will make every effort to work with our School Board. Being employees and members of our school district, we do have a vested interest to arrive at a contract that is fair and equitable to all parties.

The role of the athletic trainer in the prevention and rehabilitation of sports injuries is the focus of "Today's Health," a presentation of the General Clinic seen on local cable television.

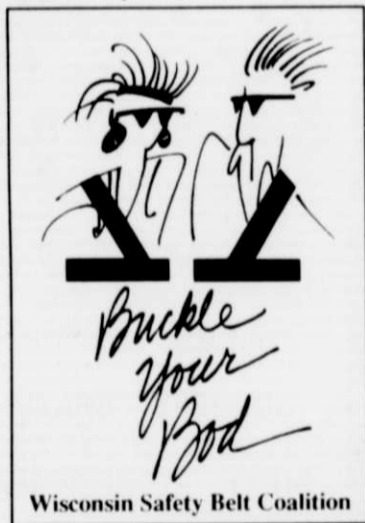

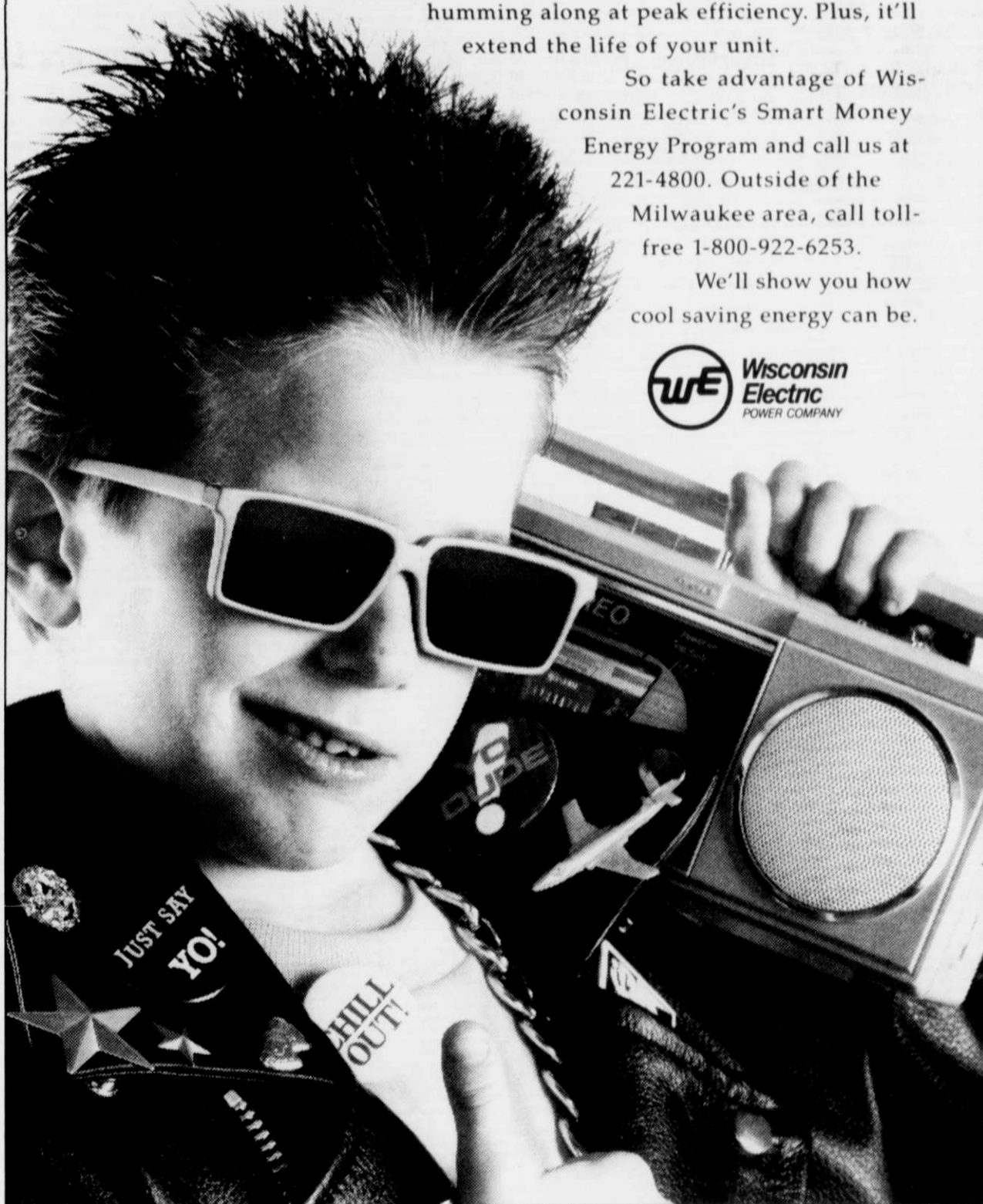

Let me relate an event from May 20, 1991. Three hundred fifty police officers and guests from law enforcement associations around the state of Wisconsin met for the annual Wisconsin Professional Police Association's convention, as they have for 59 years. During the days of the convention leading up to the banquet on the 20th, those in attendance learned of the plights of a fellow officer, Judith Baxter, and the wife of another officer, Sharon Hageny, both from Oneida County and both of whom suffer from cancer. If that is not enough for these families to bear, both will need special medical care that will cost each family about \$170,000, little of which will be covered by insurance. As police officers frequently do, the delegates at the convention rallied in support. In less than 15 minutes, from virtually every police association represented, over \$6,000 was raised to start the fundraising efforts. The

officers also dedicated themselves to continue this support.

The first thing that comes to mind is they are watching out for their own; and while that's true, it's not the whole story. Every year local police associations and the state association raise thousands of dollars for charities such as Boy Scouts, Girl Scouts, Explorer and Eagle Scouts, Big Brothers, Big Sisters, Special Olympics, Children's Trust Fund - the list goes on and on. Officers give not only money, but personal time away from their own families in an effort to help those who need help the most. Pressure Canner Testing Clinic

The canning season is again upon us here in Washington County, and whether you are an avid canner or a beginner, the time is now to check your gauge for safety and accuracy. Quality of the finished product (low-acid fruits, meats, vegetables, poultry, fish and other non-acid foods) depends on the condition of the pressure canner used for processing.

Pressure canner dial gauges should be checked each year. However, canners should be tested if (1) you do a lot of canning, (2) the lid has been dropped or submerged in water, (3) the gauge glass is cracked, or (4) if any parts are rusty. In addition, gauges should be replaced if they are more than 3-4 pounds "off."

Replacement of rubber or combination gasket seals may be necessary if they have dried and shrunk. This causes an incomplete seal and allows steam to escape. Metal-to-metal should be kept free of rust and corrosion by polishing with a non-abrasive cleaner and coating with a thin layer of petroleum jelly. Lime deposits can be removed from safety valves by using a pipe cleaner and vinegar. These areas, kept clean and dry, will enhance the performance of the canner and maintain the safety of the product.

The Washington County Extension Office is offering **Pressure Canner Testing and Inspection** to ensure safety and performance for hours of healthful canning this summer. Jan Felthous, Summer Home Economist, will be available at the following times to test gauges and answer questions. Bring your canner lid and gauge to one of the four locations.

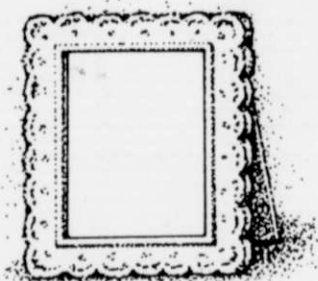

TODAY'S AGRICULTURE 25 Years Ago

Controlling Noxious Weeds

Weeds cause problems in many areas, whether it be farm fields, gardens or lawns. A great deal of effort and expense is involved with keeping weeds under control.

The State of Wisconsin has defined some weeds as noxious and have developed laws in an attempt to control them. By definition, noxious means harmful so in a general sense all weeds are noxious. However, the State Legislature has declared only three perennial weeds to be legally noxious in Wisconsin. These are Canada thistle, field bindweed and leafy spurge. The law is open ended in that any other species can be declared noxious if any governing body of any municipality or the county board of any county by ordinance or resolution declares to be noxious within its respective boundary.

The law also provides a method to try and control these noxious weeds. The law states that the chairman of each town, the president of each village and the mayor of each city, shall appoint one or more commissioners of noxious weeds. Every person shall destroy all noxious weeds on all lands which he shall own, occupy or control. The term **destroy** means the complete killing of weeds or the killing of weed plants above the surface of the ground by the use of chemicals, cutting, tillage, cropping system, pasturing livestock, or any, or all of these in effective combination, at such time and in such manner as will effectively prevent such plants from maturing to the bloom or flower stage.

It's important to recognize that the law is not effectively enforced. Each year many units of government will print the legal notice in the newspaper to property owners reminding them to control noxious weeds. Unless significant complaints are registered against property owners action is usually not taken to enforce the law.

It's easy to understand why we have not been able to eradicate the three official noxious weeds by passing the noxious weed law. This doesn't mean that the law has not been effective. It does call attention

to the importance of these weeds and it certainly has been useful in limiting their growth and spread. It also provides an awareness to people who may have these weeds on their property and the importance of keeping them under control. If uncontrolled they can continue to spread and cause further problems.

Wisconsin also has a nuisance weeds law. This includes any non-native member of the genus *Lythrum* (purple loosestrife) or hybrids thereof and multiflora rose. This law prohibits, selling, distributing, or planting nuisance plants or seeds of these species in Wisconsin.

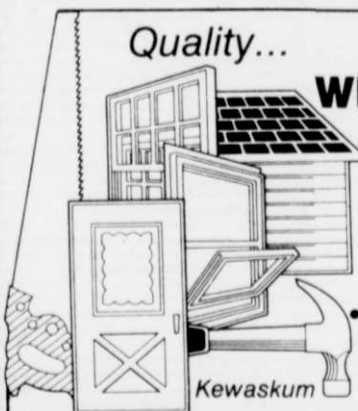
In the opener, Thelen's Construction was a little short handed, as Ike's Repair Shop won all four games, 15-0, 15-0, 15-0, and 15-0.

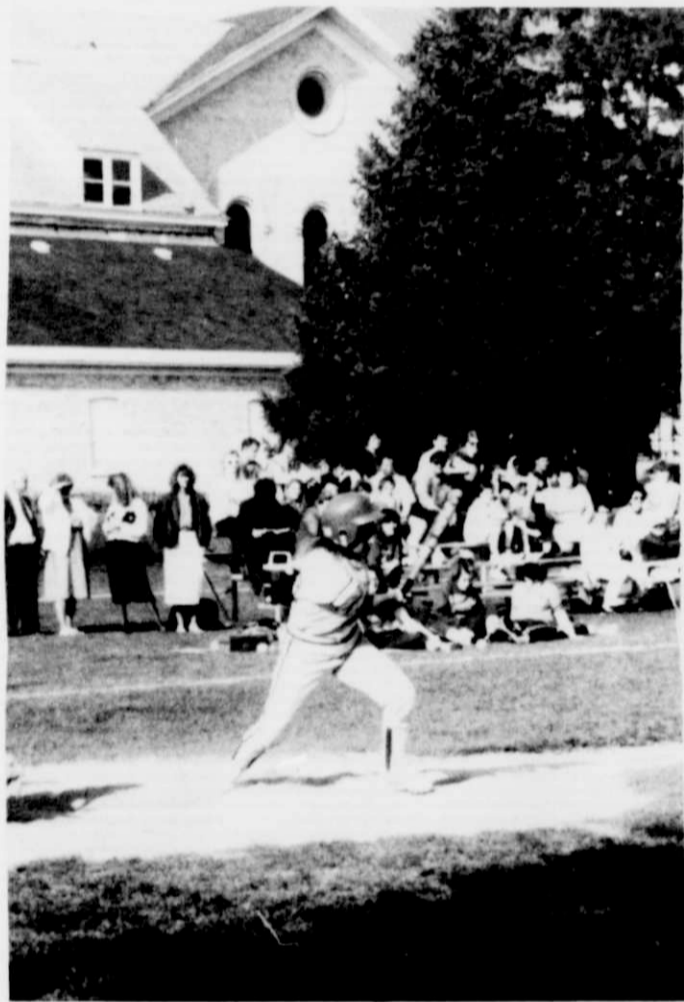
Renee Kapp is Member of Marian College Softball Team
