Failing Septic Owner Seeking Village's Sewer Service

## Board Ok's Rezoning of Industrial Park Parcel for Condominiums

Following the public hearing Monday night, the Kewaskum Village Board approved the rezoning of a parcel of land on the west side of Wildlife Drive in the former industrial park from M-1, light manufacturing, to R-4 multiple family residence district.

Purchasers of the property, Mr. and Mrs. John D. McElhatton, Robert McElhatton and Geryl Hoppe, are planning to construct an eight-unit condominium complex on the site.

The trustees also approved a resolution to proceed with the village's offer to purchase the Melvin Thompkins property, consisting of 5.22 acres of land, south of the Municipal Garage.

The purchase covers the former trailer park property less the Thompkins residence. Some of the land will be targeted for future needs in expanding the wastewater treatment and recycling facilities. There are, however, no immediate plans for any expansion.

The board also reviewed a letter from the village's engineers regarding an order sent to Kewaskum Frozen Foods for the installation of a grease trap.

Company co-owner David Nigh was present at the meeting and admitted there have been some problems with grease occasionally getting into the sewer. Nigh told the board, "we have instituted some in-house things that should improve the situation."

Nigh said some of the reasons for the grease problem had been overlooked. He said the firm felt one of the bigger sources of the grease came from cooking meats for some of its sausage products. "Before, we strained that liquid and then disposed of it," said Nigh, "but apparently that wasn't getting all the grease." "Now we cool the water down with ice and skim the hardened grease off and we feel this will make a big improvement."

Nigh told the board that the company had also ordered a 'flow meter' which would allow for testing.

Water Pollution Control Superintendent Pete Albers said his department has been monitoring the manhole, checking it two to three times a week. He noted there had been a couple more instances of grease, however, things have

improved over the last few weeks.

Nigh said his company would continue to work with the village in reducing the problem. The board voted to table enforcement of the grease trap order for three months until installation of the flow meter and sufficient testing for fats could be done.

Albers was asked by Trustee Gary Gavin if anyone else was contributing to the problem. Albers replied "any restaurant and household which dumps grease down their drains."

Albers told the board it all adds up. "We've probably got a foot-thick layer on the walls of the main lift station and I don't know how we're going to clean it out except to shut down the whole sewer system and have someone go down there and scrape it off."

During the review of correspondence, Village Administrator Dan Schmidt informed the trustees the village had received an inquiry from Dr. Charles Ogi, whose residence is in the Town of Kewaskum, regarding the possibility of being hooked up to the village's sewer system.

Ogi indicated, because of a failing septic system, he wants to hook up to the village's sewer system. He did not, however, wish to be annexed to the village. If the village did not go along with that idea, then he would seek annexation to the village but he did not want Edgewood Road extended in order to obtain that service.

Ogi has been having septic problems for about a year with fluids from his system running down into a lot adjacent to the Ogi property which is in the village limits. Both the village and county have received complaints about the situation. One neighbor complained to the village saying he was tired of putting up with the smell.

Schmidt said Ogi has been ordered by the county to correct the situation and has been cited (fined) three times, for non-compliance.

Schmidt was asked why Dr. Ogi was making these exceptions. Apparently because of the cost involved, noted Schmidt. Board president Mary Krueger said she could see no reason to make any exceptions, other individuals petitioning for annexation have complied. "We haven't done it (made exceptions) before for other individuals, I don't think we should start now."

## Lions to Host Annual Kettle 20, Chicken Bar-B-Q Sunday

Get your running shoes ready because its time once again to face on foot the rugged hills and gorgeous terrain of the Kettle Moraine State Forest, as competitors from across Wisconsin, neighboring states, and Canada converge in Kewaskum for the Kettle 20+2 race.

The 20 kilometer event (12.4 miles) will be accompanied by two easier runs — 3.5 and 5 miles, and will include various men's and women's divisions. The event is sponsored by the Kewaskum Lion's Club and is held in conjunction with the annual chicken bar-b-que at River Hill Park on Sunday, August 11. The race begins at 9 a.m. at the Park, located along the Milwaukee River. Registration begins at 8 a.m. (in advance) up until race time.

Divisions for the Kettle 20 are as follows: six men's age groups 1-17, 18-29, 30-39, 40-49, 50-59, and 60 and over; four women's age groups 1-17, 18-29, 30-39, and 40 and over. Top male and female runners will each receive a trophy, followed by medals for second and third place, and ribbons for fourth and fifth. The two small races will offer awards to the top place winners.

Entry fee for all races is \$8 with a t-shirt, and \$6 without.

vote to deny the request, Schmidt suggested the issue be placed on the next agenda for formal action then. "I don't know why we can't vote right now," said Gavin, "we all agree that we will deny the request." Schmidt noted to avoid any legal problems it would be better to put the request on the agenda. Krueger told Schmidt he should then advise Ogi that it was the unanimous consensus of the board that it would deny the request.

Schmidt was asked what other options Ogi would have if he refused to be annexed according to village standards. Then he will probably have to install a holding system.

In other action the board approved the installation of a catch basin and storm sewer line in Riverview Drive, in conjunction with the Highway S resurfacing project being done by the county.

Schmidt advised the board, "if we don't do it now, the county will not issue us a permit to cut the road open for another five years."

The board then adjourned to closed session.

"We're expecting about 80 or 90 runners to pre-register," says race chairman Dale Squier of Kewaskum. "On the day of the race, another 80 usually sign up." Racers enjoy coming back year after year to the Kettle 20+2, both for the challenge and a glimpse of the rugged landscape touched by Wisconsin Glaciers thousands of years ago.

All runners have the advantage of purchasing their chicken dinners for the special price of \$3.00 each, but must apply for their tickets before the race begins to receive the special price.

There will be water stops along the way and showers will be available at the Kewaskum Middle School.

Chicken dinners will be served throughout the day, beginning at 11 a.m. and running til 4 p.m. Cost is \$5.00 for one-half chicken and \$4.50 for one-quarter chicken plate,

complete with mashed potatoes, vegetables and salad. Carryouts will be available.

This year, an entirely new feature has been added for everyone's enjoyment - a Volleyball Tournament. There will be four teams competing at 11 a.m. at the north end of the park.

Whether you're there to cheer on the runners, compete in the race, or enjoy the food, don't miss the popular Eddie Schneider and his music. Beer, soda, hamburgers, ice-cream and other refreshments will be available at the park.

Proceeds from this annual event are used for local "Lions" community service projects, with an emphasis on the Quest program, a drug and alcohol educational project in the Kewaskum School District.

## Legislator Seeking State Moratorium On Incinerator Construction

State Senator Charles Chvala (D), of Madison is sponsoring a bill which would impose a two-year moratorium on the construction of any incinerators in Wisconsin.

Chvala is hoping Senate Bill 186, which cleared the Committee on Urban Affairs, Environmental Resources and Elections last week, will get the Department of Natural Resources moving to set up uniform standards and guidelines, including pollution control permits, for the construction of future refuse incinerators throughout the state.

Chvala indicated his purpose in sponsoring the bill is to help state taxpayers avoid having to pay for costly projects which do not work. He was referring to southwestern Wisconsin where taxpayers in Grant, Richland, and Iowa Counties are paying for an incinerator built in Muschoda during the 1980's. That facility was shut down after eighteen months of trouble-plaquet operation.

A spokesperson for State Senator Carol Buettner's office said the bill still has a long way

to go. SB 186 will go to the full Senate in October and then on to the Assembly.

Buettner's office said a similar bill has already been vetoed by Governor Thompson.

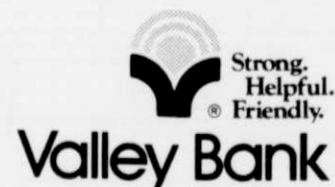

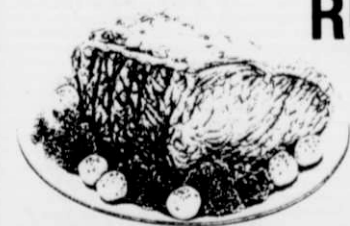

will establish the status of the offender. If it is the first offense, the citation will be issued along with information explaining the Alternative Assessment program. The first time offender will have the option of undergoing an assessment and complying with any recommendations made by the assessment staff at the Council. This may include an alcohol and drug education program provided by the Council, with mandatory parental participation. Other recommendations might be follow-up treatment and/or enrollment in a Student Assistance Program. Compliance with the Alternative Assessment Program allows the offender to waive the fine imposed for the offense and keeps the citation off the individual's record. The cost of the program is \$50.00.

If an individual chooses not to comply with the Alternative Assessment Program, he/she will forfeit the imposed fine, face suspension of driving privileges, and participate in a supervised work program. The offender will also most likely face increased auto insurance premiums.

"The Alternative program is designed to give kids the opportunity to look at their behavior," said Tom Jones, Council Prevention Specialist. "Our goal is to give parents and kids an understanding about making healthy decisions."

September 1st is the target date for the program's implementation.

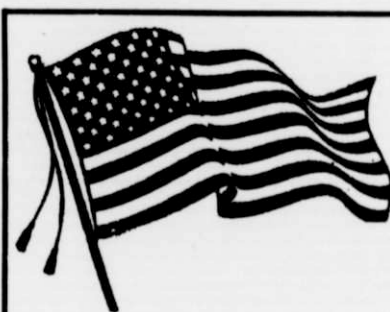

We are currently TRYING to sell our property, on Auburn Lake in the Town of Auburn, to the Department of Natural Resources. We had offered the property to the DNR in response to an ad placed by them, requesting the purchase of lake property to install a handicapped fishing access. We feel it would be a great benefit to the public (handicapped included) to have access to this lake.

To our disappointment we are facing opposition from a few people in the Town of Auburn and a couple of it's board members. Because of their protests, the DNR is having reservations about purchasing the property. It was always my understanding that a property owner has the right to sell his or her property to whoever they wish, and also that a lake is owned by the public. These few people feel that the public and it's handicapped do not have the right to access this lake. I'm sorry, but this type of action is simply outrageous!

If the DNR does not purchase the property, the current boat launching will be closed permanently. There are absolutely no deeds that contain the rights to a lake access through our property. The tax payers of the Town of Auburn should also be aware of who is paying for the lawyer that is representing the Township in this protest. I do not feel that my tax money should be used to fund a protest against a perfectly legitimate matter.

In closing, I'd like to present several challenges. First, I challenge the DNR to stand up for the rights of the public and not for a few misguided individuals. Secondly, I ask the people who support a public access to Auburn Lake, to call or write the DNR and express your opinions. Thirdly, I ask the people who do not want a public (handicapped) access to this PUBLIC lake, to try to understand the meaning of freedom and equal rights.

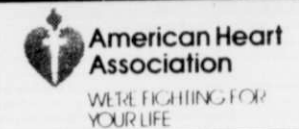

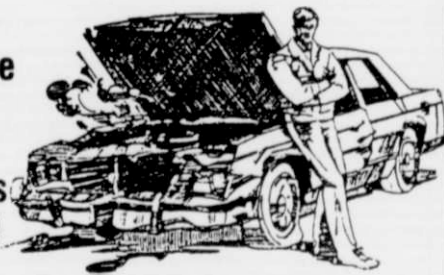

## Dear Dr. Sylvia,

I've heard that you recommend using time-out as a punishment. My husband and I have tried it, but it doesn't seem to work. Our 7-year-old son slams the door and walks in and out of his room and talks back to us. I find myself losing my temper at him and my husband gets completely out of control, so then I want to protect my son from my husband's temper. Very Angry Mom and Dad

Dear Mom and Dad,

Your son sounds very much too powerful, and time-out will clearly help you. Here are the rules for time-out that really work with such powerful children. Notice also what parents tend to do wrong. My radio listeners and my clients assure me that these rules have permitted them to take charge again. I know they'll work for you and your spouse as well.

### Recipe For Successful Time-Outs\*

[Follow Exactly]

1. All adults (parents, aunts, uncles, grandparents) must

follow the same rules.

2. One adult tells the child briefly (2 sentences or less) that the consequence for specific enumerated naughty behaviors will be to say in his/her room for ten minutes of quiet with the door closed.

3. The naughty behaviors should be specified. Don't select all, just the worst (e.g., hitting, temper tantrums, talking back to parents).

4. If the child is likely to open the door when it's closed, arrange it so the door can be locked from the outside. For most powerful children some kind of lock is required, at least initially.

5. For the first and every time the child misbehaves in the stated way, the child should be escorted to the room without the parent losing his/her temper and without giving any further explanation beyond one sentence.

6. If the child slams the door, loses his or her temper, bangs on walls, throws toys, screams, shouts, or talks, there is to be absolutely no response from anyone. Expect the first few times to be terrible. Remember, absolutely NO response from

anyone.

7. Set the timer only when the child is quiet (not screaming, tantruming or using disrespectful language).

8. After ten minutes, open the door to permit the child to leave. There should be no further explanation or apology or warning or discussion of love. Act as if nothing unusual has happened. **DON'T HUG!**

9. Repeat as necessary.

10. After one week, only a warning of the closed door should be necessary to prevent the undesirable behavior.

11. You may use "time-out" for warning purposes. Give only one warning. **ALWAYS** follow through.

12. Your child will become calmer, appear more secure and be much better behaved.

### MISTAKES FOR TIME-OUTS

Some readers will say, "I've tried time-out. Everyone knows about time-out. It just doesn't work." It's really true that most parents have tried time-out in one form or another, but hardly ever do they follow the exact instructions. Some mistakes that parents make in using time-out follow:

1. They permit children to time themselves out, in which case they will often slam the door. Parents respond by telling them not to slam the door. In

that way, children recognize that they're powerful, more powerful than parents, and they continue to slam the door.

2. Sometimes parents will make the mistake of talking to children when they call out and ask how much more time they have. Parents may actually start arguing with them. The conversation cancels the effect of withdrawn attention.

3. Some parents are hesitant about locking the door and will stand holding the door closed. The child knows that the parent is holding the door; thus, the power struggle continues.

4. Sometimes after children have thrown things around their room, parents insist that they go back to pick up what they have thrown around. Another power struggle ensues in which case children are in charge of the parent by argument again.

5. Sometimes parents use time-out only after they've yelled and screamed and lost their temper. That's too late. It has to be executed calmly, as if parents are in charge.

These tips will help you with your powerful son. As he learns to respect you and be guided by you, you'll find that you'll not need locks or temper. He'll accept your limits most of the time.

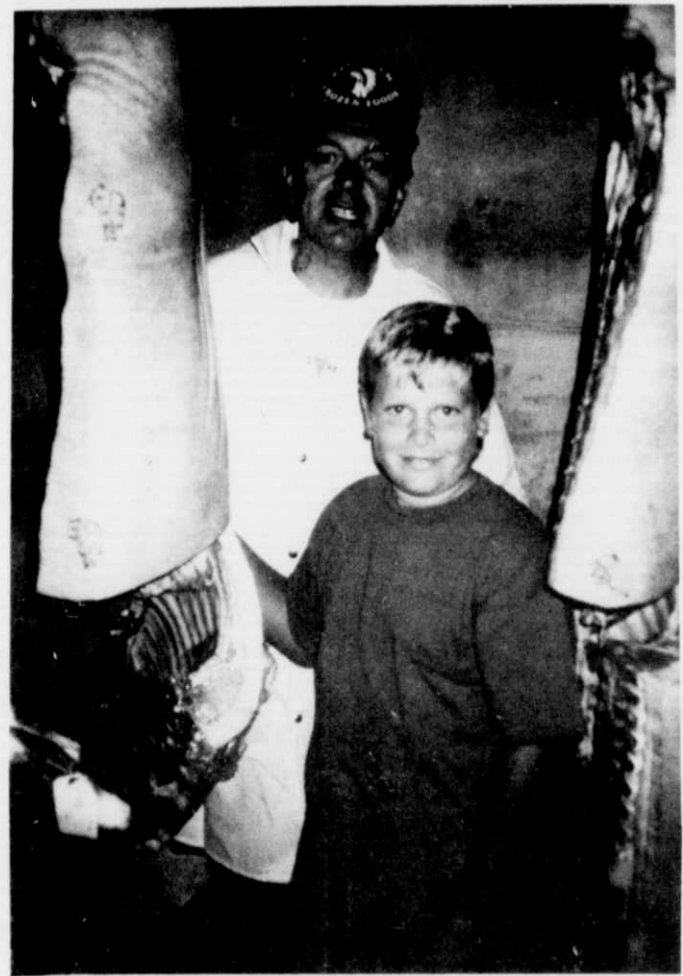

KEWASKUM — Although it was unable to wrap up a second straight Eastern Wisconsin baseball crown this summer, the Kewaskum squad did have the honor of having a pair of players make the first team all-conference squad, and also had the loop's best hitter.

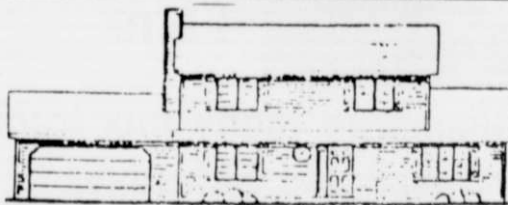
