## **Board Names New High School Principal**



#### **Charles Heidner**

The Kewaskum Board of Education, Monday night, unanimously voted to hire Charles Heidner as the new Kewaskum High School principal.

Heidner has been employed as the assistant principal at Oshkosh West High School, which has a population of 1,300 students, for the past three years. Prior to that, he and his family resided in Two Rivers for nineteen years where he taught Social Studies at Two Rivers High School. Heidner is a graduate of Carroll College. He also has a Masters Degree in Adminstrative Leadership from

UW-Milwaukee.

The board approved a two-year contract to Heidner, with a starting salary of \$53,500 plus benefits for the 1991-92 school year, plus \$2,000 for moving expenses. His first-year salary will be pro-rated, based on a 240-day schedule.

Because Heidner has not been officially released from his current contract with Oshkosh. he was not able to give the board a firm starting date. Heidner said the Oshkosh Board of Education was meeting Wednesday evening and he hoped to have an answer on his release by Thursday morning.

In a brief interview Heidner said he was excited to be here

and looked forward to assuming the duties of his new position. Heidner noted one of his responsibilities at Oshkosh was discipline. It was one of my major duties, he said. "I believe in being fair, progressive and consistent in that area." stated Heidner.

Heidner is married and has two children. His wife is employed as a mortgage lender with an Oshkosh bank. His daughter is a middle school teacher in the Milwaukee area and his son is studying Aero Space Engineering at the University of Minnesota.

Heidner is replacing Leroy Kopecky who resigned last month to accept the position of director of Instruction with the Waupun School District. Kopecky's salary at the time of his resignation was \$46,064.

District Administrator Dr. David Heather said the district had received 24 inquiries on the principal's post and interviewed four candidates before making a final selection.

Heather said the board would now begin interviewing for a new assistant principal to replace James Connell who also resigned to accept a principal's position to Grant County.

Heather said he hoped Heidner would be on staff by the time the board began interviewing for that position. "I would, very much, like to have Mr. Heidner a part of that selection process," said Heather.

## School District to Welcome Back Students Monday, Aug. 26

Monday, August 26 is the first day of school for returning and new students of the Kewaskum School District.

Parents and guardians should by this time have received information on bus rules and pick-up times. If you have not please call the Johnson Bus Company at 626-4414 to complete arrangements.

We ask that families take time to review the bus riding rules and safe boarding, riding and unloading procedures. If this is your child's first experience at riding on a bus, why not take some time to accompany him/her or arrange for someone else to accompany him/her for their first pick-up and drop-off?

Also, please be aware of the times crossing guards are present on village street corners and utilize them accordingly. Please do not send or drop your children off at school before the school doors open because they will be unsupervised.

Information for those interested and eligible for the free and reduced hot lunch program is also published in the Statesman. Middle school and high school students also received copies during registration. Forms will again be given to elementary students (one per family) during the first week of school. If you did not receive one or wish to review the qualifying criteria, please call the business office at 626-8427.

Hot lunch prices for the 1991-92 school year are as follows: elementary schools \$1.10 per day or \$5.00 per week, high school \$1.25 per day or \$5.50 per week. School on Monday is a full day and hot lunch will be served. The calendar for the school year has been published and each family will receive one at registration. Extra calendars are available for purchase at the business office. The school district does not carry accident insurance for students. We therefore urge parents/guardians to review their own policies to be certain coverage is adequate. Particularly in the case of athletics, this is a necessity. The schools do have insurance forms provided by Student Assurance Company of Stillwater, Minnesota available to parents who would like to purchase additional insurance or insurance for their children. The parents purchase the insurance on their own - the district is not involved in the sale of insurance. The buildings and grounds are in good shape and the classrooms are clean and ready

for students. All is in readiness and all are anxious to greet the children and begin anew.

Many teachers have attended various courses, workshops and seminars over the summer to improve their educational skills. Administrative staff worked to hire new staff and arrange schedules, discuss goals and establish a vision for the district.

Most important to us will be the continued support and involvement of parents, grandparents, guardians and community members at large. Please take the time to review school handbooks and rules with your children, help them with their homework, call their teachers or principals, and visit their schools. You are important and we need your assistance.

Hints for a successful start to the 1991-92 school year include the following: Be positive about the teacher(s) your child(ren) has/have and the programs available; be interested in what is happening on a daily basis; encourage participation in extra-curricular activities; set goals that are high enough yet realistic; and set aside some time to talk to your child/children.

On a 5-1 vote, the Kewaskum Board of Education has voted to approve girls softball as a regular interscholastic sport for the 1991-92 school year.

District Administrator Dr. David Heather told the board response to the sport the past season had been excellent and the team had met with some success considering the sport had been instituted on a trial basis. Approximately 29 girls participated during that trial season.

While the team needs uniforms, Heather noted that item is not a top priority. Some of the necessary equipment had already been purchased during the past season, said Heather.

Depending upon how many coaches are used, that cost would run between \$2,000 and \$3,500. Heather said that money would come from extra curricular salaries "and The Athletic Department budget will have to come up with the rest of the expense money to operate the program, said Heather.

Board member Ron Beimborn asked Heather how adding girls softball affected the equity between girls and boys sports. "We would now have eight for the girls and nine for boys,' stated Heather.

In other sports related action. the board approved the hiring of Al Brunke and Russ Freeman as assistant football coaches for 1991, and Janet Molebash as an assistant Volleyball coach.

The board again heard a request from the parents of three Kewaskum Elementary School fifth grade students asking that their children be allowed to remain at KES for the 91-92 school year. The three were among several students who are being shifted to the Wayne School as a result of the

be simulated with precise motions, weights and positions required for a particular task. It allows the therapist to set up a comprehensive therapy program which might include upper extremity rehabilitation, back treatment, cardiac conditioning, stroke rehabilitation, sports medicine and work reconditioning. If a patient has been injured on the job, the BTE can assist the worker to return to the work place quickly through conditioning exercises, duplicating the movements and stresses encountered on the job site. For this reason the BTE is often incorporated as part of the treatment in Work Hardening. Work Hardening is a highly structured, goal oriented, individualized treatment program that allows the transition from acute care to return to work. Use of the BTE may be part of this process.

Using the BTE is Timothy N Save. Klitzman is a client of St. Joseph's Work Hardening for KHS Musical program following a work related back injury. The BTE allows the therapist, Pat Waters, O.T.R., to control the amount of weight the client lifts as he is instructed in proper lifting techniques. The BTE, with its companion computer software program, records patient progress in meaningful units of measure, producing objective data which doctors, therapists, employers

and insurance carriers can rely on to determine the extent of an injury and the progress gained during the therapy program.

St. Joseph's Community Hospital recently sent Pat Water, O.T.R. to the manufacturer in Baltimore, Maryland to learn more about the various abilities of the BTE. Mrs. Waters reaction to the BTE is very positive. "I'm excited about the opportunity to enhance our patient's therapy program. This is a progressive state-of-the-art instrument that provides additional evaluation and treatment options."

Ken Schiller, Rehabilitation Services Director at St. Joseph's added, "This equipment will help in the hospital's effort to offer continued quality and 2. of care to the West Bend community and surrounding areas.

### Young Man Drowns In Lake Lenwood

A 20-year-old West Bend man drowned early Saturday in Lake Lenwood in the Town of Barton when the canoe he was in overturned, reported the Washington County Sheriff's Department.


John Gross, 706 Jefferson St., was pronounced dead at St. Joseph's Community Hospital, West Bend.

According to the Sheriff's Department, deputies were called to Lake Lenwood to investigate a possible drowning at about 12:10 a.m. The West Bend Fire Department Rescue Squad assisted the deputies, and found Gross' body in about 15 feet of water one hour later.

Gross and another 20-yearold West Bend man were 75 to 100 feet from the north shore of the lake when the canoe tipped, throwing both men in the water. The other man swam to shore.

The men were at a friend's house when they decided to take the canoe out on the lake. It is not known what caused the canoe to overturn.

Tests will be performed to determine if alcohol or drugs were a factor in the drowning.

## Clogging — Fun for the Whole Family

Clogging is a true American folk dance whose roots are buried deep in the heart of the Appalachian Mountains. The word "clog" is a Gaelic word meaning time. Clog dancing is "time" dancing with the heel being the time keeper. Cloggers wear double taps on their toes and heels which produce the double sound.

The steps performed by cloggers are combinations of eight basic toe and heel movements of the dance. Cloggers learn routines to all types of music from 50's numbers like "Old Time Rock and Roll" to the modern sounds of "Cover Girl" and "Locomotion" to the sounds of Country -Western music such as "Get Back to the Country" and "Louisiana Saturday Night."

Clogging routines can be done as solos, duets, or they may be done in lines as line dances where no partner is necessary. This is one type of dance when a partner is **not** a requirement.

Clogging is fun. It's challenging. It's healthful. People of all ages can clog from small children to senior citizens. It's a great activity that a whole family can enjoy together.

#### KOREAN WAR VETERANS MEMORIAL ASSOCIATION OF WISCONSIN, INC.

#### **Managing Editor:**

At a time when our nation seems to be revitalized by a spirit of patriotism; when yellow ribbons and flags bespeak a renewed faith in our democracy; when our collective conscience seems to have come to terms with an unpopular war and the courageous men and women who fought in it, we cannot forget the brave who have made great sacrifices for their country in Korea.

It has been 38 years since the end of the 38 month war in Korea protecting the 38th Parallel, and a memorial in Wisconsin for those who served is long overdue.

In the spring of 1987, a group of Wisconsin Korean Veterans came together to establish an organization dedicated for the purpose to have a monument built honoring the men and women of Wisconsin who served their country during the

Korean War.

A site has been chosen, and working plans have been designed by Wisconsin artist Joseph Mendla, and accepted committee. by the The Wisconsin Department Transportation has granted land for the construction of this monument. Enclosed is a complete description of the memorial.

Thanks to the many generous contributions, approximately one-third of the goal has been received. Financial support is still needed to fulfill the dreams of this memorial.

With a contribution to the Korean War Veterans Memorial Association of Wisconsin, additional gifts will join those from many others who have been inspired by this unique tribute to America's heroes.

#### KOREAN WAR MEMORIAL

The Korean Veterans' War Memorial will be located adjacent to State Wayside #81, located on the southbound lane (west side) of U.S. Highway 51, (The Korean Veterans Memorial Highway), between the towns of Coloma and Westfield.

The Memorial will sit on a wooded knoll just below Liberty Bluff, to the right of the wayside building and will sit on a 40 foot base. The Memorial is composed of a circular wall, open at the front, then slowly rising on both sides to the highest point at it's rear, from one foot to ten feet. There will be four flag poles placed around the wall at equal distance's and height. On these flag poles will fly the U.S. Flag, the U.N. Flag, The Korean Flag, and the flag of the State of Wisconsin. Inside the wall is an eight foot wide walkway, with six stone benches, one for each year U.N. Troops were in Korea: 1950, 1951, 1952, 1953, 1954, and 1955. At the front of the walkway will be a pathway leading to and from the Memorial. Just above the place where the walkway and pathway come together a four foot round bronze plaque will cover a Time Capsule. The Time Capsule will hold momentos of the Korean War and the building of the Memorial. The Plaque will simply say "HONORING WISCONSIN'S KOREAN VETERANS", and shows our state with U.S. Highway 51 marked on it. In the center of the Memorial will be a disk in the shape of the State of Wisconsin, made of native red granite. On this disk will stand the Memorial Statuary. On the back wall of the Memorial will be inscribed the following:

27 July 1953 25 June 1950 KOREA DEDICATED TO THOSE WHO SERVED WISCONSIN'S PARTICIPANTS - 132,000 CASUALTIES - 4286 KILLED IN ACTION - 801 PRISONERS OF WAR - 111 **MISSING IN ACTION - 84** 

The Memorial's main statuary is composed of five larger than life figures. A Nurse leads the group, because without the dedication, compassion, and bravery of the Medics, many would not have returned. Following the Nurse is an Army and Marine Infantryman, because the Infantryman bears the brunt of battle. Then comes an Air Force Pilot and a Sailor, without whose support the battle would have soon been lost. The statues face East, because Korea is in the Far East, and in memory of all who lost their lives, and those still missing in action. All five figures are touching, touching in a Brotherhood that comes of battle. There are no weapons on the memorial, this is to confirm the Veterans' wish for peace. The five figures together are in memory of all veterans who served our State.





## National School Lunch Program Family Eligibility

The School District of Kewaskum has announced its policy for children unable to pay the full price of meals served under the National School Lunch Program. Each school office and the central office has a copy of the policy, which may be reviewed by an interested party

The attached household size and income criteria will be used for determining eligibility. Children from families whose annual income is at or below the levels shown are eligible for free and reduced price meals.

Application forms are being sent to all homes with a notice to parents or guardians. To apply for free or reduced price meals, households must fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials. Applications may be submitted at any time during the year.

For the school officials to determine eligibility the household must provide the following information listed on the application: Names of all household members; social security numbers of all adult household members or a notation that the household member does not possess one; total household income must be listed by the amount received by each household member receiving income and the type of income it is (such as wages, child support, etc.) or a food stamp case number if the household is on food stamps; and the signature of an adult household member certifying that the information provided is correct. Households are required to report increases in household income of over \$50 per month or \$600 per year and decreases in household size.

Under the provisions of the free and reduced price meal policy, the District Administrator will review applications and determine eligibility. If a parent or guardian is dissatisfied with the ruling of the official, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent/guardian wishes to make a formal appeal, he/she may make a request either orally or in writing to: Mr. Neal Weare, Board President, W1065 Auburn-Ashford Drive, Campbellsport, WI 53010, 626-2732. If a hearing is needed to appeal the decision, the policy contains an outline of the hearing procedure.

If a household member becomes unemployed or if the household size changes, the family should contact the school. Such changes may make the household eligible for reduced price meals, or for additional benefits such as free meals if the household income falls at or below the levels shown above and they may apply at that time.

In certain cases foster children are also eligible for these benefits. If a household has foster children living with them and wishes to apply for such meals for them, the household should complete an application for a family of one or contact the school for more information.

The information provided by the household on the application is confidential and will be used only for purposes of determining eligibility and verifying data.

In the operation of the child feeding programs, no child will be discriminated against because of race, color, sex, national origin, age, or handicap. If any member of a household believes they have been discriminated against, they should write immediately to the Secretary of Agriculture, Washington, D.C. 20250.

## **OFFICIAL NOTICE NEGOTIATIONS-PERSONNEL COMMITTEE MEETING**

The Kewaskum School Board's Negotiating Committee will meet with the KEA on Wednesday, August 21, 1991 at 5:00 p.m. in the Kewaskum High School Library.

The purpose of the meeting will be to continue discussion towards negotiating a successor contract.

The meeting is closed to the public in conformance with Wisconsin State Statute 19.85(1) (e). "Deliberating or negotiating the purchasing of public properties, the investing of public funds or conducting other specified public business, whenever competitive or bargaining reasons require a closed session.

2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant

3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.

4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction

5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be referred directly to the State Superintendent of Public Instruction.

## Recreational Vessel User Fee for Boats

Recently I have received questions on the U.S. Coast Guard Recreational Vessel User Fee. Here are some of the answers.

Where does this fee apply? In Wisconsin, this applies to the Great Lakes, Mississippi River, Green Bay and any tributaries to the point which a 16' power boat is able to operate by the use of locks, canals, etc. It would not apply to Lake Winnebago.

Who must pay? Any boat 16' in length manufactured or operated primarily for pleasure. How much will it cost?

(A) Greater than 16' to less

than 20' - \$25.00 (B) 20' to less than 27' -\$35.00

(C) 27' to less than 40' - \$50.00

(D) 40' or greater - \$100.00 How do you pay the fee and obtain the required decals?

(1.) Write-in: Obtain the decal request form by calling 800-368-5647.

(2.) Phone-in: Payment can be made by Visa or Mastercard by calling 800-848-2100. (Have your boat information available when calling).

This user fee became effective July 31, 1991. Recreational boaters which the user fee applies too, should be getting in contact with the U.S. Coast Guard.


