Three Kewaskum School District groups are proving that young people can have a positive affect and do things to help improve the quality of life in their community. They are the "Just Say No" clubs of the Farmington, Kewaskum and Wayne Elementary Schools.

The clubs are groups of children seven through fourteen years old, who are united in their

commitment to say 'no' to drugs. Through a variety of educational, recreational and service activities, the clubs support and strengthen their members' determination to lead drug-free lives. Not only do the clubs work to re-enforce their own ideas and goals, they also work to help the people in their communities.

The clubs participated in the MADD (Mothers Against Drunk Drivers) Wisconsin Ribbon Campaign, Oct. 14-18, by purchasing

and distributing red ribbons to all elementary school students and staff. The ribbons had each school's name on them with the message, "Hugs, Not Drugs."

On Nov. 21, the three clubs participated in the American Cancer Society's Great American Smokeout, by making and distributing 'Survival Kits' for smokers willing to give the day of non-smoking a try. The kit contained funny postcards, tips for quitting, a peppermint and a

button reading, "Bear with me, I've just quit smoking." Classrooms were decorated and everyone wore a button which either said, "Kiss Me, I Don't Smoke," or "Be Beary Healthy. Please Don't Smoke."

The clubs' latest project was the selling of Universal Studios 'Just Say No' calendars in a nationwide fundraiser. As a result of their efforts, on Thursday, Dec. 19th, the three clubs were able to present a check for \$500 to Frank Ciesielczyk, Director of the Exodus House of Kewaskum.

Exodus House is a transitional residential facility for individuals who are trying to get their lives in order after having drug and/or alcohol abuse problems. The facility provides temporary living quarters as well as drug and alcohol abuse counseling. Exodus House presently has thirteen residents.

Other money raised from the fundraiser will be used for drug-free school activities.

The Kewaskum School District's Just Say No clubs were the result of one young man, Matthew Paulson, a FES student, approaching the school's Guidance Counselor, three years ago and asking if they could have a Just Say No Club. With the addition of the Kewaskum and Wayne clubs, there are now approximately 100 students who are regular members.

Guidance Counselor Cheryl Taylor serves as club leader for all three clubs. The club captains are, Crystal Schiltz, Farmington, Dawn Markeland, Wayne and

### New Requirements For Work Permits

Kewaskum High School has been notified by the Department of Industry, Labor and Human Relations in Madison of new requirements for the issuance of work permits. The following is effective as of January 1, 1992.

#### Requirements for Child Labor And Street Trades Permits

1. Proof of age — Birth Record or Baptismal Record. Birth records may be obtained from the register of deeds in the county of birth. Baptismal records may be secured from the pastor of the church in which the baptism took place.

2. Letter from the employer stating the intent to employ the minor along with the job duties, hours of work and time of day the minor will be working.

3. Letter from the minor's parent, guardian or court-ordered foster parent while the minor is under their care and supervision consenting to the employment. As an alternative, the parent, guardian or foster parent may countersign the employer's letter.

4. The minor's social security card.

5. Statutory permit fee is \$5.00. The employer is required to pay the permit fee. If the minor advances the fee, the employer shall reimburse the minor not later than the minor's first pay check.

6. School address minor attends or school district.

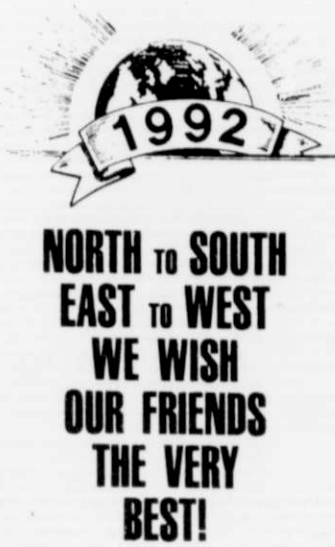

## County Veterans Received \$4,608,607 in 1990 Benefits

WEST BEND — Veterans in Washington County received an estimated \$4,608,607.00 in veterans benefits and programs from the state and federal government in 1990, announced Richard W. Baker, County Veteran Service Officer.

The veterans benefit statistics were released recently in a report from the Wisconsin Department of Veterans Affairs (WDVA). Of the total amount, \$970,846.00 was dispersed by WDVA and \$3,637,761.00 came from the U.S. Department of Veterans Affairs (VA).

In the report, WDVA Secretary John J. Maurer stated, "As a result of the effort of the County Veterans Service Office, veterans are obtaining pensions, which are spent in the county. Moreover, the housing loans they receive stimulate the county's economy, and the education benefits increase the competitiveness of the county's work force."

According to Richard Baker, County Veterans Service Officer, 9,580 veterans are living in the county, as of March 31, 1991. Of

the estimated total, 10 served during World War I, 2,110 during World War II, 1,340 during the Korean War and 3,340 during the Vietnam War. In addition 2,780 served in peacetime. No estimates are available yet on the number of Persian Gulf War veterans in Washington County.

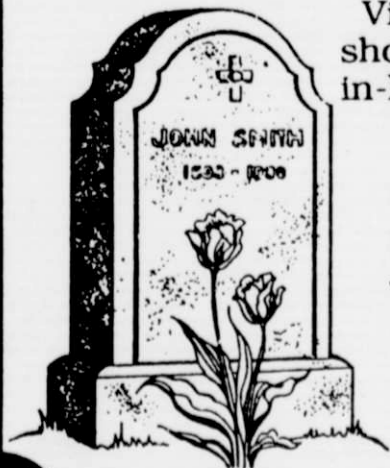

SHEBOYGAN FALLS — The score may not look all that close, but considering that Kewaskum gave up 12 forfeit points, the Indians 36-22 loss to a more experienced and powerful Sheboygan Falls team may have just been a moral victory.

# Minutes of Village Board Meeting

Mid-Monthly Meeting  
December 16, 1991  
8:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First St.

President Mary Krueger presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Wagner, seconded by Trustee Mark Vechart and unanimously carried by voice vote, the minutes of the December 2, 1991 were approved printed.

Fire Chief Robert Stoltzmann informed the board that on December 8, 1991 the Fire Department held their annual election of officers. The list of officers was read along with the information that 34 firemen voted, 4 asked to be excused and were absent and 4 were absent.

Director of Public Works Jerry Gilles informed the Board that some problems occurred with the Electric Companies street lighting hookup. Also that fuses were installed on both sides of the Main Street lights.

Administrator Daniel S. Schmidt

reviewed a variety of correspondence with the Board.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Larry Williams and unanimously carried by voice vote, the Board approved the Operators License application of Janine Herriges, Kewaskum, WI and authorized the office to issue said license upon proper payment of fee. Note: The Police Department had no objections to the application.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee Mark Vechart informed the Board that on December 11, 1991 a meeting was held and the topic of discussion was FLOW. A resolution will be brought to the Board in January supporting legislation regarding this matter.

Chief of Police, Richard L. Knoebel informed the Board that the Village did not qualify for the value pricing/bidding this year, but has already signed up for next. The Chief recommended accepting the bid of Schwartzburg Chevrolet/Oldsmobile for \$15,205.

On a motion by Trustee Robert Beisbier, seconded by Trustee Mark Vechart and unanimously carried by voice vote, the Board approved the purchasing of the 1992 police squad car from Schwartzburg Chevrolet/Oldsmobile as bid on November 18, 1991.

The Board reviewed briefly the information received from Tesch - Tesch & Associates regarding alternative uses for

the Fire House Meeting Room. The Fire Department Membership had 21 people present with the majority in opposition to any alternative uses. Fire Chief Robert Stoltzmann informed the Board that for a variety of reasons the Department is opposed to allowing outside usage of the meeting room. He also stated that an advisory vote was taken by the Department on December 8, 1991 with 33 votes cast objecting to any change. It was noted by Board Members that it was premature of any type of action by the Fire Department for the Village only began gathering information to make such a decision and that the Department would have been included with that discussion at the appropriate time. Trustee Robert Wagner expressed his concerns for safety etc. regarding such a change and indicated he could not support any change. Trustee Larry Williams explained that over the years several requests are brought to the Board for the use of the meeting room and that the taxpayers have paid for the facility and pick up the annual cost. President Mary Krueger indicated several area Fire Departments do allow for the use of their facility for many more types of events than is even being considered for Kewaskum's. On a motion by Trustee Gary Gavin, seconded by Trustee Thomas McElhatton and carried by voice vote the Board turned the matter over to the Public Services Committee to review the matter and possibly meet with the consulting firm as well as the Fire Department. Trustee Larry Williams and Trustee Robert Wagner voted "Nay" on

sending the matter to Committee.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board approved and authorized the signing of the Town of Auburn's 1992 Fire Service Contract as proposed by the Board. The cost is \$24,955.00 for said contract for 1992.

On a motion by Trustee Gary Gavin, seconded by Trustee Robert Wagner and unanimously carried by voice vote, the Board approved the Certified Survey Map for the land adjacent to Wildlife Drive as recommended and sent to the Board by the Plan Commission.

The matter of the CSM/Subdivision plat was tabled until January, 1992 at the request of the surveyor.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board approved the signing of an amendment to the listing of property to reflect a 60 day extension. (February 12, 1992).

Chief of Police, Richard L. Knoebel asked the Board to table consideration of employment of a full time police officer until January 6, 1992.

On a motion by Trustee Robert Wagner, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board authorized the signing and change of Health Insurance coverage agreement with Blue Cross & Blue Shield, United of Wisconsin for 1992.

On a motion by Trustee Gary Gavin,

seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board adjusted the Village's portion of the Health Insurance cost from the existing 3 percent cap on annual premiums to the Village making available health insurance coverage for regular full-time employees and agree to pay 90 percent per month towards the premiums for the family plan and up to 90 percent per month towards the premium for a single plan. The employee would be responsible for the balance of the premiums by voluntary payroll deduction.

KIEL — With their veteran leadership, the Kewaskum boys basketball team was hoping to contend with the leaders of the Eastern Wisconsin Conference this season. Right now, they're just looking to survive.

Chad Cook on the line for a pair of free throws.

"Things looked pretty good up until that point," Westphal said. "I wouldn't say we had the game under control, but definitely had the upper hand."

But unlike Cook, he missed both tosses, and Kiel quickly countered with Chad Ramminger launching a three-pointer to give Kiel a one-point lead.

"We have to convert those," Westphal said of the missed free throws. The Indian mentor also noted that his team was going to switch from a zone defense, which it had been playing the entire game, to a zone defense, if Cook had converted one of the two tosses.

"It was bothering them all night," Westphal said of the Indian zone. "We planned on switching to try and eliminate the three-pointer," but as it turned out, the Indians went back to the zone.

After another Indian miss, Ramminger struck again with another try, extending the Kiel

advantage to four points, and forcing the Indians into fouling.

"We got a real good shot," said Westphal. "We just didn't hit it. Then he (Ramminger) gets the ball in kind of a broken play...it ends up in his hands and he hits it."

It was too much too late for the Indians, who dropped their second straight EW encounter, while Kiel remained on top of the EW standings with a perfect 3-0 mark.

"They played some real aggressive man-to-man defense," Westphal said of the Raiders. "They're not a particularly big team. We were just in the wrong place at the wrong time."

Joel Fleischman led the Indians with 14 points, while Matt Seiser and Kim Marx chipped in 11 and 10 respectively.

"Kim played probably his best offensive game of the year," Westphal raved of Marx, while adding that Fleischman "had to work awfully hard for every shot."

# Indian Hoopsters Fare Similar Against Falcons

It was virtually impossible to view both the Kewaskum boys and girls varsity basketball contests with Sheboygan Falls last Friday, but spectators at each game could give you a rundown of what happened, and it would

tell the tale of both Indian squads. Both Indian squads started out well, but both were hampered by mistakes in the late going as the boys lost to Falls 72-65, and the girls were losers by a 50-40 count.

## Boys Downed In Overtime

KEWASKUM - Two undefeated teams in three days was just too much for the Kewaskum boys to handle.

After being bested by 3-0 Kiel 56-51 just three days earlier, the Indians faced the Eastern Wisconsin Conference's other undefeated squad, Sheboygan Falls here, last Friday night. The Falcons showed the Indians why they're on top of the EW standings with a gutty 72-65 overtime victory.

"We played three quarters of very good basketball," Indian coach Jim Westphal said of the game. "Overall, we played a pretty good game. We just got tentative late in the game."

After getting off to a slow start which saw them behind by four (18-14) at the end of the first quarter, the Indians began a comeback, pulling to within one, 27-26 at the half.

Kewaskum then unloaded on Falls in the third period, going up by as many as 11 points before heading into the final frame with a 44-38 cushion.

But the hosts suffered a big blow early in the fourth, as senior Joel Fleischman was whistled for his fifth personal foul on a charging call which appeared to be questionable, according to Westphal and others in attendance. The call exited Fleischman, as well as taking away the two points that he scored on the play.

"That, as much as anything really hurt us," Westphal said of Fleischman's departure.

The loss of Fleischman, an all-conference selection a year ago, obviously took its toll on the Indians. The Falcons methodically chipped away at the Indian lead, eventually tying the contest at 60 with under a minute to play.

The Indians played for the last shot, but were unable to get off the eventual game-winner, and

the teams went to the 3:00 minute extra session. The OT was a nightmare for the Indians, who made just two of ten shots from the field.

Falls dominated the overtime period, as they went to the line a total of 16 times in the session, making 10 of their tries. The Indians, meanwhile, struggled from the line the entire game. Kewaskum made 10 of 14 tries from the charity stripe.

"We just don't get to the line enough," Westphal said. "We have to take the ball to the basket."

"We had plenty of opportunities... plenty of good shots," he continued. "The guy who killed us was (Tom) Kuplic."

Kuplic, who was held to just six points in the first half while experiencing foul trouble, lit up the scoreboard for 13 in the final period, on his way to a game-high 28. "He just put on a show. He wanted the ball."

The Indians were led by Matt Seiser, who had 16, while Fleischman and Chad Cook chipped in 14 and 13 apiece.

"Seiser had a good game," Westphal added, also noting that "Kim (Marx) played a good floor game. He does a lot of things that go unnoticed."

The Indians, now 0-3 in the EW, 2-4 overall, travel to Slinger over the holidays to take part in the Christmas Tournament also featuring Campbellsport and Waupun.

SHEBOYGAN FALLS - It was one of those offensive lapses that have plagued the Kewaskum girls all season long.

This one occurred at the beginning of the final period of play against Sheboygan Falls, as the Falcons ran off the first 11 points of the fourth quarter en route to a 50-40 win over the Indians, sending the visitors to their seventh straight defeat.

As has been the scenario for the Lady Indians this season, Kewaskum jumped out to a first quarter lead, only to see it evaporate over the course of the game.

The Indians grabbed a 9-6 advantage after one quarter, and still held a slim 18-16 margin at the intermission, thanks largely in part to a tough defense that has been a mainstay so far this season.

The Indians maintained their cushion through the third period, although a late Falcon run gave the Indians a hint as what was to come.

Down 28-24, the Falcons got a big three-pointer from Chris Mayer, and after a free throw late in the third, Sheboygan Falls had battled back to tie things at 28 heading into the final stanza.

But that's where it ended for the Indians, as they fell behind 39-28 before they put the ball in the hoop, although the Indians did mount a threat in the late going.

The Indians pulled to within four, at 44-40, with just over a minute to go, but a mental error by the Indians cost them dearly. One of the players signalled for a timeout, when the team was out of them, calling for a technical foul.

Falls converted both free throws and then added two more

on the ensuing possession to send the Indians to a 1-7 mark on the year, 0-3 in the Eastern Wisconsin Conference. For the game, Falls went to the line 34 times, converting 21, while the Indians made just 12 of 21.

Robyn Winninghoff led all Indian scorers with 15 points, while Bonnie Schlice, on the strength of four three-pointers, added 12.

Leanna Sengerl led Falls with 14 points, while Kelly Regan added 10 and Sarah Lonens nine.


