Wins First Place at State Bee

Jim Stern, St. Lucas Student, Headed for National Geography Bee

What type of land form is located in the center of the Indian Peninsula? Sucre is the actual capitol of a country, but what is this country's official capitol? Tough questions?

Not for James Stern, winner of the state finals in the National Geography Bee held at the Olympia Resort in Oconomowoc this past Friday. Stern, an eighth grader at St. Lucas Lutheran School, grabbed 1st place this year after participating three years in a row. Last year Jim placed fourth out of the 100 state finalists.

The National Geography Bee is in its fourth year, and draws the participation of 33,000 schools from across the country for students in grades 4 to 8. The event is sponsored by the National Geographic Society.

"Competition was very hard, especially during the tie-breakers" Jim says, referring to the preliminary elimination rounds. Competition was so stiff that four tie-breaking questions had to be used to select the ten participants for the final round. To complete the final round and reach a winner required 16 tie-breaking questions!

Stern received the first place title by answering this winning question - "What is the phenomena that causes the trade winds to blow northeast instead of

east?" Jim's answer - "The Coriolis Effect" (principle dealing with the earth's rotations).

As the state finalist, Jim received an Atlas, \$100, and a trip to Washington D.C. to compete in the National Finals May 19-22.

Presidential Preference Primary Spring Election Tuesday, April 7

Tuesday, April 7, is Presidential Preference Primary Spring Election Day throughout the State of Wisconsin.

Voters will be asked to cast their ballots for Presidential Preference, plus various other county and local offices and referenda.

In the Court of Appeals, District 2, Harry G. Snyder is running unopposed.

In District 9, for Washington

County Board Supervisor, (Town of Wayne and part of the Town of Addison) incumbent Harold E. Westerman will be challenged by Mary Sauer. Westerman has been serving on the county board for a number of years.

In the Kewaskum Board of Education race, incumbent John C. Schulte will be opposed by Ray L. Engelking. This will be Engelking's second bid for a seat on the school board. Incumbent Paul Seymour, whose term has expired, decided not to seek re-election.

There are three positions available on the Kewaskum Village Board with only three candidates running. They are incumbents Gary Gavin and Tom McElhatton and newcomer Harry

E. Roecker.

Unless there are write-in candidates for both the school board and the village board positions, those on the ballot will be virtually assured of a post.

In the School District of Lomira race all the candidates are running unopposed.

Voters will also be asked to vote on two separate referenda. Please turn to pages 9 through 16 for explanations and more information to electors.

Please be aware that the Town of Kewaskum and the Village of Kewaskum voting hours have been extended. The hours for these two polling places only will be from 7:30 a.m. to 8 p.m.

Village Applies for Permit to Begin Cemeteries Sidewalk Construction

The Village of Kewaskum has requested permission from the State Historical Society to disturb ground within the boundaries of Holy Trinity and St. Lucas Cemeteries. Specifically, the village would like to build a sidewalk on the southern edges of these two cemeteries, adjacent to Main Street. Permission from the State Historical Society is necessary to do such work since the enactment of the burial sites preservation law in 1987.

Holy Trinity Cemetery is considered a cataloged burial site under state law. This means that the cemetery's boundaries have been defined in a deed and the State Historical Society has filed notice of its cataloged status in the Register of Deeds office. The Historical Society is in the process of filing a similar notice for St. Lucas Cemetery.

The burial law establishes a process through which a person may apply to disturb a cataloged burial site, which includes disturbing burials as well as land adjacent to burials as defined by the land description in the deed. As part of this process, the Village will have to notify people with a formally registered interest in these burial sites of their right to a hearing with the Division of Hearings and Appeals.

The State Historical Society is now trying to identify people who would like to formally register their interest in these cemeteries. According to the law, to be placed on the registry of interested per-

sons for a burial site, a person must apply to the Burial Sites Preservation Board, State Historical Society, 816 State Street, Madison, WI 53706. The categories under which one may claim an interest are:

- 1) direct kinship
- 2) cultural, tribal, religious affiliation
- 3) scientific, environmental, or educational purpose (including historical or aesthetic significance)
- 4) land use
- 5) commercial purpose not related to land use
- 6) other interests deemed to be in the public interest

The appropriate form may be obtained by calling the Burial Sites Office, State Historical Society, at 1-800-342-7834, or by contacting Larry or Louise Martin at 626-4291.

Any person on the registry, the person requesting to disturb the burial site (in this case, the Village), or the Director of the State Historical Society may request a hearing with the Division of Hearings and Appeals. If no one requests a hearing, then the Director of the Historical Society will decide whether to allow the disturbance by determining if the benefits to the Village outweigh the benefits to all the persons on the registry.





Kewaskum FFA to Host Annual Rabies Clinic

It is the time of year to once again begin thinking about having pets vaccinated against rabies. Wisconsin is one of the leading states in rabies reported cases, a statistic the state can do without.

Rabies is a serious public health problem as well as a deadly threat to your dog and cat. Help protect your neighbor, your pet and yourself by getting his rabies booster vaccination. We must continue to stimulate the immune system to produce antibodies against rabies virus to help protect our pets against an exposure to a rabid animal. Our state law requires that all dogs over 4 months of age be vaccinated.

The Kewaskum FFA is concerned about the problem, along with the local veterinarians Doctors Charles and Gregory Ogi, and Russell Demmon. The chapter will conduct a rabies clinic on Wednesday, April 8, 1992, from 6:00 - 8:00 p.m. in the Kewaskum High School Agriculture Shop. The vaccination will be administered at a reduced cost of \$7.00 per animal, with the proceeds going to the Dr. Ogi Scholarship Fund.

Rabies is an acute disease caused by a virus. The most common form of contamination is by means of a bite from an animal containing the virus-bearing saliva.

The incubation period is variable, but signs of the disease may become visible within 15 - 20 days after contamination. The first sign is general loss of appetite and a change of behavior. The second phase is known as a

paralytic form, where paralyzation and salivary excretion begin. The third phase, or sign, is the furious form, where the animal becomes very irrational and viciously aggressive. Dogs rarely live more than 10 days after the onset of these signs.

For more information about rabies and accompanying symptoms, consult your local veterinarian or physician.

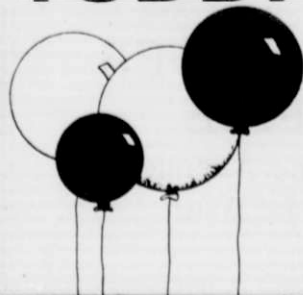

Nicole Trapp Ranked Top North American Youth At Arabian Horse Show

Nicole Trapp is a proud junior at Campbellsport High School and a member of Campbellsport 4-H Club. She is the best friend of her horse, Siramid, a seven-eighths Arabian gelding. Nicole was only three years old when she became interested in horses when she watched her older sister, Tani show horses. That's when she decided to follow her sister's footsteps. Her sister now (Mrs. Mark Vetter) is a veterinarian with the Fredonia Vet. Clinic.

Nicole began with a stubborn Welsh pony. Then she had a three quarter Arabian mare named Latif Lanet, then her pride and joy Siramid. Nicole bought "Sir", a three year old green broke, when she was 14. Nicole and Tani finished training the Arabian gelding and Nicole showed him the first time in the summer of 1988.

The ties between Nicole and her horse "Sir" are very strong. "I say my horse is my best friend. When I am lonely, I go out to the barn and I bond out and talk to him. He always makes me feel like I am his best friend. We have a bond."

In her first summer of showing Nicole and "Sir" got off to a good start. They participated in three

shows in addition to the State 4-H Horse Expo in Madison, where she placed in the top ten in two categories. Recently she was informed by Kyle Paulson, International Arabian Horse Association Youth Director, that she was named top youth in North America showing Arabians in open shows. Nicole considers this one of her greatest achievements so far.

In her first year in the Wisconsin Arabian Horse Association, Nicole was named Reserve Champion Junior Exhibitor. She went on to win Champion Junior Exhibitor Awards the next two years, as well as other championships. The junior exhibitor's award is given to exhibitors age 17 and under who accumulate the most points from competitions. Recently, she was awarded the Legion of Merit for reaching 750 points throughout the show seasons. Now she is setting her sights on the Supreme Legion of Merit, for which she needs another 250 points.

Nicole says, "everything isn't so serious at shows. After the show there is usually a competition just for fun. Usually in a egg and spoon contest you hold an egg on a spoon while riding at different paces. The last person with the egg wins." Nicole has

found that taking care of her three horses takes a lot of time, but she she loves it.

She spends a half hour or more each morning and evening feeding them. She takes time grooming and training too, especially before a big show. She also does trail riding to give the horse and herself some exercise and also to break the routine of work and training. Nicole also received the Annual High Point certificate. 1991 is the first year to have Top Five plaques generously donated by Janda Ribbons of Beatty, Nevada. The top ten youths that score the highest number of points within the calendar will receive a certificate. Nicole with Siramid scored 302 points. The next runner up had 300 points.

Last October she was chosen to represent the state at Albuquerque New Mexico. She enjoyed the judging down there. While her parents and grandparents watched. Nicole 17, is the daughter of Robert and Sharon Trapp of Campbellsport and the granddaughter of Charles and Clara Trapp of Beechwood. She would like to follow her sister and be a veterinarian.

Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is punched or marked, it shall be inserted in the envelope provided so the punches do not show or folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show. After casting his or her vote, the elector shall leave the booth, and deposit the envelope containing his or her ballot in the ballot box and where paper ballots are distributed to electors, deposit his or her folded ballots in the proper ballot boxes, or deliver the ballots to an inspector for deposit. The unused ballots should be deposited in the blank ballot box, and the elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. KHS Girls Dominate Waupun

KEWASKUM — It was a good start for the Kewaskum girls track squad, as the Indians opened up their 1992 campaign by blowing away Waupun 83-26 in an indoor meet held here, last Tuesday.

The hosts captured 11 of the 13 possible first places, highlighted by freshman Greta Kuphal's record-tying sprint in the 50-meter dash.

Kuphal matched the mark held by Melissa Braun by running a 5.9 race, one of two firsts for her on the day. Kuphal teamed with Kelly Korth, Tina Schwartz and Ginger Wiesner to win the 800 relay in 2:00, while Kuphal also added a third in the 400 run (76.3).

"She (Kuphal) actually had a 5.81," Indian coach Perry Koth said of the freshman sensation, "but anytime there's hundreds of a second involved, you have to round up. It wasn't so much a surprise (the record), because she's been running those kinds of times in practice."

Koth also had a fine day, as she accumulated three firsts. In addition to the 800 relay, Koth won the long jump (15-4.5), and had a hand in the 1600 relay triumph (4:56.2), teaming with Schwartz, Terry Vogt and Christa Schmidt.

"That's pretty well for her to start up where she left off," Koth said of Koth, who had her best jump in the state meet last year (16-3).

Schmidt also added two more wins in the hurdle events, taking the high's with an 8.4 time, and the lows in 8.2. Wiesner added a first in the 400 (67.0) and a second in the long jump (14-4), while Vogt was third in the high hurdles

(8.9+).

Beth Kempf won the shot put with a throw of 31-3, while Robyn Winninghoff took the high jump competition, leaping 4-8. Denise Ludwig, meanwhile won the 200 dash (31.5) and Chrissy Neumann took the 1600 run (6:12.6).

"She's perhaps our best distance runner right now," Koth said of the freshman Neumann. "It's nice to see our distance runners doing well. (Boys coach) Jerry (Gosa) is doing a real nice job helping them."

Another freshman has caught Koth's attention early in the season. Mary Yahr finished second to Schmidt in the low hurdles, and "is really challenging the upperclassmen," according to Koth.

"Overall, I thought we did a lot of good things in the meet," Koth said.

CLYDE J. SCHLOEMER

Clyde J. Schloemer, of West Bend, died Monday, March 23, 1992, at his residence, at the age of 83.

Turkey Hunters Could Bag a Record 8,000 Birds This Season

MADISON... This year, April 15 is a date many Wisconsinites are anxiously looking forward to. But it's turkeys, not taxes, that have them excited.

Wisconsin's 10th Spring wild turkey hunting season begins April 15, and nearly 44,000 hunters will be looking to bag one of those big birds.

"If weather conditions are good this Spring, the turkey harvest could exceed 8,000 turkeys for the first time ever," said Bill Vander Zouwen, turkey program coordinator for the Department of Natural Resources.

Turkey hunting in Wisconsin is allowed by permit only. A record 48,120 turkey permits were available, up almost 7,000 from last Spring's season.

Turkey permits are issued for a specific zone and hunting period. This Spring's six Wednesday-through-Sunday hunting periods run from April 15-19, April 22-26, April 29-May 3, May 6-10, May 13-17 and May 20-24.

Vander Zouwen anticipates a hunter success rate of approximately 20 percent, which is typical of Spring turkey hunts in the state. In the Spring of 1991 hunters bagged 6,862 turkeys.

A total of 36 zones are available to hunt in, including 16 new ones: Zone 19 in west-central Wisconsin, zones 17, 26, 27 and 28 in the southeast, and zones in 11 state parks.

Vander Zouwen noted that this is the first time a limited amount of turkey hunting, 180 permits total, will be allowed in 11 state parks. Five of the parks will provide hunting opportunities for hunters with disabilities. In all 11 parks, hunting is limited to the first three time periods so it will be finished before the time most recreational camping begins.

Wisconsin's wild turkey population is estimated at 105,000, located in approximately 50 counties south of a line running from Marinette to Polk counties. Vander Zouwen said the highest density of birds is in the southwest, where Missouri turkeys were originally released and the habitat is best suited for the big birds.

"Turkeys are tough birds," said Vander Zouwen. "They can take a lot of shot and still get up and run or fly away." He suggests refraining from shooting at turkeys that are more than 40 yards away. Before going hunting, he also recommends that hunters "pattern" their gun with the shotshells they plan on using to see how the pattern looks at different ranges, a least a half dozen pellets should hit a turkey in the head or neck.

Vander Zouwen also offered these reminders to hunters:

*Be sure of your target. Hunting accidents result from a hunter mistaking another hunter for a turkey. Never shoot at movement or sounds;

*Never wear red, white or blue. These colors appear on the head of a turkey; stalking is NOT a good strategy, it is nearly impossible to sneak up on a turkey, and this practice may lead to accidents;

*The turkey must be a gobbler (adult male) or jake (adolescent male). Look for the beard before you shoot;

*Hunters must purchase a turkey stamp (\$5.25) and a Spring turkey hunting license (\$8 resident, \$50 nonresident) before turkey hunting;

*Successful hunters must register their turkey at a designated registration station by

1:30 p.m. on the day of kill;

*Only shot sizes #4 lead or #2 steel or smaller are legal.

*Hunters may have others assist them in calling a turkey. However, a new law this year makes it illegal for anyone assisting another hunter to be in possession of a gun or bow unless they also have a valid turkey permit for that same time period and hunting zone.

"The future of turkey hunting depends on good hunter-landowner relations," Vander Zouwen emphasized. "Hunters should respect landowner rights, have permission to hunt, and know the property boundaries of the land."

"One way hunters can show their thanks is by sending their Landowner Appreciation Day envelope, which they received with their permit, along with \$5 to the National Wild Turkey Federation to get a landowner pass that entitles the landowner and his or her family to attend a free picnic in June.

Turkey Hunting Questions

Questions on the Turkey Hunting License and Turkey Stamp requirements are still being asked. Hopefully, this will clear up any questions.

In the past turkey hunters needed a small game license and a turkey stamp to hunt turkeys. Beginning in the Fall of 1991, gun and bow turkey hunters were required to purchase a turkey hun-

ting license and also a turkey stamp was required. Now only Senior Citizen Recreation Card holders do not have to purchase a license or a stamp to hunt turkeys. The Senior Citizen Recreation Card also had to be purchased prior to January 1st, 1992. It is now no longer available, even to persons who turned 65 prior to 1/1/92. Turkey hunters are reminded that they must present their turkey hunting approval notice to license vendors in order to purchase a license.

The turkey hunting stamp is good from Sept. 1991 thru Aug. 1992, so if you hunted turkeys last fall the stamp is still good for this spring. Do not attempt to remove the stamp from your license, instead carry both licenses with you.

I have also received complaints of the increased cost of turkey hunting. This is how Wisconsin compares to other states:

State - Wisconsin, Turkey Hunting Spring/Fall Combined - \$27.25; Michigan, \$27.70; Illinois, \$45.00; Minnesota, \$32.00; Missouri, \$20.00; Iowa, \$71.00.

One last rule change I would like to mention, persons assisting a turkey hunter are not required to possess a turkey hunting license, but are subject to the following restrictions: Anyone possessing a turkey hunting decoy or devise, or accompanying someone who does, may not also possess a gun or bow during the spring turkey hunting season unless that person possesses a valid, unused turkey hunting permit and carcass tag for that hunting period and zone. This rule change came about because of hunters calling for turkeys with a turkey decoy out in front of them and claiming that they were hunting for fox or coyote.

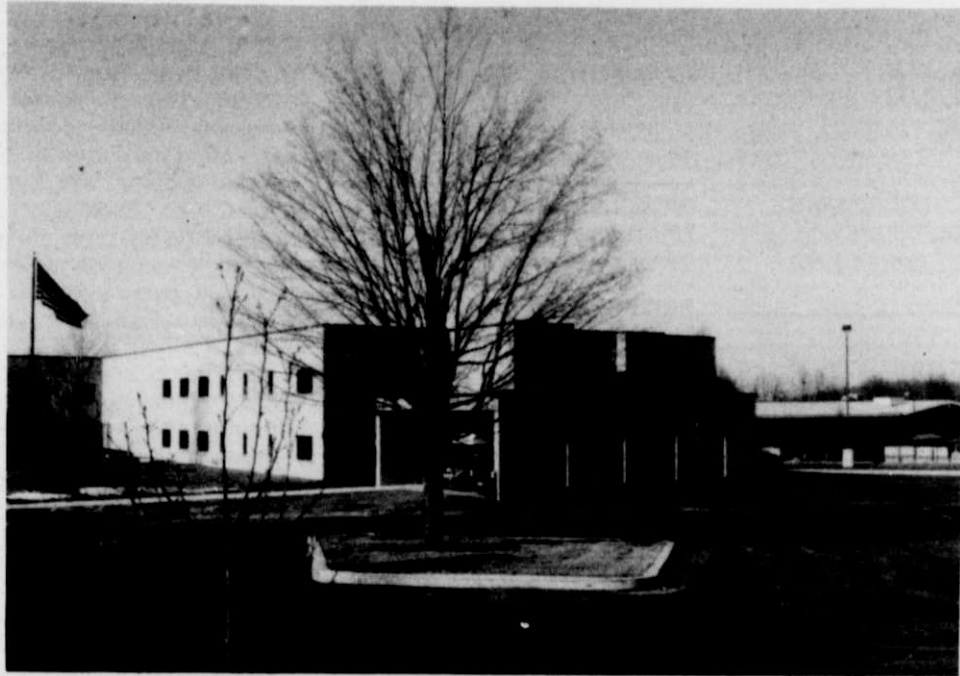

Lady Indians a Strong Third at County Indoor

WEST BEND - The team posted the most individual firsts, but the Kewaskum girls track squad wasn't able to parlay that into a first place team finish in the Washington County Indoor Meet held here last Friday.

The Indians tallied 79 points on the day, good enough to place them third behind champion Slinger (97 points), and runner-up West Bend East (84). Fourth was Hartford (46), followed by West Bend West (41), and Germantown (20).

"I didn't know what to expect," girls coach Perry Koth said, regarding the meet. "We had a lot of underclassmen running, so I didn't know how they would do. Overall, though, I was really pleased."

Indian senior Kelly Korth continued her dominance in the long jump, going 15-6.5 to easily beat the second place finisher by almost three-quarters of a foot.

Freshman Greta Kuphal continued to impress Koth with her effort in the 50-yard dash, as she nipped Slinger's Nancy Wamser at the tape to win in 6.5. Kuphal added a third in the 213 dash, as she tied with Anne Marie Punzenberger of West Bend West (28.5).

Sophomore Ginger Wiesner came up with the other Indian first, as she rolled in the 440 run, winning with a time to 66.6, four seconds ahead of Renee Beaudot of Slinger. Wiesner also placed second in the 213 dash (28.4).

Robyn Winninghoff came up just short in her bid for the high jump title, as she had to settle for second place with her 4-10 jump.

Freshman Mary Yahr also came up with a big effort, as she finished third in the 50-yard hurdles (8.4), barely edging teammate Christa Schmidt (8.6).

"That was a surprise," Koth said of Yahr's finish. "They both made it to the finals, so I was happy to see that."

Last year's shot put champ, Tammy Schmidt had to settle for a fourth-place showing this year (32.5). It was Schmidt's first competition since spraining her ankle late in the basketball season.

Kim Sabish added to the Indian long jump total with a fourth (14-3.5). Other Indians placing in the meet were Nicole Hetzel's fifth

in the mile (6:49.1), Beth Kempf's sixth in the shot put (31-0), and Chrissy Neumann's sixth in the 880 run (2:48.2). The two Indian relay teams, the 4-lap and 8-lap, were fourth and fifth, respectively.

"If there's a disappointment, it might be the relay teams," Koth said. "Their times are not as fast as I think they can run. But we don't get too worried," he added, noting that the team's ultimate goal is to be peaking near the end of the season, in time for conference and regional meets.

"We could have maybe done a little better in the meet," Koth went on to say, noting that one of his runners was disqualified from a race, or else the team might have taken second overall. "Our lack of experience hurt us. Also, the depth wasn't quite there."

The girls will have this week off as they prepare for meets at Winnebago Lutheran on Tuesday, and then home against Chilton on Thursday, April 9th.

Indian Girls Rebuild with Talent

KEWASKUM — When four athletes who combined for more than ten state meet appearances are lost due to graduation, a track team usually can look forward to a long, rebuilding year.

That might or might not be the case for the Kewaskum girls track team this year, as the Indians lost four mainstays of the program, but still will have plenty of young talent to hopefully fill in the gaps.

The departure of Melissa Braun, Rachele Zuehlke, Ingrid Ankerson and Laurie Vogt will definitely hamper the Indians, yet the team can take heart in the fact that they have the state's third best long jumper back, as well as a couple of other veteran performers.

"I kind of thought that it would be that way," girls coach Perry Koth said of the thought of a rebuilding year. "That's a lot of talent to lose. But you just never know."

Kelly Korth, who placed third in the Division 2 long jump competi-

tion in 1991, along with fellow senior Tina Schwartz will anchor the squad this season. The two will team up in the 800 and 1600 relays.

"She seems to be real strong," Koth said of Korth, who has already hit the 16-foot mark in practice. "They've both gone to state, so they seem to be providing the leadership."

The Indians will also get some help from underclassmen, including freshman Greta Kuphal, who has already tied Braun's school record in the 50m dash. "She's really showing a great deal of promise," Koth said of the frosh sprinter. "Her times are as fast as any since I've been here."

Koth will have a total of 13 letterwinners returning to the fold this year, including seniors Rachel Gosa (sprints and relays), Jessica Rohrer (hurdles), Terri Vogt (jumps, hurdles), Tammy Schmidt (weights); Juniors Beth Kempf (weights), Julie Mertz (middle distances), Christa Schmidt (hurdles), Robyn Winninghoff (jumps and discus), and sophomores Ginger Wiesner (sprints), Rachel Chambers (distances), Nicole Hetzel (distances).

"We have a lot of young talent," Koth said of the team. "It's hard to say which events will be our strongest, but we do have a lot of good sprinters. The weights should be pretty solid too."

Non-letterwinners who are hoping to help the team include juniors Kim Sabish (jumps and sprints), Jenny Thull (hurdles), Heather Koch (sprints), Karla Kirst (sprints, relays), along with freshmen Chrissy Neumann (distances), Lynn Thull (distances), Mary Yahr (hurdles), Andrea Bonlender (weights), Laura Dehler (sprints), Sara Eckles (weights), Julie Froemming (sprints), Susie Gauvin (distances), Tracey Jacak (sprints), Cindy Kuechler (sprints), Becky Kuenke (weights), Deise Ludwig (weights), Missy Rohrer (hurdles, sprints), and Becky Yogerst (weights).

Despite the high number of athletes out this year, Koth still worries about the ultimate strength of a track team. "I don't know how much depth we will have," he said. "That may be a problem."

KHS Boys Sixth at County Indoor

WEST BEND — It has occupied the bottom spot in each of the last three Washington County Indoor Meets, but it isn't hard to see that the Kewaskum boys track team is improving.

After tallying just 20 points at last year's meet, the Indians came up with a 45.5 point effort here, last Friday, but it still wasn't enough to break them out of the cellar spot.

West Bend East ran away with the meet, running to a 108-point total, easily outdistancing second-place Slinger, which piled up 77.5 points. Third was West Bend West (73), followed by Hartford (66), Germantown (52), and the Indians.

The tough opposition in the meet was obvious to first-year coach Jerry Gosa, who was pleased with his team's improvement.

"We improved 25 points (from last year), plus one of our relay teams was disqualified," Gosa said. "You're going against three Division I schools, so you're going against some pretty good athletes."

Still, Gosa got some fine efforts from his troops, headlined by Kim Marx's pair of seconds in the hurdle events. The senior mainstay finished behind West Bend East's Jason Harter in both the high hurdles (6.8 to 6.9), and in the intermediates (6.3 to 6.5). "He's been running real good," Gosa said of his top hurdler, "been very consistent."

Finishing next highest for the Indians were Jeff Dirmeier and Beau Coulter, who placed third in the mile and 50 yard dash, respectively. Dirmeier, a junior, had a time of 4:56.8, just .1 out of

second, while Coulter, a sophomore, ran a 5.9. Coulter also added a sixth in the high jump, leaping 5-8.

"Jeff ran a very good race," Gosa said of Dirmeier, whose time was just .9 off the school record. "He came up just short. He seems to be very focused."

Keith Herman continued to surprise Gosa this spring, as the junior finished fourth in the 440 dash (57.6), just .4 off the lead. Wade Kreis also added a fourth in the long jump, going 18 - 10.5. "That's his best jump ever," Gosa said of Kreis' effort.

"I'm pleased with the progress," said Gosa. "It would have been nice to finish higher than sixth, but that will come with time. We just don't have the depth that we need. But if we keep working hard, we'll continue to improve."

The Indians have this week off, as they prepare for the outdoor season, which will get under way for both Indian squads on Tuesday, when they travel to Winnebago Lutheran.

The Indians next home meet will be Thursday, April 9th against Chilton, beginning at 4:30.

KEWASKUM — The Kewaskum boys track team will look to a new leader in its attempt to make strides to be more competitive this season.

Jerry Gosa, a chemistry teacher at the school, and the middle school boys and girls track coach for the past couple of years, will move up and head the high school boys program, replacing Ralph Schacherl.

and should continue to improve. The high jump unit would have been even stronger, but returning letterwinner Erik Ankerson tore his knee ligaments last week and will be lost for the season.

Other letterwinners who should help improve last year's last year showing in both the Eastern Wisconsin Conference Washington County Indoor meets, include:
