Lions to Host Annual Kettle 20, Chicken Bar-B-Q Sunday

Get your running shoes ready because its time once again to face on foot the rugged hills and gorgeous terrain of the Kettle Moraine State Forest, as competitors from across Wisconsin, neighboring states, and Canada converge in Kewaskum for the Kettle 20+2 race.

The 20 kilometer event (12.4 miles) will be accompanied by two easier runs — 3.5 and 5 miles, and will include various men's and women's divisions. The event is sponsored by the Kewaskum Lion's Club and is held in conjunction with the annual chicken bar-b-que at River Hill Park on Sunday, August 9. The race begins at 9 a.m. at the Park, located along the Milwaukee river. Registration begins at 8 a.m. (in advance) up until race time.

Divisions for the Kettle 20 are as follows: six men's age groups 1-17, 18-29, 30-39, 40-49, 50-59, and 60 and over; four women's age groups 1-17, 18-29, 30-39, and 40 and over. Top male and female runners will each receive a trophy, followed by medals for second and third place, and ribbons for fourth and fifth. The two small races will offer awards to the top place winners.

Entry fee for all races is \$8 with t-shirt, and \$6 without. Those who register in advance will receive \$1 off each race. To date 50 runners

have pre-registered. "Were expecting about 80 or 90 runners to pre-register," according to Chairman Dale Squier of Kewaskum. "On the day of the race, another 80 usually sign up." Racers enjoy coming back year after year to the Kettle 20+2, both for the challenge and a glimpse of the rugged landscape touched by Wisconsin Glaciers thousands of years ago.

All runners have the advantage of purchasing their chicken dinners for the special price of \$3.00 each, but must apply for their tickets before the race begins to receive the special price.

There will be water stops along the way and showers will be available at the Kewaskum Middle School.

Chicken dinners will be served throughout the day, beginning at 11 a.m. and running til 4 p.m. Cost is \$5.00 for one-half chicken and \$4.50 for one-quarter chicken plate, complete with mashed potatoes, vegetables and salad. Carryouts will be available from 10:30 on.

Whether you're there to cheer on the runners, compete in the race, or enjoy the food, don't miss the popular Eddie Schneider and his music. Beer, soda, hamburgers, ice-cream and other refreshments will be available at

the park.

Proceeds from this annual event are used for local "Lions" community service projects, and a drug and alcohol educational project in the Kewaskum School District.

Mail-in registrations for the race can be sent to Dale Squier, 1305 Roseland Dr., Kewaskum, WI 53040 to register in advance. For more information on any of the days events, contact Dale at 626-2731.

In addition to the live music by Eddie Schneider from 11:00 a.m. to 2:00 p.m., there will be a Country Western Dance Exhibition at 1:00 p.m. Country Line and Two Step dancing lessons will be starting Sept. 2 for basic beginners only at the Amerahn given by the Country Western Dancers, formed in Plymouth.

Cemeteries' Archaeological Study Ordered

In reply to some of the trustees' questions Monday night, Village Administrator Dan Schmidt advised the Kewaskum Village Board that a purchase order has been sent out for the services of an archaeological study of the Holy Trinity and St. Lucas Cemeteries.

Schmidt advised the board that the study should be scheduled in thirty to ninety days.

The question of sidewalks along the two cemeteries again came up as the board and Schmidt were discussing a colored map layout of the village's sidewalk program. On the layout, Schmidt had color coded the various phases of the project, those completed and those yet to be done. It was indicated that 'problem' areas were not targeted for work until 1998.

In reviewing the map, Trustee David Goeden questioned why the cemeteries area was being contemplated in this year's phase. He wondered why, if it is a problem area, it is being considered now, and not in 1998.

Board president Mary Krueger answered Goeden's question by replying that, at the time it was in-

cluded in the 1992 phase, it was 'not' considered a 'trouble area', Goeden then questioned why that area could not be put off until 1998. "What you'd be doing is pushing it off onto another board," said Krueger. It's going to have to be faced some time, she noted.

Trustee Gary Gavin also said he would not want to be a 1996 board member faced by all the trouble areas at once, you'd have dozens of people in here, "What you're doing is seeing if you can put in a sidewalk, no one is saying we're going to do it," said Krueger.

Goeden then asked why the State had not been required to do a study when it restructured Highway 28 (Main Street) along the cemeteries. "Cemeteries have to be registered with the State Historical Society," said Schmidt, "and I suspect, at the time the roadwork was done, neither cemetery was registered, so the State was not required to do a study. I know the St. Lucas Cemetery was not registered with the Society until recently, noted Schmidt.

Schmidt said no decision on the sidewalk would be made until the

study is completed and a public hearing is held.

In other business, the board approved a contract between the village and its Building Inspector, Gordon Hoffmann.

Due to the Labor Day holiday and the Fall Primary Election, the board moved to cancel its September 7th meeting and hold just one meeting on September 21st. If necessary, a special meeting could be called.

Domestic Dispute Claims Lives of Campbellsport Couple

A Town of Osceola couple were found dead in their rural Campbellsport home Sunday afternoon, the apparent victims of a murder-suicide.

According to the Fond du Lac County Sheriff's Department, Cheri J. Backhaus, 30, and her husband Randall L. Backhaus, 32, were found shot to death shortly before 1 p.m.

Backhaus apparently shot and killed his wife with a rifle then turned the gun on himself. The tragedy followed a domestic dispute which had begun between the couple earlier in the

day.

The bodies were found in the home on Vista Drive by the couple's thirteen-year old son. According to information gathered, three of the Backhaus' four children had left the home earlier in the morning when the two began arguing. The boy was outside with two other children when he heard shots. A fourth child, two years old, was in the house at the time of the shooting but was unharmed. The boy, concerned about his parents, called "911" at 12:40 p.m.

Both victims were shot once

and died of massive head injuries.

According to neighbors the couple had a history of domestic violence. The Sheriff's Department expected to conclude its investigation this week.

The children, ranging in age from two to thirteen, have been placed with relatives.



Lottery Credit Claim Forms Being Mailed to County Home Owners

WEST BEND... Fredric A. Seefeldt, Washington County Treasurer, announced recently that lottery credit claim forms will be mailed to Washington County homeowners the last week of August. Homeowners will need the claim forms to qualify for the lottery credit on their 1992 property tax bills. The claim form will be a two-part postcard.

The method for claiming the lottery credit has been changed, explained Seefeldt. "Instead of signing and returning a postcard to the county treasurer's office," Seefeldt said.

"Homeowners may claim the credit, if on July 1, 1992, they were an owner of the property described on the postcard and they used that property as their primary residence," Seefeldt advised.

"Primary residence is defined as the dwelling unit where you live

most of the time. When you are temporarily away, it is the home you ordinarily return to. You can have only one primary residence," Seefeldt explained.

"In order to receive the lottery credit it is vital that eligible homeowners return their signed cards. The lottery credit can not be given unless we have a signed card on file for a given primary residence," Seefeldt cautioned.

The deadline for returning the postcards in Washington County will be Thursday, October 1, 1992.

St. Joseph's Hospital Contracted with Preferred Emergency Physicians to Provide Constant ER Coverage

Recently St. Joseph's Community Hospital of West Bend contracted with Preferred Emergency Physicians, S.C. (PEP) to provide 24 hour, 7 days a week coverage of the Emergency Room. These physicians have all been trained in emergency medicine, with special emphasis on trauma, orthopedic, pediatric and surgical medicine.

They are members of the largest physician group of this type in the state. They are also affiliated with St. Mary's Hospital in Milwaukee, St. Mary's Hospital - Ozaukee and Community Memorial Hospital in Menomonee Falls.

There will be three full time physicians, Dr. Mary Lewis, Medical Director for the Emergency Room; Dr. Joan Faloona and Dr. Joseph Schwartz, along with a number of physicians working part time on rotating shifts. They

are Advanced Cardiac Life Support (ACLS), Advanced Trauma Life Support (ATLS) and Pediatric Advanced Life Support (PALS) certified.

They also serve as instructors for these classes. They stress the importance of pre-hospital care, safety and patient education. Dr. Faloona and Dr. Schwartz reside in the West Bend area. Dr. Lewis and Dr. Faloona, while in residence at Milwaukee County Medical Complex, also worked as the transport physician with the Flight for Life crew.

These Emergency Room physi-

cians understand that they are often the first contact that a patient (or potential patient) may have with the hospital, and they take their responsibility as ambassadors to the community seriously. They intend to work with local Emergency Medical Technicians (EMT's) in recertification for trauma care and treatment before patients arrive at the hospital. Future plans also include patient education and community outreach efforts emphasizing safety and prevention.

Although patients coming to the Emergency Room expect to be seen immediately, there may be a wait due to serious injury or illness requiring more urgent attention. But you can count on professional, caring and concerned treatment when you visit the Emergency Room staff at St. Joseph's Community Hospital.

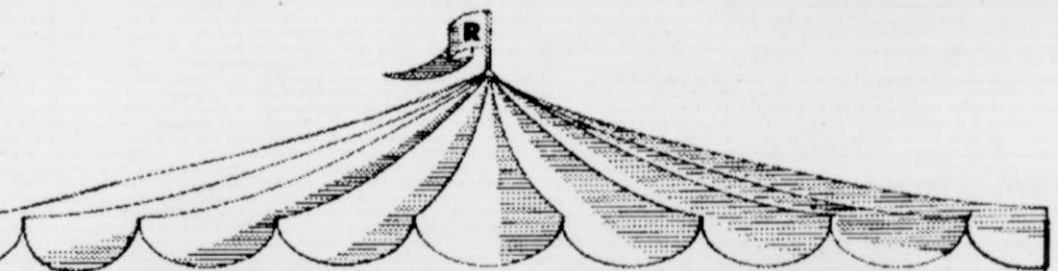

Reindl School Folder Design Winner

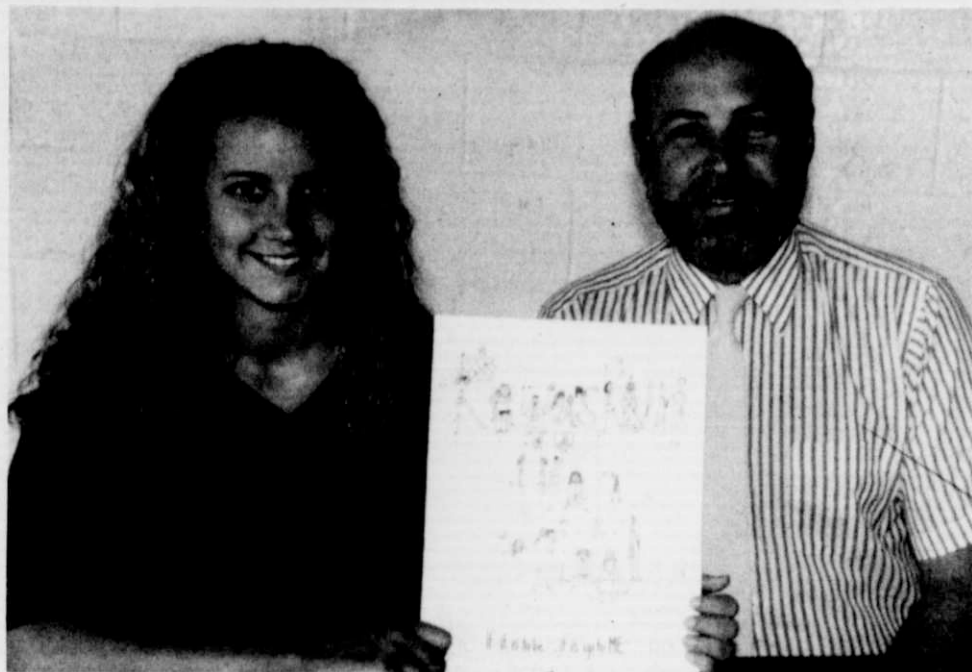

Excerpts From As I Remember

We had three cattle buyers in Kewaskum. There was a stockyard in back of the first village hall. Cattle were brought in either by foot or by wagon. The cattle buyers would purchase or assign the cattle and they were loaded in stock yards and sent to Milwaukee or Chicago for slaughtering. This area was also used for harvesting sugar beets, a cash crop for farmers and quite a few sugar beets were raised in the early 1900s.

The stockyards were later replaced by local truckers, hauling livestock to the city, both Chicago and Milwaukee.

The last Wednesday of the month was fair day, and we would see many buyers coming into the community, stopping farmers before they got into town, trying to buy the livestock.

During the peak period of egg laying, the people would take eggs, submerge them in a solution that would keep them a long period of time.

Talking about eggs, it was not unusual on a Saturday morning to

see people coming to Kewaskum on the early train with egg crates which they filled and returned to the city with later in the day. It was also not unusual to see carcasses of veal that was slaughtered in the innards removed, being taken to the city of the baggage cars.

Busy Dundee Mill Park Crew Working Hard on 5-Year Project

The Dundee Mill Park crew has been busy this past Spring and early Summer. They have been working hard to get more things done on their five year project.

The ponds have been checked for leaks and repaired. The seeding has just been completed on both the upper and lower areas. The parking lot is just about finished. The water in the upper race was lowered and the new trash rack has been installed.

A new bridge over the dam was made possible with cash donated by Frances Baker. The construction was performed by the Kettle Moraine Correctional Institution. Placement of the new bridge over the dam was done by LaVerne Immel, George Wiede, and Al Mans with the help of the boom truck donated by Lakeview Electric.

A split-rail fence was erected by the upper pond with flower beds next to the berm. The money for the materials was donated by Long Lake Fishing Club. Flowers to fill this 225 foot garden were donated by Eugene Bemis of Upland Springs Nursery. Stone was donated by Rademan Oakfield Stone. Work has also been started on clearing off the old dead trees along the river area.

The work on the inside of the mill is progressing nicely. Boards have been obtained and readied for flooring repair. A new wheel has been installed on the pulley system, and the electrical system installed in order to sell the power to the electric company.

A pavillion has been donated by Jim and Janice Rinas, who own C.C. Codys. An old threshing machine was donated by Dave Kaiser. Dave Loehr has donated a butter churn and a cream separator. Charles Poch is working on a history of dairying to be put along with the last two donations. A new weed eater has been donated by the Long Lake Fishing Club. Monies have also been raised to purchase an additional weed eater and brush cutter.

Many thanks go to these people for thinking of the Dundee Mill and Park when it comes to donations.

Progress is being made, but more progress can only be made with the addition of more funds. The other day a one dollar bill was put in the donation pot in the mill. These one dollar contributions all add up. When put together with the larger amounts they add up to something else that can be accomplished.

There are many more projects remaining. Rest rooms, and a well

with drinking fountain are probably the most expensive. Benches, tables, grills, and a shed to store lumber and tools are needed. The materials for the trails, landscaping and playground have to be purchased.

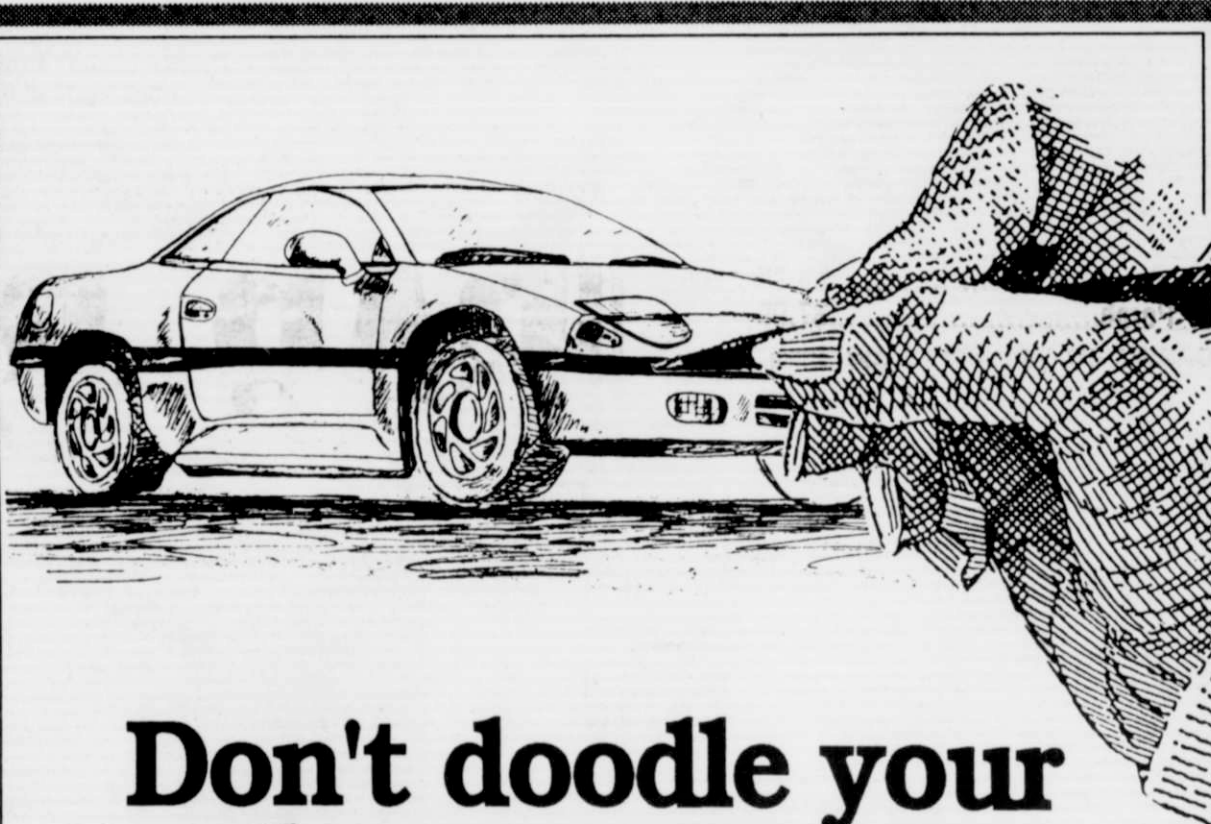
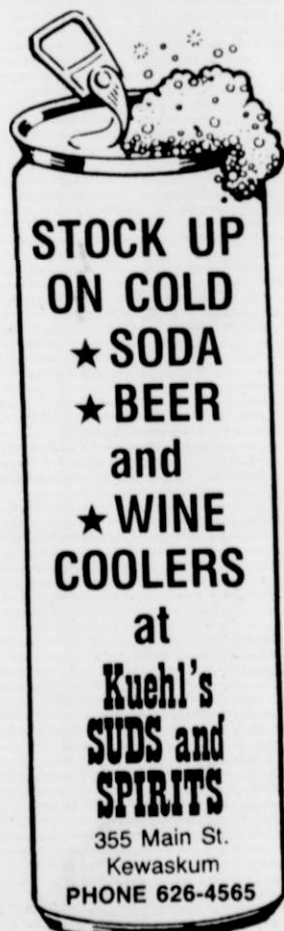

Tax Alert for Wisconsin Military Personnel; Confusion Over Desert Storm Tax Rules

Some Wisconsin military personnel may have received incorrect information regarding military pay and their taxes. According to the IRS, the confusion seems to stem from tax relief given to the men and women who served in Operation Desert Storm and Operation Desert Shield in the Persian Gulf.

John T. Ader, Director of the IRS in Wisconsin, explained that "Some military pay may be exempt from income if the pay was received for services performed in the Persian Gulf area on or after January 17, 1991. That's the date when the President declared the Persian Gulf a combat zone."

"But," Ader continued, "we understand that some of Wisconsin's military personnel have filed amended income tax returns for

1990, requesting refunds of taxes on the military pay they received that year. That is not allowed. Military pay received in 1990 for services performed in the Persian Gulf is not exempt from income tax. Amended returns should not be filed for 1990 to request a tax refund on that money."

Members of the military and their families are urged to call the IRS for more information about military pay and tax exemptions. In Milwaukee, call 271-3780. Outside Milwaukee, call 1-800-TAX(829)-1040. You can also get a free IRS booklet (Publication 945: "Tax Information for Those Affected by Operation Desert Storm") by calling 1-800-TAX-FORM (829-3676).

WEEKLY GARBAGE COLLECTION

The Village of Kewaskum has been notified by the contractor providing the Village garbage disposal that they have been sold to another company. This changed the collection process, as far as the time of day and the location the village hauls its garbage. This has had an affect on the day of the week certain residences get their garbage picked up. The Department of Public Works has worked hard to minimize any inconvenience caused by the changes imposed upon them.

REFER TO THE VILLAGE MAP

Effective immediately, the Department of Public Works will make every effort to pick up those residences that abut the blackened streets on Mondays and those residences abutting clear streets on Tuesdays.

It should be noted that as in the past if certain weather conditions prevail, or an emergency arises, some alterations to this schedule may occur.

All residents are advised that in the Village of Kewaskum Municipal Code under Chapter 14.09 Public Health and Welfare (5) (a) the placement of garbage for collection is addressed. Not earlier than noon on the day proceeding that upon which garbage and refuse collections are customarily made from such premises, such garbage cans and trash containers shall be placed within 6' of the street or just inside the curb for the purpose of permitting the collection of garbage and refuse therefrom and such garbage cans and trash containers shall be removed from such place on the same day collection is made.

The Cedar Haven Rehabilitation Agency has broadened its Summer Pediatric Program to allow for greater enrollment and a more specialized adolescent program. Any property owner in violation of this section is asked to correct the situation to alleviate any further action required by the Village. Your cooperation is appreciated in the maintenance of safety for all residents.

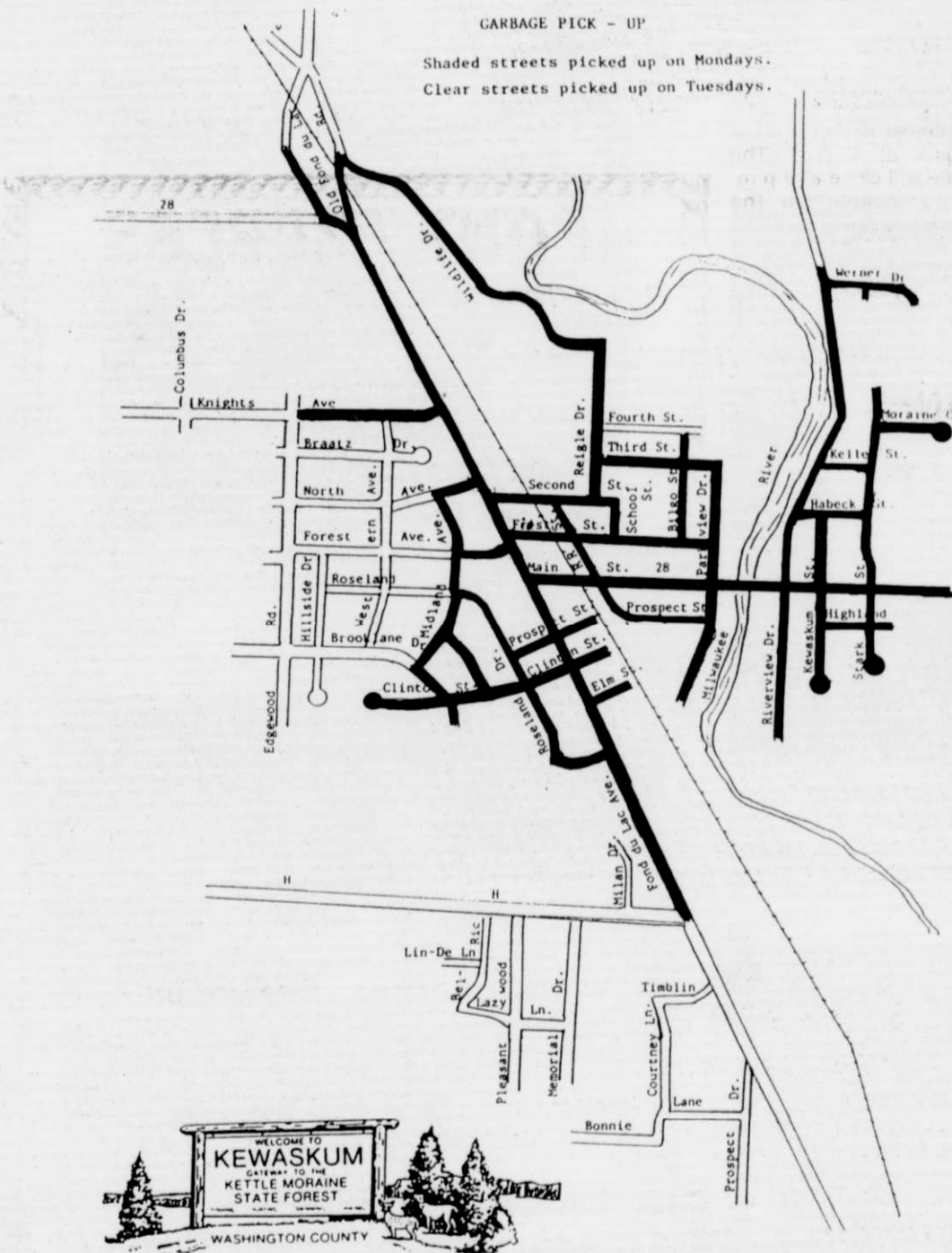

Peace Church Returns from Third Year with Habitat for Humanity

Laying a block foundation for a house, dry-walling inside a house, and reassembling another house on a new foundation were three separate projects on the Peace United Church of Christ Habitat for Humanity work schedule, July 18-25.

Twenty-three Kewaskum church members returned to Lexington, Kentucky for the third year of volunteer partnership building in the inner-city for Habitat. Upgraded neighborhoods and visible inroads against poverty are evident as a result of ecumenical Christian outreach of Habitat in this Southern city.

"The mighty crew from Wisconsin," is the affectionate title applied to Kewaskum volunteers by Greater Lexington's chairman of the Habitat Board, Lyle Hanna.

"Kewaskum gives us the 'jump start' we need each year to get going," Hanna added.

Twenty homes were built in Lexington last year by volunteers and home owners in partnership, and twenty more are the goal for 1992. Prospective owners of two of the three structures the Peace Church group shared met the workers at a celebration supper held at St. Luke's United Methodist Church in Lexington.

Chairman Hanna presented the Kewaskum crew with a recognition plaque from Habitat and the Lexington Chamber of Commerce. Lexington T.V. also interviewed the Wisconsin volunteers for a news special at the week's end.

Housed again at Koininia

House, a Christian student fellowship center on the University of Kentucky campus, the local crew ate, slept, worshipped and worked as a "family" in the 90 degree heat and 100 percent humidity of central Kentucky. Kirk Kirkpatrick, executive director of Lexington Habitat, praised the volunteers for their example of living the Christian faith by reaching out beyond their own community with hammers and love.

Peace Church members have also worked in Milwaukee and Oshkosh on Habitat homes in Wisconsin. The Peace Church congregation supports this outreach all year.

Richard Zarleng; five year volunteer is Willard Gruhle; four year workers are Wayland and Darlene Tassar and Karen Kletti; three year workers are Clark and Bret Pearson, Charles Petrie, and Howard Zemlicka; two year volunteers are Connie Zemlicka, Clayton Stautz, Mary Steinhardt, and Maury Hovland. Volunteers new in 1992 are Mary Hovland, Rich Radke, Jr., Gayle and Stephen Van Ess, Mark Steinhardt, and John and Craig Hubbell.

A monetary gift for building supplies in Lexington was sent by Peace Church with its crew, and a separate check was given by Peace Church Sunday School, following a paper brick poster project at \$1.00 per brick to "build a

house." Regal Ware of Kewaskum also provided a set of kitchen ware for a new home owner family.

Each family works 350 hours on the home they will own as well as 150 hours on another Habitat home in order to qualify for the non-interest Habitat mortgage plan. This is called "Sweat equity," a term originated by Millard Fuller, founder and president of Habitat for Humanity International.

As the Peace Church crew packed up to leave Lexington, a small boy helping on a home site asked Pastor Bettin, "but if you leave, who will finish this house?" Such questions make leaving hard, but returning easy. Just ask any 1992 crew member!

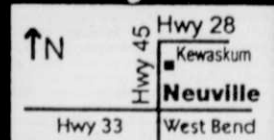

I am writing this letter in response to a campaign brochure that I recently saw. This brochure represented candidate Grover for the office of sheriff. I feel the necessity to clarify some misinformation that it contained.

The statement I am referring to is one that states officers received awards for writing seat belt tickets. I was totally taken aback when I read this. I was surprised that a candidate who is supposedly standing for law and order would take a positive program such as the safety belt challenge, and mislead people into thinking that it was nothing more than a ticket writing contest. Either Sergeant Grover is extremely misinformed, or he is intentionally misleading people with half facts.

I am on the statewide task force to help Wisconsin achieve a 70% safety belt usage rate. The pro-

gram that is being misstated is a contest where law enforcement agencies from around the State of Wisconsin educate citizens to the importance of safety belt usage, and enforcement of the safety belt and child restraint laws. Enforcement does not necessarily mean a ticket. Verbal and written warnings are also included in the term enforcement, along with citations.

Educational programs, publicity efforts and corporation involvement are among the many elements that are involved in this challenge. I was personally present when Sheriff Schulteis presented several 'Saved By the Belt' awards to citizens of Washington County for their good judgement in wearing safety belts when they were involved in traffic crashes.

Sheriff Schulteis also had one of his deputies, along with a trooper and an officer from the West Bend Police Department, pictured on a magazine cover, showing the cooperative effort for safety belt compliance. By participating in the challenge last year, Washington County area achieved a 68% usage rate, compared to the 59% usage rate, statewide.

The law enforcement safety belt challenge not only saved lives, but also dollars! NHTSA (National Highway Traffic Safety Administration), is looking at the Wisconsin law enforcement challenge as a model program to be implemented in other states.

Becoming a Game Warden

Often, when in the field, I am asked, "How does one become a game warden?"

The position for conservation warden in Wisconsin is extremely competitive, as vacancies are filled only once a year or every other year. Usually the state hires between six and twelve wardens per recruit class. In the spring, the state announces warden vacancies in the civil service exam bulletin. Applications are then accepted to take what is commonly referred to as "the warden exam."

Applicants take the exam at various locations throughout the state at the same date and time. The number of persons taking this exam usually varies between 600 and 1600 persons. Applicants are then scored and then ranked according to their exam score. A rank of number one would be the highest score, and a rank of six hundred would be the lowest score, if 600 persons took the exam.

Individuals are then invited to the initial physical agility exam and oral interview based upon their exam rank. Upon successful completion of the physical and oral interview, applicants then proceed to the medical and psychological testing and then to the final interview, where the final selections are made. Upon being appointed a conservation warden, the new warden is then sent to the State Patrol Academy at Fort McCoy for 13 weeks of basic law enforcement training. Training at the State Patrol Academy includes training in firearms, self defense, report writing, criminal investigations, criminal law, and conservation laws.

New wardens are then sent to various locations throughout the state, where they work closely with another warden called "a field training center." New wardens spend eight weeks with each field training officer and must successfully complete training with three training officers. New wardens also complete an additional seven weeks of classroom and scenario (mock) training on trapping, boating, hazardous materials, public speaking, and waterfowl enforcement.

After a new warden's first year of training, he/she is then assigned permanently to a location somewhere in the state to carry out the many responsibilities of a warden.

Persons interested in becoming a conservation warden should seek good education and experience to further their chances in acquiring a warden position. Knowledge in the state's natural resources and ecology is essential, including fish, wildlife, soil, forestry, waters, air, etc.
