A total of 210 runners competed in the 19th Annual Lion's Club Kettle 20 race on Sunday, in conjunction with their chicken bar-b-que.

Over 600 delicious dinners were served by the Lions Club, according to Frank Beesten, who stated the bar-b-que was again, a great success.

Proceeds from this annual event are used for local "Lions" community service projects.

# 157 Attend Seefeldt Family Reunion Here

"What a beautiful day for the Reunion!" and "Doesn't the bandstand look great!" The words echoed throughout the afternoon as 157 relatives and guests gathered Sunday, July 26, 1992 at Riverhill Park for the 53rd Seefeldt Annual Reunion. Members of the Seefeldt and Seefeld families, descendants of Christian Friedrich Seefeld (1795-1865) and Anna Sophia Kobs (1795-1835) meet at Riverhill Park each year on the last Sunday of July. In 8 generations there are over twenty-two hundred known members of the clan.

The theme of this year's reunion was "Discover America" and table decorations reflected places where Seefeldts have settled. Family members brought a variety of items to display and this provided a good opportunity to tell younger members of the clan about their ancestors. It also gave the relatives a chance to play "Chamber of Commerce" as families from Arizona, Florida, Georgia, Illinois, Indiana, Massachusetts, Minnesota, and many cities in Wisconsin displayed items representing their home cities or states.

One of the more unusual items on display during the reunion was a communion pitcher which had been used in the Friendship Methodist Church. The church, built by Christian and Anna's son William (1832-1903), served the Friendship community for more than 90 years; it was razed in 1946. Also on display were family items such as photographs, linens, china, and glassware which have been passed down from one generation to the next.

The day's activities began with a "share a dish" picnic dinner, with the invocation and table blessing given by the Reverend Maurice Jones of Baraboo. Following dinner, Reunion President, Phil Majerus, conducted the annual business meeting and family members expressed their thanks to the Village of Kewaskum for the repairs made to the park bandstand. Greetings and letters were shared from relatives who were unable to attend the reunion. Guests were introduced and several of them mentioned that they had come to the reunion hoping to find a link-up with their own Seefeldt ancestors.

Attendance prizes were awarded to Mrs. Alma Seefeldt Klug, 91, and Alfred H. Seefeldt, 95, both of West Bend, the oldest lady and gentleman present; 4-month old Jacob Laux of Dousman, youngest member present; and Chris and Matt Lawrenz of Mesa, Arizona, traveling farthest to attend. Milton and Margaret Seefeldt of Oshkosh, married nearly 60 years, were the longest married couple present; and Amy Stevens and Edward Netzer of Sheboygan were the most recently married couple.

Mary Jane Fink Johnson of Destin, Florida was recognized for her work in compiling the family's history. Her book, *The Descendants of Christian Friedrich Seefeld - A History of His Children Who Emigrated To America From Pomerania and Their Families*, was published in 1991 and won the 1992 Wisconsin Genealogy/Family History Book Award at the Annual Meeting of the State Historical Society in June. The award is given to the author of the book, which in the opinion of the awards judges, makes the most valuable contribution in presenting an individual genealogy pertaining to a Wisconsin family.

Fifteen members of the Knoeck family, a part of the Gottlieb Branch, received recognition as the largest family group present. The Jeff Seefeld family of Marshfield traveled the greatest distance in Wisconsin to attend the reunion (they were among the reunion guests trying to trace their Seefeld roots) and Fritz Klein traveled the shortest distance to the park. LeAnn Knoeck won the door prize, a copy of the family history book.

The secretary's report for the 1991-1992 "reunion year" listed 28 births, 7 deaths, 7 marriages and 2 members in the Seefeldt Ninety Club. Three members of the Ninety Club died during the year; Mrs. Ida Fink Weber of Fond du Lac at the age of 108, Miss Amalia Seefeldt of West Bend at the age of 92, and August H. Seefeldt of Kewaskum at 93.

Following the business meeting the Kettle Moraine Squares entertained with a square dance demonstration and family members were encouraged to join in the dances. The rest of the afternoon was spent in conversation, games, and viewing the family scrapbooks. Therese Casper and Sherri Knoeck were in charge of games. Alice and Merlin Crass; Jennifer, Julie, Doug, and Oscar Knoeck; Audrey Klumb; Chris and Matt Lawrenz; and Fred Seefeldt were in charge of arrangements.

# Letter to The Editor

Editor:

Washington County adopted the State Civil Service Ordinance pursuant to Wisconsin Statutes to provide fair and equitable treatment for all classified Sheriff's Department personnel. The Wisconsin State Supreme Court noted the importance of Civil Service when they stated in a court case that Civil Service laws were designed to protect employees and not positions. They also added that an employee accorded Civil Service status, and the public, have an interest in assuring that Civil Service employee is not deprived of his or her livelihood. Additionally, they stated that once a person attains Civil Service status, he maintains it.

What is happening in Washington County is that the Sheriff is trying to take Civil Service away by deputizing almost half of the classified work force,

some of who have been deputized more than twenty (20) years. This has resulted in a loss of available manpower and also a large turnover rate because of low morale of the workers after being "slapped in the face" by the Sheriff. The only thing that can be concluded by his actions is that he wants to hire and fire at will. A perfect example is what happened to Kurt Vogelsberg. The end result of this is that it will breed nepotism, fear and mistrust among employees as their careers can be thwarted by a mere stroke of the pen.

The Jailers and Dispatchers union is involved in a lengthy and bitter contract dispute and court case over this issue. The employees at the Sheriff's Department and the taxpayers of Washington County will suffer the most from these actions. I believe that the taxpayers of Washington County want and deserve accountability for the actions of the Sheriff. I do not believe the taxpayers of Washington County want a hostile environment at great expense to them where one man is judge and jury over the people who work under him.

## VILLAGE OF KEWASKUM ★ NEWS NOTES ★

The Village of Kewaskum recently had the water rates reviewed by the Public Service Commission. The rates were adjusted as well as some of the rules governing the operation of the utility. One of those rule changes is addressed in schedule B-1 which refers to the **Bulk Sale of Water**. This provision allows the Village to sell bulk water and to fill swimming pools and establishes the appropriate charges.

The utility personnel shall supervise the delivery of water and the customer shall be charged as follows:

Service charge - \$12.00  
Plus volume charge - \$2.00 per 1,000 gallons

If a pool is filled the contemporary method the customer pays \$1.03 or \$.81 per 1,000 gallons for the water and \$1.718 per 1,000 gallons for sewage.

*Example:* To fill a 15,000 gallon swimming pool using the new method the cost would equal:  
\$12.00 plus \$2.00 times 15 equalling \$30.00 for a TOTAL of \$42.00.

To fill a 15,000 gallon swimming pool using the contemporary method the cost would equal:  
\$1.03 times 15 equalling \$15.43 plus \$1.718 times 15 equalling \$25.77 for a TOTAL of \$41.22.

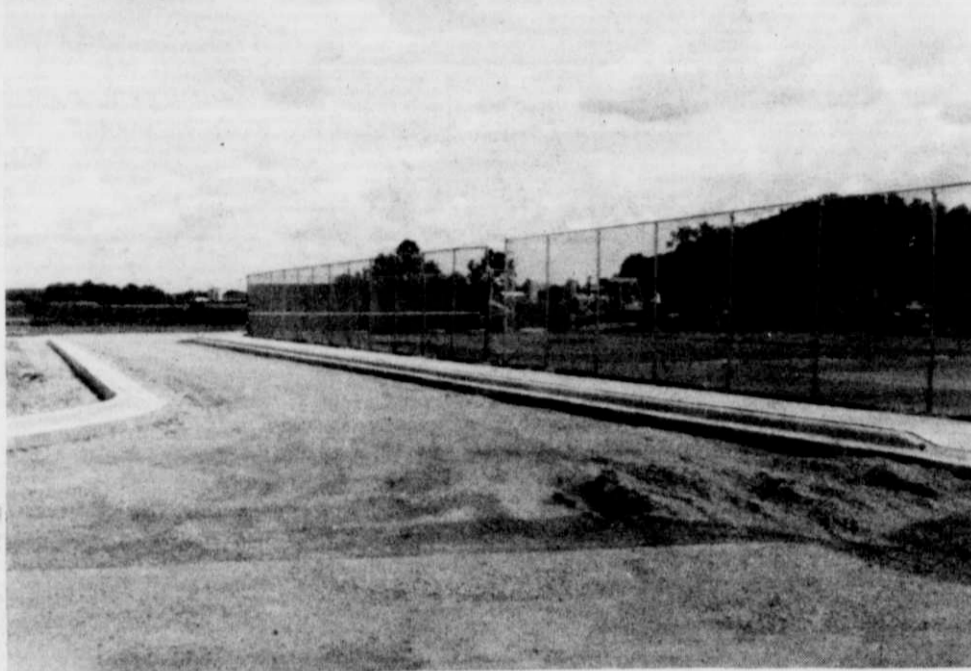

## County Multi-Jurisdictional Drug Unit to Receive Federal, State Funds

The Washington County Multi-Jurisdictional Drug Unit will again be receiving Federal and State funds in addition to local matching funds to continue its drug enforcement efforts in 1992-1993. At a July 17, 1992 meeting the Governor's Law Enforcement and Crime Commission approved a grant request submitted by the Washington County Multi-Jurisdictional Drug Unit. The grant award includes \$67,067 in Federal funding, along with \$13,413 in State funds and \$8,942 in local funds, for a total of \$89,422. The local funds are contributed by the law enforcement agencies who, along with the Washington County Sheriff's Department, comprise the Washington County Multi-Jurisdictional Drug Unit. These agencies are the West Bend Police Department, Germantown Police Department, Hartford Police Department, Kewaskum Police Department, Slinger Police Department, and Jackson Police Department.

This grant award is obviously beneficial in that it reduces the strain on the County budget with no reduction in the aggressive manner in which the Washington County Multi-Jurisdictional Drug Unit and its member agencies continue their drug enforcement and anti-drug abuse efforts throughout Washington County.

These efforts continue to be successful as indicated by records showing that in 1990 and 1991, ninety (90) defendants were referred to the District Attorney for felony prosecution. Therefore, in 1992 the Washington County Multi-Jurisdictional Drug Unit has prepared cases against twenty-five (25) defendants. It is of note that many of these defendants face multiple felony charges.

The impact of these drugs enforcement efforts in Washington County is also reflected in the penalties imposed on the drug case defendants. In 1991, thirty-four such defendants were sentenced in Washington County courts. These sentences totaled fifty-one (51) months of County jail, sixty-eight and one half (68½) years of probation, eighty-eight (88) years of prison sentences, fifty-three (53) of which were stayed, and \$68,557 in fines and assessments.

The Washington County Multi-Jurisdictional Drug Unit continues to welcome citizen involvement in its county-wide drug enforcement effort. The Kewaskum School District is committed and dedicated to the task of providing the best education possible for every child in the District for as long as the student can benefit from attendance and the student's conduct is compatible with the welfare of the entire student body.

The right of the student to be admitted to school and to participate fully in curricular, extracurricular, student services, recreational or other programs or activities shall not be abridged or impaired because of a student's sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability.

Complaints regarding the interpretation or application of this policy shall be referred to the District Administrator and processed in accordance with procedures established by the Discrimination Complaint Procedure.

- 1) Any student, parent or resident of the School District complaining of discrimination on the basis of sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability in school programs or activities shall report the complaint in writing to the District Administrator.
- 2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant.
- 3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.
- 4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.
- 5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

Highway 45 was put in sometime in the 1920s. Before that, if you wanted to go to Milwaukee or anywhere else of any distance, you would often have to find a spot on the way and ask for directions. It was not unusual to find someone who would misdirect you on purpose.

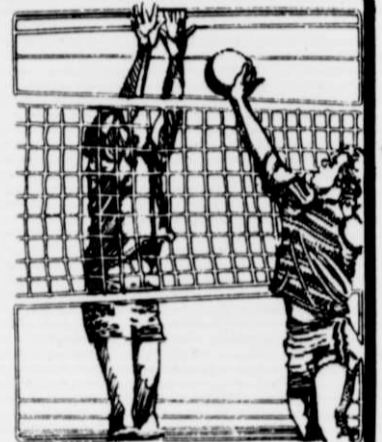

Local wrestlers Greg Guelig, ten year old son of Steve and Linda Guelig, and Joel Dziedzic, thirteen year old son of Jeff and Kathy Dziedzic, along with Greg's father, Steve Guelig recently returned from Japan. They were part of an entourage of eighteen young wrestlers and five coaches chosen from throughout Wisconsin to participate in the July of 92 Wisconsin to Japan Wrestling Exchange Program.

This was no ordinary trip for our 'boys'. Although Joe, Greg, and Steve had traveled to many different states in America, none had traveled abroad before. They met the exchange group in Chicago and began their venture with a 13 hour flight to Japan. Greg and Steve Guelig were deservedly anxious before the flight because it was the first time either of them had flown. According to Steve, the flights to and from Japan turned out to be "pleasantly uneventful," while Greg found viewing the mountains and lakes from the plane absolutely fascinating.

The wrestlers and coaches adjusted to the 14 hour time difference remarkably well, adequately learned to say words like "hello" and "thank you" in Japanese and quickly exchanged their money for Japanese yen. And although it rained the first week, sunny skies found their way into the forecast for the remainder of their stay.

Greg and Joel both fared well at the five wrestling meets they participated in while in Japan. Greg won six of seven matches, while Joel won four of five. Greg also participated in the Japanese Nationals; unfortunately, he did not fare as well there. He lost his first match and according to Japanese wrestling rules, a wrestler is automatically eliminated after one loss. (Because Joel was over 12, he was not eligible to participate in the National competition.)

Nevertheless, a few losses didn't dampen Greg or Joel's spirits while in Japan — experiencing Japanese culture was what was foremost on their minds. Staying at host families' homes, they discovered things like "Coke-Cola" as part of a balanced breakfast, very small bedrooms with only mats for beds, distinctly different bathroom facilities, and no chairs at the dinner table. They also developed an expertise in shoe removal because it is a Japanese custom not to enter homes and other establishments with shoes on. Cookouts didn't include Wisconsin grilled hamburgers and brats; instead, stir-fried baby octopus and

vegetables were on the menu. For entertainment, watermelons were broke open with a large stick rather than pinatas filled with candy. Greg, Joel and Steve found time to visit shops, schools, subways, graveyards, temples, waterfalls, and even a McDonald's Restaurant.

All in all, the trip was a huge

success — one definitely worth repeating. New friends and many wonderful memories were created. Greg Guelig and Joel Dziedzic, along with their families, would like to sincerely thank all those businesses, friends and family who sponsored them to help make this opportunity possible for them.

## County Officers Aid Hartford in Drug Seizure

On July 22, 1992, a search warrant was executed in the City of Hartford by officers of the Hartford Police Department, and members of the Washington County Multi-Jurisdictional Drug Unit.

The search warrant was executed at approximately 5:30 p.m. and as the result of the execution of the search warrant, marijuana plants, and other drug paraphernalia was seized. A 23-year-old Hartford man will be referred to the District Attorney's Office for charges.

This matter remains under investigation by the Washington County Multi-Jurisdictional Drug Unit which is supported in part by a grant which includes \$77,000 in Federal funding. This \$77,000 represents approximately 75 percent of the total grant award.

Yesterday at work, I got a call from my daughter, Jenni. She was so excited because she had an injured Heron in her yard. I was out of the Shelter in a flash, nets in hand. I must admit, I was also very excited. I have always admired the elegant Heron from afar. Now I had the chance to not only see one close up, but perhaps help it find its way back to the wild.

As I pulled into Jen's driveway, she motioned me to be very quiet. I turned off the car, stepped out and slowly got the nets. Without speaking, we headed down a small slope and into the swamp. "Can you see it?" Jenni whispered, pointing to a delicate head in a small clump of bushes. I told her to go slowly as we approached the bird. As quietly as we could, we inched forward. This magnificent bird heard us and tried, in vain, to fly away. Jenni took one net and went right. I circled around to the left with my net, trying to stop the bird from going further into the swamp. We were waist deep in rushes. The mosquitoes were having a ball because Jenni was only wearing shorts and a tank top.

"I got him", she yelled. As I waded toward her, I was praying that the bird would not become too frightened and die. I can't describe the incredible feeling that came over us as we glanced down at this beautiful, golden eyed, grey bird with the long yellow beak. Being cautious of its long beak, we carefully lifted the net, got control of the neck and covered the bird with a sheet so that we could get it to Wildlife Rehabilitator Jean Lord.

Gingerly I slipped into my car, holding the birds body with one arm and its long, slender neck with my other hand. Off we went. Once during the ride, the bird

stretched its head so fast and unexpectedly, that I lost control of the delicate neck I was holding. Its beak reached toward, Jen's face. I have to laugh when I think of how fast she hit the brakes, had her head out the window, with her arms fully stretched to reach the steering wheel.

We got to the rehabilitator in record time. After a brief examination by Jean, the bird seemed to settle down. There were no obvious injuries. The bird would see the Vet the next day to determine

why it couldn't fly. We left with a feeling that all would be well.

As we were driving home, the bird was all we could talk about. We both felt honored to be able to be a part of this great birds future. I was reminded of an old saying that goes something like this, "If you talk to the animals, they will talk with you and you will know each other. If you do not talk to them, you will not know them. And what you do not know, you will fear. What one fears-one destroys"

Think about it. Remember, the animals were here first.

## Lottery Credit Multiple Claims

WEST BEND....Washington County Treasurer, Fredric A. Seefeldt, announced today that there are situations in Washington County where property owners can rightfully claim more than one lottery credit on a given parcel of land. He pointed out that there will be a special line to cover those situations on the lottery credit claim postcards being mailed out the end of this month.

"Multiple claims were correctly made for the lottery credit on last year's tax bills and we anticipated that the same will be true for this year," said Seefeldt.

"One example would be a duplex jointly owned by two parties and each party occupies one of the units as their primary residence. That property would be entitled to two lottery credits," said Seefeldt.

"Another example would be the

family farm owned by several family members either through a farm partnership, joint ownership, or a farm corporation. If the parcel in question had a duplex on it or more than one farmhouse and each dwelling unit were occupied by one of the owners, then the parcel would qualify for more than one lottery credit," instructed Seefeldt.

"The owner receiving the postcard should write in the number of eligible dwelling units in the space provided on the return postcard," said Seefeldt.

If property owners are not sure of their eligibility, they can call my office for additional information. Our office telephone numbers will appear on the postcards including our Metro and Hartford area numbers," said Seefeldt.

The postcards are due back to the County Treasurer by October 1.

Application forms were given to each family on registration day. To apply for free or reduced price meals households must fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials. Applications may be submitted at any time during the year.

To obtain free or reduced price meals for children for whom households receive Food Stamps or Aid to Families with Dependent Children (AFDC), an adult member needs only to list the names of the school children, give Food Stamp or AFDC case number for each child, sign his/her name and return the application to the school office. Households must inform the school authorities when they no longer receive Food Stamps or AFDC.

For the school officials to determine eligibility for free or reduced price meals of households not receiving Food Stamps or AFDC, the household must provide the following information requested on the application: names of all household members, and the social security number of the adult household member who signs the application. In lieu of a social security number, the household may indicate that the signer does not possess a social security number. Also, the income received by each household member must be provided by amount and source (wages, welfare, child support, etc.). Households are required to report increases in income of over \$50 per month or \$600 per year and decreases in household size.

Under the provisions of the free and reduced price meal policy, the District Administrator will review applications and determine eligibility. If a parent or guardian is dissatisfied with the ruling of the official, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent/guardian wishes to make a formal appeal, he/she may make a request either orally, or in writing to: Mr. Neal Weare, School Board President, W1065 Auburn-Ashford, Campbellsport, WI 53010, phone: 626-2782. If a hearing is needed to appeal the decision, the policy contains an outline of the hearing procedure.

If a household member becomes unemployed, or if the household size changes, the family should contact the school. Such changes may make the household eligible for reduced price meals or free meals if the household income falls at or below the levels shown above, and they may reapply at that time.

In certain cases foster children are also eligible for these benefits. If a household has foster children living with them and wishes to apply for free or reduced price meals, the household should complete an application for a family of one or contact the school for more information.

The information provided by the household on the application is confidential and will be used only for purposes of determining eligibility and verifying data.

In the operation of the child feeding programs, no child will be discriminated against because of race, color, sex, national origin, age, or handicap. If any member of a household believes they have been discriminated against, they should write immediately to the Secretary of Agriculture, Washington D.C. 20250.

Any questions regarding the application should be directed to the determining official.

## Wisconsin Goose Hunters Can Expect Reduced Harvest This Fall

MADISON... Wisconsin's 1992 maximum allowable harvest of Canada geese will be 66,700 birds... down about 100,000 from last year, following Mississippi Flyway Council recommendations of major harvest reductions for states harvesting Mississippi Valley Population (MVP) geese, Jon Bergquist, Department of Natural Resources waterfowl and wetland wildlife ecologist, said. "Although initial 1992 Canada goose production estimates appeared near average, most of the gosling production was lost as a result of a major snowstorm on June 28," Bergquist said. "Banding crews working the coast of Hudson Bay reported finding almost no goslings in the normal brood rearing areas along much of the coast."

Because harvest objectives are based on gosling production, states harvesting MVP geese will face major harvest cuts this year. Gosling production in 1990 and 1991 was considered average and Wisconsin received 65,000 and 57,000 bonus birds in addition to our base quota, which was over 110,000 for those years.

Due to the snowstorm, Wisconsin hunters will see reduced Canada goose seasons in 1992 and may face similar restrictive seasons in the next couple of years to allow the population to recover, Bergquist added.

"We are now preparing recommendations for our season framework based on the harvest objectives recommended by the Flyway Council," Bergquist said. "These recommendations will be reviewed by the U.S. Fish and Wildlife Service in early August." Meetings were scheduled with the Conservation Congress Migratory Bird Committee in Stevens Point on August 7 and with other interest groups in Stevens Point on August 8.

Public hearings on Wisconsin's

proposed waterfowl season will be held in Wausau on August 11; La Crosse on August 12; and Waukesha on August 13. The Natural Resources Board will set the 1992 waterfowl season at its meeting on August 20 in Superior.

Bergquist anticipates that Canada goose hunters will face seasons similar to those in 1988 and 1989 to ensure that the population is not over harvested. He noted that although the harvest objective is substantially reduced from last year, Wisconsin Canada goose hunters will have better hunting opportunities than they had in the mid 1980s.

Proposals for the 1992 Canada goose season include the following:

\* Canada goose hunting in the state will open no earlier than Sept. 26 this year, possibly later.

\* Daily bag limits will drop to one bird per day. Last year's daily bag was two birds per day, when our statewide quota was about 185,000 birds.

Season length in the Exterior Zone will be 80 days or less and the season will close early if the harvest objective is reached before 80 days.

\* Hunters selecting the Horicon Zone (including the former Pine Island and Theresa zones) will probably receive only one or two tags, depending on the total number of applications received. Hunters will again be restricted to hunting in only one zone and time periods will probably be less than 30 days in length.

\* Collins Zone hunters will also receive fewer tags this year and be restricted to a daily bag of a one bird.

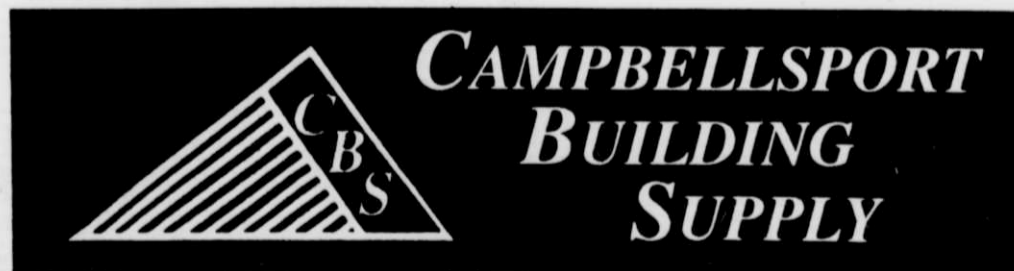
