Country Music Festival Proposed for This Area

A Town of Auburn Planning Commission meeting on Monday, May 17 at 7:00 p.m. at the Auburn Town Hall (Hwys. 45 and 67) will have a large bearing on the future of organized professional entertainment being presented in this area.

Bill Heberer of Kewaskum (Town of Auburn resident) has asked for the rezoning with the idea of developing a Country Music festival and locating it in the township.

Plans for the festival are slated for the summer of '94 and will be sponsored by the Bill Heberer family along with long-time friend Dale Trinrud and his family. "I've been a country music fan for years and wondered why this couldn't be done in the area," comments Bill.

Similar three day festivals are held around the state such as Country Jam, USA in Lake Geneva and the Hodag Country

Festival in Rhineland. Big names head the line-ups -- Dolly Parton, Kenny Rogers, Alan Jackson, Billy Ray Cyrus, Tanya Tucker and Vince Gill, to name a few.

The proposed site is located in the town of Auburn, 3 1/2 miles north of Kewaskum, and development includes the improvement of over 100 acres. Roads will be put in as well as portable stages, light and sound equipment, camping facilities, parking facilities, food stands and more. Areas will also be available for vendors and the sale of country western apparel. The open air festival will take place rain or shine.

Bill, in the process of seeking approval from the Planning Commission, said "I feel it will be a great asset to our community and area businesses. There's a lot of enthusiasm out there for a festival like this."

Fire Equipment Truck to be Bid Out

KEWASKUM -- The Kewaskum Village Board last Monday night voted to send out for bids on a custom fire equipment truck proposed by Fire Chief Mark Groeschel.

Groeschel went to the board for approval to negotiate with a Madison, Alabama, company to build the custom truck, which would have a total cost of around \$160,000.

"It would be perfectly fine," village Administrator Dan Schmidt said, noting that the Village does not have to bid out for the equipment.

But trustees Gary Gavin and Tom McElhatton said they had problems with that idea, noting that the Village could possibly save money by bidding out.

But Groeschel argued that the specifications needed by the department would not be satisfied by some of the other companies' prices. He added that the group from Alabama was the only company who would work with the Department and what they wanted.

The department's current truck, a 1966 model with no air conditioning, heat, or seat belts, is in dire need of replacement,

according to Groeschel. "There are some guys in the department that will not drive it," because of safety reasons, Groeschel told the Board.

Groeschel also noted that the Village has not replaced a department truck since 1982. The only other equipment change since then took place in 1987, when the department bought a new truck and donated

it to the village.

But McElhatton said he didn't want to rush into negotiating before he was sure that the Village got the best deal.

"I would feel a whole lot better if we wrote up some specs and bid them out," McElhatton said. The rest of the Board agreed, and voted to send out for bids.

New Additions to Committees

KEWASKUM - The election of Robert Wagner as the new Kewaskum Village President means that there will be several new members on the various Board committees.

Taking Wagner's trustee position is Charles Waala, who will also serve on three separate committees. Waala will be on the Protection and Public Safety, and Public Services Committees, and will also be the Board's representative on the Library Board, assuming the position left by Wagner's promotion.

Fellow trustee Harry Roecker will also be serving on a new committee, taking over for Wagner on the Park and Recrea-

tion group.

In addition to Waala, the Library Board will have three more new faces, meaning there will be an 80 percent turnover rate from the last Board. Clark Pearson, Cheryl Ammel and Betty Hallen will all be serving as new members of the Board.

August Bilgo will be the lone new face on the Police and Fire Commission, while Gene Bohn and John Stephani will serve on the Board of Appeals.

Trustee Tom McElhatton will join Wagner as members of the Planning Commission, as will Paul Ziebert. The Citizens Advisory Board will also have some new faces, with Larry Martin and Dennis Kuehl joining the committee.

Thefts On the Increase

Village Not Necessarily a 'Speed Trap'

KEWASKUM -- Though the Village is often referred to by people as a speed trap for area motorists, figures released by the Police Department last Monday seem to indicate otherwise.

Only about one in five motorists stopped in 1992 actually received a citation, according to the annual report issued by Police Chief Richard Knoebel. A total of 1,776 warnings were given, compared to just 471 citations. Of those 471 citations, 271 were for speeding, a rate of about five per week.

"I hope people realize that this isn't a speed trap," Trustee Tom McElhatton commented on

the report.

On the negative side, total index crimes reported to police increased in 1992 by 73.8 percent. Thefts increased 94 percent, from 51 in 1991 to 99 in 1992. Violent crimes increased 400 percent, from one in 1991 to five last year.

"When you have very low numbers like these, it can really make your percentages jump," Knoebel explained to the Village Board. He noted a positive in the index crime figures, reporting that the number of motor vehicle thefts went from six in 1991 to just one last year.

Of the 108 index crimes reported, 57 (or 52.8%) were cleared by arrests. That clearance rate is more than double

the statewide rate of just 24.5 percent.

The Village's property recovery rate (58.9%) was also much better than the overall state rate (34%), although it was down some what from the previous year's mark of 76.9 %.

Knoebel explained that more cash was stolen last year, "which makes it harder to get back."

Complaints were on the rise last year, as well. A total of 1688 complaints were handled, compared to 1991's figure of 1455. The number of total arrests (adults and juvenile combined) was also up, from 376 in 1991 to 422 last year.

In the nearly 30 years it was a federal prison, no one ever permanently escaped from Alcatraz.

KMS Music Students Attend Performance Of Milwaukee Symphony Orchestra

On Wednesday, April 28th, music students from Kewaskum Middle School attended an educational performance by the Milwaukee Symphony Orchestra at the Performing Arts Center in Milwaukee.

The theme for this one hour performance was; Creativity in Music. Before playing each piece, Conductor Neal Gittleman posed the question, "What if...?"

The first selection, "Battalia", written by Biber consisted of eight very short movements expressing the events of wartime. The brass, woodwind and percussion are not written into this piece, which led to the question, "What if there were no life and drum how could you acquire their musical sound?"

The sound of the fife was accomplished by the violins playing very high notes, and the drum sound was accomplished

by waving a piece of paper between the double-bass strings and striking the strings with the bow. To achieve the sound of swords in battle, the musicians tapped on their instruments with their hands or bows.

The second selection was the final movement, "Farewell," to Haydn's symphony No. 45 in F-sharp minor. This piece was composed for an Austrian prince for whom Haydn and his orchestra worked. The Austrian prince had a secluded vacation spot in Hungary, where he stayed during the summer months.

Haydn and his orchestra also went for the summer too summer to entertain the prince, which meant they were away from their families for a very long time. One summer, the prince was enjoying himself so much he decided to stay longer, which meant Haydn and his orchestra also stayed. After a time, the musicians missed their families very much and they asked Haydn to tell the prince they wanted to go home. The question posed for Haydn was, "what if I need to tactfully convey a message and not hurt the prince's feelings?" So Haydn wrote, "Farewell," and to get the message to the prince in a very

tactful way, as the piece came to a close the musicians left the stage one by one, leaving only 2 violins to finish the piece. The prince got the message and everyone returned home to Austria the next day.

"What if you need to address a shocking subject?" This was the question Stravinsky answered in the third piece, "Danse Sacrale" which addressed the subject of human sacrifice. A colony of people who lived a short distance away, celebrated the rite of Spring by sacrificing a young woman. This colony felt the sacrifice they offered to their gods would bring a fruitful spring and summer. This peace was considered "shocking music" because of the syncopation and the blend of many melodies.

The final piece, written by Beethoven in 1772 answered the question, "What if you would like to express honor and respect for a hero? Beethoven's hero was Napoleon, for whom this piece was written. When played in its entirety the symphony lasts about 45 minutes, the longest written up to that point in time. The last movement "Eroica," which lasts about 15 minutes, concluded the performance.

"The postcards carry the coat of arms of the State of Wisconsin to distinguish them from promotional materials," advised Seefeldt.

"Your primary residence is where you live most of the time. When you are temporarily away, it is the home you ordinarily return to. You can have only one primary residence," Seefeldt quoted from the form.

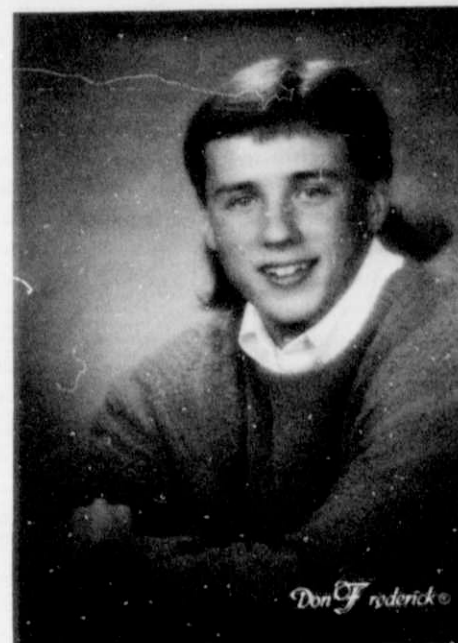

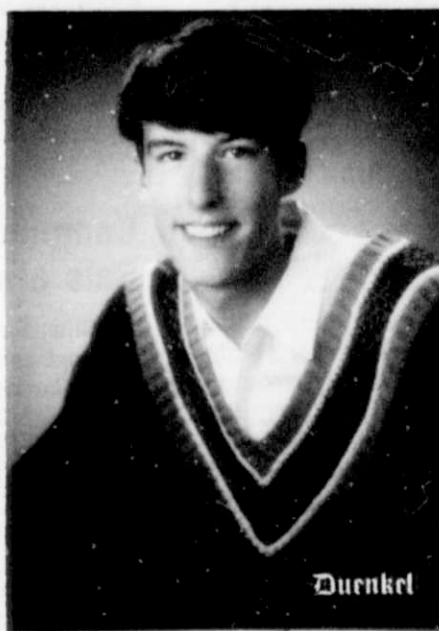

The Town of Auburn Planning Commission is meeting on Monday, May 17, 1993, at the Auburn Town Hall, Highway 45, to consider rezoning of 120 acres of agricultural land to rural development for the purpose of developing an outdoor music festival with a permanent viewing stand and camping sites.

We are totally opposed to this rezoning of 80 acres (owner, Jim Kieckhafer, West Bend--the former Ed Ferber farm) and 40 acres (Maynard Bartelt, Campbellsport). Not only will our properties be devalued up to 25 percent or more, we will also be subject to the noise, dust, garbage, drug and alcohol abuse, traffic, trespassing, and other abuses which occur on adjoining properties of the Country Western Hodags at Mole Lake, Rhinelander and Eau Claire.

We urge all interested citizens to attend the Auburn Planning Commission meeting on May 17 to hear the presentations. We believe that safer, better options are available to these music fest promoters including Dodge County Fairgrounds with some 500 acres of available parking or the 200 acres of land on and adjoining the property and residence of one of the promoters.

We also would urge the Kewaskum Chamber of Commerce members to reconsider their hasty recommendation of this country music fest without knowing the exact location it would be held and without considering all the repercussion and after effects of holding such a fest in this community.

--The Postal Service delivers to nearly 50% more addresses than it did 20 years ago? (That's more than service for your money... especially if you or family members live at one of the 80 million new addresses.)

--We deliver to 116 MILLION households and business addresses?

--We will keep future postage rates below the rates of inflation by using automation and innovation to reduce our costs?

--To hold down postal costs in the future, bar codes will guide virtually all mail through an automated postal system by 1995?

--Through participative management, we are identifying ways to work smarter... and cheaper?

--We continue to enhance customer convenience through stamp sales in grocery stores and other retail outlets, through Stamps by Mail and Stamps by Phone?

--Thanks to the automated equipment currently in place, the Postal

After reading all of this, I am hoping that I could put a little "insight" into all the Postal Service strives to do for YOU... our customer! Like any other business, we DO MAKE MISTAKES and will be the first ones to admit that! In next week's column, I will cover the "avenues" that you, as a customer, can take to vent your feelings and let the entire postal organization realize the "personal bad feelings" that you just may have had with our services. Hope that you will be looking forward to this "valued information." Now some POSTAL TIPS OF THE WEEK:

--ALWAYS put your return address on each and every letter and parcel that you mail out. IF, for some reason, it cannot be delivered, the return address will enable us to return it to you "in a speedy manner" (with the reason for non-delivery). Without a "return address," a piece that is undeliverable will go to the "dead letter office" and it will "take some time" to get it returned to you, if it can be returned to you at all. (The contents inside are read and "fathomed out for who it can be returned to").

--Mailing a letter to a foreign country (excluding all military addressing)? PLEASE make sure that appropriate postage is applied as even if it makes it "all the way to the country," if sufficient postage is not applied... it will be returned to you. Foreign mail DOES NOT GO ON "POSTAGE DUE." It is not allowed. Stop in and see us and we will weigh those letters for you. Rates are: 50 cents for UP TO ONE HALF OUNCE and 95 CENTS FOR A FULL OUNCE (note... 29 cents in the United States covers UP TO A FULL OUNCE).

Hope that you found this column to be interesting and informative. In closing... I LOVE WRITING THIS COLUMN... I JUST LOVE KEWASKUM... THOROUGHLY ENJOY BEING YOUR POSTMASTER! TRY to have a good day... a happy every day.

Huskies Sweep Pair from KHS Girls

KEWASKUM - Defense has been a bit of a liability for the Kewaskum girls softball team this season, and that trend continued here, last Thursday in a doubleheader against New Holstein.

Indian errors led to several big innings by the Huskies, who took both games from KHS. New Holstein blasted the Indians 12-5, while the Huskies overcame eight errors in the nightcap to pull out a dramatic 10-9 win.

"We had a lot of errors, both fielding and mental errors," KHS coach Janet Molebash said of the team's bad day. "When you have that many errors (15 total), you're not going to win that many games."

In the opener, the Huskies jumped out in front with three runs in the top of the first. That continued another trend that has seen the Indians fall behind early in their last four games.

"A lot of our errors occur at the beginning of the game," Molebash pointed out, noting that six of the Indians' eight errors in the opener came in the first three innings. "We always seem to

start out real sluggish."

But as usual, Kewaskum battled back, scoring a pair in the bottom half of the inning. Julie Wagner's two-run triple closed the margin to one, as the hit scored Rachele Krahn and Julie Mertz, both of whom had singled.

The Huskies upped their lead to 6-2 with two in the third and another in the fourth. New Holstein then put the game away with six runs crossing the plate in the fifth.

The Indians scored a single run in the bottom half of the inning, thereby not getting ten-runned. The Huskies ended up with the same number of hits as the Indians, 10 apiece, but eight KHS errors spelled the difference.

Wagner and Angie Bindrich each had a pair of hits for the Indians, while Hochrein had three for the Huskies.

In the nightcap, New Holstein once again took the early lead with two in the bottom of the first (New Holstein was the home team because it was a makeup game). Two Indian errors led to the runs.

Kewaskum came right back to take the lead with three runs in the second inning. Shelly Williams and Tanya Laubach each had RBI hits in the inning. The Huskies upped their lead in the second with three more runs,

and added another in the third after KHS had cut the lead to just 5-4.

The Indians regained the lead in the fifth, scoring three runs. Two came on a sacrifice by Stephanie Heberer.

Down 7-6, New Holstein rallied for three more runs in the fifth, using a pair of Indian errors to their advantage. Field Events Help KHS Boys To Fourth Place at Vanderpan

SHEBOYGAN FALLS - It's been a while since the boys track program at Kewaskum has been competitive with the other schools in the Eastern Wisconsin Conference. But from the looks of things at the Vanderpan Invitational here, last Friday, KHS coach Jerry Gosa has the Indians on the right track, literally.

The KHS boys finished fourth in the nine-team meet with 73 points, just four points out of the runner-up spot. Southern Door (144) ran away with the meet, while New Holstein was second (77) and Sheboygan Falls third (76).

"It was a good showing," Gosa concluded regarding the meet. "It was interesting to see that our jumpers (field events) did so well. They all had good nights."

Sophomore Travis Jacak had his best day, clearing the 6-3 mark in the high jump, which was good enough for first place. "He's jumping real well right now," Gosa said. "He's probably looking at clearing 6-4 real soon."

Brian Bruendl also had a personal best, leaping 39-10 in the triple jump, also good enough for first. "That's over a foot better than his previous personal best," Gosa noted.

The Indians lone other win came in the long jump, where Jim Wichtoski continued to shine. The senior went 20-4.5 to take the top spot. Teammate Wade Kreis went 19-3.5 (fourth) to give KHS a double place in the event, one of three for the Indians in the field events.

Pole vaulters Brad Jackson (12-6) and Wade Kreis (11-6) finished second and fourth, respectively, while shot putters Jim Rix (44-9) and Dan Schulteis (43-10.75) were third and sixth. Rix's throw was his best ever as well.

Jeff Dirmeier ran his fastest 800 race (2:04.8), good enough

for fourth, and added another fourth in the 1600 (4:45.5). Junior Randy Thull also had his best two-mile clocking (10:36.27), which placed him fourth.

"That's five seconds faster," than his previous best, according to Gosa, who added, "He represents our first real threat in the two-mile race in quite awhile."

The Indians' 400 relay (fourth, 47.36) and 3200 relay (fifth, 3:44.86) also placed.

Somewhat hampering the KHS effort was the absence of David Gosa, who along with Dirmeier, forms a tough 1-2 punch for the Indians in the distances. Gosa is out with bronchitis, but may be back in time for Thursday's conference meet at Plymouth.

"We still have a ways to go," Gosa said, although pleased with the effort. "Things are going pretty well."

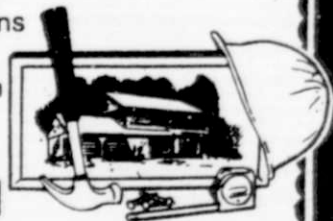
