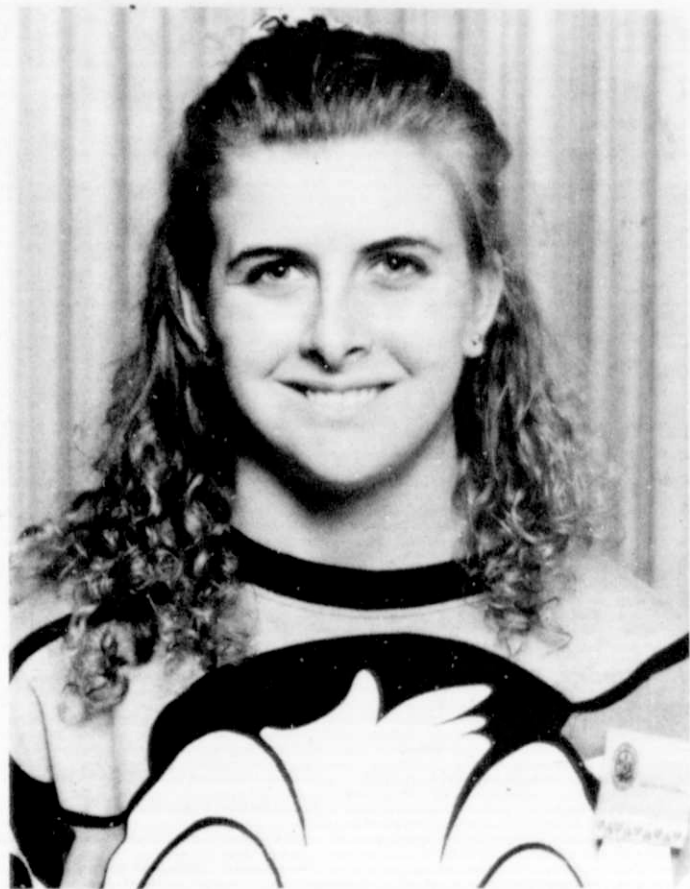

Birthdays for June are Ryan DeLaurier, Spring Gehring, Jenny Johnson, Kimberly Erdmann, and Heather Hackbarth.

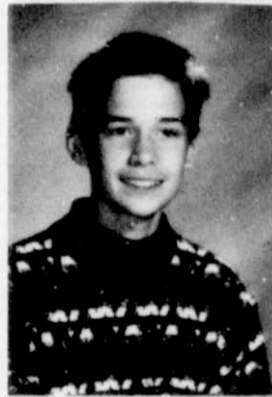
The motion to adjourn the meeting was made by Kimberly Erdmann and Kathy Deshotels.

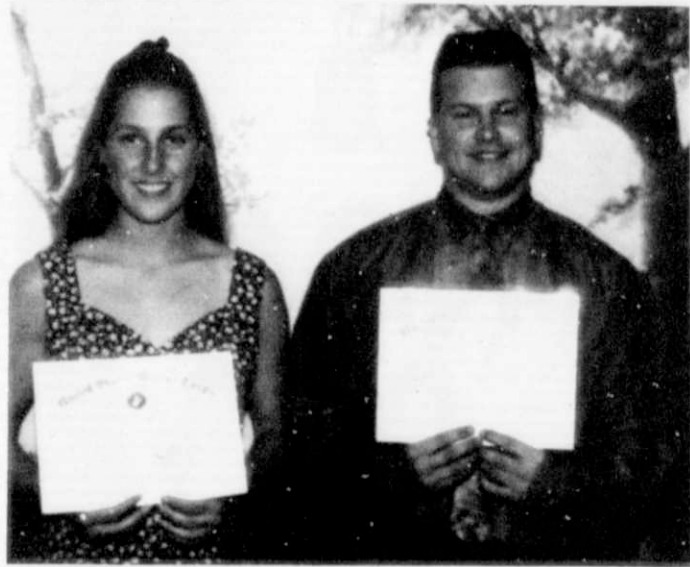

Vogt, Kohl Collaborate in Making Gallium Arsenide More Useful

The following article reprinted from Georgia Tech Research News highlights the work of a 1984 KHS graduate, Kirkland Vogt, now a graduate student at the Georgia Institute of Technology.

An improved technique for growing stable insulating films on the surface of gallium arsenide semiconductors could help make the optically- important material easier to process and expand its range of potential uses.

The technique, which could also be used with other III-V compound semiconductors, produces stable nitride films at low temperatures and without damaging the fragile crystalline structure of the material. Researchers at the Georgia Institute of Technology say the thin films could be used as insulating layers in circuits -- or even to "passivate" an entire gallium arsenide device, protecting it from corrosion, mechanical damage and electrical deterioration.

Details of the process will be presented to the spring meeting of the Materials Research Society April 12 in San Francisco. The work was supported by the Air Force Office of Scientific Research through the American Institute of Chemical Engineers (AIChE).

"This could potentially open up a number of technologies and device applications for gallium arsenide that don't exist today," explained Dr. Paul A. Kohl, professor of chemical engineering at Georgia Tech. "This is one of the processing steps that would make gallium arsenide and other III-V semiconductors more like silicon and more attractive for use."

Gallium arsenide offers optical properties and speed advantages which make it attractive for use in electronic and optoelectronic applications, but processing difficulties and other disadvantages have limited its use. One of those disadvantages is that gallium arsenide does not form stable insulating oxide compounds -- unlike silicon, now the most widely-used semiconductor material.

Because III-V compounds develop unstable oxides, they must be passivated through a complex process to prevent corrosion damage and changes in electronic properties. Existing passivation processes, however, use high temperatures or high energy particles which can damage the fragile crystalline structure which gives gallium arsenide its attractive properties.

"The goal is to come up with a relatively benign set of conditions for growing this insulator, and to do it by consuming the base material just like you would in growing silicon dioxide on silicon," Kohl explained. "We are trying to keep the temperature as low as possible (300 to 400C) to keep the gallium arsenide from

decomposing."

The Georgia Tech process, developed by Graduate Student Kirkland W. Vogt and Kohl, uses chemical energy to create the desired surface changes rather than kinetic or thermal energy used by existing processes.

The process begins with a through cleaning of the gallium arsenide surface to remove the native oxide. The semiconductor material is then treated to remove as much arsenic as possible from the surface maximizing the amount of gallium metal available for reaction.

The sample is then placed in a heated, oxygen-free reaction chamber. Small amounts of hydrazine, a reactive chemical better-known as a rocket fuel, is then vaporized into a carrier gas. The gas then flows over the heated gallium arsenide.

Because it is an unstable molecule, hydrazine splits into two reactive nitrogen molecules. The nitrogen species react with the gallium on the surface to form a nitride compound which is electrically insulating and chemically stable.

The thin coating serves to prevent unwanted electrical currents from flowing, halts corrosion which would otherwise take place on the gallium arsenide surface, and prevents mechanical damage to the crystalline semiconductor.

"III-V compound semiconductor devices are used for optoelectronics, lasers, light-emitting diodes, photodetectors and electronic devices, Kohl noted. "In all of these applications, you could use this process."

The Georgia Tech scientists believe the nitriding process could be used to insulate and seal the junctions of capacitors, to insulate areas between transistors, and to provide the dielectric layer for making capacitors. And because it uses low temperatures, the process could be used to passivate a fully-fabricated electronic device.

Vogt and Kohl have used photoluminescence techniques to show that their films provide improved insulating properties. They now plan to optimize the process by determining the processing steps, temperatures and film thicknesses which provide the highest quality films.

Using the facilities of Georgia Tech's Joseph M. Pettit Microelectronics Research Center, they are also building test devices to demonstrate that practical electronic devices can be built using the new technique.

Because of the reactive nature of hydrazine, Vogt designed a reaction system to contain the material during processing and to neutralize it afterward.

Also participating in the research project were Leslie Naugher, a chemical engineering undergraduate, Dr. Brent Carter of the School of Materials Engineering and Drs.

Ajeet Rohargi and Ajit Bhat from the School of Electrical Engineering.

A Place of Honor - at Last Civil War Veterans to Have Memorial Thanks to Grafton Man's Determination

Grafton -- James Andre's determination has become one soldier's gift to his fellow veterans.

Though it has taken nearly 130 years, Ozaukee County residents who died in military service during the Civil War will soon receive a lasting memorial. On June 5, a large wooden plaque bearing the names of 85 such veterans will be unveiled during a ceremony at Pioneer Village in the Town of Saukville.

The plaque is being paid for by Andre, a Grafton resident who attempted unsuccessfully to have it placed in or near the Ozaukee County Justice Center two years ago. It's a long-overdue tribute, Andre believes.

"I'm glad I found a place for this," he said. "It needs to be seen somewhere."

Andre, 82, made local headlines in late 1991, when he offered to pay for a \$350 Civil War plaque to be installed at the Veterans Memorial outside the Justice Center in Port Washington. At that time, though, members of the Ozaukee County Veterans Memorial Committee turned down his offer, stating that plans for their \$1000,000 project had been finalized.

The Veterans Memorial bears the names of 89 county residents who died in both World Wars, the Korean War and the Vietnam War. Members of the committee said they agreed to include only the names of fallen soldiers from 20th-century wars, primarily because few families of earlier veterans remain in the area.

But Andre, an Army veteran whose grandfathers both fought in the Civil War, wasn't satisfied. He couldn't have proposed a Civil War memorial any earlier since he only moved to Ozaukee County in March 1991, he said.

In any case, he wondered, when are soldiers too old to be remembered?

County officials not interested

Andre subsequently offered the plaque to the County Board, which could have approved its display inside the Justice Center. But that idea died in committee.

The reception his offer was given still bothers Andre.

"The least thing they could have done would be to accept

the plaque to be put somewhere," he said. "That kind of burned me up."

Frustrated, Andre withdrew his offer to the county. However, a member of the Ozaukee County Historical Society eventually approached him with the Pioneer Village plan.

"His idea is good, and there's no reason why it shouldn't be completed," said Peter Jacobsohn, a member of the society's board of directors who contacted Andre. "Furthermore, more people might be able to see it at Pioneer Village."

The plaque, Jacobsohn said, will fit in well with many of the Pioneer Village buildings which are vintage-1860s. "We also have a small collection of Civil War memorabilia, which makes it appropriate," he said.

Andre was happy to accept a new offer. He contacted a talented woodworking friend, Edwin Bretschneider of Newburg, to make the plaque. The collaboration proved fitting, since Andrew and Bretschneider served in the military together.

Attached to the emblem-shaped plaque are engraved metal plates, including 85 bearing the names of county residents who died in Civil War military service. Few are actually buried locally. Andre said, pointing out that "bodies were usually never sent home at the time."

Honoring Americans who have died serving their country is nothing new for Andre, a Kewaskum native. He's put up more than a dozen grave markers for Civil War soldiers in cemeteries throughout Washington and Ozaukee counties.

And he's researched and compiled lists of residents in both counties who served in the Civil War -- including home towns and dates, places and causes of death.

More than 380 locals served

According to Andre, 387 Ozaukee County residents served in the Civil War. Though he's uncovered the war-related deaths of 85 due to injury, illness and other causes, he believes there may be others. A number of local soldiers served with regiments outside Wisconsin, which makes finding information on them more difficult, he said.

But Andre has persevered, mainly because of his long time interest in military history. During World War II, he served in the Army's 40th Engineer Combat Regiment, which took

part in Allied invasions of southern France and Sicily.

His grandfathers, Fred Andre and Peter Kohn, both fought for the Union during the Civil War. They died years later.

Andre's memorial plaque will probably be displayed inside a 19th century log cabin moved to Pioneer Village from Cedarburg last year, Jacobsohn said. Fittingly, the dedication will take place during a Saturday encampment by a Civil War re-enactment group. The events will be open to the public.

Members of the Historical Society are looking forward to having the plaque become a permanent fixture at Pioneer Village, according to Jacobsohn.

"I'm glad that we were able to turn a negative thing into a positive thing," he said.

QUESTION: How does my name get on a particular mailing list?

ANSWER: One company will often "rent" a list of prospective customers from another company selling a particular product. So, once you've ordered, say, some cooking equipment, you will likely be receiving cook's catalogs.

QUESTION: There is a company that my friend gets catalogs from and I want to receive them also. What do I do?

ANSWER: If you want to be added to a mailing list, that is quite simple. All you have to do is get ahold of the particular catalog that you would like to receive. You may find a toll-free number to call or you can write to the mailing or subscription address listed.

QUESTION: I want my name removed from a mailing list. How do I go about doing that?

ANSWER: This is easier than you may expect. Many catalogs state their mailing-list policy, including an address that you can write to if you do not

want your name "rented" or "traded." If you do not want to be on national mailing lists, you can write to Mail Preference Service, Direct Marketing Association, 6 East 43rd Street, New York, NY 10017-4609.

QUESTION: I do a lot of shopping by mail. Most of the time I get just what was promised but there are some items that I am not at all satisfied with. What can I do?

ANSWER: The first place to notify is the company from which you ordered the item. The Postal Service can also help you. If you have trouble with a company that has no phone number listed and only a post office box for an address, you can write to the Postmaster of the particular city in which the post office box is located. Include a copy of the ad or the appropriate catalog page citing the post office box. The Postmaster can then send you the name and address of the company.

QUESTION: I received some "unwanted" and "unordered" merchandise. Not knowing what it was, I opened the package. I do not want this merchandise and do not feel that it is right that they sent it to me. The clerk at the Post Office told me that "once opened," I had to pay to return it. Any suggestions?

ANSWER: This is an excellent question and happens daily to customers across the country. By law, you have the right to keep anything that comes in the mail and you did not order. The first thing that will happen is that they will send you a bill for the merchandise. IGNORE IT! You will probably get a few more bills and then the "clinker"... the one that usually gets a customer to pay for the item or pay the postage to return it... a notice from the company that reads: "this matter is being turned over to a collection notice." You can STILL ignore this but if this last notice "bothered you," here is my advice: Buy a postcard (most inexpensive form of communication) and note this on the card... "The Postal Service has advised me that BY LAW, unwanted and unordered merchandise mailed to me is "mine to keep." I DO NOT WANT this item... I DID NOT ORDER this item. If you would like to send me (amount of postage), I will gladly return the item. If not, I will keep this unordered merchandise and consider this matter closed." I would make a photostat copy of the card and then "relax." The company will either send you the amount of postage or you will never hear from them again. Just make sure that no one in your household DID order the

item. Now, a few tips concerning ordering items in the mail:

REPUTATION - if you haven't heard of the company or it does not advertise a street address or phone number, contact the Better Business Bureau BEFORE ORDERING.

RETURNS - make sure that there is a stated merchandise return policy.

DESCRIPTIONS - make sure you read them carefully. Pictures can be misleading.

WARRANTIES - You have the right to get copies before buying.

SHIPMENT DATE - if no date is stated, most companies are required to ship your order within 30 days of receiving payment or charging to your credit card account.

HANDLING/SHIPPING COSTS - they can sometimes be large enough to counteract a "bargain price."

DISCOUNT PRICES - have a good idea of a product's retail value and comparison shop among catalogs to make sure you are in fact getting an advertised discount.

RECORD YOUR CHECK - keep a record of the complete mailing address, check number and date sent, just in case you have to "follow up."

Minutes of Village Board Meeting

Mid-Monthly Meeting
May 17, 1993
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First St.

The Administrator declared the posting and mailing of the notice and agenda.

President Robert Wagner presided. Trustee Robert Beisbier asked to be excused and was absent; all other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Gary Gavin, seconded by Trustee David Goeden and unanimously carried by voice vote, the minutes of the May 3, 1993 meeting were approved as printed.

Fire Chief Mark Groeschel, April 1993 report: Fire calls - 4, Year to date - 14; Jaws of Life (used) - 2, Year to date - 8; Jaws of Life (not used) - , Year to date - 3; Rescue Calls - 15, Year to date - 65; Transports - 15, Year to date - 67; Miles - 385; Training - 299, Year to Date - 1,022.5; Extra training - 182.5, Year to date - 710.5.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board authorized the Fire Department to advertise for bids for a new chassis for the new proposed equipment truck.

Chief of Police Richard L. Knoebel, April 1993 monthly report: Criminal arrests - 21, Criminal investigations - 42; Traffic warnings - 143, Traffic citations - 43; Adult arrests - 25; Juvenile arrests - 14; Property stolen - \$1,873, Property recovered - \$1,598; Parking warnings - 3, Parking citations - 10.

Director of Public Works, Jerry Gilles informed the Board that the street light cable on Fond du Lac Avenue was fixed (4 breaks). The slurry seal proposal for 1993 is identical to that of 1992 and lower than that of 1991. It was noted Knights Avenue going west of Edgewood Road, 100 feet of Forest Avenue, Braatz Drive and Third Street will be done, as well as a portion of KKCP.

On a motion by Trustee Gary Gavin, seconded by Trustee David Goeden and unanimously carried by voice vote, the Board authorized the installation of two new electric services at River Hill Park by Kettle Moraine Electric, the low proposal received (\$6,000).

Administrator Daniel S. Schmidt reviewed the following:

- 2) Building permit report of April 30, 1993.
- 3) Mid Moraine Municipal Association meeting May 19, 1993.
- 4) Statement of Assessment increase noted at 4.0% for 1993.
- 5) Survey on elected officials compensation and liquor licensing almost complete.
- 6) Taxpayer Alliance and League bulletins and news items.
- 7) Explanation regarding the Municipal Court jail costing.

On a motion by Trustee David Goeden, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board approved the application for an Operator's License upon proper payment of fees and documentation and authorized the office to issue said license as follows:

Note: The Police Department had no objections to any of the applications.

Chairman of Public Works Committee, Trustee Harry Roecker informed the Board that at a meeting held earlier, the Committee recommended leaving the winter parking restrictions as is. It was noted that Municipal Parking Lot Permits will be reviewed.

Chairman of the Park and Recreation Committee, Gary Gavin informed the Board the proposals for the electric at RHP have been reviewed and action had been taken regarding the low proposal.

Board Representative for the Plan Commission, Trustee Thomas McElhatton, reported that a Commission meeting is scheduled for May 25, 1993 at 7:00 p.m.

It was reported that the 1993 sidewalk rehabilitation project is approximately 2/3 the size of 1992's and that bid opening would be June 4, with the public hearing scheduled for June 21, 1993.

Action was taken on Resolution No. 93-11 a resolution regarding a grant for monumentation and topography work as attached hereto:

President Robert Wagner reported that Administrator Daniel Schmidt, Phil Evenson, trustee Gary Gavin and himself had attended a Town of Kewaskum Board meeting asking for their support on the aforementioned and that they were supportive.

The Department of Transportation response to the Village Board's five points of concern were reviewed. It was noted the Administrator should prepare another letter regarding a clarification on the signals to be installed at the intersection of Fond du Lac Avenue and CTH "H".

On a motion by Trustee David Goeden, seconded by Trustee

McElhatton and unanimously carried by voice vote, the Board directed the Chief of Police and Director of Public Works to bring a recommendation back to the Board regarding the restricting of parking and times for the restrictions.

A brief discussion was held on the possibility of hiring Professor Barry Orton to negotiate the new franchise with Star Cablevision. Further discussion will take place upon receipt of more information.

President Robert Wagner informed the Board that the 1993 Board of Review met on May 10, 1993 from 12:30 to 4:30 p.m. and that a review of the assessment roll took place and that no one had filed any objection to their assessment.

Mrs. Mary Buddenhagen was present and asked a question pertaining to a personnel matter, relating to her husband. She was advised it was a personnel matter and should be handled according to policy and union contract.

Mrs. Buddenhagen brought up a second point of concern regarding the need for a portable sanitation facility at an equipment station.

County Sheriff's Department Begins Summer C.A.R.E. Campaign

Speeders and intoxicated drivers are the targets of this year's Coordinated Accident Reduction Effort (CARE) and Sheriff Robert Schulteis says the Washington County Sheriff's Department will be playing an active role in the campaign, which began May 21, 1993 and runs through Labor Day September 6, 1993.

"The CARE program is designed to concentrate law enforcement officers on roadways that have high incidents of speed and alcohol crashes, the most severe crash types in Wisconsin," said Sheriff Schulteis. "Our deputies will be working overtime to target those days and hours when crashes occur most often."

Wisconsin Department of Transportation Secretary Charles H. Thompson, in announcing the kickoff of this year's program, noted it was the first time municipal police departments will be joining county sheriff's departments and State Patrol troopers in the CARE program. "We are indeed fortunate to have police departments joining our cooperative efforts to get speeders and impaired drivers off the road," he said. "It means all levels of law enforcement are making the extra effort to improve highway safety. And that's great news!"

Sheriff Schulteis noted the first letter in CARE stands for "coordinated." "We will be working with other law enforce-

ment agencies in the area to patrol roadways that have been targeted for the CARE enforcement effort."

They are: Highway 60 (Town of Polk), Highway 41 (Town of Polk), Highway 167 (Town of Richfield).

"CARE works because it starts with state-of-the-art crash analysis and ends with strategic law enforcement," explained David Manning, director of WisDOT's Office of Transportation Safety. "WisDOT identifies routes with high crash rates. That information also tells us which segments of the highway have the highest incidents of speed and alcohol-related crashes, and when these crashes are likely to happen. We have identified 172 different roadway sectors for this year's CARE program," said Manning. "That's where CARE patrols will be focusing their efforts."

The WisDOT Office of Transportation Safety provides funding for overtime enforcement by law enforcement agencies on highways targeted by the CARE program.

Sheriff Schulteis emphasized that the CARE program's goal is to reduce crashes and to improve highway safety. He noted that speeders and drunk drivers cannot avoid the CARE enforcement effort. "While the Washington County Sheriff's Department and others involved in CARE will be making extra efforts to monitor targeted roads, other roads will still be watched as part of our regular patrols," he said.
