Kewaskum Town Hall Dedication Date Set

At its monthly meeting held Monday, August 16th the Kewaskum Town Board selected Sunday, Oct. 3, 1993 as the dedication date for the newly constructed town hall building located on the corner of Highway 28 East and Kettle Moraine Drive. The general public is invited to view the new structure from 2-6 p.m. on that date. More details will be published later.

The Board received written notice of a line fence dispute between property owners Ray and Agnes Schaefer of the Town of Kewaskum and Elizabeth Pohle of Milwaukee. A fence setting meeting has been scheduled for Monday, Aug. 23rd at 6:00 p.m. at the town hall to resolve this dispute.

In other matters before the Board, a picnic license was approved for St. Michael's parish for their fall festival. Robert Mlejnek, a town of Kewaskum resident, was appointed and sworn in as a temporary alternate Board of Appeals member and a resolution unanimously carried to change the official polling place to the new town hall at 9019 Kettle Moraine Drive.

Two items for the September agenda will be the discussion of an ordinance regarding proper disposal of animal waste in the Town of Kewaskum and discussion and action on the division of the former Staehler property. The next town board meeting will be Monday, Sept. 20, 1993, at 8 p.m. in the town hall and is open to the public.

School District to Welcome Students Back on Monday

Monday, August 23 is the first day of school for new and returning students of the Kewaskum School District.

Johnson Bus Company will soon be sending out information on bus rules and pick-up times. If you have not received this information by August 16th please call them at 626-4414 to complete arrangements.

We ask that families take time to review the bus riding rules and safe boarding, riding, and unloading procedures. If this is your child's first experience at riding on a bus, why not take some time to accompany him/her or arrange for someone else to accompany him/her for their first pick-up and drop-off?

Also, please be aware of the times crossing guards are present on village street corners and utilize them accordingly. Please do not send or drop your children off at school before the school doors open because they will be unsupervised.

Information for those interested and eligible for the free and reduced hot lunch program is also published in the Statesman. During registration the forms were available to those interested. If you did not receive a form and now would like one sent to you, or wish to review the qualifying criteria, please call the business office at 626-8427.

Hot lunch prices for the 1993-94 school year are as follows: elementary schools \$1.25 per day or \$5.50 per week, middle school and high school \$1.40 per day or \$6.25 per week. School on Monday is a full day and hot lunch will be served. The calendar for the school year has been published and each family will receive one at registration. Extra calendars are available for purchase at the business office.

The school district does not carry accident insurance for stu-

dents. We therefore urge parents/guardians to review their own policies to be certain coverage is adequate. Particularly in the case of athletics, this is a necessity. The schools do have insurance forms provided by Student Assurance Company of Stillwater, Minnesota available to parents who would like to purchase additional insurance or insurance for their children. The parents purchase the insurance on their own - the district is not involved in the sale of insurance.

The buildings and grounds are in good shape and the classrooms are clean and ready for students. All is in readiness and we are anxious to greet the children and begin another year.

Many teachers have attended various courses, workshops and seminars over the summer to improve their skills. Administrative staff worked to hire new staff and arrange schedules, discuss goals and refine the vision of the district.

Most important to us will be the continued support and involvement of parents, grandparents, guardians and community members at large. Please take the time to review school handbooks and rules with your children, help them with their homework, call their teachers or principals, and visit their schools. You are important and we need your assistance.

Hints for a successful start to the 1993-94 school year include the following: Be positive about the teacher(s) your child(ren) has/have and the programs available; be interested in what is happening on a daily basis; encourage participation in extra-curricular activities; set goals that are high enough yet realistic; and set aside some time to talk to your child/children each day.

Carob -- What is This Chocolate-Like Confection

Carob, like chocolate, comes from a bean from the pod of the *Certonia siliqua* tree, a Mediterranean evergreen. Carob powder looks and smells like cocoa powder, but it contains less than one percent fat and no caffeine. When carob is processed for use, as in milk flavorings or candy, it becomes much like chocolate.

According to the University of California Berkeley Wellness Letter, some carob bars contain more saturated fat than a chocolate bar and more sugar than a serving of ice cream. Carob has one distinct advantage: It can be eaten by people who are allergic to chocolate. (Information from Joyce Albrecht, Washington County UW Extension Home Economist.)

Openings Still Available in Kewaskum Three-Year-Old YMCA Tot Time Class

Openings are still available in the three-year-old Kewaskum YMCA Tot Time Class for the 1993-94 school year. The three-year-old class will meet from 9:30 to 11:30 a.m. on Tuesdays and Thursdays. Classes are taught at Peace United Church of Christ by Vicki Fenrick, teacher, and Joy Thorn, teacher aide.

Library Receives LSCA Grant

The Kewaskum Public Library expects to add more than 1000 books and audio cassettes to its collection in the next few months. Library Director Nancy Bauer recently was awarded an LSCA grant amounting to \$18,739, for collection development. She has been busy unpacking new books and ordering more. Bauer said this grant would "enable our library to correct deficiencies in our collection and progress toward meeting the minimum measurements of standards."

The library's projected targets of new materials are: 500 adult and juvenile non-fiction books, 200 adult fiction books, 300 juvenile fiction books including easy reader and 3-6 grade level, and 50 adult books on audio cassette.

Bauer said the library needs the new materials: "When our patrons do not find what they

need here - even basic information - they travel the short distance to West Bend to fill their needs. We need to provide the basics HERE at the local level."

The Kewaskum Public Library serves citizens in Find du Lac and Washington Counties. It is a member of the Mid-Wisconsin Federated Library System.

The Library Services and Construction Act (LSCA) grants federal funds to libraries around the nation.

About Board Business...

To the People of Kewaskum:

Well as Paul Harvey would say, "And now, for the rest of the story..."

I would like to share with everyone the outcome of the village board's discussion with the Farmer's Union Co-op at our August 2nd village board meeting.

I feel it went very well for both parties involved. The board worked out an agreement that is fair to the Cooperative and that doesn't overburden our wastewater treatment facility. We had a few different proposed discharge rate schedules presented to us by the village engineer for review with the Farmer's Union.

After a lengthy discussion, we agreed to a rate schedule that will be more lenient with them at initial startup, allowing higher discharge levels and low excess discharge charge rate. After six months of operation, their discharge levels will be lowered and the excess charge rate raised.

After one year, the discharge levels will again be lowered and the rates will be increased more, which, barring any unforeseen circumstances, is where it will hold. The philosophy and reasoning behind this was to allow the Cooperative time to work out the bugs of their operation and time to fine tune their in-house pretreatment and waste reduction programs.

After one year, the village will hold them to 65 pounds of BOD per day, 20,000 gallons per day flow rate, 65 pounds of suspended solids and 8 pounds of phosphorous per day, with a very stiff excess discharge charge rate if they would go over the limit. This will give the Farmer's Union an incentive to comply with its discharge agreement.

The actual contract hasn't been written up at this time, because our village lawyer and engineer need to work out the language and details with

Farmers' Union. At that time the board will sign it. The board did approve the rate schedule at this meeting.

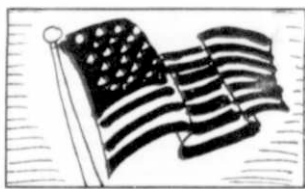
I hope you don't think I have some kind of hangup about sewage, but I have one more thing to discuss, and that is the new sludge storage addition the village will be building in the near future.

Building this 85 feet diameter by 26 feet deep storage tank will give the village a six month storage capacity. It will cost around \$865,000 plus engineering fees. We are adding this due to the new DNR requirements, not because of the Farmer's Union. The board has been planning this for some time now.

The DNR requires that we have a minimum of six months sludge storage. The DNR will not be allowing the land spreading of sludge in the winter months due to the frozen ground and water runoff. Again, this storage tank has nothing to do with the Farmer's Union Co-op.

Well, that about does it... no more sewage talk. I promise. In about two weeks, you will hear from me again, but a new topic. Maybe it might be the upcoming Hwy. 45 improvements, or if anyone has anything else they would like explained or discussed, please call me or write.

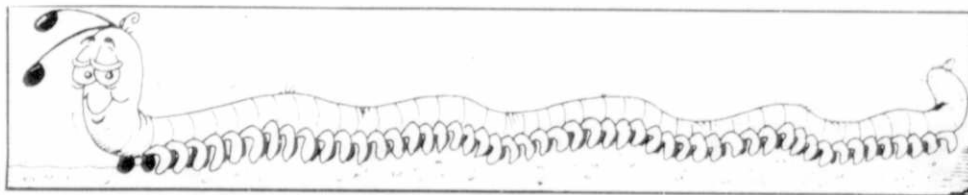

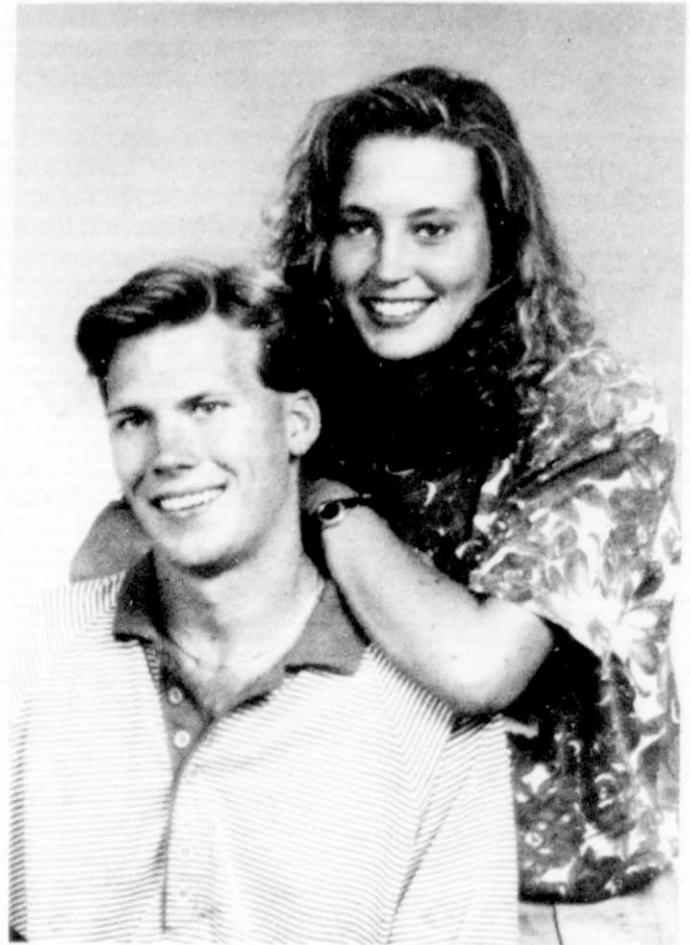

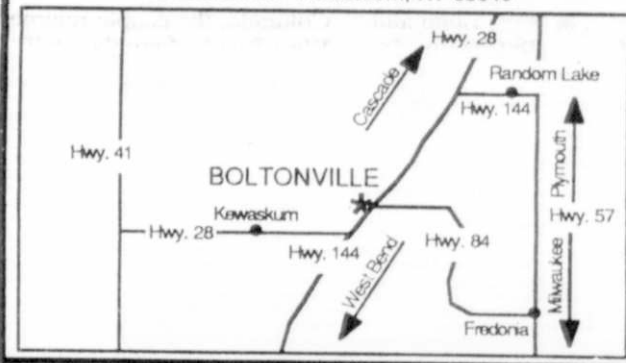

A Message from the Postmaster

Hello Kewaskum Statesman readers. It is Sunday afternoon and I just got done reading the paper and the "sad plight" of four Fond du Lac teens killed in an automobile accident. As most of you know, they were returning from Great America... the driver fell asleep, they crossed the median and were struck by a semi.

I, personally, did not know any of the young men... but knew some of the parents and/or grandparents. TWO accidents on Highway 41 - within a short period of time - it is scary to say the least.

My parents called me the morning of the "huge fog-related pileup" just to insure that I was safely at work. I usually drive 45, did so that morning.. it as a "weird fog."

Tragedy has struck twice, actually three times, as hardly any of us can forget the accident on 45 just a short time ago... and the loss of another life. Community support at such a time is STRONG and in "some small way" hopefully that will help all families involved to "carry on." Well... on to some Postal news okay?

In this week's column, I would like to once again, talk about "unwanted and unordered" merchandise received in the mail. Many of you have belonged to book, tape, CD, and/or movie clubs. You join, receive the "bonus items," buy what is obligated and then notify the company that you want to "cancel."

Most of the time, the companies will cease sending information and/or merchandise. But then... there are the companies that seem to ignore your request and just keep sending and sending and sending. What can you, as a consumer, do about this? DO NOT OPEN ANY correspondence from that company. You have notified them of your desire to cancel.

Any correspondence received from them should be marked "refused," dated and initialed by you and returned to the Post Office or given to the rural carrier. PLEASE REMEMBER... do not open anything as any part of the correspondence opened will require you to pay postage to return the item.

Okay, now what about the things that come in the mail? You have no idea why you received it... did not order a thing from that company and you have no idea what is inside. You must remember the LAW! Unwanted and unordered merchandise received by you is yours to keep. What will the company do?

First of all, you will receive a bill. Then... another bill and maybe another bill. Ultimately, comes the notice that most people will "fall for." The notice will read something like this: "merchandise sent to you has not been paid for and we are putting this matter into the hands of a collection agency."

That gets your attention. They KNOW THAT! What can you do? Well, you can help

yourself, your friends and neighbors by NOT falling for this last attempt. Companies that send unwanted and unordered merchandise must be stopped. You may want to clip this next part out... keep it for reference in case that you need it. My advice is:

Buy a 19 cent postcard. Address it to the company and on the reverse state: "The Postal Service has advised me that UNWANTED and UNORDERED merchandise received in the mail is mine to keep. I DO NOT WANT IT... I DID NOT ORDER (whatever it is you received). If, however, you would like to send me the postage (just take the package to the Post Office and have it weighed to find this out), I will gladly return the item. I consider this matter closed."

TRUST ME... you will either hear from the company and they will send the proper postage to return the item or you will never hear from them again. You should make a copy of both sides of the postcard and note the day that you sent this back to them.

You MUST insure also that no one in your household did indeed order the merchandise. As your Postmaster, customers come in daily with unwanted and unordered merchandise. As stated before, help yourself and help each other to put a stop to this.

One other matter that should be "touched upon." What about the items that you DO order? You open them up and they are NOT what you originally ordered, wrong size, etc. Some companies will state... "we will pay the return postage."

That may indeed be true... BUT... you have to deal with them to have them remit that to YOU. If you open ANY part of the package... yes, that includes the envelope atop the parcel... YOU must pay to return the item. Let's say that you receive a parcel... do not open any part of it and take it to the Post Office for return. There is just one more thing that you have to be aware of.

If the words, "Return Postage Guaranteed" are NOT noted on parcel... AGAIN... YOU are responsible to pay the postage. If you have any questions on this or anything else about the Postal Service, please feel free to call me and/or stop in...

"Customer Satisfaction is OUR Priority."

Postal tip of the week: When mailing a package, write recipient's name and address CLEARLY on ONE side of the parcel. ALWAYS use your return address. INSIDE the package, put the recipient's name and address and your return address, just in case the outside would become obliterated for some reason.

That is it for this week. Try to have a good day... a happy every day!

August 6, 1993, marked the actual groundbreaking for the elevator and stair tower at the Old Washington County Courthouse. In accordance with the Americans With Disabilities Act, the elevator will give access to all individuals.

"This elevator project signifies the beginning of the building's transformation to a Historic Museum," said Shawn Graff, President of Graff and Associates, the museum consulting firm overseeing the renovation and fundraising efforts.

Area volunteers have been working at the courthouse since January, 1993, removing false

ceilings and walls in preparation for the construction of the elevator/stair tower.

"To date, the volunteers have saved Washington county and the Historical Society tens of thousands of dollars. Volunteers will be working with contractors on additional demolition projects saving an additional \$5-10,000," said Graff, acknowledging the importance of volunteers in the renovation process.

After the elevator/stair tower is finished in November, Washington County and the Historical Society will focus their energy on the renovation of the courtroom and establishing the Sila Bast Bell Collection in the museum, Graff said.

Schwengel Running for Vacant Stitt Senate Seat

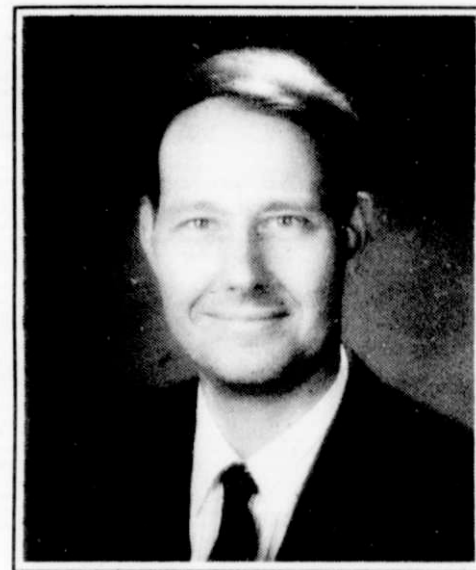

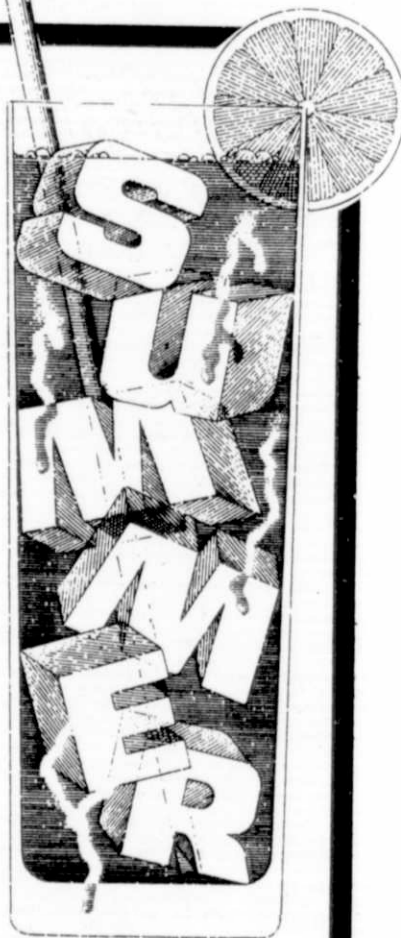

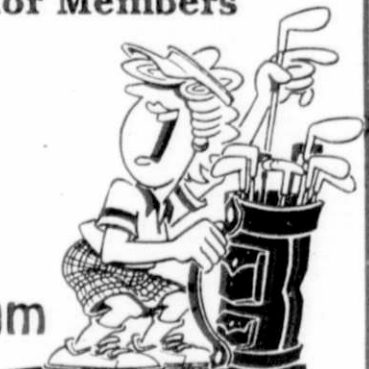

Schleif apparently saw the truck, but failed to see a big log trailer which was attached to the truck. As he dashed behind the truck to get the flag he was struck on the head by a crow bar on the empty log rack.

Liermann, 24, a graduate of the Kewaskum High School, and son of Mr. and Mrs. Oscar Liermann of Cedarburg, former residents of Beechwood, was fatally injured in an accident on August 7 at Camp Stewart, Georgia, where he was stationed. The shocking news was received Saturday by Sgt. Liermann's parents and wife, the former Betty Mae Brandstetter of Kewaskum, now residing with her parents at West Bend.

Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is marked, it shall be folded so the inside marks do not show, but so the printed endorsements and inspectors' initials on the outside do show. If you voted with punch card, it shall be inserted in the envelope provided so the punches do not show. Wisconsin Senators Vow to Continue Fight On Forage Assistance; Pass Disaster Bill

WASHINGTON -- U.S. Senators Herb Kohl and Russ Feingold applauded Senate passage on Wednesday evening of disaster legislation that will provide \$5.8 billion in federal aid and another \$502 million in loans to the nine states declared disaster areas by the President, including Wisconsin. Final Congressional approval of the bill is expected before Congress adjourns for its summer recess.

Feingold and Kohl were part of a bipartisan coalition of Senators who fought successfully for an amendment to increase disaster payment rates from 50.04% to 100% the rate authorized by the 1990 Farm Bill. The lower rate had been adopted by the Bush Administration in 1991 and was proposed in the President's disaster legislation submitted to Congress. The amendment passed 63 - 32.

"Under the previous '50.04' formula, farmers got about 20 cents on the dollar for their losses. At the rate adopted by the Senate, farmers will be assured of at least 40 cents for each dollar lost," the Senators said.

The Senators had also sought an amendment to provide federal cost-sharing assistance for reseeding alfalfa hay and other forage crops damaged by this year's disastrous weather. The amendment met with significant opposition and was not included in the Senate measure. While the amendment was not adopted yesterday, Kohl and Feingold received assurances from the Administration and the Senate leadership that every effort would be made to include this provision in upcoming legislation.

"Obviously there's more to be done," the Senators said. "In

Wisconsin, we've lost 750,000 acres of our 2.2 million acres of alfalfa. Our amendment would help farmers get these acres reseeded as quickly as possible. While we could not get the Senate to agree to our amendment today, we're optimistic that we can work out the problems soon. We will certainly persevere in our efforts."

We thought nothing of it; kids sometimes go back in the woods to goof around. We walked farther into the woods and noticed a large pile of freshly heaped dirt. We went over to inspect it, and there before us lay a rectangle about six feet long and three feet wide with huge tennis shoe tracks all around it. It was a grave!

None of us said anything; we just turned around and walked rapidly and steadily out of the woods. As we neared the edge of the woods, my mom suggested that maybe someone had a very big dog that had died and had thought Janet and Ralph wouldn't mind if it were buried back in the woods. "It must have been a very big dog," I said.

When we finally got back to Janet and Ralph's house, a terrifying sight met our eyes. The front door was standing wide open, and there were dirty footprints on the carpet. We all grasped one another's arms and marched in; after all, it was our responsibility to be taking care of that house. We rounded the corner and screamed!

It was the lady next door!
