New Ambulance in Service At No Cost to Taxpayers

After many months of comparing bids, quotes and shopping, members of the Kewaskum Fire Department are proud to announce and provide the Kewaskum area with a 1993 Ford chassis diesel powered Foster ambulance.

This newest addition was purchased by the department

from funds raised through ambulance runs, the annual Firemen-Legion picnic and the decathlon that was organized and sponsored by the department two years ago. No taxpayer dollars were used in this acquisition.

There is no doubt that technology has had an impact on our lives and department members were on hand Sunday evening for an orientation of the new

vehicle and the technology within.

The new vehicle features up-to-date communication capabilities through superior radios and a cellular phone. It has enclosed storage compartments for equipment that is accessible from the inside as well as outside the vehicle. It is climate controlled and is brightly lit with fluorescent lights.

The one man cot is now positioned in the center of the vehicle for easier accessibility when helping a patient. There is a spe-

Four Lives Claimed in Traffic Accident North of Kewaskum

Four persons lost their lives in a one-car accident that took place on Hwy. 45 early Sunday morning.

According to a news release from the Fond du Lac County Sheriff's Department, the accident occurred in Fond du Lac County, just north of the Washington County line around 1:40 a.m.

A 1972 Camaro driven by Steven A. Morris, 29, of Hwy. 45 North, Campbellsport, which also contained three passengers,

was traveling northbound on Hwy. 45 and failed to negotiate a curve.

The vehicle left the roadway and struck a haybale located on the Buss property. The car evidently lodged beneath the large piece of farm machinery and remained hidden until 8:45 a.m. Sunday morning when a farmhand noticed the haybale had been moved a few feet from its position near a shed.

All four people in the car died upon impact, according to Chief Deputy Coroner Donald

Primary Choice is Grothman

Attorney Glenn Grothman, West Bend, was clearly the voter's choice in Tuesday's GOP Primary election in the 59th Assembly District. Kewaskum voters also favored Grothman.

Grothman garnered votes almost three to one compared to his closest opponent, runnerup Betty Pearson of West Bend.

Despite problems with the punch card ballots, which invalidated nearly 900 votes, all five of Grothman's opponents declared that his margin of victory made it unlikely that they

would contest the outcome of the election.

Other GOP candidates included Pearson, John Torinus, William Reid, Ruth Schmitt and Mark Helmle.

Grothman will now face Libertarian candidate Kevin Scheunemann, 21, and independent Richard Buntrock, 55, in the December 7th election for the Assembly seat formerly held by Rep. Mary Panzer who won the State Senate seat vacated by Donald Stitt in September's special election.

School Board Selects Expansion Package

The Kewaskum School Board unanimously approved sending a referendum to the voters for a building expansion and remodeling project at Kewaskum Middle School and High School.

The purpose of the project is to alleviate overcrowding at the middle school by adding nine classrooms and to update the science, special education, home ec, fine arts, athletic and cafeteria areas at the high school.

Board member Jean Goeden explained that this proposal has been in the making for nearly two years. It is not something that has come up in the last few months.

Representatives from the architectural firm of Eppstein, Keller and Uhen were in attendance to explain the building plan recommended by the district building and grounds com-

mittee.

Representatives received input from teachers, administrators and members of the building and grounds committee to determine what options would best serve the district's needs. The plan chosen was considered a very efficient, no nonsense approach that addresses immediate needs yet also looks to the future for growth.

The project is in the middle range as far as cost. The plan does include a 700 seat fine arts center that could be available for all of the community to utilize. The approximate cost of the project is projected at \$7,515,000.00. The resolution(s) for the February referendum will be discussed and approved at the December board meeting.

Board member Ron Beimborn addressed the board regarding Beechwood Elementary School and would like to

Board Approves Fire Equipment Purchase

KEWASKUM - The Kewaskum Village Board last Monday night voted to approve the purchase of an Equipment Box from Excellence, Inc., of Madison, Alabama. The total cost of the box, which will go on the Department's Equipment Truck, is \$133,501, the highest of the three bids received.

The vote ended weeks of confusion surrounding the bidding process. The other two firms which submitted bids - American Fire and Rescue and Welch - were turned down because their bids did not meet the specifications listed by the Fire Department.

"From our experience of knowing the products, they do not comply, nor can they comply with the method of construction that was specified in your bid specs," said Dan Schroeder, a representative of Excellence who addressed the Board. "There are not only ambiguities - there are outright lies in what they submitted to you."

As Fire Chief Mark Groeschel did the previous meeting, Schroeder went over a list of variances in the other two company's proposals. Several specifications that the Department requested were not met by American Fire and Rescue and Welch. The lone spec not met by Excellence was the Department's request for a \$5 million liability. Excellence submitted a \$2 million figure, noting that few contractors will insure that large a liability.

Excellence's \$133,501 price tag was \$30,000 more than the other contractor's bids. This prompted trustees Gary Gavin and Tom McElhatton at the last meeting to direct Groeschel to check out why the erroneous bids were submitted. Groeschel wasn't in attendance at last Monday's meeting, and it was unclear whether he had spoken to either American Fire and Rescue or Welch.

Nevertheless, Schroeder noted that if either of the two contractors would have submitted the wanted specifications, their final costs "would have been very close" to that of Excellence.

"You get what you pay for," Schroeder pointed out. But he added that if the Board were to go with either of the other two bids, "You are not going to get what you went to bid for. I can guarantee that."

The majority of the Board agreed, as they voted 5-2 in favor of accepting Excellence's bid. Gavin and Charles Waala voted against the motion.

In another ongoing matter, the Board made some decisions involving the Bonnie Lane project, while both trustees and residents accepted some of the blame regarding problems with the project.

After considerable discus-

sion between Board members and residents in attendance, the Board agreed to allow the residents to do the restoration on the properties, with the individual property owner absorbing the costs.

In addition, the Board voted to have a contractor install asphalt leading to the driveways of the properties, connecting it to existing pavement when possible, and have the costs billed back to the individual residents. The cost of this would be \$1500, which would be split among the properties which needed it.

The Board also voted to hire an independent surveyor to look at the entire Bonnie Lane project to see if the work done meets the specifications to which the Board originally agreed.

Public Hearing Nov. 29 '94 Tax Levy to Increase

KEWASKUM - After benefiting from a municipal tax decrease in 1993, Kewaskum residents can expect a slight increase in their taxes in 1994, according to figures presented to the Village Board last Monday evening.

Village Administrator Dan Schmidt presented the preliminary figures to the Board at the meeting, and noted that the total 1994 budget would be less than the '93 version.

The original proposed budget had expenditures totalling \$1,535,540. After some revenue and expenditure adjustments, however, the total was reduced to \$1,486,489. The total tax levy on that figure would have been approximately \$450,000, or an increase from 1993's levy of \$419,674.

After several more reductions were discussed for the 1994 budget, the total package came to approximately \$1,467,700, or about a \$9,900 decrease from 1993. The new figure includes a tax levy of \$431,658, or an increase of nearly .20 per \$1,000 of property.

In other words, a person owning a \$50,000 home would pay \$9.98 more on property taxes in 1994. A \$70,000 home would cost \$13.98 more, while a \$90,000 home would cost \$17.97 more. These figures are based on a tax levy increase of 2.87%.

Schmidt, along with the Board members, suggested other means of reducing the levy even further. Among the items discussed were two resurfacing

projects, Werner Drive and Prospect Drive. The Werner Drive was slated to be done in 1994 and was included in the budget.

Resurfacing Prospect Drive, instead of Werner, however, would result in a savings of about \$2,400, which could be used against the levy. The Board didn't come to any specific conclusion on the projects, though. The Board members did make a motion to direct Schmidt to try and reduce the total levy to 2.5%, using the suggestions offered.

The final budget figures will be addressed at a public hearing on November 29th, beginning at 7 p.m. The hearing will take place in the Council Room of the Municipal Building, and will precede the Board's final November meeting at 8 p.m.

A Kewaskum man was injured in a fire Sunday at Wild Wings Hunting and Fishing, Inc. located at N865 County Trunk W, shortly before 7 a.m.

Todd Boegel was listed in stable and fair condition and is improving, as of Tuesday morning at St. Mary's Burn Center in Milwaukee. He is being treated for second degree burns and smoke inhalation.

Boegel was transported to Milwaukee by the Flight for Life Helicopter from St. Joseph's Community Hospital, West Bend.

Campbellsport firefighters responded to the fire, which began in a one-story residence

in the living room during a party, according to fire chief Phil Hahn.

One of the occupants, David Limbach, went to bed before the party ended, but smelled smoke and was out of the building by the time help arrived. At the time, he was unaware anyone else was inside until he saw Boegel's arm hanging out of a window.

Limbach and James Coblenz, Wild Wings owner, removed Boegel from the building.

Fire department officials believe the fire was caused by careless use of smoking materials.

75th Anniversary of World War I

Sirens may sound and church bells may ring again on the eleventh hour of the eleventh day of the eleventh month, honoring those who fought in world War I, on the 75th anniversary of the Armistice.

The end of the War to end all wars was thought to have happened on the 8th of November and wild celebrations broke out across the country, Washington County communities included. This, which would be known later, as the false Armistice, in no way dampened the enthusiasm when the actual Armistice occurred on November 11, 1918.

Washington County suffered losses of servicemen from disease, accidents and battle. Harvey Bruhy of West Bend was killed in an airplane accident at Kelly Field, Texas in September 1918. Hartford lost Frank J. Murphy and John Courtney to illness in March of 1918. The county's first battlefield casualty was Joseph G. Gudschenritter, Town of Addison. He was killed in action in October 1918.

World War I put 4.7 million Americans in uniform; 116,500 would never return. Washington

County lost 26.

November 11 was called Armistice Day until 1954 when it was changed to Veterans Day to recognize all veterans from all wars. This November 11, at 11 o'clock a.m. take a moment to reflect on the sacrifices of so many, and if you would, stand and face the East in recognition of those who fought World War I.

New Ambulance

cific biohazard waste disposal area that permits ambulance personnel to comply with new OSHA guidelines. The siren is now located in the grill area directed at traffic rather than on the cab resulting in less noise within the ambulance.

Finally, a demonstration was given to department personnel by Fire Chief Mark Groeschel on the use of the radios and ambulance lights.

The ambulance is staffed 24 hours a day by 36 dedicated volunteers whose only motivation is to help someone in need.

To qualify as an emergency medical technician (EMT) one must complete a 33 week EMT Basic Course and successfully pass a practical and written national registry exam. To retain their license, the EMT attends a ten week refresher course every two years. In addition, the EMT recertifies in CPR every year.

The ambulance is equipped with a defibrillator for use in cardiac arrest patients. Currently, the Kewaskum Rescue Squad includes 16 members who are certified defibrillators through St. Joseph's Community Hospital. To participate in the defibrillator program, Kewaskum has a certified defib technician on call at all times.

Those technicians attended a three week defib class and successfully passed a written and

practical exam to become certified. Every six months they recertify at the hospital. 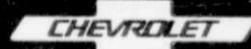

SOCIAL SECURITY EXPANDS TOLL-FREE NUMBER SERVICE

You can now call Social Security's toll-free phone number, 1-800-772-1213, after normal business hours to request certain Social Security forms and pamphlets and to listen to recorded messages about Social Security programs. Social Security service representatives are available from 7 a.m. to 7 p.m. Monday through Friday. Now to receive some services, you don't need to talk to a service representative, nor do you need to call during business hours.

If you use a touchtone telephone and call the 800 number from 7 p.m. to 7 a.m. on weekdays, and on weekends and holidays, you will be connected to an automated system that will enable you to request:

- * a form for a new or replacement Social Security card;

- * a form to obtain a record of your earnings and an estimate of your future Social Security retirement benefits; or

- * a document that provides proof that you receive benefit payments from Social Security, Supplemental Security Income

(SSI) or both.

You can listen to recorded messages or obtain pamphlets about:

- * retirement benefits;
- * disability;
- * benefits for a spouse of a disabled, retired or deceased worker;

- * how work and earnings affect your Social Security payments;

- * Medicare;
- * Qualified Medicare Beneficiary Program (QMB);

- * benefits for people with HIV infection; and
- * benefits for children with disabilities.

Social Security service representatives are available to answer your call 7 a.m. through 7 p.m. Monday through Friday. In some areas you may also be able to use the automated service if you call the 800 number during normal business hours and a representative is not immediately available. The best time to reach a representative is from 7 a.m. through 9 a.m. and from 5 p.m. to 7 p.m. when the 800 number is least busy.

Kohl Calls for Investigation Into Diesel Fuel Pricing

WASHINGTON -- U.S. Senator Herb Kohl recently called on the Department of Justice to launch an immediate investigation into the climbing price of low-sulphur diesel fuel. Kohl, a member of the Senate Subcommittee on Antitrust, also requested that the Justice Department monitor average national diesel fuel prices to determine whether price-gouging could be occurring in the Midwest.

"I have heard from a lot of Wisconsin residents upset about the dramatic price increase on low-sulphur diesel fuel," Kohl told the Justice Department, "They are entitled to a quick and thorough explanation -- each passing day costs diesel users more money."

While a cost increase in diesel fuel was expected on October 1st, reflecting the 4.3 cent per gallon increase in the federal fuel tax and the implementation of Clean Air Act standards, some areas of Wisconsin experienced a 35 cent per gallon increase.

The Department of Energy issued a statement citing the wide spread summer flooding and the shut down of a section of the "Explorer Pipeline," the

main source of low-sulphur diesel fuel from the Gulf Coast, as the cause of the increased price.

"That same report tells us the problems have been resolved and prices should have returned to expected levels. I haven't seen that happen," Kohl said, "Folks in Wisconsin continue to pay more for diesel fuel than drivers in other parts of the country. Let's make sure this was an isolated incident, and not a trend."

November 9, 1918

PEACE IS DELAYED

Paris, Nov. 8... German delegates sent to the French front to receive from Gen. Foch allied terms for an armistice crossed the allied line near La Capelle last night. The German Delegation came into the Allied Lines under a white flag. At the time the Allied Armies were slashing forward on a 150 mile front tearing the German defenses to pieces and driving the enemy in utter rout.

At a meeting of the Board of Health at the village hall last Wednesday evening, the ban which was placed on this community due to the number of cases of Spanish influenza, was raised and things may now assume their regular routine. The cases of "flu" have been reduced to a very small number, which justifies the board in taking the step they have. Therefore all churches will be open and services held next Sunday as formerly. The Kewaskum High School and the parochial schools of the village will re-open on Monday, November 11. It is desired, however, that the citizens use judgment and not take too many chances in coming in contact with persons suffering from

colds, as the epidemic is not entirely checked, and can very easily revive at most any time. All should realize that influenza can be had more than once, and those who have it, should avoid getting a relapse, as the result may prove fatal. We caution all to be careful in coughing, sneezing and expectorating, so that the germs of the disease may not be transmitted to others.

In response to an urgent request by telegraph from the Gas Defense Division Chemical Welfare Service, U.S. Army, New York City, Governor Philipp asks that the people of the state give special attention to the collection of fruit pits and nutshells. In order to meet the demands for this high quality of carbon for gas masks, one million pounds a day of fruit pits and nut shells are required.

The auction held here last Wednesday, by Mat. Rodenkirch, was largely attended and a fair price was received for the personal property. Mr. and Mrs. Rodenkirch expect to leave for Minneapolis, Minnesota as soon as Mr. Rodenkirch's health permits him to travel.

A Message from the Postmaster

Hello Kewaskum Statesman readers. Are you all surviving the COLD? I am a born and raised "Wisconsinite" but will openly admit, I HATE WINTER. Oh well, no sense complaining about it... just have to look "onward and forward" to SPRING.

As promised in last week's column, I will continue on with the subject of Mail Fraud. Have you ever been asked to participate in a chain letter guaranteed to earn you big \$\$\$ with one small investment?

Don't waste your money... chain letters are a form of lottery and may violate federal mail fraud laws. The same three elements that apply to lotteries (payment, prize and chance) also make these schemes illegal via the mail.

People lose hundreds of dollars every year through these schemes. The promise that all participants in a chain letter will be winners is mathematically impossible. The first investor in the chain may receive some money, but later participants rarely even get their original investments back.

A typical scheme may require you to mail the chain letter, along with a specified amount of money to six people, each of whom must then mail letters to six more people, and so on. Think about it! You mail a specific amount of money to six people, ask them to do the same... well by the time 13 mailings are accomplished, there are 13,060,694,016 participants. As your Postmaster, I encourage you to not become involved in chain letters.

The best thing that you can do... to help yourself, your friends and neighbors is to bring these so-called chain letters into the Post Office. I will be more than happy to send them on to the Postal Inspection service for analysis.

Bring the envelope and contents in and after investigation, the Inspection service will write directly back to you. Thank you for your co-operation in this matter.

An ad that shows up in newspapers from time to time is one that advertises Postal Jobs. No, I am not talking about the official notices directly from the Postal Service. These are privately-

owned companies that promise you a specific score on the Postal Exam or you receive your money back.

Money back? What are you paying for? You are paying for them to "teach you to memorize." Hundreds of people have fallen prey to this and hopefully, you will not!!

IF and WHEN the Postal Clerk/Carrier exam is available... you will be notified through an announcement by me in the Statesman and official notices will be distributed to businesses in the area. It will also be posted at the Post Office.

Want to get an idea what the test is like? PLEASE... do not be ployed into spending \$40-50 for this information. Just a trip to the library will do it. Ask for the Clerk-Carrier study guide and it will only cost you a little bit of your time... not dollars out of your pocket.

Now, what do you do if you have been conned? Consumers who believe they are victims of mail fraud should contact me. The information that I will need to pass on to the Postal Inspection service will be:

--full name and address of the individual seller or firm

--copies of advertisements relating to the order

--copies of correspondence to and from the firm, including copies of envelopes, if possible

--method of payment, including a copy of the receipt, canceled check or money order

--whether money was required before receiving the merchandise.

Not every unsatisfactory mail transaction is fraudulent. Many complaints received from dissatisfied customers show the seller has not violated postal laws. Legitimate complaints are normally resolved to the satisfaction of both parties by the Inspection Service contacting the sellers direct and asking them to resolve the complaint.

Last, but not least... tips on "protecting your mail."

-- NEVER send cash or coins through the mail. Always send a

check or money order.

-- Make sure that your mailbox is in good condition. Covers on your mailbox should be in working order and "be there."

--Collect mail from your mailbox promptly. Going out of town for a few days? Stop in the post office or put a note in the mailbox for the carrier requesting that your mail be held until you return.

--Contact the issuing agency if you do not receive an expected check, food coupons or other valuable mail.

--Notify the Post Office and mailers immediately if you change your address. Free cards to notify correspondents are available at the Post Office.

--Deposit outgoing mail in an AUTHORIZED mail collection box or give it to your carrier. NEVER place mail for your carrier in an unprotected area where it can be easily stolen.

--Address mail properly and include your return address.

--Advise me immediately if your mail is stolen.

Well, that is about it for this week. "Turkey Day" is quickly approaching. Christmas will be here before we know it and we'll have a lot of fun things happening at the Kewaskum Post Office for the Holidays. I will be keeping you updated on it all through my column.

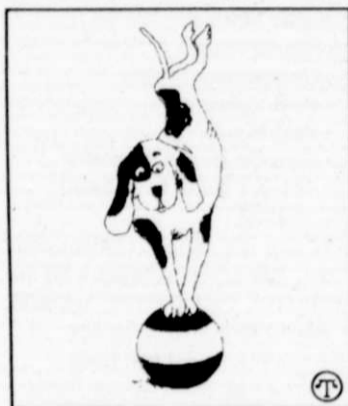

Minutes of Village Board Meeting

October 18, 1993
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First St.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Beisbier, seconded by Trustee Charles Waala and unanimously carried by voice vote, the minutes of the October 4, 1993 meeting were approved as printed.

Fire Chief Mark Groeschel, September 1993 monthly report: Fire calls - 2, Year to date - 24; Jaws of Life (used) - 2, Year to date - 23; Jaws of Life (not used) -, Year to date - 3; Rescue Calls - 15, Year to date - 138; Miles - 260; Training - 265, Year to Date - 2,194; Extra training - 141.2, Year to date - 1,175.

Fire Chief Mark Groeschel reported on the bids received for the Fire Equipment Truck as bid October 7, 1993. Three bids were received as follows:

Welch Fire Equipment Corporation, Marion, WI, \$98,168; Foster Coach Sales, Sterling, IL (Michigan), \$103,210; Excellence Inc., Madison, AL, \$133,501.

It was further noted that the two low bidders were non-responsive to the specs as sent out and that the Fire Department Equipment Committee was recommending to the Board that the high bid of Excellence Inc. be awarded the contract. A lengthy discussion reviewing the bids took place with the Fire Chief receiving direction from the Board to call Foster Coach and ask for explanations to several questions and to also call several of their references and report back to the Board on November 1, 1993.

Chief of Police Richard L. Knoebel, September 1993 monthly report: Criminal arrests - 30, Criminal investigations - 41; Traffic warnings - 141, Traffic citations - 56; Adult arrests - 24, Juvenile arrests - 10; Property stolen - \$65, Property recovered - 0-0; Parking violations - 20, Parking citations - 10.

Chief of Police Richard L. Knoebel informed the Board that the Department would be attempting to use the state bidding process (VALUE) to purchase the new squad, hoping to realize a savings.

Director of Public Works, Jerry Gilles informed the Board as to the upcoming leaf pickup and work being accomplished. The status of the work on the KKCP ice skating pond was discussed. It was the consensus of the Board to send a letter to the Railroad to request signals on the Old Fond du Lac Avenue crossing.

Administrator Daniel S. Schmidt reviewed the following with the Board:

- 1) Review of the budget control sheet for the period ending September 30, 1993.
- 2) Review of the building permit report for the month of September 1993.
- 3) Legislative bulletins and Taxpayer Alliance bulletins.
- 4) Information regarding the revocation of punch card voting.

Chairman of the Public Works Committee, Trustee Harry Roecker informed the Board of a Committee meeting held earlier this same evening and that the Department of Public Works proposed budget was reviewed. Further discussion will take place on this topic under new

business.

Chairman of the Park and Recreation Committee Gary Gavin announced a committee meeting scheduled for Monday, November 1, 1993 at 7:30 p.m.

Board Representative for the Plan Commission, Trustee Thomas McElhatton announced a commission meeting scheduled for Wednesday, October 20, 1993.

Board Representative for the County-Wide Library Board, Trustee Charles Waala announced a Board meeting scheduled for Wednesday evening, October 20, 1993.

Discussion was held on the capital improvement project involving Bonnie Lane. There have been some problems and concerns raised regarding the work. A review of a letter sent by the Engineer, with optional solutions to those problems, was read and further discussed. No corrective action or decisions were reached, but additional discussion with the contractors will be held prior to the Board making any decisions. Eight of the area residents/property owners were present.

A review of the Fire Department proposed budget for 1994 was again discussed with the main topic being the Fire House Maintenance and more specifically the resurfacing of the concrete floors. The proposed cost is \$10,000 and accounts for the substantial increase in the department's budget. Options regarding the payment for the work was discussed as well as alternatives regarding the resurfacing. On a motion by Trustee David Goeden, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board withdrew \$5,000 from the fire house maintenance account and proposed 1994 Fire Department to lower the total dollars and directed the office to notify the Town of Kewaskum and the Town of Auburn as to the proposed contract information for 1994. The dollar amount being requested of the Village of Kewaskum under the contract formula increased to \$77,022 or up \$14,014 or plus 22.2%, the Town of Kewaskum under the contract formula decreased to \$48,791 or down \$8,567 minus 14.9%, and the Town of Auburn under the contract formula increased to \$27,617 or up \$3,138 plus 12.8%.

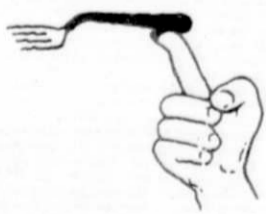
A brief review of the Department of Public Works accounts took place with further discussion to take place at future meetings.


