

Tedious Evening for Village Board

A tedious evening of near year-end resolution passing and going over more budget figures faced Kewaskum Village Board members at their Mid-Monthly meeting held Monday, November 15.

The budget is in its final stages before being presented to the taxpayers at the annual Budget Hearing which will be held Monday, November 29.

All residents and taxpayers are strongly urged to attend this meeting to observe the workings of the board and to become aware of where their tax dollars are going.

Although the budget was the top priority on the agenda, the Bonnie Lane project was again touched on briefly. Upon discussion, it was the consensus of a few of the board members that after the landscaping turns green and full again in Spring everything would look a great deal better.

It was mentioned that one of the residents had on that same day, had his retaining wall erected at his expense, which should take care of a runoff problem.

The last item on the agenda was a request by Village Administrator Dan Schmidt on

how to proceed with the financing needed to purchase the new equipment box for the fire department. The majority of the board (Gavin and Waala voted no) authorized the purchase of the equipment box from Excellence, Inc. for \$133,501.

On a motion by Trustee Harry Roecker and seconded by Trustee David Goeden, the board authorized Village Administrator Dan Schmidt to request borrowing \$120,000 from the State Trust Fund and to further investigate the refinancing of one or two existing loans. Trustee Gary Gavin was the lone dissenter.

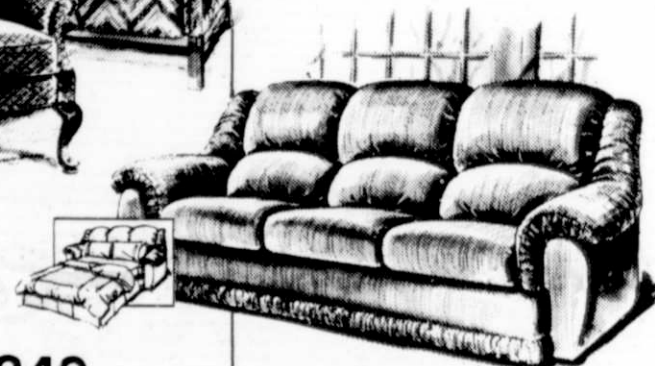

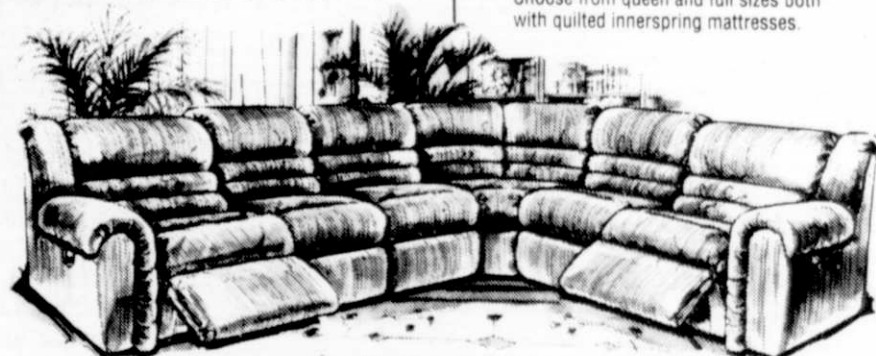

Free Prostate Cancer Screenings

(NAPS)—Free prostate cancer screenings coordinated by the Prostate Cancer Education Council will be provided at about 1,000 sites throughout the United States during Prostate Cancer Awareness Week, September 20 to 30. Information on screening site locations, the dates and times for screenings for each site and how to make an appointment for a screening is available through a nationwide toll free telephone number: 1-800-227-2345.

Prostate cancer is the second most common cause of death among American men. The American Cancer Society and the Prostate Cancer Educational Council estimate that in 1993 about 165,000 men will be diagnosed with prostate cancer. Eventually, about one in four diagnosed with prostate cancer will die from the disease. This is about the same ratio seen in breast cancer.

To arrange for a screening, men must make an appointment at a screening site. The number of appointments for free screenings are limited and available on a first come, first served basis.

Prostate Cancer Awareness Week was initiated in 1989 by the Prostate Cancer Education Council, a consortium of physicians, health educators, and patient support groups dedicated to increasing the awareness among men and the women in their lives about prostate cancer, especially the importance of early detection.

West Bend Receives Military Base Expansion Funding

MADISON... A National Guard building expansion project worth almost \$9 million was approved November 17 for the city of West Bend, announced State Senator Mary E. Panzer (R-West Bend).

Senator Panzer said that the State Building Commission granted the 832nd Medical Company (Air Ambulance) the authority to construct an Army Aviation Support Facility, an Armory and a Motor Vehicle Storage Building.

According to Panzer, the National Guard unit's current facilities were deemed inadequate by the Commission. "The West Bend air ambulance unit is expected to immediately respond to future state, national, and international crises," said

Panzer. "The approved project will dramatically improve the conditions of the military base and will provide the 832nd Medical Company with the ability to meet this new mission."

Panzer added that the grant is contingent upon the state receiving a match from the Federal government. "The West Bend National Guard Unit will be awarded \$1,383,100 from general fund supported borrowing when the \$7,529,400 in Federal funds is received by the state," said Panzer.

For those who have a little more time, try this festive recipe combining sliced apples with cinnamon and nutmeg.

Apple Muffin Macaroon Cobbler Serves 6

3/4 cup sugar
2 tablespoons cornstarch

- 1 teaspoon ground cinnamon
- 1/2 teaspoon ground nutmeg
- 5 cups thinly sliced apples
- 1/2 cup apple juice

Cobbler Topping

- 1/2 cup butter or margarine, softened
- 2/3 cup sugar
- 2 eggs
- 1 cup ground almonds
- 1/2 cup half-and-half
- 2 teaspoons grated orange rind
- 3 Bays English Muffins cut into 1/2-inch cubes

Preheat oven to 375 degrees. In medium-sized bowl, combine sugar, cornstarch, cinnamon and nutmeg. Mix in apples and juice. Arrange in greased 9 x 9-inch baking dish. Bake for 25 minutes. Remove from oven.

While apples are baking, in medium-sized bowl, cream butter and sugar until smooth. Add eggs; mixing well. Stir in almonds, half-and-half and orange rind. Fold in English muffin cubes. Spoon over apples. Continue baking for 20 to 25 minutes or until top is golden brown and apples are tender. Serve warm.

Preceding her in death were an infant son, two brothers, two sisters and a son-in-law, Roy Stark.

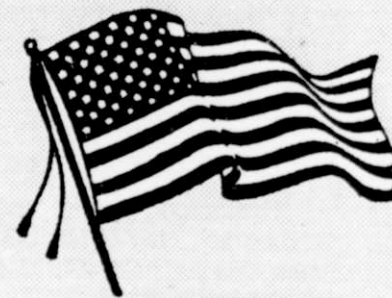

I realize that I have to strictly limit their time spent in front of it. But, tell me, is there any value to youngsters such as good eye coordination? I feel it's wasted time!

Dear Persevering Mom,

Please continue to persevere in monitoring your children's television watching and please add to your thankless tasks, the monitoring of Nintendo. I'm sure your relative meant well and I shall try, for your sake, to find some benefits of Nintendo.

Like many other video games, Nintendo probably may improve your child's visual motor integration. It may even serve to help them maintain some good concentration. If they play with others, it may serve to help them learn good sportsmanship. As your children improve in skill, it may increase some very specific confidence in Nintendo playing. Further more, it serves as a reasonable form of punishment, to be taken away for a day, if their behavior has been inappropriate.

I hope, however, that I haven't been too convincing since a computer can provide all those advantages and many others is definitely preferable to Nintendo.

Unfortunately, there is a long list of disadvantages for Nintendo. Some Nintendo games are violent and seem to encourage aggressive behavior in children. Furthermore, children spend so much time playing these games, that it may seem difficult to lure them away for healthier outdoor play, their chores and responsibilities, reading and/or homework.

Since Nintendo is here to stay for awhile, I suggest you reserve it for weekend play or until all chores and homework are completed. Even then, allowing only a reasonable amount of time for play, like no more than 45 minutes to an hour, will minimize any damage and still permit your children to enjoy their relative's gift without major harm.

You're one of the few moms who care so much that you're willing to set limits. Your children may not tell you that they appreciate that on a daily basis, but they feel much more secure as a result. Keep up your good work.

WINTER PARKING

The Winter Parking Restrictions and Snow Emergency Parking Restrictions go into effect on December 1, 1993.

Municipal Code Section 7.04 (3) NIGHT PARKING RESTRICTIONS, reads as follows: Signs have been erected at or reasonably near the corporate limits as provided in Section 349.13, Wisconsin Statutes, no person excepting physicians or licensed emergency vehicles on emergency calls, shall park or stop any vehicle on any public street or highway within the village between the hours of 2:00 A.M. and 6:00 A.M. from December 1, to April 1, of each year; provided that, notwithstanding such restrictions vehicles may be parked a period of time not longer than three minutes for actually loading or unloading of passengers, and provided further that no other regulation restricting parking as to place, time or manner violated thereby.

The fine for violating the ordinance is:

\$5.00 if paid within three (3) days of the issuance of the parking citation.

\$10.00 if paid after ten (10) days but before 28 days.

After 28 days, the amount is \$25.00 and a notice will be sent to the Motor Vehicle Department to suspend your vehicle, registrations and refuse renewals until the citation is satisfied.

An important fact is the owner of the vehicle is responsible for the payment of the citation whether or not he was the operator.

Municipal Code Section 7.04 (4) REMOVAL OF ILLEGALLY PARKED VEHICLES. This section covers the issuance of citations to and possible removal of such vehicles in violation of this ordinance. In addition to other penalties provided by Section 7.04 (6) of this code, the owner or operator of a vehicle so removed shall pay the cost of the towing and storage.

TOWN OF WAYNE NOTICE OF PUBLIC HEARING AND NOTICE OF TOWN BOARD MEETING

PLEASE TAKE NOTICE that the following proposed ordinance for the Town of Wayne, Washington County, Wisconsin, has been prepared:

AN ORDINANCE TO AMEND THE ZONING CODE OF THE TOWN OF WAYNE MUNICIPAL CODE TO REGULATE ADULT-ORIENTED ESTABLISHMENTS

WHEREAS, it is a lawful purpose of the Town Board of the Town of Wayne, Wisconsin, to enact regulations for the purpose of promoting health, safety and general welfare of its citizens and,

WHEREAS, pursuant to the Town of Wayne's authority, it is the intent of the Town Board to adopt by ordinance regulations restricting the location of adult-oriented establishments as defined herein to promote the Town of Wayne's interest in protecting and preserving the quality of its neighborhoods, commercial districts, and quality of urban life through effective land-use planning and,

WHEREAS, it has been the experience of other cities including Seattle and Renton, Washington and Detroit, Michigan that adult-oriented establishments can contribute to the impairment of the character and quality of a surrounding residential neighborhood and can contribute to a decline in the value of surrounding properties.

WHEREAS, adult-oriented establishments in proximity to residential areas, churches, parks, and schools may lead to an increase in criminal activities in the surrounding areas and the town desires to protect the youth of the community from the deleterious effects such businesses have on adjacent areas by restricting their close proximity to places of worship, schools and residential areas; and

WHEREAS, a reasonable regulation of the location of adult entertainment establishments will provide for the protection of the image of the community and its property values and protect the residents of the community from the adverse secondary effects of an adult-oriented establishment, while providing to those who desire to patronize adult-oriented establishments, such an opportunity in areas within the Town which are appropriate for a location of adult-oriented establishments and;

WHEREAS, the United States Supreme Court has approved efforts by local governments to regulate the location of adult-oriented establishments through land use plans and,

WHEREAS, the proposed ordinance serves a substantial government interest and does not unreasonably limit alternative avenues of communication.

NOW THEREFORE, the Town Board of the Town of Wayne, Washington County, Wisconsin do ordain as follows:

SECTION I: Section 1.27 of the Zoning Code of the Town of Wayne is created to read as follows:

1.27 ADULT-ORIENTED ESTABLISHMENTS

(1) DEFINITIONS.

(a) "Adult-oriented establishment," shall include, but is not limited to, "adult bookstores," "adult motion picture theaters," "adult mini-motion picture establishments," or "adult cabarets." It further means any premises to which public patrons or members are invited or admitted and which are so physically arranged so as to provide booths, cubicles, rooms, compartments or stalls separate from the common areas of the premises for the purposes of viewing adult-oriented motion pictures, or wherein an entertainer provides adult entertainment to a member of the public, a patron or a member, whether or not such adult entertainment is held, conducted, operated or maintained for a profit, direct or indirect.

(b) "Adult bookstore" means an establishment having as a substantial or significant portion of its stock in trade, for sale, rent, lease, inspection or viewing, books, films, video cassettes, magazines or other periodicals which are distinguished or characterized by their emphasis on matters depicting, describing or relating to "specified anatomical areas" as defined below, or an establishment with a segment or section devoted to the sale, rent and display of such material.

(c) "Adult motion picture theater" means an enclosed building with a capacity of fifty (50) or more persons used for presenting materials distinguished or characterized by an emphasis on, matters depicting, describing or relating to "specified sexual activities," or "specified anatomical areas," as defined below, for observation by patrons therein.

(d) "Adult mini-motion picture theater" means an enclosed building with a capacity of less than fifty (50) persons used for presenting material having as its dominant theme, or distinguished or characterized by an emphasis on, matters depicting, describing or relating to "specified sexual activities," or "specified anatomical areas," as defined below, for observation by patrons therein.

(e) "Adult cabaret" means a cabaret which features topless dancers, strippers, male or female impersonators, or similar entertainers.

(f) "Adult entertainment" means any exhibition of any motion pictures, live performance, display or dance of any type, which has as its dominant theme, or is distinguished or characterized by an emphasis on, any actual or simulated "specified sexual activities," or "specified anatomical areas," as defined below.

(g) "Specified sexual activities" means simulated or actual:

1. Showing of human genitals in a state of sexual stimulation or arousal;
2. Acts of masturbation, sexual intercourse, sodomy, bestiality, necrophilia, sado-masochistic abuse, fellatio or cunnilingus;
3. Fondling or erotic touching of human genitals, pubic region, buttocks or female breasts.

(h) "Specified anatomical areas" means:

1. Less than completely and opaquely covered human genitals, pubic region, buttocks, and female breasts below the point immediately above the top of the areola;
2. Human male genitals in a discernible turgid state, even if opaquely covered.

(2) Adult-oriented establishments are subject to the following conditions:

(a) Adult-oriented establishments shall only be allowed as conditional uses in B-2 Districts. Adult-oriented establishments are prohibited in all districts except as conditional uses in the B-2 Districts.

(b) No adult-oriented establishment shall be located within 1,000 feet of any public or private school, church, religious institution, day care center or public park. No adult-oriented establishment shall be located within 500 feet of any residential district or any other adult-oriented establishment. The above-noted distances shall be measured in a straight line without regard to intervening structures or objects from the closest point of the structure or portion of the structure occupied or proposed for occupancy by the adult-oriented establishments to the nearest point of the parcel of property or land use district boundary from which the proposed land use is to be separated.

(c) In addition to the above-noted limitations and restrictions upon adult-oriented establishments, and such establishment shall comply with all regulations and requirements of this Zoning Code and must comply with all provisions of the zoning district in which the establishment is located. Said establishment shall also comply with all other applicable provisions of the Town of Wayne Municipal Code.

SECTION III: Section 1.22(2) (c) of the Zoning Code of the Town of Wayne is hereby created to read as follows

(c). "Adult-oriented establishment," as defined in this ordinance.

SECTION IV: The several sections of this Ordinance are declared to be severable. If any section or portion thereof shall be declared by a decision of a court of competent jurisdiction to be invalid, unlawful, or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and not affect the validity of all other provisions, sections or portions thereof of the Ordinance which shall remain in full force and effect. Any other Ordinances whose terms are in conflict with the provisions of this Ordinance are hereby repealed as to those terms that conflict.

SECTION V: This Ordinance shall take effect immediately upon passage and posting or publication as provided by law.

PLEASE TAKE FURTHER NOTICE that a public hearing to consider its adoption will be held before the Town Board on Wednesday, December 15, 1993, at 7:45 P.M. at the Town Hall of Wayne, 6030 Hwy. H, Campbellsport, Wisconsin 53010. Copies of the proposed Ordinance are on file with the Town clerk and available for public inspection. All interested persons or their representatives will be given the opportunity to be heard at the public hearing.

PLEASE TAKE FURTHER NOTICE that immediately following the public hearing, and at the same meeting place, a regular monthly meeting of the Town Board will be held and that one of the agenda items at such meeting will be the adoption of the above ordinance as presented at the public hearing.

75 Years Ago

November 23, 1918

Sneak thieves indulged in a carnival of robbery in the village of Campbellsport, last Monday night staging their getaway in a dramatic manner by the aid of a gasoline handcar on the North Western Railroad. At the Seering and Curran General Store plunder to the amount of \$300 was taken. Entrance was accomplished by the removal of a basement window. Several men's overcoats, three dozen khaki shirts, a revolver and some money from the safe, was taken at the Seering and Curran place. The Knickel-Krans Company Store was also entered and several suits, a large number of mittens, gloves and sweaters were taken. The garage of the Campbellsport Auto Company was entered through a window but as yet it is not known whether anything was stolen. After plundering the stores, the thieves evidently made their way to the railroad signal house, where they appropriated a gasoline hand car which they lifted on the track and utilized to make their getaway.

Last week Saturday, the Kewaskum 30th Separate Co., W.S.G.R., received their Springfield rifles, forty in number, which are furnished by the state. These guns will be used for outdoor practice on a five hundred yard rifle range, the smaller guns for indoor practice have as yet not arrived, but are expected to be here in a very short time. With the guns were sent the complete equipment, 700 rounds of ammunition, 200 rounds of which are blank cartridges, gun slings, bayonets, scabbards and belts. On Tuesday evening the regular drill night, Captain Fellenz explained the different parts of the gun to the members of the company at the Armory, after which they marched to the Opera House where they received their first drill in the manual of arms. Although the members at first were somewhat awkward in handling the firearms, they soon became accustomed to them and went through the drills like "old vets."

The bill providing for a nationwide bone dry prohibition was passed by the Senate on Monday, and will become effective if President Wilson signs same. Upon the signature of the bill it will mean that after June 30, 1919, no more intoxicating liquor of any description can be sold. Legal experts of the "wet" variety express the opinion that the courts will hold the bill unconstitutional, on the ground that as framed it is intended for the purpose of conserving the man power of the nation, and to increase the efficiency in the production of arms, munitions, ships, food and clothing for the army and navy during war time only, and that if peace is signed before July 1st, the bill cannot become effective, especially now that the armistice has been signed, making the approach of peace possible.

Adolph Friess of Schleisingerville, while driving on the road with an auto truck last week Friday was instantly killed. The engine of the car was not in good working order and

in trying to climb a hill he commenced to shift gears, but the car started to move backwards down the hill and finally turned turtle, pinning Mr. Friess beneath same. The young man was strangled and was dead when found.

The Senior Class of Kewaskum High School met Tuesday evening and the following class officers were elected: President, Leo Brodzeller; Treasurer, Agnes Stoffel; Secretary, Ella Bunkelmann.

The Kewaskum Creamery erected a chimney the past few weeks at its plant. The new chimney which is being constructed by Opgenorth and Sons

of this village, is of white brick and when completed will be sixty feet high and five feet square at its base. This certainly is a good move on the part of S.C. Wollensak, owner and manager of the creamery, as the old chimney, through constant use, was in a dangerous state, and at times had started small fires in the roof of the building.

The marriage of Mrs. Katherine Kudek of this village to Gregory Schmitz of the Town of Farmington, took place at the Holy Trinity Church on November 21 at 7 o'clock. Miss Ida Fellenz and John Brunner acted as witnesses.

Study Finds Cancer Treatment For Women Differs With Age

MADISON -- When diagnosed with cancer, older women are less likely to receive innovative treatment or choose such treatments when they are offered, according to a study by two University of Wisconsin Medical School professors in a recent *Journal of the National Cancer Institute*.

The study by Dr. Polly Newcomb, an epidemiologist, and Dr. Paul Carbone, a medical oncologist and director of the UW Comprehensive Cancer Center, found that patient age appears to have a strong influence on the choice of treatment.

Researchers asked more than 600 women from throughout Wisconsin treated for breast or colo-rectal cancer what types of therapy they received and what factors had influenced the selection of their therapy. There were marked differences in the therapies offered to, and accepted by, women over age 65.

"Physicians offer older women with cancer different treatments from those offered to younger women and are less likely to recommend specialist consultation," Newcomb said. "The study also showed that older women were more likely to reject chemotherapy and radiotherapy treatment when offered and were more con-

cerned about side effects."

Although the participants' ages ranged from 20 to 74, Newcomb said the women over 65 were one third less likely than younger women to receive conservative surgery like lumpectomy, in which only cancerous tissue is removed. They were approximately one fourth less likely to receive chemotherapy. Instead, the older women were more likely to accept mastectomy, in which the entire breast is surgically removed.

The study revealed other differences in treatment, showing that older women were less likely to be referred to a medical or radiation oncologist and less likely to have alternative therapies presented to them. One third of the women aged 65 and older said they had not consulted an oncologist, compared with only 19 percent of younger women.

When asked to describe all specific therapies that their doctors discussed with them, older women were less likely (19 percent versus 31 percent) to report that their physicians presented more than one treatment option.

Regardless of age, the most common reasons for not selecting treatments were physicians' recommendations and the desire for more comprehensive treatment.

"We determined that a major reason for differences in therapy was related to the physician not offering all of the appropriate treatment options to the older women," Newcomb said. "Even though patients appear to have biases against

some therapies, most patients wanted the most comprehensive therapy."

Decisions based on age alone are clearly inappropriate, Newcomb said. Both patients and physicians must be educated and involved in the selection of treatment for a cancer diagnosis at any age.

TYPE E NOTICE - VOTING BY ABSENTEE BALLOT

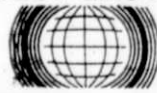

Village Board Meeting Minutes

**Regular Meeting
November 1, 1993
8:00 p.m.**

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First St.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Beisbier, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the minutes of the October 18, 1993 meeting were approved as printed.

Fire Chief Mark Groeschel was absent, but Assistant Fire Chief Mark Herriges was in attendance to review the Fire Equipment Truck bids as received October 7, 1993. It was noted that the Equipment Committee was still recommending the purchase of the Equipment Box from Excellence, Inc., Madison, Alabama, the high bidder, at \$133,501. Mr. Dan Schroeder and Mr. Knob representatives of the company, were present to explain differences within the bids. On a motion by Trustee David Goeden, seconded by Trustee Robert Beisbier and carried by the majority voice vote, the Board authorized the purchase of the Equipment Truck Box, etc., from Excellence, Inc. for \$133,501. Voice vote was 5 "Aye", 2 "Nay", 0 "Absent." Trustee Gary Gavin and Trustee Charles Waala voting nay.

Chief of Police Richard L. Knoebel had nothing specific to report.

Director of Public Works, Jerry Gilles informed the Board that the parks have been winterized and that on Tuesday, November 2, 1993, from 9:00 a.m. until noon a portion of the water will be turned off on Memorial Drive to complete the water loop connection. It was further noted that the contractor had accepted the Village's offer on the tank truck and that it would be brought to the village on Thursday, November 4, 1993 for a demonstration.

Discussion was held on the repair work needed on well #3 due to the reduction of water being pumped. Three proposals were received as follows:

CTW Pump \$16,600;
Municipal/Milaeger \$14,812; Layne Pump #1 - \$13,910 for model 9BEH, #2 \$14,205 for model 10RKHC (existing).

On a motion by Trustee Gary Gavin, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board authorized the emergency repair work to well #3 by Layne Pump for \$13,910.

Administrator Daniel S. Schmidt reviewed a few correspondence with the Board.

On a motion by Trustee David Goeden, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. The total of all claims as recommended are as follows:

Chairman of the Protection and

Public Safety Committee, Trustee Robert Beisbier brought three parking/traffic items to the Board for consideration as follows:

1) Parking limits Main Street/Parkview Drive (the problem basically took care of itself and the matter is dropped).

2) Request of the Kewaskum School District to waive parking restrictions for three days for a state meeting. On a motion by Trustee Gary Gavin, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board authorized the waiving of parking restrictions for November 10, 11 & 12, 1993.

3) Request to have a stop sign placed at the intersection of Prospect Street and Roseland Drive. It was noted the request was anonymous and the police indicated there were no reported incidents at that location since 1990.

Chairman of the Park and Recreation Committee, Gary Gavin informed the Board that the Softball Association was unable to attend the meeting, but that a letter would be sent to them regarding the operation of the concession stand and teams for 1994.

Board Representative for the Plan Commission, Trustee Thomas McElhatton informed the Board that the CSM is under new business for consideration and has been sent to the Board by the Plan Commission and recommended for approval.

Board Representative for the Library Board, Trustee Charles Waala informed the Board that Library Board Member Marge Rosenthal has asked to be replaced.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee David Goeden informed the Board that a Legislative meeting has been scheduled for Wednesday, November 10, 1993.

Discussion was again held on the capital improvement project involving Bonnie Lane. There were four of the property owners present. Trustee Thomas McElhatton reviewed the results of a meeting held with the contractors and indicated what was suggested regarding restoration, drives, retaining walls and replacement of some sidewalk. After considerable discussion it was the consensus of the Board and property owners in attendance that if the Village would not pay for restoration the property owner would take care of it. It was further noted that the drives and approaches should be completed by the contractor and then billed back to the appropriate properties. The retaining wall issue was left as the sole responsibility of each property owner. The Director of Public Works was directed to improve the short section of storm drainage on the south side of the road. The matter of the 200 plus feet of supposedly high sidewalk was discussed and the matter is still under investigation, but for the time being will remain unchanged. On a motion by Trustee Gary Gavin, seconded by Trustee Thomas McElhatton and carried by the majority voice vote, the Board authorized the contractor to install asphalt within the driveway approaches and to connect to the existing pavement if in existence and the cost would be born by the property owners receiving the benefit. Trustee David Goeden voting nay.

On a motion by Trustee Gary Gavin, seconded by Trustee Thomas McElhatton and carried by the majority roll call vote, the Board directed the Administrator to hire someone to verify the noted work as to its correctness. Roll call vote was 4 "Aye," 3 "Nay," 0 "Absent." Trustee David Goeden, Trustee Robert Beisbier and Trustee Harry Roecker voting nay.

On a motion by Trustee Gary

Gavin, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board approved the CSM for Shefond Oil Inc., dividing the parcel known as V4-619. The Village President and Administrator were authorized to sign said survey.

Administrator Daniel S. Schmidt reviewed with the Board the combined preliminary budget for 1994. Expenditures exceeded the revenues by an estimated \$134,000, prior to further revenue and expenditure adjustments. Discussion was held on items to be and not to be cut from the proposed budget. On a motion by Trustee Gary Gavin, seconded by Trustee Thomas McElhatton and carried by the majority voice vote, the Board directed the Administrator to implement their suggestions regarding adjustments and to try and achieve a tax rate of 2.5% increase.

The Board was informed as to how the VTAE and Kewaskum School District will affect local taxpayers. It is estimated that VTAE will increase \$.15 or 7.7% and that the School District will increase \$1.20 or 6.2%.

On a motion by Trustee Robert Beisbier, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board set the budget public hearing date for November 29, 1993 at 7:00 p.m. and adjusted the December meeting schedule by canceling the meetings of December 6 and 20, 1993, and establishing December 13, 1993 as December regular meeting.

Discussion was held on Resolution No. 93-21 a resolution accepting by dedication the street and utility improvements within dedicated right of way on Timblin Drive. It was noted that said had not been completed as of this date and that the development agreement indicated the improvements were needed prior to action and also issuance of any occupancy permits. On a motion by Trustee Charles Waala, seconded by Trustee Robert Beisbier and carried by the majority voice vote, the Board authorized the issuance of the occupancy permits upon completion of the dwellings and completion of the road base, curb/gutter and base course of asphalt. Trustee David Goeden abstained.

On a motion by Trustee Robert Beisbier, seconded by Trustee Charles Waala and carried by the majority roll call vote, to adjourn to closed session under Chapter 19.85 (1) (c) of the statutes to consider employment, compensation and performance of public employees over which the governmental body has jurisdiction. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

William Volkert, Wildlife/Ice Age Naturalist at Horicon's Department of Natural Resources Office, will present a program at the Friends of the Kettle Moraine Annual Meeting on November 30th.

"Across the Arctic - Travels in the Far North," will be the theme of his presentation. His program will include slides and experiences of his six arctic expeditions over the past twelve years.

He will take the audience on a trip, via slides, that traces the various and changing landscapes from the low and sub-Arctic region of the Hudson Bay lowlands to the farthest reaches of the high Arctic, more than 1,000 miles beyond the Arctic Circle. Along the way, vast and varied habitats that provide the nesting grounds for many of our migrant birds will be seen.

Volkert is widely traveled

and well known and has made several trips to the former USSR. He was invited by the USSR Academy of Sciences to tour the world's greatest lake, "Lake Baikal," and to meet with scientists working on research and management of the Lake.

In addition, he was selected to be part of a Wisconsin Department of Natural Resources delegation that was sent to the Lake Baikal Area in June of 1993. He spent July and August of this year studying the area's wildlife, ecology and human culture.

The program will be held at the Ice Age Visitor Center near Dundee on Tuesday, November 30, at 8 p.m. following the Friends Group annual business meeting.

Pheasant Stamp Design Contest

MADISON -- Artists interested in entering a contest to select the 1994 Wisconsin Pheasant Stamp design have until January 18, 1994 to submit their entries to the Department of Natural Resources.

This is the third annual contest to select a state pheasant stamp, according to Bill VanderZouwen, upland wildlife ecologist for the Wisconsin Department of Natural Resources.

Wisconsin requires pheasant hunters to purchase a stamp to hunt in pheasant management districts, VanderZouwen said. Funds raised through the sale of stamps are used for pheasant management, stocking and habitat restoration, he said.

Wildlife artist Rev. Samuel Timm of Wautoma won the 1993 pheasant stamp design contest with a painting of a pair of pheasants in a field along a fence line. His entry was chosen from 27 submitted.

The design must be the artist's original creation and cannot be copied or duplicated from previously-published art, including photographs. The subject must be a ring-necked pheasant

in a setting typical of the Wisconsin environment. An artist may submit only one entry and any artist who has won the contest during the preceding two years is ineligible.

Judging for the 1994 stamp will take place in February and the winner will be announced immediately after judging.
