Russ Darrow Purchases Neuville Chevrolet Here

WEST BEND - Just recently announced, Russ Darrow, President of the Russ Darrow Automotive Group, has entered into a Buy/Sell agreement to purchase the assets of Neuville Chevrolet in Kewaskum. The details were not available, but the purchase by the Darrow organization apparently represents a further expansion into additional domestic car and truck lines... this time, Chevrolet.

When asked to comment, Darrow said, "Yes, it's true... Lou Neuville and I have signed a Buy/Sell agreement and the process of completing the transaction is underway. Naturally, I am pleased to be acquiring a Chevrolet dealership because it further expands the products we can offer our existing customers, in both cars and trucks, and it substantially opens up new opportunities for our sales efforts, our service and parts departments. In addition, our current Russ Darrow Group employees, now have the choice

to work in a Chevrolet dealership, and will be able to service their friends and relatives who intend to purchase a Chevrolet product."

Darrow said the dealership transfer would probably be complete within four to six weeks, and in the meantime, he will be working on staffing up the dealership sales with the best possible personnel and management in areas of service, parts, and sales.

According to Darrow, approximately twenty job opportunities will be available in Kewaskum. On that subject, Darrow said, "We will really be working hard to find the best possible people for the necessary positions."

Then we will be training and 'Darrowizing' the selected people so we can assure our dealership prospects as well as the present loyal Chevrolet customers that they will receive the highest possible quality of treatment in each dealership department. Naturally, we will be

aggressively informing Washington County residents about our dealership after the switch-over is complete, and our people are in place ready to do business."

When contacted, Joe Neuville, Kewaskum, confirmed the Buy/Sell agreement and thought the agreement would be "good for Kewaskum."

The Russ Darrow Group is the 25th largest privately held company in Wisconsin, and the #1 automotive dealership group in the state, according to Arthur Andersen & Company 1993 "Top 100" survey.

The Group currently represents 13 different franchises and six dealership locations in Appleton, Cedarburg, Mequon, Madison, Waukesha, and West Bend.

Pending factory approval, this acquisition would increase the number of franchises to 14 and add one dealership location to the Russ Darrow Group, therefore totalling seven separate locations.

State Lottery Credit Decreases

Village Approves 2.55% Tax Hike

KEWASKUM - Village of Kewaskum taxpayers seem to be happy with the efforts of the Village Board in their attempt to keep the 1994 tax rate increase to a minimum, judging by the lack of attendance at a public hearing last Monday night.

No one was present to oppose a 2.55 percent tax rate increase that was unanimously approved by the Board at the meeting. The increase will mean that Village residents will pay \$7.12 per \$1,000 of assessed property value in 1994.

The \$7.12 figure represents about 20 percent of the village resident's gross tax rate. School

district taxes account for the highest percentage (58%) of the tax rate, while state taxes account for the smallest (0.7%).

A owner of a property worth \$50,000 will see an increase of \$8.86 on their tax bill; a \$70,000 property will see an increase of \$12.40; and a property valued at \$100,000 will see an increase of \$17.71.

The \$7.12 rate pays for approximately 71 municipal services, broken down into the following departments: General Government - \$1.46; Protection/Police - \$1.54; Protection/Fire - \$.71; Public Works - \$1.34; Health and Welfare - \$.01; Park and

Grothman Wins Assembly Seat

Republican candidate Glenn Grothman, West Bend, handily won his bid for the 59th Assembly District seat in Tuesday's Special Election in his first try at elective office.

Grothman easily defeated Libertarian candidate Kevin Scheunemann, 21, and Independent Richard Buntrock, 55, with 79% of the vote.

In the Village of Kewaskum, a sparse 169 votes were cast, with Grothman receiving 128, Buntrock 27 and Scheunemann, 12.

The Special Election was held for the 59th District Assembly seat formerly held by Mary Panzer, who won another Special Election in September for the State Senate seat vacated by Donald Stitt.

Grothman will serve the remainder of Panzer's term, which will run through 1994.

United Way Closer to Goal

It's getting close! United Way of Washington County officials report that as of December 2, the campaign is at \$820,999.75 in pledges and gifts received. This represents 97.7 percent of the \$840,000 county wide goal.

"We've added \$18,000 in the past three weeks," said Andy Gumm, Campaign Chairman. "This is significant progress, and we need the momentum to continue as the drive heads into the final month."

The 1993 goal represents a 6.7% increase over last year's \$785,000 goal. The \$808,700 that was officially raised last year has been surpassed.

Campaign volunteers are cautiously optimistic that the goal can be reached. "The needs of our agencies and the vital services they provide depend on United Way. And United Way depends on the generous giving spirit of donors," said Gumm. 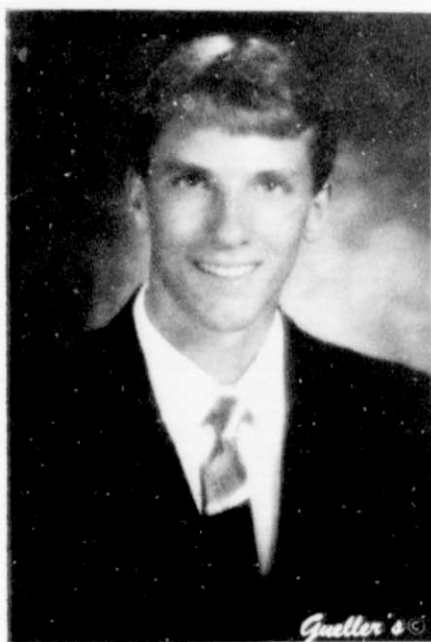
Rachael Chambers

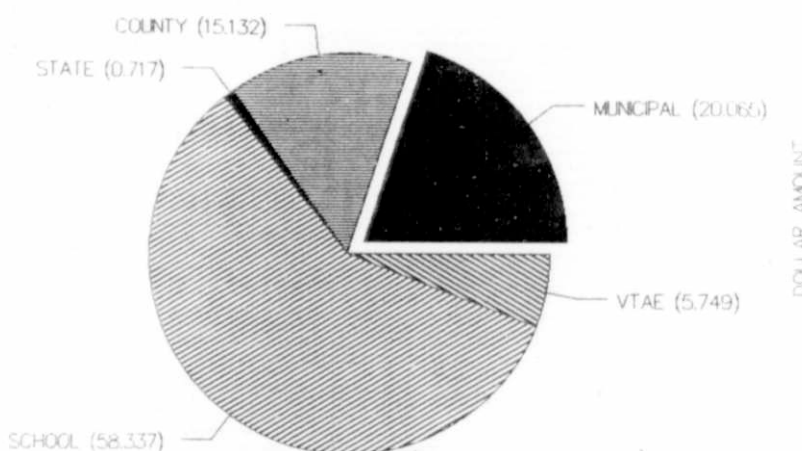

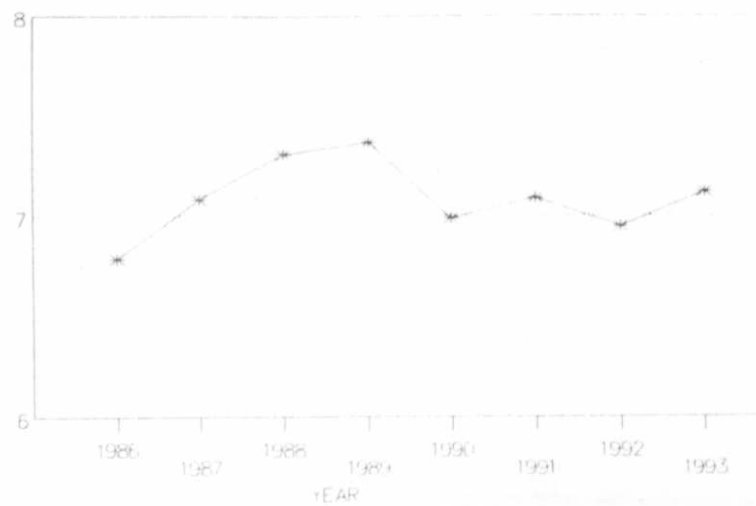

Education \$.79; Conservation and Development - \$.15; Debt Service (CIP) - \$.85; Special Revenue Fund - \$.02, Debt Service General - \$.25.

The total budget showed a slight decrease of .28 percent, from \$1,417,905 in 1993 to \$1,417,509 in 1994. The tax levy, meanwhile, increased 8.67 percent from \$343, 898 in '93 to \$373,710 in '94. The growth of the village has helped offset the increase in the tax levy, thus, the residents won't bear much of the burden, according to Village Administrator Daniel Schmidt, who received praise for his efforts working on the budget.

"I would like to thank Mr. Schmidt for his fine work, and the work of the department heads," Trustee Gary Gavin said.

Schmidt noted that the vil-

lage's TIF fund would realize almost \$90,000 in excess revenues, meaning that the TIF loan would probably be paid off 4-5 years sooner than expected. Thus, the village would save money by not having to pay the interest due for the remaining years of the loan.

In a related matter, Schmidt told the Board that the village's state lottery credit would be decreased by 37.9 percent next year, from \$154.70 to \$96.01. The amount has decreased because the state legislature borrowed money from this year's lottery receipts to maintain the level of lottery credit in 1992. The legislature chose not to do this for 1993, thus the decrease in the credit.

The Board of Directors of Kewaskum Youth Scholarships, Inc. has announced that ten scholarships totalling \$30,200 will be awarded to this year's graduating Kewaskum High School seniors. The following is a listing of the amount and number of each kind of scholarship.

Two four-year college scholarships, each worth a total of \$10,000 (\$2,500 a year for four years) are being offered. One of these \$10,000 scholarships is provided by the KEYS scholarship fund, and the other is provided by the Oscar C. and Augusta Schlegel Foundation. Two \$2,000 KEYS College or Technical Scholarships (\$1,000 per year for two years) will also be awarded. A \$1,000 KEYS Technical Scholarship will be awarded for the second time this year as well. New this year is the Barbara York College Scholarship worth \$1,200.

Three memorial scholarships will also be awarded this year: The Ann-Marie Horner Memorial Scholarship will be presented for the fifth time, the

Kilian A. Honeck Memorial Scholarship will be presented for the third time, and the Evelyn Joyce Gruber Memorial Scholarship will be presented for the second time. Each memorial scholarship is worth \$1,000. The James and Sarah Andre Scholarship, also worth \$1,000, will be awarded to a student pursuing a nursing career.

The first scholarships awarded by KEYS, Inc. were worth \$500 and were presented in the spring of 1986 and 1987. In 1988, \$1,500 in scholarships were awarded, followed by \$3,000 in scholarships in 1989. In 1990, the dollar amount jumped to \$12,000 and then climbed to \$16,000 in 1991. Then, in 1992, the dollar amount awarded rose to \$20,500 and escalated to \$25,000 in scholarships last year. With the \$30,200 in scholarships to be awarded in the spring of 1994, the total amount will reach \$109,200 awarded since 1986. The KEYS organization wishes to thank the alumni, businesses,

organizations, and community members for their generous donations which make these scholarships possible!

KEYS officials hope that the community senses the pride that is involved in this accomplishment. Even with this kind of success, KEYS realizes that more funds must be raised to provide the interest for even more scholarship help. If KEYS is to continue to grow, donations are necessary from the whole community. Past and new donors are asked to please continue to contribute to KEYS.

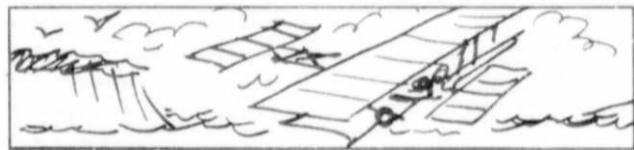

LOMIRA -- A team expends a lot of energy when it has to come back from an early deficit. That can sometimes lead to problems when it comes crunch time in the fourth quarter.

That's what happened to the Kewaskum boys basketball team here, last Thursday night, as Lomira raced to an early lead, then hung on down the stretch to secure a 68-60 win over the Indians.

"I really had a feeling that we were going to pull it out," Westphal said of the rally. "But

we just could never get over the hump."

Lomira gradually pulled away late, as it dominated the boards in the final period.

"They had a lot of second chance opportunities," Westphal said of their bounding edge. "They've got a very good ball team."

Junior guard Tim Strigenz "did a fine job" for the Indians, according to Westphal. Strigenz led the Indians with 20 points, including a pair of three-pointers. Travis Jacak also played well, chipping in 17 points.

"We played very well in the second half," Westphal added. "But I was very disappointed in the way we came out in the first half. We just weren't making a very good effort."

Turnovers once again hurt the Indians, as they accumulated more than 20 miscues. "That's just way too many," Westphal pointed out.

After splitting their first two games of the year, the Indians have just one non-conference tilt remaining (Tuesday at Germantown) before diving into the Eastern Wisconsin Conference schedule. The Indians open the conference slate Friday, when they host Two Rivers.

Next week, the Indians will be at home for two more EW contests, hosting New Holstein on Tuesday, and Chilton on Friday.

I think I can speak for each and every one of my employees in saying... "thanks for the warm hellos, smiles and waves as we came down the street." Hopefully, it gave you a chance to see us... YOUR postal employees, families and yes, even the retired Postmasters and their wives.

The busy season is upon us and I cannot think of any other community that I would rather be "sharing" it with than... Kewaskum. You've heard me say this, read it before, BUT must reiterate it one more time... I LOVE KEWASKUM and each and every one of you just "make our day" with your visits to the Post Office.

The SONG is probably still with your and please well remember... WE DELIVER, WE DELIVER... WE DELIVER FOR YOU... AND YOU... AND YOU!

In this week's column, I will cover some questions and answers that hopefully you will find interesting and helpful.

QUESTION: With Christmas quickly approaching, can I still mail my packages parcel post? Will they arrive within the United States by Christmas?

ANSWER: If your packages are going out of state and you want to mail them parcel post, (the less expensive way), I would strongly suggest that they be mailed this week. Within the state, next week should be still okay. A helpful tip that I would recommend would be that check into BOTH prices as you may see that for a few cents more, your package can go First Class/Priority. For your convenience, feel free to call us at 626-2575 with the weight of your package and the zip code of destination we will be more than happy to quote prices over the phone for you.

QUESTION: Does the Postal Service have a "gift line" like they did a few years back (t-shirts, teddy bears, trucks, banks?)

ANSWER: We no longer carry those type of items but can give you some helpful hints for that "hard to buy person." EVERYONE uses postage stamps. Maybe you are thinking of a nice box of stationery. A little "tuck in" could be a sheet of our no-lick stamps. Remember, you do not pay any extra for these. Your choice would be 18

roses for \$5.22, 18 squirrels for \$5.22, 18 pine cones for \$5.22, 17 eagles for \$4.93 or 12 Christmas stamps for \$3.48. We have booklets of "lick and stick" stamps also and they sell for 10 for \$2.90 or 20 for \$5.80. Have a stamp collector to buy for? No problem. Get that person the stamp guide that they can look up their stamps (cancelled and uncanceled) and check on current value. Did you know that the Postal Service has a game? Yep, it is a "neat" board game that will certainly be a collectible as it is the ONLY game ever put out by the Postal Service. Stop in and check it out... might just fit someone on your list!

QUESTION: A friend of mine told me about a Mint Set that the Postal Service puts out each year. Can you tell me about that?

ANSWER: Gladly! A Mint Set is a collection of each and every commemorative stamp that was issued during the year. The current one is on sale for \$24.95 and there is almost \$21 worth of stamps PLUS a hard back book to put them into. Each page gives you the story behind the stamp and the stamp is included (in mint condition) along with a protective to keep it in. Some might think that this gift would only be appropriate for a stamp collector, but this is a "piece of history." My daughter has 20 sets of these (one for every year of her life) and she still looks forward to opening up the current year to add to her collection. Keep in mind that the stamps DO NOT lose their value and if anything, increases. You may want to stop in and ask one of the clerks to show you this item. We will be more than happy to!

And now, a few items to report on for you: We will be extending our Saturday window hours on Saturday, December 11th and Saturday, December 18th. The window will be open from 8:30 a.m. to 12:30 and hopefully this will assist you in mailing! We also post West Bend and Fond du Lac office hours as they will be open even longer on Saturdays and also have Sunday hours for your convenience. A sincere thank you to each

and everyone of you that are bringing your cards and letters to the window. Every piece of mail has to be cancelled before dispatch to Milwaukee during the Christmas "rush" so you are helping us to move the mail a little quicker by doing this. Those that can, please separate in town, out-of-town and Campbellsport as those are three separations that we make.

KEWASKUM - The Kewaskum wrestling team continued to surprise coach John Nell here, last Thursday as the Indians battled a tough Cedar Grove squad.

The Rockets, rated among the top Division 3 schools in the state, barely escaped with a 33-27 win, as Cedar Grove heavyweight Mark Martinez pinned the Indians' Tim Gundrum in the night's final match. The two teams entered the match tied at 27-all.

"We knew that their 275-pounder would be tough," Nell said. "But our kids did well. It was a real close meet. I guess we're doing a lot better than I thought we would."

Both responded with easy wins, as did Dziedzic, who, according to Nell, "is looking real tough." Dziedzic will eventually be moving down to the 103 spot after the Christmas break, when the WIAA gives a two-pound allowance in each weight class.

Kewaskum's other victory came at 140 pounds, where Jason Czaja was successful in his varsity debut, beating Craig Schwanz 12-5.

"He did a real nice job," Nell said of Czaja. "He was real tired after the match, because he hadn't wrestled much. He's inexperienced, but he's a real fighter."

The loss left the Indians with just a 2-2 dual meet record, but considering those losses came to Cedar Grove and Campbellsport, two of the top schools in their respective Divisions, Nell isn't exactly worrying at this point.

"They both are real tough teams," Nell said of the losses. "That's good though. I'm glad our kids got a chance to go against some state-caliber opponents. It gives them an idea of where they are, and how much

work they still have to do."

The Indians have a couple of light work weeks before the Christmas break. The Indians host Chilton this Thursday night, and then entertain Germantown next Thursday. The KHS JV's will also be hosting a JV Invitational here, this Saturday, beginning at 10 a.m.

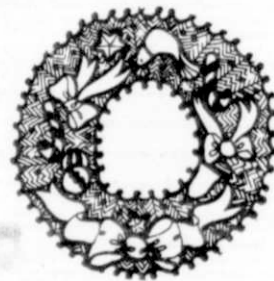

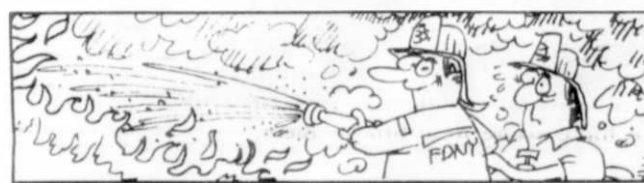

Village Board Meeting Minutes

Mid-Monthly Meeting
November 15, 1993
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First St.

President Robert Wagner presided. Trustee Thomas McElhatton asked to be excused and was absent, all other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Beisbier, seconded by Trustee David Goeden and unanimously carried by voice vote, the minutes of the November 1, 1993 meeting were approved as printed.

Fire Chief Mark Groeschel asked to be excused and was absent, due to Fire Department business.

Chief of Police Richard Knoebel, October 1993 monthly report: Criminal arrest 34, Criminal investigations 41; Traffic warnings 137, Traffic citations 44; Adult arrests 9, Juvenile arrests 15; Property stolen \$113, Property recovered \$22; Parking violations 9, Parking citations 11.

Chief of Police Richard L. Knoebel informed the board that the state type bidding for squad cars was going to be on November 30, 1993.

Director of Public Works, Jerry Gilles informed the board that the tank truck was brought for the demonstration and the truck had been purchased. The matter of the roots in the sewer line at RHP were discussed as well as the status of the ice skating pond refurbishing. The testing of the water system was reviewed and test results were reported.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review of the budget control sheet for the month ending October 31, 1993.

2) Review of building permit report for October 1993.

3) Review of League bulletins and Taxpayer Alliance bulletins.

4) Informed the Board that Star Cablevision Group was in the process of being sold to Marcus Cable Partners, Dallas and Goldman Sachs Investment Firm of New York.

5) Discussed a letter from the School District of Kewaskum requesting an audience with the Board to inform them of the districts expansion/remodeling at the high school and middle school. It was the consensus of the board to invite them to the mid-monthly meeting of January 1994.

On a motion by Trustee Gary Gavin, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board authorized a "STOP" sign at the intersection of Courtney Lane and Timblin Drive. The "STOP" sign will be placed on Courtney adjacent to Timblin Drive.

Chairman of the Park and Recreation Committee, Gary Gavin, brought up discussion of the situation regarding the Softball Association and continued support of the lighted softball diamond. It was noted a letter was sent to them following the last Board meeting and that no formal response had been received. Trustee Gary Gavin asked that the Administrator prepare an ad soliciting an organization or an individual interested in running the program.

Board Representative for the Plan Commission, Trustee Thomas McElhatton, was absent, but the Board was informed that the November meeting was not going to be held because of deer hunting and the Thanksgiving holiday.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee David Goeden, reported on a meeting where cooperation between jurisdictions was discussed.

Discussion was held regarding the request to have an outside engineering firm review the Bonnie Lane project. The firm contacted was R.A. Smith & Associates, Inc. It was noted that a two hour meeting was held with two engineers, three telephone conversations, a walking of the construction area and that several pictures were taken. All of this was done at no cost to date. If the Board wants a survey crew to resurvey and then a formal response prepared, the projected cost would be \$1,900 to \$2,300. The following points were noted as follows:

1) The problem basically began with the Board agreeing to the changing of the plans, leaving the existing road base and reducing the greenway, all at the property owners request.

2) The second portion of that problem was not to go back to the engineer to have the project redrawn and pricing reverified by the contractor. This would have added substantial cost, but may have eliminated some of the current problems. It was further noted that if changes are made it is not unusual for the matter to be handled like the Village Board did, so as to save money.

3) Some of the problems may have been eliminated if an engineering inspector would have been hired to oversee the project, but that too would have added cost to that project.

4) If the survey would now take place it would be difficult to determine who, if anyone, is at fault because the original staking is gone. Who was in error; the engineer, contractor or subcontractor, etc.

5) If the Board still wants to proceed, different options or corrective measures may come forward, but probably several recommendations will be the same as already received.

The Board, after hearing the above, did not take any follow up action to proceed with the spending of the \$1,900 to \$2,300. It was noted that if a problem still exists in Spring that money may get put to better use paying for corrective action.

Action was taken on Resolution No. 93-21 a Resolution Accepting by Dedication the Street and Utility Improvements within the Dedicated Right of Way as Attached hereto:

The Board reviewed the preliminary budget for 1994, the changes as requested were all incorporated into the budget leaving the rate at 2.55% above that of 1993,

which would equal a \$.1768 increase. The budget revenue and expenditure totals actually reflect a decrease of .28%. The public hearing will be held on November 29, 1993 at 7:00 p.m.

It was noted in general discussion that the Village, according to preliminary figures, would have the smallest increase of all taxing jurisdictions for 1994.

Action was taken on Resolution No. 93-22 a Resolution Prorating Departmental Expense as attached hereto:

Action was taken on Resolution No. 93-23 a Resolution to Request Tax Exemption from the County-Wide Library System Tax Levy under provisions of Wisconsin Statutes 43.64 (2) as attached hereto:

On a motion by Trustee Robert Beisbier, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board authorized the signing of the 1994 Aquatic Biologists, Inc. contract for swim pond maintenance.

The Board reviewed the proposed TIF/CIP budget for 1994. It was noted the revenue is increasing and the expenditures are decreasing to the final stabilized payments. If all continues as predicted, the TIF should be paid off in 1998 or 1997.

The Board reviewed the proposed Water Department budget for 1994. The revenue reflected a .7% increase and the expenditures reflect an 8.2% increase. This would indicate that the budget will balance, but will not show the Public Service Commissions ordered rate of return. This would mean the Board will be looking at the PSC for an adjustment in Water utility rates within 1994.

The Board reviewed the Water Pollution Control Departments budget for 1994. The revenue is increasing by 1% and the expenditures reflect a 2.7% increase. This means the amount of return is decreasing, but not at an alarming rate. It was noted that the Board has already asked the Engineers to review the sewer rates and to bring a recommendation back to the Board.

On a motion by Trustee David Goeden, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board moved to take the TIF, Water and Sewer budgets to public hearing as presented.

On a motion by Trustee Robert Beisbier, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board

approved the snowmobile route for the 93/94 season as it was in 92/93.

Discussion was held regarding the financing of the purchase of the Fire Department Equipment Truck. On a motion by Trustee Harry Roecker, seconded by Trustee David Goeden and carried by the majority voice vote, the Board authorized the Administrator to request the borrowing of \$120,000 from the State Trust Fund and to further investigate the refinancing of one or two existing loans and to sign the appropriate documentation required by the State. Trustee Gary Gavin voting "NAY".

On a motion by Trustee David Goeden, seconded by Trustee Charles Waala and carried by the majority roll call vote, to adjourn to closed session under Chapter 19.85(1)(c) of the statutes to consider employment, compensation and performance of public employees over which the governmental body has jurisdiction. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent."

Balance Lifts KHS Boys in Opener

KEWASKUM - After being eliminated by Port Washington in the WIAA Regionals last season, the Kewaskum boys basketball team may have had a little revenge on its mind here, last Tuesday night.

Whatever motivated the Indians, it worked. After falling behind early, the Indians came back strong against the Pirates, holding off a late rally to win 63-61, in the season opener for both teams.

"We're just happy to get off to a good start," KHS coach Jim Westphal said of the victory. "We really didn't play all that well."

Especially early. In the opening period, the KHS defense let Port Washington standout Brian Hebein run wild. Hebein outscored the Indians all by himself, with nine of Port's 11 points in the first, as the Pirates built an early 11-7 lead.

"He started off real hot," Westphal said of Hebein, who led all scorers with 20 points on the night. "We, on the other hand, got off to a real sluggish start. But we played better in the second quarter."

The Indians played much better, in fact, using the three point shot to outscore the Pirates 22-11 in the second stanza. Tim Strigenz, James Zautner and Erik Ankerson all hit "treys," as the Indians rolled to a 29-22 halftime advantage.

"We finally got our running game going (in the second quarter)," Westphal pointed out. "We got the tempo where we wanted it."

But Port Washington slowly crept back into the game in the second half. The lead was cut to 46-42 after three periods of play, and the Pirates actually took the lead in the final eight minutes of play.

But Kewaskum maintained its composure, quickly regaining the lead. The Indians went up by as many as ten in the final period, before Hebein brought Port back late.

Hebein hit a pair of three-pointers in the final minute and a half, turning a 60-51 lead into a nailbiter. KHS didn't help itself at all, missing several free throws in the late going.

Zautner hit one of two free throws with just three seconds to play, extending the KHS lead to two points, at 63-61. Port had one last chance at victory, but Hebein's half-court prayer wasn't answered, and the Indians escaped with the win.

"We missed some big free

throws down the stretch," Westphal said. "That made it kind of scary at the end."

Zautner ended up sharing the KHS scoring honors with Travis Jacak, each connecting for 14 points. Two more Indians, Ankerson and Tim Strigenz, hit for 11 points each, as the balanced attack proved to be the difference.

"It was a very good team effort," the Indian boss pointed out. On the down side, though, Westphal added "We gave away the ball way too much."

The Indians had 26 turnovers for the game, somewhat offsetting their hot shooting (nearly 50% from the floor.)

JACKSON - Kewaskum girls basketball coach Glenn Eichstedt is hoping that in the future, games between his Indians and Kettle Moraine Lutheran will be scheduled for much later in the season.

Eichstedt said that it appeared the Chargers were "in mid-season form" here, last Tuesday night, as KML raced to a 16-3 first-quarter advantage, and easily beat the Indians, 52-33.

"They seemed much more prepared and much more in sync than we did," Eichstedt said of the talented Chargers, who moved to 4-1 on the young season. The Indians, meanwhile, dropped to 2-2.

"We didn't come out to play with the kind of intensity needed to be successful," Eichstedt went on about the first-quarter woes. "You're just not going to be able to overcome a deficit like that. We let them get out of the box too quickly."

The Indians did play better in the second and third quarters, however, cutting the deficit to just six at one point in the third. "We just weren't able to push it

down any further," Eichstedt noted.

KHS guard Ginger Wiesner had much to do with the Indian comeback, as she tallied 13 of her game-high 17 points in the middle two quarters. But Wiesner didn't get much help from her teammates, as the next highest scorer registered just four points.

"We need to get more people involved in our offense," Eichstedt repeated. "As good as she (Wiesner) is, teams are going to find a way to slow her down, and then other people are going to have to help out."

The Indians had trouble with the KML pressure, as they had "a high number of turnovers," according to Eichstedt. "That just translates into more oppor-

tunities for them."

Kate Lepein and Chrissy Adnerson each scored 12 points to lead the Chargers.

"What's so impressive (about KML) is that they are so fundamentally sound," Eichstedt said, raving about the Chargers. "They play very well as a team, taking advantage of your mistakes."

"I think we just ran out of gas in the fourth quarter, and they hit their shots."
