New Subdivision to Be Constructed Here

A new single family land development, Sunset Estates, goes up before the Kewaskum Village Plan Commission March 21 at a public hearing.

Village residents, Gary and Linda Gavin, are seeking approval to improve land located between Knights Avenue and Edgewood Drive, for the purpose of creating a new single family residence subdivision.

Still in the formative stages, Gavin's plan is designed for two phases of construction, with the first to begin sometime in May. The building project includes 31 lots, approximately 75 x 95 feet, with 150 feet of depth, situated south of Knights Avenue on a piece of property behind existing homes.

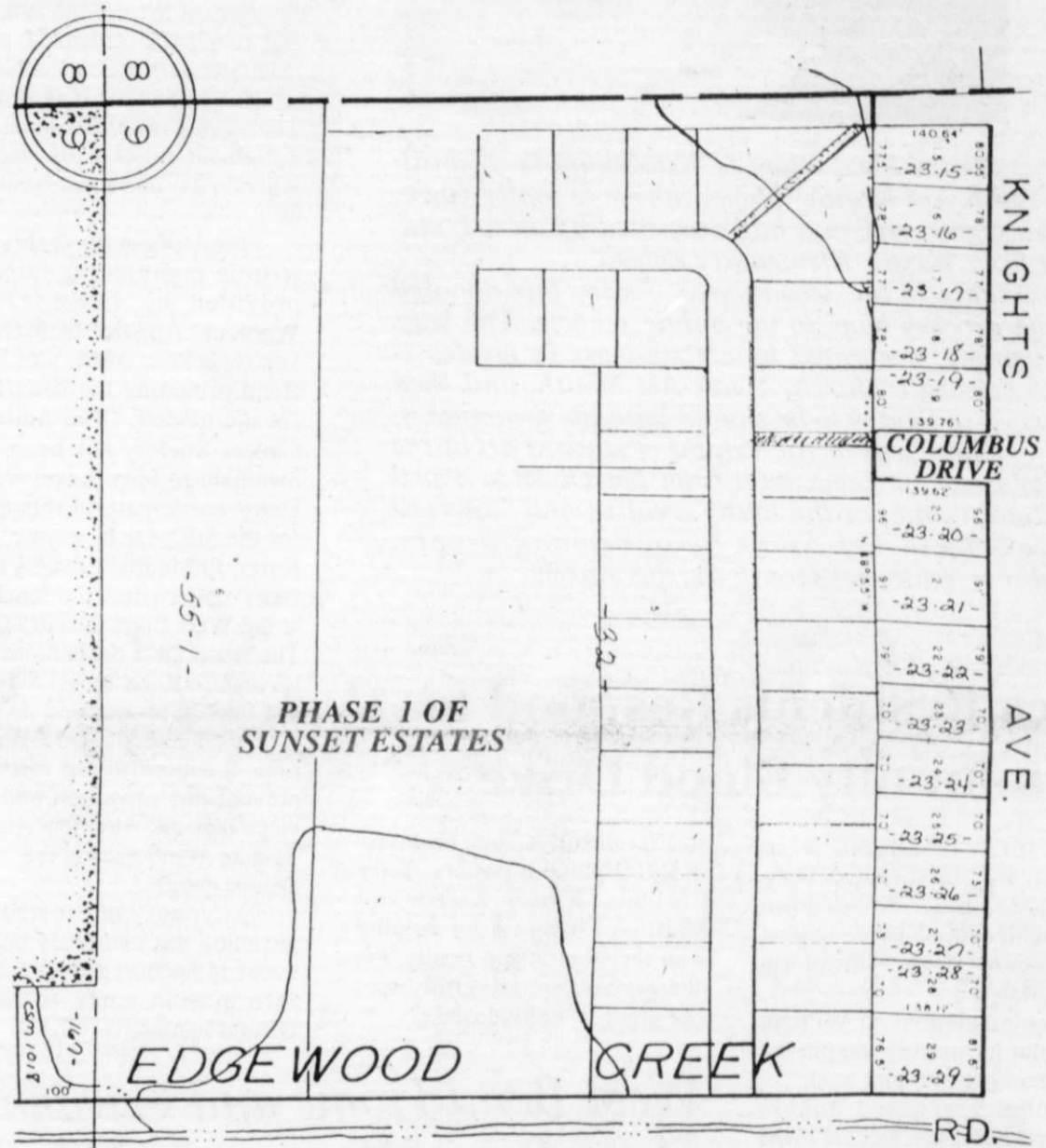
The first two houses constructed will be spec homes bordering on Edgewood, and will

include approximately 1,500 square feet of living space.

Gavin explains Sunset Estates' only two specific requirements include at least 1,300 square feet of living space constructed and a two car garage. Lots will average between \$18,000 to \$20,000, pre-construction price, and before the road goes in.

"I think this will really go," Gavin comments, relating the demand for single family homes in the community. "There are only nine lots available right now in the entire village."

Village Engineers Rueckert & Mielke will oversee all improvements, including land surveying and layout of the streets. Several options are being planned for Phase II of the Sunset Estates Development.



Village Board Breezes Through Light Agenda

Fire Chief Mark Groeschel was on the top of Monday evening's village board agenda and during his monthly report to the board he gave an update on the status of the new equipment truck which is currently in production. Groeschel also gave a projection of his department's needs for the future.

He reported that he had met with the fire department's equipment committee on the status of the tanker and he reiterated the consensus was, "the chassis should be replaced and the second option that we have, we felt that the tank itself should be replaced also because it has a high leak in it right now towards the top and we don't know what the outlook looks one year down the road, two years down the road, three years down the road, or how long the tanker is going to last."

Groeschel added, "I have no idea. That tanker was built in 1983, the chassis itself is a '72 and was purchased June 5, 1972. Originally that tanker had a 26,000 gallon tank on it and that was replaced with the smaller version that we have now... the 16,000 gallon tank."

Groeschel questioned the dates on the equipment replacement sheets and Village Administrator Dan Schmidt

replied, "The dates in reference to replacements are just target dates. There's no gospel to that. We just felt we should put something on there in reference to time frames. I don't think we've ever hit one of the target dates right on the head yet on that sheet."

Groeschel then asked, "What direction do you want us to take. If you want a rough guess on what it is going to cost us to replace that truck, you're talking about \$80,000. And that's the chassis and the tank."

Groeschel and Trustee Tom McElhatton discussed if there was a possibility of sealing or coating the truck. Former Fire Chief Robert Stoltzmann interjected there was a way of coating the inside of the tank, "but if your exterior is still starting to get rotten, it don't pay." He called the idea, "a bandaid."

Trustee Charles Waala inquired if the fire department had anyone else look at it to which Groeschel replied, "No, I'm just here tonight to ask what direction you guys want me to take."

Trustee David Goeden asked the status of other equipment coming up for replacement and said, "My idea is to push it off for a year or two down the road and then push the one (due for replacement) in '98 off until 2001 or 2002."

Stoltzmann stated, "Don't push this water tanker off too far... there's going to be problems."

Trustee Tom McElhatton replied, "Yes, but the cup is empty right now."

Groeschel said he understood this and even though some of the trucks might have low mileage, when they do get used, they get used hard... especially the tanker and he had no idea about its longevity.

Trustee Charles Waala stated that there had to be companies out there that do repairs on these trucks, to which Groeschel stated the leak is a high leak and he could live with that but the problems lie in the chassis.

Waala asked, "Estimates gotta be free, right?" McElhatton again reiterated, "I don't care, the cupboard is empty."

Trustee Goeden said, "To me, if your committee wants to go out and do some shopping and make some phone calls, that's fine, but I personally wouldn't be for this truck for a

year or two down the road. For that reason... the cupboard is empty and if we can make it (the tanker), last another year and a half rather than spending the 80 grand, spend a grand or two grand to make it last two years and we're money ahead."

Trustee McElhatton said the fire department should check into how much it would cost to maintain the tanker for now.

In the absence of Police Chief Richard Knoebel, who had another commitment, the board heard the report from DPW head Jerry Gilles. Gilles discussed the option of replacing or repairing two village comminutors.

Village Administrator Dan Schmidt added there had been money budgeted the past few

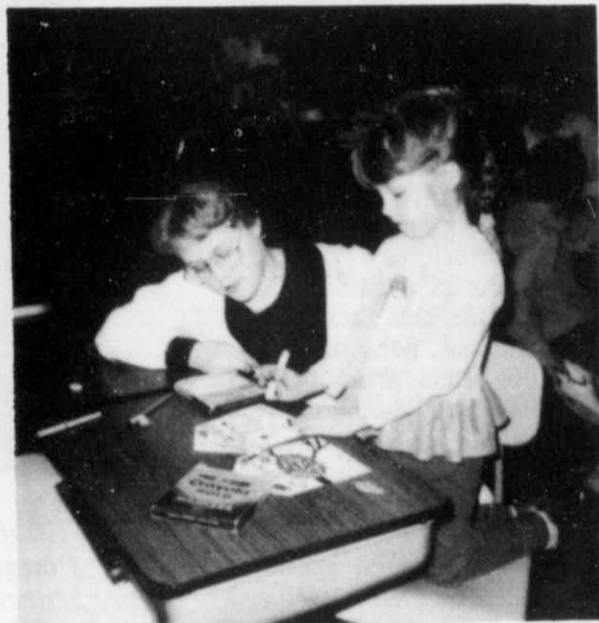
Students Pair Up For 'Big Buddies'

years to replace the comminutors. The board then voted unanimously to replace the comminutors.

Schmidt updated the board on plans for the village's centennial which will be held next year. He stated letters had gone out to all local civic organizations asking a representative to be present at an organizational meeting for the centennial celebration on April 11. More information on the centennial plans will be forthcoming.

Schmidt also reported on correspondence, cable franchise fees, the videotaping of the village sewage lines and the replacement/addition of light poles when the roadwork begins on the Highway 45 project.

It is estimated there will be six poles on the north end and

four on the south. There are currently 25 or 26 existing fixtures on Fond du Lac Avenue. There are currently 2 poles now that have deteriorated to where they should be replaced.

It was stated the poles run around \$1,500 each with ornamental poles running almost double that figure. A decision was made to go with the same concrete poles of which the Department of Transportation will pick up 50% of the cost.

Administrator Schmidt then gave a demonstration on the new Accu Vote Tabulator voting machine. The new machine will be utilized in the upcoming April 5 Spring Election.

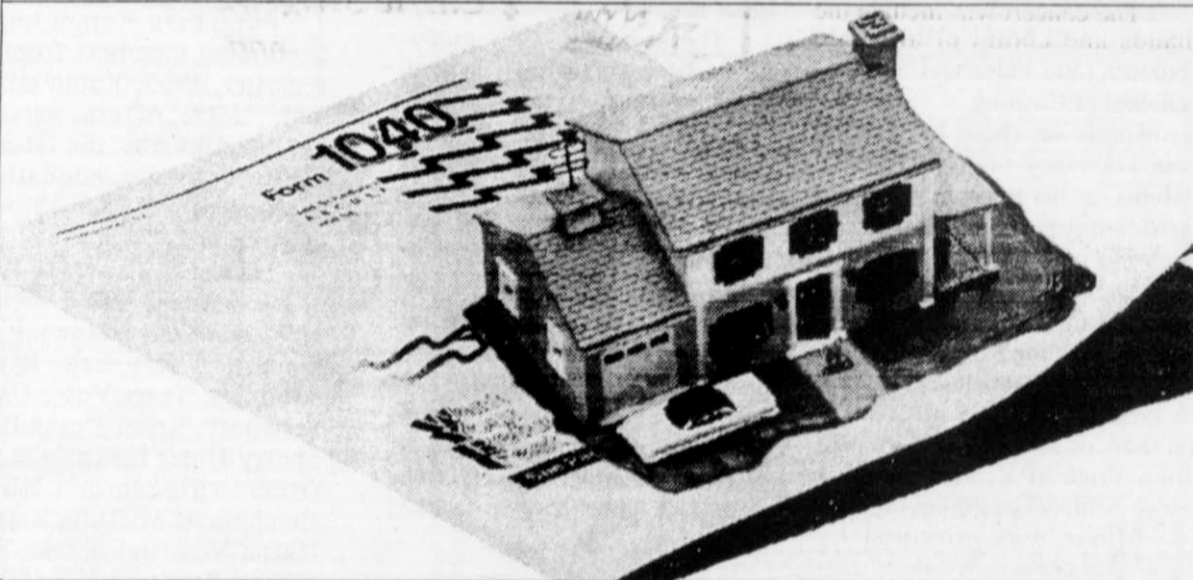

50 Years Ago

February 25, 1944

The annual cutting and harvesting of the ice supply for the summer months was completed by Otto Backhaus, local iceman and his crew, last Sunday. The ice was taken from the Milwaukee River and stored in Mr. Backhaus' ice house. The ice is of a good quality this year considering the mild weather. It measures from 14 to 16 inches in thickness.

The gauze for surgical dressings has arrived at local Red Cross headquarters and all women should come to the high school on Monday, Tuesday, Wednesday and Thursday afternoons at 3 p.m. to assist in making dressings and also Tuesday evenings at 7 p.m. There are 750 utility bags to be made for sending to soldiers overseas and knitting to be done in the home. If women cannot come to help with the surgical dressings, they can knit or sew utility bags in their homes.

Thirteen young men were sworn into the air corps enlisted reserve and 15 others met mental qualifications for aviation cadet training on February 14, when the Milwaukee aviation cadet training board held examinations at the Elks' clubhouse in Fond du Lac as a part of a statewide tour. Among the 13 sworn in to the enlisted reserve was Joseph F. Cechvala of Kewaskum.

Miss Ottilia Schladweiler, daughter of Mr. and Mrs. John Schladweiler of Route 1, Kewaskum, and Norbert Mueller, son of Mr. and Mrs. Alvin Mueller of Route 2, West Bend, were married during a 9 o'clock nuptial service read in St. Michael's Church, St. Michaels, on February 16.

A daughter was born to Mr. and Mrs. Walter Ohmann of West Bend, at St. Joseph's Hospital, West Bend, on February 19. Mrs. Ohmann is the former Miss Ethel Eggert, daughter of Mr. and Mrs. George Eggert of this village. The Ohmanns have another daughter, Jean.

Mr. and Mrs. Milton Coulter of Mayville, are the parents of a son born February 28 at St. Agnes Hospital, Fond du Lac. Mrs. Coulter is the former Miss Elva Schaefer, daughter of Mr. and Mrs. Louis Schaefer of this village. The Coulters also have a daughter, Judy.

75 Years Ago

March 8, 1919

A very sad call came to this village this week from far away Kansas City, Missouri, announcing the taking away of two young men, sons of prominent citizens of Wayne. The boys had left home but two short weeks ago to enter an automobile school at Kansas City, to prepare themselves to meet life's battles in the world of men and numerous hardships that each and every one must meet before achieving the success which we all covet so

greatly. We can still plainly see the light of ambition which illuminated their youthful faces as they left for new fields of opportunity, with but one desire uppermost in their hearts and minds, to conquer and make a credible showing to loved ones back home. We feel that the boys would have made good had it not been willed otherwise by an unforeseen power which gives and takes at will. Wilmer J. Kippenhan, eldest son of Mr. and Mrs. William Kippenhan, was born in Wayne, Washington County, Wisconsin, on October 7, 1901, having attained the age of 18 years. His death occurred March 3, 1919, at University Hospital, Kansas City, after an eight days' illness with pneumonia. Clarence B.H. Petri, only son of Mrs. Minnie Petri, was born in the Town of Wayne, Washington County, Wisconsin, on May 2, 1901, and attained the age of 18 years. His death occurred March 4, 1919 at Sweeney Hospital, Kansas City, after an illness of but six days with measles and pneumonia.

Oil is still flowing from the well on the Jacob Scharf farm, located near Cambria. Mr. Scharf, upon consulting a chemist in Madison, was informed that the oil is of a high test. The Horicon Reporter has the following to say about the well: "Jacob Scharf went to Madison on Monday to consult a chemist in regard to his oil well at Cambria. The chemists at the Wisconsin University pronounced it a phenomena of rare consequence. Usually oil is found in a crude state, but the oil from Mr. Scharf's well is of a much higher test. From 10 to 15 percent of the pumpings of the well are oil, which flashes and burns like gasoline. There is considerable excitement in Cambria over the discovery. Local tradition points out that there are traces of oil in the vicinity, with a creek nearby showing an oily scum on the surface. It is told that Golden Rule Jones of Toledo, once visited the village in the early days, having a sister at that time that was a resident. He was a practical oil man himself and noticed traces of oil. On his return he sent a man to drill for oil. A derrick was constructed but a well was never drilled and the project was abandoned finally and nothing more was ever heard of it. Chemists say that if the well continues to produce at the present rate, that there will be a fortune in it for the owner.

NEW HOLSTEIN - After battling each other and knocking each other out of the playoffs, there is just one Eastern Wisconsin Conference squad alive in the WIAA boys basketball tournament.

Plymouth survived Regional competition, and will aim this weekend to earn a spot in the WIAA State Tournament next weekend.

The Panthers, champions of the EW, beat fellow EW member Two Rivers in their opening contest, 73-67. Plymouth then ousted Valders, 67-62, before crunching Little Chute, 76-49, in the New Holstein Regional

final.

The only other action involving the EW took place in Division 3, where Chilton won its opening game against Random Lake, 58-54 in overtime. The Tigers could advance no further, however, falling to Elkhart Lake, 62-58, in their next contest.

Hartford and West Bend East are both still alive in Division 1 action. Hartford beat Heartland Arrowhead 90-80, and then downed Sussex Hamilton 63-54, to win the


Sussex Regional.

The Orioles will face East in the first round of the Sectionals, after the Suns beat Menomonee Falls (68-45), and West Bend West (63-44) to win their own Regional.

The lone other area team still alive in the tournament series is Oostburg, which beat Elkhart Lake in the Cedar Grove Regional final, 67-59. The Flying Dutchmen also eliminated Cedar Grove a game earlier, 47-43.

Village Board Meeting Minutes

Special Informational Meeting
January 24, 1994
7:00 p.m.

President Robert Wagner presided over an informational meeting of the Village Board. All members were present except Trustee Charles Waala, who arrived at 7:50 p.m. A quorum was present.

The meeting was scheduled to hear information regarding the Kewaskum School District's upcoming referendum on the proposed building addition and remodeling. Present were School Superintendent David Heather, High School Principal Charles Heidner, School Board President Neal Weare and building committee members Jeffrey Rohrer and Gail Van Ess. There were better than a dozen interested citizens present to hear the proposal.

President Robert Wagner thanked the School Representatives for sharing the information with the Board as well as answering questions from the Board and audience.

The informational meeting closed at 8:10 p.m.

Mid-Monthly Meeting
January 24, 1994
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First St.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Harry Roecker, seconded by Trustee Charles Waala and unanimously carried by voice vote, the minutes of the January 5 & 10, 1994 meetings were approved as printed.

Discussion on the possibility of changing the July 4th Fireworks from July 3rd to the Friday of the Kewaskum Firemen/Legion Picnic (July 8, 1994). The results of the informal poll was reviewed.

A total of 145 people voted, with 88 voting no to any change and 57 voting yes to the change. That would equal 40% for change and 60% against change. The amount of work required by the Fire Department members was again discussed and options were discussed as to how the Village or the community could assist them. On a motion by Trustee Gary Gavin, seconded by Trustee David Goeden and carried by the majority by voice vote, the Board moved to keep the Fireworks display on July 3rd. Trustee Robert Beisbier voted in opposition.

Fire Chief Mark Groeschel, December 1993 monthly report: Fire calls 4, Year to date 33; Jaws of life (used) 1, Year to date 33, (not used) -, Year to date 3; Rescue calls 10, Year to date 167; Miles 186; Training 299, Year to date 2,857; Extra training 128.7, Year to date 1,610.

Chief of Police Richard L. Knoebel, December monthly report: Criminal arrest 18, Criminal investigations 32; Traffic warnings 133, Traffic citations 30; Adult arrests 12, Juvenile arrests 8; Property stolen \$4,897, Property recovered \$2,089; Parking violations 109, Parking citations 80.

Director of Public Works Jerry Gilles reported that there was one major water main break during the cold weather snap. It was also reported that the new ice rink is being used a lot at River Hill Park

along with miscellaneous information.

On a motion by Trustee David Goeden, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board approved the application for an Operator's License upon proper payment of fees and documentation and authorized the office to issue said license as follows:

Arndt, Lisa J. - Kewaskum, WI
Note: The Police Department had no objections to any of the applications.

Administrator Daniel S. Schmidt reviewed the following:

1) Tax bill collection update being 2.5% ahead of last year.

2) Reviewed the 1993 building permit report. The Village having issued 20 more permits, equalling an increase of 17.7%

3) League bulletins and pending legislation.

4) Distribution and comment regarding the proposed excavation ordinance.

Board Representative for the Plan Commission, Trustee Thomas McElhatton informed the Board of a Commission meeting scheduled for January 25, 1994 at 7:00 p.m.

Discussion was held on the payment for portable toilets needed for Kettle Kountry Kolors, because of a sewer problem. On a motion by Trustee Gary Gavin, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board approved the payment of \$195,000 for said facilities.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee David Goeden informed the Board that John Rose spoke to the Committee regarding the CATV franchise renewals and transferring of such franchises. The main point being inspecting of existing facilities for safety.

Discussion was held regarding the grant approval for the survey work for the Land Use Plan. It was noted that the grant has been approved, but with an estimated \$7,400 shortfall. The County Committee has discussed the matter and it was suggested that the unfunded balance be shared 50/50. On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board approved the additional payment for the survey work splitting the difference with the County.

Discussion regarding a sanitary sewer problem within Main Street and Fond du Lac Avenue was discussed. To proceed it has been advised that the Village televise the troubled areas. Two proposals were received for the approximate 4,000 feet of sewer. One proposal was at 64c per foot and the other was 75c per foot, both included cleaning and televising of lines. On a motion by Trustee Robert Beisbier, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board authorized said work to the low proposal of GPS at 64c per foot. The work should be completed as soon as possible, at a projected cost of \$2,560.

It was also noted that the preliminary resolution for work to be accomplished on Wildlife Drive will be coming to the Board in February.

Discussion was held on the tentative three year Collective Bargaining Agreement with the Village of Kewaskum Municipal Employees Union, District Council #40, Local 3024, AFSCME, AFL-CIO and the Village of Kewaskum. This agreement calls for an increase in pay as negotiated in 1994 equal to a split of 20c effective 1/1/94 and a 20c effective 7/1/94 generally at the top end or three level. The related percentages to be used on the

hire, one and two year levels, with the 20c cap. This equals an approximate average adjustment of 3.89%, plus some language clarifications/changes. On a motion by Trustee Thomas McElhatton, seconded by Trustee David Goeden and unanimously carried by voice vote, the Board authorized the signing of said Agreement.

Mr. Al Abramson, with the University of Wisconsin-Madison, Telecommunications Outreach Department, was present to review several points regarding cable television. Ms. Linda Bothe, with Star Cablevision Group was also present for the discussion. The points discussed were as follows:

1) The resolution to authorize the transfer of the cable television franchise.

2) The resolution and the pros and cons regarding the Village regulating basic service tier rates and related equipment, etc.

3) The franchise renewal process and what is to be expected and asked for.

4) General CATV discussion looking into the new FCC regulations and the future of CATV.

No action was taken but Mr. Abramson indicated he would provide some recommendations so the Board could possibly take action on February 7, 1994.

On a motion by Trustee Gary Gavin, seconded by Trustee David Goeden and unanimously carried by voice vote, the Board approved the appointments to the Library Board as made by President Robert H. Wagner. There are two appointments to fill the unexpired terms of the resigning Members. The appointees are Frank Beesten and Lynn Zanders.

Discussion was held on options regarding cleaning of the Municipal Building. Cost proposals were received from two cleaning services for said service, both at cost savings in comparison to hiring a custodian. On a motion by Trustee Harry Roecker, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board authorized contracting Kettle Moraine Professional Cleaners, West Bend, WI at a price of \$67.50 per cleaning. The service calls for two cleanings per week with the annual estimated cost equalling \$7,020 compared to an in house custodian costing \$8,412.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Harry Roecker and carried by the majority roll call vote, to adjourn. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

Kewaskum FFA to Host Annual Rabies Clinic



Dr. Charles Ogi, shown in left photo, and Dr. Greg Ogi, shown in right photo, will once again be on hand to administer shots to local pets. The Kewaskum Veterinary Clinic has been very instrumental in working with the Kewaskum FFA in sponsoring the annual Rabies Clinic.

It's that time of year again, when your loving pets need to be vaccinated against rabies.

The Kewaskum FFA is concerned for pets and pet owners. They are hosting their annual Rabies Clinic in the agriculture room at the high school on March 22. Vaccinations will begin at 6 p.m. and continue until 8 p.m.

Shots will be administered at a reduced price of \$10 per animal. Proceeds are going to a scholarship fund for FFA students.

Administering the vaccinations will be Dr. Charles and Greg Ogi. They enjoy keeping man's best friend happy and healthy.

Rabies is a virus which is

passed through the saliva of animals. The incubation period can vary from 15 to 20 days of the first sign.

The first sign is a loss of appetite and behavior change. The second phase is known as the paralytic form, where paralysis and salivary excretion begin. In the third stage the ani-

mal becomes very irrational and viciously aggressive. Dogs rarely live more than ten days after the first sign.

Knowing these signs, it's a good idea to have all pets vaccinated against Rabies. If you are unsure about your animal's health, contact your local veterinary clinic.

Kettle Moraine Pheasant Habitat Restoration Project

Kettle Moraine Wings Over Wisconsin is working hard to increase the wild pheasant population and habitat in the habitat restoration project area north of Kewaskum.

This 9,000 acre project area has been set aside as a wild Iowa pheasant release site. The goal is to improve the habitat in the area in order to increase existing wildlife populations.

The Kettle Moraine Chapter would like to provide and enhance as much wildlife habitat as possible and will be asking local landowners to help them out. The Chapter is looking for landowners that could plant food plots near winter cover, establish grasses for secure nest cover on fields difficult to farm and delay mowing of roadsides and odd areas. The Kettle Moraine Chapter will provide free seed, technical and financial assistance for these food plots and nest cover.

Through this project, the Chapter is hoping to improve the countryside for all wildlife species while still sustaining profitable agriculture.

Plymouth Wins Outright Title

Zautner, Jacak, Ankerson Among EW Leaders

KEWASKUM - Having finished dead-last in the Eastern Wisconsin Conference race, the Kewaskum boys basketball team will have to look for individual highlights in assessing this season.

For three members of this year's Indian squad, there may be some satisfaction gained.

James Zautner, for one, has plenty to be proud of, as he finished among the EW leaders in numerous categories. The 5-9 senior guard was fourth in the conference in scoring (168 points, 14.0 ppg), and was second behind Plymouth's John Knowles (37) in steals with 31.

Zautner was one Indian who was consistent at the free throw line as well. Zautner led the league with 68 free throws made, 95 attempted, and his 71.6 percent clip at the line ranked him eighth in the EW. His three-point percentage of

44.4 percent placed him fifth in the loop.

Travis Jacak and Erik Ankerson, meanwhile, battled each other for the top rebounding spot all season long. While they were snaring boards from each other, though, Sheboygan Falls' Rick Moser sneaked in and won the rebounding title with 112 total boards. Jacak, who won the rebounding title as a sophomore last year, was second (108), and Ankerson was third (96), and had the most offensive boards (49).

Jacak also finished 13th in the EW in scoring (9.6 ppg), while Ankerson was 21st (8.5). Sheboygan Falls' Matt Wieseckel (17.3) and Jason Meerdink (16.5) swept the top spots in scoring, while Chilton's Paul Eisner (14.1) edged out Zautner for third.

Despite Wieseckel and Meerdink's presence, Sheboygan Falls was unable to beat Plymouth in the season-ending

championship game. Playing before their home crowd, Plymouth destroyed the Falcons, 71-52, to win the EW title outright with their 11-1 mark. Falls was second (10-2). No other EW squad finished the season with an above .500 record.

It was plain to see why Kewaskum finished 2-10 and in last place in the EW. The Indians made just 37.5 percent of their field goal tries, and 23.8 percent of their three-point attempts, both representing the worst in the league. KHS scored just 52.4 points per game, and gave up 65.4 per game. Only Kiel (51.9) and Chilton (65.5) were poorer in those categories.

Finish Season a Disappointing 5-16 Mayville Dominates Indians in Regional

KEWASKUM - Kewaskum boys basketball coach Jim Westphal has said all season that his Indian team has a tough time against physical teams. Never was that assertion more evident than in KHS WIAA Division 2 Regional against Mayville here, last Thursday night.

Mayville simply outmuscled the Indians in the first half, using their bulk to pull down 13 offensive rebounds. Those second-chance opportunities helped the Cardinals stake claim to a 53-26 halftime lead, from which they pulled away to an easy 82-54 win.

The win improved Mayville's record to 17-5, while Kewaskum ended the season with a 5-16 mark. And there was no doubt in Westphal's mind what the difference was between the two squads.

"They are very strong physically, and we just couldn't handle them," he said. "Those are just not the kinds of teams that we play well against."

That was obvious from the start, as the Cardinals jumped out to a 25-14 lead after one quarter of play. Mayville's Collin Gassner (nine) and Kevin Frank (eight) provided most of the spark, combining for 17 of the guest's points.

The Indians did keep things close for awhile. Playing a scrappy zone defense, Kewaskum was down by just four, at

15-11, midway through the opening quarter. But then Mayville started to heat up from the outside, and outscored KHS 10-3 the rest of the stanza.

The onslaught continued in the second period, as Mayville's full-court pressure gave the Indians trouble.

"That was the first time all season that we've been bothered by a press," Westphal said. "We did get some easy baskets off of it, but then we just got sloppy with the ball."

The pressure, combined with Mayville's physical presence up front, spelled the end for the Indians.

"Offensive rebounds just killed us," Westphal continued. "If we could have rebounded, we could have made a game out of it."

Instead Mayville rolled to the 27-point lead at the intermission, and coasted to the win. But Westphal was happy to see that his team didn't concede after the embarrassing first half.

"Give our guys some credit," he said. "We stuck in there pretty well in the second half. We didn't just give up."

Actually, KHS was outscored by just a single point in the second half (29-28), but the damage had already been done.

"Gassner finished with 16 points in three quarters of action. He is as good a ballplayer as there is around here," Westphal said of the 6-0 guard. "He has extremely quick hands."

Granke ended up with 14

points for the Cardinals, who, Westphal says, "play awfully good defense. I just can't figure out how they have as many losses (five) as they do."

For the Indians, James Zautner and Erik Ankerson, two seniors playing in their final prep games, led the way with 14 and 13 points.

"James had a pretty fine game... did some really good things," Westphal said. Ankerson, meanwhile, "gave up so much physically, yet he hung in there and did a good job," grabbing nine rebounds on the night.

Once again, shooting was a sore spot for KHS, which hit just 35 percent of its field goal tries, and under 50 percent from the line. The inability to put the

ball in the hoop was a major role in the disappointing 1993-94 campaign.

"I expected that we'd shoot much better than that all season," Westphal said. "We just never got anyone to step up and make the shots consistently."

"It was a disappointing season in that respect," he continued. "But again, we played with a lot of younger ballplayers (only three seniors)."

Muckerheide Heads KHS Matmen Award-Winners

KEWASKUM - It is known that Kewaskum wrestling coach John Nell places a strong emphasis on hard work towards his grapplers. Obviously, senior Chad Muckerheide heeded Nell's words.

For his hard work and dedication to the Indian program, Muckerheide was named the recipient of the Roman Muckerheide Memorial Award by the KHS coaching staff.

In addition to that prestigious honor, Muckerheide was also named as the 1993-94 team's Most Valuable Wrestler, as voted by his teammates. He also joined fellow senior Brad Jackson as the Indian co-captains.

Muckerheide recently capped off a fine career at KHS by placing fourth at 152 pounds in the WIAA State Individual Tournament in Madison.

Two more wrestlers that Nell will be more than happy to have returning are Rich Farchione (29-4) and Jake Thull (19-12), who shared the Most Improved Wrestler award.

After completing another stellar season that saw the first-ever double-place at state (Dziedzic and Muckerheide), and appearance in the WIAA Team Tournament, Nell says he is satisfied by the results.

"We really did well.... alot better than anyone, including myself, thought," he said. "The program is really coming along nicely."

Nell is stressing a dedicated off-season regimen for his wrestlers, including camps and freestyle tournaments. The added mattime should help the Indians accomplish Nell's early goals for next season, which include an Eastern Wisconsin Conference title and berth in the WIAA State Team Tournament.

"If they work hard in the off-season, the goals are realistic," Nell says. "We definitely have some kids that are capable of doing real well next year."

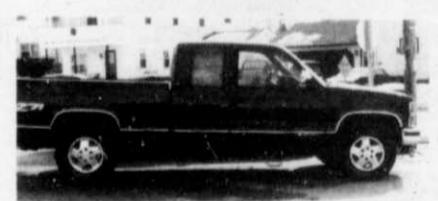
