Construction of Balancing Plant in Full-Swing at Farmers Union Co-Op

The activity surrounding the Farmers Union Milk Marketing Co-Op means phase II of their construction plans is in full swing.

The balancing plant will be producing cheese, if all goes well, by the first week of August. Three 8000 pound vessels were delivered two weeks ago and moved by crane into the building. The Damroe Double O Cheese Vats are capable of holding up to 40,000 pounds of milk, and they act as big cheese

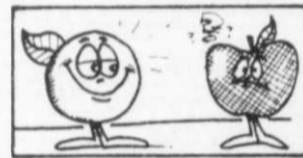

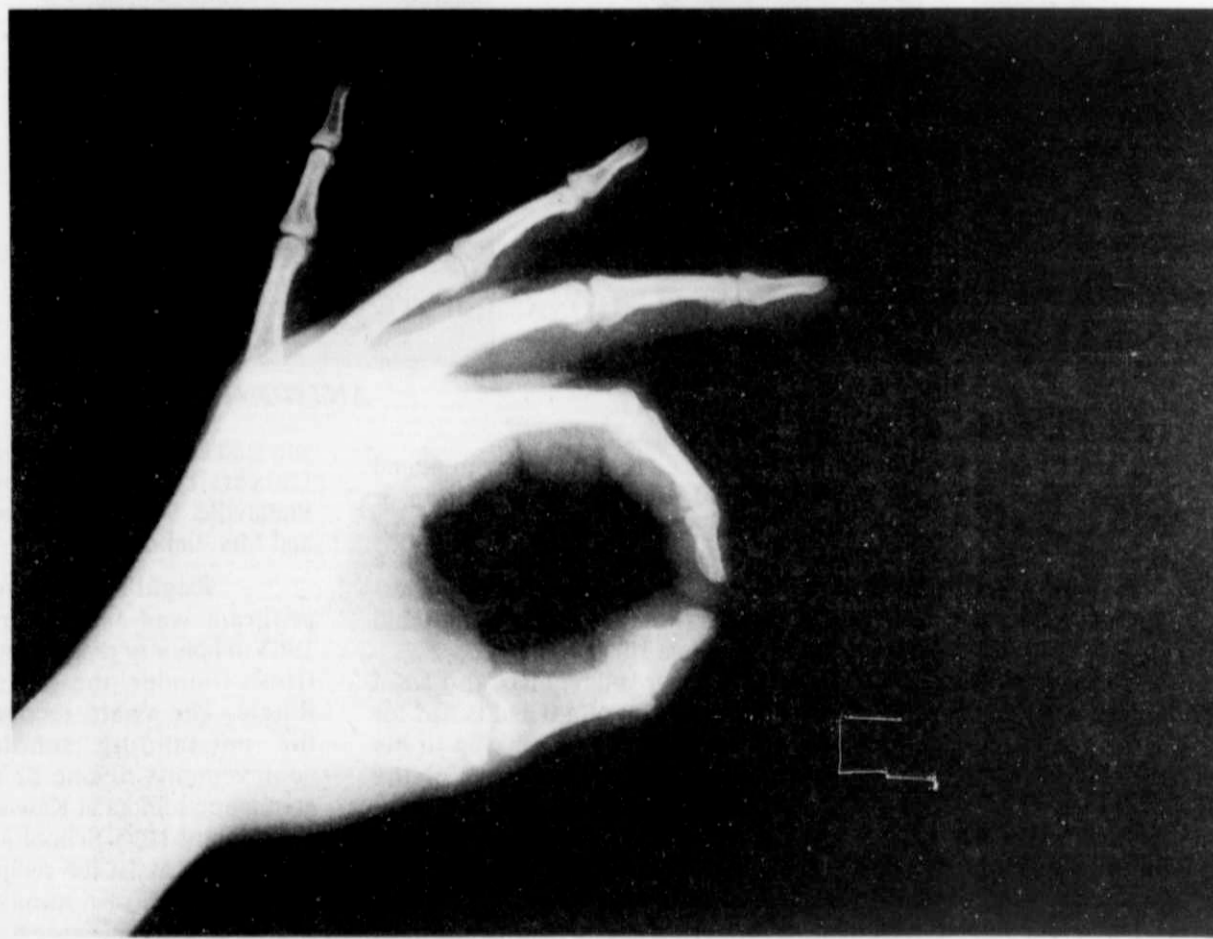

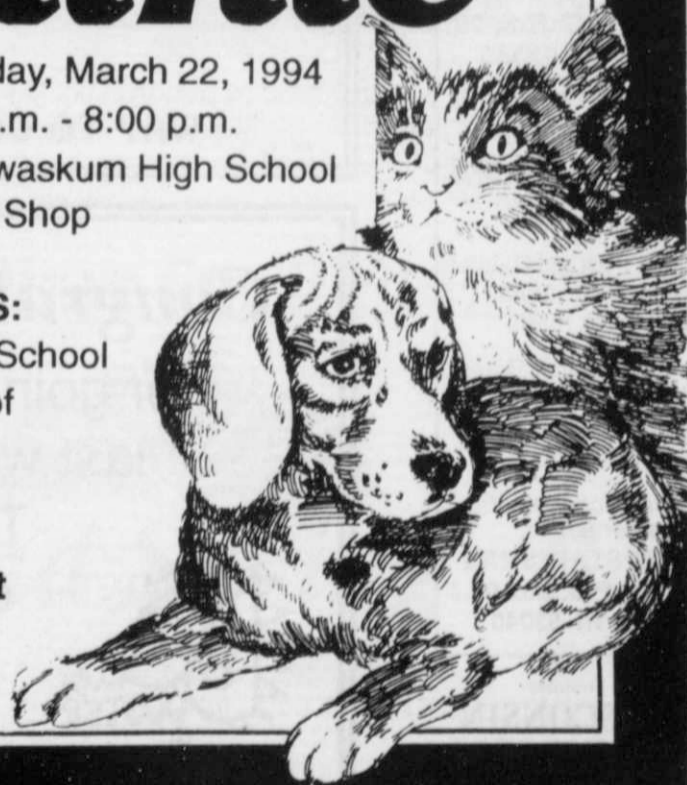

Surplus Food to Be Distributed Saturday

Washington County has received surplus commodity food items that will be distributed to eligible households on Saturday, March 19, 1994, from 8:30 to 9:30 a.m. (as long as the supply lasts).

Food being distributed includes butter, cornmeal, raisins, peanut butter, tuna fish, apple juice and rice.

Locations for the free distribution are as follows:

West Bend - St. Francis Cabrini Church, 615 Hawthorn Dr., (lower level parking lot); Hartford - St. Kilian School, 245 High Street (Johnson Street entrance); Germantown - Senior Activity Center, W162 N11960 Park Avenue; Slinger - Village Hall, 220 Slinger Road; Allenton - Addison Town Hall, Village of Allenton; Kewaskum - Kewaskum High School, North Entrance; Jackson - Jackson Fire Department, S. Jackson Drive.

Eligibility is based on the current MONTHLY GROSS INCOME (before taxes) of all household members with the following limits. Household size 1, income limit \$871; 2 - \$1,179; 3 - \$1,486; 4 - \$1,794; 5 - \$2,101; 6 - \$2,409; 7 - \$2,716; 8 - \$3,024; 9 - \$3,331; 10 - \$3,639.

Home delivery is available for the ELDERLY and HANDICAPPED if there is no one in the household who can get to a distribution site. To make arrangements, call the distribution site in your area. West Bend residents, please call 335-4610.

Although no income verification is required, a self declaration form must be signed by the recipient and is subject to state audit. You may also be asked to provide proof of residency.

1) To get all students to use trash containers located throughout the building, and if they see paper, etc., on the floor, to take a second to pick it up and dispose of it properly.

2) To add enough staff to properly clean the schools and maintain them.

3) We have to commit to an ongoing maintenance budget. Since 1986 the Board of Education has committed and built into the school budget a regular maintenance budget since 1957. Please keep in mind when looking at the dollars spent, that this was spent district-wide on all of our buildings.

Fishing Clinics Offered To Area Youngsters

Spring is on its way and with it comes the yearning to tease fish in the hopes of making a catch. Many area young people would enjoy the experience, but need a place and opportunity to be instructed in proper, safe techniques.

The chance to learn, topped off with trying to catch a fish, will be available to children, ages six through twelve. Back-to-back clinics (advanced in the morning; beginners in the afternoon) will be held at Sandy Knoll Park on Wallace Lake Drive, West Bend, on Saturday, April 9.

The morning session is an advanced seminar for children up to the age of 12 who have participated in a previous LLFC clinic at Sandy Knoll. A review of previous sessions will be followed by advanced instruction including Catch and Release; Fishing and Boating Etiquette; Being a Responsible Citizen; and Equipment and Rigging. On-site check-in for the advanced clinic begins at 8:30 a.m. The session will conclude at 12 noon.

The afternoon session, for beginners, welcomes children age six through 12 who desire to learn the basics of good fishing techniques and water/boating safety.

Instructional sessions will include: Environment: Lakes and Watersheds -- Keeping Them Clean; Fish Habitats and Identification; Equipment and Rigging; Boat Safety, Rules and Regulations; and Casting Practice. On site registration for this session will begin at 12:30 p.m. The session will conclude at 4 p.m. Participants completing the beginners session will receive "Youth Angler" patches. There is no fee for either clinic but advance reservations are required. Parents are invited to observe. A child who is dropped off must be picked up immediately following the completion of the chosen clinic.

Members of the Long Lake Fishing Club, many of them DNR-trained Master Anglers, will conduct the clinic. Following the completion of the learning sessions, members of the club will assist the youngsters in fishing for rainbow trout. Some equipment is available for use. If a child has access to a rod and reel, it is suggested he/she bring it along. Bait will be provided.

Crafter With Local Ties to Be Featured At 'Unique Craft Show' On Sunday

Sue Rupp doesn't mind if people talk about her "dust bunnies." Nor does she get concerned about a "hare in the soup." This is not a reflection on Sue's housekeeping or culinary skills. Rather, it is indicative of Sue's artistic skills.

Sue has turned her love of animals and a natural talent for art into a business featuring limited edition prints of cute little bunnies and other animals.

The bunnies and many of her additional art works will be featured along with other artists at this Spring's "Unique Craft Show," being held this Sunday, March 20, at Amerahn on Hwy. 45, just north of Kewaskum.

"I've been drawing since I was little," Sue said. First and foremost were horses. Since Sue couldn't have horses, she drew them. At the age of 12, Sue got her first horse, but that didn't stop her from drawing them and other animals. And she raised rabbits.

In fact, while some say they count sheep at night, Sue said she saw rabbits. She has had no formal art training but watched her sister and learned from her. Sue's sister is Therese Randall, winner of the 1986 Great Lakes Salmon and Trout Stamp and a three-time runner-up in the Turkey Stamp competition.

Both Sue and Therese graduated from Campbellsport High School. (Their maiden name was Pankratz). Sue had a great deal of help with basic art from a teacher in the third grade. But other than that, she learned there was little encouragement for her to look at art as a lifelong career.

Sue's first print was "Hare Coloring" depicting a rabbit in a strainer being dipped in blue Easter egg dye. "Hare Cut" and "Receding Hareline" as well as "Hare Dressing" soon followed. They quickly took off and Sue's first limited editions were on the market. With 650 prints or each, Sue's first Harelines quickly sold out and are no longer available. Since that time Sue has increased the printings to 950 to

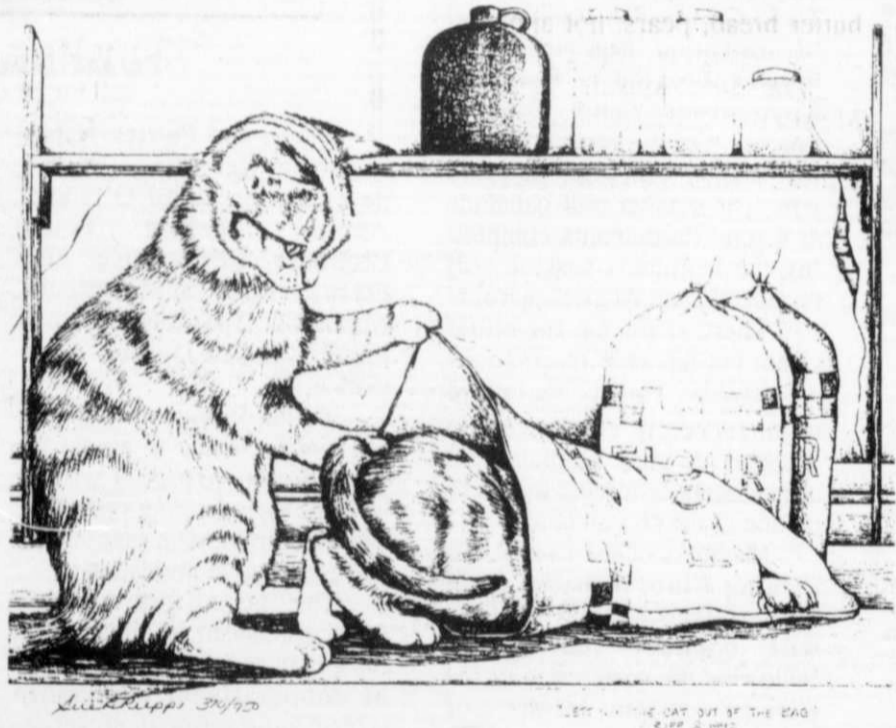
satisfy demand. Of the 58 bunnies in the Hareline series, only 13 prints are still available.

In 1984, Sue moved to Colorado where she continues to live with her two children, Sarah and Dan. The Hareline bunnies began in 1986.

Two years after the bunnies took form, Sue opened her studio in Berthoud, Colorado. Her business has grown and now she has two employees in the studio/gift shop. Back in Eden, her mother-in-law, Judy began handling Sue's work for local sales.

Judy's first show experience was joining Sue at a show in Colorado. That's when Sue said, "Gee Judy, why not do this back in Wisconsin?" Judy replied, "Why not?" And she began spreading Sue's work in the area moving on to do shows in Illinois and Indiana. At one time Judy did as many as 30 shows a year. But now she has cut back, doing 15 a year.

One of those shows is the Unique Craft Show being held from 9 a.m. to 4 p.m. at Amerahn on Sunday.

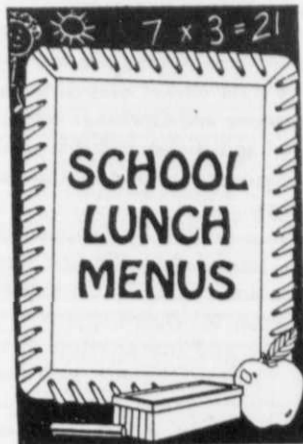
If you have further questions and/or comments about the consumer service cards... please feel free to contact me at 626-2575 or stop in to see me, okay?

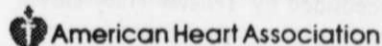

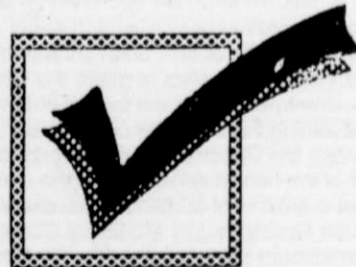

Village Board Meeting Minutes

Mid-Monthly Meeting
February 21, 1994
8:00 p.m.

President Robert Wagner presided. Trustee Beisbier asked to be excused and was absent; all other Board Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Waala and unanimously carried by voice vote, the minutes of the February 7, 1994 meeting were approved as printed.

Mr. Dick Kapinos and Mr. Steffic were present to introduce themselves to the Board and to inform them that they have intentions of opening a Subway Restaurant within the Kewaskum Mall this Spring.

Chief of Police Richard L. Knoebel, January 1994 monthly report: Criminal arrest 14, Criminal investigations 14; Traffic warnings 84, Traffic citations 29; Adult arrest 13, Juvenile arrests 9; Property stolen \$.00, Property recovered \$.00; Parking warnings 12, Parking tags 63.

Director of Public Works, Jerry Gilles bi-monthly: Director Gilles informed the Board that the Village had experienced four water main breaks and frozen storm sewer lines. It was further noted that Farmers Union is hoping to be in production in mid-summer or fall. Some problems exist on Knights and Columbus regarding the storm sewer that the Village will need to investigate.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Waala and carried by the majority voice vote, the Board authorized the advertising for summer part-time help, 2 for the DPW and 1 for the WPC Departments. Trustee Gary Gavin voting "Nay."

Fire Chief Mark Groeschel, January 1994 monthly report: Fire calls 1, Year to date 1; Jaws of life (used) 1, Year to date 1, (not used) - Year to date -; Rescue calls 20, Year to date 20; Training 176, Year to date 176; Extra training 45.5, Year to date 45.5. Annual report for 1993: Fire calls 33; Jaws of life (used) 5; (not used) 31; Rescue calls 202; Rescue transports 201; Rescue miles 4,179; Training 2,857; Extra training 1,610.

It was noted the Fire Department is in the process of reviewing the bi-laws and when complete will bring them to the Board for approval. The last time it was reviewed was in 1985.

On a motion by Trustee Gary Gavin, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board approved the applications for Operator's Licenses upon proper payment of fees and documentation and authorized the office to issue said licenses as follows:

Taylor, Marion L. - Kewaskum, WI.
Jacak, Melissa L. - Fredonia, WI.
Note: The Police Department had no objections to any of the applications.

The 1994 tax bill and collection process was reviewed with the Board and it was noted a total of 24 tax bills went delinquent and in general payments are ahead of last year.

Administrator Daniel S. Schmidt reviewed the following:

1) Reviewed the unaudited budget control sheet for year ending

December 31, 1994.

2) League and other bulletins regarding pending legislation.

3) Update on the arrival of the new election equipment and training sessions planned.

4) Information on Dyslexia Awareness Week being February 27 through March 5, 1994.

Chairman of the Park and Recreation Committee, Gary Gavin reviewed the outcome of the Committee meeting held February 21, 1994.

On a motion by Trustee David Goeden, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board authorized the advertising of help wanted regarding the NE ball diamond and concession. The ad is to include the notation that a private party will contribute \$600 and the Village will match that in reference paying for said services.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board approved the contracting for two portable toilets for RHP & KKCP for 1994 from the low provider, Port A John at \$68.00 per month.

On a motion by Trustee David Goeden, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board authorized the advertising for summer part-time park and recreation employees.

Discussion was held with the Land O Lakes Kewaskum Athletic Club regarding the improvement needed for them to use the SW softball diamond in a safe manner. By consensus the committee agreed to work with them and to get quotes as to fencing cost and to move money into the budget to cover an estimated \$3,000 of projected cost.

The proposed dam ramp installation was reviewed and it was noted to proceed with final arrangements and to bring final dollar figures back to the board for approval.

On a motion by Trustee David Goeden, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board authorized the purchase of 2 tables with umbrellas, 2 eight foot picnic tables, 4 ball player benches and 1 slide for the parks as budgeted.

Chief of Police Richard L. Knoebel informed the Board that the local sports clubs will be stocking the Milwaukee River with some pan type fish hopefully in Spring of 1994.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee David Goeden informed the Board that discussion was held at the last meeting on dam type repairs.

A review of the letter received from the Town of Auburn's Attorney was discussed and a review of the four points took place. It was the consensus of the Board to have the Administrator work with the townships to resolve the points and to let Auburn know we will continue to serve them and that the Village expects to be paid for such service in a timely manner.

On a motion by Trustee Gary Gavin, seconded by Trustee David Goeden and unanimously carried by voice vote, the Board authorized the Administrator to sign the Agreement between Washington County, the Village of Kewaskum, the Washington County Surveyor and SEWRPC attendant to large scale topographic mapping, control survey and land survey work in the Kewaskum area.

The list for the amounts to be special assessed and for what was reviewed by the Board and it was indicated the matter can be forward-

ed to the Village Engineer.

Ordinance No. 94-1 an ordinance to amend Chapter 8 Public Works 8.04 Street and Sidewalk Excavations and Openings was distributed and it was noted it would be considered at one of the next meetings.

On a motion by Trustee Gary Gavin, seconded by Trustee David Goeden and carried by the majority voice vote, the Board approved the purchase and installation of the Supervisory Control and Data Acquisition from Ruekert and Mielke at a cost of \$29,775. It was noted this was the low proposal and is what was budgeted for in the 1994 Water and Water Pollution Control Department budgets. Trustee Charles Waala voting "Nay."

On a motion by Trustee David Goeden, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board confirmed President Robert Wagner's appointments of John Stephani to the Plan Commission and Mark Slangenhoup to the Board of Appeals.

The Administrator was directed to notify the local organizations to ask them to meet and discuss the establishment of a Village of Kewaskum Centennial Celebration Committee for 1995.

On a motion by Trustee Gary Gavin, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board approved salary/wage adjustments as follows, for 1994 effective 1/1/94. That the Administrator and Police Chief receive a 3.5% adjustment. That the Director of Public Works and The Library Director receive a 3.25% adjustment and consideration of the progression to the mid-point of their grade level in a timely manner. That the Deputy Clerk/Treasurer receive a 4% adjustment. This reflects an average increase of 3.5% as reflected on Exhibit A-1-94. In conjunction with this non-represented employee adjustment the "Salary and Benefit Program" as existed from 1987 with minor changes caused by the AFSCME personnel being removed from its coverage in 91/92 and reflecting those discussed changes. The inclusion of a wage adjustment for the part-time employees in the amount of 3.5%.

President Robert Wagner read a letter he received indicating that Mr. Peter Albers of the Water Pollution Control Department has decided to retire effective the 20th day of April 1994.

Administrator Daniel S. Schmidt informed the Board that the 1994-1995 Local Roads Improvement Program regarding the request of funds for Wildlife Drive has been approved for an amount of \$29,320.50. On a motion by Trustee Thomas McElhatton, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board authorized the signing of the LRIP Agreement with the Department of Transportation.

President Robert Wagner suggested that the Village support community unity and in so doing promote a Spring clean up day. The Board agreed and directed the Director of Public Works and Administrator to work on the planning of such an event.

On a motion by Trustee Thomas McElhatton, seconded by Trustee Charles Waala and carried by the majority roll call vote, to adjourn. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent."

ORDINANCE NO. 94 -1 AN ORDINANCE TO AMEND CHAPTER 8 PUBLIC WORKS 8.04 STREET AND SIDEWALK EXCAVATIONS AND OPENINGS IN THE VILLAGE OF KEWASKUM, WISCONSIN

The Village Board of the Village of Kewaskum, Wisconsin do ordain as follows:

The Village Board of the Village of Kewaskum, Wisconsin wish to repeal and recreate the old 8.04 and ordain the new 8.04 as follows:

8.04 (A) EXCAVATIONS OF STREETS, ALLEYS, PUBLIC WAYS AND GROUNDS.

1. **Permit Required.** No person, partnership or corporation, or their agents or employees or contractors, shall excavate in or disturb the surface of any public street, public alley public way, public ground, public sidewalk or Village-owned easement within the Village of Kewaskum without first obtaining a permit therefor from the Village.

2. **Application for Permit.** The Application for a permit shall be in writing and signed by the applicant or his agent. The applicant shall submit to the Village Director of Public Works, at the time the permit is applied for, sufficient information relating to the work to be done including the general location and nature of the work and the method the applicant proposes to use in doing the work. The Village Director of Public Works or Village Engineer shall determine if sufficient information is submitted.

3. **Exception.** The provisions of this Section shall not apply to the Village excavation work done under the direction of the Director of Public Works or the Village Engineer.

4. **Validity of Permit.** Permits shall be valid for a period of thirty (30) days from the date of approval. Any person or utility who has been granted a permit to excavate in the public right-of-way or to disturb the same shall perform such work in such a manner and in such time as the Director of Public Works or Village Engineer shall direct and shall restore the surface of the public right-of-way pursuant to the requirements of this Section.

5. **Excavations by Public Utilities.** Any public utility having a franchise to lay pipe, cable, conduit and etc. in or near the public way shall, before excavation or disturbing any portion of the right-of-way, give written notice and present plans thereof to the Director of Public Works or the Village Engineer in such form as the Director of Public Works and Village Engineer may prescribe.

6. **Village Standards.** All street work shall be performed in accordance with the current standard specifications for street openings. Any damaged curb and gutter, sidewalk or grass-covered area shall be restored to the condition prior to damage.

a. All excavated openings on Fond du Lac Avenue and Main Street require the Director of Public Works or his designate to inspect each opening to view the street light cables and conduit for their integrity.

1) Hand digging is required in these locations unless otherwise authorized by the Director of Public Works or the Village Engineer.
2) When boring underneath the pavement the integrity of the cables and conduit are also to be checked.

b. When utilities run parallel to each other it is required that four (4) feet of clearance be maintained from all utilities: electric cables, gas, communication cables and etc. from sewer and water utility pipes, valve boxes, manholes, hydrants and etc. or as otherwise authorized by the Director of Public Works or the Village Engineer.

c. When utilities cross each other a minimum of 12 inches of clearance is required, or as otherwise allowed by the Director of Public Works or Village Engineer.

7. Permit Fee and Deposit.

a. The following fees shall be submitted with applications for permits under this Section:

1) Opening street	\$60.00
2) Opening curb, alleyway or parkway	\$40.00
3) Perform work or labor or deposit excavation or construction materials within a public right-of-way	\$30.00

b. If the work is not accomplished in a manner as prescribed and acceptable by the Director of Public Works or Village Engineer within the 30 day permit period, said work will be ordered and the person opening the street or public way will be billed for all labor, materials and equipment used plus twenty percent (20%) for administration.

8. **Insurance Required.** A permit shall be issued only upon condition that the applicant submit to the Village Administrator a Certificate of Insurance, indicating that the Applicant has in force the following kinds of insurance, with an Insurance Company or Insurance Companies rated "A" or better A. M. Best & Company: Commercial General Liability with limits, minimum, \$500,000.00 Combined Single Limit for Bodily Injury and Property Damage Liability, \$1,000,000.00 General Aggregate Limit, policy to include Completed Operations Liability, Automobile Liability Policy with limits, minimum, of \$250,000.00 per person and \$500,000.00 per accident for Bodily Injury Liability and \$100,000.00 Property Damage Liability, to include Hired Automobiles and Employers Non-ownership Auto Liability, Worker's Compensation with limits, minimum, as required by the State of Wisconsin. Certificate(s) shall indicate that the Insurance Company or companies will provide thirty (30) days written notice in the event of reduction of limits/coverage or cancellation of any policy or policies.

9. **Bond.** Before a permit is granted, a bond shall be filed by the applicant for such permit with the Village Administrator/Clerk in the amount of \$5,000, which bond shall be executed by a licensed surety company as a guarantee that the applicant for such permit will comply with all Village ordinances relating to such permit and will maintain and restore the street, alley, sidewalk, or public grounds as required by the Municipal Code and will maintain the same for a period of one (1) year and that he will pay all fines of forfeitures imposed upon him for any violation of any rules, regulations or ordinances governing street openings or drain laying adopted by the Village Board. Such statement shall also guarantee that, if the Village shall elect to make the street repair, the person opening the street/public way will pay all cost of making such repair and of maintaining the same for one (1) year, plus twenty percent (20%). In the event the Director of Public Works or Village Engineer determines that the nature and extent of the excavation or opening requires a bond in excess of \$5,000 to guarantee restoration of the excavated area as required by Municipal Code, the bond shall be established in an amount so determined by the Director of Public Works or Village Engineer.

10. BUILDING CODE. Section 30.17 of the Building Code shall also apply.

8.04 (B) REGULATIONS GOVERNING EXCAVATIONS AND OPENINGS.

1. **Frozen Ground.** No person, partnership or corporation, or their agents or employees or contractors, shall make or cause to be made

any excavation or openings in the streets, alleys, sidewalks or other public way within the Village between November 15th and April 1st, except where it is determined by the Director of Public Works to be an emergency excavation/opening.

2. Protection of Public.

a. Every excavation and opening shall be enclosed with sufficient barriers, signing, and such other traffic control devices as may be required by the Director of Public Works, and in accordance with Section VI of the Manual of Uniform Traffic Control Devices. Sufficient warning lights shall be kept on from sunset to sunrise. No open flame warning devices shall be used. Except by special permission from the Director of Public Works, no trench shall be excavated more than two hundred fifty (250) feet in advance of pipe or conduit laying nor left unfilled more than five hundred (500) feet from where pipe or conduit has been laid.

b. All necessary precautions shall be taken to guard the public effectively from accidents or damage to persons or property through the period of the work. Each person making such opening shall be held liable for all damages, including cost incurred by the Village in defending any action brought against it for damages, as well as cost of any appeal, that may result from the neglect by such persons, vehicles or property of any kind.

c. Unless otherwise approved by the Director of Public Works or Village Engineer, a minimum of one (1) lane of traffic in each direction shall be provided. Every effort shall be made on the part of the permittee to provide reasonable access to all properties adjacent to his project. In the event traffic is limited to less than one (1) lane in each direction, a flagman or temporary traffic control signal shall be provided so as to safely cycle traffic in each direction past the work area, shall be provided by the contractor.

d. The permittee shall perform the work in such a manner so as not to disrupt the flow of traffic in the area or endanger the safety of workmen or passerby. It shall be the responsibility of the permittee to prevent traffic backup during construction operation. The permittee shall notify the Director of Public Works or Village Administrator twenty-four (24) hours prior to commencement of excavation, unless the excavation is an emergency excavation, as identified in section 8.04 (B) (7).

e. When the operations will result in the loss of any utility service to private properties, the private properties shall be notified in writing or by personal contact at least twenty-four (24) hours prior to the loss of service, unless the operations are part of an emergency excavation as defined in section 8.04 (B) (7).

2. Pavement Removal.

a. Removal of existing pavement shall be in neat, straight lines. The permittee shall make a final saw cut in the existing pavement after backfilling. Excavations shall be kept to the minimum possible and acceptable for the convenience and safe performance of the work and in accordance with all applicable codes and regulations.

b. If the pavement is damaged during excavation beyond the original saw cut lines, it shall be saw cut again along neat, straight lines. The finished saw cut shall leave a regular rectangular section for pavement replacement. Should the street opening occur within adjacent or close to an existing patch or require more than one (1) opening within a short distance, the permittee shall identify and locate the existing patches or additional openings on the permit application form. The Director of Public Works shall, on the basis of an on-site inspection, approximate the boundaries of the pavement replacement area.

c. Pavement replacement areas with the long dimension in the direction of travel shall have the long parallel with the curb line or the direction of travel. Pavement replacement areas in concrete pavements shall be parallel with or at right angles to the direction of travel.

d. The Director of Public Works may order the permittee to remove and replace up to one (1) full lane width of pavement along the patched or excavated area. Special care shall be taken with concrete pavement to produce a vertical face on the existing concrete at the point of the saw cut to insure a full depth of concrete at the joint.

3. Excavation.

a. All excavated material shall be piled in a manner such that pedestrian and motor traffic is not unnecessarily disrupted. Gutters shall be kept clear or other satisfactory provisions made for street drainage, and natural water courses shall not be obstructed.

b. Excavated material to be used for backfilling of the trench must be so handled and placed as to be of as little inconvenience as practical to public travel and adjoining tenants.

4. Backfilling.

a. All backfill material shall be free from cinders, ashes, refuse, vegetable or organic matter, boulders, rock or stones greater than eight (8) inches in their greatest dimension, frozen lumps or other material which in, in the opinion of the Director of Public Works, is unsuitable.

b. In refilling the excavation, if there is not sufficient material excavated suitable for refilling, the deficiency shall be made up with material, approved prior to use by the Director of Public Works, hauled in.

c. Wherever an excavation crosses an existing utility, pipe or other structure, backfill shall be carefully compacted in stages from the bottom of the excavation. Any sanitary sewer, storm sewer, water, telephone, natural gas or other service shall not be interrupted by the permittee. It shall be the permittee's responsibility to have the various utilities locate and mark their facilities prior to excavation.

d. Mechanical compaction shall be used on all materials used for trench backfill. Each layer (12 inch maximum) shall be uniformly compacted to a dry density of at least ninety five percent (95%) of the maximum dry density as determined by the Modified Proctor Test (ASTM-1557). Compaction or consolidation by flooding shall not be permitted.

e. All excavation shall be subject to testing by the Village. Backfilled material not achieving the above compaction requirements shall be removed and recompactd by the permittee. The cost of any retesting shall be paid by the permittee.

f. When the sides of the trench will not stand perpendicular, sheathing and braces shall be used to prevent caving. No timbers, bracing, lagging, sheathing or other lumber shall be left in any trench. At no time shall any street pavements be permitted to overhang the excavation.

g. When so ordered by the Director of Public Works or the Village Engineer, slurry backfill shall be used. The material used shall conform to section 6.43.8 standards specifications for sewer and water construction in Wisconsin.

5. **Notice.** It shall be the duty of the permittee to notify the Director of Public Works and all public and private individuals, firms and corporations affected by the work to be done at least one (1) business day before such work is to commence. The Director of Public Works shall also be notified at least one (1) business day prior to backfilling or repairs and/or restoring the surface on Saturday when noticed on Friday.

6. Pavement Replacement.

a. Backfill material shall be left below the original surface to allow for four (4) inches of three (3) inch crushed stone and four (4) of three-quarter (3/4) inch crushed stone, plus the thickness of the required pavement structure. If paving will not occur as part of the initial street restoration operation, the balance of the opening to the original surface elevation shall be backfilled with compacted three-quarter (3/4) inch crushed stone.

b. Bituminous pavement shall be placed the full depth of the existing pavement or two and one-half (2 1/2) inches, whichever is greater. Bituminous pavement shall be placed in a maximum of a one and one-half (1 1/2) inch base layer and a one (1) inch top layer, with each layer compacted to maximum density and shall consist of Wisconsin Department of Transportation Gradation No. 1 for the binder course and Wisconsin Department of Transportation No. 3 for the surface course. The finished surface shall be smooth and free of surface irregularities and shall match the existent pavement and any castings or street appurtenances. Allowable deviations shall be no more than one-quarter (1/4) inch as measured with a ten (10) foot straight edge.

c. Concrete pavement shall be placed to the full depth of the existing pavement or seven (7) inches, whichever is greater. Concrete used shall not contain calcium chloride. The surface shall be given a light broom finish. The edges shall be tooled to prevent spalling at the saw cut edge. The surface shall be evenly and completely sealed with a white pigmented curing compound. The surface shall be protected from traffic for a minimum of three (3) days. Tie bars shall be installed as directed by the Director of Public Works.

d. In emergency excavations during winter months when it is not possible to replace the removed pavement with a like material, the excavation shall be temporarily resurfaced with a minimum of three (3) inches of cold mix bituminous material. This temporary wearing surface shall be compacted and rolled smooth. These temporary wearing surfaces shall be removed and replaced with material as specified above by not later than the following June 1st, except as provided above. Permanent pavements shall be replaced within sixty days of the date of the permit.

7. **Emergency Excavation.** In the event of an emergency, any person, firm or corporation owning or controlling any sewer, gas main, water main, conduit or other utility in or under any public street, alley easement, way or ground and his agents and employees may take immediate proper emergency measures to remedy dangerous conditions for protection of property, life, health or safety without obtaining an excavation permit, provided that such person, firm or corporation shall apply for an excavation permit not later than the next business day and shall notify the Police Department immediately.

8. **Excavation in New Streets Limited.** Whenever the Village Board determines to provide for permanent improvement or repaving of any street, such determination shall be made not less than thirty (30) days before the work of improvement or repaving shall begin. After such permanent improvement or repaving, no permit shall be issued to open or excavate said street for a period of five (5) years after the date of improvement or repaving unless, in the opinion of the Director of Public Works, conditions exist which make it absolutely essential that the permit be issued. Every effort shall be made to place gas, electric, telephone and television cable lines in street terraces.

9. **Street Condition.** Whenever a contractor, utility, property owner leave debris (mud, dirt, soil, gravel or waste) of any type on the street, alley or public way it is their obligation to remove and clean such debris immediately. If such debris is not removed within twenty four (24) hours, the Director of Public Works shall order the work to be accomplished and the party responsible will be charged a minimum of \$100.00 or the actual cost of said cleaning, plus twenty percent (20%) for administration, whichever is greater.

This ordinance shall take effect upon passage and publication as provided by law.

NOTICE TO ALL WASHINGTON COUNTY DOG OWNERS

Pursuant to Section 174.052, Wisconsin Statutes, notice is hereby given to all owners of dogs in Washington County that dog licenses and rabies vaccinations are required.

Vaccination by a licensed veterinarian against rabies is required of all dogs (Section 95.21(2)) within 30 days after the dog reaches 4 months of age and revaccinated within one year after the initial vaccination. The owner of a dog shall have the dog revaccinated against rabies by a veterinarian when the certificate expires or within three (3) years of previous vaccination. The certificate of rabies vaccination must be presented to the collecting official before a dog license may be issued.

All dogs five (5) months of age or older require a license. The minimum license fee for neutered males or spayed females is \$3.00, upon presentation of evidence attesting to the same, and \$8.00 for the unneutered male or unspayed female dog or one-half of these amounts if the dog became five (5) months of age after July 1 of the license year. The governing body of any town, village or city may raise the minimum dog license tax. Any person who keeps or operates a kennel may apply for a kennel license. The fee is \$35.00 for twelve (12) dogs or less and an additional \$3.00 for each dog in excess of twelve (12).

Dog licenses can be obtained from your local town, village or city treasurer or designee during the course of any given year. Dog owners should notify their treasurer if their dog is given away or has died, so that you will not be considered delinquent. An affidavit of death is available.

PENALTY

Every owner of a dog 5 months of age or older who fails to obtain a license by April 1 will be assessed a late fee of \$5.00

Wisconsin Lutheran Girls Are New WISAA Champs

MILWAUKEE - It took 13 years for some team to do it, but Wisconsin Lutheran's girls basketball team finally knocked Pius XI off the perch in WISAA Division 1 state tournament action.

The Vikings upset Pius XI 63-60 in the girls semifinals, and then capped off a stellar season with a 61-59 win over Green Bay Notre Dame to win the girls Division 1 state championship.

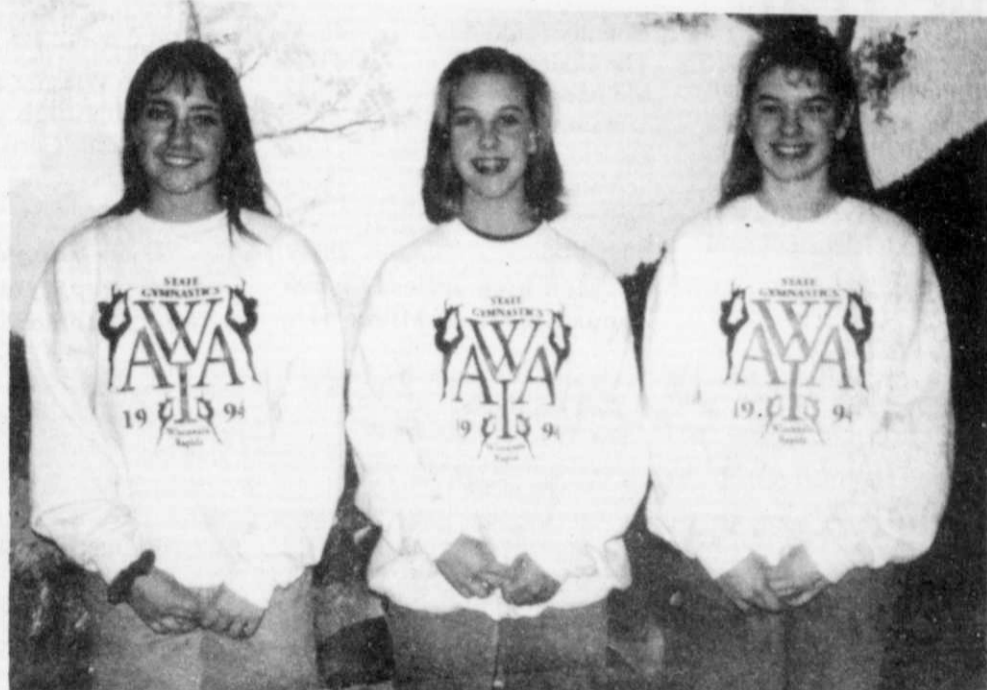

Zautner Named to EW's Second Team

NEW HOLSTEIN - After compiling a 2-10 record in the Eastern Wisconsin Conference, there wasn't much of a chance that Kewaskum would be well-represented in the league's all-conference selections.

Nevertheless, the Indians did have one player named to the loop's second team, as senior James Zautner was honored for his overall contributions.

Plymouth and Sheboygan Falls, which finished 1-2 in the league and basically dominated all others during the season, each had two players named to the All-EW first team.

Plymouth, which won the conference title with their 11-1 mark, was represented by John Kwoles (12.0 ppg, 49 assists) and Travis Streblov (11.2 ppg, 86.4% FT's). The Falcons, meanwhile, placed the top two scorers, Matt Wieseckel (17.3 ppg) and Jason Meerdink (16.5 ppg) on the first team. Zautner was joined on the second team by Plymouth's Dave Mikolyk (31 steals, 50 assists), falls' Rick Moser (112 rebounds, 10.9 ppg), Kiel's Scott Adelman (13.3 ppg, 74 rebounds) and Mike Schuler (11.7 ppg), and Two Rivers' Rob Remiker (10.4 ppg, 31 steals). All are seniors, with the

exception of the sophomore Mikolyk.

Kewaskum's Erik Ankerson was the lone other Indian to be honored, as he received honorable mention. Ankerson averaged 8.5 points per game, and was third in the rebounding race (96).

bruena, Raatke Receive Honorable Mention Wiesner Named Co-Player of the Year

NEW HOLSTEIN - Kewaskum guard Ginger Wiesner showed late in the year that she was a big-time scorer. Her coach, Glenn Eichstedt, and the rest of the coaches in the Eastern Wisconsin Conference, already knew that the 5-7 senior was a defensive standout.

That complete all-around game was one reason why the EW coaches named Wiesner to the All-EW first team, and in addition earned her a share of the Player of the Year award with Two Rivers' Shanna Miller.

In addition to Wiesner's honor, two other Lady Indians were given honorable mention in the balloting. Seniors Ali Bruendl and Missy Radtke were honored by the coaches for their contributions.

But as was the case all season, it was Wiesner who stole the show. Literally. Anchoring the Lady Indians' pressing defense, Wiesner finished third in the EW in steals (47), and was fourth in assists (38).

Propelled by a three-game stretch in which she averaged 27 points per game, Wiesner finished the conference slate second in scoring (196 points, 16.3 average). She also led the EW in free throws made (56) and attempted (77), and her 72.7% from the stripe was second in the league.

"She may be the most sincerely gifted and coachable player I've ever enjoyed working with," Eichstedt said of Wiesner. "Her greatest attribute is her attitude."

While Miller may have led the EW in scoring (200 points, 16.7 average) the 6-0 junior probably wasn't the focal point of the other team's defense like Wiesner was, according to Eichstedt.

"The biggest compliment paid to (Wiesner)," Eichstedt said, "was the variety of gimmick defenses utilized designed to stop her."

Also named to the first team were Chilton's ChyAnne Kapitzke (12.8 ppg., 112 rebounds), New Holstein's Tammy Kraus (11.1 ppg., 67 steals, 69 assists), and Two Rivers' Angie Gates (10.9 ppg., 59 steals, 75 assists). Kraus was the only other senior on the first team. Miller and Gates are juniors, and Kapitzke is a sophomore.

Kewaskum didn't have any representatives on the second team. It consisted of New Holstein's Mindy Schmitz (12.0 ppg), and Cybil Corning (98 rebounds), Plymouth's Jenny Sorensen (12.3 ppg), Kiel's Karla Niemuth (38 assists), Two Rivers' Jennifer DeGroot (39 assists), and Chilton's Denise Woefel. Niemuth and DeGroot are seniors. The rest are juniors, with the exception of Dorensen, who is a sophomore.

Bruendl "was the heart and soul of our team," said Eichstedt. The 5-9 forward averaged 4.4 points per game, and was eighth in the EW with 88

rebounds. "Her competitive drive and basketball instincts proved to be invaluable throughout the season," Eichstedt added.

Radtke, meanwhile, led the EW in rebounding (125), and

averaged 6.1 points. She also led the EW, averaging nearly seven blocked shots per game. "Missy may have had the most significant defensive impact in the conference," Eichstedt said of the 6-1 center.
