# Four Seeking Village Trustee Positions, School District Referendum to Be Decided at Tuesday's Spring Election

When village residents go to the voting polls on Tuesday, April 5th, they will be deciding on three village board trustees, state, county and school board positions, and the school referendum issue.

Four village residents are running for the two year term trustee position.

John Borland has been a village resident for the past six years and has lived in the Kewaskum area most of his life.

This is his first bid for public office and Borland stated he has an interest in the community as his primary reason for running. In the early stages of filing, it did not appear there were many candidates for office. Borland felt this would be a good opportunity to become involved politically on the local level. Working second shift for

a number of years, Borland was not able to attend evening meetings. His employment situation has changed allowing his attendance and involvement in evening meetings.

Immediate community concerns Borland feels need to be addressed are the changing of Highway 45 to four lanes, side street maintenance, water tanker for the fire department, and village centennial in 1995. To elaborate more on Highway 45, Borland has concerns for the businesses located on 45 that will be affected by the highway change. He also questions if our quiet village is progressing and changing too fast. Is the fact that Kewaskum is a quiet village been a drawing factor for the growth Kewaskum has recently experienced? How will the change in Highway 45 affect current residents and businesses?

The Kewaskum Fire Department serves village residents and outlying areas. If a new water tanker is needed to adequately serve residents, Borland feels this should be a priority item.

Village resident Gary Gavin is the only incumbent seeking reelection. Gavin has served as a village trustee for four years and is seeking another term to, "see through programs and projects that have been started." Gavin stated, "I live here, I work here and I like to be active in the community."

Gavin sights several areas

of immediate community needs with the first being the change to four lanes on Highway 45 yet preserving parking on Fond du Lac Avenue. This will be a village expense, but it is what residents want.

Gavin wants to see the village continue to grow at a slow pace that can be handled. The board has kept property taxes at a good pace and expenses down to a minimum. He stated the number of village employees is the same as ten years ago with the same services provided for an increased village population. Gavin stated sometimes you need to look at the free market to save money as was done when the village contracted with Hechimovich Sanitary Landfill, Inc. for community garbage pick-up and recycling. In the long run, this resulted in savings for the village in terms of cost and freeing up village employees for other needs.

Gavin currently serves as Park Chairman and stated several park equipment purchases and improvements have been made. The ball diamonds at the Kiwanis Park are scheduled to be upgraded this year. He also explained the sewer plant will be a major upcoming expense for the village as the village continues to grow. The Board is taking steps now to minimize that expense.

Finally, new street lights are one other area Gavin feels needs to be addressed by the

new board.

Bill Kulas is an 18 year resident of Kewaskum, seeking his first term for public office. Kulas holds a Bachelor of Arts and Master degrees in Business Administration and views the operation of community government is very much like operating a business. Being a community businessman, Kulas feels quaified for the village board trustee position.

Kulas has ideas for the expansion of the village sewer and water system without adding an extra tax burden on village taxpayers. He feels this should be a priority with the Board.

Kulas is also concerned about the community growth and how that growth is formatted.

Robert Stoltzmann has been a Kewaskum resident since 1972. This is also his first bid for public office.

Stoltzmann is familiar with the workings of the village board having served as fire chief of the Kewaskum Fire Department from 1989 to 1992. In that capacity, Stoltzmann attended and made monthly reports at the village board meetings.

Stoltzmann has no political motive for running for office. He expressed concern of the lack of candidates for office at the time when he filed papers as a deciding factor to run.

Stoltzmann feels the future growth of our community and the planning of such should be top priority for the new board.

In addition to the village board seats, residents will also decide on a Justice of the Supreme Court Janine Geske or William Pangman. Incumbents Jean Goeden and Neal Weare are school board candidates and uncontested positions in District 2 and county level positions will be decided as well as the local school referendum issue.

# Plan Commission Ok's Preliminary Plat Plan

A sprinkling of village residents were in attendance at last Tuesday's Plan Commission meeting to find out more information on the proposed new Gavin subdivision, Sunset Estates. The subdivision will be located just west of Edgewood Drive in Kewaskum. (See preliminary plat plan on page 6). Review of the Preliminary Plat Plan was the main order of business for the Plan Commission as they listened to a presentation by Ken Ward, Village Engineer, who has been retained by Gary and Linda Gavin. For those unaware, Ward mentioned the proposed subdivision "is bordered basically by the Ideal subdivision on the north, village boundary on the west, Edgewood Avenue on the east and a little bit offset from the park on the south. The first phase of the development encompasses 31 lots. Ward further explained, "the general size of the lots, the smallest size lot is 10,790 feet.

The zoning requires 10,000 square feet. The average size of the lots is right around 11,000 to 12,000 square feet."

The lots vary in size to

Kevin Pamperin, son of Mr. and Mrs. Lloyd Pamperin, 6570 Hwy. D, Allenton, was chosen as one of 384 students statewide to participate in Science World '94.

The Department of Public Instruction sponsors the summer enrichment program for eighth grade students. State Superintendent John T. Benson said, "Science World encourages young people to expand their talents and interests in science, mathematics, and technology through hands-on learning and exploration."

Pamperin will attend one of six, week-long sessions to be held at the Pigeon Lake Field Station located near Drummond in northern Wisconsin's Chequamegon National Forest.

While at the summer camp, he will participate in a variety of science activities and interact with visiting scientists and technologists from higher education, business and industry.

Approximately 1,000 students throughout the state were nominated for this summer's program.

Kevin was nominated by Mr. Floyd Brenner, science teacher at Kewaskum Middle School, and was selected for his potential in science and technology. accommodate different size and design homes.

# Ask the School Board President...

EDITOR'S NOTE: This week The Kewaskum Statesman is happy to publish the second phase of our new "Ask The Board Presidents" column with School Board President Neal Weare answering the questions.

We currently have only one more letter on file so we ask you to get your questions down on paper and send them in so we can keep the column going and keep the lines of communication open between taxpayers and our elected board presidents.

This is YOUR school and YOUR community. If our officials do not know about the questions you ask your friends and neighbors, or how you feel on issues... how can we expect them to govern us?

We ask that your letters be addressed to the "Ask Your Board President," column, c/o The Kewaskum Statesman, P.O. Box 98, Kewaskum, WI 53040. All letters must be signed, HOWEVER, the names are covered up before the copy is made to forward to the presidents.

Our second letter was directed to our school board president, Neal Weare, and it stated:

"Can't you make this building plan work WITHOUT removing the stage in Rose Hall? You told us at the Town Meeting the plan couldn't

work without the theater - two days later you had a plan! The same one - only without the theater. Students in Fine Arts are upset that they won't have a stage. There must be another way at this time to not remove it - until such time the public votes or approves the Fine Arts Theater. Thank you. Why arn't you using the Middle School kitchen for the district's central kitchen as it was designed for? This should definitely be looked into."

#### ANSWER BY SCHOOL-**BOARD PRESIDENT** NEAL WEARE:

**OUESTION #1:** After the February 15th referendum, I called a special meeting of the board to see what, if anything, should be done. It was the feeling of the board that the problem of the facilities was still there and that we had to do something. It was felt that the Fine Arts Theater (Auditorium) had been the cause of the referendum not passing. It was then decided to go with everything except the auditorium. That meant taking the stage and band room out as in the original plan and moving the art room. This would then allow us to have the necessary room to gain the ten (10) additional classrooms that

were in the original plan.

We knew from the start that the stage and band room had to be moved and the Fine Arts Theater had to be built as part of the whole plan so we wouldn't lose the ability to still put on plays or other activities.

Since the stage area, which is outdated, will no longer exist, we will have to be creative in the use of Rose Hall until a Fine Arts Theater is built. Some ideas have been to have a Theater in the Round. If this doesn't work, the only other alternative we have left is to rent the auditorium in the West Bend School District or perhaps the auditorium at UWWC in West Bend.

**QUESTION #2:** The reason the Kewaskum Middle School kitchen isn't being used as the district's central kitchen is because it never was designed for that purpose. After talking with two former district employees, one of which was the food supervisor, the other the business manager at the time the middle school was built, it was learned that it never was designed with that purpose in mind.

I received a letter addressed to me which contained comments, no questions, and was originally UNSIGNED. I would ask that whenever you write to

me here at the Kewaskum Statesman, or to my home, please sign your name. I only ask that you PLEASE respect the Statesman's policy when writing to this column.



The hormone has been a hot topic of conversation recently, as small dairy farmers are upset that it is used by larger farms to increase milk production in cows. The safety of BGH has also come under fire by those opposed to its use.





# To the People of Kewaskum...

I would like to talk to you about a topic that most property owners don't like thinking about. That is "reassessment."

The Village of Kewaskum will be conducting a villagewide reassessment this fall. We have been long overdue for a number of years now. It's not my idea and I'm not trying to pass the buck (or take your bucks), but the State of Wisconsin is telling us to do it.

State Statutes say that when the municipality has a 10% or more disparity between the state's equalized value, which is set at 100%, and the municipalities appraised value which can be either above or below 100%, the municipality MUST conduct a reassessment within three years and must inact it no later than the fourth year.

In most cases, it will end up being lower, because one thing we all would like, is for our house values to increase and in Kewaskum, house values have been increasing. That is basical-

ly what the state's equalized value is... what the state has determined the fair market value is for a comparable property as yours in this area.

It has been a very, very long time since we had any village reassessment done. Due to that reason we are at about 78% which is well below the state mandate of 10% plus or minus of 100% which would mean 90% is the lower limit.

In a way, it's good to have an accurate value assessment for the village. When a municipality is conducting its government, it's no different than you as a individual working on your personal finances to have accurate records and to find what your net worth is.

Reassessment doesn't necessarily mean your village property taxes will be going up, because as we all know, the village has a set budget and does something I wish the Federal Government would do, which is

to have a balanced budget.

The village doesn't run a deficit nor do we make a profit. Dan Schmidt works very hard to have everything balance out. So the village board would adjust the tax rate per thousand to accommodate our budget, which in this case would be lowered.

Well, I hope I explained this as clear as I could. I know it was confusing me just writing it.

If you have any questions about this, please call me or send a letter to the "Letters to the Board Presidents" column, in care of this newspaper. I will try to help you. If I don't have the answer, I'll talk to Dan and find out. Sometimes I think he lives, sleeps and studies this kind of stuff 24 hours a day, seven days a week. Thanks.

The children will have the opportunity to participate in storytime, music, art, and other creative activities during the 12 day session.



Just as Christmas has its various symbols such as holly and wreaths, so does the Easter holiday feature its own special characteristics. One that immediately comes to mind is the Easter egg. How did eggs become associated with the season we know as Easter?

The answer may lie in myths and customs of long, long ago. The ancient Egyptians and Hindus believed that the world began as a huge egg. According to a Hindu legend, this egg broke in two, with half becoming the sky and the other half becoming the earth; what was hatched from the egg became our sun.

The Finns had a similar legend. It seems that the god Ukko sent a water bird to nest on the knee of the great Water-Mother. Earth and the Heavens were formed from the broken eggs of the water bird, the Finns once thought.

Samoans believed that the God Tangaloa-Langi was hatched out of an egg, with the bits of its shell scattering over the Pacific to become the Samoan Islands.

It was the custom of the ancient Persian and Greeks to gift each other with eggs during spring festivals in celebration of the new life springing up around them, while the ancient Druids had a ceremony that centered on the eggs of serpents, which were sacred to these pagan people. During the ceremony, the Druids would circle around the eggs, which represented life; the circle signified eternity. 10.2

So it seems that the association

of eggs with birth was a universal one; in fact, historians think that Easter eggs go back a very long way, although they were not mentioned in writings until 500 years ago.

Because eggs were given up (along with meat) during Lent in the Middle Ages - due to religious reasons and due to the scarcity of food in winter - they became a special treat. The nobility made it a practice to gift their servants with fresh eggs at Easter time, and children were sometimes gifted with eggs for the holiday.

#### Easter Eggs Magical

In time, people began to believe in the magical powers of Easter eggs. Many thought that burying painted eggs in the ground around Easter time would make their grapevines grow well. Up to a century ago, the British believed that the yolk of an egg laid on Good Friday and kept for a hundred years would turn into a diamond.

Over the years, decorating eggs for Easter evolved into a folk art, especially in Eastern Europe. There, the peasants made their own dyes, using onion skins, hickory bark, roots and walnut shells to create the hues that colored their eggs. Intricate designs were often used, but certain motifs occured again and again: the sun, symbolizing good luck; a hen or rooster, to make wishes come true; a deer, symbolizing good health; and flowers, representing

love and beauty.

These intricately decorated eggs were blessed at the local church and then distributed to friends and family.

In Germany, designs were scratched on colored eggs; this art was brought to the United States by the Pennsylvania Dutch.

Nowadays, Easter eggs are still part of the holiday celebration,

not only in the United States, but in other parts of the world.

In Switzerland, after attending morning services, Swiss children hurry home to see if the Easter Hare has left them gifts such as candy eggs and other goodies.

In Sweden, egg-rolling contests are held on Easter Sunday; this custom is also popular in England and other European countries. It is thought that the custom was originally associated with the stone being rolled away from the tomb of Christ on Easter Sunday.

#### Norwegian Tradition

Norwegian children begin collecting eggshells weeks before Easter. They paste the shells together with bright paper and then decorate them with cutouts, or paint pictures on them.

In the Netherlands, Easter Sunday means hunting for brightly colored eggs. Dutch children also engage in a game of hitting the eggs, which have been hardboiled, or course! The players try to match up their Easter eggs with a friend's of the same color. The object is to try and break the shell of the other egg without breaking your own. Italian children enjoy fancy

candies shaped like eggs and resembling semiprecious stones after their traditional feast of roast lamb at Easter.

Young German girls are taught the art of painting and decorating Easter eggs by melting wax over charcoal and then "painting" the wax onto the egg with a pen. The eggs are then colored and the wax removed, leaving a white design. The eggs are then rubbed with bacon to make them shine.

The Polish people make a ritual of cutting a colored Easter egg; this is done by the father of the household, who distributed a portion to everyone at the table.

In the United States, every youngster expects to find a basket filled with candy eggs, left by the Easter bunny. And, the annual eggrolling contest on the White

House lawn is dutifully recorded by the media, reflecting the countless other Easter egg contests and hunts participated in by youngsters across the country.

Whatever the reason, the Easter egg is as common to this spring holiday around the world as gifts are to Christmas.


#### **101 Pins Over Average**

Notice is hereby given of a spring election to be held in several wards in the Counties of Washington, Fond du Lac and Sheboygan on the 5th day of April 1994 at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column.

#### INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the nonpartisan election, the elector shall make a punch or a hole or complete arrows at the right of the candidate's name with a HEAVY BOLD line for each office for whom he or she intends to vote, or insert or write in and connect the arrow of the name of the candidate of his or her choice on the ballot envelope provided or in the space provided.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official. who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is punched or marked, it shall be inserted in the envelope provided so the punches do not show or folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show.

After casting his or her vote, the elector shall leave the booth, and deposit the envelope containing his or her ballot in the ballot box and where paper ballots are distributed to electors, deposit his or her folded ballots in the paper ballot boxes, or deliver the ballots to an inspector for deposit. The unused ballots should be deposited in the blank ballot box, and the elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of the employer or an officer or agent of a labor organization which represents the elector.

AUTHORIZING GENERAL OBLIGATION SCHOOL BUILDING BONDS IN AN AMOUNT NOT TO EXCEED \$5,300,000 BE IT RESOLVED by the School Board of the School District of Kewaskum, Washington, Fond du Lac and Sheboygan Counties, Wisconsin that there shall be issued pursuant to Chapter 67 of the Wisconsin Statutes, general obligation school building bonds in an amount not to exceed \$5,300,000 for the public purpose of paying the cost of constructing additions to and remodeling and renovation of the Kewaskum High School and Middle School and acquiring equipment and furnishings."

#### EXPLANATORY STATEMENT AND EFFECT OF VOTE

The referendum election ballot will ask District electors to vote "yes" or "no" on the referendum election question as set forth above

A "yes" vote on the question is in favor of the initial Resolution and is a vote to approve the borrowing of \$5,300,000 by the School District of Kewaskum through the Issuance of general obligation school building bonds for the purpose of paying the cost of constructing additions to and remodeling and renovation of the Kewaskum High School and Middle School and acquiring equipment and turnishings.

A 'no' vote on the question is opposed to the Initial Resolution set forth above and is a vote to deny the School District of Kewaskum the authority to borrow \$5,300,000 through the issuance of general obligation school building bonds for the purpose of paying the cost of constructing additions to and remodeling and renovation of the Kewaskum High School and Middle School and acquiring equipment and furnishings.

In the event a majority of the electors voting vote "Yes" on the question set forth above, the District will be authorized to undertake the school building program described above and borrow not in excess of \$5,300,000 therefor; if a majority vote "No" on the question set forth above, the District will not be so authorized.

#### POLLING PLACES AND HOURS

District electors must vote at the times and in the places at which they cast their ballots at regularly scheduled elections

#### INFORMATION TO ELECTORS

(a) Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of 2 inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her vote, except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

(b) (l) If paper ballots or lever machines are used, then on the referendum election question, the elector shall make a cross (X) in the square at the right of or depress the button or lever next to the answer which he or she intends to give.

(ii) If a punch card voting system is used, then on the referendum election question, the elector shall make a punch or a hole at the right of "yes" if in favor of the question, or the elector shall make a punch or a hole at the right of "no" if opposed to the question.

(iii) If a mark sense voting system is used, then on the referendum election question, the elector shall make a mark in the space at the right of "yes" if in favor of the question, or the elector shall make a mark in the space at the right of "no" if opposed to the question.

(c) The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. If the ballot has not been initialed by 2 inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than 5 minutes time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking or punching his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

(d) (i) After an official paper ballot is marked, it shall be folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show. After casting his or her vote, the elector shall leave the voting machine or booth and, where paper ballots are distributed to the electors, deposit his or her folded ballot in the ballot box or deliver it to an inspector for deposit in the box, and shall leave the polling place promptly.

(ii) If a punch card voting system is used, then after an official ballot is punched, it shall be inserted in the envelope provided so the punches do not show. After casting his or her vote, the elector shall leave the booth, deposit the envelope containing his or her ballot in the ballot box, or deliver the envelope to an inspector for deposit, and shall leave the polling place promptly.

(iii) If a mark sense voting system is used, then after an official ballot is marked it shall be inserted in the envelope provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, discard the envelope, and shall leave the polling place promptly

(e) An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty in reading, writing or understanding English, or that due to disability is unable to cast his or her vote. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

NOTE: Electors residing in municipalities which require voter registation must be registered to vote in this referendum election. You can register by contacting your municipal clerk.





### **RESOLUTION NO. 94-7**

### VILLAGE OF KEWASKUM'S ETHICS LAW

#### I. Effective Date.

The ethics law went into effect on August 15, 1991. The Village of Kewaskum's ethics law effective date will be March 21. 1994.

#### II. Statutory References.

The ethics law can be found in the Wisconsin Statutes ss. 19.42 and ss. 19.59.

III. Governmental Units and Local Public Officials Affected.

( ss. 19.42 (7u); ss.19.42 (7w); ss.19.42 (7x) ). 1. Local governmental unit - a political subdivision of this state, a special purpose district in this state, an instrumentality or corporation of such a political instrumentality or corporation of such a political subdivision or special district, a combination of subunit of any of the foregoing or an instrumentality of the state and any of the foregoing. 2. Local public official -

(a) an individual holding an elective office of a local government; (b) a village administrator or village manager;

(c) an individual holding an appointive office or position of a local government in which an individual serves for a specified or unspecified term, or a position filled by an independent contractor, or (d) an individual holding an appointive office or position of a local government which is filled by the governing body of the local government or the executive or administrative head of the local government and in which incumbent serves at the pleasure of the appointing authority, except a clerical position limited to the exercise of ministerial action or a position filled by an independent contractor.

IV. Prohibited Conduct. (ss. 19.59 (1))

1. Use of Office for Private Gain. No local public official may use his or her public position or office to obtain financial gain or anything of substantial value for the private benefit of himself or herself of his or her immediate family, or for an organization with which he or she is associated.

2. Offer or Receipt of Anything of Value. No person may offer or give to a local public official, directly or indirectly, and no local public official may solicit or accept from any person, directly or indirectly, anything of value if it could reasonably be expected to influence the local public official's vote, official's actions or judgement, or could reasonably be considered as a reward for any official action or inaction on the part of the local public official.

Note - This paragraph does not prohibit a local public official from engaging in outside employment.

3. Action Affecting Substantial Interest or Benefits. No public official may take any official action substantially affecting a matter in which the official, a member of his or her immediate family, or an organization with which the official is associated has a substantial

financial interest.

4. Actions Affecting Substantial Interest or Benefits. No public official may use his or her office or position in a way that produces or assists in the production of a substantial benefit, direct or indirect, for the official, one or more members of the official's immediate family either separately or together, or organization with which the official is associated.

Note - Paragraphs 3 and 4 do not prohibit a local official from taking any action concerning the lawful payment of salaries or employe benefits or reimbursement of actual and necessary expenses.

#### V. Penalty and Enforcement. (ss 19.59 (7); ss 19.59 (8) ).

1. Any person who violates the prohibitions outlined in ss 19.59 (1) may be fined up to \$1,000.00 for each violation. In addition, other legal or equitable relief may be obtained, including but not limited to mandamus, injunction or declaratory judgement, as appropriate. 2. The ethics law shall be enforced in the name and on behalf of the state by action of the district attorney or any county in which the violation may occur, upon the verified complaint of any person. If any district attorney fails or refuses to commence action within 20 days after receiving a verified complaint, the person making the complaint may petition the attorney general who may act upon the complaint. Note - If the district attorney prevails, the court shall award reasonable costs and any forfeiture recovered to the county of violation. If the attorney general prevails, the court shall award the same to the state.

VI. Advisory Opinions. ( ss 19.59 (5); ss 19.59 (6) ).

1. Any individual, either personally or on behalf of an organization or governmental body, or any appointing officer, with the consent of prospective appointee, may in writing request an advisory opinion regarding the propriety of any matter to which the person or prospective appointee is or may become a party. The request should be directed to the county or municipal ethics board if there is one, or to the county corporation counsel or attorney for the local governmental unit.

Mr. Rick Kania of SEWRPC was present to review additional information regarding the proposed Land Use Plan. Mr. Kania discussed the three pages that reflected revisions to Chapter III and gave a brief update as to revisions/clarifications to Chapter V. Discussion regarding Chapter IV for the next meeting was reviewed along with an outline of what was to be included in it. The topic for this meeting was review of upcoming policy type decisions, such as pedestrian walkways, ownership or easements, length of blocks, etc.

On a motion by Richard Schmidt, seconded by Paul Ziebert and carried by the majority roll call vote, the Commission adjourned the meeting. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent."

### **RESOLUTION NO. 94-7A**

Such request shall be reviewed and an advisory opinion may be given in writing. However, an advisory opinion is not required to be given. The identity of an individual requesting an advisory opinion or of individuals or organizations mentioned in the opinion may not be made public.

3. It is prima facie evidence of intent to comply with this section when a person refers a matter to a county or municipal ethics board or a county corporation counsel or attorney for a local governmental unit and abides by the advisory opinion, if the material facts are as stated in the opinion request.

4. The advisory opinion may be made public with the consent of the individual requesting the advisory opinion or organization or governmental body on whose behalf it is requested. A summary of an advisory opinion issued under this subsection may be made public after making sufficient alterations in the summary to prevent disclosing the identities of individuals involved in the opinion.

5. A person who makes or purports to make public the substance of or any portion of an advisory opinion requested by or on behalf of the person waives the confidentiality of the request of an advisory opinion and of any records obtained or prepared in connection with the request for an advisory opinion.

6. Any county corporation counsel, attorney for a local governmental unit or statewide association of local governmental units may request the Wisconsin Ethics Board to issue an opinion concerning the interpretation of the statutory code of ethics for local public officials. The Board shall review such a request and may (but is not required to) advise the person making the request.

VII. Formal Opinions of the Wisconsin Ethics Board.

Meals, Lodging Travel and Entertainment. The Department of Development may sponsor an anniversary celebration of a Wisconsin Corporation if, but only if, the department determines that the event will benefit the State of Wisconsin and will promote business, economic development, or tourism. State and local public officials may accept food, drink and lodging offered in connection with the celebration to the extent that the items are provided by the Department of Development. OEB 93-2 (January 27, 1993).

2. Influencing Official Judgement. A vendor should not sponsor a river cruise for local public officials attending a convention if more than an insignificant number of the officials attending are responsible for making or approving purchasing decisions that could involve the vendor's goods. OEB 92-31 (November 25, 1992).

3. Improper Use of Office. A village engineer should not act in an official capacity with respect to the review of plans the engineer has prepared in a private capacity or submitted by developers with which the village engineer is associated. OEB 92-28 (September 15, 1992). 4. Improper Use of Office. A Village Board member should not participate in official discussions, deliberations and votes with respect to legislation (that is, ordinances and the like) affecting his or her real estate interests except to the extent that he action affects a whole class of similarly situated interests, and the board member's interest is insignificant when compared to all affected interests, and the action's effect on the board member's private interests is neither significantly greater nor less than upon other interests affected by the act.

The Village Board member ought not to participate in quasi-judicial deliberations or decision-making such as actions on permits, licenses, rezoning of specific parcels, and the like affecting the member's interests or competing real estate interests. In those instances in which the member should refrain from votes, the member should also refrain from discussion and deliberations and ask that the minutes reflect that the member has withdrawn. OEB 92-22 (June 16, 1992).

5. Improper Use of Office. A law firm should not purchase meals for officials of local units of government the firm represents (nor should a local public official accept) unless, and only to the extent that, the local government would otherwise bear the official's expense and the govemmental units obligation to bear the expense is expressly authorized by, and in accordance with, established written criteria. OEB 92-17 (April 17, 1992)

6. Disqualification. A local public official is not disqualified from participating in the award of a contract to a business simply because that business is involved in an unrelated joint venture with the official's employer. OEB 92-10 (March 24, 1992).

7. Entertainment. A local public official should not permit another to pay the official's costs of a golf outing to which the official has been invited because of holding an official position. OEB 92-9 (March 24, 1992).

8. Meals. A local public official may attend a breakfast meeting sponsored by a private firm at a convention if the official's local governmental unit would otherwise pay the cost. OEB 92-9 (March 24, 1992).



### RECYCLING TIPS

The Village of Kewaskum continues its Mandatory Recycling Program. This article is one in a series of several that is designed to help you more thoroughly understand the details of the program.

Items to be placed <u>inside</u> the bin or bag together include: aluminum containers, glass bottles and jars (clear, green & brown), #1 P.E.T. plastic bottles, #2 H.D.P.E. plastic bottles and wide mouth containers, steel/tin cans, and bi-metal steel/aluminum containers. Items to be bundled and set <u>along side</u> the bins or bags include: newsprint, corrugated cardboard, and magazines. Lead acid batteries are also to be set <u>along side</u> the bins or bags for pick up.

NOTE, the dark green recycling bins may be placed at the curb every Wednesday for pick up unless specifically noticed in the newspaper. The blue recycling bags from multi-family dwellings are only to be placed for pick up the 1st and 3rd Wednesday of each month.

The focus recyclable items this week is <u>tin and steel</u> cans.

Type of Cans: Food Cans Only.

Preparation: **RINSE CLEAN**. This is the most important aspect of a successful recycling program. Containers that are contaminated with food residue cannot be recycled. **REMOVE LABELS**. This is easily done by slitting the label with a knife or fingernail and peeling it off. Place the cover into the can. Flattening the can is optional, but will conserve space in the bin or bag. Place cans in the dark green recycling bin or blue recycling bag.

### West Bend Outlet Mall Purchased by Picus Family





**KEWASKUM** - Things went pretty much as expected in the opening meet of the season for the Kewaskum girls track team.


Senior Ginger Wiesner won




