## Sidewalks Again An Issue

The continuing saga of the Kewaskum sidewalk issue reared its head again at last Monday evening's Village Board meeting.

The proposed sidewalk in question runs along the east side of Reigle Drive with the property belonging to the Kewaskum School District.

In his opening statement on this issue, President Robert Wagner said, "There has been quite a bit of behind-the-scenes discussion held with the school district regarding the proposed sidewalk. One reason it became an issue is because the Village does not have the right-of-way to put them in."

When the road was laid out the curb was placed right on the easement.

Wagner also stated, "I know in the past, sidewalks have always been a real hot topic in this town. And it probably will continue to be. I feel sidewalks should be put where they're needed. A month or so back I was opposed to the sidewalk next to Herges Oil."

"With this particular sidewalk (east of Reigle Drive) I feel personally it is needed. Of all places you want a sidewalk, it is at a school. For obvious safety reasons and especially

with the improvements they are going to be doing up at the school, it doesn't make sense."

Wagner continued, "From what I understand, in the past, one thing that led to sidewalk policy in this town, was the fact that the school was pushing for it. And now when it's in their backyard, they don't want it."

He further stated, "It's also foolish for units of government to be fighting over this, because it's only costing the taxpayers money. It isn't a matter of if the taxpayers are going to pay for it or not... it's what pocket it's coming out of... I felt we needed to go public with it at this time due to the similar situations. One of the school board members suggested if we wanted sidewalks, tear up the street and put it in the street. I'll be honest with you... talking foolish... we did a study on it. It's going to cost them a helluva lot more money because they could be assessed the full amount to do that."

Wagner stressed, "Again, I think this is ludicrous that we would argue over not putting a sidewalk at a school! Of all places that you would want sidewalk, especially with the improvements going up at school, this just doesn't make sense."

A member of the audience,

former trustee Gary Gavin, commented, "You made a comment that it's either the left pocket or the right pocket it comes out of. That's not true. Because if the village pays for it, it's the village residents. If it comes out of the school system, it's everybody in the district. There's a big difference between who's paying for what."

Trustee Charles Waala said, "But it doesn't make any sense for you to pay twice as much to do it, no matter whose pocket it comes out of."

Gavin reiterated, "The village is providing a lot of services and doing a lot of things that the taxpayers in the Village of Kewaskum are providing for the school system that the outlying communities are receiving. I don't see why the Village residents should have to pay more for it."

Police Chief Richard Knoebel added, "I agree with the safety factor. They're putting a new football field in. Right

now, it will probably be during the day but someday they'll probably put lights in and it will be dark. It's bad enough now when they're walking around the streets in the dark, I'd much rather have people on the sidewalks walking to and from the games, rather than walking up and down the road."

Gavin added, "I think as more and more people see how foolish the school system is being about this... maybe it wouldn't hurt for the village to write a letter in the paper letting the people know in the school district and the village what's going on... explaining the situation, and maybe some of the people on the school board will wake up and decide that maybe they should work with the village instead of talking as foolish as they have been, not worrying about the cost or what it's going to do to the village. A mistake was made that the right-of-way was not given or taken. Somewhere along the line you should try and work it out instead of spending \$7,000 by working it out or paying \$14,000. It's still taxpayers money being spent. Let more of the public know about it."

President Wagner agreed, saying, "The School Board had agreed to have a meeting on this at their last meeting and I was going to attend it, but they said, no, they would bring it up and talk about it but then they didn't take any action on it. Up until now, I didn't want to start rubbing their face in it, and we

wanted to be nice about it at first, but now, I felt, you're right, we are going more public with it."

Trustee Dave Goeden stated he had been in contact with a school board member and the subject possibly could be brought up at the school board meeting, also held Monday evening.

Gavin said, "I see no reason why the village residents should have to pay for half of that sidewalk. You put sidewalks in front of our churches, any other building, and they have to pay 100%. I see no reason to make an exception for the school system."

To clarify, Administrator Daniel Schmidt explained, "...The option the board shows... instead of paying the legal expense, offering to pay half the sidewalk... it's a benefit for both units of government."

Following more discussion, it was the consensus of the board to write another letter to the school board, further explaining the situation and stating the options. Therefore, the ball will again be in the school board's court.

Wagner did state in closing, "It's already too bad that we couldn't do it (put in the sidewalk) this year because I think the safety of the children is of the utmost importance and I don't think that should take a back seat to anything else."

The above building on Main Street in Kewaskum, now owned by Gary Gavin and Gregg Krueger, was owned and occupied for over fifty years by the Frank Felix family. Mr. Felix ran a Gamble Store and Radio and TV Sales and Service. The family had living quarters upstairs.

Prior to that it was owned by William and Lena Ziegler. Mr. Ziegler operated a tavern and his wife, Lena, ran a boarding house. During prohibition, Mr. Ziegler did not sell any intoxicating liquor, only soft drinks and snacks. Children from Holy Trinity School would cross the street at recess and buy penny snacks. Prior to that the upper story was used as a dance hall. Kaspar Puppet Shows

were also held there in the German language.

The house to the rear was owned and occupied by the Nic Rimmel family, now the home of Jim and Kathy Paul.

Note the hitching post and wooden sidewalks. The photo is believed to have been taken over a hundred years ago.

Students have the advantage of a small liberal arts college, combined with the resources of the University of Wisconsin System.

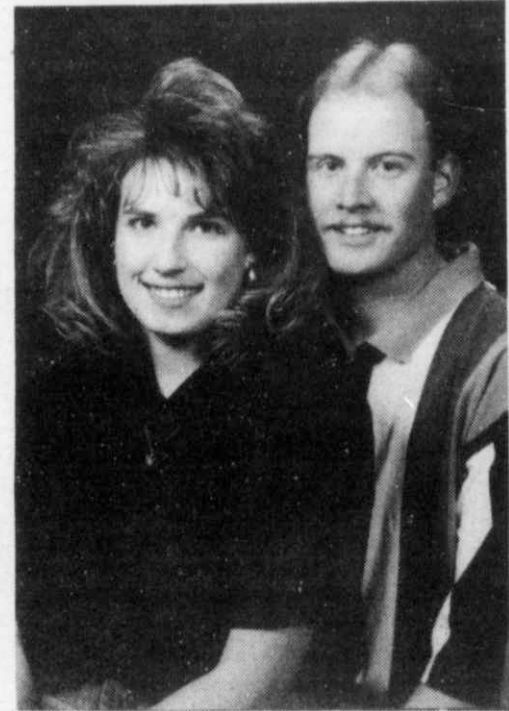

## Washington County Opens Two New Parks

After the Washington County Board of Supervisors met on Tuesday, July 12, the Board Members travelled to the sites of two new County Parks.

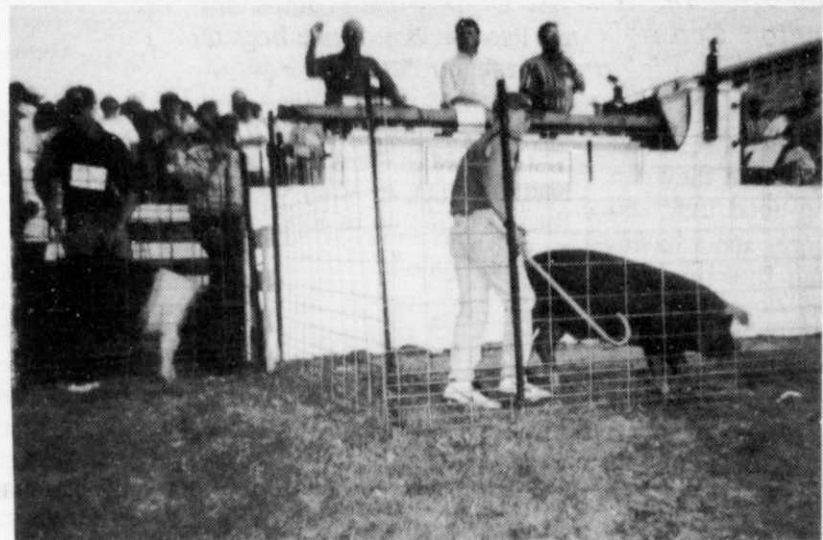

## Fire Helped to Shape Wisconsin's Forests

Although most Wisconsin residents associate Mrs. O'Leary's cow with starting the Chicago fire of 1864, they are not aware of equally severe fires that destroyed large sections of the State of Wisconsin during the nineteenth century.

One hundred years ago, during the summer of 1894, the area around Phillips was literally transformed into a towering inferno. The blaze destroyed more than 100,000 acres of land.

Unlike Chicago, there are no anecdotes concerning the origin of the Phillips fire, nor is there any solid historical evidence that establishes the reason for the tragedy. A second difference lies in the fact that this fire did not bring out public sentiment for fire prevention.

Part of the reason may be due to the public attitude that fire constituted a viable option for clearing land for farming development. When settlers originally arrived in Wisconsin in the 1620s, they discovered a land which contained seemingly endless forests. The missionaries and fur traders were followed by trappers and small cities were formed. As farming communities developed, lumbermen cut down thousands of acres of pines to provide lumber for buildings in Milwaukee, Chicago and St. Louis.

Farmers tried to use the cleared land for farming and during the nineteenth century would even intentionally start

forest fires to clear the land. Wisconsin forests acquired the nickname of "the Cutover," since farmers considered fire to be as much of an agricultural tool as the plow or the ax.

Although some environmental pioneers, such as Aldo Leopold, recognized the futility of these procedures, little thought was given to forest conservation until the early portion of the twentieth century. In 1904, E.M. Griffith was appointed as Wisconsin's first state forester, but forestry conservation measures still lacked public support.

Today, foresters from the Department of Natural Resources estimate that an average of 2,500 forest fires per year occurred in Wisconsin during the early 1930's and that these fires destroyed nearly half a million acres each year.

Eventually economic and soil conditions ended hopes for a large scale farming industry in Northern Wisconsin and efforts were made to restore forest lands. During the depression, The Civilian Conservation Corps provided over 66,000 men to help replant the forests and fight forest fires. With competent fire protection, the forested land became highly desirable property and today Wisconsin's forests have become an integral part of the state's economy.

# Looking back..

## 75 Years Ago

July 19, 1919

What probably is considered one of the best moves that has ever been made toward the interest of the cheese business in this community, was pulled off last week when B. Schriber, wholesale cheese dealer of Sheboygan, decided to place a warehouse in this village for the purpose of storing and shipping cheese. Part of the L. Rosenheimer warehouse, located near the malt house has been rented, and equipped with a paraffine tank, storing and shipping room. Otto Hammen of Sheboygan has been engaged to take charge of the warehouse, and will take care of all cheese brought to him. Ernest Slyfield, also of Sheboygan, will do the buying for Mr. Schriber. The placing of a warehouse in this village by Mr. Schriber was made necessary on account of too much cheese being spoiled while being shipped from Kewaskum to Sheboygan. It is said that cheese shipped from this village on Tuesdays would not reach the warehouse until the following Monday, during which time hundreds of dollars worth of cheese would be spoiled with each shipment. With a warehouse in this village, cheese makers can bring their cheese to said place at any time during the forepart of the week instead of one particular day as heretofore. When a carload has been received, it will be shipped direct to the eastern market. Mr. Hammen informed us that it is the intentions of Mr. Schriber to erect a large warehouse in this village as soon as business will warrant it.

Martin Knickel and Gregor Altenhofen of Campbellsport, miraculously escaped serious injury last Monday morning at about 1 o'clock when the Mitchell car driven by Mr. Knickel ran off the road and landed at the bottom of a six foot embankment. The two men were on their way home from Cedar Lake, and when they were about a mile north of this

village, where the road is about 12 feet wide, the front wheels of the car jumped out of a rut to the side of the road and the machine plunged down a six foot embankment and landed along side of a large tree, which prevented the car from tipping over. The occupants of the car walked back to the village immediately after the accident and were examined by Dr. Hausmann at the latter's office where it was learned that Mr. Knickel had received a double fracture of the left arm and his body was badly bruised. Mr. Altenhofen escaped injury.

Born, to Mr. and Mrs. Walter Belger of Kewaskum last week Friday, a baby boy.

July 26, 1919

Our neighboring village of Barton at last succeeded in landing a big manufacturing enterprise. At a meeting held Monday the Stevenson Manufacturing Company was organized with a capital stock of \$100,000. The company bought two acres of land from Albert Klemke, situated north of the depot, between the river and the railroad track. On this site a modern fireproof factory building, 80 x 128 feet ground space, will be erected. The plant is expected to be ready in about three months. Barn equipment and hardware are to be manufactured in it.

The intense heat of the past two weeks has caused large numbers of city people to go to the lakes to find relief. Forest Lake, northeast of this village, seems to be the mecca for these resorters, as many Chicago people are arriving daily to enjoy the cool lake breezes at this popular resort.

On account of high cost of cream and flavors, the following prices will be charged after August 1st: Plain ice cream, 10 cents; with flavor, 15 cents; and crushed fruit, 20 cents; brick and bulk, 30 cents a pint. War tax, 10 per cent.

August 2, 1919

The minimum wage law for women and minors became effective Friday. Much interest is being taken by all those employing help. Representatives were sent out to some cities where large numbers of women are employed. The following four points as given out by the representatives should be borne in mind: 1. For experienced adult women and for experienced minor employees who are over 17 years of age, 22 cents per hour. 2. For inexperienced adult women employees and inexperienced minor employees who are over 17 years of age, 18 cents per hour for the first three months, and 20 cents per hour for the next three months. 3. Children of permit age between 14 and 16 years of age, 18 cents per hour, regardless of the length of their experience. 4. Permit children between 16 and 17 years of age, 20 cents per hour if they have had three months' experience, otherwise 18 cents per hour.

Harvesting in this vicinity and Washington County is now

in full swing. The intense heat of Saturday and Sunday when the thermometer registered 101 and 98 in the shade, put the finishing touches to the grain crop. Oats and barley, which a week ago were turning and ripening were burned to a crisp. Farmers here hoped against hope that a downpour of rain would soon come. Although a little rain fell here Sunday evening, it was not enough to answer the purpose in refreshing the grain for the damage done during the long and dry spell. Indications for a heavy crop were good during the early part of the season, but farmers have not given up all hope, and unless it rains within the next few days the corn and potato crop, as well as all garden vegetables, will be a complete failure, as the leaves of same are curled up and are commencing to dry up. Threshing has already begun here, reports reaching this office are that the wheat and rye yield is from poor to fair, oats will be light and barley will not fare much better.

The total number of autos in Wisconsin will reach 240,000 before the end of the year, according to predictions made in the license department of the secretary of state's office at Madison. 210,000 licenses have so far been issued, which is an increase of 50,000 over that of last year.

## Parents Help Kids Discover Interests

(West Bend) -- It may seem like the list of activities available to your child is endless -- sports teams, music lessons, dance, gymnastics, art, summer camps, Scouts, 4-H. And that's just the beginning.

It's easy for parents to get caught up in offering children all these opportunities and forgetting that kids don't need to be busy every minute to have fun and learn.

Parents may want to assess whether they want their children to participate because they think their child will enjoy the activity and learn from it, or because the activity meets some of the parents' expectations about what children should do.

There's a difference between providing an opportunity to discover a child's interests, and pushing a child into something they clearly dislike. It's easy for parents to introduce children to activities that they think the children will like or excel in. But children are individuals, and they need to have some say in the matter.

When parents choose activities for their children, they:

-- Evaluate whether the program or project is developmentally appropriate. Is your child ready for a structured activity? Can he or she sit still for half an hour and follow instructions? Does he or she have the energy, fine motor skills and concentration needed?

-- Examine whether the program is balanced. Does it provide opportunities to be active,

creative, reflective and social with other children?

-- Take into consideration what type of person your child is. Talk to him or her about personal interests. Think about what he or she enjoys and what he or she is good at.

-- Think about why you as a parent are interested in the program. Is it because the activity will appeal to your child and develop skills, or because you want a winner in the family?

-- Decide what you will do if your child dislikes the activity. Parents need to evaluate whether it is really in the children's best interest to stick with an activity if he or she doesn't enjoy it.

Parents also can remember that kids don't have to be busy and active all the time. One thing parents can teach their children is that they can't do it all. It's not realistic. One of the luxuries of childhood is being without a strict schedule.

Parents can show their children how to enjoy themselves without a lot of formal activities. You can encourage your child to read, dream and reflect without enrolling him or her in a program. Perhaps you and he can keep a journal of the summer, plan a special outing or visit a park together. Children often say what they enjoy most is one-on-one time with a parent, regardless of what they do together.

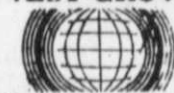

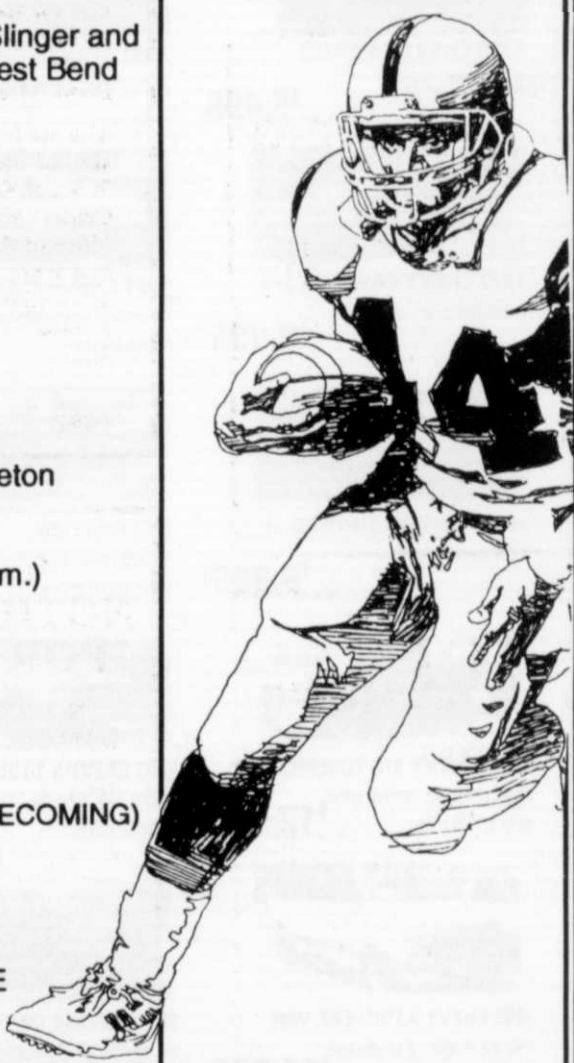

## Sheboygan Falls Stock Car Driver Chalks Up First Career Victory

PLYMOUTH.... Jim DePachter of Sheboygan Falls collected his first career feature victory in the 30 lap Modified Main Event Saturday night in Eastern Wisconsin Stock Car racing action at Sheboygan County Fair Park.

DePachter started the race from the pole and quickly took advantage of a fast and smooth race surface to pull out to a half straightaway lead over second place Dennis Klumb of Mequon in the early going. The gap narrowed on lap 20 when DePachter encountered lapped traffic. Klumb, the 1990 Hobby Stock champion, reeled in DePachter on lap 23 and closed up to the leader's rear bumper two laps later.

Over the final five laps, Klumb stayed within striking distance but was never able to mount a serious challenge for the lead. DePachter, the 1992 Modified rookie of the year, held off Klumb by three car lengths at the finish line to score a wire to wire victory in a red flag free race.

Klumb finished in second, Chuck Melis of Plymouth was third, Milwaukee's Pete Ostrowski took fourth, and Eddie Staehler of Kewaskum rounded out the top five.

Todd Gerlach of Random Lake picked up his second win of the season in the 25 lap Sportsman feature.

Pole sitter Jeff Fechter of West Bend led the first three laps before Gerlach, who started third, took over the top spot in turn two on lap four. By lap 12, Gerlach had built up a full straightaway advantage but red flags on lap 14 and 21 tightened the field. On both restarts, Gerlach jumped out to a comfortable lead while the rest of the pack battled for the second through tenth place positions.

Gerlach cruised to victory and became only the second Sportsman driver to notch more than one feature victory during

the 1994 racing season. Port Washington driver Jim Rychtik followed Gerlach to the finish line in second place, rookie Scott Specht of Sheboygan Falls charged up from his seventh row starting position to take third, two-time Sportsman champion Jim Pitzen of Plymouth maneuvered from eighteenth starting position to finish fourth, and Mark Dingel of Sheboygan was fifth.

In the Hobby Stock division, Jeff Leonhard of Sheboygan won his first 20 lap feature event of the year.

Second row starter Rick Mahlberg was in command of the event when the red flag came out on lap 16 for a stalled car. When the race resumed, Leonhard used the outside groove to dart by Mahlberg coming out of turn four. Leonhard held off a heated challenge from Mahlberg on the final lap to take the checkered flag.

With his win, Leonhard became the ninth different Hobby Stock driver to record victory this year. Mahlberg settled for second, Dave Enders of Kiel moved up from the tenth row to finish third, and current point leader Chad Kistner worked his way up from seventeenth starting position to take fourth, and Elkhart Lake's Brian Gilles came up from the eighth row to finish fifth.

In other action Saturday night, Troy Wondra of Lomira won the Modified C semi-feature. Pete Ostrowski won the Modified dash for cash. Henry Dickmann of Sheboygan took the victory in the Sportsman semi-feature. In the Hobby Stock division, Bruce Holz of Fond du Lac won the semi-fea-

ture and 1987 Hobby Stock champion Don Dippel returned to racing with a win in the consolation race.

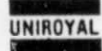
