

# Lorene's Flowers

#### By Sharon Callaway Roznik

There's a special kind of bond between Jim and Lorene Martin... the kind you rarely get a glimpse of, but when you do, it lifts the spirits and inspires the heart.

Both 77, and residents of Beechwood Rest Home, they can attest to the fact that life can be difficult, but never worth giving up on. Wheelchairs don't confine their zest for life or their love for each other. Jim does the talking for both of them since a stroke left Lorene unable to speak, walk, read or write, and paralyzed on one side.

He tells her story, and claims to have none of his own, yet, and Richard talked them into their combined talents landed them on the front page of the Milwaukee Sentinel recently. "We have to keep busy," insists Jim, also confined to a wheelchair because of a stroke. And it isn't easy to fit a 6'6" frame into the confines of a chair, "so it's specially built for me," he adds, without a complaint.

Lorene has recently completed a three-dimensional crewel work entitled "Lorene's Flowers," which she plans on entering in the Sheboygan County Fair next month. The one by three foot piece took her ten years to complete, after she learned to master the use of her left hand.

Displayed on the wall at Beechwood Rest Home, the artwork is a magnificent achievement for a person with only the use of one hand. "She was always an expert seamstress," Jim explains, "and sewed everything from my underwear to pants, shirts... everything I wore." A good friend and West Bend high school teacher, Marianne Pulda, framed the piece for Lorene.

The daughter of a preacher, she loves music and became a concert pianist, working out of Lawrence College. Lorene won the Chicago Musicland Festival two years in a row, and played the organ in the Methodist Church for 35 years. Singing her praises, her husband emphatically states, "she was probably THE best organist and cook in the state!"

World War II started, and each other.

moved from West Allis to the Calhoun Farms in Brookfield. Jim worked at Briggs and Stratton for 40 years, retiring as office manager. Lorene studied accounting and worked for a car dealer in Waukesha." Back then she used to have to submit a handwritten report every month to Ford Motor Company," remembers Jim. "In seven years, there were no mistakes, so they treated her to a big dinner in Chicago."

The Martins retired to Florida in 1977, where Lorene suffered a stroke, which was devastating for both of them. It was so difficult for Jim to care for her alone, their sons Larry coming home. Larry took them in, where they lived up until two years ago when a stroke landed Jim in a wheelchair. "We took care of parents when the kids were growing up and it was a hard life," he recalls. "They had to be quiet and things like that. So we decided to come here, and this is where we'll remain!"

Refusing to become idle, Jim has written and published a 150 page manual on commitment entitled, "The Faithaction Stewardship Commitment Program," developed for use by all Christian denominations. The Martins are members of Batavia Methodist Church. His autobiography is soon to be published with a future book signing planned at the Random Lake Library. "I plan on working on more projects like this," Jim adds, turning the conversation back to Lorene, who listens patiently nearby with expressive eyes that meet her husband's

"She's been taking piano lessons. She had to start all over, but it's coming back slowly, beginning with the primary music. But it's very difficult to find sheet music that's for the left hand only. There's a rare piece in a Madison music store, but they want \$100 for it. That's too much for us.'

There's no stopping the two of them with Lorene dreaming of that blue ribbon from the fair, and Jim forming plans for his next book, this couple believes in planning for their future. But They were married for the time being, the present is September 1, 1939, the year filled with the joy of being with






Roland C. Koepke, 74, of Beechwood, passed away on Sunday, August 7, 1994, at his home.

#### **Kewaskum School District** Official Notice **Non-Discrimination Statement** and Discrimination Complaint Procedure

The Kewaskum School District is committed and dedicated to the task of providing the best education possible for every child in the District for as long as the student can benefit from attendance and the student's conduct is compatible with the welfare of the entire student body.

The right of the student to be admitted to school and to participate fully in curricular, extracurricular, student services, recreational or other programs or activities shall not be abridged or impaired because of the student's sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability.

Complaints regarding the interpretation or application of this policy shall be referred to the District Administrator and processed in accordance with procedures established by the Discrimination Complaint Procedure.

#### Discrimination Complaint Procedure

Any complaint regarding the interpretation or application of Kewaskum School District's student non-discrimination policies shall be processed in accordance with the following grievance procedure:

1) Any student, parent or resident of the School District complaining of discrimination on the basis of sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability in school programs or activities shall report the complaint in writing to the District Administrator.

2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken. if any, and report in writing the findings and the resolution of

the case to the grievant.

3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.

4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.

5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be referred directly to the State Superintendent of Public Instruction.







Minutes of Village Plan Commission

> Village of Kewaskum Plan Commission June 28, 1994 7:00 p.m.

The Plan Commission of the Village of Kewaskum, Washington County, Wisconsin met in the Council Room of the Municipal Building, 204 First Street.

President Robert H. Wagner called the meeting to order, Members present were David Goeden, John Stephani, Paul Ziebert, Richard Schmidt, Gerald Stollenwerk, Donald Mlodzik, Zoning Administrator Richard Zarling and Administrator Daniel Schmidt. A quorum was present.

The meeting was opened with a Moment of Silence and the Pledge of Allegiance.

On a motion by Richard Schmidt, seconded by Paul Ziebert and unanimously carried by voice vote, the Commission approved the minutes as printed for April 26,

Discussion was held on the preliminary plat of Gary and Linda Gavin for phase II of Sunset Estates, adjacent to Edgewood Road and south of Braatz Drive. It was noted the subdivision is being accomplished in two phases. The reason for doing the project in phases is the need to have the Army Corps of Engineers and the DNR verification of the existing wetlands (conservancy area). It was noted that the Army Corps did locate the

wetlands/conservancy area and that the plat before the Commission represents that staking. On a motion by Richard Schmidt, seconded by Gerald Stollenwerk and unanimously carried by voice vote, the Commission recommended the approval of the preliminary plat approval of said parcel (V4-0032) Phase II of Sunset Estate and sent the matter to the Village Board. The motion included the requirement that the deed restrictions as to the wetlands should be approved by either the Plan Commission or the Village Board in conjunction with the final plat approval. It should be further noted that extensive discussion was held on land accessibility to the south.

Mr. Rick Kania of SEWRPC was present to discuss the proposed Land Use Plan for the Village; Chapter VI Objectives, Principle Standards, and Design Guidelines. Mr. Kania reviewed the chapter with the Plan Commission and explained the general text of the chapter. On a motion by John Stephani, seconded by Paul Ziebert and unanimously carried by voice vote, the Commission approved the preliminary draft of Chapter VI.
