## Valley Bank Officially Becomes Bank Wisconsin

St. Francis Capital Corporation (NASDAQ: STFR) announced the consummation of the acquisition of the Valley Bank - East Central office in Kewaskum and the Valley Bank - Milwaukee office in Hartford from Marshall and Ilsley Corporation. The transaction became official at 12:01 a.m. on Monday, November 21, 1994 and is subject to certain post-closing adjustments.

Bank Wisconsin, the newly chartered subsidiary of the Company, will operate as a separate commercial bank subsidiary under the bank charter which was acquired in the transaction. This new bank subsidiary will be headquartered in Kewaskum.

James C. Hazzard has

been appointed President of the Bank Wisconsin subsidiary. Upon completion of the transaction, Bank Wisconsin will have approximately \$84 million in assets.

St. Francis Capital Corporation is the parent company of St. Francis Bank, F.S.B., which is the third largest Milwaukee-based savings institution, and Bank Wisconsin, the second largest commercial banking entity headquartered in Washington County, Wisconsin. Prior to the acquisition of Bank Wisconsin, St. Francis Capital Corporation had assets of \$1.027 million. St. Francis Capital Corporation now has offices in Kenosha, Milwaukee, Ozaukee, Washington and Waukesha Counties.

## Tax Rate to Increase 2.73% Village Board Approves '95 Budget

The Kewaskum Village Board met on Monday, November 28, to approve the 1995 budget.

In reviewing budget items, that were previously discussed at great length at past board meetings, Administrator Daniel Schmidt was asked by audience member Gary Gavin to go over, "areas where major increases are from last year."

Schmidt explained, "property tax proposed for 1995 is \$445,152.00 and that reflects a \$14,872.00 increase and that would equal 3.5%."

After further discussion, Gavid asked, "What is the highway project actually costing the village." To which Schmidt replied, "\$262,000." Schmidt also stated the stop and go lights on Highway H are included in the project.

In a memo to taxpayers the village explained it has again been able to maintain a stable/balanced budget. As

far as the general budget, an increase of 4.8% was realized. The property tax portion of the budget has increased by \$14,872 or 3.5%. The equalized value for 1994 increasing \$12,608,300 or 14.8% and the assessed value for 1994 increased \$2,706,500 or 4.0%.

What this translates into for the Village of Kewaskum taxpayers is good news. The tax levy for 1995 reflects an increase of 6.9% and a tax rate increase of 2.73% or \$.19 per \$1,000 of assessed value. The rate for the year ending December 31, 1994 is \$7.3179 per \$1,000 of assessed value.

The State of Wisconsin has kept the "Lottery Credit" on the tax bill. This "Lottery Credit" is estimated to be \$105.68 per each claimed primary residence.

The level of all basic services are to remain almost

the same, as is with maintenance of all Village property to continue on an even schedule.

The assessed gross tax rate has increased from \$35.50 to \$37.91 this year. This does not mean all taxing jurisdictions have followed in the Villages footsteps. The Kewaskum School District is realizing an increase of \$1.438 or 6.9% for 1995. The Washington County rate has increased \$.602 or 11.2%, the MPTC (VTAE) rate has increased \$.144 or 7.1% and the State rate has increased \$.026 or 10.3%. The Village has no authority to approve or disapprove these rate increases; they are just mandated to collect those taxes.

The State Tax Credit for 1995, \$1.84 reflects a decrease. This means a decrease in the tax credit of \$.04 or 2.3% which means an increase in the net tax rate will be realized.

KEYS is a non-profit organization established to accept gifts to provide additional scholarships for Kewaskum High School graduates.

The Moraine Chorus and The Kewaskum Swing Choir have donated their time and talent to perform this concert to help raise money for KEYS. The KEYS Christmas concert is the only Christmas concert that the Swing Choir performs.

The concert is a major fund raiser for KEYS. Tickets are \$2 (donations for more are accepted) and are available at Miller's Furniture, Kewaskum High School and at the door on the day of the concert.



KEWASKUM - A new era has dawned on the girls basketball program at Kewaskum high school, although the man running the show is no stranger to the KHS sports program.

Longtime volleyball coach Dave Rizzardi now calls the shots for the Lady Indians hoopsters, and if he can experience the same success that he has in the volleyball program, the Lady Indians should continue to improve.

"I really don't know what we should look like at this point," Rizzardi said of his inexperience in judging the team's early returns. "I think the girls are doing as much as they can right now."

Rizzardi doesn't have a whole lot to work with, as his rosters currently consists of just nine players. Leading that list are senior letterwinners Mary Yahr and Andrea Bonlander.

"Yahr has probably been playing the most consistent on the team," Rizzardi said of his veteran, whom he knows quite well from the volleyball squad. In fact, several of the players are familiar to Rizzardi from that sport, making the transition a bit easier.

Senior Christine Neumann is "making a good impact," in her first year on the varsity squad. "I guess overall, they are giving 100 percent and that's all I can ask for."

Those three are the lone seniors on the club, which is filled out by a half-dozen juniors. Tanya Laubach, Maureen Leitheiser, Laura Fleischman and Kelly Schreffler head the list of non-seniors, as they will all see extensive action this season, according to Rizzardi.

"We're trying to run and press a lot," Rizzardi said of his style of coaching. "I think though we've been running ourselves out of energy dur-

ing games."

The Lady Indians will have to do quite a bit of running during the Eastern Wisconsin Conference portion of their schedule. KHS

will have to face the likes of Two Rivers, which is favored to win the EW, and possible a state title, with the abundance of talent it has returning this season.

KHS will try to nestle in somewhere near the top of the EW standings, although detroning the Purple Raiders may be out of the question this season.

# Memories Retained in 'The Doctor's Inn'

"Doc" Edwards is sort of a legend in these parts; at least in Kewaskum, he's remembered as the country doctor, sometimes story teller, who brought alot of today's residents into this world with the help of his wife, Alma.

Now a part of their lives lives on through their daughter, Gwen Dreher, and her new Bed and Breakfast establishment, "The Doctor's Inn." Dreher recently purchased her parent's home on Fond du Lac Avenue, a sprawling two story trimmed in green shutters and landscaped like a country garden, and has put her experience as an interior designer to work.

The Dreher's had settled in Kenosha, and for 15 years, Gwen worked as a designer while her husband Jules owned and operated five gas stations throughout the area. In 1988, her parents asked if she would like to move back home and live with them, seeing they were getting up there in years and would prefer staying in the comfort of their own house rather than go to a nursing home.

In '89, Gwen began the slow process of moving back to Kewaskum, but in 1990 her father died at the age of 85. Left with her mother to care for, she realized Alma had Alzheimer's Disease -- creating the added challenge of keeping a constant eye on her. She also began redecorating her childhood home, working with a room at a time in the winter, and taking on the yard work in the summer.

Her husband finished tying up loose ends in 1992, and joined Gwen. They purchased the house across the street as an investment, fixed

it up, and recently sold it in order to purchase the Edward's home, which became official this past October 11th.

Doc and Alma Edwards traveled here from Minnesota in 1929, settling in the house next to the present property, which at that time contained an apple orchard. The orchard was purchased from the government in 1847, and changed hands several times, before they bought the piece of property, hired an architect, and built their dream home in 1940.

"In her teens, Alma worked in some wealthy homes in Sheboygan - that's how she met Doc," Gwen explains. "She was caring for Doc's sister, who had just lost a baby." Mrs. Edwards grew up on a farm, and had always longed to own an elegant home of her own someday. When her dream became a reality, the couple worked side by side, serving as the doctor and his assistant for this community for several decades. "It wasn't always easy," remembers Gwen. "With five children and cousin Annabelle Tessar living with us, our parents often worked 'til after midnight. We were alone alot."

The home is truly elegant, inside and out, graced with two fireplaces, one in the living room and the other in the basement. But for thirty years it had no real upkeep and needed a major overhaul. "I spent the past four and a half years fixing it up," remarks Dreher, "and it turned out to be alot of work."

All the hardwood floors were redone, rooms were wallpapered in bright colors, and she recently framed Doc's old diplomas, on display in the dining area.

Everything was purchased, along with the house, an in all the nooks and crannies lies evidence of a doctor's life, (although most of his things are on display at the Kewaskum Historical Society.

Painted metal cabinets are chock full of old medical equipment and original desks and furnishings are located throughout the interior, as well as childhood photos of the family growing up. Every bit of wall space is filled with memorabilia. You'll also discover Jules' passion for collecting treasures and antiques which create a finishing touch to The Doctor's Inn.

Gwen adds her love for creating stitcheries and afghans, and their enthusiasm for car racing, the Brewers and the Packers, decorates the rec room in the basement.

His original doctor's office has been turned into a five room apartment, which they rent out. At one time, the area served as examining, treatment and drug storage rooms. This little country hospital of sorts was connected to the main house.

Two bedrooms upstairs have been turned into guest rooms for the Bed and

Breakfast. The Cupid and Floral Room is done in teal and peach with an old-fashioned four-poster double bed, and a full size pull-out sleeper sofa. A ceiling fan is located overhead for summer comfort and towel racks, thick with towels, are located behind the door in each of the two rooms.

"I call the next room the Stars and Stripes Room, because Dad was such a politician," she explains. Decorated in red, white and blue, this sleeping area holds two twin beds, or they can be pushed together to create a king size bed, also with a ceiling fan and the rich, hardwood flooring. A baby crib is available to those needing one. There is a shared bath upstairs, but in the future, Gwen will be adding a sink and toilet to each room, and converting a third bedroom to the guest list, along with a Jacuzzi room.

The couple have their permit and the state came through this past week and approved The Doctor's Inn. After the state approval, The Wisconsin Bed and Breakfast Homes and Historic Inns Association will come through to review the home

to include in their listings.

"I just saw the potential," mentions Gwen, regarding her new business endeavor. She plans to serve a full breakfast in the dining area, offering a scenic view of the large patio and backyard. The Doctor's Inn is located near the State Park lakes, offering water sports, biking, hiking, snowmobile trails, horseback riding, as well as skiing, downhill and cross country, golfing, antiquing, and mall shopping. "We're located in the small town with country charm." Their grand opening is planned for Sunday, December 18th.

# Phase II of Condo Project Nearly Completed



John and Mary Ellen McElhatton, developers of Country Reflections

After raising eight children, John and Mary Ellen McElhatton of Kewaskum aren't afraid of keeping busy. Their family traditions include working on long-term projects together, and their latest endeavor is the development of three condominiums on Wildlife Dr.

Their son, Robert, first initiated the idea when he asked them if they'd be interested in putting up an apartment complex with him, but they were recently retired and didn't want to be landlords at that point in their lives. Then the topic of condos arose, which was something Mary Ellen could relate to. "I'm the third generation of Millers from Millers Furniture Store, and I'm used to seeing a lot of buildings and how they're set up. We used to furnish and arrange models for open houses", she explains. "I found out what worked and what didn't after seeing what was out there".

Exploring their options, the McElhattons came across two buildings, one in Jackson and the other in Milwaukee, that appealed to them. They found their own architect, and made some changes in the floor plan. "We enlarged the master bedroom and made it more interesting", Mary Ellen emphasizes, "and I worked with the floor plan and furniture placement".

In 1991 they purchased three lots from the village, one at a time. "We were hoping we could eventually buy the entire section of lots, but once we bought one, they started to sell". The first building was erected in '92, the concept being a cluster of three condominium structures with eight units in each - four uppers and four

lowers, reflecting an "open space" design. Everything was jobbed out by contract, with John supervising. "I've been in construction all my life, and you really learn a lot", he adds. Working with Valley Bank, now Bank Wisconsin, they were required to comply with all state regulations, which have become more stringent over the past few years.

Each unit is the same building architecturally, varied only with window changes and different positioning. The colors have been maintained throughout the project, adding to the continuity. On the side of the third building a berm will be built up and evergreens placed atop to keep the units offset and preserve individuality. The second one will be completed sometime this February, but the bank requires that two units be sold before a building can be started - so the third in a series is still just a lot. "The first building has been sold out for almost a year now before we got two pre-sales on the new one", Mary Ellen explains.

The McElhattons chose the name "Country Reflections" because, as Mary Ellen states, "you'll always be able to look out the window and view the country atmosphere...watch the changing colors of the trees". After living down the road from the properties for the past 41 years, they've seen the area change from farmland to a developed community. Still part of the township, the village limits reach right up to their front door. "I remember watching the migrant workers picking corn in the nearby field", McElhatton recalls, "there were only about twelve of

them, but they'd fling the corn into big wagons, singing the entire time, sounding just like a chorus".

While Robert and his wife GERALYNN work in partnership with his parents, the other seven children lead equally successful lives, including those in the construction business - one plumber, two electricians, (one being a son-in-law), and two in plaster and dry walling. "Because of this, there's a misconception in this village that all the work we have done is free", Mary Ellen points out, "but it's far from the truth".

Country Reflections Condominiums offers private entrances, a one car detached garage, two bedrooms, two baths, and an in unit stackable washer/dryer. Also included in the purchase are a stove, refrigerator, dishwasher, and a gas furnace with central air. The first floor plan includes 1,120 square feet of living space, and the second floor has 1,195 square feet.

Asked about their success as parents, the McElhattons answer, "we made them work from little on. We always worked together, and they tell people they learned how to work from their parents".

# Lady Indians Split in Openers

PORT WASHINGTON - As far as season openers go, new Kewaskum girls basketball coach Dave Rizzardi will take his team's effort last week in the Port Washington Invitational here.

The Lady Indians made Rizzardi's debut as KHS boss a successful one, beating the host Pirates in the first round of the tournament, 44-41 on Friday night.

But Kewaskum couldn't make it a perfect weekend the following evening, as the Indians ran into a cold spell in the first half, leading to a 47-33 loss to Ozaukee in the championship contest.

Against the Pirates, the Lady Indians fell behind in the first half. Some sloppy offensive play by Kewaskum enabled Port Washington to hold a 26-20 lead heading into the lockerroom at half-time.

But KHS came out on fire in the second behind the hot shooting of senior forward Kelly Schreffler. She hit three three-pointers in the contest, as the Lady Indians rallied to tie things at 36-all after three quarters.

Some tough defense by KHS in the final stanza enable them to take the lead for good. The Indians held Port Washington to just five points in the final eight minutes of play, thus allowing them to pull out the close win.

"It was nice to get a victory," in his initial coaching contest, said KHS boss Rizzardi. "We didn't play all

that great. We had a lot of turnovers, but we were able to come back in the second half."

Schreffler finished with a game-high 18 points to pace the Indians attack. Senior Mary Yahr added nine points, while Tanya Laubach chipped in eight.

In Saturday's championship game, KHS jumped out on top 10-8 after one period of play. But the Lady Indians seemed to tire in the second quarter, losing at both end so the court. The Warriors outscored KHS in the second frame 18-7, thus taking a 26-17 halftime advantage.

"I thought we had a good opportunity to play well against a good team," Rizzardi said. "But then we had that two or three minute stretch, and that did us in."

Yahr was the lone KHS player in double figures against the Warriors, as she tallied 12 points. Schreffler, meanwhile, struggled from the floor, hitting for just nine. Laubach had another solid outing, scoring eight.



Discussion followed with concerns expressed by the Commission and Director of Public Works that the minor street travel and parking lane cross sections appeared too narrow at thirty-six feet, especially in snow removal situations. The Commission also felt that the inclusion of an island in a cul-de-sac street would cause undue liability for the Village.

Mr. Kania stressed the street cross section plan would be a useful tool in implementing the Land Use Plan and presented desirable scenarios which could be revised due to the topography of the land encountered. Further input and consideration are needed by the Commission before adoption of a street cross sections design plan.

## Village Board Meeting Minutes

Regular Meeting  
November 7, 1994  
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the minutes of the October 17, 1994 meeting were approved as printed.

Assistant Fire Chief Mark Herriges, September 1994 monthly report:

Fire calls - 1, Year to date - 23; Jaws of life (used) - 4, Year to date - 20; (not used) Year to date; Rescue calls - 31, Year to date; Training - 201, Year to date - 1,806.5; Extra training - 81.75, Year to date - 1,226.9.

Assistant Fire Chief Mark Herriges, October 1994 monthly report:

Fire calls - 2, Year to date - 25; Jaws of life (used) - 2, Year to date - 22, (not used), Year to date; Rescue calls - 29, Year to date; Training - 226.75, Year to date - 2,033.25; Extra training - 184, Year to date - 1,410.9.

Assistant Fire Chief Mark Herriges reported on the Bylaw changes to the Village Board. Several items were added that were practices of the department, but never written down, as well as making the appropriate gender changes. The residency clause is a change from the Village Ordinance and will require an amendment to the existing ordinance. On a motion by Trustee William Kulas, seconded by Trustee John Borland and unanimously carried by voice vote, the Board approved the Fire Department Bylaw changes as presented and recognized the need to amend the Municipal Code regarding the residency requirements.

Chief of Police Richard L. Knoebel informed the Board that the Value bidding on the squad car is running a little later than last year but the results should be in shortly.

Director of Public Works, Jerry Gilles informed the Board that the manhole project on Main Street and Fond du Lac Avenue has been completed and that the official last leaf pick up day is scheduled for November 8, 1994.

Administrator Daniel S. Schmidt reviewed the following with the Board:

- 1) Reviewed the building permit report for the month of October 1994.
- 2) Reviewed Tax Payer Alliance Bulletins and League Letters.
- 3) Announcement of the Centennial Committee meeting scheduled for Monday, November 14, 1994 at 7:00 p.m.
- 4) Reviewed miscellaneous correspondence.

On a motion by Trustee Charles Waala, seconded by Trustee David Goeden and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. The

Board Representative for the Plan Commission, Trustee David Goeden reported on the October 24, 1994 Commission meeting, indicating that Mr. Rick Kania of SEWRPC was present to update the Commission on the proposed Land Use Plan for the Village; and to present a summary of desirable street cross section plans for arterial, collector, minor and cul-de-sac streets.

Board Representative for the Library Board, Trustee Charles Waala reported that library circulation is up for 1994 by 4,745; also the new cost as related to MOLL/Athena was reviewed with the Board.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee William Kulas informed the Board that the MMMA will be scheduling several seminars for employees as well as Board Members and encouraged good participation.

It was noted that the Wildlife Drive project is completed and that the special assessment would be mailed out in early December. It was also noted the installation of street lights on Bonnie Lane have been scheduled for this fall and that there would be a total of 5 lights installed.

On a motion by Trustee Charles Waala, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board authorized the issuance of a contract with Aquatic Biologist, Inc., Fond du Lac, WI for swim pond maintenance for 1995 as presented and reviewed.

Action was taken on Resolution No. 94-20 a resolution to amend the 1994 Village of Kewaskum General Fund Adopted Budget as attached hereto:

Action was taken on Resolution No. 94-21 a resolution to Request Tax Exemption from the County-Wide Library System Tax Levy under provisions of Wisconsin Statutes 43.64(2) as attached hereto:

On a motion by Trustee Robert Beisbier, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board authorized the signing and mailing of the letter as presented to the Kewaskum School Board and Dr. David Heather regarding the installation of sidewalk on Reigle Drive adjacent to the athletic field.

Costs were reviewed regarding the renovation needed on the rental house located at 1102 Fond du Lac Avenue. It was noted the cosmetic type repair equalled an estimated \$6,650 and that the immediate capital improvements would equal an estimated \$23,100 for a total of \$29,750. The additional capital items not needed to rent the house, but proposed for the future, were estimated at \$25,000. The appraised value of the house was \$57,700 or less per the Village Assessor. It was noted that all of the contractors contacted except one, indicated the Village would best be served

if the building were razed. The same comment came from the Assessor, Attorney and Building Inspector. It was further noted that the Village did not have any funds budgeted for such work in 1994 or in the proposed 1995 budget. If the Village Board would borrow the estimated \$30,000 to complete said work and pay for it over a 10 year period, the monthly payments would be \$342.07. The Village Board also asked the Director of Public Works to get an estimate on razing the property which came in at \$3,300 to \$7,300 depending on a motion by Trustee David Goeden, seconded by Trustee John Borland and unanimously carried by voice vote, the Board authorized the razing of the property located at 1102 Fond du Lac Avenue. It was further noted that when the property was purchased in the mid 70's it was purchased with the intent to raze the structure for the placement of the fire house. The building was in fair enough condition to rent out to hopefully recoup some of the purchase cost. In reality, this was accomplished with no major outlays.

A review of the Special Revenue Fund noted that \$36,530 would be taken from the Open Space Fund to pay for those items on the Park Outlay budget for 1995.

A review of the TIF/CIP budget as proposed for 1995 revealed that the amount of increment is estimated at \$332,018, in increase of \$107,556 or + 46.7%.

The Water Department proposed budget for 1995 was reviewed. It was noted the cur-

rent revenue is up slightly, but not in comparison to the expenditures. It was further noted that the Village's rate adjustment has been submitted to the Public Service Commission for review.

The Water Pollution Control Department proposed budget for 1995 was reviewed. The revenues are up considering the rate adjustment recently acted on by the Village Board and taking into account the dairy may only be located in the Village 6 to 9 months. The expenditure side of the budget is proposed to increase \$37,510 or 10.7%.

A review of the 1995 Budget Summary was held indicating that the general fund actually reflected a decrease in the tax levy. This was clarified by noting that some capital project accounts have been set up to make proper determinations for the Department of Revenues Expenditure Restraint Program. On a motion by Trustee Charles Waala, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board established the date and time for the budget public hearings. The public hearing will be held on Monday, November 28, 1994 at 7:00 p.m.

Some general budget discussion was held noting that as presented on the budget summary a 2.72% increase would be reflected on the tax rate, which would equal \$0.194 per \$1,000 of assessed value increase. The gross Village tax rate using these figures equals \$7.318 per \$1,000 of assessed value. This would mean a property assessed at \$70,000 would pay \$13.58 more

for Village tax.

On a motion by Trustee William Kulas, seconded by Trustee John Borland and unanimously carried by voice vote, the Board authorized the signing of the retirement agreement for Gregor Rohlinger as both he and the union signed. It was noted in this agreement Mr. Rohlinger announces his official retirement date of December 13, 1994.

On a motion by Trustee David Goeden, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board conditionally approved the changing of Health Insurance policies and authorized the signing of the appropriate paperwork related to such a change if in fact all items materialize.

On a motion by Trustee John Borland, seconded by Trustee Charles Waala and carried by the majority roll call vote, to adjourn to closed session under Chapter 19.85(1)(c) of the statutes to consider employment, compensation and performance of public employees over which the governmental body has jurisdiction. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

**ORDINANCE NO. 94-11**  
AN ORDINANCE TO AMENDING CHAPTER 5  
FIRE DEPARTMENT

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM DO ORDAIN AS FOLLOWS:

WHEREAS, the Fire Department of the Village of Kewaskum has brought Bylaw changes before the Village Board and the Village Board has approved those changes as presented and needs to bring the Municipal Code into compliance.

NOW THEREFORE BE IT RESOLVED, that 5.05 ORGANIZATION.

(1) (a) COMPOSITION - The Fire Department shall consist of one Chief, an Assistant Chief, First and Second Captain, First and Second Lieutenant, Rescue Captain, Rescue Lieutenant, Secretary Lieutenant, Treasurer Lieutenant and fire fighters. The Members of the Fire Department shall reside within the Village or in the sections of the Townships protected by the Fire Department, the Village of Kewaskum and protected townships. In addition, persons resident on the roads which form the perimeter of this area are eligible to become members, provided that their addresses are listed as resident on such roads. Any Members resident outside of or absent from the area here specified, for a period of 90 days or longer, shall be dropped from the roster of the Kewaskum Fire Department, unless excused by the Chief.

(b) To be eligible for the Rescue Squad, you must be a member of the Kewaskum Fire Department and shall reside within the Village limits or in sections 3, 4, 5, 8, 9, 10, that portion of section 14 bounded on the east by Oak Road, 15, 16, and 17. In addition, persons resident on the roads which form the perimeter of this area are eligible to become members of the rescue squad providing that their addresses are listed as residing on such roads. You may also become a rescue squad member if you live in the fire department boundaries (as described in section (a) of this chapter) and work within the boundaries described above and that your employer allows you to leave work to respond to calls during working hours.

NOW THEREFORE BE IT RESOLVED, that the existing 5.05 Organization be replaced with aforementioned.

This Ordinance shall take effect upon passage and publication as provided by law.

KEWASKUM -- A team can play a nearly flawless game for three quarters - even three and a half quarters - and still come up a loser. The Kewaskum girls basketball team found that out the hard way here, last Tuesday night.

The Lady Indians played well in their annual battle with Slinger. But KHS was outscored 19-0 during two stretches totalling about 5:00, and came up on the short end of a 51-44 decision.

The loss dropped the Lady Indians to 1-2 on the season, while Slinger, playing its season-opener, is 1-0.

## KHS Grapplers Blending Youth, Experience

**KEWASKUM** -- After a stellar 1993-94 campaign that saw several firsts recorded by his squad, Kewaskum wrestling mentor John Nell will have a challenge on his hands this season.

His quest will be to blend a group of talented returning letterwinners with some enthusiastic underclassmen. The mix, Nell hopes, will be a winning one.

"We're very young at the lower weights," Nell said of his team. "We've got some nice kids back though, and they are working real well. I'm really happy with the team that I've got."

Heading the list of returning grapplers is sophomore Joel Dziedzic, who will open the 1994 campaign at 119 pounds. Dziedzic finished fifth at the WIAA state meet at 103 pounds last year, and Nell thinks he will be heading back to Madison this year.

"He's looking real tough," Nell said of Dziedzic, who will probably move to 112 pounds after the Christmas break. Wrestlers are allowed a two-pound allowance at each weight class after the holidays.

Several seniors return to the mix, including longtime veterans Tyler Dieringer (135), Jake Thull (130), and Rich Farchione (171).

Farchione is a two-time Eastern Wisconsin Conference champion, and finished 29-4 last season after being upset in Regional competition. "He's real tough, and has set some high goals for himself this year," Nell said.

Dieringer, meanwhile, finished 22-10 as a junior, and "is wrestling real aggressively," this season, according to his coach. Thull, a three-year varsity wrestler, is very experienced and should hold his own against anyone, Nell said.

Other seniors returning to the varsity lineup include Jason Czaja (140), Brian Redig (145) and Peter Reis (152), although Reis is having a problem with sore ribs, and will be out of action for awhile.

Junior Tim Gundrum is back and should hold down the heavyweight spot in the lineup. "He looks real tough," Nell said, adding, "he went to some camps over the summer and is very confident."

Matt Heather and Craig Erdmann will battle for the 160-pound slot, while Richard Wolff will battle sophomore Bruce Gundrum for the 189-pound spot. Both Erdmann and Wolff missed a lot of practice time during the hunting season, and will need catching up before cracking the starting lineup, Nell noted. Transfer Eric Kopecky will occupy the 152-pound slot for the time being.

Nell is equally excited about several freshmen who should see significant mat time this year. Dieringer's brother, Josh, will begin the season as the starting 112-Pounder, although he likely will be moved to another weight class when Dziedzic is ready to move down.

"He's got a great attitude," Nell said of the younger Dieringer, who, "is hanging right in there with the more experienced kids."

Fellow freshman Josh Sterr will open the season at 125 pounds. "He's not afraid of anybody," Nell said of the inexperienced Sterr. "He just needs to get some mat time."

Nell said that the Indians currently don't have anyone to fill the 103 pound spot, although freshman Clint Bindrich could fill the void. "He might have to wait until after Christmas though," when he can actually wrestle at 105 pounds.

It will be tough to duplicate last year's success, as that squad won its Regional tournament, thus qualifying for the state team tournament for the first time in school history. The Indians also had a pair of places at the state meet - senior Chad Muckerheide took fourth - for the first time ever.

Making things more difficult for Nell is that several seniors who had been a part of the program the past three years decided not to go out for the sport this season. That surprised Nell, who noted that all four were quality wrestlers, who had experienced success in previous years.

While he says that he "will leave the door open for their return," Nell is confident that those who did try out for the sport will perform well.

"I think we'll be alright," he said. "We have some really nice kids out. We've been running them through the mill, working them pretty

hard. But they never complain. They really have been working hard."

As for the Indians' chances in the EW this year, Nell is optimistic, yet cautious.

"It's going to be a dog-fight," he said. "One move (in any match) can determine a lot."

He pointed to New Holstein, Sheboygan Falls and Plymouth as other teams that will be challenging the Indians for the conference title. KHS finished third at the conference meet last season.

"My main goal is to get kids down to state," Nell said. "And I think that we've got some kids that can do that."

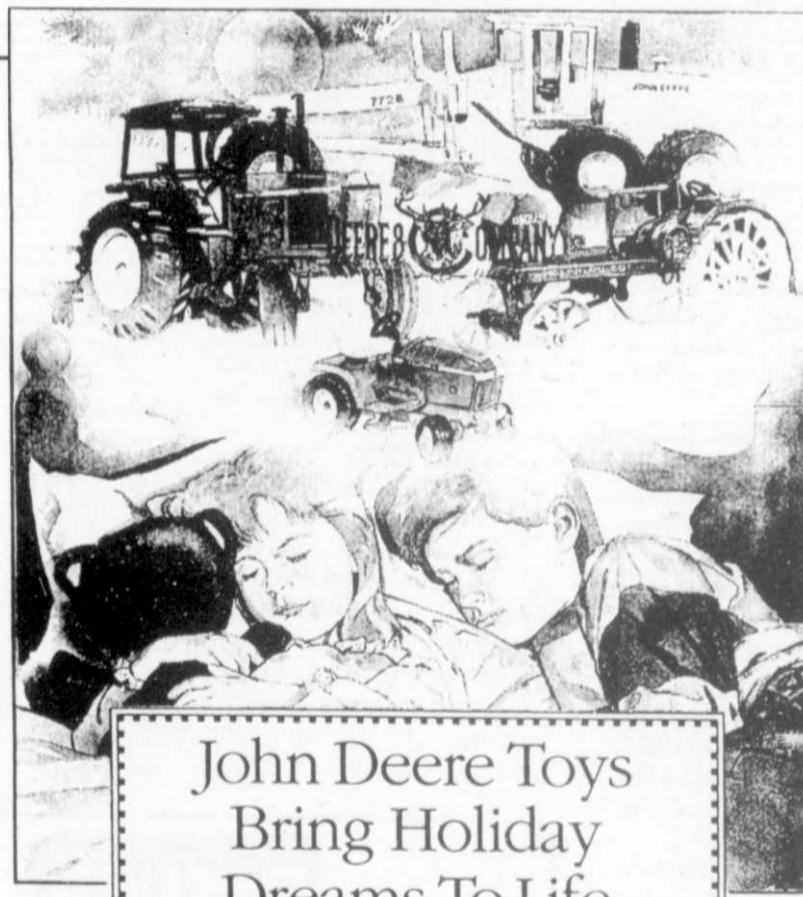

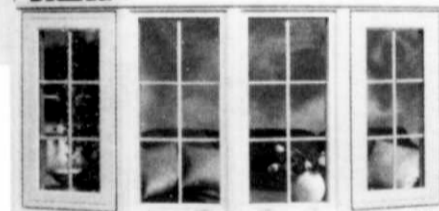
